

## 1 VIRGINIA ACTS OF ASSEMBLY — CHAPTER

2 *An Act to amend and reenact § 54.1-119 of the Code of Virginia, relating to professional and*  
3 *occupational licenses; temporary licenses for spouses of military service members.*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 54.1-119 of the Code of Virginia is amended and reenacted as follows:**8 **§ 54.1-119. Expediting the issuance of licenses, etc., to spouses of military service members;**  
9 **issuance of temporary licenses, etc.**

10 A. Notwithstanding any other law to the contrary and unless an applicant is found by the board to  
11 have engaged in any act that would constitute grounds for disciplinary action, a regulatory board within  
12 the Department of Professional and Occupational Regulation or the Department of Health Professions or  
13 any other board named in this title shall expedite the issuance of a license, permit, certificate, or other  
14 document, however styled or denominated, required for the practice of any business, profession, or  
15 occupation in the Commonwealth to an applicant whose application has been deemed complete by the  
16 board and (i) who holds the same or similar license, permit, certificate, or other document required for  
17 the practice of any business, profession, or occupation issued by another jurisdiction; (ii) whose spouse  
18 is the subject of a military transfer to the Commonwealth; and (iii) who ~~left employment to accompany~~  
19 *accompanies* the applicant's spouse to Virginia, if, in the opinion of the board, the requirements for the  
20 issuance of the license, permit, certificate, or other document in such other jurisdiction are substantially  
21 equivalent to those required in the Commonwealth.

22 B. If a board is unable to (i) complete the review of the documentation provided by the applicant or  
23 (ii) make a final determination regarding substantial equivalency within 20 days of the receipt of a  
24 completed application, the board shall issue a temporary license, permit, or certificate, provided the  
25 applicant otherwise meets the qualifications set out in subsection A. Any temporary license, permit, or  
26 certification issued pursuant to this subsection shall be limited for a period not to exceed ~~six~~ 12 months  
27 and shall authorize the applicant to engage in the profession or occupation while the board completes its  
28 review of the documentation provided by the applicant or the applicant completes any specific  
29 requirements that may be required in Virginia that were not required in the jurisdiction in which the  
30 applicant holds the license, permit, or certificate.

31 C. The provisions of this section shall apply regardless of whether a regulatory board has entered  
32 into a reciprocal agreement with the other jurisdiction pursuant to subsection B of § 54.1-103.

33 D. Any regulatory board may require the applicant to provide documentation it deems necessary to  
34 make a determination of substantial equivalency.
