WHEREAS, Michael Irvine lives his faith through his actions and enjoys fellowship and worship with the community at St. John's United Methodist Church, where he is a past chair of the church council, past chair of trustees, chair of the endowment committee, and a Sunday school teacher; and

WHEREAS, a man of great integrity, Michael Irvine served the community and the Commonwealth with the utmost professionalism, dedication, and distinction; now, therefore, be it
