4. Title: Vehicle registration fees; funds allocated to Department of State Police.

- **5. Summary:** The proposal raises the vehicle registration fee by an additional \$1.25 per year on each July 1 from 2016 through 2025 and allocates the funds to the Department of State Police. The cumulative increase in the fee, as of July 1, 2025, would be \$12.50.
- **6. Budget Amendment Necessary**: Yes. Item 442 (expenditure), and Item 423 (revenue).
- **7. Fiscal Impact Estimates:** Tentative. See7a. and 7b., and 8.

8. Fiscal Implications:

The proposal annually increases the motor vehicle registration fee on each vehicle type as listed in § 46.2-694 Code of Virginia by \$1.25. The revenue collected from the additional fee is to be allocated to the Department of State Police (Department). The proposed \$1.25 fee is to be compounded annually each year from 2016 through 2025.

Currently, the fee for most private passenger cars is either \$33.00 (for vehicles weighing 4,000 pounds or less) or \$38.00 (for vehicles weighing more). By calendar year 2025, this proposal would raise those fees to \$45.50 and \$50.50, respectively.

According to the Department of Motor Vehicles (DMV), there were 7,974,773 vehicles registered in Virginia in FY 2015. Assuming a two percent annual projected increase in the number of vehicles to be registered, the following table represents revenue estimates from the additional motor vehicle registration fee for fiscal year 2017 through fiscal year 2026 under the proposed legislation:

Further, due to credit card merchant fees, DMV will incur additional costs associated the increased registration fees paid by payment cards. Each time a card is used, DMV pays two percent of the transaction cost. Since under the proposal the collected revenue is allocated to State Police, DMV will not retain any portion of the collected revenue to cover the additional merchant fees. Assuming that approximately 48 percent of vehicle registration transactions is paid with credit cards, the estimated additional expenditure impact to DMV is outlined below:
