6 **Be it enacted by the General Assembly of Virginia:**7 **1. That §§ 1 and 2, as amended, of Chapter 66 of the Acts of Assembly of 1960 are amended and**
8 **reenacted as follows:**

9 § 1. The creation of the Hampton Roads Sanitation District is hereby ratified, validated and
10 confirmed, and said District shall embrace all the territory within the Cities of Chesapeake, Hampton,
11 Newport News, Norfolk, Poquoson, Portsmouth, Suffolk, Virginia Beach, and Williamsburg; the
12 Counties of Gloucester, Isle of Wight, James City, King and Queen, King William, Mathews, Middlesex
13 and York; *the County of Surry, excluding the Town of Claremont*; and the Town of Urbanna. Territory
14 may be added to the District as hereinafter provided in this act.

15 For the purpose of this section, the territory of a county included within the District shall include all
16 the territory lying within the boundaries of any town in the county *unless otherwise specified*.

17 Said District shall constitute a political subdivision of Commonwealth established as a governmental
18 instrumentality to provide for the public health and welfare.

19 § 2. The functions, affairs and property of the Hampton Roads Sanitation District shall be managed
20 and controlled by a commission, known as the "Hampton Roads Sanitation District Commission,"
21 consisting of eight members appointed by the Governor. The Commission and the term of each such
22 member shall continue until his successor shall be duly appointed and qualified. The successor of each
23 such member shall be appointed for a term of four years and until his successor shall be duly appointed
24 and qualified, except that any person appointed to fill a vacancy shall serve only for the unexpired term.
25 Any member of the Commission shall be eligible for reappointment without limitation as to the number
26 of terms that may be served. Members of the Commission may be suspended or removed by the
27 Governor at his pleasure.

28 At the time of their appointment, one of the members of the Commission, and each of his
29 successors, shall be residents of the territory in the District within the City of Norfolk; one of the
30 members, and each of his successors, shall be residents of the territory in the District within the City of
31 Virginia Beach; one of the members, and each of his successors, shall be residents of the territory in
32 the District within the City of Newport News; one of the members, and each of his successors, shall be
33 residents of the territory in the District within the City of Hampton; one of the members, and each of
34 his successors, shall be residents of the territory in the District within the City of Chesapeake; one of
35 the members, and each of his successors, shall be residents of the territory in the District within the City
36 of Suffolk or Isle of Wight County; *or Surry County*; one of the members, and each of his successors,
37 shall be residents of the territory in the District within the City of Williamsburg or James City County
38 or York County or the City of Poquoson or Gloucester County or King William County or Mathews
39 County or Middlesex County or the Town of Urbanna; or King and Queen County; and one of the
40 members, and each of his successors, shall be residents of the territory in the District within the City of
41 Portsmouth. Any member who shall cease to reside within the territory from which he was appointed
42 shall thereupon be disqualified from holding office as a member of the Commission and the vacancy
43 thus created shall be filled by appointment by the Governor for the balance of the unexpired term.
