17103726D **SENATE BILL NO. 1539** 1 2 Offered January 20, 2017 3 A BILL to amend and reenact § 2.2-435.7 of the Code of Virginia, relating to the Chief Workforce 4 Development Advisor; responsibilities. 5 Patron-Ruff 6 7 Referred to Committee on General Laws and Technology 8 9 Be it enacted by the General Assembly of Virginia: 1. That § 2.2-435.7 of the Code of Virginia is amended and reenacted as follows: 10 § 2.2-435.7. Responsibilities of the Chief Workforce Development Advisor. 11 A. The Governor's responsibilities as carried out by the Chief Workforce Development Advisor shall 12 13 include: 14 1. Developing a strategic plan for the statewide delivery of workforce development and training 15 programs and activities. The strategic plan shall be developed in coordination with the development of 16 the comprehensive economic development policy required by § 2.2-205. The strategic plan shall include performance measures that link the objectives of such programs and activities to the record of state 17 agencies, local workforce development boards, and other relevant entities in attaining such objectives; 18 19 2. Determining the appropriate allocation, to the extent permissible under applicable federal law, of 20 funds and other resources that have been appropriated or are otherwise available for disbursement by the 21 Commonwealth for workforce development programs and activities; 22 3. Ensuring that the Commonwealth's workforce development efforts are implemented in a 23 coordinated and efficient manner by, among other activities, taking appropriate executive action to this 24 end and recommending to the General Assembly necessary legislative actions to streamline and eliminate 25 duplication in such efforts; 4. Facilitating efficient implementation of workforce development and training programs by cabinet 26 27 secretaries and agencies responsible for such programs; 28 5. Developing, in coordination with the Virginia Board of Workforce Development, (i) certification 29 standards for programs and providers and (ii) uniform policies and procedures, including standardized 30 forms and applications, for one-stop centers; 6. Monitoring, in coordination with the Virginia Board of Workforce Development, the effectiveness 31 32 of each one-stop center and recommending actions needed to improve their effectiveness; 33 7. Establishing measures to evaluate the effectiveness of the local workforce development boards and 34 conducting annual evaluations of the effectiveness of each local workforce development board. As part 35 of the evaluation process, the Governor shall recommend to such boards specific best management 36 practices: 37 8. Conducting annual evaluations of the performance of workforce development and training programs and activities and their administrators and providers, using the performance measures 38 39 developed through the strategic planning process described in subdivision 1. The evaluations shall 40 include, to the extent feasible, (i) a comparison of the per-person costs for each program or activity, (ii) a comparative rating of each program or activity based on its success in meeting program objectives, 41 and (iii) an explanation of the extent to which each agency's appropriation requests incorporate the data 42 reflected in the cost comparison described in clause (i) and the comparative rating described in clause 43 (ii). These evaluations, including the comparative rankings, shall be considered in allocating resources 44 for workforce development and training programs. These evaluations shall be submitted to the chairs of 45 46 the House and Senate Commerce and Labor Committees and included in the biennial reports pursuant to 47 subdivision 10: 9. Monitoring federal legislation and policy, in order to maximize the Commonwealth's effective use 48 49 of and access to federal funding available for workforce development programs; and 10. Submitting biennial reports, which shall be included in the Governor's executive budget 50 51 submissions to the General Assembly, on improvements in the coordination of workforce development 52 efforts statewide. The reports shall identify (i) program success rates in relation to performance measures 53 established by the Virginia Board of Workforce Development, (ii) obstacles to program and resource 54 coordination, and (iii) strategies for facilitating statewide program and resource coordination. 55 B. The Chief Workforce Development Advisor shall report *directly* to the Governor and shall not 56 serve in any other capacity.
