Estimate of Local Fiscal Impact

2016 General Assembly Session

In accordance with the provisions of §30-19.03 of the Code of Virginia, the staff of the Commission on Local Government offers the following analysis of the above-referenced legislation:

Bill Summary:

Firefighters employed by localities; entitlement to continued compensation during period of quarantine or isolation. Provides that a firefighter who is the subject of an order of quarantine or an order of isolation as a result of potential exposure that occurred in the line of duty is entitled to the continued payment of compensation from his local employer during the period of such quarantine or isolation.

Executive Summary:

As per the provisions of HB 1104, firefighters employed by localities would be entitled to receive continued compensation during the period of quarantine or isolation as a result of potential exposure in the line of duty.

Localities have evaluated a negative fiscal impact of \$0.01 - \$5,000. The provisions of the bill would affect all local governments in some way. Localities noted that the impact could be large depending on the interpretation of the bill including questions on compensation and administration related to (1) payment of salary and overtime, and (2) compensation from workers compensation and the employer.

Firefighters in some localities already receive full compensation for the duration of a quarantine or isolation either through regular pay or worker's compensation. These localities are concerned about the potential implication and interpretation of this bill on their existing compensation procedures for quarantine and isolation.

Local Analysis:

We are unable to provide an estimate as we do not have any history/trend information regarding this area. However, the impact could be large depending upon the interpretation of the bill.

This bill does raise some very important questions: How will this interact with Workers Compensation? Could someone potentially draw pay in accordance to this bill and receive Workers Compensation due to one incident? Also there are not definitions for order of quarantine, order of isolation, or exposure. (for contagious/communicable diseases?) This could be interpreted in a broad manner that may not be the original intent of the bill.

Considering that sometimes workers comp covers these incidents and sometimes they don't, the amount listed above would be the average firefighters salary + benefits for one month. So the impact would be dependent upon the number of firefighters x the number of days/months they would be out of work. Of course, this amount is just salary and benefits for the full-time firefighter. The actual impact would be greater, and hard to determine, because it depends upon the individual(s) covering for their absence: full-time at over-time rate, or part-time.
