8. Fiscal Implications: The Lottery has the legal authority to sell subscriptions over the Internet, and has done so for 10 years. Removing the restriction regarding single draws/single tickets will supplement Lottery profits constitutionally dedicated to local K-12 public education. Internet sales would be secure, age verified and include responsible gaming provisions – similar to the current safeguards in place for internet lottery subscription sales.

These revenue estimates are based on experiences of other U.S. lotteries, and assume no additional administrative restrictions. Lottery sales at over 5,200 licensed retailer locations across Virginia will continue to grow and represent well over 90% of total Lottery profits into the future. Full support for traditional in-store lottery sales will continue.

The costs to implement and execute internet sales would be paid from the sales dollars generated, and would not require any start-up or continued funding. The position and appropriation impact shown is an estimate based on the need to have increased digital marketing, financial/contractual and regulatory/legal support for implementation and to sustain those needs going forward. These positions would require specific skills and experience, and are estimated to average \$85,000 annual salaried positions. An additional \$101,760 is estimated for benefits and other non-personal costs associated with the additional three positions.

Technical Amendment Necessary:** Yes, modify the wording for the existing Lottery sum sufficient appropriation (Item 485): There is hereby appropriated from affected funds in the state treasury, for payment of prizes awarded by the state lottery, for compensation to gaming system providers under percentage of sales agreements, and of commissions to lottery sales agents, in accordance with law, a sum sufficient.
