18106383D 1 **HOUSE BILL NO. 1554** 2 AMENDMENT IN THE NATURE OF A SUBSTITUTE 3 (Proposed by the House Committee on General Laws 4 on February 6, 2018) 5 (Patron Prior to Substitute—Delegate Pillion) 6 A BILL to amend and reenact §§ 54.1-700 and 54.1-706 of the Code of Virginia, relating to the Board 7 for Barbers and Cosmetology; license requirements; barbers. 8 Be it enacted by the General Assembly of Virginia: 9 1. That §§ 54.1-700 and 54.1-706 of the Code of Virginia are amended and reenacted as follows: 10 § 54.1-700. Definitions. 11 As used in this chapter, unless the context requires a different meaning: 12 "Barber" means any person who shaves, shapes or trims the beard; cuts, singes, shampoos or dyes the hair or applies lotions thereto; applies, treats or massages the face, neck or scalp with oils, creams, 13 lotions, cosmetics, antiseptics, powders, clays or other preparations in connection with shaving, cutting 14 15 or trimming the hair or beard, and practices barbering for compensation and when such services are not 16 performed for the treatment of disease. "Barbering" means any one or any combination of the following acts, when done on the human body 17 for compensation and not for the treatment of disease, shaving, shaping and trimming the beard; cutting, 18 singeing, shampooing or dyeing the hair or applying lotions thereto; applications, treatment or massages 19 20 of the face, neck or scalp with oils, creams, lotions, cosmetics, antiseptics, powders, clays, or other 21 preparations in connection with shaving, cutting or trimming the hair or a beard. The term "barbering" 22 shall not apply to the acts described hereinabove when performed by any person in his home if such 23 service is not offered to the public. 24 "Barber instructor" means any person who has been certified by the Board as having completed an 25 approved curriculum and who meets the competency standards of the Board as an instructor of 26 barbering. 27 "Barbershop" means any establishment or place of business within which the practice of barbering is 28 engaged in or carried on by one or more barbers. 29 "Board" means the Board for Barbers and Cosmetology. 30 "Body-piercer" means any person who for remuneration penetrates the skin of a person to make a 31 hole, mark, or scar, generally permanent in nature. "Body-piercing" means the act of penetrating the skin of a person to make a hole, mark, or scar, generally permanent in nature. 32 33 34 "Body-piercing salon" means any place in which a fee is charged for the act of penetrating the skin 35 of a person to make a hole, mark, or scar, generally permanent in nature. 36 'Body-piercing school" means a place or establishment licensed by the Board to accept and train 37 students in body-piercing. 38 "Cosmetologist" means any person who administers cosmetic treatments; manicures or pedicures the 39 nails of any person; arranges, dresses, curls, waves, cleanses, cuts, shapes, singes, waxes, tweezes, 40 shaves, bleaches, colors, relaxes, straightens, or performs similar work, upon human hair, or a wig or 41 hairpiece, by any means, including hands or mechanical or electrical apparatus or appliances unless such 42 acts as adjusting, combing, or brushing prestyled wigs or hairpieces do not alter the prestyled nature of the wig or hairpiece, and practices cosmetology for compensation. 43 "Cosmetology" includes, but is not limited to, the following practices: administering cosmetic 44 treatments; manicuring or pedicuring the nails of any person; arranging, dressing, curling, waving, 45 cleansing, cutting, shaping, singeing, waxing, tweezing, shaving, bleaching, coloring, relaxing, straightening, or similar work, upon human hair, or a wig or hairpiece, by any means, including hands 46 47 **48** or mechanical or electrical apparatus or appliances, but shall not include hair braiding or such acts as 49 adjusting, combing, or brushing prestyled wigs or hairpieces when such acts do not alter the prestyled 50 nature of the wig or hairpiece. 51 "Cosmetology instructor" means a person who has been certified by the Board as having completed 52 an approved curriculum and who meets the competency standards of the Board as an instructor of 53 cosmetology. 54 "Cosmetology salon" means any commercial establishment, residence, vehicle or other establishment, 55 place or event wherein cosmetology is offered or practiced on a regular basis for compensation and may include the training of apprentices under regulations of the Board. 56 57 "Esthetician" means a person who engages in the practice of esthetics for compensation.

58 "Esthetics" includes, but is not limited to, the following practices of administering cosmetic59 treatments to enhance or improve the appearance of the skin: cleansing, toning, performing effluerage or

other related movements, stimulating, exfoliating, or performing any other similar procedure on the skin 60

of the human body or scalp by means of cosmetic preparations, treatments, or any nonlaser device, 61

whether by electrical, mechanical, or manual means, for care of the skin; applying make-up or eyelashes 62 63 to any person, tinting or perming eyelashes and eyebrows, and lightening hair on the body except the

64 scalp; and removing unwanted hair from the body of any person by the use of any nonlaser device, by 65 tweezing, or by use of chemical or mechanical means. However, "esthetics" is not a healing art and shall not include any practice, activity, or treatment that constitutes the practice of medicine, osteopathic medicine, or chiropractic. The terms "healing arts," "practice of medicine," "practice of osteopathic 66

67 medicine," and "practice of chiropractic" shall mean the same as those terms are defined in § 54.1-2900. 68 "Esthetics instructor" means a licensed esthetician who has been certified by the Board as having 69

completed an approved curriculum and who meets the competency standards of the Board as an 70 71 instructor of esthetics.

72 "Esthetics spa" means any commercial establishment, residence, vehicle, or other establishment, place, or event wherein esthetics is offered or practiced on a regular basis for compensation under 73 74 regulations of the Board.

75 "Master barber" means a licensed barber who, in addition to the practice of barbering, performs 76 waving, shaping, bleaching, relaxing, or straightening upon human hair; performs similar work on a 77 wig or hairpiece; or performs waxing limited to the scalp.

78 "Master esthetician" means a licensed esthetician who, in addition to the practice of esthetics, offers 79 to the public for compensation, without the use of laser technology, lymphatic drainage, chemical 80 exfoliation, or microdermabrasion, and who has met such additional requirements as determined by the Board to practice lymphatic drainage, chemical exfoliation with products other than Schedules II through 81 VI controlled substances as defined in the Drug Control Act (§ 54.1-3400 et seq.), and 82 83 microdermabrasion of the epidermis. 84

"Nail care" means manicuring or pedicuring natural nails or performing artificial nail services.

85 "Nail salon" means any commercial establishment, residence, vehicle or other establishment, place or event wherein nail care is offered or practiced on a regular basis for compensation and may include the 86 87 training of apprentices under regulations of the Board.

"Nail school" means a place or establishment licensed by the board to accept and train students in 88 89 nail care.

90 "Nail technician" means any person who for compensation manicures or pedicures natural nails, or 91 who performs artificial nail services for compensation, or any combination thereof.

92 "Nail technician instructor" means a licensed nail technician who has been certified by the Board as 93 having completed an approved curriculum and who meets the competency standards of the Board as an 94 instructor of nail care.

"Physical (wax) depilatory" means the wax depilatory product or substance used to remove 95 96 superfluous hair.

97 'School of cosmetology" means a place or establishment licensed by the Board to accept and train 98 students and which offers a cosmetology curriculum approved by the Board.

99 "School of esthetics" means a place or establishment licensed by the Board to accept and train 100 students and which offers an esthetics curriculum approved by the Board. 101

"Tattoo parlor" means any place in which tattooing is offered or practiced.

102 "Tattoo school" means a place or establishment licensed by the Board to accept and train students in 103 tattooing. 104

"Tattooer" means any person who for remuneration practices tattooing.

"Tattooing" means the placing of designs, letters, scrolls, figures, symbols or any other marks upon 105 or under the skin of any person with ink or any other substance, resulting in the permanent coloration of 106 the skin, including permanent make-up or permanent jewelry, by the aid of needles or any other 107 108 instrument designed to touch or puncture the skin.

109 "Wax technician" means any person licensed by the Board who removes hair from the hair follicle 110 using a physical (wax) depilatory or by tweezing.

"Wax technician instructor" means a licensed wax technician who has been certified by the Board as 111 112 having completed an approved curriculum and who meets the competency standards of the Board as an instructor of waxing. 113

"Waxing" means the temporary removal of superfluous hair from the hair follicle on any area of the 114 human body through the use of a physical (wax) depilatory or by tweezing. 115

116 "Waxing salon" means any commercial establishment, residence, vehicle or other establishment, place or event wherein waxing is offered or practiced on a regular basis for compensation and may include the 117 training of apprentices under regulations of the Board. 118

"Waxing school" means a place or establishment licensed by the Board to accept and train students 119 120 in waxing.

§ 54.1-706. Different requirements for licensure. 121

A. The Board shall have the discretion to impose different requirements for licensure for the practiceof barbering, cosmetology, nail care, waxing, tattooing, body-piercing, and esthetics.

- 124 B. The Board shall issue a license to practice as a master barber in the Commonwealth to:
- 125 1. An individual who holds a valid, unexpired license as a barber issued by the Board prior to 126 December 8, 2017; or
- 127 2. An applicant who has successfully (i) completed the educational requirements as required by the
 128 Board, (ii) completed the experience requirements as required by the Board, and (iii) passed the
 129 examination approved by the Board.
- 130 2. That an emergency exists and this act is in force from its passage.
