That § 54.1-2523.1 of the Code of Virginia is amended and reenacted as follows: § 54.1-2523.1. Criteria for indicators of misuse; Director's authority to disclose information; 10 11 intervention. A. The Director shall develop, in consultation with an advisory panel which shall include 12 13 representatives of the Boards of Medicine and Pharmacy, criteria for indicators of unusual patterns of prescribing or dispensing of covered substances by prescribers or dispensers and misuse of covered 14 15 substances by recipients and a method for analysis of data collected by the Prescription Monitoring 16 Program using the criteria for indicators of misuse to identify unusual patterns of prescribing or 17 dispensing of covered substances by individual prescribers or dispensers or potential misuse of a covered 18 substance by a recipient. B. In cases in which analysis of data collected by the Prescription Monitoring Program using the 19 20 criteria for indicators of misuse indicates an unusual pattern of prescribing or dispensing of a covered 21 substance by an individual prescriber or dispenser or potential misuse of a covered substance by a 22 recipient, the Director may, in addition to the discretionary disclosure of information pursuant to 23 § 54.1-2523: 24 1. Disclose information about the unusual prescribing or dispensing of a covered substance by an 25 individual prescriber or dispenser to the Enforcement Division of the Department of Health Professions; 26 or 27 2. Disclose information about the specific recipient to (i) the prescriber or prescribers who have 28 prescribed a covered substance to the recipient for the purpose of intervention to prevent misuse of such 29 covered substance or (ii) an agent who has completed the Virginia State Police Drug Diversion School 30 designated by the Superintendent of State Police or designated by the chief law-enforcement officer of any county, city, or town or campus police department for the purpose of an investigation into possible 31 32 drug diversion. 33 C. The Director shall annually review, in consultation with an advisory panel that shall include 34 representatives from the relevant health regulatory boards, the Department of Health, the Department of 35 Medical Assistance Services, and the Department of Behavioral Health and Developmental Services, 36 controlled substance prescribing and dispensing patterns and shall (i) make any necessary changes to 37 the criteria for unusual patterns of prescribing and dispensing required by subsection A and (ii) report 38 any findings and recommendations for best practices to the Joint Commission on Health Care by 39 November 1 of each year.
