## VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend and reenact § 2.2-4310 of the Code of Virginia, relating to the Virginia Public 3 Procurement Act; participation of service disabled veteran-owned business.

## Approved

6 Be it enacted by the General Assembly of Virginia:

7 1. That § 2.2-4310 of the Code of Virginia is amended and reenacted as follows:

8 § 2.2-4310. Discrimination prohibited; participation of small, women-owned, minority-owned, 9 and service disabled veteran-owned businesses and employment services organizations.

10 A. In the solicitation or awarding of contracts, no public body shall discriminate against a bidder or offeror because of race, religion, color, sex, national origin, age, disability, status as a service disabled 11 12 veteran, or any other basis prohibited by state law relating to discrimination in employment. Whenever 13 solicitations are made, each public body shall include businesses selected from a list made available by the Department of Small Business and Supplier Diversity, which list shall include all companies and 14 15 organizations certified by the Department.

B. All public bodies shall establish programs consistent with this chapter to facilitate the participation 16 17 of small businesses, businesses owned by women, minorities, and service disabled veterans, and employment services organizations in procurement transactions. The programs established shall be in 18 19 writing and shall comply with the provisions of any enhancement or remedial measures authorized by 20 the Governor pursuant to subsection C or, where applicable, by the chief executive of a local governing 21 body pursuant to § 15.2-965.1, and shall include specific plans to achieve any goals established therein. State agencies shall submit annual progress reports on (i) small, women-owned, and minority-owned 22 23 business procurement, (ii) service disabled veteran-owned business procurement, and (iii) employment 24 services organization procurement to the Department of Small Business and Supplier Diversity in a form 25 specified by the Department of Small Business and Supplier Diversity. Contracts and subcontracts 26 awarded to employment services organizations and service disabled veteran-owned businesses shall be 27 credited toward the small business, women-owned, and minority-owned business contracting and 28 subcontracting goals of state agencies and contractors. The Department of Small Business and Supplier 29 Diversity shall make information on service disabled veteran-owned procurement available to the 30 Department of Veterans Services upon request.

C. Whenever there exists (i) a rational basis for small business or employment services organization 31 32 enhancement or (ii) a persuasive analysis that documents a statistically significant disparity between the 33 availability and utilization of women-owned and minority-owned businesses, the Governor is authorized 34 and encouraged to require state agencies to implement appropriate enhancement or remedial measures 35 consistent with prevailing law. Any enhancement or remedial measure authorized by the Governor pursuant to this subsection for state public bodies may allow for small businesses certified by the 36 37 Department of Small Business and Supplier Diversity or a subcategory of small businesses established as a part of the enhancement program to have a price preference over noncertified businesses competing for 38 39 the same contract award on designated procurements, provided that the bid of the certified small 40 business or the business in such subcategory of small businesses established as a part of an enhancement 41 program does not exceed the low bid by more than five percent.

42 D. In awarding a contract for services to a small, women-owned, or minority-owned business that is 43 certified in accordance with § 2.2-1606, or to a business identified by a public body as a service disabled veteran-owned business where the award is being made pursuant to an enhancement or remedial 44 45 program as provided in subsection C, the public body shall include in every such contract of more than 46 \$10,000 the following:

"If the contractor intends to subcontract work as part of its performance under this contract, the 47 48 contractor shall include in the proposal a plan to subcontract to small, women-owned, minority-owned, 49 and service disabled veteran-owned businesses."

50 E. In the solicitation or awarding of contracts, no state agency, department or institution shall 51 discriminate against a bidder or offeror because the bidder or offeror employs ex-offenders unless the state agency, department or institution has made a written determination that employing ex-offenders on 52 53 the specific contract is not in its best interest. 54

F. As used in this section:

55 "Employment services organization" means an organization that provides community-based 56 employment services to individuals with disabilities that is an approved Commission on Accreditation of SB386ER

57 Rehabilitation Facilities (CARF) accredited vendor of the Department for Aging and Rehabilitative58 Services.

59 "Minority individual" means an individual who is a citizen of the United States or a legal resident 60 alien and who satisfies one or more of the following definitions:

61 1. "African American" means a person having origins in any of the original peoples of Africa and62 who is regarded as such by the community of which this person claims to be a part.

63 2. "Asian American" means a person having origins in any of the original peoples of the Far East,
64 Southeast Asia, the Indian subcontinent, or the Pacific Islands, including but not limited to Japan, China,
65 Vietnam, Samoa, Laos, Cambodia, Taiwan, Northern Mariana Islands, the Philippines, a U.S. territory of
66 the Pacific, India, Pakistan, Bangladesh, or Sri Lanka and who is regarded as such by the community of
67 which this person claims to be a part.

3. "Hispanic American" means a person having origins in any of the Spanish-speaking peoples of
Mexico, South or Central America, or the Caribbean Islands or other Spanish or Portuguese cultures and
who is regarded as such by the community of which this person claims to be a part.

4. "Native American" means a person having origins in any of the original peoples of North America and who is regarded as such by the community of which this person claims to be a part or who is recognized by a tribal organization.

74 "Minority-owned business" means a business that is at least 51 percent owned by one or more 75 minority individuals who are U.S. citizens or legal resident aliens, or in the case of a corporation, 76 partnership, or limited liability company or other entity, at least 51 percent of the equity ownership 77 interest in the corporation, partnership, or limited liability company or other entity is owned by one or 78 more minority individuals who are U.S. citizens or legal resident aliens, and both the management and 79 daily business operations are controlled by one or more minority individuals, or any historically black college or university as defined in § 2.2-1604, regardless of the percentage ownership by minority 80 individuals or, in the case of a corporation, partnership, or limited liability company or other entity, the 81 equity ownership interest in the corporation, partnership, or limited liability company or other entity. 82

83 "Šervice disabled veteran" means a veteran who (i) served on active duty in the United States
84 military ground, naval, or air service, (ii) was discharged or released under conditions other than
85 dishonorable, and (iii) has a service-connected disability rating fixed by the United States Department of
86 Veterans Affairs.

87 "Service disabled veteran business" means a business that is at least 51 percent owned by one or
88 more service disabled veterans or, in the case of a corporation, partnership, or limited liability company
89 or other entity, at least 51 percent of the equity ownership interest in the corporation, partnership, or
90 limited liability company or other entity is owned by one or more individuals who are service disabled
91 veterans and both the management and daily business operations are controlled by one or more
92 individuals who are service disabled veterans.

"Small business" means a business, independently owned and controlled by one or more individuals
who are U.S. citizens or legal resident aliens, and together with affiliates, has 250 or fewer employees,
or annual gross receipts of \$10 million or less averaged over the previous three years. One or more of
the individual owners shall control both the management and daily business operations of the small
business.

98 "State agency" means any authority, board, department, instrumentality, institution, agency, or other99 unit of state government. "State agency" shall not include any county, city, or town.

100 "Women-owned business" means a business that is at least 51 percent owned by one or more women 101 who are U.S. citizens or legal resident aliens, or in the case of a corporation, partnership, or limited 102 liability company or other entity, at least 51 percent of the equity ownership interest is owned by one or 103 more women who are U.S. citizens or legal resident aliens, and both the management and daily business 104 operations are controlled by one or more women.
