12	Be it enacted by the General Assembly of Virginia:
13	1. That § 38.2-3125 of the Code of Virginia is amended and reenacted and that the Code of
14	Virginia is amended by adding sections numbered 38.2-3111.1 and 38.2-3122.1 as follows:
15	§ 38.2-3111.1. Annuity contract purchased to fund retirement benefits; transfer subject to
16	Commission approval.
17	A. As used in this section:
18	"Employer" means a person doing business in or operating within the Commonwealth who employs a
19	resident of the Commonwealth to work for wages or a salary or on commission and includes any similar
20	entity acting directly or indirectly in the interest of an employer in relation to an employee. "Employer"
21	does not include the Commonwealth or any of its agencies, institutions, or political subdivisions or any
22	public body.
23	"ERISA" means the federal Employee Retirement Income Security Act of 1974 (P.L. 93-406, 88 Stat.
24 25	829), as amended. "Pension plan" has the same meaning ascribed to that term in § 3(2) of ERISA.
23 26	"Retirement annuity contract" means an allocated or unallocated group annuity contract that is
27	issued or issued for delivery by an insurer to an employer or a pension plan, pension plan sponsor, or
28	affiliate of such employer, pension plan, or pension plan sponsor, for the purpose of providing
29	retirement benefits to employees or retirees of the employer under a defined benefit plan and that (i) is
30	issued or issued for delivery in the Commonwealth or (ii) affects retired employees residing in the
31	Commonwealth who are certificate holders or beneficiaries of a contract if the Commission has
32	jurisdiction over the insurer issuing the contract.
33	B. On and after July 1, 2018, no retirement annuity contract shall be transferred to or assumed by
34	another insurer without the prior written approval of the Commission. The Commission shall not
35	approve such a transfer or assumption of a retirement annuity contract until the insurer has provided to
36 37	the Commission written certification, which shall include a legal opinion by an attorney whom the
37 38	Commission finds has sufficient experience with and knowledge of ERISA and related relevant issues to render such an opinion, that the annuity benefits payable under the retirement annuity contract either
39	will continue to be or will no longer be protected under ERISA or by the Federal Pension Benefit
40	Guaranty Corporation. If the annuity benefits:
41	1. Will continue to be protected under ERISA or by the Federal Pension Benefit Guaranty
42	Corporation, the Commission shall approve the proposed transfer or assumption; and
43	2. Will no longer be protected under ERISA or by the Federal Pension Benefit Guaranty
44	Corporation, the Commission shall not approve the proposed transfer or assumption unless (i) the
45	transfer is made to an assuming insurer that has the financial strength to fulfill its obligations under the
46	retirement annuity contract and (ii) the assuming insurer is licensed in the Commonwealth to write the
47	class or classes of insurance applicable to its assumed obligations under the retirement annuity
48	contract. The Commission shall find that the assuming insurer to which the retirement annuity contract
49 50	is proposed to be transferred has the financial strength to fulfill its obligations under the retirement
50 51	annuity contract if it maintains a rating equivalent of A or better from two or more nationally recognized rating agencies
51 52	recognized rating agencies. C. If the Commission determines that an insurer has violated this section or any order or regulation
52 53	adopted hereunder, the Commission, after notice and opportunity to be heard, may impose a penalty in
54	accordance with §§ 38.2-218 and 38.2-219.

56 57 58 A. As used in this section: "Employer" means a person doing business in or operating within the Commonwealth who employs

another to work for wages or a salary or on commission and includes any similar entity acting directly 59 60 or indirectly in the interest of an employer in relation to an employee. "Employer" does not include the Commonwealth or any of its agencies, institutions, or political subdivisions or any public body. 61

64 "Pension plan" has the same meaning ascribed to that term in § 3(2) of ERISA.

B. Any interest in or amounts payable to a participant or beneficiary from any allocated or 65 unallocated group annuity contract issued or issued for delivery in the Commonwealth to an employer 66 or a pension plan for the purpose of providing retirement benefits to employees or retirees of the 67 employer under a defined benefit plan, which retirement benefits were protected under ERISA or the 68 Federal Pension Benefit Guaranty Corporation prior to the effective date of the group annuity contract 69 and will not be protected under ERISA or the Federal Pension Benefit Guaranty Corporation on and 70 after the effective date of the group annuity contract, shall be exempt from the claims of all creditors of 71 72 such participant or beneficiary.

C. The exemption from the claims of creditors provided under subsection B shall not apply to claims 73 74 arising under a qualified domestic relations order.

75 § 38.2-3125. Other rights of beneficiaries and assignees protected.

76 Since the purpose of §§ 38.2-3122, 38.2-3122.1, and 38.2-3123 is to confer additional rights, privileges, and benefits upon beneficiaries and assignees of policies, no beneficiary or assignee shall by 77 78 reason of these sections be divested or deprived of or prohibited from exercising or enjoying any right, 79 privilege, or benefit that he would have or could exercise or enjoy had §§ 38.2-3122, 38.2-3122.1, and 80 38.2-3123 not been enacted.
