1.	Title:	Establishes Consortium Comprehensive Cancer Center Advisory Board					

5. Summary: The proposed legislation establishes, as an independent advisory board in state government, a 13-member Consortium Comprehensive Cancer Center Advisory Board. Of the thirteen members, seven are to be nonlegislative citizen members and six ex-officio members. The provisions of the bill sunset on July 1, 2021.

Nonlegislative citizen members shall be appointed as follows: three nonlegislative citizen members, including one representative from Eastern Virginia Medical School, to be appointed by the Speaker of the House of Delegates; two nonlegislative citizen members, including one representative from the Virginia Tech Carilion School of Medicine and Research Institute, to be appointed by the Senate Committee on Rules; and two nonlegislative citizen members to be appointed by the Governor, including one representative of the State Council of Higher Education for Virginia (SCHEV), subject to confirmation by the General Assembly. The President of Virginia Commonwealth University (VCU) or his designee, one member of the VCU Board of Visitors, the Vice President for Health Sciences at VCU, or his designee, the President of the University of Virginia (UVA) or his designee, one member of the UVA Board of Visitors, and the Executive Vice-President for Health Affairs at the UVA or his designee shall serve as ex officio with voting privileges. All nonlegislative citizen members shall be citizens of the Commonwealth and have experience in health care or cancer research

The duties of the Board are to study the requirements for designation as a consortium Comprehensive Cancer Center and make recommendations to VCU and UVA relating to the process for establishing a joint National Cancer Institute-designated consortium Comprehensive Cancer Center. The Board will also make recommendations relating to a joint leadership structure, research integration, and programmatic integration and submit an annual report to the Governor and General Assembly for publication as a report document as provided in the procedures of the Division of Legislative Automated Systems for processing of legislative documents and reports. In addition, the Chairman shall submit an annual executive summary of the interim activity and work of the Advisory Board to the Governor and General Assembly no later than the first day of each regular session of the General Assembly. The Executive Summary shall be submitted as a report document as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents and reports and shall be posted on the General Assembly's website.

8. Fiscal Implications: The Advisory Board will elect a chairman and vice-chairman from among the membership and meet no more than four times each year. A majority of members will constitute a quorum. Members shall receive compensation for the performance of their duties as provided in §2.2-2813, Code of Virginia. All members shall be reimbursed for all reasonable and necessary expenses incurred in the performance of their duties as provided in §\$2.2-2813 and 2.2-2825, Code of Virginia. It is difficult to estimate the exact costs for reimbursement to members of the Advisory Board since at this time, the appointments have not been made and the number of meetings to be held is not known. It is anticipated, though that these costs can be absorbed by the higher education institutions benefiting from the work of the Advisory Board. Funding for the costs of compensation and expenses for the members shall be provided jointly by each educational institution.

The House Appropriations Committee, the Senate Finance Committee, SCHEV, VCU, UVA, Eastern Virginia Medical School, and Virginia Tech Carilion School of Medicine and Research Institute shall provide staff to the Advisory Board. All agencies of the Commonwealth shall assist the Advisory Board, upon request.
