5 Be it enacted by the General Assembly of Virginia: 6

- 1. That § 19.2-59.1 of the Code of Virginia is amended and reenacted as follows:
- § 19.2-59.1. Strip searches prohibited; exceptions; how strip searches conducted.

7 8 A. No person in custodial arrest for a traffic infraction, Class 3 or Class 4 misdemeanor, or a 9 violation of a city, county, or town ordinance, which is punishable by no more than thirty 30 days in 10 jail shall be strip searched unless there is reasonable cause to believe on the part of a law-enforcement officer authorizing the search that the individual is concealing a weapon. All strip searches conducted 11 12 under this section shall be performed by persons of the same sex as the person arrested and on premises 13 where the search cannot be observed by persons not physically conducting the search.

14 B. A regional jail superintendent or the chief of police or the sheriff of the county or city shall 15 develop a written policy regarding strip searches.

C. A search of any body cavity must be performed under sanitary conditions and a search of any 16 body cavity, other than the mouth, shall be conducted either by or under the supervision of medically 17 18 trained personnel.

19 D. Strip searches authorized pursuant to the exceptions stated in subsection A of this section shall be 20 conducted by a law-enforcement officer as defined in § 9.1-101.

21 E. The provisions of this section shall not apply when the person is taken into custody by or 22 remanded to a law-enforcement officer pursuant to a circuit or district court order.

23 F. For purposes of this section, "strip search" shall mean means having an arrested person remove or 24 arrange some or all of his clothing so as to permit a visual inspection of the genitals, buttocks, anus, 25 female breasts, or undergarments of such person.

26 G. Nothing in this section shall prohibit a sheriff or a regional jail superintendent from requiring that 27 inmates take hot water and soap showers and be subjected to visual inspection upon assignment to the 28 general population area of the jail or upon determination by the sheriff or regional jail superintendent 29 that the inmate must be held at the jail by reason of his inability to post bond after reasonable 30 opportunity to do so.

31 H. Except for children committed to the Department of Juvenile Justice or confined or detained in a 32 secure local facility for juveniles or a jail or other facility for the detention of adults and except as provided in subsection A or E, no child under the age of 18 shall be strip searched or subjected to a 33 34 search of any body cavity by a law-enforcement officer, as defined in § 9.1-101, or a jail officer.
