10	Be it enacted by the General Assembly of Virginia:
11	1. That § 20-124.3 of the Code of Virginia is amended and reenacted as follows:
12	§ 20-124.3. Best interests of the child; visitation.
13	In determining best interests of a child for purposes of determining custody or visitation
14	arrangements, including any pendente lite orders pursuant to § 20-103, the court shall consider the
15	following:
16	1. The age and physical and mental condition of the child, giving due consideration to the child's
17	changing developmental needs;
18 19	2. The age and physical and mental condition of each parent;
19 20	3. The relationship existing between each parent and each child, giving due consideration to the positive involvement with the child's life, the ability to accurately assess and meet the emotional,
20 21	intellectual, and physical needs of the child;
22	4. The needs of the child, giving due consideration to other important relationships of the child,
23	including but not limited to siblings, peers, and extended family members;
24	5. The role that each parent has played and will play in the future, in the upbringing and care of the
25	child;
26	6. The propensity of each parent to actively support the child's contact and relationship with the other
27	parent, including whether a parent has unreasonably denied the other parent access to or visitation with
28	the child;
29	7. The relative willingness and demonstrated ability of each parent to maintain a close and
30	continuing relationship with the child, and the ability of each parent to cooperate in and resolve disputes
31	regarding matters affecting the child;
32	8. The reasonable preference of the child, if the court deems the child to be of reasonable
33	intelligence, understanding, age, and experience to express such a preference;
34	9. Any history of family abuse as that term is defined in § 16.1-228 [, any act of violence, force, or
35	threat as that phrase is defined in § 19.2-152.7:1 against an intimate partner or the intimate partner's
36	child,] or any history of [child abuse or] sexual abuse. If the court finds such a history or act, the
37	court may disregard the factors in subdivision 6; and
38 39	10. Such other factors as the court deems necessary and proper to the determination.
	The judge shall communicate to the parties the basis of the decision either orally or in writing.
40 41	Except in cases of consent orders for custody and visitation, this communication shall set forth the judge's findings regarding the relevant factors set forth in this section. At the request of either party, the
+1 42	court may order that the exchange of a child shall take place at an appropriate meeting place.
