AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the Senate Committee on the Judiciary

on January 27, 2020)

(Patron Prior to Substitute—Senator Stuart)

- 5 6 A BILL to amend and reenact §§ 16.1-253.2 and 18.2-60.4 of the Code of Virginia, relating to 7 violations of protective orders; penalty. 8
 - Be it enacted by the General Assembly of Virginia:
- 9 1. That §§ 16.1-253.2 and 18.2-60.4 of the Code of Virginia are amended and reenacted as follows: 10 § 16.1-253.2. Violation of provisions of protective orders; penalty.

A. In addition to any other penalty provided by law, any person who violates any provision of a protective order issued pursuant to § 16.1-253, 16.1-253.1, 16.1-253.4, 16.1-278.14, or 16.1-279.1 or 11 12 13 subsection B of § 20-103, when such violation involves a provision of the protective order that prohibits such person from (i) going or remaining upon land, buildings, or premises; (ii) further acts of family 14 15 abuse; or (iii) committing a criminal offense, or which prohibits contacts by the respondent with the 16 allegedly abused person or family or household members of the allegedly abused person as the court 17 deems appropriate, is guilty of a Class 1 misdemeanor. The punishment for any person convicted of a second offense of violating a protective order, when the offense is committed within five years of the 18 19 prior conviction and when either the instant or prior offense was based on an act or threat of violence, 20 shall include a mandatory minimum term of confinement of 60 days. Any person convicted of a third or 21 subsequent offense of violating a protective order, when the offense is committed within 20 years of the 22 first conviction and when either the instant or one of the prior offenses was based on an act or threat of 23 violence is guilty of a Class 6 felony and the punishment shall include a mandatory minimum term of 24 confinement of six months. The mandatory minimum terms of confinement prescribed for violations of 25 this section shall be served consecutively with any other sentence.

26 B. In addition to any other penalty provided by law, any person who, while knowingly armed with a 27 firearm or other deadly weapon, violates any provision of a protective order with which he has been 28 served issued pursuant to § 16.1-253, 16.1-253.1, 16.1-253.4, 16.1-278.14, or 16.1-279.1 or subsection B 29 of § 20-103 is guilty of a Class 6 felony.

30 C. If the respondent commits an any assault and battery, or causes a bodily injury in violation of Article 4 (§ 18.2-51 et seq.) of Chapter 4 of Title 18.2, upon any party protected by the protective order 31 32 resulting in bodily injury to the party or stalks any party protected by the protective order in violation of § 18.2-60.3, he is guilty of a Class 6 felony. Any person who violates such a protective order by 33 34 furtively entering the home of any protected party while the party is present, or by entering and 35 remaining in the home of the protected party until the party arrives, is guilty of a Class 6 felony, in 36 addition to any other penalty provided by law.

37 D. Upon conviction of any offense hereunder for which a mandatory minimum term of confinement 38 is not specified, the person shall be sentenced to a term of confinement and in no case shall the entire 39 term imposed be suspended. Upon conviction, the court shall, in addition to the sentence imposed, enter 40 a protective order pursuant to § 16.1-279.1 for a specified period not exceeding two years from the date 41 of conviction. 42

§ 18.2-60.4. Violation of protective orders; penalty.

A. Any person who violates any provision of a protective order issued pursuant to § 19.2-152.8, 43 44 19.2-152.9, or 19.2-152.10 is guilty of a Class 1 misdemeanor. Conviction hereunder shall bar a finding of contempt for the same act. The punishment for any person convicted of a second offense of violating 45 a protective order, when the offense is committed within five years of the prior conviction and when 46 47 either the instant or prior offense was based on an act or threat of violence, shall include a mandatory minimum term of confinement of 60 days. Any person convicted of a third or subsequent offense of **48** 49 violating a protective order, when the offense is committed within 20 years of the first conviction and 50 when either the instant or one of the prior offenses was based on an act or threat of violence, is guilty 51 of a Class 6 felony and the punishment shall include a mandatory minimum term of confinement of six months. The mandatory minimum terms of confinement prescribed for violations of this section shall be 52 53 served consecutively with any other sentence.

54 B. In addition to any other penalty provided by law, any person who, while knowingly armed with a 55 firearm or other deadly weapon, violates any provision of a protective order with which he has been served issued pursuant to § 19.2-152.8, 19.2-152.9, or 19.2-152.10 is guilty of a Class 6 felony. 56

C. If the respondent commits an any assault and battery, or causes a bodily injury in violation of 57 Article 4 (§ 18.2-51 et seq.), upon any party protected by the protective order resulting in bodily injury 58 59 to the party or stalks any party protected by the protective order in violation of § 18.2-60.3, he is guilty

60 of a Class 6 felony. Any person who violates such a protective order by furtively entering the home of

any protected party while the party is present, or by entering and remaining in the home of the protected
party until the party arrives, is guilty of a Class 6 felony, in addition to any other penalty provided by
law.

64 D. Upon conviction of any offense hereunder for which a mandatory minimum term of confinement65 is not specified, the person shall be sentenced to a term of confinement and in no case shall the entire66 term imposed be suspended.

67 E. Upon conviction, the court shall, in addition to the sentence imposed, enter a protective order 68 pursuant to § 19.2-152.10 for a specified period not exceeding two years from the date of conviction.

69 2. That the provisions of this act may result in a net increase in periods of imprisonment or 70 commitment. Pursuant to § 30-19.1:4 of the Code of Virginia, the estimated amount of the 71 necessary appropriation is ______ for periods of imprisonment in state adult correctional 72 facilities; therefore, Chapter 854 of the Acts of Assembly of 2019 requires the Virginia Criminal 73 Sentencing Commission to assign a minimum fiscal impact of \$50,000. Pursuant to § 30-19.1:4 of 74 the Code of Virginia, the estimated amount of the necessary appropriation is ______ for periods

75 of commitment to the custody of the Department of Juvenile Justice.
