11	Be it enacted by the General Assembly of Virginia:
12	1. That § 9.1-184 of the Code of Virginia is amended and reenacted and that the Code of Virginia
13 14	is amended by adding a section numbered 22.1-279.10 as follows: § 9.1-184. Virginia Center for School and Campus Safety created; duties.
15	A. From such funds as may be appropriated, the Virginia Center for School and Campus Safety (the
16	Center) is hereby established within the Department. The Center shall:
17	1. Provide training for Virginia public school personnel in school safety, on evidence-based
18	antibullying tactics based on the definition of bullying in § 22.1-276.01, and in the effective
19 20	identification of students who may be at risk for violent behavior and in need of special services or assistance;
20 21	2. Serve as a resource and referral center for Virginia school divisions by conducting research,
22	sponsoring workshops, and providing information regarding current school safety concerns, such as
23	conflict management and peer mediation, bullying as defined in § 22.1-276.01, school facility design and
24 25	technology, current state and federal statutory and regulatory school safety requirements, and legal and constitutional issues regarding school safety and individual rights;
23 26	3. Maintain and disseminate information to local school divisions on effective school safety
27	initiatives in Virginia and across the nation;
28	4. Develop a case management tool for the collection and reporting of data by threat assessment
29 30	teams pursuant to § 22.1-79.4; 5. Collect, analyze, and disseminate various Virginia school safety data, including school safety audit
31	information submitted to it pursuant to § 22.1-279.8, collected by the Department and, in conjunction
32	with the Department of Education, information relating to the activities of school resource officers and
33	school security officers submitted pursuant to § 22.1-279.10;
34 35	6. Encourage the development of partnerships between the public and private sectors to promote school safety in Virginia;
36	7. Provide technical assistance to Virginia school divisions in the development and implementation of
37	initiatives promoting school safety, including threat assessment-based protocols with such funds as may
38	be available for such purpose;
39 40	8. Develop a memorandum of understanding between the Director of the Department of Criminal Justice Services and the Superintendent of Public Instruction to ensure collaboration and coordination of
40 41	roles and responsibilities in areas of mutual concern, such as school safety audits and crime prevention;
42	9. Provide training for and certification of school security officers, as defined in § 9.1-101 and
43	consistent with § 9.1-110;
44 45	10. Develop, in conjunction with the Department of State Police, the Department of Behavioral Health and Developmental Services, and the Department of Education, a model critical incident response

48	11. In consultation with the Department of Education, provide schools with a model policy for the
49 50	establishment of threat assessment teams, including procedures for the assessment of and intervention with students whose behavior poses a threat to the safety of school staff or students; and
50 51	12. Develop a model memorandum of understanding setting forth the respective roles and
52	responsibilities of local school boards and local law-enforcement agencies regarding the use of school
53	resource officers. Such model memorandum of understanding may be used by local school boards and
54 55	local law-enforcement agencies to satisfy the requirements of § 22.1-280.2:3. B. All agencies of the Commonwealth shall cooperate with the Center and, upon request, assist the
55 56	Center in the performance of its duties and responsibilities.

58	The Department of Criminal Justice Services, in coordination with the Department of Education and

59 the Department of Juvenile Justice, shall annually collect, report, and publish on its website data on the 60 use of force against students, including the use of chemical, mechanical, or other restraints and 61 instances of seclusion; detentions of students; arrests of students; student referrals to court or court service units; and other disciplinary actions by school resource officers and school security officers 62 involving students. Such data shall (i) be published in a manner that protects the identities of students; 63 (ii) be disaggregated by local school division and by student age, grade, race, ethnicity, gender, and 64 65 disability, if such data is available; and (iii) note the approximate time and location of the incident and 66 whether the incident took place on school property and during school hours.
