### **SENATE BILL NO. 179** AMENDMENT IN THE NATURE OF A SUBSTITUTE (Proposed by the Senate Committee on the Judiciary on January 15, 2020) (Patron Prior to Substitute—Senator Favola) Senate Amendments in [] - February 7, 2020

A BILL to amend and reenact §§ 8.01-42.1, 8.01-49.1, 18.2-57, 18.2-121, and 52-8.5 of the Code of Virginia, relating to hate crimes; gender, disability, gender identity, or sexual orientation; penalty.

Be it enacted by the General Assembly of Virginia:

1. That §§ 8.01-42.1, 8.01-49.1, 18.2-57, 18.2-121, and 52-8.5 of the Code of Virginia are amended and reenacted as follows:

## § 8.01-42.1. Civil action for racial, religious, or ethnic harassment, violence or vandalism.

14 A. An action for injunctive relief or civil damages, or both, shall lie for any person who is subjected 15 to acts of (i) intimidation or harassment or, (ii) violence directed against his person;, or (iii) vandalism directed against his real or personal property, where such acts are motivated by racial, religious, gender, 16 17 disability, gender identity, sexual orientation, or ethnic animosity.

18 B. Any aggrieved party who initiates and prevails in an action authorized by this section shall be entitled to damages, including punitive damages, and in the discretion of the court to an award of the 19 20 cost of the litigation and reasonable attorneys attorney fees in an amount to be fixed by the court.

21 C. The provisions of this section shall not apply to any actions between an employee and his 22 employer, or between or among employees of the same employer, for damages arising out of incidents 23 occurring in the workplace or arising out of the employee-employer relationship. 24

# D. As used in this section:

25 "Disability" means a physical or mental impairment that substantially limits one or more of a 26 person's major life activities. 27

## § 8.01-49.1. Liability for defamatory material on the Internet.

28 A. No provider or user of an interactive computer service on the Internet shall be treated as the 29 publisher or speaker of any information provided to it by another information content provider. No 30 provider or user of an interactive computer service shall be liable for (i) any action voluntarily taken by 31 it in good faith to restrict access to, or availability of, material that the provider or user considers to be 32 obscene, lewd, lascivious, excessively violent, harassing, or intended to incite hatred on the basis of 33 race, religious conviction, gender, disability, gender identity, sexual orientation, color, or national origin, 34 whether or not such material is constitutionally protected, or (ii) any action taken to enable, or make 35 available to information content providers or others, the technical means to restrict access to information 36 provided by another information content provider. 37

#### B. Definitions. As used in this section:

"Disability" means a physical or mental impairment that substantially limits one or more of a person's major life activities.

40 "Information content provider" means any person or entity that is responsible, in whole or in part, for 41 the creation or development of information provided through the Internet or any other interactive 42 computer service.

"Interactive computer service" means any information service, system, or access software provider 43 44 that provides or enables computer access by multiple users to a computer server, including specifically a service or system that provides access to the Internet and such systems operated or services offered by 45 libraries or educational institutions. 46

"Internet" means the international computer network of interoperable packet-switched data networks.

## § 18.2-57. Assault and battery; penalty.

49 A. Any person who commits a simple assault or assault and battery is guilty of a Class 1 misdemeanor, and if the person intentionally selects the person against whom a simple assault is 50 committed because of his race, religious conviction, gender, disability, gender identity, sexual 51 orientation, color, or national origin, the penalty upon conviction shall include a term of confinement of 52 53 at least six months, 30 days of which shall be a mandatory minimum term of confinement.

54 B. However, if a person intentionally selects the person against whom an assault and battery resulting in bodily injury is committed because of his race, religious conviction, gender, disability, gender 55 identity, sexual orientation, color, or national origin, the person is guilty of a Class 6 felony, and the 56 penalty upon conviction shall include a term of confinement of at least six months, 30 days of which 57 shall be a mandatory minimum term of confinement. 58

59 C. In addition, if any person commits an assault or an assault and battery against another knowing or **SB179ES1**

47 **48**  60 having reason to know that such other person is a judge, a magistrate, a law-enforcement officer as 61 defined in subsection F, a correctional officer as defined in § 53.1-1, a person directly involved in the care, treatment, or supervision of inmates in the custody of the Department of Corrections or an 62 63 employee of a local or regional correctional facility directly involved in the care, treatment, or 64 supervision of inmates in the custody of the facility, a person directly involved in the care, treatment, or 65 supervision of persons in the custody of or under the supervision of the Department of Juvenile Justice, 66 an employee or other individual who provides control, care, or treatment of sexually violent predators committed to the custody of the Department of Behavioral Health and Developmental Services, a 67 firefighter as defined in § 65.2-102, or a volunteer firefighter or any emergency medical services 68 personnel member who is employed by or is a volunteer of an emergency medical services agency or as 69 70 a member of a bona fide volunteer fire department or volunteer emergency medical services agency, regardless of whether a resolution has been adopted by the governing body of a political subdivision 71 72 recognizing such firefighters or emergency medical services personnel as employees, engaged in the performance of his public duties anywhere in the Commonwealth, such person is guilty of a Class 6 73 74 felony, and, upon conviction, the sentence of such person shall include a mandatory minimum term of 75 confinement of six months.

Nothing in this subsection shall be construed to affect the right of any person charged with a 76 77 violation of this section from asserting and presenting evidence in support of any defenses to the charge 78 that may be available under common law.

79 D. In addition, if any person commits a battery against another knowing or having reason to know 80 that such other person is a full-time or part-time employee of any public or private elementary or secondary school and is engaged in the performance of his duties as such, he is guilty of a Class 1 81 82 misdemeanor and the sentence of such person upon conviction shall include a sentence of 15 days in 83 jail, two days of which shall be a mandatory minimum term of confinement. However, if the offense is 84 committed by use of a firearm or other weapon prohibited on school property pursuant to § 18.2-308.1, the person shall serve a mandatory minimum sentence of confinement of six months. 85

86 E. In addition, any person who commits a battery against another knowing or having reason to know 87 that such individual is a health care provider as defined in § 8.01-581.1 who is engaged in the 88 performance of his duties in a hospital or in an emergency room on the premises of any clinic or other 89 facility rendering emergency medical care is guilty of a Class 1 misdemeanor. The sentence of such 90 person, upon conviction, shall include a term of confinement of 15 days in jail, two days of which shall 91 be a mandatory minimum term of confinement.

F. As used in this section:

93 "Disability" means a physical or mental impairment that substantially limits one or more of a 94 person's major life activities.

95 "Hospital" means a public or private institution licensed pursuant to Chapter 5 (§ 32.1-123 et seq.) of 96 Title 32.1 or Article 2 (§ 37.2-403 et seq.) of Chapter 4 of Title 37.2.

97 "Judge" means any justice or judge of a court of record of the Commonwealth including a judge 98 designated under § 17.1-105, a judge under temporary recall under § 17.1-106, or a judge pro tempore 99 under § 17.1-109, any member of the State Corporation Commission, or of the Virginia Workers' 100 Compensation Commission, and any judge of a district court of the Commonwealth or any substitute 101 judge of such district court.

102 "Law-enforcement officer" means any full-time or part-time employee of a police department or 103 sheriff's office that is part of or administered by the Commonwealth or any political subdivision thereof 104 who is responsible for the prevention or detection of crime and the enforcement of the penal, traffic or 105 highway laws of the Commonwealth, any conservation officer of the Department of Conservation and Recreation commissioned pursuant to § 10.1-115, any special agent of the Virginia Alcoholic Beverage 106 Control Authority, conservation police officers appointed pursuant to § 29.1-200, full-time sworn 107 108 members of the enforcement division of the Department of Motor Vehicles appointed pursuant to 109 § 46.2-217, and any employee with internal investigations authority designated by the Department of 110 Corrections pursuant to subdivision 11 of § 53.1-10, and such officer also includes jail officers in local 111 and regional correctional facilities, all deputy sheriffs, whether assigned to law-enforcement duties, court 112 services or local jail responsibilities, auxiliary police officers appointed or provided for pursuant to §§ 15.2-1731 and 15.2-1733, auxiliary deputy sheriffs appointed pursuant to § 15.2-1603, police officers 113 114 of the Metropolitan Washington Airports Authority pursuant to § 5.1-158, and fire marshals appointed pursuant to § 27-30 when such fire marshals have police powers as set out in §§ 27-34.2 and 27-34.2:1. 115 116

"School security officer" means the same as that term is defined in § 9.1-101.

G. "Simple assault" or "assault and battery" shall not be construed to include the use of, by any school security officer or full-time or part-time employee of any public or private elementary or 117 118 secondary school while acting in the course and scope of his official capacity, any of the following: (i) 119 120 incidental, minor or reasonable physical contact or other actions designed to maintain order and control; (ii) reasonable and necessary force to quell a disturbance or remove a student from the scene of a 121

disturbance that threatens physical injury to persons or damage to property; (iii) reasonable and 122 123 necessary force to prevent a student from inflicting physical harm on himself; (iv) reasonable and 124 necessary force for self-defense or the defense of others; or (v) reasonable and necessary force to obtain 125 possession of weapons or other dangerous objects or controlled substances or associated paraphernalia 126 that are upon the person of the student or within his control.

127 In determining whether a person was acting within the exceptions provided in this subsection, due 128 deference shall be given to reasonable judgments that were made by a school security officer or 129 full-time or part-time employee of any public or private elementary or secondary school at the time of 130 the event.

## § 18.2-121. Entering property of another for purpose of damaging it, etc.

132 A. As used in this section, "disability" means a physical or mental impairment that substantially 133 limits one or more of a person's major life activities.

134 B. It shall be is unlawful for any person to enter the land, dwelling, outhouse, or any other building 135 of another for the purpose of damaging such property or any of the contents thereof or in any manner to 136 interfere with the rights of the owner, user, or the occupant thereof to use such property free from 137 interference.

138 Any person violating the provisions of this section shall be is guilty of a Class 1 misdemeanor. 139 However, if a person intentionally selects the property entered because of the race, religious conviction, 140 color, gender, disability, gender identity, sexual orientation, or national origin of the owner, user, or 141 occupant of the property, the person shall be is guilty of a Class 6 felony, and the penalty upon 142 conviction shall include a term of confinement of at least six months, 30 days of which shall be a 143 mandatory minimum term of confinement. 144

#### § 52-8.5. Reporting hate crimes.

131

145 A. The Superintendent shall establish and maintain within the Department of State Police a central 146 repository for the collection and analysis of information regarding hate crimes and groups and 147 individuals carrying out such acts.

B. State, county, and municipal law-enforcement agencies shall report to the Department all hate 148 149 crimes occurring in their jurisdictions in a form, time, and manner prescribed by the Superintendent. 150 Such reports shall not be open to public inspection except insofar as the Superintendent shall permit. 151

C. For purposes of this section, "hate crime" As used in this section:

152 "Disability" means a physical or mental impairment that substantially limits one or more of a 153 person's major life activities.

154 "Hate crime" means (i) a criminal act committed against a person or his property with the specific 155 intent of instilling fear or intimidation in the individual against whom the act is perpetrated because of 156 race, religion, gender, disability, gender identity, sexual orientation, or ethnic or national origin or that 157 is committed for the purpose of restraining that person from exercising his rights under the Constitution or laws of this the Commonwealth or of the United States,; (ii) any illegal act directed against any 158 159 persons or their property because of those persons' race, religion, gender, disability, gender identity, 160 sexual orientation, or ethnic or national origin; and (iii) all other incidents, as determined by law-enforcement authorities, intended to intimidate or harass any individual or group because of race, 161 162 religion, gender, disability, gender identity, sexual orientation, or ethnic or national origin.

2. That the provisions of this act may result in a net increase in periods of imprisonment or 163 commitment. Pursuant to § 30-19.1:4 of the Code of Virginia, the estimated amount of the 164 necessary appropriation cannot be determined for periods of imprisonment in state adult 165 166 correctional facilities; therefore, Chapter 854 of the Acts of Assembly of 2019 requires the Virginia Criminal Sentencing Commission to assign a minimum fiscal impact of \$50,000. Pursuant to 167 168 § 30-19.1:4 of the Code of Virginia, the estimated amount of the necessary appropriation cannot be 169 determined for periods of commitment to the custody of the Department of Juvenile Justice.

170 [ 3. That the provisions of this act shall not become effective unless an appropriation effectuating 171 the purposes of this act is included in a general appropriation act passed in 2020 by the General

172 Assembly that becomes law. ]
