Submit an annual report to the Governor and the General Assembly for publication as a report 66 document as provided in the procedures of the Division of Legislative Automated Systems for the 67 processing of legislative documents and reports. The chairman of the Board shall submit to the Governor and the General Assembly an annual executive summary of the interim activity, findings, and **68** 69 recommendations of the Board no later than the first day of each regular session of the General 70 Assembly. The executive summary shall be submitted for publication as a report document as provided 71 in the procedures of the Division of Legislative Automated Systems for the processing of legislative 72 documents and reports and shall be posted on the General Assembly's website.
