## VIRGINIA ACTS OF ASSEMBLY - CHAPTER

An Act to amend and reenact §§ 3.1, 3.4, 3.5, 3.9, 5.1, 5.4, 5.6, 5.8, 5.9, 5.10, and 5.11 of Chapter 243 2 3 of the Acts of Assembly of 1998, which provided a charter for the Town of Scottsville in the County 4 of Albemarle, and to amend Chapter 243 of the Acts of Assembly of 1998 by adding sections 5 numbered 5.12 and 5.13, relating to town council and other town officers.

### Be it enacted by the General Assembly of Virginia: 8

9 1. That §§ 3.1, 3.4, 3.5, 3.9, 5.1, 5.4, 5.6, 5.8, 5.9, 5.10, and 5.11 of Chapter 243 of the Acts of 10 Assembly of 1998 are amended and reenacted and that Chapter 243 of the Acts of Assembly of 1998 is amended by adding sections numbered 5.12 and 5.13 as follows: 11

#### 12 § 3.1. Governing body.

13 There shall be a mayor who shall be an elector of said town, and who, together with the six 14 members of the council, shall constitute the governing body of the town. He or she shall be elected by 15 the qualified electors of said town at the general election to be held on the first Tuesday in May 1998, and every two four years thereafter, and shall enter upon the duties of his or her office on the first day 16 17 of July next succeeding his or her election, and shall continue in office until his or her successor is 18 elected and qualified.

19 There shall be six members of the council, all of whom shall be electors of said town, who, together 20 with the mayor, shall constitute the governing body of said town, and they shall be elected to serve 21 staggered four-year terms by the qualified electors of said town at the general election to be held on the first Tuesday in May 1998, and every two years thereafter. All members of the council shall enter upon 22 23 the duties of that office on the first day of July next succeeding their election, and shall continue in 24 office until their successors are elected and qualified.

25 However, in 2020, the mayor and the three town council candidates receiving the greatest number of 26 votes shall be elected for terms of four years, and the three town council candidates receiving the next 27 greatest number of votes shall be elected for terms of two years. Beginning in 2020 and every four 28 years thereafter, three council members shall be elected at the time of the May general election, with 29 terms to commence on July 1 following the election. Beginning in 2022 and every four years thereafter, 30 the mayor and three council members shall be elected at the time of the May election, with terms to 31 commence on July 1 following the election. 32

§ 3.4. Mayor chief executive.

33 The mayor shall be the chief executive officer of the town, and may receive a salary to be fixed by 34 the council. He or she shall see that the ordinances and bylaws of the town are fully executed and 35 enforced.

§ 3.5. Powers of mayor.

37 The mayor shall preside over the deliberations of the council, but shall have no vote except in case 38 of a tie. The mayor shall have the power to appoint and swear in special policemen for any occasion 39 when in his or her judgment it is expedient for the peace and good government of the territory under 40 the criminal jurisdiction of said town, and at such compensation as may be fixed by the council. In case 41 of a vacancy in the office of town sergeant, the mayor shall have power and authority to fill same by 42 temporary appointment until the council shall meet and appoint a town sergeant, such temporary 43 appointment by the mayor to be at such compensation as may be fixed by the council. 44

§ 3.9. Appointment of council president vice-mayor.

45 The council shall appoint one of its members president vice-mayor who shall, in the absence or inability of the mayor, preside over the meetings of the council. In the absence or the inability of the **46** mayor, the president of the council vice-mayor shall have the powers of, and perform the duties of the 47 48 mayor. 49

§ 5.1. Town sergeant; police officers.

50 The council shall appoint a town sergeant who shall be the chief police officer of the town, and who shall hold office at the pleasure of the council- His with such salary as shall be fixed by the council. 51 The council may appoint an additional police officer, or officers, for the town whenever deemed 52 53 necessary or expedient who shall hold office at the pleasure of the council, and receive such 54 compensation as the council shall fix. Any The town sergeant, or other police officer, may at any time 55 be removed from office by a majority of votes of the council.

56 The town sergeant shall perform such other duties as the council may direct. He or she shall be

vested with all the powers which that the general laws of the Commonwealth confer upon constables 57 58 and police officers.

59 The council may require the town sergeant to execute before the mayor bond, with surety to be 60 approved by him or her in the amount to be approved by the council, conditioned for the faithful 61 performance of his the duties as of town sergeant. 62

§ 5.4. Duties of treasurer.

The treasurer shall receive all money belonging to the town, and shall perform such other duties as 63 64 are, or may be, prescribed by the council. He or she shall keep his or her books and accounts in such manner as the council may prescribe, and such books and accounts shall always be subject to the 65 66 inspection of the mayor and council. 67

§ 5.6. Deposit of town moneys.

68 The treasurer shall be required to keep all moneys in his or her hands belonging to the town in such 69 place, or places, of deposit as the town council by ordinance may provide or direct. 70

§ 5.8. Report of treasurer.

71 The treasurer shall report to the town council, or a committee thereof, as often as required a full and 72 detailed account of all receipts and expenditures during the month, and the state of the treasury. He or 73 she shall also keep a record of all warrants, or orders, their dates, amount, number and the person to 74 whom paid, specifying also the time of payment; and such warrants, or orders, shall be examined at the 75 time of making such report to the council by the auditing committee thereof who shall examine and 76 compare the same with the books of the treasurer and report discrepancies, if any, to the council. 77

§ 5.9. Town clerk.

78 The council shall appoint a town clerk, who shall hold office at the pleasure of the council, and who 79 shall receive such compensation as may be fixed by the council and may hold other appointive office or 80 not.

81 The town clerk shall have the custody of the corporate seal, and he or she shall keep all the papers that by the provisions, or the direction of the council, are required to be filed with, or kept by him or 82 83 her; and he or she shall perform such other acts and duties as the council may require. He or she shall receive such compensation as may be allowed by the council. 84 85

§ 5.10. Appointment; duties of clerk of the council.

86 The council shall appoint a clerk, to be known as the clerk of the council, who may *either* be either 87 a member of the council or hold other appointive office or not.

88 The clerk of the council shall attend the meetings of the council and keep the record of its 89 proceedings and he or she shall perform such other acts and duties as the council may require. He or 90 *she* shall receive such compensation as may be allowed by the council. 91

§ 5.11. Appointment of town attorney.

92 The council shall designate from time to time or annually in its discretion, a discrete and competent 93 attorney at law, licensed to practice his or her profession in all the courts of the Commonwealth, and 94 shall fix his or her compensation.

95 The town attorney shall advise the mayor and council and the town officers on any official matter 96 presented to him or her, and shall prosecute the violation of all town ordinances, upon authorization 97 from the council. 98

§ 5.12. Town administrator.

99 The council shall appoint a town administrator, who shall be the executive officer of the town and shall be responsible to the town council and mayor for the proper administration of the town 100 government. It shall be the duties of the town administrator to: 101 102

(a) Attend all meetings of the town council, with the right to speak when recognized but not to vote;

103 (b) Keep the mayor and town council advised of the financial condition, with advice from the town 104 treasurer, and the future needs of the town and all matters pertaining to its proper administration, and 105 make such recommendations as may seem desirable with the assistance of other Charter officers to the 106 mayor and town council;

107 (c) With the mayor, prepare and submit, with the assistance of the town treasurer and other town 108 officers, the annual budget of the town and be responsible for its administration after its adoption; 109

(d) Submit adequate reports as required by the town council and mayor; and

110 (e) Perform such other duties as may be prescribed by this Charter, or required in accordance therewith by the mayor and town council, or which may be required by the chief executive officer of a 111 112 town by the general laws of the Commonwealth.

All employees of the town, except those appointed by the town council pursuant to this Charter or 113 114 the general laws of the Commonwealth, shall be appointed and may be removed by the town 115 administrator, who shall report each appointment or removal to the mayor and town council immediately. The town council shall designate a person to act as town administrator in case of the 116 absence, incapacity, death, or resignation of the town administrator, until his or her return to duty or 117

- 118 appointment of a successor. Until such time as the town council appoints any such town administrator,
- 119 the duties and powers outlined herein shall be given to the mayor or such other person as may be
- **120** designated by the town council. The removal of such town administrator shall be by majority vote of the 121 town council.
- 122 § 5.13. Appointment of one person to more than one office.
- 123 The town council may appoint the same person to more than one appointive office, at the discretion
- 124 of the town council, subject to limitations set forth in the Constitution of Virginia and Title 15.2
- 125 (§ 15.2-100 et seq.) of the Code of Virginia, as amended from time to time.
  126 2. That an emergency exists and this act is in force from its passage.
