## VIRGINIA ACTS OF ASSEMBLY - CHAPTER

An Act to amend and reenact §§ 3.4, 3.7, 4.1, as amended, and 4.2 of Chapter 423 of the Acts of 2 3 Assembly of 1983 and to amend Chapter 423 of the Acts of Assembly of 1983 by adding sections numbered 3.3:1, 4.1:1, 4.1:2, and 4.1:3, which provided a charter for the Town of Middleburg in 4 5 Loudoun County, relating to powers of council and mayor, salaries, and appointed officers.

### Approved

#### 8 Be it enacted by the General Assembly of Virginia:

9 1. That §§ 3.4, 3.7, 4.1, as amended, and 4.2 of Chapter 423 of the Acts of Assembly of 1983 are 10 amended and reenacted and that Chapter 423 of the Acts of Assembly of 1983 is amended by adding sections numbered 3.3:1, 4.1:1, 4.1:2, and 4.1:3 as follows: 11

#### § 3.3:1. Powers and duties of the council. 12

13 The government of the Town of Middleburg shall be vested in the council, which shall have the 14 power to enact and enforce ordinances to carry into effect all powers granted by this charter and by law. The council shall be responsible for the determination of all matters of policy for the Town of 15 16 Middleburg and for ensuring the implementation thereof by the town administration.

17 § 3.4. Mayor.

18 The mayor shall be the chief executive officer of the town. He shall have and exercise all the 19 privileges and authority conferred by general law not inconsistent with this charter. He shall preside over the meetings of the town council and shall have the right to speak therein as a member of the council 20 21 but shall not vote except in the case of a tie vote. He see that the duties of the various appointed 22 officers are faithfully performed and shall execute such documents or instruments as the council, this 23 charter, or the laws of the Commonwealth shall require. The mayor shall be the head of the town 24 government for all ceremonial purposes and shall perform such other duties consistent with his the office 25 as may be imposed by the town council. He The mayor shall see that preside over the duties meetings 26 of the various town officers are faithfully performed and council but shall authenticate his signature on 27 such documents or instruments as the council, this charter or the laws of the Commonwealth shall 28 require not vote except in the case of a tie vote. 29

§ 3.7. Salaries.

30 The salaries of the mayor, councilmen, members of boards and commissions, and all appointed 31 officers and employees of the town shall be authorized and fixed by the council at a sum not to exceed 32 any limitations placed thereon by the laws of the Commonwealth of Virginia. Increases in the salaries of the mayor and members of the council shall not be effective until the first day of July following the 33 34 next local election after the council approves such increase. 35

#### Chapter 4. Appointive Appointed Officers.

§ 4.1. Appointments Town manager.

37 The council may shall appoint: a town administrator, who a town manager, who shall be the chief 38 administrative officer of the town and have the powers and perform the duties set forth in this charter, 39 general law, and town ordinances, and shall be responsible to the council for the proper administration 40 of all affairs of the town, for the control and supervision of all town departments, employees, and 41 property, for the preparation and implementation of an annual budget, and for any other duties as 42 prescribed by the council; a town attorney, who shall be an attorney-at-law licensed to practice in the 43 Commonwealth of Virginia; a chief of police; a town clerk; a town treasurer, who may also be the town 44 clerk; and any other officers that shall be deemed necessary and proper.

45 The town manager shall be chosen by the council solely on the basis of executive and administrative qualifications in the profession of public management. The town manager need not be a resident of the 46 47 town or Commonwealth.

The town manager shall appoint and when necessary suspend, demote, and remove any of the **48** 49 officers and employees of the town except as otherwise provided in this charter or town ordinances. The 50 town manager may authorize the head of a town office, department, or board to appoint subordinates in such office, department, or board. With regard to any of the officers subject to the town manager's 51 appointment power, the town manager may appoint an acting officer in the case of the absence, 52 53 incapacity, death, or resignation of the permanent officer.

54 The action of the council in suspending or removing the town manager shall be final, it being the 55 intention of this charter to vest all authority and fix all responsibility for any such suspension or removal in the council. 56

57 § 4.1:1. Acting town manager.

58 The town manager may designate an individual who shall serve as the acting town manager in the 59 event of the absence, incapacity, death, or resignation of the town manager, until the town manager's 60 return to duty or the appointment by the council of a successor.

61 § 4.1:2. Town clerk.

62 Unless otherwise provided by town ordinance, the town manager shall appoint a town clerk who shall be clerk of the council and who shall serve at and during the pleasure of the town manager. The 63 clerk of the council shall attend all meetings of the council and shall keep the journal of its proceedings 64 and shall record all ordinances and resolutions in a book or books kept for that purpose. The clerk 65 shall be custodian of the corporate seal of the town and shall be the officer authorized to use and 66 67 authenticate it. The clerk shall perform such other duties and keep such other records as the town manager or the general laws of the Commonwealth require of town clerks. 68

§ 4.1:3. Town attorney. The council shall appoint a town attorney, who shall be an attorney-at-law licensed to practice in 70 71 the Commonwealth of Virginia. The town attorney may designate an individual who shall serve as the 72 acting town attorney in the event of the absence, incapacity, death, or resignation of the town attorney, 73 until the town attorney's return to duty or the appointment by the council of a successor.

74 § 4.2. Term of office.

75 Appointees under this chapter The council's appointed officers shall serve for an indefinite term at 76 the pleasure of the council.
