6	A BILL to amend and reenact §§ 40.1-28.9 and 40.1-28.10 of the Code of Virginia, relating to the
7	minimum wage.
8	Be it enacted by the General Assembly of Virginia:
9	1. That §§ 40.1-28.9 and 40.1-28.10 of the Code of Virginia are amended and reenacted as follows:
10	§ 40.1-28.9. Definitions.
11	A. As used in this article:
12 13	"Adjusted state hourly minimum wage" means the amount established by the Commissioner pursuant to subsection H of § 40.1-28.10.
13	"Employee" includes any individual employed by an employer, except the following. "Employee"
15	includes a home care provider. "Employee" does not include the following:
16	1. Any person employed as a farm laborer or farm employee;
17	2. Any person employed in domestic service or in or about a private home or in an eleemosynary
18	institution primarily supported by public funds;
19 20	3. 2. Any person engaged in the activities of an educational, charitable, religious, or nonprofit organization where the relationship of employer-employee does not, in fact, exist, or where the services
20 21	rendered to such organizations organization are on a voluntary basis;

23	5. 4. Traveling salesmen or outside salesmen working on a commission basis; taxicab drivers and
24	operators;
25	6. 5. Any person under the age of 18 in the employ of his father, mother parent or legal guardian;
26 27	7. 6. Any person confined in any penal or corrective institution of the State Commonwealth or any of its political subdivisions or admitted to a state hospital or training center operated by the Department of

57	"Federal minimum wage" means the minimum wage or, if applicable, the federal training wage
58 50	prescribed by the U.S. Fair Labor Standards Act, 29 U.S.C. § 201 et seq.
59	"Home care provider" means an individual who provides (i) home health services, including services

provided by or under the direct supervision of any health care professional under a medical plan of 60 care in a patient's residence on a visit or hourly basis to patients who have or are at risk of injury, 61 62 illness, or a disabling condition and require short-term or long-term interventions, or (ii) personal care 63 services, including assistance in personal care to include activities of a daily living provided in an 64 individual's residence on a visit or hourly basis to individuals who have or are at risk of an illness,

65 injury, or disabling condition.

66 "Tipped employee" means an employee engaged in an occupation in which he customarily and 67 regularly receives more than \$30 per month in tips.

68 Wages" means legal tender of the United States or checks or drafts on banks negotiable into cash on 69 demand or upon acceptance at full value; provided, wages may include. "Wages" includes the reasonable cost to the employer of furnishing meals and for lodging to an employee, if such board or lodging is 70 71 customarily furnished by the employer, and used by the employee.

72 B. In determining the wage of a tipped employee, the amount paid such employee by his employer shall be deemed to be increased on account of tips by an amount determined by the employer, except in 73 74 the case of an employee who establishes by clear and convincing evidence that the actual amount of tips 75 received by him was less than the amount determined by the employer. In such case, the amount paid 76 such employee by his employer shall be deemed to have been increased by such lesser amount. An 77 employer shall not classify an individual as a tipped employee if the individual is prohibited by 78 applicable federal or state law or regulation from soliciting tips. 79

§ 40.1-28.10. Minimum wages.

80 Every A. 1. Prior to January 1, 2021, every employer shall pay to each of his its employees wages at a rate not less than the federal minimum wage and a training wage as prescribed by the U.S. Fair 81 82 Labor Standards Act (29 U.S.C. § 201 et seq.).

2. Beginning January 1, 2021, every employer shall pay to each of his employees at a rate not less than the federal minimum wage or 75 percent of the Virginia minimum wage provided for in this 83 84 85 section, whichever is greater. For the purposes of this subdivision "employee" means any person an individual who is enrolled in an established employer on-the-job or other training program for a period 86 not to exceed 90 days which meets standards set by regulations adopted by the Commissioner. 87

B. From January 1, 2021, until January 1, 2022, every employer shall pay to each of its employees 88 89 wages at a rate not less than the greater of (i) \$9.50 per hour or (ii) the federal minimum wage.

90 C. From January 1, 2022, until January 1, 2023, every employer shall pay to each of its employees 91 wages at a rate not less than the greater of (i) \$11.00 per hour or (ii) the federal minimum wage.

D. From January 1, 2023, until January 1, 2025, every employer shall pay to each of its employees 92 wages at a rate not less than the greater of (i) \$12.00 per hour or (ii) the federal minimum wage. 93

E. From January 1, 2025, until January 1, 2026, every employer shall pay to each of its employees wages at a rate not less than the greater of (i) \$13.50 per hour or (ii) the federal minimum wage. F. From January 1, 2026, until January 1, 2027, every employer shall pay to each of its employees 94 95

96 97 wages at a rate not less than the greater of (i) \$15.00 per hour or (ii) the federal minimum wage.

98 G. From and after January 1, 2027, every employer shall pay to each of his employees wages at a 99 rate not less than the greater of (i) the adjusted state hourly minimum wage or (ii) the federal minimum 100 wage.

101 H. By October 1, 2026, and annually thereafter, the Commissioner shall establish the adjusted state 102 hourly minimum wage that shall be in effect during the 12-month period commencing on the following January 1. The Commissioner shall set the adjusted state hourly minimum wage at the sum of (i) the 103 104 amount of the state hourly minimum wage rate that is in effect on the date such adjustment is made and (ii) a percentage of the amount described in clause (i) that is equal to the percentage by which the 105 United States Average Consumer Price Index for all items, all urban consumers (CPI-U), as published by the Bureau of Labor Statistics of the U.S. Department of Labor, or a successor index as calculated 106 107 108 by the U.S. Department of Labor, has increased during the most recent calendar year for which such 109 information is available. The amount of each annual adjustment shall not be less than zero.

2. Beginning January 1, 2022, the Virginia Department of Housing and Community Development, 110 the Virginia Economic Development Partnership Authority, and the Virginia Employment 111 Commission (the agencies) shall conduct a joint review of the feasibility and potential impact of 112 instituting a regional minimum wage in the Commonwealth. In evaluating a regional minimum 113 wage, the agencies shall form a work group to assess various factors, including, but not limited to, 114 the cost of living in the Commonwealth; the potential impact on employers and any fringe benefits 115 offered to employees such as employer-sponsored health insurance; the potential impact on 116 workers, with a focus on income inequality; the potential impact on agricultural workers; the 117 experience of other states with a regional wage; and the equity and fairness of the exemption from 118 the minimum wage for any person employed as a farm laborer or farm employee provided by § 40.1-28.10 of the Code of Virginia. The agencies also shall provide an assessment of options for 119 120 utilizing a minimum wage in the Commonwealth, the feasibility of a regional minimum wage, and 121

the economic benefits or impacts of utilizing a minimum wage. The agencies shall also assess the effects of the minimum wage increases scheduled in § 40.1-28.10 of the Code of Virginia, as amended by this act. The agencies shall submit to the General Assembly and the Governor an executive summary and a report of their findings and recommendations. The executive summary and report shall be submitted as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents no later than December 1, 2023, and shall be posted on the General Assembly's website.

- 129 3. That the provisions of subsections E and F of § 40.1-28.10 of the Code of Virginia, as amended
- 130 by this act, shall not become effective unless reenacted by a regular or special session of the
- 131 General Assembly prior to July 1, 2024. If the General Assembly does not reenact subsections E
- 132 and F by July 1, 2024, then (i) the Commissioner of Labor and Industry shall establish the 133 adjusted state hourly minimum wage as provided in subsection H by October 1, 2024, and
- 133 aujusted state nourry minimum wage as provided in subsection H by October 1, 2024, and 134 annually thereafter; and (ii) from and after January 1, 2025, every employer shall pay to each of
- 135 his employees wages as specified in subsections G.
