- **5. Summary:** The bill establishes the Virginia Revolutionary 250 Commission to plan, develop, and perform programs and activities to commemorate the 250th anniversary of the American Revolution, the Revolutionary War, and the independence of the United States. The bill has an expiration date of July 1, 2027.
- 6. Budget Amendment Necessary: See item 8.
- 7. Fiscal Impact Estimates: Preliminary.
- **8. Fiscal Implications:** The Senate of Virginia estimates an annual impact of \$2,400 to pay the interim meeting compensation for the two Senate members of the Commission. The House of Delegates estimates an annual impact of \$2,400 to pay the interim meeting compensation for the two House members. The Secretary of Education estimates the agency would incur an annual cost of \$10,295 to cover the travel costs and per diems of the 17 nonlegislative citizen members. Gunston Hall indicates that it can absorb within its existing budget for any costs associated with the creation and leading of an advisory council. As detailed in the table below, the Jamestown-Yorktown Foundation estimates staffing and operating expenses for the Commission to be \$447,536 the first year, and \$4,309,228 the second year to staff and support the duties of the Commission.
