HOUSE BILL NO. 5108

AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the House Committee on Public Safety

on August 25, 2020)

(Patron Prior to Substitute—Delegate Guzman)

A BILL to amend and reenact §§ 9.1-108 and 9.1-112 of the Code of Virginia, relating to the Criminal Justice Services Board; Committee on Training; membership and responsibilities. Be it enacted by the General Assembly of Virginia:

1. That §§ 9.1-108 and 9.1-112 of the Code of Virginia are amended and reenacted as follows:

10 § 9.1-108. Criminal Justice Services Board membership; terms; vacancies; members not 11 disqualified from holding other offices; designation of chairmen; meetings; compensation.

A. The Criminal Justice Services Board is established as a policy board within the meaning of 12 § 2.2-2100, in the executive branch of state government. The Board shall consist of 29 30 members as 13 follows: the Chief Justice of the Supreme Court of Virginia, or his designee; the Attorney General or his 14 15 designee; the Superintendent of the Department of State Police; the Director of the Department of Corrections; the Director of the Department of Juvenile Justice; the Chairman of the Parole Board; the 16 17 Executive Director of the Virginia Indigent Defense Commission or his designee; and the Executive Secretary of the Supreme Court of Virginia. In those instances in which the Executive Secretary of the 18 Supreme Court of Virginia, the Superintendent of the Department of State Police, the Director of the 19 20 Department of Corrections, the Director of the Department of Juvenile Justice, or the Chairman of the 21 Parole Board will be absent from a Board meeting, he may appoint a member of his staff to represent 22 him at the meeting.

23 Seventeen Eighteen members shall be appointed by the Governor from among citizens of the 24 Commonwealth. At least one shall be a representative of a crime victims' organization or a victim of 25 crime as defined in subsection B of § 19.2-11.01, and one two shall represent community interests be 26 representatives of a civil rights organization, two shall be representatives of community interests of 27 minorities from one of the four groups of minority individuals defined in subsection F of § 2.2-4310, and 28 one shall be a representative from a mental health service provider as defined in § 54.1-2400.1.

29 The remainder shall be representative of the broad categories of state and local governments, criminal 30 justice systems, and law-enforcement agencies, including but not limited to, police officials, sheriffs, 31 attorneys for the Commonwealth, defense counsel, the judiciary, correctional and rehabilitative activities, 32 and other locally elected and appointed administrative and legislative officials. Among these members there shall be two sheriffs one sheriff representing the Virginia Sheriffs' Association selected from 33 34 among names submitted by the Association; one member who is an active duty law-enforcement officer 35 appointed after consideration of the names, if any, submitted by police or fraternal associations that have 36 memberships of at least 1,000; two representatives one representative of the Virginia Association of 37 Chiefs of Police appointed after consideration of the names submitted by the Association, if any; one 38 attorney for the Commonwealth appointed after consideration of the names submitted by the Virginia 39 Association of Commonwealth's Attorneys, if any; one person who is a mayor, city or town manager, or 40 member of a city or town council representing the Virginia Municipal League appointed after consideration of the names submitted by the League, if any; one person who is a county executive, 41 42 manager, or member of a county board of supervisors representing the Virginia Association of Counties appointed after consideration of the names submitted by the Association, if any; one member 43 representing the Virginia Association of Campus Law Enforcement Administrators appointed after 44 consideration of the names submitted by the Association, if any; one member of the Private Security 45 Services Advisory Board; and one representative of the Virginia Association of Regional Jails appointed 46 47 after consideration of the names submitted by the Association, if any.

Four members of the Board shall be members of the General Assembly appointed as follows: one **48** member of the House Committee on Appropriations appointed by the Speaker of the House of Delegates 49 after consideration of the recommendation by the committee's chairman; one member of the House 50 51 Committee for Courts of Justice appointed by the Speaker of the House of Delegates after consideration of the recommendation by the committee's chairman; one member of the Senate Committee on Finance 52 53 and Appropriations appointed by the Senate Committee on Rules after consideration of the recommendation of the chairman of the Senate Committee on Finance and Appropriations; and one 54 member of the Senate Committee for Courts of Justice on the Judiciary appointed by the Senate 55 Committee on Rules after consideration of the recommendation of the chairman of the Senate 56 Committee for Courts of Justice on the Judiciary. The legislative members shall serve for terms 57 coincident with their terms of office and shall serve as ex officio, nonvoting members. Legislative 58 59 members may be reappointed for successive terms.

B. The members of the Board appointed by the Governor shall serve for terms of four years, 60 provided that no member shall serve beyond the time when he holds the office or employment by 61 reason of which he was initially eligible for appointment. Gubernatorial appointed members of the Board 62 63 shall not be eligible to serve for more than two consecutive full terms. Three or more years within a 64 four-year period shall be deemed a full term. Any vacancy on the Board shall be filled in the same 65 manner as the original appointment, but for the unexpired term.

66 C. The Governor shall appoint a chairman of the Board for a two-year term. No member shall be eligible to serve more than two consecutive terms as chairman. The Board shall designate one or more 67 68 vice-chairmen from among its members, who shall serve at the pleasure of the Board.

D. Notwithstanding any provision of any statute, ordinance, local law, or charter provision to the 69 70 contrary, membership on the Board shall not disgualify any member from holding any other public 71 office or employment, or cause the forfeiture thereof.

72 E. The Board shall hold no less than four regular meetings a year. Subject to the requirements of this subsection, the chairman shall fix the times and places of meetings, either on his own motion or upon 73 74 written request of any five members of the Board. 75

F. The Board may adopt bylaws for its operation.

G. Legislative members of the Board shall receive such compensation as provided in § 30-19.12 and 76 77 nonlegislative citizen members shall receive such compensation as provided in § 2.2-2813 for the 78 performance of their duties. All members shall be reimbursed for all reasonable and necessary expenses 79 incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Funding for the 80 costs of compensation and expenses of the members shall be provided by the Department of Criminal 81 Justice Services. 82

§ 9.1-112. Committee on Training; membership.

83 There is created a permanent Committee on Training under the Board that shall be the policy-making 84 body responsible to the Board for effecting the provisions of subdivisions 2 through 17 of § 9.1-102. 85 The Committee on Training shall be composed of 15 members of the Board as follows: the 86 Superintendent of the Department of State Police; the Director of the Department of Corrections; a 87 member of the Private Security Services Advisory Board; the Executive Secretary of the Supreme Court 88 of Virginia; two sheriffs one sheriff representing the Virginia State Sheriffs Sheriffs' Association; two 89 representatives one representative of the Virginia Association of Chiefs of Police Association; the 90 active-duty law-enforcement officer representing police and fraternal associations; the attorney for the 91 Commonwealth representing the Virginia Association of Commonwealth's Attorneys; one representative 92 of the Virginia Indigent Defense Commission; a representative of the Virginia Municipal League; a 93 representative of the Virginia Association of Counties; a representative from a mental health service 94 provider as defined in § 54.1-2400.1; a regional jail superintendent representing the Virginia Association of Regional Jails; one citizen representing a civil rights organization; and one citizen representing 95 96 community interests; and one member designated by the chairman of the Board from among the other 97 appointments made by the Governor of minorities from one of the four groups of minority individuals 98 defined in subsection F of § 2.2-4310. 99

The Committee on Training shall annually elect its chairman from among its members.

100 The Committee on Training may appoint curriculum review committees to assist the Committee on 101 Training in carrying out its duties under this section. Any curriculum review committee shall be 102 composed of nine members appointed by the Committee on Training. At least one member shall be a representative of a regional criminal justice academy, one member shall be a representative of an 103 104 independent criminal justice academy, one member shall be a representative of the Department of State Police Training Academy, and one member shall be a representative of a community-based organization. 105 The remainder shall be selected after consideration of names submitted by the Department of individuals 106 107 with relevant experience.
