6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 53.1-1 of the Code of Virginia is amended and reenacted as follows:**8 **§ 53.1-1. Definitions.**

9 As used in this title, unless the context requires a different meaning:

10 "Board" or "State Board" means the State Board of Local and Regional Jails.

11 "Community correctional facility" means any group home, halfway house or other physically
12 unrestricting facility used for the housing, treatment or care of adult offenders established or operated
13 with funds appropriated to the Department of Corrections from the state treasury and maintained or
14 operated by any political subdivision, combination of political subdivisions or privately operated agency
15 within the Commonwealth.16 "Community supervision" means probation, parole, postrelease supervision, programs authorized
17 under the Comprehensive Community Corrections Act for local responsible offenders, and programs
18 authorized under Article 7 (§ 53.1-128 et seq.) of Chapter 3.19 "Correctional officer" means a duly sworn employee of the Department of Corrections whose normal
20 duties relate to maintaining immediate control, supervision and custody of prisoners confined in any
21 state correctional facility.

22 "Department" means the Department of Corrections.

23 "Deputy sheriff" means a duly sworn officer appointed by a sheriff pursuant to § 15.2-1603 whose
24 normal duties include, but are not limited to, maintaining immediate control, supervision and custody of
25 prisoners confined in any local correctional facility and may include those duties of a jail officer.

26 "Director" means the Director of the Department of Corrections.

27 "Jail officer" means a duly sworn employee of a local correctional facility, except for deputy sheriffs,
28 whose normal duties relate to maintaining immediate control, supervision and custody of prisoners
29 confined in any local correctional facility. This definition in no way limits any authority otherwise
30 granted to a duly sworn deputy sheriff whose duties may include those of a jail officer.31 "Local correctional facility" means any jail, jail farm or other place used for the detention or
32 incarceration of adult offenders, excluding a lock-up, which is owned, maintained, or operated by any
33 political subdivision or combination of political subdivisions of the Commonwealth. *For the purposes of*
34 *subsection B of § 53.1-68 and §§ 53.1-69, 53.1-69.1, and 53.1-127, "local correctional facility" also*
35 *includes any facility owned, maintained, or operated by any political subdivision or combination of*
36 *political subdivisions of the Commonwealth that is used for the detention or incarceration of people*
37 *pursuant to a contract or third-party contract with the federal government or any agency or contractor*
38 *thereof.*39 "Lock-up" means a facility whose primary use is to detain persons for a short period of time as
40 determined by the Board.41 "State correctional facility" means any correctional center or correctional field unit used for the
42 incarceration of adult offenders established and operated by the Department of Corrections, or operated
43 under contract pursuant to § 53.1-262. This term shall include "penitentiary" whenever used in this title
44 or other titles of the Code.
