**4. Title:** Law-enforcement civilian review boards.

- 5. Summary:** The proposed legislation authorizes a locality to establish a law-enforcement civilian oversight body that may: (1) receive, investigate, and issue findings on complaints from civilians regarding conduct of law-enforcement officers and civilian employees of a law-enforcement agency serving under the authority of the locality; (2) investigate and issue findings on incidents, including the use of force by a law-enforcement officer, death or serious injury to any person held in custody, serious abuse of authority or misconduct, allegedly discriminatory stops, and other incidents regarding the conduct of law-enforcement officers or civilian employees of a law-enforcement agency serving under the authority of the locality; (3) to make binding disciplinary determinations, under specified circumstances, in cases that involve serious breaches of departmental and professional standards, as defined by the locality; (4) to investigate policies, practices, and procedures of law-enforcement agencies under the authority of the locality and to make recommendations regarding changes to such policies, practices, and procedures of law-enforcement agencies under the authority of the locality; (5) to review all investigations conducted internally by law-enforcement agencies under the authority of the locality, including internal investigations of civilians employed by such law-enforcement agencies, and to issue findings regarding the accuracy, completeness, and impartiality of such investigations and the sufficiency of any discipline resulting from such investigations; (6) to request reports of the annual expenditures of the law-enforcement agencies under the authority of the locality and to make budgetary recommendations to the local government body concerning future appropriations; (7) to make public reports on the activities of the oversight body, including investigations, hearings, findings, recommendations, determinations, and oversight activities; and (8) to undertake any other duties as reasonably necessary for the oversight body to effectuate its lawful purpose as provided for in the proposed legislation to effectively oversee the law-enforcement agencies as authorized by the locality.

Additionally, the proposed legislation states that a locality shall establish the policies and procedures for the performance of duties by any oversight body. The proposed legislation also permits an oversight body to request a judicial subpoena in order to secure evidence necessary to perform its duties. The proposed legislation also prohibits any person currently employed by a law-enforcement agency is from serving on an oversight body. The proposed legislation also provides that a law-enforcement officer who is subject to a binding disciplinary determination may file a grievance requesting a final hearing pursuant

to the locality's local grievance procedures.

The proposed legislation also establishes that an oversight body may retain legal counsel to represent the oversight body in all cases, hearings, controversies, or matters involving the interests of the oversight body. Such counsel shall be paid from the funds appropriated by the locality.

The proposed legislation exempts any law-enforcement officer or law enforcement agency that serves under the authority of a locality that has established a law-enforcement oversight body, as specified, from the provisions of § 15.2-1507.
