10	Be it enacted by the General Assembly of Virginia:
11	1. That § 15.2-1542 of the Code of Virginia is amended and reenacted as follows:
12	§ 15.2-1542. Creation of office of county, city or town attorney authorized; appointment, salary
13	and duties.
14	A. Every county, city or town, not otherwise authorized to create the office, may create the office of
15	county, city or town attorney. Such attorney shall be appointed by the governing body to serve at the
16	pleasure of the governing body. He shall serve at a salary or at an hourly rate to be fixed by the
17	governing body and shall be allowed to recover his reasonable costs expended. Any such attorney
18	serving at an hourly rate shall provide the locality with an itemized list of fees and expenses. In the
19	event of the appointment of such attorney, the attorney for the Commonwealth for such locality shall be
20	relieved of any duty imposed upon him by law in civil matters of advising the governing body and all
21	boards, departments, agencies, officials and employees of the locality, of drafting or preparing
22	ordinances, of defending or bringing actions in which the local government or any of its boards,
23	departments or agencies, or officials or employees, thereof, shall be a party, and in any other manner
24	advising or representing the local government, its boards, departments, agencies, officials and employees,
25	and all such duties shall be performed by the local government attorney. Nothing herein, however, shall
26	relieve such attorney for the Commonwealth from any of the other duties imposed on him by law
27	including those imposed by § 2.2-3126. In addition to any rule or provision prohibiting the same, any
28	attorney appointed pursuant to this subsection or pursuant to a local charter shall be prohibited from
29	handling any matter related to a will on behalf of such governing body wherein he was privately
30	retained by an individual to prepare or alter such will or otherwise represent such individual with
31	respect to such will.
32 33	B. The county attorney may prosecute violations of the Uniform Statewide Building Code, the
33	Statewide Fire Prevention Code and all other ordinances as may be agreed upon with the attorney for

33 Statewide Fire Prevention Code and all other ordinances as may be agreed upon with the attorney for
 34 the Commonwealth. Such attorney shall be accountable to the governing body in the performance of his
 35 duties.
 36 C. The county attorney of Montgomery, Fairfax or Prince William Counties may prosecute violations

C. The county attorney of Montgomery, Fairfax or Prince William Counties may prosecute violations
of county ordinances, except those ordinances which regulate, in a manner similar to State statute, the
operation of motor vehicles on the highway.

D. City and town attorneys, if so authorized by their local governing bodies, and with the concurrence of the attorney for the Commonwealth for the locality, may prosecute criminal cases charging either the violation of city or town ordinances, or the commission of misdemeanors within the city or town, notwithstanding the provisions of § 15.2-1627.
