6	A BILL to amend and reenact § 59.1-441.2 of the Code of Virginia, relating to legal service plans;
7	seller registration.
8	Be it enacted by the General Assembly of Virginia:
9	1. That § 59.1-441.2 of the Code of Virginia is amended and reenacted as follows:
10	§ 59.1-441.2. Registration; fees.
11 12	A. It shall be is unlawful for any legal services plan seller to offer, advertise, or execute, or cause to
12	be executed by the subscriber, any subscription contract in the Commonwealth unless the legal services plan seller at the time of the offer, advertisement, sale, or execution of a subscription contract has been
13	properly registered with the Commissioner or the legal services plan seller has submitted the
15	registration information and fee required by this section to the legal services organization for which the
16	seller will offer subscription contracts. The registration shall (i) disclose the address, ownership, and
17	affiliation with the legal services organization and such other information as the Commissioner may
18	require consistent with the purposes of this chapter, (ii) be renewed annually on July 1, and (iii) be
19	accompanied by the appropriate registration fee of \$50 per each annual registration. Further, the
20	registration shall be accompanied by a late fee of \$25 if the registration renewal is neither postmarked
21	nor received on or before July 1. A legal services plan seller's initial or renewal registration may be
22 23	accomplished either by the legal services plan seller or on behalf of such seller by the legal services organization for which the seller offers subscription contracts, and the Commissioner shall accept any
23 24	registration information or fee required to be submitted pursuant to this chapter that is submitted to the
25	Commissioner on a monthly basis by the organization on behalf of such a legal services plan seller. A
26	legal services organization shall submit the registration information and fees received pursuant to this
27	section to the Commissioner, in a form and manner prescribed by the Commissioner, no later than 30
28	days after the information and fees are received by the organization.
29	B. Any legal services plan seller or legal services organization that sells a subscription contract prior
30	to registering pursuant to this section violates the provisions of subsection A shall pay a late filing fee of
31	\$100 for each 30-day period the registration is late. This fee shall be in addition to all other penalties
32 33	allowed by law. C. A registration shall be amended within 21 days if there is a change in the information included in
33 34	the registration. If the legal service plan seller has submitted such changes to the legal services
35	organization for which the seller will offer subscription contracts, the legal services organization shall
36	submit the amend registration, in the form and manner prescribed by the Commissioner, no later than
37	30 days after such information is received by the organization.
38	D. Any matter subject to the insurance regulatory authority of the State Corporation Commission
39	pursuant to Title 38.2 shall not be subject to the provisions of this chapter.
40	E. All fees shall be remitted to the State Treasurer and shall be placed to the credit and special fund
41	of the Virginia Department of Agriculture and Consumer Services to be used in the administration of
42 43	this chapter. E All insurance agent licenses issued by the State Corporation Commission including authority to
43 44	F. All insurance agent licenses issued by the State Corporation Commission including authority to sell legal services plan subscription contracts shall continue in effect for a period of 90 days following
45	the effective date of this chapter, during which time those holding such authority from the State
46	Corporation Commission shall apply for registration with the Department. At the end of the 90-day
47	period, no insurance agent license shall include the authority to sell legal services plan subscription
<b>48</b>	contracts.
