15 16	and conditions as may be agreed to by the parties, a parcel of land that is a portion of Tax Map Parcel 211-130-1, containing a building at 281 Bagley Circle known as the Rehabilitation Building, previously
17	used by the Department of Behavioral Health and Developmental Services as the Southwestern Virginia
18	Mental Health Institute. The conveyance shall be made without consideration.
19	§ 2. The conveyance shall be made in a form approved by the Attorney General. The appropriate
20	officials of the Commonwealth are hereby authorized to prepare, execute, and deliver such deed and
21	other documents as may be necessary to accomplish the conveyance.
