3	Recognizing that access to clean, potable, and affordable water is a necessary human right.

8	WHEREAS, water is a public good that is held by the Commonwealth as a public trust, not as a
9 10	commodity, but many Virginians have been and continue to be locked out of equitable water sources
10 11	due to affordability challenges; and WHEREAS, United Nations standards suggest that total expenditures on water and sanitation
12	services, together with any needed alternative source of clean water, should not exceed three to five
13	percent of household income; and
14	WHEREAS, the lack of access to drinking water and water-related illnesses disproportionately impact
15	low-income communities and communities of color, and all efforts must be made to ensure public access
16	to and affordability of water for private use by all residents of the Commonwealth; and
17	WHEREAS, the realities of the COVID-19 pandemic have exacerbated and amplified the critical
18	importance of water as a quality of life issue; in some cases, access to safe water may be the difference
19	between sickness and health or life and death; and
20	WHEREAS, in addition, climate change has resulted in challenges to accessibility and affordability
21	of water, with freshwater and groundwater increasingly threatened by storm surges, sea level rise, and
22 23	drought; and WHEREAS the Commonwealth has a responsibility to promote and protect all human rights, which
23 24	WHEREAS, the Commonwealth has a responsibility to promote and protect all human rights, which are universal, indivisible, interdependent, and interrelated, and must be treated in a fair and equal
25	manner, on the same footing and with the same emphasis; and
26	WHEREAS, equitable access to safe drinking water and sanitation is an integral component of the
27	realization of all human rights; the Commonwealth must protect its water resources and ensure the
28	ability of its residents to access and afford water for growing food, cooking, bathing, and drinking; now,
29	therefore, be it
30	RESOLVED by the House of Delegates, the Senate concurring, That the General Assembly recognize
31	that:
32 33	1. Access to clean, potable water in amounts that will ensure an acceptable standard of living is a
33 34	necessary human right; 2. The use of water for personal and domestic uses, such as drinking, sanitation, and food
35	preparation, should be prioritized over the use of water by commercial or industrial entities;
36	3. Effective strategies should be used by state agencies to limit contamination of water by residents,
37	but most importantly to ensure the reduction of pollution by commercial or industrial entities, and
38	mitigate the impact of climate change on the Commonwealth's freshwater resources;
39	4. Direct or indirect costs to connect, deliver, and provide water should not be a hindrance to the
40	access of water, and the costs of access to water should not compromise the ability to pay for other
41	essential items, such as food, housing, and health care, so that no one is deprived of water because of
42 43	inability to pay;
43 44	5. Access to water for schools currently without adequate safe drinking water should be addressed as a matter of urgency;
45	6. Relevant state agencies shall consider that water is a human right when revising, adopting, or
46	establishing policies and regulations, especially when those policies are pertinent to personal and
47	domestic uses;
48	7. A statewide water affordability program would ensure that every household can afford to pay its
49	water, wastewater, and stormwater bills based on the household's income through percentage of income
50	payment plans with arrears management;
51	8. Water service disconnections for nonpayment are contrary to promoting public welfare and public
52 53	health, and the Commonwealth must protect vulnerable populations, including seniors, youths, and medically compromised individuals, from water service disconnections; and
55 54	9. The act of unauthorized reconnections of water services that were disconnected for an inability to
55	pay should be decriminalized; and, be it
56	RESOLVED FURTHER, That the Clerk of the House of Delegates transmit [a copy copies] of this
57	resolution to Virginia Interfaith Power & Light [and Food & Water Watch], requesting that the [
58	organization organizations] further disseminate copies of this resolution to their respective constituents
