14	1. That §§ 8.01-9, 8.01-407, 16.1-77, 16.1-305, 17.1-213, 19.2-389, as it is currently effective and as
15	it shall become effective, 46.2-301, 46.2-301.1, 46.2-411, and 53.1-21 of the Code of Virginia are
16	amended and reenacted and that the Code of Virginia is amended by adding a section numbered

18 19	§ 8.01-9. Guardian ad litem for persons under disability; when guardian ad litem need not be appointed for person under disability.
20	A. A suit wherein a person under a disability is a party defendant shall not be stayed because of
2 1	such disability, but the court in which the suit is pending, or the clerk thereof, shall appoint a discreet
22	and competent attorney-at-law as guardian ad litem to such defendant, whether the defendant has been
23	served with process or not. If no such attorney is found willing to act, the court shall appoint some
24	other discreet and proper person as guardian ad litem. Any guardian ad litem so appointed shall not be
25	liable for costs. Every guardian ad litem shall faithfully represent the estate or other interest of the
26 27	person under a disability for whom he is appointed, and it shall be the duty of the court to see that the interest of the defendant is so represented and protected. Whenever the court is of the opinion that the
28	interest of the defendant is so requires, it shall remove any guardian ad litem and appoint another in his
2 9	stead. When, in any case, the court is satisfied that the guardian ad litem has rendered substantial
30	service in representing the interest of the person under a disability, it may allow the guardian reasonable
31	compensation therefor, and his actual expenses, if any, to be paid out of the estate of the defendant.
32	However, if the defendant's estate is inadequate for the purpose of paying compensation and expenses,
33 34	all, or any part thereof, may be taxed as costs in the proceeding or, in the case of proceedings to adjudicate a person under a disability as an habitual offender pursuant to former § 46.2-351.2 or former
34 35	<u>§ 46.2-352</u> , shall be paid by the Commonwealth out of the state treasury from the appropriation for
36	criminal charges. In a civil action against an incarcerated felon for damages arising out of a criminal act,
37	the compensation and expenses of the guardian ad litem shall be paid by the Commonwealth out of the
38	state treasury from the appropriation for criminal charges. If judgment is against the incarcerated felon,
39	the amount allowed by the court to the guardian ad litem shall be taxed against the incarcerated felon as
40 41	part of the costs of the proceeding, and if collected, the same shall be paid to the Commonwealth. By
41	order of the court, in a civil action for divorce from an incarcerated felon, the compensation and expenses of the guardian ad litem shall be paid by the Commonwealth out of the state treasury from the
43	appropriation for criminal charges if the crime (i) for which the felon is incarcerated occurred after the
44	date of the marriage for which the divorce is sought, (ii) for which the felon is incarcerated was
45	committed against the felon's spouse, child, or stepchild and involved physical injury, sexual assault, or
46	sexual abuse, and (iii) resulted in incarceration subsequent to conviction and the felon was sentenced to
47 19	confinement for more than one year. The amount allowed by the court to the guardian ad litem shall be
48 49	taxed against the incarcerated felon as part of the costs of the proceeding, and if collected, the same shall be paid to the Commonwealth.
49 50	B. Notwithstanding the provisions of subsection A or the provisions of any other law to the contrary,
51	in any suit wherein a person under a disability is a party and is represented by an attorney-at-law duly

61 § 8.01-407. How summons for witness issued, and to whom directed; prior permission of court 62 to summon certain officials and judges.

A. A summons may be issued, directed as prescribed in § 8.01-292, commanding the officer to summon any person to attend on the day and at the place that such attendance is desired, to give evidence before a court, grand jury, arbitrators, magistrate, notary, or any commissioner or other person appointed by a court or acting under its process or authority in a judicial or quasi-judicial capacity. The summons may be issued by the clerk of the court if the attendance is desired at a court or in a proceeding pending in a court. The clerk shall not impose any time restrictions limiting the right to properly request a summons up to and including the date of the proceeding:

70 If attendance is desired before a commissioner in chancery or other commissioner of a court, the summons may be issued by the clerk of the court in which the matter is pending, or by such commissioner in chancery or other commissioner;

If attendance is desired before a notary or other officer taking a deposition, the summons may be
 issued by such notary or other officer at the instance of the attendance of the
 person sought;

76 If attendance is sought before a grand jury, the summons may be issued by the attorney for the77 Commonwealth, or the clerk of the court, at the instance of the attorney for the Commonwealth.

78 Except as otherwise provided in this subsection, if attendance is desired in a civil proceeding pending 79 in a court or at a deposition in connection with such proceeding, including medical malpractice review 80 panels, and a claim before the Workers' Compensation Commission, a summons may be issued by an attorney-at-law who is an active member of the Virginia State Bar at the time of issuance, as an officer 81 of the court. An attorney-issued summons shall be on a form approved by the Supreme Court, signed by 82 the attorney and shall include the attorney's address. The summons and any transmittal sheet shall be 83 deemed to be a pleading to which the provisions of § 8.01-271.1 shall apply. A copy of the summons 84 and, if served by a sheriff, all service of process fees, shall be mailed or delivered to the clerk's office 85 of the court in which the case is pending or the Workers' Compensation Commission, as applicable, on 86 87 the day of issuance by the attorney. The law governing summonses issued by a clerk shall apply mutatis 88 mutandis. When an attorney-at-law who is an active member of the Virginia State Bar transmits one or 89 more attorney-issued subpoenas to a sheriff to be served in his jurisdiction, such subpoenas shall be 90 accompanied by a transmittal sheet. The transmittal sheet, which may be in the form of a letter, shall 91 contain for each subpoena (i) the person to be served, (ii) the name of the city or county in which the 92 subpoena is to be served, in parentheses, (iii) the style of the case in which the subpoena was issued, 93 (iv) the court in which the case is pending, and (v) the amount of fees tendered or paid to each clerk in 94 whose court the case is pending together with a photocopy of either (a) the payment instrument and a 95 photocopy of the letter sent to the clerk's office that accompanied such payment instrument or (b) the clerk's receipt. If copies of the same transmittal sheet are used to send subpoenas to more than one 96 97 sheriff for service of process, then subpoenas shall be grouped by the jurisdiction in which they are to 98 be served. For each person to be served, an original subpoena and copy thereof shall be included. If the 99 attorney desires a return copy of the transmittal sheet as proof of receipt, he shall also enclose an 100 additional copy of the transmittal sheet together with an envelope addressed to the attorney with 101 sufficient first class postage affixed. Upon receipt of such transmittal, the transmittal sheet shall be 102 date-stamped and, if the extra copy and above-described envelope are provided, the copy shall also be 103 date-stamped and returned to the attorney-at-law in the above-described envelope.

However, when such transmittal does not comply with the provisions of this section, the sheriff may 104 promptly return such transmittal if accompanied by a short description of such noncompliance. An 105 attorney may not issue a summons in any of the following civil proceedings: (a) habeas corpus under 106 107 Article 3 (§ 8.01-654 et seq.) of Chapter 25 of this title, (b) delinquency or abuse and neglect 108 proceedings under Article 3 (§ 16.1-241 et seq.) of Chapter 11 of Title 16.1, (c) civil forfeiture proceedings, (d) habitual offender proceedings under Article 9 (§- 46.2-351 et seq.) of Chapter 3 of Title 109 46.2, (e) administrative license suspension pursuant to § 46.2-391.2, and (f) (e) petition for write of 110 111 mandamus or prohibition in connection with criminal proceedings. A sheriff shall not be required to serve an attorney-issued subpoena that is not issued at least five business days prior to the date that 112 attendance is desired. 113

114 In other cases, if attendance is desired, the summons may be issued by the clerk of the circuit court 115 of the county or city in which the attendance is desired.

A summons shall express on whose behalf, and in what case or about what matter, the witness is to attend. Failure to respond to any such summons shall be punishable by the court in which the proceeding is pending as for contempt. When any subpoena is served less than five calendar days before appearance is required, the court may, after considering all of the circumstances, refuse to enforce the subpoena for lack of adequate notice. If any subpoena is served less than five calendar days before appearance is required upon any judicial officer generally incompetent to testify pursuant to § 19.2-271,such subpoena shall be without legal force or effect unless the subpoena has been issued by a judge.

B. No subpoend shall, without permission of the court first obtained, issue for the attendance of the
Governor, Lieutenant Governor, or Attorney General of this Commonwealth, a judge of any court
thereof; the President or Vice President of the United States; any member of the President's Cabinet; any
ambassador or consul; or any military officer on active duty holding the rank of admiral or general.

§ 16.1-77. Civil jurisdiction of general district courts; amending amount of claim.

Except as provided in Article 5 (§ 16.1-122.1 et seq.), each general district court shall have, within the limits of the territory it serves, civil jurisdiction as follows:

130 (1) Exclusive original jurisdiction of any claim to specific personal property or to any debt, fine or 131 other money, or to damages for breach of contract or for injury done to property, real or personal, or for 132 any injury to the person that would be recoverable by action at law or suit in equity, when the amount of such claim does not exceed \$4,500 exclusive of interest and any attorney fees, and concurrent 133 134 jurisdiction with the circuit courts having jurisdiction in such territory of any such claim when the 135 amount thereof exceeds \$4,500 but does not exceed \$25,000, exclusive of interest and any attorney fees. 136 However, this \$25,000 limit shall not apply with respect to distress warrants under the provisions of 137 § 8.01-130.4, cases involving liquidated damages for violations of vehicle weight limits pursuant to § 138 46.2-1135, nor cases involving forfeiture of a bond pursuant to § 19.2-143. While a matter is pending in 139 a general district court, upon motion of the plaintiff seeking to increase the amount of the claim, the 140 court shall order transfer of the matter to the circuit court that has jurisdiction over the amended amount 141 of the claim without requiring that the case first be dismissed or that the plaintiff suffer a nonsuit, and 142 the tolling of the applicable statutes of limitations governing the pending matter shall be unaffected by 143 the transfer. Except for good cause shown, no such order of transfer shall issue unless the motion to 144 amend and transfer is made at least 10 days before trial. The plaintiff shall pay filing and other fees as 145 otherwise provided by law to the clerk of the court to which the case is transferred, and such clerk shall 146 process the claim as if it were a new civil action. The plaintiff shall prepare and present the order of 147 transfer to the transferring court for entry, after which time the case shall be removed from the pending 148 docket of the transferring court and the order of transfer placed among its records. The plaintiff shall 149 provide a certified copy of the transfer order to the receiving court.

(2) Jurisdiction to try and decide attachment cases when the amount of the plaintiff's claim does not exceed \$25,000 exclusive of interest and any attorney fees.

(3) Jurisdiction of actions of unlawful entry or detainer as provided in Article 13 (§ 8.01-124 et seq.)
of Chapter 3 of Title 8.01, and in Chapter 14 (§ 55.1-1400 et seq.) of Title 55.1, and the maximum
jurisdictional limits prescribed in subdivision (1) shall not apply to any claim, counter-claim or
cross-claim in an unlawful detainer action that includes a claim for damages sustained or rent against
any person obligated on the lease or guarantee of such lease.

(4) Except where otherwise specifically provided, all jurisdiction, power and authority over any civil action or proceeding conferred upon any general district court judge or magistrate under or by virtue of any provisions of the Code.

(5) Jurisdiction to try and decide suits in interpleader involving personal or real property where the 160 161 amount of money or value of the property is not more than the maximum jurisdictional limits of the 162 general district court. However, the maximum jurisdictional limits prescribed in subdivision (1) shall not 163 apply to any claim, counter-claim, or cross-claim in an interpleader action that is limited to the 164 disposition of an earnest money deposit pursuant to a real estate purchase contract. The action shall be 165 brought in accordance with the procedures for interpleader as set forth in § 8.01-364. However, the general district court shall not have any power to issue injunctions. Actions in interpleader may be 166 167 brought by either the stakeholder or any of the claimants. The initial pleading shall be either by motion 168 for judgment, by warrant in debt, or by other uniform court form established by the Supreme Court of 169 Virginia. The initial pleading shall briefly set forth the circumstances of the claim and shall name as 170 defendant all parties in interest who are not parties plaintiff.

171 (6) Jurisdiction to try and decide any cases pursuant to § 2.2-3713 of the Virginia Freedom of
172 Information Act (§ 2.2-3700 et seq.) or § 2.2-3809 of the Government Data Collection and
173 Dissemination Practices Act (§ 2.2-3800 et seq.), for writs of mandamus or for injunctions.

(7) Concurrent jurisdiction with the circuit courts having jurisdiction in such territory to adjudicate
 habitual offenders pursuant to the provisions of Article 9 (§- 46.2-355.1 et seq.) of Chapter 3 of Title
 46.2.

177 (8) Jurisdiction to try and decide any cases pursuant to § 55.1-1819 of the Property Owners'
178 Association Act (§ 55.1-1800 et seq.) or § 55.1-1959 of the Virginia Condominium Act (§ 55.1-1900 et seq.).

180 (9) (8) Concurrent jurisdiction with the circuit courts to submit matters to arbitration pursuant to 181 Chapter 21 (§ 8.01-577 et seq.) of Title 8.01 where the amount in controversy is within the jurisdictional 182 limits of the general district court. Any party that disagrees with an order by a general district court
183 granting an application to compel arbitration may appeal such decision to the circuit court pursuant to §
184 8.01-581.016.

185 For purposes of this section, the territory served by a county general district court expressly186 authorized by statute to be established in a city includes the general district court courtroom.

187 § 16.1-305. Confidentiality of court records.

A. Social, medical and psychiatric or psychological records, including reports or preliminary inquiries, predisposition studies and supervision records, of neglected and abused children, children in need of services, children in need of supervision and delinquent children shall be filed with the other papers in the juvenile's case file. All juvenile case files shall be filed separately from adult files and records of the court and shall be open for inspection only to the following:

193 1. The judge, probation officers and professional staff assigned to serve the juvenile and domestic194 relations district courts;

195 2. Representatives of a public or private agency or department providing supervision or having legal
196 custody of the child or furnishing evaluation or treatment of the child ordered or requested by the court;
197 3. The attorney for any party, including the attorney for the Commonwealth;

198 4. Any other person, agency or institution, by order of the court, having a legitimate interest in the 199 case or in the work of the court. However, for the purposes of an investigation conducted by a local 200 community-based probation services agency, preparation of a pretrial investigation report, or of a 201 presentence or postsentence report upon a finding of guilty in a circuit court or for the preparation of a 202 background report for the Parole Board, adult probation and parole officers, including United States Probation and Pretrial Services Officers, any officer of a local pretrial services agency established or operated pursuant to Article 5 (§ 19.2-152.2 et seq.) of Chapter 9 of Title 19.2, and any officer of a 203 204 local community-based probation services agency established or operated pursuant to the Comprehensive 205 206 Community Corrections Act for Local-Responsible Offenders (§ 9.1-173 et seq.) shall have access to an 207 accused's or inmate's records in juvenile court without a court order and for the purpose of preparing the 208 discretionary sentencing guidelines worksheets and related risk assessment instruments as directed by the 209 court pursuant to subsection C of § 19.2-298.01, the attorney for the Commonwealth and any pretrial 210 services or probation officer shall have access to the defendant's records in juvenile court without a 211 court order:

5. Any attorney for the Commonwealth and any local pretrial services or community-based probation officer or state adult probation or parole officer shall have direct access to the defendant's juvenile court delinquency records maintained in an electronic format by the court for the strictly limited purposes of preparing a pretrial investigation report, including any related risk assessment instrument, any presentence report, any discretionary sentencing guidelines worksheets, including related risk assessment instrument, any presentence investigation report or preparing for any transfer or sentencing hearing.

A copy of the court order of disposition in a delinquency case shall be provided to a probation officer or attorney for the Commonwealth, when requested for the purpose of calculating sentencing guidelines. The copies shall remain confidential, but reports may be prepared using the information contained therein as provided in §§ 19.2-298.01 and 19.2-299.

6. The Office of the Attorney General, for all criminal justice activities otherwise permitted and forpurposes of performing duties required by Chapter 9 (§ 37.2-900 et seq.) of Title 37.2.

A1. Any person, agency, or institution that may inspect juvenile case files pursuant to subdivisions A
1 through A 4 shall be authorized to have copies made of such records, subject to any restrictions,
conditions, or prohibitions that the court may impose.

B. All or any part of the records enumerated in subsection A, or information secured from such records, which is presented to the judge in court or otherwise in a proceeding under this law shall also be made available to the parties to the proceedings and their attorneys.

B1. If a juvenile 14 years of age or older at the time of the offense is adjudicated delinquent on the basis of an act which would be a felony if committed by an adult, all court records regarding that adjudication and any subsequent adjudication of delinquency, other than those records specified in subsection A, shall be open to the public. However, if a hearing was closed, the judge may order that certain records or portions thereof remain confidential to the extent necessary to protect any juvenile victim or juvenile witness.

C. All other juvenile records, including the docket, petitions, motions and other papers filed with a
case, transcripts of testimony, findings, verdicts, orders and decrees shall be open to inspection only by
those persons and agencies designated in subsections A and B of this section. However, a licensed bail
bondsman shall be entitled to know the status of a bond he has posted or provided surety on for a
juvenile under § 16.1-258. This shall not authorize a bail bondsman to have access to or inspect any
other portion of his principal's juvenile court records.

242 D. Attested copies of papers filed in connection with an adjudication of guilty for an offense for
 243 which the clerk is required by § 46.2-383 to furnish an abstract to the Department of Motor Vehicles,

which shows the charge, finding, disposition, name of the attorney for the juvenile, or waiver of attorney
shall be furnished to an attorney for the Commonwealth upon certification by the prosecuting attorney
that such papers are needed as evidence in a pending criminal, *or* traffic, or habitual offender proceeding
and that such papers will be only used for such evidentiary purpose.

D1. Attested copies of papers filed in connection with an adjudication of guilt for a delinquent act that would be a felony if committed by an adult, which show the charge, finding, disposition, name of the attorney for the juvenile, or waiver of attorney by the juvenile, shall be furnished to an attorney for the Commonwealth upon his certification that such papers are needed as evidence in a pending criminal prosecution for a violation of § 18.2-308.2 and that such papers will be only used for such evidentiary purpose.

254 E. Upon request, a copy of the court order of disposition in a delinquency case shall be provided to
255 the Virginia Workers' Compensation Commission solely for purposes of determining whether to make an
256 award to the victim of a crime, and such information shall not be disseminated or used by the
257 Commission for any other purpose including but not limited to actions pursuant to § 19.2-368.15.

F. Staff of the court services unit or the attorney for the Commonwealth shall provide notice of the disposition in a case involving a juvenile who is committed to state care after being adjudicated for a criminal sexual assault as specified in Article 7 (§ 18.2-61 et seq.) of Chapter 4 of Title 18.2 to the victim or a parent of a minor victim, upon request. Additionally, if the victim or parent submits a written request, the Department of Juvenile Justice shall provide advance notice of such juvenile offender's anticipated date of release from commitment.

G. Any record in a juvenile case file which is open for inspection by the professional staff of the
Department of Juvenile Justice pursuant to subsection A and is maintained in an electronic format by the
court, may be transmitted electronically to the Department of Juvenile Justice. Any record so transmitted
shall be subject to the provisions of § 16.1-300.

268 § 17.1-213. Disposition of papers in ended cases.

A. All case files for cases ended prior to January 1, 1913, shall be permanently maintained in hardcopy form, either in the locality served by the circuit court where such files originated or in The Library of Virginia in accordance with the provisions of § 42.1-86 and subsection C of § 42.1-87.

B. The following records for cases ending on or after January 1, 1913, shall be retained for 10 years after conclusion:

- 1. Conditional sales contracts;
- 275 2. Concealed weapons permit applications;
- **276** 3. Minister appointments:
- 4. Petitions for appointment of trustee;
- **278** 5. Name changes;
- 279 6. Nolle prosequi cases;

280 7. Civil actions that are voluntarily dismissed, including nonsuits, cases that are dismissed as settled
281 and agreed, cases that are dismissed with or without prejudice, cases that are discontinued or dismissed
282 under § 8.01-335, and district court appeals dismissed under § 16.1-113 prior to 1988;

8. Misdemeanor and traffic cases, except as provided in subdivision C 3, including those which were
 commenced on a felony charge but concluded as a misdemeanor;

- **285** 9. Suits to enforce a lien;
 - 10. Garnishments;

287 11. Executions except for those covered in § 8.01-484; and

288 12. Miscellaneous oaths and qualifications, but only if the order or oath or qualification is spread in289 the appropriate order book; and

290 13. Civil cases pertaining to declarations of habitual offender status and full restoration of driving
 291 privileges.

292 C. All other records or cases ending on or after January 1, 1913, shall be retained subject to the 293 following:

294 1. All civil case files to which subsection D does not pertain shall be retained 20 years from the295 court order date.

296 2. All criminal cases dismissed, including those not a true bill, acquittals, and not guilty verdicts,297 shall be retained 10 years from the court order date.

3. Except as otherwise provided in this subdivision, criminal case files involving a felony conviction and all criminal case files involving a misdemeanor conviction under § 16.1-253.2, 18.2-57.2, or 18.2-60.4 shall be retained (i) 20 years from the sentencing date or (ii) until the sentence term ends, whichever comes later. Case files involving a conviction for a sexually violent offense as defined in § 37.2-900, a violent felony as defined in § 17.1-805, or an act of violence as defined in § 19.2-297.1 shall be retained (a) 50 years from the sentencing date or (b) until the sentence term ends, whichever comes later.

305 D. Under the provisions of subsections B and C, the entire file of any case deemed by the local clerk 306 of court to have historical value, as defined in § 42.1-77, or genealogical or sensational significance shall 307 be retained permanently as shall all cases in which the title to real estate is established, conveyed or 308 condemned by an order or decree of the court. The final order for all cases in which the title to real 309 estate is so affected shall include an appropriate notification thereof to the clerk.

310 E. Except as provided in subsection A, the clerk of a circuit court may cause (i) any or all papers or 311 documents pertaining to civil and criminal cases; (ii) any unexecuted search warrants and affidavits for unexecuted search warrants, provided at least three years have passed since issued; (iii) any abstracts of 312 313 judgments; and (iv) original wills, to be destroyed if such records, papers, documents, or wills no longer have administrative, fiscal, historical, or legal value to warrant continued retention, provided such 314 315 records, papers, or documents have been microfilmed or converted to an electronic format. Such microfilm and microphotographic processes and equipment shall meet state archival microfilm standards 316 317 pursuant to § 42.1-82, or such electronic format shall follow state electronic records guidelines, and such 318 records, papers, or documents so converted shall be placed in conveniently accessible files and provisions made for examining and using same. The clerk shall further provide security negative copies 319 320 of any such microfilmed materials for storage in The Library of Virginia.

§ 19.2-389. (Effective until July 1, 2021) Dissemination of criminal history record information.

322 A. Criminal history record information shall be disseminated, whether directly or through an 323 intermediary, only to:

324 1. C. No criminal justice agency or person shall confirm the existence or nonexistence of criminal history record information for employment or licensing inquiries except as provided by law.

777 D. Criminal justice agencies shall establish procedures to query the Central Criminal Records 778 Exchange prior to dissemination of any criminal history record information on offenses required to be 779 reported to the Central Criminal Records Exchange to ensure that the most up-to-date disposition data is 780 being used. Inquiries of the Exchange shall be made prior to any dissemination except in those cases 781 where time is of the essence and the normal response time of the Exchange would exceed the necessary 782 time period. A criminal justice agency to whom a request has been made for the dissemination of 783 criminal history record information that is required to be reported to the Central Criminal Records 784 Exchange may direct the inquirer to the Central Criminal Records Exchange for such dissemination. 785 Dissemination of information regarding offenses not required to be reported to the Exchange shall be 786 made by the criminal justice agency maintaining the record as required by § 15.2-1722.

787 E. Criminal history information provided to licensed nursing homes, hospitals and to home care organizations pursuant to subdivision A 15 shall be limited to the convictions on file with the Exchange for any offense specified in §§ 32.1-126.01, 32.1-126.02, and 32.1-162.9:1.

F. Criminal history information provided to licensed assisted living facilities and licensed adult day
care centers pursuant to subdivision A 16 shall be limited to the convictions on file with the Exchange
for any offense specified in § 63.2-1720.

793 G. Criminal history information provided to public agencies pursuant to subdivision A 36 shall be 794 limited to the convictions on file with the Exchange for any offense set forth in clause (i) of the 795 definition of barrier crime in § 19.2-392.02.

796 H. Upon receipt of a written request from an employer or prospective employer, the Central Criminal

797 Records Exchange, or the criminal justice agency in cases of offenses not required to be reported to the 798 Exchange, shall furnish at the employer's cost a copy of conviction data covering the person named in 799 the request to the employer or prospective employer making the request, provided that the person on 800 whom the data is being obtained has consented in writing to the making of such request and has presented a photo-identification to the employer or prospective employer. In the event no conviction data 801 802 is maintained on the person named in the request, the requesting employer or prospective employer shall 803 be furnished at his cost a certification to that effect. The criminal history record search shall be 804 conducted on forms provided by the Exchange.

805 I. Nothing in this section shall preclude the dissemination of a person's criminal history record 806 information pursuant to the rules of court for obtaining discovery or for review by the court.

807 § 46.2-301. Driving while license, permit, or privilege to drive suspended or revoked.

A. In addition to any other penalty provided by this section, any motor vehicle administratively 808 impounded or immobilized under the provisions of § 46.2-301.1 may, in the discretion of the court, be 809 impounded or immobilized for an additional period of up to 90 days upon conviction of an offender for 810 driving while his driver's license, learner's permit, or privilege to drive a motor vehicle has been (i) 811 812 suspended or revoked for (i) a violation of § 18.2-36.1, 18.2-51.4, 18.2-266, 18.2-272, or 46.2-341.24 or a substantially similar ordinance or law in any other jurisdiction or (ii) driving after adjudication as an 813 814 habitual offender, where such adjudication was based in whole or in part on an alcohol-related offense, 815 or where such person's license has been administratively suspended under the provisions of § 46.2-391.2. 816 However, if, at the time of the violation, the offender was driving a motor vehicle owned by another 817 person, the court shall have no jurisdiction over such motor vehicle but may order the impoundment or 818 immobilization of a motor vehicle owned solely by the offender at the time of arrest. All costs of 819 impoundment or immobilization, including removal or storage expenses, shall be paid by the offender 820 prior to the release of his motor vehicle.

821 B. Except as provided in §§ § 46.2-304 and 46.2-357, no resident or nonresident (i) whose driver's 822 license, learner's permit, or privilege to drive a motor vehicle has been suspended or revoked or (ii) who 823 has been directed not to drive by any court or by the Commissioner, or (iii) who has been forbidden, as 824 prescribed by operation of any statute of the Commonwealth or a substantially similar ordinance of any 825 county, city or town, to operate a motor vehicle in the Commonwealth shall thereafter drive any motor 826 vehicle or any self-propelled machinery or equipment on any highway in the Commonwealth until the 827 period of such suspension or revocation has terminated or the privilege has been reinstated or a 828 restricted license is issued pursuant to subsection E. For the purposes of this section, the phrase "motor 829 vehicle or any self-propelled machinery or equipment" shall not include mopeds. 830

C. A violation of subsection B is a Class 1 misdemeanor.

831 D. Upon a violation of subsection B, the court shall suspend the person's license or privilege to drive 832 a motor vehicle for the same period for which it had been previously suspended or revoked. In the event 833 the person violated subsection B by driving during a period of suspension or revocation which was not 834 for a definite period of time, the court shall suspend the person's license, permit or privilege to drive for 835 an additional period not to exceed 90 days, to commence upon the expiration of the previous suspension 836 or revocation or to commence immediately if the previous suspension or revocation has expired.

837 E. Any person who is otherwise eligible for a restricted license may petition each court that 838 suspended his license pursuant to subsection D for authorization for a restricted license, provided that 839 the period of time for which the license was suspended by the court pursuant to subsection D, if 840 measured from the date of conviction, has expired, even though the suspension itself has not expired. A 841 court may, for good cause shown, authorize the Department of Motor Vehicles to issue a restricted 842 license for any of the purposes set forth in subsection E of § 18.2-271.1. No restricted license shall be 843 issued unless each court that issued a suspension of the person's license pursuant to subsection D 844 authorizes the Department to issue a restricted license. Any restricted license issued pursuant to this 845 subsection shall be in effect until the expiration of any and all suspensions issued pursuant to subsection 846 D, except that it shall automatically terminate upon the expiration, cancellation, suspension, or 847 revocation of the person's license or privilege to drive for any other cause. No restricted license issued 848 pursuant to this subsection shall permit a person to operate a commercial motor vehicle as defined in the 849 Commercial Driver's License Act (§ 46.2-341.1 et seq.). The court shall forward to the Commissioner a 850 copy of its authorization entered pursuant to this subsection, which shall specifically enumerate the 851 restrictions imposed and contain such information regarding the person to whom such a license is issued as is reasonably necessary to identify the person. The court shall also provide a copy of its authorization 852 853 to the person, who may not operate a motor vehicle until receipt from the Commissioner of a restricted 854 license. A copy of the restricted license issued by the Commissioner shall be carried at all times while 855 operating a motor vehicle.

F. Any person who operates a motor vehicle or any self-propelled machinery or equipment in 856 857 violation of the terms of a restricted license issued pursuant to subsection E of § 18.2-271.1 is not guilty 858 of a violation of this section but is guilty of a violation of § 18.2-272.

859 § 46.2-301.1. Administrative impoundment of motor vehicle for certain driving while license 860 suspended or revoked offenses; judicial impoundment upon conviction; penalty for permitting 861 violation with one's vehicle.

A. The motor vehicle being driven by any person (i) whose driver's license, learner's permit or 862 863 privilege to drive a motor vehicle has been suspended or revoked for a violation of § 18.2-51.4 or 864 18.2-272 or driving while under the influence in violation of § 18.2-266, 46.2-341.24 or a substantially 865 similar ordinance or law in any other jurisdiction; (ii) driving after adjudication as an habitual offender, 866 where such adjudication was based in whole or in part on an alcohol-related offense, or where such 867 person's license has been administratively suspended under the provisions of § 46.2-391.2; (iii) driving 868 after such person's driver's license, learner's permit or privilege to drive a motor vehicle has been 869 suspended or revoked for unreasonable refusal of tests in violation of § 18.2-268.3, 46.2-341.26:3 or a 870 substantially similar ordinance or law in any other jurisdiction; or (iv) driving without an operator's 871 license in violation of § 46.2-300 having been previously convicted of such offense or a substantially similar ordinance of any county, city, or town or law in any other jurisdiction shall be impounded or 872 873 immobilized by the arresting law-enforcement officer at the time the person is arrested for driving after 874 his driver's license, learner's permit or privilege to drive has been so revoked or suspended or for driving without an operator's license in violation of § 46.2-300 having been previously convicted of such offense 875 876 or a substantially similar ordinance of any county, city, or town or law in any other jurisdiction. The 877 impoundment or immobilization for a violation of elauses clause (i) through, (ii), or (iii) shall be for a 878 period of 30 days. The period of impoundment or immobilization for a violation of clause (iv) shall be 879 until the offender obtains a valid operator's license pursuant to § 46.2-300 or three days, whichever is 880 less. In the event that the offender obtains a valid operator's license at any time during the three-day 881 impoundment period and presents such license to the court, the court shall authorize the release of the 882 vehicle upon payment of all reasonable costs of impoundment or immobilization to the person holding 883 the vehicle.

884 The provisions of this section as to the offense described in clause (iv) of this subsection shall not 885 apply to a person who drives a motor vehicle with no operator's license (i) (a) whose license has been 886 expired for less than one year prior to the offense or (ii) (b) who is under 18 years of age at the time of 887 the offense. The arresting officer, acting on behalf of the Commonwealth, shall serve notice of the 888 impoundment upon the arrested person. The notice shall include information on the person's right to 889 petition for review of the impoundment pursuant to subsection B. A copy of the notice of impoundment 890 shall be delivered to the magistrate and thereafter promptly forwarded to the clerk of the general district 891 court of the jurisdiction where the arrest was made. Transmission of the notice may be by electronic 892 means.

893 At least five days prior to the expiration of the period of impoundment imposed pursuant to this
894 section or § 46.2-301, the clerk shall provide the offender with information on the location of the motor
895 vehicle and how and when the vehicle will be released; however, for a violation of clause (iv) above,
896 such information shall be provided at the time of arrest.

897 All reasonable costs of impoundment or immobilization, including removal and storage expenses, 898 shall be paid by the offender prior to the release of his motor vehicle. Notwithstanding the above, where 899 the arresting law-enforcement officer discovers that the vehicle was being rented or leased from a 900 vehicle renting or leasing company, the officer shall not impound the vehicle or continue the 901 impoundment but shall notify the rental or leasing company that the vehicle is available for pickup and 902 shall notify the clerk if the clerk has previously been notified of the impoundment.

903 B. Any driver who is the owner of the motor vehicle that is impounded or immobilized under 904 subsection A may, during the period of the impoundment, petition the general district court of the 905 jurisdiction in which the arrest was made to review that impoundment. The court shall review the 906 impoundment within the same time period as the court hears an appeal from an order denying bail or 907 fixing terms of bail or terms of recognizance, giving this matter precedence over all other matters on its 908 docket. If the person proves to the court by a preponderance of the evidence that the arresting 909 law-enforcement officer did not have probable cause for the arrest, or that the magistrate did not have 910 probable cause to issue the warrant, the court shall rescind the impoundment. Upon rescission, the motor 911 vehicle shall be released and the Commonwealth shall pay or reimburse the person for all reasonable 912 costs of impoundment or immobilization, including removal or storage costs paid or incurred by him. 913 Otherwise, the court shall affirm the impoundment. If the person requesting the review fails to appear 914 without just cause, his right to review shall be waived.

915 The court's findings are without prejudice to the person contesting the impoundment or to any other 916 potential party as to any proceedings, civil or criminal, and shall not be evidence in any proceedings, 917 civil or criminal.

918 C. The owner or co-owner of any motor vehicle impounded or immobilized under subsection A who 919 was not the driver at the time of the violation may petition the general district court in the jurisdiction

920 where the violation occurred for the release of his motor vehicle. The motor vehicle shall be released if 921 the owner or co-owner proves by a preponderance of the evidence that he (i) did not know that the 922 offender's driver's license was suspended or revoked when he authorized the offender to drive such 923 motor vehicle; (ii) did not know that the offender had no operator's license and that the operator had 924 been previously convicted of driving a motor vehicle without an operator's license in violation of 925 § 46.2-300 or a substantially similar ordinance of any county, city, or town or law in any other 926 jurisdiction when he authorized the offender to drive such motor vehicle; or (iii) did not consent to the 927 operation of the motor vehicle by the offender. If the owner proves by a preponderance of the evidence 928 that his immediate family has only one motor vehicle and will suffer a substantial hardship if that motor 929 vehicle is impounded or immobilized for the period of impoundment that otherwise would be imposed 930 pursuant to this section, the court, in its discretion, may release the vehicle after some period of less 931 than such impoundment period.

D. Notwithstanding any provision of this section, a subsequent dismissal or acquittal of the charge of driving without an operator's license or of driving on a suspended or revoked license shall result in an immediate rescission of the impoundment or immobilization provided in subsection A. Upon rescission, the motor vehicle shall be released and the Commonwealth shall pay or reimburse the person for all reasonable costs of impoundment or immobilization, including removal or storage costs, incurred or paid by him.

E. Any person who knowingly authorizes the operation of a motor vehicle by (i) a person he knows
has had his driver's license, learner's permit or privilege to drive a motor vehicle suspended or revoked
for any of the reasons set forth in subsection A or (ii) a person who he knows has no operator's license
and who he knows has been previously convicted of driving a motor vehicle without an operator's
license in violation of § 46.2-300 or a substantially similar ordinance of any county, city, or town or law
in any other jurisdiction shall be guilty of a Class 1 misdemeanor.

944 F. Notwithstanding the provisions of this section or § 46.2-301, nothing in this section shall impede 945 or infringe upon a valid lienholder's rights to cure a default under an existing security agreement. 946 Furthermore, such lienholder shall not be liable for any cost of impoundment or immobilization, 947 including removal or storage expenses which may accrue pursuant to the provisions of this section or 948 § 46.2-301. In the event a lienholder repossesses or removes a vehicle from storage pursuant to an 949 existing security agreement, the Commonwealth shall pay all reasonable costs of impoundment or 950 immobilization, including removal and storage expenses, to any person or entity providing such services 951 to the Commonwealth, except to the extent such costs or expenses have already been paid by the 952 offender to such person or entity. Such payment shall be made within seven calendar days after a 953 request is made by such person or entity to the Commonwealth for payment. Nothing herein, however, 954 shall relieve the offender from liability to the Commonwealth for reimbursement or payment of all such 955 reasonable costs and expenses.

§ 46.2-301.2. Intervention required for certain offenders; fee; penalty; notice.

A. Upon receiving notification of a second conviction entered on or after July 1, 1999, for driving
while the offender's license, permit, or privilege to drive is suspended or revoked in violation of
§ 46.2-301, the Commissioner shall notify such person that he shall report to a Virginia Alcohol Safety
Action Program within 60 days of the date of such notice for intervention. Intervention shall be in
accordance with § 18.2-271.1. The program shall provide the Commissioner with information of the
offender's compliance.

B. An interview shall be conducted by a representative of a Virginia Alcohol Safety Action Program.
The representative shall review all applicable laws with the person attending the interview, provide guidance with respect to budgeting for payment of court fines and costs, if applicable, and explain the laws and the consequences of future offenses and may refer the person to any driver improvement clinic.
A fee of \$30 shall be paid to the Virginia Alcohol Safety Action Program for attendance at a driver intervention interview. All fees collected by a Virginia Alcohol Safety Action Program shall be used to meet its expenses.

970 C. The Commissioner shall suspend the driving privilege of any person who fails to complete and
971 pay the required fee for an intervention interview within the 60-day period. The suspension shall
972 continue until such time as the person has completed and paid for the intervention interview.

973 D. Notice to report for intervention shall be sent by the Department by certified mail, return receipt
 974 requested, to the driver at the last known address supplied by the driver and on file with the
 975 Department.

976 E. Failure of the offender to attend as required or failure of the Department to notify the offender
977 upon the second offense shall not prevent conviction for any subsequent offense committed in violation
978 of § 46.2-301.

979 § 46.2-411. Reinstatement of suspended or revoked license or other privilege to operate or 980 register a motor vehicle; proof of financial responsibility; reinstatement fee.

981 A. The Commissioner may refuse, after a hearing if demanded, to issue to any person whose license

has been suspended or revoked any new or renewal license, or to register any motor vehicle in the nameof the person, whenever he deems or in case of a hearing finds it necessary for the safety of the publicon the highways in the Commonwealth.

B. Before granting or restoring a license or registration to any person whose driver's license or other privilege to drive motor vehicles or privilege to register a motor vehicle has been revoked or suspended pursuant to § 46.2-389, 46.2-391, 46.2-391.1, or 46.2-417, the Commissioner shall require proof of financial responsibility in the future as provided in Article 15 (§ 46.2-435 et seq.), but no person shall be licensed who may not be licensed under the provisions of §§ 46.2-389 through 46.2-431.

990 C. Whenever the driver's license or registration cards, license plates and decals, or other privilege to 991 drive or to register motor vehicles of any resident or nonresident person is suspended or revoked by the 992 Commissioner or by a district court or circuit court pursuant to the provisions of Title 18.2 or this title, 993 or any valid local ordinance, the order of suspension or revocation shall remain in effect and the driver's 994 license, registration cards, license plates and decals, or other privilege to drive or register motor vehicles 995 shall not be reinstated and no new driver's license, registration cards, license plates and decals, or other 996 privilege to drive or register motor vehicles shall be issued or granted unless such person, in addition to 997 complying with all other provisions of law, pays to the Commissioner a reinstatement fee of \$30. The 998 reinstatement fee shall be increased by \$30 whenever such suspension or revocation results from 999 conviction of involuntary manslaughter in violation of § 18.2-36.1; conviction of maining resulting from 1000 driving while intoxicated in violation of § 18.2-51.4; conviction of driving while intoxicated in violation 1001 of § 18.2-266 or 46.2-341.24; conviction of driving after illegally consuming alcohol in violation of 1002 18.2-266.1 or failure to comply with court imposed conditions pursuant to subsection D of 1003 § 18.2-271.1; unreasonable refusal to submit to drug or alcohol testing in violation of § 18.2-268.2; 1004 conviction of driving while a license, permit or privilege to drive was suspended or revoked in violation 1005 of § 46.2-301 or 46.2-341.21; disqualification pursuant to § 46.2-341.20; violation of driver's license 1006 probation pursuant to § 46.2-499; failure to attend a driver improvement clinic pursuant to § 46.2-503 or 1007 habitual offender interventions pursuant to § 46.2-301.2 or former § 46.2-351.1; conviction of eluding 1008 police in violation of § 46.2-817; conviction of hit and run in violation of § 46.2-894; conviction of 1009 reckless driving in violation of Article 7 (§ 46.2-852 et seq.) of Chapter 8 of Title 46.2 or a conviction, finding or adjudication under any similar local ordinance, federal law or law of any other state. Five 1010 1011 dollars of the additional amount shall be retained by the Department as provided in this section and \$25 1012 shall be transferred to the Commonwealth Neurotrauma Initiative Trust Fund established pursuant to Article 12 (§ 51.5-178 et seq.) of Chapter 14 of Title 51.5. When three years have elapsed from the 1013 1014 termination date of the order of suspension or revocation and the person has complied with all other 1015 provisions of law, the Commissioner may relieve him of paying the reinstatement fee.

1016 D. No reinstatement fee shall be required when the suspension or revocation of license results from 1017 the person's suffering from mental or physical infirmities or disabilities from natural causes not related 1018 to the use of self-administered intoxicants or drugs. No reinstatement fee shall be collected from any 1019 person whose license is suspended by a court of competent jurisdiction for any reason, other than a 1020 cause for mandatory suspension as provided in this title, provided the court ordering the suspension is 1021 not required by § 46.2-398 to forward the license to the Department during the suspended period.

1022 E. Except as otherwise provided in this section and § 18.2-271.1, reinstatement fees collected under 1023 the provisions of this section shall be paid by the Commissioner into the state treasury and shall be set 1024 aside as a special fund to be used to meet the expenses of the Department.

F. Before granting or restoring a license or registration to any person whose driver's license or other privilege to drive motor vehicles or privilege to register a motor vehicle has been revoked or suspended, the Commissioner shall collect from such person, in addition to all other fees provided for in this section, an additional fee of \$40. The Commissioner shall pay all fees collected pursuant to this subsection into the Trauma Center Fund, created pursuant to § 18.2-270.01, for the purpose of defraying the costs of providing emergency medical care to victims of automobile accidents attributable to alcohol or drug use.

1032 G. Whenever any person is required to pay a reinstatement fee pursuant to subsection C or pursuant 1033 to subsection E of § 18.2-271.1 and such person has more than one suspension or revocation on his 1034 record for which reinstatement is required, then such person shall be required to pay one reinstatement 1035 fee, the amount of which shall equal the full reinstatement fee attributable to the one of his revocations 1036 or suspensions that would trigger the highest reinstatement fee, plus an additional \$5 fee for 1037 administrative costs associated with compliance for each additional suspension or revocation. Fees 1038 collected pursuant to this subsection shall be set aside as a special fund to be used to meet the expenses 1039 of the Department.

1040 § 53.1-21. Transfer of prisoners into and between state and local correctional facilities.

1041 A. Any person who (1) (*i*) is accused or convicted of an offense (a) in violation of any county, city, or town ordinance within the Commonwealth, (b) against the laws of the Commonwealth, or (c) against

1043 the laws of any other state or country, or (2) (ii) is a witness held in any case in which the

1044 Commonwealth is a party and who is confined in a state or local correctional facility, may be 1045 transferred by the Director, subject to the provisions of § 53.1-20, to any other state or local correctional 1046 facility which he may designate.

1047 B. The following limitations shall apply to the transfer of persons into the custody of the 1048 Department:

1049 1. No person convicted of violating § 20-61 shall be committed or transferred to the custody of the 1050 Department.

1051 2. No person who is convicted of any violation pursuant to Article 9 (§ 46.2-355.1 et seq.) of 1052 Chapter 3 of Title 46.2 shall be committed or transferred to the custody of the Department without the 1053 consent of the Director.

1054 3. No person who is convicted of a misdemeanor or a felony and receives a jail sentence of twelve
 1055 12 months or less shall be committed or transferred to the custody of the Department without the
 1056 consent of the Director.

4. 3. Beginning July 1, 1991, and subject to the provisions of § 53.1-20, no person, whether
convicted of a felony or misdemeanor, shall be transferred to the custody of the Department when the
combined length of all sentences to be served totals two years or less, without the consent of the
Director.

1061 2. That Article 9 (§§ 46.2-355.1 through 46.2-363) of Chapter 3 of Title 46.2 of the Code of Virginia is repealed.

3. That the Commissioner of the Department of Motor Vehicles shall reinstate a person's privilege to drive a motor vehicle that was suspended or revoked solely on the basis that such person was determined to be or adjudicated a habitual offender pursuant to the provisions of Article 9 (§ 46.2-355.1 et seq.) of Chapter 3 of Title 46.2 of the Code of Virginia prior to the effective date of this act. Nothing in this act shall require the Commissioner to reinstate a person's driving privileges if such privileges have been otherwise lawfully suspended or revoked or if such person is otherwise ineligible for a driver's license.
