2 An Act to amend the Code of Virginia by adding in Article 2 of Chapter 1 of Title 23.1 a section
3 numbered 23.1-110, by adding in Article 3 of Chapter 1 of Title 32.1 a section numbered 32.1-23.3,
4 and by adding a section numbered 54.1-2400.03, relating to Department of Health; Eligible Health
5 Care Provider Reserve Directory; emergency.

8 Be it enacted by the General Assembly of Virginia:

9 1. That the Code of Virginia is amended by adding in Article 2 of Chapter 1 of Title 23.1 a
10 section numbered 23.1-110, by adding in Article 3 of Chapter 1 of Title 32.1 a section numbered
11 32.1-23.3, and by adding a section numbered 54.1-2400.03 as follows:

12 § 23.1-110. *Medical schools to report information concerning fourth-year medical students to the*
13 *Department of Health; Eligible Health Care Provider Reserve Directory.*

14 All medical schools in the Commonwealth shall report information prescribed in subsection B of
15 § 32.1-23.3 for fourth-year medical students who are in good standing and scheduled to graduate early
16 or on time to the Department of Health for inclusion in the Eligible Health Care Provider Reserve
17 Directory (the Directory) when such students register for inclusion in the Directory and consent to the
18 release of their education records required for inclusion in the Directory in compliance with the Family
19 Educational Rights and Privacy Act of 1974, 20 U.S.C. § 1232g.

20 § 32.1-23.3. *Eligible Health Care Provider Reserve Directory.*

21 A. As used in this section, "eligible health care provider" means (i) any person licensed, registered,
22 or certified by a health regulatory board within the Department of Health Professions whose license,
23 registration, or certification is in good standing, or was in good standing within five years or less prior
24 and only lapsed because such person retired; (ii) any emergency medical services provider certified or
25 licensed by the Department of Health whose certification or licensing is in good standing, or was in
26 good standing within five years or less prior and only lapsed because such person retired; and (iii) any
27 fourth-year medical student who is engaged in a course of study approved by the Board of Medicine
28 and is in good standing with the student's medical school and is scheduled to graduate early or on time
29 who registers for the Eligible Health Care Provider Reserve Directory (the Directory).

30 B. The Department shall establish an Eligible Health Care Provider Reserve Directory to collect
31 information regarding eligible health care providers in the Commonwealth who are qualified and who
32 may be available to assist in the response to a public health emergency. The Directory shall include the
33 name, contact information, and licensure, certification, or registration type and status of the eligible
34 health care provider or, if the eligible health care provider is a fourth-year medical student, academic
35 standing and anticipated graduation date of the fourth-year medical student. Every health regulatory
36 board of the Department of Health Professions, the Office of Emergency Medical Services of the
37 Department of Health, and each medical school located in the Commonwealth, upon the request of a
38 fourth-year medical student, shall provide such information to the Department for inclusion in the
39 Directory.

40 C. During a declared public health emergency, the Governor may request and the Commissioner may
41 provide information regarding eligible health care providers from the Directory. Information obtained
42 from the Directory may be used to (i) identify eligible health care providers who may be able to assist
43 in responding to the public health emergency and (ii) contact such eligible health care providers to
44 request assistance in responding to the public health emergency. Information contained in the Directory
45 shall not be used for any other purpose.

47 *the Department of Health; Eligible Health Care Provider Reserve Directory.*

48 Every health regulatory board within the Department of Health Professions shall report information
49 prescribed in subsection B of § 32.1-23.3 for persons licensed, registered, or certified or previously
50 licensed, registered, or certified by the health regulatory board to the Department of Health for
51 inclusion in the Eligible Health Care Provider Reserve Directory. However, a health regulatory board
52 shall not report information for any such person who has notified the health regulatory board in writing
53 that he does not want his information included in the Eligible Health Care Provider Reserve Directory.

54 2. That an emergency exists and this act is in force from its passage.
