Pursuant to § 30-19.1:4, fiscal impact statements prepared by the Virginia Criminal Sentencing Commission only include the estimated increase in operating costs associated with additional state-responsible prison beds and do not reflect any other costs or savings that may be associated with the proposed legislation.

Summary of Proposed Legislation:

The proposed legislation amends § 18.2-308.5 of the *Code of Virginia*, relating to the manufacture, import, sale, transfer, or possession of an undetectable firearm. Currently, under § 18.2-308.5, it is a Class 5 felony for any person to sell, possess, etc., any plastic firearm as defined in that section.

The proposed legislation would expand the Class 5 felony defined in § 18.2-308.5 to include any firearm that, after removal of all parts other than a major component (i.e., the slide or cylinder, or the frame or receiver, of the firearm), is not detectable as a firearm by the types of detection devices, including X-ray machines, commonly used at airports for security screening.

The bill also adds § 18.2-308.5:2 to make it a Class 1 misdemeanor for any person (i) to sell, offer to sell, transfer, or purchase an unfinished frame or receiver, unless the party receiving the unfinished frame or receiver is a federal firearms importer or manufacturer or the unfinished frame or receiver is imprinted with a serial number issued by a federal firearms importer or manufacturer, (ii) to manufacture, cause to be manufactured, assemble, or cause to be assembled a firearm that is not imprinted with a serial number issued by a federal firearms importer or manufacturer in compliance with all federal laws and regulations regulating the manufacture and import of firearms, or (iii) to sell, offer to sell, transfer, or purchase a firearm that is not imprinted with a serial number issued by a federal firearms importer or federal firearms manufacturer in compliance with all federal laws and regulations, unless the party receiving the firearm is

a law-enforcement agency or a federal firearms importer or federal firearms manufacturer. A second or subsequent violation under this provision would be punishable as a Class 4 felony.

Analysis:

According to the Circuit Court Case Management System (CMS) for fiscal year (FY) 2015 through FY2020, there were no convictions under § 18.2-308.5 during the most recent six-year period.

Impact of Proposed Legislation:

State adult correctional facilities. By expanding an existing felony and creating a new felony offense for which imprisonment is authorized, the proposal may increase the future state-responsible (prison) bed space needs of the Commonwealth. However, available data do not provide sufficient detail to estimate the number of new felony convictions that may result from enactment of the proposal. Therefore, the magnitude of the impact on prison bed space needs cannot be determined.¹

Local adult correctional facilities. By defining new crimes and expanding an existing felony, the proposal may also increase local-responsible (jail) bed space needs, but the magnitude of the impact cannot be determined.

Adult community corrections programs. Because the proposal could result in felony convictions and subsequent supervision requirements for an additional number of offenders, the proposal may increase the need for state community corrections resources. Since the number of cases that may be affected by the proposal cannot be determined, the potential impact on community corrections cannot be quantified.

Virginia's sentencing guidelines. Felony convictions under § 18.2-308.5 are not covered by the sentencing guidelines when this offense is the primary, or most serious, offense in a case. Convictions under the proposed § 18.2-308.5:2 also would not be covered. However, convictions under these statutes could augment the guidelines recommendation if the most serious offense at sentencing is covered by the guidelines. No adjustment to the guidelines would be necessary under the proposal.

Juvenile direct care. According to the Department of Juvenile Justice, the impact of the proposal on direct care (juvenile correctional center or alternative commitment placement) bed space needs cannot be determined.

Juvenile detention facilities. The Department of Juvenile Justice reports that the proposal's impact on the bed space needs of juvenile detention facilities cannot be determined.

Pursuant to § 30-19.1:4, the estimated amount of the necessary appropriation cannot be determined for periods of imprisonment in state adult correctional facilities; therefore, Chapter 1289 of the Acts of Assembly of 2020 requires the Virginia Criminal Sentencing Commission to assign a minimum fiscal impact of \$50,000.

Pursuant to § 30-19.1:4, the estimated amount of the necessary appropriation cannot be determined for periods of commitment to the custody of the Department of Juvenile Justice.
