6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That the Code of Virginia is amended by adding in Title 30 a chapter numbered 64, consisting**  
 8 **of sections numbered 30-409 through 30-413, as follows:**

9 **CHAPTER 64.**

10 **SCHOOL HEALTH SERVICES COMMITTEE.**

11 **§ 30-409. School Health Services Committee; purpose.**

12 *The School Health Services Committee (the Committee) is established in the legislative branch of*  
 13 *state government. The purpose of the Committee is to review and provide advice to the General*  
 14 *Assembly and other policy makers regarding proposals that require local school boards to offer certain*  
 15 *health services in a school setting. The Committee shall submit its findings and recommendations to the*  
 16 *General Assembly and the Governor by October 1 of each year.*

17 **§ 30-410. Membership; terms; quorum; meetings.**

18 *A. The Committee shall have a total membership of 15 members that shall consist of 8 legislative*  
 19 *members, five nonlegislative citizen members, and two ex officio members. Members shall be appointed*  
 20 *as follows: three members of the Senate, each of whom shall be a member of the Senate Committee on*  
 21 *Education and Health, to be appointed by the Senate Committee on Rules; five members of the House of*  
 22 *Delegates, each of whom shall be a member of either the House Committee on Health, Welfare and*  
 23 *Institutions or a member of the House Committee on Education, to be appointed by the Speaker of the*  
 24 *House of Delegates in accordance with the principles of proportional representation contained in the*  
 25 *Rules of the House of Delegates; three nonlegislative citizen members, one of whom shall be an*  
 26 *educator at a public school in the Commonwealth, one of whom shall be a school nurse at a public*  
 27 *school in the Commonwealth, and one of whom shall be a public health expert, to be appointed by the*  
 28 *Senate Committee on Rules; and two nonlegislative citizen members, one of whom shall be an educator*  
 29 *at a public school in the Commonwealth and one of whom shall be a public health expert, to be*  
 30 *appointed by the Speaker of the House of Delegates. The Superintendent of Public Instruction and the*  
 31 *State Health Commissioner, or their designees, shall serve ex officio with nonvoting privileges.*  
 32 *Nonlegislative citizen members of the Committee shall be citizens of the Commonwealth. Unless*  
 33 *otherwise approved in writing by the chairman of the Committee and the respective Clerk, nonlegislative*  
 34 *citizen members shall only be reimbursed for travel originating and ending within the Commonwealth*  
 35 *for the purpose of attending meetings.*

36 *Legislative members and ex officio members of the Committee shall serve terms coincident with their*  
 37 *terms of office.*

38 *Appointments to fill vacancies, other than by expiration of a term, shall be for the unexpired terms.*  
 39 *Vacancies shall be filled in the same manner as the original appointments. All members may be*  
 40 *reappointed.*

41 *Nonlegislative citizen members shall be appointed for a term of two years.*

42 *The Committee shall elect a chairman and vice-chairman from among its membership, who shall be*  
 43 *members of the General Assembly.*

44 *B. A majority of the members shall constitute a quorum. The meetings of the Committee shall be held*  
 45 *at the call of the chairman or whenever the majority of the members so request.*

46 *No recommendation of the Committee shall be adopted if a majority of the Senate members or a*  
 47 *majority of the House members appointed to the Committee (i) vote against the recommendation and (ii)*  
 48 *vote for the recommendation to fail notwithstanding the majority vote of the Committee.*

49 **§ 30-411. Compensation; expenses; annual report.**

50 *Legislative members of the Committee shall receive such compensation as provided in § 30-19.12,*  
 51 *and nonlegislative citizen members shall receive such compensation for the performance of their duties*  
 52 *as provided in § 2.2-2813. All members shall be reimbursed for all reasonable and necessary expenses*  
 53 *incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Compensation to*  
 54 *members of the General Assembly for attendance at official meetings of the Committee shall be paid by*  
 55 *the offices of the Clerk of the House of Delegates or Clerk of the Senate, as applicable. All other*  
 56 *compensation and expenses shall be paid from existing appropriations to the Committee or, if unfunded,*

57 shall be approved by the Joint Rules Committee.

58 The Committee shall submit to the General Assembly and the Governor an annual report for  
59 publication as a report document as provided in the procedures of the Division of Legislative Automated  
60 Systems for the processing of legislative documents and reports. The chairman of the Committee shall  
61 submit to the General Assembly and the Governor an annual executive summary of the interim activity  
62 and work of the Committee no later than the first day of each regular session of the General Assembly.  
63 The executive summary shall be submitted for publication as a report document as provided in the  
64 procedures of the Division of Legislative Automated Systems for the processing of legislative documents  
65 and reports and shall be posted on the General Assembly's website.

66 **§ 30-412. Staffing.**

67 Administrative staff support shall be provided by the Office of the Clerk of the Senate or the Office  
68 of the Clerk of the House of Delegates as may be appropriate for the house in which the chairman of  
69 the Committee serves. The Division of Legislative Services shall provide legal, research, policy analysis,  
70 and other services as requested by the Committee.

71 **§ 30-413. Sunset.**

72 This chapter shall expire on July 1, 2025.

73 **2. That, for its first year of existence, if the School Health Services Committee (the Committee) is**  
74 **not funded by a separate appropriation in the appropriation act, the Committee may be funded**  
75 **from the operating budgets of the Clerk of the Senate and the Clerk of the House of Delegates**  
76 **upon the approval of the Joint Rules Committee. If the Committee is not funded by a separate**  
77 **appropriation in the appropriation act for any year thereafter, this chapter shall expire on July 1**  
78 **of the fiscal year in which the Committee fails to receive such funding.**
