Without limiting the foregoing, 88 any semiconductor equipment, fuel, power, energy, supplies, or other tangible personal property shall be 89 deemed used as part of the integrated process if its use contributes, before, during, or after production, 90 to higher product quality, production yields, or process efficiencies. Except as otherwise provided by 91 law, "integrated process" does not mean general maintenance or administration.

92 "Internet" means collectively, the myriad of computer and telecommunications facilities, which93 comprise the interconnected worldwide network of computer networks.

94 "Internet service" means a service that enables users to access proprietary and other content,
95 information electronic mail, and the Internet as part of a package of services sold to end-user
96 subscribers.

97 "Lease or rental" means the leasing or renting of tangible personal property and the possession or use98 thereof by the lessee or renter for a consideration, without transfer of the title to such property.

99 "Manufacturing, processing, refining, or conversion" includes the production line of the plant starting 100 with the handling and storage of raw materials at the plant site and continuing through the last step of 101 production where the product is finished or completed for sale and conveyed to a warehouse at the 102 production site, and also includes equipment and supplies used for production line testing and quality 103 control. "Manufacturing" also includes the necessary ancillary activities of newspaper and magazine 104 printing when such activities are performed by the publisher of any newspaper or magazine for sale 105 daily or regularly at average intervals not exceeding three months.

106 The determination of whether any manufacturing, mining, processing, refining or conversion activity 107 is industrial in nature shall be made without regard to plant size, existence or size of finished product 108 inventory, degree of mechanization, amount of capital investment, number of employees or other factors 109 relating principally to the size of the business. Further, "industrial in nature" includes, but is not limited 110 to, those businesses classified in codes 10 through 14 and 20 through 39 published in the Standard 111 Industrial Classification Manual for 1972 and any supplements issued thereafter.

"Modular building" means, but is not limited to, single and multifamily houses, apartment units, 112 113 commercial buildings, and permanent additions thereof, comprised of one or more sections that are intended to become real property, primarily constructed at a location other than the permanent site, built 114 to comply with the Virginia Industrialized Building Safety Law (§ 36-70 et seq.) as regulated by the 115 Virginia Department of Housing and Community Development, and shipped with most permanent 116 components in place to the site of final assembly. For purposes of this chapter, "modular building" does 117 not include a mobile office as defined in § 58.1-2401 or any manufactured building subject to and 118 certified under the provisions of the National Manufactured Housing Construction and Safety Standards 119 Act of 1974 (42 U.S.C. § 5401 et seq.). 120

"Modular building manufacturer" means a person that owns or operates a manufacturing facility and
is engaged in the fabrication, construction and assembling of building supplies and materials into
modular buildings, as defined in this section, at a location other than at the site where the modular
building will be assembled on the permanent foundation and may or may not be engaged in the process
of affixing the modules to the foundation at the permanent site.

"Modular building retailer" means any person that purchases or acquires a modular building from a modular building manufacturer, or from another person, for subsequent sale to a customer residing within or outside of the Commonwealth, with or without installation of the modular building to the foundation at the permanent site.

"Motor vehicle" means a "motor vehicle" as defined in § 58.1-2401, taxable under the provisions of
the Virginia Motor Vehicles Sales and Use Tax Act (§ 58.1-2400 et seq.) and upon the sale of which all
applicable motor vehicle sales and use taxes have been paid.

133 "Occasional sale" means a sale of tangible personal property not held or used by a seller in the 134 course of an activity for which it is required to hold a certificate of registration, including the sale or 135 exchange of all or substantially all the assets of any business and the reorganization or liquidation of 136 any business, provided that such sale or exchange is not one of a series of sales and exchanges 137 sufficient in number, scope and character to constitute an activity requiring the holding of a certificate of 138 registration.

"Open video system" means an open video system authorized pursuant to 47 U.S.C. § 573 and, for
purposes of this chapter only, also includes Internet service regardless of whether the provider of such
service is also a telephone common carrier.

"Person" includes any individual, firm, copartnership, cooperative, nonprofit membership corporation,
joint venture, association, corporation, estate, trust, business trust, trustee in bankruptcy, receiver,
auctioneer, syndicate, assignee, club, society, or other group or combination acting as a unit, body
politic or political subdivision, whether public or private, or quasi-public, and the plural of "person"
means the same as the singular.

147 "Prewritten program" means a computer program that is prepared, held or existing for general or
148 repeated sale or lease, including a computer program developed for in-house use and subsequently sold
149 or leased to unrelated third parties.

"Qualifying locality" means Charlotte County, Gloucester County, Halifax County, Henry County,
 Mecklenburg County, Northampton County, Patrick County, Pittsylvania County, or the City of Danville.
 "Railroad rolling stock" means locomotives, of whatever motive power, autocars, railroad cars of

152 Rainoad forming stock means locomotives, of whatever motive power, autocars, rainoad cars of every kind and description, and all other equipment determined by the Tax Commissioner to constitute railroad rolling stock.

"Remote seller" means any dealer deemed to have sufficient activity within the Commonwealth to require registration under § 58.1-613 under the criteria specified in subdivision C 10 or 11 of § 58.1-612 or any software provider acting on behalf of such dealer.

158 "Retail sale" or a "sale at retail" means a sale to any person for any purpose other than for resale in 159 the form of tangible personal property or services taxable under this chapter, and shall include any such 160 transaction as the Tax Commissioner upon investigation finds to be in lieu of a sale. All sales for resale 161 must be made in strict compliance with regulations applicable to this chapter. Any dealer making a sale 162 for resale which is not in strict compliance with such regulations shall be personally liable for payment 163 of the tax.

164 The terms "retail sale" and a "sale at retail" specifically include the following: (i) the sale or charges 165 for any accommodations furnished to transients for less than 90 continuous days; (ii) sales of tangible personal property to persons for resale when because of the operation of the business, or its very nature, 166 167 or the lack of a place of business in which to display a certificate of registration, or the lack of a place 168 of business in which to keep records, or the lack of adequate records, or because such persons are 169 minors or transients, or because such persons are engaged in essentially service businesses, or for any 170 other reason there is likelihood that the Commonwealth will lose tax funds due to the difficulty of 171 policing such business operations; (iii) the separately stated charge made for automotive refinish repair 172 materials that are permanently applied to or affixed to a motor vehicle during its repair; and (iv) the 173 separately stated charge for equipment available for lease or purchase by a provider of satellite television 174 programming to the customer of such programming. Equipment sold to a provider of satellite television 175 programming for subsequent lease or purchase by the customer of such programming shall be deemed a 176 sale for resale. The Tax Commissioner is authorized to promulgate regulations requiring vendors of or 177 sellers to such persons to collect the tax imposed by this chapter on the cost price of such tangible personal property to such persons and may refuse to issue certificates of registration to such persons. 178 179 The terms "retail sale" and a "sale at retail" also specifically include the separately stated charge made 180 for supplies used during automotive repairs whether or not there is transfer of title or possession of the supplies and whether or not the supplies are attached to the automobile. The purchase of such supplies 181

182 by an automotive repairer for sale to the customer of such repair services shall be deemed a sale for 183 resale.

184 The term "transient" does not include a purchaser of camping memberships, time-shares, 185 condominiums, or other similar contracts or interests that permit the use of, or constitute an interest in, 186 real estate, however created or sold and whether registered with the Commonwealth or not. Further, a 187 purchaser of a right or license which entitles the purchaser to use the amenities and facilities of a 188 specific real estate project on an ongoing basis throughout its term shall not be deemed a transient, 189 provided, however, that the term or time period involved is for seven years or more.

190 The terms "retail sale" and "sale at retail" do not include a transfer of title to tangible personal 191 property after its use as tools, tooling, machinery or equipment, including dies, molds, and patterns, if (i) 192 at the time of purchase, the purchaser is obligated, under the terms of a written contract, to make the 193 transfer and (ii) the transfer is made for the same or a greater consideration to the person for whom the 194 purchaser manufactures goods.

195 "Retailer" means every person engaged in the business of making sales at retail, or for distribution, 196 use, consumption, or storage to be used or consumed in the Commonwealth.

197 "Room charge" means the full retail price charged to the customer by the accommodations 198 intermediary for the use of the accommodations, including any accommodations fee, before taxes. 199 "Room charge" includes any fee, other than an accommodations fee, charged to the customer and 200 retained as compensation for facilitating the sale. The room charge shall be determined in accordance 201 with 23VAC10-210-730 and the related rulings of the Department on the same.

202 "Sale" means any transfer of title or possession, or both, exchange, barter, lease or rental, conditional 203 or otherwise, in any manner or by any means whatsoever, of tangible personal property and any rendition of a taxable service for a consideration, and includes the fabrication of tangible personal 204 property for consumers who furnish, either directly or indirectly, the materials used in fabrication, and 205 206 the furnishing, preparing, or serving for a consideration of any tangible personal property consumed on the premises of the person furnishing, preparing, or serving such tangible personal property. A 207 transaction whereby the possession of property is transferred but the seller retains title as security for the 208 209 payment of the price shall be deemed a sale.

210 "Sales price" means the total amount for which tangible personal property or services are sold, including any services that are a part of the sale, valued in money, whether paid in money or otherwise, 211 212 and includes any amount for which credit is given to the purchaser, consumer, or lessee by the dealer, 213 without any deduction therefrom on account of the cost of the property sold, the cost of materials used, 214 labor or service costs, losses or any other expenses whatsoever. "Sales price" does not include (i) any 215 cash discount allowed and taken; (ii) finance charges, carrying charges, service charges or interest from 216 credit extended on sales of tangible personal property under conditional sale contracts or other 217 conditional contracts providing for deferred payments of the purchase price; (iii) separately stated local 218 property taxes collected; (iv) that portion of the amount paid by the purchaser as a discretionary gratuity 219 added to the price of a meal; or (v) that portion of the amount paid by the purchaser as a mandatory 220 gratuity or service charge added by a restaurant to the price of a meal, but only to the extent that such 221 mandatory gratuity or service charge does not exceed 20 percent of the price of the meal. Where used 222 articles are taken in trade, or in a series of trades as a credit or part payment on the sale of new or used 223 articles, the tax levied by this chapter shall be paid on the net difference between the sales price of the 224 new or used articles and the credit for the used articles.

225 "Semiconductor cleanrooms" means the integrated systems, fixtures, piping, partitions, flooring, 226 lighting, equipment, and all other property used to reduce contamination or to control airflow, 227 temperature, humidity, vibration, or other environmental conditions required for the integrated process of 228 semiconductor manufacturing.

229 "Semiconductor equipment" means (i) machinery or tools or repair parts or replacements thereof; (ii) 230 the related accessories, components, pedestals, bases, or foundations used in connection with the operation of the equipment, without regard to the proximity to the equipment, the method of attachment, 231 232 or whether the equipment or accessories are affixed to the realty; (iii) semiconductor wafers and other 233 property or supplies used to install, test, calibrate or recalibrate, characterize, condition, measure, or 234 maintain the equipment and settings thereof; and (iv) equipment and supplies used for quality control 235 testing of product, materials, equipment, or processes; or the measurement of equipment performance or 236 production parameters regardless of where or when the quality control, testing, or measuring activity 237 takes place, how the activity affects the operation of equipment, or whether the equipment and supplies 238 come into contact with the product. 239

"Short-term rental" means the same as such term is defined in § 15.2-983.

240 "Storage" means any keeping or retention of tangible personal property for use, consumption or 241 distribution in the Commonwealth, or for any purpose other than sale at retail in the regular course of 242 business.

"Tangible personal property" means personal property that may be seen, weighed, measured, felt, or

touched, or is in any other manner perceptible to the senses. "Tangible personal property" does not include stocks, bonds, notes, insurance or other obligations or securities. "Tangible personal property" 244 245 246 includes (i) telephone calling cards upon their initial sale, which shall be exempt from all other state and 247 local utility taxes, and (ii) manufactured signs.

248 "Use" means the exercise of any right or power over tangible personal property incident to the 249 ownership thereof, except that it does not include the sale at retail of that property in the regular course 250 of business. "Use" does not include the exercise of any right or power, including use, distribution, or 251 storage, over any tangible personal property sold to a nonresident donor for delivery outside of the 252 Commonwealth to a nonresident recipient pursuant to an order placed by the donor from outside the 253 Commonwealth via mail or telephone. "Use" does not include any sale determined to be a gift 254 transaction, subject to tax under § 58.1-604.6.

255 "Use tax" refers to the tax imposed upon the use, consumption, distribution, and storage as defined in 256 this section.

257 "Used directly," when used in relation to manufacturing, processing, refining, or conversion, refers to 258 those activities that are an integral part of the production of a product, including all steps of an integrated manufacturing or mining process, but not including ancillary activities such as general maintenance or administration. When used in relation to mining, "used directly" refers to the activities 259 260 specified in this definition and, in addition, any reclamation activity of the land previously mined by the 261 262 mining company required by state or federal law.

263 "Video programmer" means a person that provides video programming to end-user subscribers.

264 "Video programming" means video and/or information programming provided by or generally 265 considered comparable to programming provided by a cable operator, including, but not limited to, 266 Internet service. 267

§ 58.1-612.2. Tax collectible from accommodations providers and intermediaries.

268 A. For any retail sale of accommodations not facilitated by an accommodations intermediary, the 269 accommodations provider shall collect the retail sales and use taxes imposed in accordance with this 270 chapter, computed on the total charges for the accommodations, and shall remit the same to the 271 Department and shall be liable for the same.

272 B. For any retail sale of accommodations facilitated by an accommodations intermediary, the 273 accommodations intermediary shall be deemed under this chapter as a dealer making a retail sale of an 274 accommodation. The accommodations intermediary shall collect the retail sales and use taxes imposed in 275 accordance with this chapter, computed on the room charge. When the accommodations are at a hotel, 276 the accommodations intermediary shall remit the taxes on the accommodations fee to the Department 277 and shall remit any remaining taxes to the hotel, which shall remit such taxes to the Department. When 278 the accommodations are at a short-term rental, as defined in § 15.2-983, or at any other 279 accommodations, the accommodations intermediary shall remit the taxes on the room charge to the 280 **Department**, and shall remit the same to the Department and shall be liable for the same.

281 C. An accommodations intermediary shall not be liable for retail sales and use taxes remitted to an 282 accommodations provider but that are not then remitted to the Department by the accommodations 283 provider. For any retail sale of accommodations facilitated by an accommodations intermediary, an 284 accommodations provider shall be liable for that portion of retail sales and use taxes that relates to the 285 discount room charge only to the extent that the accommodations intermediary has remitted such taxes 286 to the accommodations provider For any transaction for the retail sale of accommodations involving two 287 or more parties that meet the definition of accommodations intermediary, nothing in this section shall 288 prohibit such parties from making an agreement regarding which party shall be responsible for 289 collecting and remitting the tax, so long as the party so responsible is registered as a dealer with the 290 Department. In such event, the party agreeing to collect and remit the tax shall be the sole party liable 291 for the tax, and the other parties to such agreement shall not be liable for such tax.

292 D. For any retail sale of accommodations facilitated by an accommodations intermediary, nothing 293 herein shall relieve the accommodations provider from liability for retail sales and use taxes on any 294 amounts charged directly to the customer by the accommodations provider that are not collected by the 295 accommodations intermediary.

296 E. For any retail sale of accommodations not facilitated by an accommodations intermediary, the 297 accommodations provider shall separately state the amount of the tax on the bill, invoice, or similar 298 documentation and shall add the tax to the total charges charged to the transient by the accommodations 299 provider. For any retail sale of accommodations facilitated by an accommodations intermediary, the 300 accommodations intermediary shall separately state the amount of the tax on the bill, invoice, or similar 301 documentation and shall add the tax to the room charge; thereafter, such tax shall be a debt from the 302 customer to the accommodations intermediary, recoverable at law in the same manner as other debts.

303 § 58.1-3826. Scope of transient occupancy tax.

304 A. The transient occupancy tax imposed pursuant to the authority of this article shall be imposed 305 only for the use or possession of any room or space that is suitable or intended for occupancy by transients for dwelling, lodging, or sleeping purposes.

B. For any retail sale of accommodations not facilitated by an accommodations intermediary, the accommodations provider shall collect the tax imposed pursuant to this article, computed on the total price paid for the use or possession of the accommodations, and shall remit the same to the locality and shall be liable for the same.

311 C. For any retail sale of accommodations facilitated by an accommodations intermediary, the accommodations intermediary shall be deemed under this article as a facility making a retail sale of an 312 313 accommodation. The accommodations intermediary shall collect the tax imposed pursuant to this article, computed on the room charge. When the accommodations are at a hotel, the accommodations 314 315 intermediary shall remit the taxes on the accommodations fee to the locality and shall remit any remaining taxes to the hotel, which shall remit such taxes to the locality. When the accommodations are 316 317 at a short-term rental, as defined in § 15.2-983, or at any other accommodations, the accommodations 318 intermediary shall remit the taxes on the room charge to the locality, and shall remit the same to the 319 locality and shall be liable for the same.

320 D. An accommodations intermediary shall not be liable for taxes under this article remitted to an 321 accommodations provider but that are then not remitted to the locality by the accommodations provider. For any retail sale of accommodations facilitated by an accommodations intermediary, an 322 323 accommodations provider shall be liable for that portion of the taxes under this article that relate to the 324 discount room charge only to the extent that the accommodations intermediary has remitted such taxes 325 to the accommodations provider For any transaction for the retail sale of accommodations involving two 326 or more parties that meet the definition of accommodations intermediary, nothing in this section shall 327 prohibit such parties from making an agreement regarding which party shall be responsible for 328 collecting and remitting the tax, so long as the party so responsible is registered with the locality for 329 purposes of remitting the tax. In such event, the party that agrees to collect and remit the tax shall be 330 the sole party liable for the tax, and the other parties to such agreement shall not be liable for such tax.

331 E. In any retail sale of any accommodations in which an accommodations intermediary does not 332 facilitate the sale of the accommodations, the accommodations provider shall separately state the amount 333 of the tax in the bill, invoice, or similar documentation and shall add the tax to the total price paid for 334 the use or possession of the accommodations. In any retail sale of any accommodations in which an 335 accommodations intermediary facilitates the sale of the accommodation, the accommodations 336 intermediary shall separately state the amount of the tax on the bill, invoice, or similar documentation 337 and shall add the tax to the room charge; thereafter, such tax shall be a debt from the customer to the 338 accommodations intermediary, recoverable at law in the same manner as other debts.

339 2. That the provisions of the first enactment of this act shall become effective on October 1, 2022.

340 3. That the Department of Taxation shall develop and make publicly available guidelines no later 341 than August 1, 2022, for purposes of developing processes and procedures for implementing the 342 provisions of this act. The development, issuance, and publication of the guidelines shall be exempt

343 from the provisions of the Administrative Process Act (§ 2.2-4000 et seq. of the Code of Virginia).
