## Referred to Committee on Privileges and Elections

WHEREAS, a proposed amendment to the Constitution of Virginia, hereinafter set forth, was agreed 10 to by a majority of the members elected to each of the two houses of the General Assembly at the 11 special session I of 2021 and referred to this, the next regular session held after the 2021 general 12 election of members of the House of Delegates, as required by the Constitution of Virginia; now, 13 14 therefore, be it

15 RESOLVED by the House of Delegates, the Senate concurring, That the following amendment to the 16 Constitution of Virginia be, and the same hereby is, proposed in conformity with the provisions of Section 1 of Article XII of the Constitution of Virginia, namely: 17

Amend Section 1 of Article II of the Constitution of Virginia as follows: 18 19

ARTICLE II

## FRANCHISE AND OFFICERS

21 Section 1. Qualifications of voters.

22 (a) In elections by the people, the qualifications of voters shall be as follows: Each voter shall be a 23 citizen of the United States, shall be eighteen years of age, shall fulfill the residence requirements set 24 forth in this section subsection (b), and shall be registered to vote pursuant to this article. Every person 25 who meets these qualifications shall have the fundamental right to vote in the Commonwealth, and such 26 right shall not be abridged by law, except that:

27 (1) No person who has been convicted of a felony shall be qualified entitled to vote unless his eivil 28 rights have been restored by the Governor or other appropriate authority. during any period of 29 incarceration for such felony conviction, but every such person, upon release from incarceration for that felony conviction and without further action required of him, shall be invested with all political rights, 30 31 including the right to vote; and

32 As prescribed by law, no (2) No person who has been adjudicated to be mentally incompetent by a 33 court of competent jurisdiction to lack the capacity to understand the act of voting shall be qualified 34 *entitled* to vote *during such period of incapacity* until his <del>competency</del> *capacity* has been reestablished as 35 prescribed by law.

36 (b) The residence requirements shall be that each voter shall be a resident of the Commonwealth and of the precinct where he votes. Residence, for all purposes of qualification to vote, requires both domicile and a place of abode. The General Assembly may provide for persons who are employed 37 38 39 overseas, and their spouses and dependents residing with them, and who are qualified to vote except for 40 relinquishing their place of abode in the Commonwealth while overseas, to vote in the Commonwealth 41 subject to conditions and time limits defined by law. The General Assembly may provide for persons who are qualified to vote except for having moved their residence from one precinct to another within 42 the Commonwealth to continue to vote in a former precinct subject to conditions and time limits defined 43 by law. The General Assembly may also provide, in elections for President and Vice President of the 44 45 United States, alternatives to registration for new residents of the Commonwealth.

46 (c) Any person who will be qualified with respect to age to vote at the next general election shall be 47 permitted to register in advance and also to vote in any intervening primary or special election.
