11	Be it enacted by the General Assembly of Virginia:
12	1. That § 3 of Chapter 133 of the Acts of Assembly of 1966, as amended by the second enactment
13	of Chapter 541 and the second enactment of Chapter 557 of the Acts of Assembly of 2017, is
14 15	amended and reenacted as follows:
15 16	§ 3. "Chesapeake Airport Authority."
17	There is hereby created and constituted a political subdivision of the Commonwealth to be known as the "Chesapeake Airport Authority". The exercise by the Authority of the powers conferred by this act
18	in the construction, operation and maintenance of the project authorized by this act shall be deemed and
19	held to be the performance of an essential governmental function.
20	The Authority shall consist of seven members, all of whom shall be appointed by the council of the
2 1	city of Chesapeake. Four of the members of the Authority first appointed shall continue in office for
22	terms expiring on June thirty, nineteen hundred sixty-nine, and three for terms expiring on June thirty,
23	nineteen hundred sixty-eight the term of each such member to be designated by said council and to
24	continue until his successor shall be duly appointed and qualified. On and after July one, nineteen
25	hundred seventy-five, the membership of the Authority shall increase to nine members and there shall be
26	appointed by the city council two additional members, one of whom shall serve until June thirty,
27	nineteen hundred seventy-nine and the other to serve until June thirty, nineteen hundred seventy-eight.
28	The successor of each such member shall be appointed for a term of five years and until his successor
29 20	shall be duly appointed and qualified, except that any person appointed to fill a vacancy shall serve only
30 31	for the unexpired term. Any member of the Authority shall be eligible for reappointment; however, after
31 32	July 1, 2017, no member shall serve more than two consecutive terms. Any person who has served more than one and one-half terms as a member of the Authority as of July 1, 2017, shall not be eligible for
32	reappointment for another consecutive term. A member of the Authority shall serve at the pleasure of
33 34	the city council of the City of Chesapeake. No Authority member shall work for the Authority within
35	one year after serving as a member. Members of the Authority shall be subject to removal from office
36	in like manner as are State, county, town and district officers under the provisions of §§ 15.1-63 to
37	15.1-66, inclusive, of the Code of Virginia. The Authority shall annually elect one of its members as
38	chairman and another as vice-chairman and shall also elect annually a secretary-treasurer, who may or
39	may not be a member of the Authority.
40	The secretary-treasurer shall keep a record of the proceedings of the Authority and shall be custodian
41	of all books, documents and papers filed with the Authority and of the minute book or journal of the
42	Authority and of its official seal. He shall have authority to cause copies to be made of all minutes and
43	other records and documents of the Authority and to give certificates under the official seal of the
44 45	Authority to the effect that such copies are true copies, and all persons dealing with the Authority may
45	rely upon such certificates.
46 47	Five members of the Authority shall constitute a quorum and the affirmative vote of five members shall be necessary for any action taken by the Authority. No vacancy in the membership of the
47 48	shall be necessary for any action taken by the Authority. No vacancy in the membership of the Authority shall impair the right of a quorum to exercise all the rights and perform all the duties of the
40 49	Authority.
5 0	Before the issuance of any revenue bonds under the provisions of this act the secretary-treasurer of
51	the Authority shall execute a surety bond in the penal sum of fifty thousand dollars, such surety bond to
52	be conditioned upon the faithful performance of the duties of his office, to be executed by a surety
53	company authorized to transact business in the Commonwealth as surety and to be approved by the
54	Attorney General and filed in the office of the Secretary of the Commonwealth.
55	The members of the Authority shall be entitled to reimbursement for their expenses incurred in
54	Attorney General and filed in the office of the Secretary of the Commonwealth.
