11	Be it enacted by the General Assembly of Virginia:
12	1. That the Code of Virginia is amended by adding a section numbered 23.1-610.2 as follows:
13	§ 23.1-610.2. Comprehensive community colleges; conditionally forgivable loans for tuition and
14 15	other fees and expenses. A. Each comprehensive community college shall establish a process whereby admitted students may
15 16	apply for a conditionally forgivable loan in an amount sufficient to cover the full cost of tuition,
17	mandatory fees, and required textbooks or other course materials to earn a certain degree or credential
18	at such college. Any such student applicant is entitled to such a conditionally forgivable loan from the
19	comprehensive community college if the student applicant:
20	1. Demonstrates that the student applicant is a single parent of a dependent child or dependent
21	children and has a total household income that is not more than 250 percent of the current annual
22	federal poverty guidelines established by the U.S. Department of Health and Human Services;
23	2. Signs an agreement to (i) pursue a field of study that leads to a high-demand occupation
24 25	identified by the Virginia Office of Education Economics on its high-demand occupations list, (ii) earn
25 26	within 30 months of initial enrollment at the comprehensive community college a degree or credential that leads to such a high-demand occupation, and (iii) maintain employment in the Commonwealth in
27 27	such a high-demand occupation for at least five years during the seven-year period that begins on the
28	date on which the student applicant earns such a degree or credential; and
29	3. Signs a promissory note to repay the full amount of the loan in a lump sum, without interest, 84
30	months from the date on which the student applicant fails to meet any condition of the agreement signed
31	pursuant to subdivision 2.
32	B. Each comprehensive community college shall forgive the full amount of any loan made pursuant
33	to subsection A on the date on which the recipient demonstrates full satisfaction of the conditions of the
34 35	agreement signed pursuant to subdivision A 2, as determined by the Office of the Attorney General. C. Any comprehensive community college that forgives a loan pursuant to the provisions of
