2 An Act to amend and reenact §§ 59.1-335.2 and 59.1-335.7 of the Code of Virginia, relating to Virginia
3 Credit Services Businesses Act; definitions; credit reports.

6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That §§ 59.1-335.2 and 59.1-335.7 of the Code of Virginia are amended and reenacted as**
8 **follows:**

9 **§ 59.1-335.2. Definitions.**

10 In this chapter the following words have the following meanings:

11 "Attorney General" means the Office of the Attorney General of Virginia.

12 "Commissioner" means the Commissioner of Agriculture and Consumer Services, or a member of his
13 staff to whom he may delegate his duties under this chapter.

14 "Consumer" means any individual who is solicited to purchase or who purchases the services of a
15 credit services business.

16 "Consumer report" means any written, oral, or other communication of any information by a
17 consumer reporting agency bearing on a consumer's creditworthiness, credit standing, credit capacity,
18 character, general reputation, personal characteristics, or mode of living which (i) is furnished or (ii) is
19 used or expected to be used or collected in whole or in part for the purpose of serving as a factor in
20 establishing the consumer's eligibility for:

21 1. Credit or insurance to be used primarily for personal, family, or household purposes; or

22 2. Employment purposes; or

23 3. Other purposes which shall be limited to the following circumstances:

24 a. In response to the order of a court having jurisdiction to issue the order.

25 b. In accordance with the written instructions of the consumer to whom the report relates.

26 c. To a person which the agency has reason to believe:

27 (i) Intends to use the information in connection with a credit transaction involving the consumer on
28 whom the information is to be furnished and involving the extension of credit to or review or collection
29 of an account of, the consumer; or

30 (ii) Intends to use the information for employment purposes; or

31 (iii) Intends to use the information in connection with the underwriting of insurance involving the
32 consumer; or

33 (iv) Intends to use the information in connection with a determination of the consumer's eligibility
34 for a license or other benefit granted by a governmental instrumentality required by law to consider an
35 applicant's financial responsibility or status; or

36 (v) Otherwise has a legitimate business need for the information in connection with a business
37 transaction involving the consumer.

38 The term "consumer report" does not include:

39 1. Any report containing information solely as to transactions or experiences between the consumer
40 and the person making the report;

41 2. Any authorization or approval of a specific extension of credit directly or indirectly by the issuer
42 of a credit card or similar device; or

43 3. Any report in which a person who has been requested by a third party to make a specific
44 extension of credit directly or indirectly to a consumer conveys his decision with respect to the request,
45 if the third party advises the consumer of the name and address of the person to whom the request was
46 made and the person makes the disclosures to the consumer as to the exact nature of the request and the
47 effect of the report on its decision to extend credit.

48 "Consumer reporting agency" means any person ~~which~~ *that*, for monetary fees, dues, or on a
49 cooperative nonprofit basis, regularly engages in whole or in part in the practice of assembling or
50 evaluating consumer credit information or other information on consumers for the purpose of furnishing
51 consumer reports to third parties; and ~~which~~ *that* uses any means or facility of commerce for the
52 purpose of preparing or furnishing consumer reports. "Consumer reporting agency" does not include a
53 private ~~detective or~~ investigator ~~licensed~~ *registered* under the provisions of Article 4 (§ 9.1-138 et seq.)
54 of Chapter 1 of Title 9.1.

55 "Credit services business" means any person ~~who~~ *that*, with respect to the extension of credit by
56 others, sells, provides, or performs, or represents that such person can or will sell, provide, or perform,

57 any of the following services in return for the payment of money or other valuable consideration:

- 58 1. Improving a consumer's credit record, history, or rating;
- 59 2. Obtaining an extension of credit for a consumer; or
- 60 3. Providing advice or assistance to a consumer with regard to either subdivision 1 or 2 herein.

61 "Credit services business" does not include:

62 (i) ~~The making, arranging, or negotiating for a loan or extension~~ *Any person authorized to make,*
63 *arrange, or negotiate loans or extensions* of credit under the laws of ~~this~~ *the* Commonwealth or the
64 United States;

65 (ii) Any bank, trust company, savings bank, or savings institution whose deposits or accounts are
66 eligible for insurance by the Federal Deposit Insurance Corporation or other federal insurance agency, or
67 any credit union organized and chartered under the laws of ~~this~~ *the* Commonwealth or the United States;

68 (iii) Any nonprofit organization exempt from taxation under § 501(c) (3) of the Internal Revenue
69 Code (26 U.S.C. § 501(c) (3));

70 (iv) Any person licensed as a real estate broker by ~~this~~ *the* Commonwealth where the person is
71 acting within the course and scope of that license;

72 (v) Any person licensed to practice law in ~~this~~ *the* Commonwealth where the person renders services
73 within the course and scope of that person's practice as a lawyer;

74 (vi) Any broker-dealer registered with the Securities and Exchange Commission or the Commodity
75 Futures Trading Commission where the broker-dealer is acting within the course and scope of that
76 regulation;

77 (vii) Any consumer reporting agency as defined in the Federal Fair Credit Reporting Act (15 U.S.C.
78 ~~§§ 1681-1681v~~ § 1681 *et seq.*); or

79 (viii) Any person selling personal, family, or household goods to a consumer who, in connection
80 with the seller's sale of its goods to the consumer, assists the consumer in obtaining a loan or extension
81 of credit or extends credit to the consumer.

82 "Extension of credit" means the right to defer payment of debt or to incur debt and defer its
83 payment, offered or granted primarily for personal, family, or household purposes.

84 "File" when used in connection with information on any consumer, means all of the information on
85 that consumer recorded and retained by a consumer reporting agency regardless of how the information
86 is stored.

87 "Investigative consumer report" means a consumer report or portion of it in which information on a
88 consumer's character, general reputation, personal characteristics, or mode of living is obtained through
89 personal interviews with neighbors, friends, or associates of the consumer reported on or with others
90 with whom he is acquainted or who may have knowledge concerning any items of information.
91 However, the information does not include specific factual information on a consumer's credit record
92 obtained directly from a creditor of the consumer or from a consumer reporting agency when the
93 information was obtained directly from a creditor of the consumer or from the consumer.

94 "Person" includes an individual, corporation, government or governmental subdivision or agency,
95 business trust, estate, trust, partnership, association, two or more persons having a joint or common
96 interest, and any other legal or commercial entity.

97 **§ 59.1-335.7. Contents of information statement.**

98 The information statement required under § 59.1-335.6 of ~~this chapter~~ shall include all of the
99 following:

100 1. a. A complete and accurate statement of the consumer's right to review any file on the consumer
101 maintained by any consumer reporting agency, and the right of the consumer to receive a copy of a
102 consumer report containing all information in that file as provided under the Federal Fair Credit
103 Reporting Act (15 U.S.C. § 1681g);

104 b. *A complete and accurate statement of the consumer's right to receive a free copy of the*
105 *consumer's credit report every 12 months from each of the three nationwide consumer reporting*
106 *agencies, including identification of the website and toll-free telephone number through which the free*
107 *report may be obtained, as provided under the Federal Fair Credit Reporting Act (15 U.S.C. § 1681j);*

108 c. A complete and accurate statement that a copy of the consumer report containing all information
109 in the consumer's file will be furnished free of charge by the consumer reporting agency if requested by
110 the consumer within ~~30~~ 60 days of receiving a notice of a denial of credit as provided under the Federal
111 Fair Credit Reporting Act (15 U.S.C. § 1681j); and

112 e- d. *A complete and accurate statement that a nominal charge may be imposed on the consumer by*
113 *the consumer reporting agency for a copy of the consumer report containing all information in the*
114 *consumer's file, if the consumer has already obtained the free credit report to which the consumer is*
115 *entitled on an annual basis and the consumer has not been denied credit within ~~30~~ 60 days from receipt*
116 *of the consumer's request;*

117 2. A complete and accurate statement of the consumer's right to dispute the completeness or accuracy

118 of any item contained in any file on the consumer that is maintained by any consumer reporting agency,
119 as provided under the Federal Fair Credit Reporting Act (15 U.S.C. § 1681i);

120 3. A complete and detailed description of the services to be performed by the credit services business
121 for or on behalf of the consumer, and the total amount the consumer will have to pay, or become
122 obligated to pay, for the services. Such statement shall include the following notice in at least 10-point
123 bold type:

124 IMPORTANT NOTICE:

125 YOU HAVE NO OBLIGATION TO PAY ANY FEES OR CHARGES UNTIL ALL SERVICES
126 HAVE BEEN PERFORMED COMPLETELY FOR YOU, UNLESS YOU ENTER INTO A
127 SUBSCRIPTION AGREEMENT REQUIRING PERIODIC PAYMENTS IN CONSIDERATION FOR
128 ONGOING SERVICES.

129 ; and

130 4. The notice prescribed by subdivision 3 of ~~this section~~ shall also be posted by means of a
131 conspicuous sign so as to be readily noticeable and readable at the location within the premises of the
132 credit services business where consumers are interviewed by personnel of the business.
