(Effective until date pursuant to Va. Const., Art. IV, § 13) Virginia taxable income: subtractions. 12 13 In computing Virginia taxable income pursuant to § 58.1-322, to the extent included in federal 14 adjusted gross income, there shall be subtracted: 15 1. Income derived from obligations, or on the sale or exchange of obligations, of the United States and on obligations or securities of any authority, commission, or instrumentality of the United States to 16 17 the extent exempt from state income taxes under the laws of the United States, including, but not limited to, stocks, bonds, treasury bills, and treasury notes but not including interest on refunds of 18 19 federal taxes, interest on equipment purchase contracts, or interest on other normal business transactions. 20 2. Income derived from obligations, or on the sale or exchange of obligations, of the Commonwealth 21 or of any political subdivision or instrumentality of the Commonwealth. 22 3. Benefits received under Title II of the Social Security Act and other benefits subject to federal 23 income taxation solely pursuant to § 86 of the Internal Revenue Code. 4. Up to \$20,000 of disability income, as defined in § 22(c)(2)(B)(iii) of the Internal Revenue Code; 24 25 however, any person who claims a deduction under subdivision 5 of § 58.1-322.03 may not also claim a subtraction under this subdivision. 26 27 5. The amount of any refund or credit for overpayment of income taxes imposed by the 28 Commonwealth or any other taxing jurisdiction. 6. The amount of wages or salaries eligible for the federal Work Opportunity Credit which was not 29 30 deducted for federal purposes on account of the provisions of § 280C(a) of the Internal Revenue Code. 7. Any amount included therein less than \$600 from a prize awarded by the Virginia Lottery. 31 32 8. The wages or salaries received by any person for active and inactive service in the National Guard of the Commonwealth of Virginia, (i) for taxable years beginning before January 1, 2023, not to exceed the amount of income derived from 39 calendar days of such service or \$3,000, whichever amount is 33 34 35 less; however, only those persons in the ranks of O3 and below shall be entitled to the deductions 36 specified in this clause, and (ii) for taxable years beginning on or after January 1, 2023, not to exceed 37 the amount of income derived from 39 calendar days of such service or \$3,000 \$5,000, whichever 38 amount is less; however, only those persons in the ranks of  $\Theta 3$  O6 and below shall be entitled to the 39 deductions specified in this subdivision clause. 40 9. Amounts received by an individual, not to exceed \$1,000 for taxable years beginning on or before 41 December 31, 2019, and \$5,000 for taxable years beginning on or after January 1, 2020, as a reward for information provided to a law-enforcement official or agency, or to a nonprofit corporation created 42 exclusively to assist such law-enforcement official or agency, in the apprehension and conviction of 43 44 perpetrators of crimes. This subdivision shall not apply to the following: an individual who is an employee of, or under contract with, a law-enforcement agency, a victim or the perpetrator of the crime 45 for which the reward was paid, or any person who is compensated for the investigation of crimes or 46 47 accidents. **48** 10. The amount of "qualified research expenses" or "basic research expenses" eligible for deduction for federal purposes, but which were not deducted, on account of the provisions of § 280C(c) of the 49 50 Internal Revenue Code and which shall be available to partners, shareholders of S corporations, and 51 members of limited liability companies to the extent and in the same manner as other deductions may pass through to such partners, shareholders, and members. 52 53 11. Any income received during the taxable year derived from a qualified pension, profit-sharing, or 54 stock bonus plan as described by § 401 of the Internal Revenue Code, an individual retirement account or annuity established under § 408 of the Internal Revenue Code, a deferred compensation plan as 55 defined by § 457 of the Internal Revenue Code, or any federal government retirement program, the 56 contributions to which were deductible from the taxpayer's federal adjusted gross income, but only to the 57 extent the contributions to such plan or program were subject to taxation under the income tax in 58 59 another state.

60 12. Any income attributable to a distribution of benefits or a refund from a prepaid tuition contract or savings trust account with the Virginia College Savings Plan, created pursuant to Chapter 7 61 (§ 23.1-700 et seq.) of Title 23.1. The subtraction for any income attributable to a refund shall be 62 63 limited to income attributable to a refund in the event of a beneficiary's death, disability, or receipt of a 64 scholarship.

13. All military pay and allowances, to the extent included in federal adjusted gross income and not 65 66 otherwise subtracted, deducted, or exempted under this section, earned by military personnel while serving by order of the President of the United States with the consent of Congress in a combat zone or 67 qualified hazardous duty area that is treated as a combat zone for federal tax purposes pursuant to § 112 68 69 of the Internal Revenue Code.

For taxable years beginning before January 1, 2015, the gain derived from the sale or exchange 71 of real property or the sale or exchange of an easement to real property which results in the real 72 property or the easement thereto being devoted to open-space use, as that term is defined in § 58.1-3230, for a period of time not less than 30 years. To the extent that a subtraction is taken in accordance with 73 74 this subdivision, no tax credit under this chapter for donating land for its preservation shall be allowed for three years following the year in which the subtraction is taken. 75

15. Fifteen thousand dollars of military basic pay for military service personnel on extended active 76 duty for periods in excess of 90 days; however, the subtraction amount shall be reduced dollar-for-dollar 77 78 by the amount by which the taxpayer's military basic pay exceeds \$15,000 and shall be reduced to zero 79 if such military basic pay amount is equal to or exceeds \$30,000.

16. The first \$15,000 of salary for each federal and state employee whose total annual salary from all 80 81 employment for the taxable year is \$15,000 or less.

17. Unemployment benefits taxable pursuant to § 85 of the Internal Revenue Code.

18. a. Any amount received as military retirement income by an individual awarded the 83 84 Congressional Medal of Honor.

85 b. For taxable years beginning on and after January 1, 2022, but before January 1, 2023, up to 86 \$10,000 of military benefits; for taxable years beginning on and after January 1, 2023, but before 87 January 1, 2024, up to \$20,000 of military benefits; for taxable years beginning on and after January 1, 2024, but before January 1, 2025, up to \$30,000 of military benefits; and for taxable years beginning on 88 89 and after January 1, 2025, up to \$40,000 of military benefits. For purposes of this subdivision b, "military benefits" means any (i) military retirement income received for service in the Armed Forces of 90 the United States, (ii) qualified military benefits received pursuant to § 134 of the Internal Revenue 91 92 Code, (iii) benefits paid to the surviving spouse of a veteran of the Armed Forces of the United States 93 under the Survivor Benefit Plan program established by the U.S. Department of Defense, and (iv) military benefits paid to the surviving spouse of a veteran of the Armed Forces of the United States. 94 95 The subtraction allowed by this subdivision b shall be allowed only for military benefits received by an 96 individual age 55 or older. No subtraction shall be allowed pursuant to this subdivision b if a credit, 97 exemption, subtraction, or deduction is claimed for the same income pursuant to subdivision a or any 98 other provision of Virginia or federal law.

99 19. Items of income attributable to, derived from, or in any way related to (i) assets stolen from, 100 hidden from, or otherwise lost by an individual who was a victim or target of Nazi persecution or (ii) damages, reparations, or other consideration received by a victim or target of Nazi persecution to 101 102 compensate such individual for performing labor against his will under the threat of death, during World War II and its prelude and direct aftermath. This subtraction shall not apply to assets acquired with such 103 104 items of income or with the proceeds from the sale of assets stolen from, hidden from, or otherwise lost 105 to, during World War II and its prelude and direct aftermath, a victim or target of Nazi persecution. The 106 provisions of this subdivision shall only apply to an individual who was the first recipient of such items of income and who was a victim or target of Nazi persecution, or a spouse, surviving spouse, or child 107 108 or stepchild of such victim. 109

As used in this subdivision:

110 "Nazi regime" means the country of Nazi Germany, areas occupied by Nazi Germany, those European countries allied with Nazi Germany, or any other neutral European country or area in Europe 111 112 under the influence or threat of Nazi invasion.

"Victim or target of Nazi persecution" means any individual persecuted or targeted for persecution by 113 114 the Nazi regime who had assets stolen from, hidden from, or otherwise lost as a result of any act or omission in any way relating to (i) the Holocaust, (ii) World War II and its prelude and direct aftermath, 115 116 (iii) transactions with or actions of the Nazi regime, (iv) treatment of refugees fleeing Nazi persecution, or (v) the holding of such assets by entities or persons in the Swiss Confederation during World War II 117 and its prelude and aftermath. A "victim or target of Nazi persecution" also includes any individual 118 119 forced into labor against his will, under the threat of death, during World War II and its prelude and 120 direct aftermath.

121 20. The military death gratuity payment made after September 11, 2001, to the survivor of deceased

military personnel killed in the line of duty, pursuant to 10 U.S.C. Chapter 75; however, the subtraction amount shall be reduced dollar-for-dollar by the amount that the survivor may exclude from his federal gross income in accordance with § 134 of the Internal Revenue Code.

125 21. The death benefit payments from an annuity contract that are received by a beneficiary of such contract, provided that (i) the death benefit payment is made pursuant to an annuity contract with an insurance company and (ii) the death benefit payment is paid solely by lump sum. The subtraction under this subdivision shall be allowed only for that portion of the death benefit payment that is included in federal adjusted gross income.

22. Any gain recognized from the sale of launch services to space flight participants, as defined in
49 U.S.C. § 70102, or launch services intended to provide individuals with the training or experience of
a launch, without performing an actual launch. To qualify for a deduction under this subdivision, launch
services must be performed in Virginia or originate from an airport or spaceport in Virginia.

134 23. Any gain recognized as a result of resupply services contracts for delivering payload, as defined
135 in 49 U.S.C. § 70102, entered into with the Commercial Orbital Transportation Services division of the
136 National Aeronautics and Space Administration or other space flight entity, as defined in § 8.01-227.8,
137 and launched from an airport or spaceport in Virginia.

138 24. Any income taxed as a long-term capital gain for federal income tax purposes, or any income 139 taxed as investment services partnership interest income (otherwise known as investment partnership 140 carried interest income) for federal income tax purposes. To qualify for a subtraction under this 141 subdivision, such income shall be attributable to an investment in a "qualified business," as defined in 142 § 58.1-339.4, or in any other technology business approved by the Secretary of Administration, provided 143 that the business has its principal office or facility in the Commonwealth and less than \$3 million in 144 annual revenues in the fiscal year prior to the investment. To qualify for a subtraction under this subdivision, the investment shall be made between the dates of April 1, 2010, and June 30, 2020. No 145 taxpayer who has claimed a tax credit for an investment in a "qualified business" under § 58.1-339.4 146 147 shall be eligible for the subtraction under this subdivision for an investment in the same business.

148 25. For taxable years beginning on and after January 1, 2014, any income of an account holder for
149 the taxable year taxed as (i) a capital gain for federal income tax purposes attributable to such person's
150 first-time home buyer savings account established pursuant to Chapter 12 (§ 36-171 et seq.) of Title 36
151 and (ii) interest income or other income for federal income tax purposes attributable to such person's
152 first-time home buyer savings account.

153 Notwithstanding the statute of limitations on assessments contained in § 58.1-312, any subtraction 154 taken under this subdivision shall be subject to recapture in the taxable year or years in which moneys 155 or funds withdrawn from the first-time home buyer savings account were used for any purpose other 156 than the payment of eligible costs by or on behalf of a qualified beneficiary, as provided under 157 § 36-174. The amount subject to recapture shall be a portion of the amount withdrawn in the taxable 158 year that was used for other than the payment of eligible costs, computed by multiplying the amount 159 withdrawn and used for other than the payment of eligible costs by the ratio of the aggregate earnings in 160 the account at the time of the withdrawal to the total balance in the account at such time.

However, recapture shall not apply to the extent of moneys or funds withdrawn that were (i)
withdrawn by reason of the qualified beneficiary's death or disability; (ii) a disbursement of assets of the
account pursuant to a filing for protection under the United States Bankruptcy Code, 11 U.S.C. §§ 101
through 1330; or (iii) transferred from an account established pursuant to Chapter 12 (§ 36-171 et seq.)
of Title 36 into another account established pursuant to such chapter for the benefit of another qualified
beneficiary.

167 For purposes of this subdivision, "account holder," "eligible costs," "first-time home buyer savings account," and "qualified beneficiary" mean the same as those terms are defined in § 36-171.

169 26. For taxable years beginning on and after January 1, 2015, any income for the taxable year
170 attributable to the discharge of a student loan solely by reason of the student's death. For purposes of
171 this subdivision, "student loan" means the same as that term is defined under § 108(f) of the Internal
172 Revenue Code.

173 27. a. Income, including investment services partnership interest income (otherwise known as 174 investment partnership carried interest income), attributable to an investment in a Virginia venture 175 capital account. To qualify for a subtraction under this subdivision, the investment shall be made on or 176 after January 1, 2018, but before December 31, 2023. No subtraction shall be allowed under this 177 subdivision for an investment in a company that is owned or operated by a family member or an 178 affiliate of the taxpayer. No subtraction shall be allowed under this subdivision for a taxpayer who has 179 claimed a subtraction under subdivision 24 or a tax credit under § 58.1-339.4 for the same investment.

180 b. As used in this subdivision 27:

181 "Qualified portfolio company" means a company that (i) has its principal place of business in the182 Commonwealth; (ii) has a primary purpose of production, sale, research, or development of a product or

183 service other than the management or investment of capital; and (iii) provides equity in the company to the Virginia venture capital account in exchange for a capital investment. "Qualified portfolio company" 184 185 does not include a company that is an individual or sole proprietorship.

186 "Virginia venture capital account" means an investment fund that has been certified by the 187 Department as a Virginia venture capital account. In order to be certified as a Virginia venture capital 188 account, the operator of the investment fund shall register the investment fund with the Department prior 189 to December 31, 2023, (i) indicating that it intends to invest at least 50 percent of the capital committed 190 to its fund in qualified portfolio companies and (ii) providing documentation that it employs at least one investor who has at least four years of professional experience in venture capital investment or 191 substantially equivalent experience. "Substantially equivalent experience" includes, but is not limited to, 192 193 an undergraduate degree from an accredited college or university in economics, finance, or a similar field of study. 200 28. a. Income attributable to an investment in a Virginia real estate investment trust. To qualify for a 201 subtraction under this subdivision, the investment shall be made on or after January 1, 2019, but before 202 December 31, 2024. No subtraction shall be allowed for an investment in a trust that is managed by a 203 family member or an affiliate of the taxpayer. No subtraction shall be allowed under this subdivision for 204 a taxpayer who has claimed a subtraction under subdivision 24 or 27 or a tax credit under § 58.1-339.4 205 for the same investment. 206

b. As used in this subdivision 28:

207 "Distressed" means satisfying the criteria applicable to a locality described in subdivision E 2 of 208 § 2.2-115.

209 "Double distressed" means satisfying the criteria applicable to a locality described in subdivision E 3 210 of § 2.2-115.

211 "Virginia real estate investment trust" means a real estate investment trust, as defined in 26 U.S.C. 212 § 856, that has been certified by the Department as a Virginia real estate investment trust. In order to be 213 certified as a Virginia real estate investment trust, the trustee shall register the trust with the Department 214 prior to December 31, 2024, indicating that it intends to invest at least 90 percent of trust funds in 215 Virginia and at least 40 percent of trust funds in real estate in localities that are distressed or double 216 distressed. If the Department determines that the trust satisfies the preceding criteria, the Department 217 shall certify the trust as a Virginia real estate investment trust at such time as the trust actually invests 218 at least 90 percent of trust funds in Virginia and at least 40 percent of trust funds in real estate in 219 localities that are distressed or double distressed.

220 29. For taxable years beginning on and after January 1, 2019, any gain recognized from the taking of 221 real property by condemnation proceedings.

30. For taxable years beginning before January 1, 2021, up to \$100,000 of all grant funds received 222 223 by the taxpayer under the Rebuild Virginia program established by the Governor and administered by 224 the Department of Small Business and Supplier Diversity.

31. For taxable years beginning on and after January 1, 2022, any compensation for wrongful 225 226 incarceration awarded pursuant to the procedures established under Article 18.2 (§ 8.01-195.10 et seq.) 227 of Chapter 3 of Title 8.01.

329 under the influence or threat of Nazi invasion.

330 "Victim or target of Nazi persecution" means any individual persecuted or targeted for persecution by 331 the Nazi regime who had assets stolen from, hidden from, or otherwise lost as a result of any act or 332 omission in any way relating to (i) the Holocaust, (ii) World War II and its prelude and direct aftermath, 333 (iii) transactions with or actions of the Nazi regime, (iv) treatment of refugees fleeing Nazi persecution, 334 or (v) the holding of such assets by entities or persons in the Swiss Confederation during World War II and its prelude and aftermath. A "victim or target of Nazi persecution" also includes any individual 335 336 forced into labor against his will, under the threat of death, during World War II and its prelude and 337 direct aftermath.

20. The military death gratuity payment made after September 11, 2001, to the survivor of deceased
military personnel killed in the line of duty, pursuant to 10 U.S.C. Chapter 75; however, the subtraction amount shall be reduced dollar-for-dollar by the amount that the survivor may exclude from his federal gross income in accordance with § 134 of the Internal Revenue Code.

342 21. The death benefit payments from an annuity contract that are received by a beneficiary of such
343 contract, provided that (i) the death benefit payment is made pursuant to an annuity contract with an
344 insurance company and (ii) the death benefit payment is paid solely by lump sum. The subtraction under
345 this subdivision shall be allowed only for that portion of the death benefit payment that is included in
346 federal adjusted gross income.

347 22. Any gain recognized from the sale of launch services to space flight participants, as defined in
348 49 U.S.C. § 70102, or launch services intended to provide individuals with the training or experience of
a launch, without performing an actual launch. To qualify for a deduction under this subdivision, launch
350 services must be performed in Virginia or originate from an airport or spaceport in Virginia.

351 23. Any gain recognized as a result of resupply services contracts for delivering payload, as defined
352 in 49 U.S.C. § 70102, entered into with the Commercial Orbital Transportation Services division of the
353 National Aeronautics and Space Administration or other space flight entity, as defined in § 8.01-227.8,
354 and launched from an airport or spaceport in Virginia.

355 24. Any income taxed as a long-term capital gain for federal income tax purposes, or any income 356 taxed as investment services partnership interest income (otherwise known as investment partnership carried interest income) for federal income tax purposes. To qualify for a subtraction under this 357 358 subdivision, such income shall be attributable to an investment in a "qualified business," as defined in 359 § 58.1-339.4, or in any other technology business approved by the Secretary of Administration, provided 360 that the business has its principal office or facility in the Commonwealth and less than \$3 million in 361 annual revenues in the fiscal year prior to the investment. To qualify for a subtraction under this subdivision, the investment shall be made between the dates of April 1, 2010, and June 30, 2020. No 362 taxpayer who has claimed a tax credit for an investment in a "qualified business" under § 58.1-339.4 363 shall be eligible for the subtraction under this subdivision for an investment in the same business. 364

365 25. For taxable years beginning on and after January 1, 2014, any income of an account holder for
366 the taxable year taxed as (i) a capital gain for federal income tax purposes attributable to such person's
367 first-time home buyer savings account established pursuant to Chapter 12 (§ 36-171 et seq.) of Title 36

368 and (ii) interest income or other income for federal income tax purposes attributable to such person's 369 first-time home buyer savings account.

370 Notwithstanding the statute of limitations on assessments contained in § 58.1-312, any subtraction 371 taken under this subdivision shall be subject to recapture in the taxable year or years in which moneys 372 or funds withdrawn from the first-time home buyer savings account were used for any purpose other 373 than the payment of eligible costs by or on behalf of a qualified beneficiary, as provided under 374 § 36-174. The amount subject to recapture shall be a portion of the amount withdrawn in the taxable 375 year that was used for other than the payment of eligible costs, computed by multiplying the amount 376 withdrawn and used for other than the payment of eligible costs by the ratio of the aggregate earnings in 377 the account at the time of the withdrawal to the total balance in the account at such time.

378 However, recapture shall not apply to the extent of moneys or funds withdrawn that were (i) 379 withdrawn by reason of the qualified beneficiary's death or disability; (ii) a disbursement of assets of the 380 account pursuant to a filing for protection under the United States Bankruptcy Code, 11 U.S.C. §§ 101 381 through 1330; or (iii) transferred from an account established pursuant to Chapter 12 (§ 36-171 et seq.) 382 of Title 36 into another account established pursuant to such chapter for the benefit of another qualified 383 beneficiary.

384 For purposes of this subdivision, "account holder," "eligible costs," "first-time home buyer savings 385 account," and "qualified beneficiary" mean the same as those terms are defined in § 36-171.

386 26. For taxable years beginning on and after January 1, 2015, any income for the taxable year 387 attributable to the discharge of a student loan solely by reason of the student's death. For purposes of 388 this subdivision, "student loan" means the same as that term is defined under § 108(f) of the Internal 389 Revenue Code.

390 27. a. Income, including investment services partnership interest income (otherwise known as 391 investment partnership carried interest income), attributable to an investment in a Virginia venture 392 capital account. To qualify for a subtraction under this subdivision, the investment shall be made on or 393 after January 1, 2018, but before December 31, 2023. No subtraction shall be allowed under this 394 subdivision for an investment in a company that is owned or operated by a family member or an 395 affiliate of the taxpayer. No subtraction shall be allowed under this subdivision for a taxpayer who has 396 claimed a subtraction under subdivision 24 or a tax credit under § 58.1-339.4 for the same investment. 397

b. As used in this subdivision 27:

398 "Qualified portfolio company" means a company that (i) has its principal place of business in the 399 Commonwealth; (ii) has a primary purpose of production, sale, research, or development of a product or 400 service other than the management or investment of capital; and (iii) provides equity in the company to 401 the Virginia venture capital account in exchange for a capital investment. "Qualified portfolio company" 402 does not include a company that is an individual or sole proprietorship.

"Virginia venture capital account" means an investment fund that has been certified by the 403 404 Department as a Virginia venture capital account. In order to be certified as a Virginia venture capital 405 account, the operator of the investment fund shall register the investment fund with the Department prior 406 to December 31, 2023, (i) indicating that it intends to invest at least 50 percent of the capital committed 407 to its fund in qualified portfolio companies and (ii) providing documentation that it employs at least one 408 investor who has at least four years of professional experience in venture capital investment or 409 substantially equivalent experience. "Substantially equivalent experience" includes, but is not limited to, 410 an undergraduate degree from an accredited college or university in economics, finance, or a similar 411 field of study. The Department may require an investment fund to provide documentation of the 412 investor's training, education, or experience as deemed necessary by the Department to determine 413 substantial equivalency. If the Department determines that the investment fund employs at least one 414 investor with the experience set forth herein, the Department shall certify the investment fund as a 415 Virginia venture capital account at such time as the investment fund actually invests at least 50 percent 416 of the capital committed to its fund in qualified portfolio companies.

417 28. a. Income attributable to an investment in a Virginia real estate investment trust. To qualify for a 418 subtraction under this subdivision, the investment shall be made on or after January 1, 2019, but before 419 December 31, 2024. No subtraction shall be allowed for an investment in a trust that is managed by a 420 family member or an affiliate of the taxpayer. No subtraction shall be allowed under this subdivision for 421 a taxpayer who has claimed a subtraction under subdivision 24 or 27 or a tax credit under § 58.1-339.4 422 for the same investment. 423

b. As used in this subdivision 28:

424 "Distressed" means satisfying the criteria applicable to a locality described in subdivision E 2 of 425 § 2.2-115.

426 "Double distressed" means satisfying the criteria applicable to a locality described in subdivision E 3 427 of § 2.2-115.

428 'Virginia real estate investment trust" means a real estate investment trust, as defined in 26 U.S.C. 429 § 856, that has been certified by the Department as a Virginia real estate investment trust. In order to be 430 certified as a Virginia real estate investment trust, the trustee shall register the trust with the Department 431 prior to December 31, 2024, indicating that it intends to invest at least 90 percent of trust funds in 432 Virginia and at least 40 percent of trust funds in real estate in localities that are distressed or double distressed. If the Department determines that the trust satisfies the preceding criteria, the Department 433 434 shall certify the trust as a Virginia real estate investment trust at such time as the trust actually invests 435 at least 90 percent of trust funds in Virginia and at least 40 percent of trust funds in real estate in 436 localities that are distressed or double distressed.

437 29. For taxable years beginning on and after January 1, 2019, any gain recognized from the taking of438 real property by condemnation proceedings.

439 30. For taxable years beginning before January 1, 2021, up to \$100,000 of all grant funds received
440 by the taxpayer under the Rebuild Virginia program established by the Governor and administered by
441 the Department of Small Business and Supplier Diversity.

442 31. For taxable years beginning on and after January 1, 2022, any compensation for wrongful
443 incarceration awarded pursuant to the procedures established under Article 18.2 (§ 8.01-195.10 et seq.)
444 of Chapter 3 of Title 8.01.
