[S 1427] 5 6 Approved 7 Be it enacted by the General Assembly of Virginia: 8 1. That §§ 24.2-949.6, 24.2-949.7, and 24.2-953.1 of the Code of Virginia are amended and 9 reenacted and that the Code of Virginia is amended by adding a section numbered 24.2-949.7:1 as 10 follows: 11 § 24.2-949.6. Filing schedule for political action committees. 12 A. Political action committees shall file the prescribed campaign finance reports with the State Board in accordance with the applicable provisions of this section. The first filed report shall be complete for 13 the entire period from the time the committee was organized or contributions were received. 14 15 B. The reporting requirements shall continue in effect for each committee until a final report is filed. C. Political action committees shall file the prescribed campaign finance reports as follows: 16 1. Not later than April 15 complete from the preceding report through March 31; 17 18 2. Not later than July 15 June 1 complete from the preceding report through June 30 May 25; 19 3. Not later than October September 15 complete from the preceding report through September 30 20 August 31; and 21 4. Not later than October 15 complete from the preceding report through October 7; and 22 5. Not later than January 15 complete from the preceding report through December 31, and then 23 continuing in accordance with this subsection until a final report is filed. 24 D. A political action committee that files its statement of organization on or after March 15 and 25 before the third Tuesday in June in any odd-numbered year shall file with its statement of organization a campaign finance report as provided in § 24.2-949.5 for that year, complete through the date that it 26 27 files its statement of organization, and if such political action committee files its statement of organization before the twelfth day before the third Tuesday in June, such political action committee 28 29 shall file its next campaign finance report in accordance with subdivision C 2. After the twelfth day 30 before the third Tuesday in June, or after the date a political action committee has filed its statement of 31 organization if the political action committee has filed its statement of organization on or after the 32 eleventh day before the third Tuesday in June, and until the third Tuesday in June, the political action 33 committee shall report any single contribution or expenditure of \$1,000 or more to the State Board in 34 writing or electronically pursuant to § 24.2-946.1, and the report shall be received by the State Board 35 by 11:59 p.m. on the following day or, for a contribution received or expenditure made on a Saturday, by 11:59 p.m. on the following Monday. However, any such contribution received or expenditure made 36 37 within the 24 hours prior to the third Tuesday in June shall be reported and a report thereof received 38 on the day prior to the third Tuesday in June. Any activity reported pursuant to this subsection shall 39 also be reported on the report required to be filed for activity through August 31. 40 E. A political action committee that files its statement of organization on or after August 15 and 41 before the November election day in any odd-numbered year shall file with its statement of organization 42 a campaign finance report as provided in § 24.2-949.5 for that year, complete through the date that it 43 files its statement of organization, and if such political action committee files its statement of 44 organization before September 30 October 15, such political action committee shall file its next campaign finance report in accordance with subdivision C 3 4. After September 30 October 15, or after 45 the date a political action committee has filed its statement of organization if the political action 46 committee has filed its statement of organization on or after October 1 October 16, and until the 47 November election day, the political action committee shall report any single contribution or expenditure 48 49 of \$500 \$1,000 or more to the State Board in writing or electronically pursuant to § 24.2-946.1, and the 50 report shall be received by the State Board by 11:59 p.m. on the following day, or, for a contribution received or expenditure made on a Saturday, by 11:59 p.m. on the following Monday. However, any 51 such contribution received or expenditure made within the 24 hours prior to the election day shall be 52 53 reported and a report thereof received on the day prior to the election. Any activity reported pursuant to 54 this subsection shall also be reported on the report required to be filed for activity through December 55 31.

57 In addition to the quarterly scheduled reports required by § 24.2-949.6, political action committees 58 shall report any single contribution or loan of \$10,000 or more received at any time during the calendar 59 year within three business days of receipt of the contribution or loan.

1. The report shall be filed on a "large dollar contribution report" form prescribed by the State Board 60 61 and shall be filed in writing or electronically in the same manner as the political action committee files 62 its quarterly disclosure scheduled reports.

2. Any contribution or loan reported pursuant to this section shall also be reported on the next 63 subsequent report required under § 24.2-949.6 following receipt of the contribution or loan. 64

65 3. For the purposes of this section, political action committees shall report as one contribution 66 multiple contributions from a single source that have been subdivided into smaller amounts or given 67 through different bank accounts for the purpose of evading the \$10,000 threshold. A political action 68 committee that receives contributions from affiliated organizations shall not be deemed to be receiving 69 contributions from a single source. 70

§ 24.2-949.7:1. Special report required of certain large pre-election expenditures.

71 A. Any contribution or expenditure reported pursuant to this section shall also be reported on the 72 first report required by this article after any election.

73 B. Political action committees shall report any single contribution received or expenditure made of 74 \$1,000 or more between May 26 and the third Tuesday in June in odd-numbered years. Such 75 contribution or expenditure shall be reported electronically pursuant to § 24.2-946.1, and the report shall be received by the State Board by 11:59 p.m. on the following day or, for a contribution received or expenditure made on a Saturday, by 11:59 p.m. on the following Monday. However, any such 76 77 78 contribution received or expenditure made within the 24 hours prior to the third Tuesday in June shall 79 be reported and a report thereof received on the day prior to the third Tuesday in June.

80 C. Political action committees shall report any single contribution received or expenditure made of \$1,000 or more between October 8 and the date of the November general election. Such contribution or 81 expenditure shall be reported electronically pursuant to § 24.2-946.1, and the report shall be received 82 by the State Board by 11:59 p.m. on the following day or, for a contribution received or expenditure made on a Saturday, by 11:59 p.m. on the following Monday. However, any such contribution received 83 84 85 or expenditure made within the 24 hours prior to the election day shall be reported and a report thereof 86 received on the day prior to the election. 87

§ 24.2-953.1. Failure to file the required reports.

88 A. In the case of a failure to file the statement of organization for a candidate campaign committee 89 or political committee required by this chapter, there shall be a civil penalty not to exceed \$500.

90 B. In the case of the failure to file a required report, the candidate campaign committee or political 91 committee shall be assessed a civil penalty not to exceed \$500. In the case of the failure to file a report required pursuant to subsection D or E of § 24.2-949.6, the political action committee shall be assessed 92 93 a civil penalty not to exceed \$500. In the case of a second or any subsequent such violation pertaining to one election cycle, the candidate campaign committee or political committee shall be assessed a civil 94 95 penalty of \$1,000 for each such failure to file.

C. In the case of a failure to file the report of any large pre-election contribution required by 96 97 § 24.2-947.9 or 24.2-949.7.1 or a report required pursuant to subsection D or E of § 24.2-949.6, there 98 shall be a rebuttable presumption that the violation was willful.
