76 **§ 2.2-221. Position established; agencies for which responsible; additional powers and duties.**

77 A. The position of Secretary of Public Safety and Homeland Security (the Secretary) is created. The
78 Secretary shall be responsible to the Governor for the following agencies: the Virginia Alcoholic
79 Beverage Control Authority, *Virginia Cannabis Control Authority*, Department of Corrections,
80 Department of Juvenile Justice, Department of Criminal Justice Services, Department of Forensic
81 Science, Virginia Parole Board, Department of Emergency Management, Department of State Police,
82 Department of Fire Programs, and Commonwealth's Attorneys' Services Council. The Governor may, by
83 executive order, assign any other state executive agency to the Secretary, or reassign any agency listed
84 above to another Secretary.

85 B. The Secretary shall by reason of professional background have knowledge of law enforcement,
86 public safety, or emergency management and preparedness issues, in addition to familiarity with the
87 structure and operations of the federal government and of the Commonwealth.

88 Unless the Governor expressly reserves such power to himself, the Secretary shall:

89 1. Work with and through others, including federal, state, and local officials as well as the private
90 sector, to develop a seamless, coordinated security and preparedness strategy and implementation plan.

91 2. Serve as the point of contact with the federal Department of Homeland Security.

92 3. Provide oversight, coordination, and review of all disaster, emergency management, and terrorism
93 management plans for the state and its agencies in coordination with the Virginia Department of
94 Emergency Management and other applicable state agencies.

95 4. Work with federal officials to obtain additional federal resources and coordinate policy
96 development and information exchange.

97 5. Work with and through appropriate members of the Governor's Cabinet to coordinate working
98 relationships between state agencies and take all actions necessary to ensure that available federal and
99 state resources are directed toward safeguarding Virginia and its citizens.

100 6. Designate a Commonwealth Interoperability Coordinator to ensure that all communications-related
101 preparedness federal grant requests from state agencies and localities are used to enhance
102 interoperability. The Secretary shall ensure that the annual review and update of the statewide
103 interoperability strategic plan is conducted as required in § 2.2-222.2. The Commonwealth
104 Interoperability Coordinator shall establish an advisory group consisting of representatives of state and
105 local government and constitutional offices, broadly distributed across the Commonwealth, who are
106 actively engaged in activities and functions related to communications interoperability.

107 7. Serve as one of the Governor's representatives on regional efforts to develop a coordinated
108 security and preparedness strategy, including the National Capital Region Senior Policy Group organized
109 as part of the federal Urban Areas Security Initiative.

110 8. Serve as a direct liaison between the Governor and local governments and first responders on
111 issues of emergency prevention, preparedness, response, and recovery.

112 9. Educate the public on homeland security and overall preparedness issues in coordination with
113 applicable state agencies.

114 10. Serve as chairman of the Secure and Resilient Commonwealth Panel.

115 11. Encourage homeland security volunteer efforts throughout the state.

116 12. Coordinate the development of an allocation formula for State Homeland Security Grant Program
117 funds to localities and state agencies in compliance with federal grant guidance and constraints. The
118 formula shall be, to the extent permissible under federal constraints, based on actual risk, threat, and
119 need.

120 13. Work with the appropriate state agencies to ensure that regional working groups are meeting
121 regularly and focusing on regional initiatives in training, equipment, and strategy to ensure ready access

to response teams in times of emergency and facilitate testing and training exercises for emergencies and mass casualty preparedness.

14. Provide oversight and review of the Virginia Department of Emergency Management's annual statewide assessment of local and regional capabilities, including equipment, training, personnel, response times, and other factors.

15. Employ, as needed, consultants, attorneys, architects, engineers, accountants, financial experts, investment bankers, superintendents, managers, and such other employees and agents as may be necessary, and fix their compensation to be payable from funds made available for that purpose.

16. Receive and accept from any federal or private agency, foundation, corporation, association, or person grants, donations of money, real property, or personal property for the benefit of the Commonwealth, and receive and accept from the Commonwealth or any state, any municipality, county, or other political subdivision thereof, or any other source, aid or contributions of money, property, or other things of value, to be held, used, and applied for the purposes for which such grants and contributions may be made.

17. Receive and accept from any source aid, grants, and contributions of money, property, labor, or other things of value to be held, used, and applied to carry out these requirements subject to the conditions upon which the aid, grants, or contributions are made.

18. Make grants to local governments, state and federal agencies, and private entities with any funds of the Secretary available for such purpose.

19. Provide oversight and review of the law-enforcement operations of the Alcoholic Beverage Control Authority *and the Virginia Cannabis Control Authority*.

20. Take any actions necessary or convenient to the exercise of the powers granted or reasonably implied to this Secretary and not otherwise inconsistent with the law of the Commonwealth.

§ 2.2-507. Legal service in civil matters.

A. All legal service in civil matters for the Commonwealth, the Governor, and every state department, institution, division, commission, board, bureau, agency, entity, official, court, or judge, including the conduct of all civil litigation in which any of them are interested, shall be rendered and performed by the Attorney General, except as provided in this chapter and except for any litigation concerning a justice or judge initiated by the Judicial Inquiry and Review Commission. No regular counsel shall be employed for or by the Governor or any state department, institution, division, commission, board, bureau, agency, entity, or official. The Attorney General may represent personally or through one or more of his assistants any number of state departments, institutions, divisions, commissions, boards, bureaus, agencies, entities, officials, courts, or judges that are parties to the same transaction or that are parties in the same civil or administrative proceeding and may represent multiple interests within the same department, institution, division, commission, board, bureau, agency, or entity. The soil and water conservation district directors or districts may request legal advice from local, public, or private sources; however, upon request of the soil and water conservation district directors or districts, the Attorney General shall provide legal service in civil matters for such district directors or districts.

B. The Attorney General may represent personally or through one of his assistants any of the following persons who are made defendant in any civil action for damages arising out of any matter connected with their official duties:

1. Members, agents, or employees of the Virginia Alcoholic Beverage Control Authority *or the Virginia Cannabis Control Authority*;

2. Agents inspecting or investigators appointed by the State Corporation Commission;

3. Agents, investigators, or auditors employed by the Department of Taxation;

4. Members, agents, or employees of the State Board of Behavioral Health and Developmental Services, the Department of Behavioral Health and Developmental Services, the State Board of Health, the State Department of Health, the Department of General Services, the State Board of Social Services, the Department of Social Services, the State Board of Local and Regional Jails, the Department of Corrections, the State Board of Juvenile Justice, the Department of Juvenile Justice, the Virginia Parole Board, or the Department of Agriculture and Consumer Services;

5. Persons employed by the Commonwealth Transportation Board, the Department of Transportation, or the Department of Rail and Public Transportation;

6. Persons employed by the Commissioner of Motor Vehicles;

7. Persons appointed by the Commissioner of Marine Resources;

8. Police officers appointed by the Superintendent of State Police;

9. Conservation police officers appointed by the Department of Wildlife Resources;

10. Hearing officers appointed to hear a teacher's grievance pursuant to § 22.1-311;

11. Staff members or volunteers participating in a court-appointed special advocate program pursuant to Article 5 (§ 9.1-151 et seq.) of Chapter 1 of Title 9.1;

12. Any emergency medical services agency that is a licensee of the Department of Health in any

civil matter and any guardian ad litem appointed by a court in a civil matter brought against him for alleged errors or omissions in the discharge of his court-appointed duties;

13. Conservation officers of the Department of Conservation and Recreation; or

14. A person appointed by written order of a circuit court judge to run an existing corporation or company as the judge's representative, when that person is acting in execution of a lawful order of the court and the order specifically refers to this section and appoints such person to serve as an agent of the Commonwealth.

Upon request of the affected individual, the Attorney General may represent personally or through one of his assistants (i) any basic or advanced emergency medical care attendant or technician possessing a valid certificate issued by authority of the State Board of Health in any civil matter in which a defense of immunity from liability is raised pursuant to § 8.01-225 or (ii) any member of the General Assembly in any civil matter alleging that such member in his official capacity violated the Virginia Freedom of Information Act (§ 2.2-3700 et seq.) pursuant to § 2.2-3713 or 2.2-3714.

C. If, in the opinion of the Attorney General, it is impracticable or uneconomical for such legal service to be rendered by him or one of his assistants, he may employ special counsel for this purpose, whose compensation shall be fixed by the Attorney General. The compensation for such special counsel shall be paid out of the funds appropriated for the administration of the board, commission, division, or department being represented or whose members, officers, inspectors, investigators, or other employees are being represented pursuant to this section. Notwithstanding any provision of this section to the contrary, the Supreme Court may employ its own counsel in any matter arising out of its official duties in which it, or any justice, is a party.

D. Nothing herein shall limit the powers granted in § 16.1-88.03.

§ 2.2-511. Criminal cases.

A. Unless specifically requested by the Governor to do so, the Attorney General shall have no authority to institute or conduct criminal prosecutions in the circuit courts of the Commonwealth except in cases involving (i) violations of the Alcoholic Beverage Control Act (§ 4.1-100 et seq.) or the *Cannabis Control Act* (§ 4.1-600 et seq.), (ii) violation of laws relating to elections and the electoral process as provided in § 24.2-104, (iii) violation of laws relating to motor vehicles and their operation, (iv) the handling of funds by a state bureau, institution, commission or department, (v) the theft of state property, (vi) violation of the criminal laws involving child pornography and sexually explicit visual material involving children, (vii) the practice of law without being duly authorized or licensed or the illegal practice of law, (viii) violations of § 3.2-4212 or 58.1-1008.2, (ix) with the concurrence of the local attorney for the Commonwealth, violations of the Virginia Computer Crimes Act (§ 18.2-152.1 et seq.), (x) with the concurrence of the local attorney for the Commonwealth, violations of the Air Pollution Control Law (§ 10.1-1300 et seq.), the Virginia Waste Management Act (§ 10.1-1400 et seq.), and the State Water Control Law (§ 62.1-44.2 et seq.), (xi) with the concurrence of the local attorney for the Commonwealth, violations of Chapters 2 (§ 18.2-18 et seq.), 3 (§ 18.2-22 et seq.), and 10 (§ 18.2-434 et seq.) of Title 18.2, if such crimes relate to violations of law listed in clause (x) of this subsection, (xii) with the concurrence of the local attorney for the Commonwealth, criminal violations by Medicaid providers or their employees in the course of doing business, or violations of Chapter 13 (§ 18.2-512 et seq.) of Title 18.2, in which cases the Attorney General may leave the prosecution to the local attorney for the Commonwealth, or he may institute proceedings by information, presentment or indictment, as appropriate, and conduct the same, (xiii) with the concurrence of the local attorney for the Commonwealth, violations of Article 9 (§ 18.2-246.1 et seq.) of Chapter 6 of Title 18.2, (xiv) with the concurrence of the local attorney for the Commonwealth, assisting in the prosecution of violations of §§ 18.2-186.3 and 18.2-186.4, (xv) with the concurrence of the local attorney for the Commonwealth, assisting in the prosecution of violations of § 18.2-46.2, 18.2-46.3, or 18.2-46.5 when such violations are committed on the grounds of a state correctional facility, and (xvi) with the concurrence of the local attorney for the Commonwealth, assisting in the prosecution of violations of Article 10 (§ 18.2-246.6 et seq.) of Chapter 6 of Title 18.2.

In all other criminal cases in the circuit courts, except where the law provides otherwise, the authority of the Attorney General to appear or participate in the proceedings shall not attach unless and until a notice of appeal has been filed with the clerk of the circuit court noting an appeal to the Court of Appeals or the Supreme Court. In all criminal cases before the Court of Appeals or the Supreme Court in which the Commonwealth is a party or is directly interested, the Attorney General shall appear and represent the Commonwealth, unless, and with the consent of the Attorney General, the attorney for the Commonwealth who prosecuted the underlying criminal case files a notice of appearance to represent the Commonwealth in any such appeal.

B. The Attorney General shall, upon request of a person who was the victim of a crime and subject to such reasonable procedures as the Attorney General may require, ensure that such person is given notice of the filing, of the date, time and place and of the disposition of any appeal or habeas corpus proceeding involving the cases in which such person was a victim. For the purposes of this section, a

victim is an individual who has suffered physical, psychological or economic harm as a direct result of the commission of a crime; a spouse, child, parent or legal guardian of a minor or incapacitated victim; or a spouse, child, parent or legal guardian of a victim of a homicide. Nothing in this subsection shall confer upon any person a right to appeal or modify any decision in a criminal, appellate or habeas corpus proceeding; abridge any right guaranteed by law; or create any cause of action for damages against the Commonwealth or any of its political subdivisions, the Attorney General or any of his employees or agents, any other officer, employee or agent of the Commonwealth or any of its political subdivisions, or any officer of the court.

§ 2.2-1119. Cases in which purchasing through Division not mandatory.

A. Unless otherwise ordered by the Governor, the purchasing of materials, equipment, supplies, and nonprofessional services through the Division shall not be mandatory in the following cases:

1. Materials, equipment and supplies incident to the performance of a contract for labor or for labor and materials;

2. Manuscripts, maps, audiovisual materials, books, pamphlets and periodicals purchased for the use of The Library of Virginia or any other library in the Commonwealth supported in whole or in part by state funds;

3. Perishable articles, provided that no article except fresh vegetables, fish, eggs or milk shall be considered perishable within the meaning of this subdivision, unless so classified by the Division;

4. Materials, equipment and supplies needed by the Commonwealth Transportation Board; however, this exception may include, office stationery and supplies, office equipment, janitorial equipment and supplies, and coal and fuel oil for heating purposes shall not be included except when authorized in writing by the Division;

5. Materials, equipment, and supplies needed by the Virginia Alcoholic Beverage Control Authority or the Virginia Cannabis Control Authority, including office stationery and supplies, office equipment, and janitorial equipment and supplies; however, coal and fuel oil for heating purposes shall not be included except when authorized in writing by the Division;

6. Binding and rebinding of the books and other literary materials of libraries operated by the Commonwealth or under its authority;

7. Printing of the records of the Supreme Court; and

8. Financial services, including without limitation, underwriters, financial advisors, investment advisors and banking services.

B. Telecommunications and information technology goods and services of every description shall be procured as provided by § 2.2-2012.

§ 2.2-2499.8. Cannabis Equity Reinvestment Fund.

There is hereby created in the state treasury a special nonreverting fund to be known as the Cannabis Equity Reinvestment Fund, referred to in this section as "the Fund." The Fund shall be established on the books of the Comptroller. All funds appropriated for such purpose and any gifts, donations, grants, bequests, and other funds received on its behalf shall be paid into the state treasury and credited to the Fund. Interest earned on moneys in the Fund shall remain in the Fund and be credited to it. Any moneys remaining in the Fund, including interest thereon, at the end of each fiscal year shall not revert to the general fund but shall remain in the Fund. Moneys in the Fund shall be used solely for the purposes of:

1. Supporting persons, families, and communities historically and disproportionately targeted and affected by drug enforcement;

2. Providing scholarship opportunities and educational and vocational resources for historically marginalized persons, including persons in foster care, who have been adversely impacted by substance use individually, in their families, or in their communities;

3. Awarding grants to support workforce development, mentoring programs, job training and placement services, apprenticeships, and reentry services that serve persons and communities historically and disproportionately targeted by drug enforcement.

4. Contributing to the Virginia Indigent Defense Commission established pursuant to § 19.2-163.01; and

5. Contributing to the Virginia Cannabis Equity Business Loan Fund established pursuant to § 4.1-1501; and

6. *Funding the staffing and administrative costs of the Cannabis Equity Reinvestment Board. Expenditures for staffing and administration shall be limited to those that are reasonable and necessary for carrying out the powers and duties of the Cannabis Equity Reinvestment Board.*

Expenditures and disbursements from the Fund shall be made by the State Treasurer on warrants issued by the Comptroller upon written request signed by the Director of Diversity, Equity, and Inclusion.

§ 2.2-2818. Health and related insurance for state employees.

306 A. The Department of Human Resource Management shall establish a plan, subject to the approval
307 of the Governor, for providing health insurance coverage, including chiropractic treatment,
308 hospitalization, medical, surgical and major medical coverage, for state employees and retired state
309 employees with the Commonwealth paying the cost thereof to the extent of the coverage included in
310 such plan. The same plan shall be offered to all part-time state employees, but the total cost shall be
311 paid by such part-time employees. The Department of Human Resource Management shall administer
312 this section. The plan chosen shall provide means whereby coverage for the families or dependents of
313 state employees may be purchased. Except for part-time employees, the Commonwealth may pay all or a
314 portion of the cost thereof, and for such portion as the Commonwealth does not pay, the employee,
315 including a part-time employee, may purchase the coverage by paying the additional cost over the cost
316 of coverage for an employee.

317 Such contribution shall be financed through appropriations provided by law.

318 B. The plan shall:

319 1. Include coverage for low-dose screening mammograms for determining the presence of occult
320 breast cancer. Such coverage shall make available one screening mammogram to persons age 35 through
321 39, one such mammogram biennially to persons age 40 through 49, and one such mammogram annually
322 to persons age 50 and over and may be limited to a benefit of \$50 per mammogram subject to such
323 dollar limits, deductibles, and coinsurance factors as are no less favorable than for physical illness
324 generally.

325 The term "mammogram" shall mean an X-ray examination of the breast using equipment dedicated
326 specifically for mammography, including but not limited to the X-ray tube, filter, compression device,
327 screens, film, and cassettes, with an average radiation exposure of less than one rad mid-breast, two
328 views of each breast.

329 In order to be considered a screening mammogram for which coverage shall be made available under
330 this section:

331 a. The mammogram shall be (i) ordered by a health care practitioner acting within the scope of his
332 licensure and, in the case of an enrollee of a health maintenance organization, by the health maintenance
333 organization provider; (ii) performed by a registered technologist; (iii) interpreted by a qualified
334 radiologist; and (iv) performed under the direction of a person licensed to practice medicine and surgery
335 and certified by the American Board of Radiology or an equivalent examining body. A copy of the
336 mammogram report shall be sent or delivered to the health care practitioner who ordered it;

337 b. The equipment used to perform the mammogram shall meet the standards set forth by the Virginia
338 Department of Health in its radiation protection regulations; and

339 c. The mammography film shall be retained by the radiologic facility performing the examination in
340 accordance with the American College of Radiology guidelines or state law.

341 2. Include coverage for postpartum services providing inpatient care and a home visit or visits that
342 shall be in accordance with the medical criteria, outlined in the most current version of or an official
343 update to the "Guidelines for Perinatal Care" prepared by the American Academy of Pediatrics and the
344 American College of Obstetricians and Gynecologists or the "Standards for Obstetric-Gynecologic
345 Services" prepared by the American College of Obstetricians and Gynecologists. Such coverage shall be
346 provided incorporating any changes in such Guidelines or Standards within six months of the publication
347 of such Guidelines or Standards or any official amendment thereto.

348 3. Include an appeals process for resolution of complaints that shall provide reasonable procedures
349 for the resolution of such complaints and shall be published and disseminated to all covered state
350 employees. The appeals process shall be compliant with federal rules and regulations governing
351 nonfederal, self-insured governmental health plans. The appeals process shall include a separate
352 expedited emergency appeals procedure that shall provide resolution within time frames established by
353 federal law. For appeals involving adverse decisions as defined in § 32.1-137.7, the Department shall
354 contract with one or more independent review organizations to review such decisions. Independent
355 review organizations are entities that conduct independent external review of adverse benefit
356 determinations. The Department shall adopt regulations to assure that the independent review
357 organization conducting the reviews has adequate standards, credentials and experience for such review.
358 The independent review organization shall examine the final denial of claims to determine whether the
359 decision is objective, clinically valid, and compatible with established principles of health care. The
360 decision of the independent review organization shall (i) be in writing, (ii) contain findings of fact as to
361 the material issues in the case and the basis for those findings, and (iii) be final and binding if
362 consistent with law and policy.

363 Prior to assigning an appeal to an independent review organization, the Department shall verify that
364 the independent review organization conducting the review of a denial of claims has no relationship or
365 association with (i) (a) the covered person or the covered person's authorized representative; (ii) (b) the
366 treating health care provider, or any of its employees or affiliates; (iii) (c) the medical care facility at
367 which the covered service would be provided, or any of its employees or affiliates; or (iv) (d) the

development or manufacture of the drug, device, procedure or other therapy that is the subject of the final denial of a claim. The independent review organization shall not be a subsidiary of, nor owned or controlled by, a health plan, a trade association of health plans, or a professional association of health care providers. There shall be no liability on the part of and no cause of action shall arise against any officer or employee of an independent review organization for any actions taken or not taken or statements made by such officer or employee in good faith in the performance of his powers and duties.

4. Include coverage for early intervention services. For purposes of this section, "early intervention services" means medically necessary speech and language therapy, occupational therapy, physical therapy and assistive technology services and devices for dependents from birth to age three who are certified by the Department of Behavioral Health and Developmental Services as eligible for services under Part H of the Individuals with Disabilities Education Act (20 U.S.C. § 1471 et seq.). Medically necessary early intervention services for the population certified by the Department of Behavioral Health and Developmental Services shall mean those services designed to help an individual attain or retain the capability to function age-appropriately within his environment, and shall include services that enhance functional ability without effecting a cure.

For persons previously covered under the plan, there shall be no denial of coverage due to the existence of a preexisting condition. The cost of early intervention services shall not be applied to any contractual provision limiting the total amount of coverage paid by the insurer to or on behalf of the insured during the insured's lifetime.

5. Include coverage for prescription drugs and devices approved by the United States Food and Drug Administration for use as contraceptives.

6. Not deny coverage for any drug approved by the United States Food and Drug Administration for use in the treatment of cancer on the basis that the drug has not been approved by the United States Food and Drug Administration for the treatment of the specific type of cancer for which the drug has been prescribed, if the drug has been recognized as safe and effective for treatment of that specific type of cancer in one of the standard reference compendia.

7. Not deny coverage for any drug prescribed to treat a covered indication so long as the drug has been approved by the United States Food and Drug Administration for at least one indication and the drug is recognized for treatment of the covered indication in one of the standard reference compendia or in substantially accepted peer-reviewed medical literature.

8. Include coverage for equipment, supplies and outpatient self-management training and education, including medical nutrition therapy, for the treatment of insulin-dependent diabetes, insulin-using diabetes, gestational diabetes and noninsulin-using diabetes if prescribed by a health care professional legally authorized to prescribe such items under law. To qualify for coverage under this subdivision, diabetes outpatient self-management training and education shall be provided by a certified, registered or licensed health care professional.

9. Include coverage for reconstructive breast surgery. For purposes of this section, "reconstructive breast surgery" means surgery performed on and after July 1, 1998, (i) coincident with a mastectomy performed for breast cancer or (ii) following a mastectomy performed for breast cancer to reestablish symmetry between the two breasts. For persons previously covered under the plan, there shall be no denial of coverage due to preexisting conditions.

10. Include coverage for annual pap smears, including coverage, on and after July 1, 1999, for annual testing performed by any FDA-approved gynecologic cytology screening technologies.

11. Include coverage providing a minimum stay in the hospital of not less than 48 hours for a patient following a radical or modified radical mastectomy and 24 hours of inpatient care following a total mastectomy or a partial mastectomy with lymph node dissection for treatment of breast cancer. Nothing in this subdivision shall be construed as requiring the provision of inpatient coverage where the attending physician in consultation with the patient determines that a shorter period of hospital stay is appropriate.

12. Include coverage (i) to persons age 50 and over and (ii) to persons age 40 and over who are at high risk for prostate cancer, according to the most recent published guidelines of the American Cancer Society, for one PSA test in a 12-month period and digital rectal examinations, all in accordance with American Cancer Society guidelines. For the purpose of this subdivision, "PSA testing" means the analysis of a blood sample to determine the level of prostate specific antigen.

13. Permit any individual covered under the plan direct access to the health care services of a participating specialist (i) authorized to provide services under the plan and (ii) selected by the covered individual. The plan shall have a procedure by which an individual who has an ongoing special condition may, after consultation with the primary care physician, receive a referral to a specialist for such condition who shall be responsible for and capable of providing and coordinating the individual's primary and specialty care related to the initial specialty care referral. If such an individual's care would most appropriately be coordinated by such a specialist, the plan shall refer the individual to a specialist.

429 For the purposes of this subdivision, "special condition" means a condition or disease that is ~~(i)~~ (a)
430 life-threatening, degenerative, or disabling and ~~(ii)~~ (b) requires specialized medical care over a prolonged
431 period of time. Within the treatment period authorized by the referral, such specialist shall be permitted
432 to treat the individual without a further referral from the individual's primary care provider and may
433 authorize such referrals, procedures, tests, and other medical services related to the initial referral as the
434 individual's primary care provider would otherwise be permitted to provide or authorize. The plan shall
435 have a procedure by which an individual who has an ongoing special condition that requires ongoing
436 care from a specialist may receive a standing referral to such specialist for the treatment of the special
437 condition. If the primary care provider, in consultation with the plan and the specialist, if any,
438 determines that such a standing referral is appropriate, the plan or issuer shall make such a referral to a
439 specialist. Nothing contained herein shall prohibit the plan from requiring a participating specialist to
440 provide written notification to the covered individual's primary care physician of any visit to such
441 specialist. Such notification may include a description of the health care services rendered at the time of
442 the visit.

443 14. Include provisions allowing employees to continue receiving health care services for a period of
444 up to 90 days from the date of the primary care physician's notice of termination from any of the plan's
445 provider panels. The plan shall notify any provider at least 90 days prior to the date of termination of
446 the provider, except when the provider is terminated for cause.

447 For a period of at least 90 days from the date of the notice of a provider's termination from any of
448 the plan's provider panels, except when a provider is terminated for cause, a provider shall be permitted
449 by the plan to render health care services to any of the covered employees who (i) were in an active
450 course of treatment from the provider prior to the notice of termination and (ii) request to continue
451 receiving health care services from the provider.

452 Notwithstanding the provisions of this subdivision, any provider shall be permitted by the plan to
453 continue rendering health services to any covered employee who has entered the second trimester of
454 pregnancy at the time of the provider's termination of participation, except when a provider is terminated
455 for cause. Such treatment shall, at the covered employee's option, continue through the provision of
456 postpartum care directly related to the delivery.

457 Notwithstanding the provisions of this subdivision, any provider shall be permitted to continue
458 rendering health services to any covered employee who is determined to be terminally ill (as defined
459 under § 1861(dd)(3)(A) of the Social Security Act) at the time of a provider's termination of
460 participation, except when a provider is terminated for cause. Such treatment shall, at the covered
461 employee's option, continue for the remainder of the employee's life for care directly related to the
462 treatment of the terminal illness.

463 A provider who continues to render health care services pursuant to this subdivision shall be
464 reimbursed in accordance with the carrier's agreement with such provider existing immediately before
465 the provider's termination of participation.

466 15. Include coverage for patient costs incurred during participation in clinical trials for treatment
467 studies on cancer, including ovarian cancer trials.

468 The reimbursement for patient costs incurred during participation in clinical trials for treatment
469 studies on cancer shall be determined in the same manner as reimbursement is determined for other
470 medical and surgical procedures. Such coverage shall have durational limits, dollar limits, deductibles,
471 copayments and coinsurance factors that are no less favorable than for physical illness generally.

472 For purposes of this subdivision:

473 "Cooperative group" means a formal network of facilities that collaborate on research projects and
474 have an established NIH-approved peer review program operating within the group. "Cooperative group"
475 includes (i) the National Cancer Institute Clinical Cooperative Group and (ii) the National Cancer
476 Institute Community Clinical Oncology Program.

477 "FDA" means the Federal Food and Drug Administration.

478 "Multiple project assurance contract" means a contract between an institution and the federal
479 Department of Health and Human Services that defines the relationship of the institution to the federal
480 Department of Health and Human Services and sets out the responsibilities of the institution and the
481 procedures that will be used by the institution to protect human subjects.

482 "NCI" means the National Cancer Institute.

483 "NIH" means the National Institutes of Health.

484 "Patient" means a person covered under the plan established pursuant to this section.

485 "Patient cost" means the cost of a medically necessary health care service that is incurred as a result
486 of the treatment being provided to a patient for purposes of a clinical trial. "Patient cost" does not
487 include (i) the cost of nonhealth care services that a patient may be required to receive as a result of the
488 treatment being provided for purposes of a clinical trial, (ii) costs associated with managing the research
489 associated with the clinical trial, or (iii) the cost of the investigational drug or device.

490 Coverage for patient costs incurred during clinical trials for treatment studies on cancer shall be

provided if the treatment is being conducted in a Phase II, Phase III, or Phase IV clinical trial. Such treatment may, however, be provided on a case-by-case basis if the treatment is being provided in a Phase I clinical trial.

The treatment described in the previous paragraph shall be provided by a clinical trial approved by:

- a. The National Cancer Institute;
- b. An NCI cooperative group or an NCI center;
- c. The FDA in the form of an investigational new drug application;
- d. The federal Department of Veterans Affairs; or
- e. An institutional review board of an institution in the Commonwealth that has a multiple project assurance contract approved by the Office of Protection from Research Risks of the NCI.

The facility and personnel providing the treatment shall be capable of doing so by virtue of their experience, training, and expertise.

Coverage under this subdivision shall apply only if:

- (1) There is no clearly superior, noninvestigational treatment alternative;
- (2) The available clinical or preclinical data provide a reasonable expectation that the treatment will be at least as effective as the noninvestigational alternative; and
- (3) The patient and the physician or health care provider who provides services to the patient under the plan conclude that the patient's participation in the clinical trial would be appropriate, pursuant to procedures established by the plan.

16. Include coverage providing a minimum stay in the hospital of not less than 23 hours for a covered employee following a laparoscopy-assisted vaginal hysterectomy and 48 hours for a covered employee following a vaginal hysterectomy, as outlined in Milliman & Robertson's nationally recognized guidelines. Nothing in this subdivision shall be construed as requiring the provision of the total hours referenced when the attending physician, in consultation with the covered employee, determines that a shorter hospital stay is appropriate.

17. Include coverage for biologically based mental illness.

For purposes of this subdivision, a "biologically based mental illness" is any mental or nervous condition caused by a biological disorder of the brain that results in a clinically significant syndrome that substantially limits the person's functioning; specifically, the following diagnoses are defined as biologically based mental illness as they apply to adults and children: schizophrenia, schizoaffective disorder, bipolar disorder, major depressive disorder, panic disorder, obsessive-compulsive disorder, attention deficit hyperactivity disorder, autism, and drug and alcoholism addiction.

Coverage for biologically based mental illnesses shall neither be different nor separate from coverage for any other illness, condition or disorder for purposes of determining deductibles, benefit year or lifetime durational limits, benefit year or lifetime dollar limits, lifetime episodes or treatment limits, copayment and coinsurance factors, and benefit year maximum for deductibles and copayment and coinsurance factors.

Nothing shall preclude the undertaking of usual and customary procedures to determine the appropriateness of, and medical necessity for, treatment of biologically based mental illnesses under this option, provided that all such appropriateness and medical necessity determinations are made in the same manner as those determinations made for the treatment of any other illness, condition or disorder covered by such policy or contract.

18. Offer and make available coverage for the treatment of morbid obesity through gastric bypass surgery or such other methods as may be recognized by the National Institutes of Health as effective for the long-term reversal of morbid obesity. Such coverage shall have durational limits, dollar limits, deductibles, copayments and coinsurance factors that are no less favorable than for physical illness generally. Access to surgery for morbid obesity shall not be restricted based upon dietary or any other criteria not approved by the National Institutes of Health. For purposes of this subdivision, "morbid obesity" means (i) a weight that is at least 100 pounds over or twice the ideal weight for frame, age, height, and gender as specified in the 1983 Metropolitan Life Insurance tables, (ii) a body mass index (BMI) equal to or greater than 35 kilograms per meter squared with comorbidity or coexisting medical conditions such as hypertension, cardiopulmonary conditions, sleep apnea, or diabetes, or (iii) a BMI of 40 kilograms per meter squared without such comorbidity. As used herein, "BMI" equals weight in kilograms divided by height in meters squared.

19. Include coverage for colorectal cancer screening, specifically screening with an annual fecal occult blood test, flexible sigmoidoscopy or colonoscopy, or in appropriate circumstances radiologic imaging, in accordance with the most recently published recommendations established by the American College of Gastroenterology, in consultation with the American Cancer Society, for the ages, family histories, and frequencies referenced in such recommendations. The coverage for colorectal cancer screening shall not be more restrictive than or separate from coverage provided for any other illness, condition or disorder for purposes of determining deductibles, benefit year or lifetime durational limits,

benefit year or lifetime dollar limits, lifetime episodes or treatment limits, copayment and coinsurance factors, and benefit year maximum for deductibles and copayments and coinsurance factors.

20. On and after July 1, 2002, require that a prescription benefit card, health insurance benefit card, or other technology that complies with the requirements set forth in § 38.2-3407.4:2 be issued to each employee provided coverage pursuant to this section, and shall upon any changes in the required data elements set forth in subsection A of § 38.2-3407.4:2, either reissue the card or provide employees covered under the plan such corrective information as may be required to electronically process a prescription claim.

21. Include coverage for infant hearing screenings and all necessary audiological examinations provided pursuant to § 32.1-64.1 using any technology approved by the United States Food and Drug Administration, and as recommended by the national Joint Committee on Infant Hearing in its most current position statement addressing early hearing detection and intervention programs. Such coverage shall include follow-up audiological examinations as recommended by a physician, physician assistant, nurse practitioner or audiologist and performed by a licensed audiologist to confirm the existence or absence of hearing loss.

22. Notwithstanding any provision of this section to the contrary, every plan established in accordance with this section shall comply with the provisions of § 2.2-2818.2.

C. Claims incurred during a fiscal year but not reported during that fiscal year shall be paid from such funds as shall be appropriated by law. Appropriations, premiums and other payments shall be deposited in the employee health insurance fund, from which payments for claims, premiums, cost containment programs and administrative expenses shall be withdrawn from time to time. The funds of the health insurance fund shall be deemed separate and independent trust funds, shall be segregated from all other funds of the Commonwealth, and shall be invested and administered solely in the interests of the employees and their beneficiaries. Neither the General Assembly nor any public officer, employee, or agency shall use or authorize the use of such trust funds for any purpose other than as provided in law for benefits, refunds, and administrative expenses, including but not limited to legislative oversight of the health insurance fund.

D. For the purposes of this section:

"Peer-reviewed medical literature" means a scientific study published only after having been critically reviewed for scientific accuracy, validity, and reliability by unbiased independent experts in a journal that has been determined by the International Committee of Medical Journal Editors to have met the Uniform Requirements for Manuscripts submitted to biomedical journals. Peer-reviewed medical literature does not include publications or supplements to publications that are sponsored to a significant extent by a pharmaceutical manufacturing company or health carrier.

"Standard reference compendia" means:

1. American Hospital Formulary Service — Drug Information;
2. National Comprehensive Cancer Network's Drugs & Biologics Compendium; or
3. Elsevier Gold Standard's Clinical Pharmacology.

"State employee" means state employee as defined in § 51.1-124.3; employee as defined in § 51.1-201; the Governor, Lieutenant Governor and Attorney General; judge as defined in § 51.1-301 and judges, clerks and deputy clerks of regional juvenile and domestic relations, county juvenile and domestic relations, and district courts of the Commonwealth; interns and residents employed by the School of Medicine and Hospital of the University of Virginia, and interns, residents, and employees of the Virginia Commonwealth University Health System Authority as provided in § 23.1-2415; and employees of the Virginia Alcoholic Beverage Control Authority as provided in § 4.1-101.05 and the *Virginia Cannabis Control Authority as provided in § 4.1-623*.

E. Provisions shall be made for retired employees to obtain coverage under the above plan, including, as an option, coverage for vision and dental care. The Commonwealth may, but shall not be obligated to, pay all or any portion of the cost thereof.

F. Any self-insured group health insurance plan established by the Department of Human Resource Management that utilizes a network of preferred providers shall not exclude any physician solely on the basis of a reprimand or censure from the Board of Medicine, so long as the physician otherwise meets the plan criteria established by the Department.

G. The plan shall include, in each planning district, at least two health coverage options, each sponsored by unrelated entities. No later than July 1, 2006, one of the health coverage options to be available in each planning district shall be a high deductible health plan that would qualify for a health savings account pursuant to § 223 of the Internal Revenue Code of 1986, as amended.

In each planning district that does not have an available health coverage alternative, the Department shall voluntarily enter into negotiations at any time with any health coverage provider who seeks to provide coverage under the plan.

This subsection shall not apply to any state agency authorized by the Department to establish and administer its own health insurance coverage plan separate from the plan established by the Department.

H. Any self-insured group health insurance plan established by the Department of Human Resource Management that includes coverage for prescription drugs on an outpatient basis may apply a formulary to the prescription drug benefits provided by the plan if the formulary is developed, reviewed at least annually, and updated as necessary in consultation with and with the approval of a pharmacy and therapeutics committee, a majority of whose members are actively practicing licensed (i) pharmacists, (ii) physicians, and (iii) other health care providers.

If the plan maintains one or more drug formularies, the plan shall establish a process to allow a person to obtain, without additional cost-sharing beyond that provided for formulary prescription drugs in the plan, a specific, medically necessary nonformulary prescription drug if, after reasonable investigation and consultation with the prescriber, the formulary drug is determined to be an inappropriate therapy for the medical condition of the person. The plan shall act on such requests within one business day of receipt of the request.

Any plan established in accordance with this section shall be authorized to provide for the selection of a single mail order pharmacy provider as the exclusive provider of pharmacy services that are delivered to the covered person's address by mail, common carrier, or delivery service. As used in this subsection, "mail order pharmacy provider" means a pharmacy permitted to conduct business in the Commonwealth whose primary business is to dispense a prescription drug or device under a prescriptive drug order and to deliver the drug or device to a patient primarily by mail, common carrier, or delivery service.

I. Any plan established in accordance with this section requiring preauthorization prior to rendering medical treatment shall have personnel available to provide authorization at all times when such preauthorization is required.

J. Any plan established in accordance with this section shall provide to all covered employees written notice of any benefit reductions during the contract period at least 30 days before such reductions become effective.

K. No contract between a provider and any plan established in accordance with this section shall include provisions that require a health care provider or health care provider group to deny covered services that such provider or group knows to be medically necessary and appropriate that are provided with respect to a covered employee with similar medical conditions.

L. The Department of Human Resource Management shall appoint an Ombudsman to promote and protect the interests of covered employees under any state employee's health plan.

The Ombudsman shall:

1. Assist covered employees in understanding their rights and the processes available to them according to their state health plan.

2. Answer inquiries from covered employees by telephone and electronic mail.

3. Provide to covered employees information concerning the state health plans.

4. Develop information on the types of health plans available, including benefits and complaint procedures and appeals.

5. Make available, either separately or through an existing Internet web site utilized by the Department of Human Resource Management, information as set forth in subdivision 4 and such additional information as he deems appropriate.

6. Maintain data on inquiries received, the types of assistance requested, any actions taken and the disposition of each such matter.

7. Upon request, assist covered employees in using the procedures and processes available to them from their health plan, including all appeal procedures. Such assistance may require the review of health care records of a covered employee, which shall be done only in accordance with the federal Health Insurance Portability and Accountability Act privacy rules. The confidentiality of any such medical records shall be maintained in accordance with the confidentiality and disclosure laws of the Commonwealth.

8. Ensure that covered employees have access to the services provided by the Ombudsman and that the covered employees receive timely responses from the Ombudsman or his representatives to the inquiries.

9. Report annually on his activities to the standing committees of the General Assembly having jurisdiction over insurance and over health and the Joint Commission on Health Care by December 1 of each year.

M. The plan established in accordance with this section shall not refuse to accept or make reimbursement pursuant to an assignment of benefits made to a dentist or oral surgeon by a covered employee.

For purposes of this subsection, "assignment of benefits" means the transfer of dental care coverage reimbursement benefits or other rights under the plan. The assignment of benefits shall not be effective until the covered employee notifies the plan in writing of the assignment.

675 N. Beginning July 1, 2006, any plan established pursuant to this section shall provide for an
676 identification number, which shall be assigned to the covered employee and shall not be the same as the
677 employee's social security number.

678 O. Any group health insurance plan established by the Department of Human Resource Management
679 that contains a coordination of benefits provision shall provide written notification to any eligible
680 employee as a prominent part of its enrollment materials that if such eligible employee is covered under
681 another group accident and sickness insurance policy, group accident and sickness subscription contract,
682 or group health care plan for health care services, that insurance policy, subscription contract or health
683 care plan may have primary responsibility for the covered expenses of other family members enrolled
684 with the eligible employee. Such written notification shall describe generally the conditions upon which
685 the other coverage would be primary for dependent children enrolled under the eligible employee's
686 coverage and the method by which the eligible enrollee may verify from the plan that coverage would
687 have primary responsibility for the covered expenses of each family member.

688 P. Any plan established by the Department of Human Resource Management pursuant to this section
689 shall provide that coverage under such plan for family members enrolled under a participating state
690 employee's coverage shall continue for a period of at least 30 days following the death of such state
691 employee.

692 Q. The plan established in accordance with this section that follows a policy of sending its payment
693 to the covered employee or covered family member for a claim for services received from a
694 nonparticipating physician or osteopath shall (i) include language in the member handbook that notifies
695 the covered employee of the responsibility to apply the plan payment to the claim from such
696 nonparticipating provider, (ii) include this language with any such payment sent to the covered employee
697 or covered family member, and (iii) include the name and any last known address of the
698 nonparticipating provider on the explanation of benefits statement.

699 R. The Department of Human Resource Management shall report annually, by November 30 of each
700 year, on cost and utilization information for each of the mandated benefits set forth in subsection B,
701 including any mandated benefit made applicable, pursuant to subdivision B 22, to any plan established
702 pursuant to this section. The report shall be in the same detail and form as required of reports submitted
703 pursuant to § 38.2-3419.1, with such additional information as is required to determine the financial
704 impact, including the costs and benefits, of the particular mandated benefit.

705 **§ 2.2-2905. Certain officers and employees exempt from chapter.**

706 The provisions of this chapter shall not apply to:

- 707 1. Officers and employees for whom the Constitution specifically directs the manner of selection;
- 708 2. Officers and employees of the Supreme Court and the Court of Appeals;
- 709 3. Officers appointed by the Governor, whether confirmation by the General Assembly or by either
710 house thereof is required or not;
- 711 4. Officers elected by popular vote or by the General Assembly or either house thereof;
- 712 5. Members of boards and commissions however selected;
- 713 6. Judges, referees, receivers, arbiters, masters and commissioners in chancery, commissioners of
714 accounts, and any other persons appointed by any court to exercise judicial functions, and jurors and
715 notaries public;
- 716 7. Officers and employees of the General Assembly and persons employed to conduct temporary or
717 special inquiries, investigations, or examinations on its behalf;
- 718 8. The presidents and teaching and research staffs of state educational institutions;
- 719 9. Commissioned officers and enlisted personnel of the National Guard;
- 720 10. Student employees at institutions of higher education and patient or inmate help in other state
721 institutions;
- 722 11. Upon general or special authorization of the Governor, laborers, temporary employees, and
723 employees compensated on an hourly or daily basis;
- 724 12. County, city, town, and district officers, deputies, assistants, and employees;
- 725 13. The employees of the Virginia Workers' Compensation Commission;
- 726 14. The officers and employees of the Virginia Retirement System;
- 727 15. Employees whose positions are identified by the State Council of Higher Education and the
728 boards of the Virginia Museum of Fine Arts, The Science Museum of Virginia, the
729 Jamestown-Yorktown Foundation, the Frontier Culture Museum of Virginia, the Virginia Museum of
730 Natural History, the New College Institute, the Southern Virginia Higher Education Center, and The
731 Library of Virginia, and approved by the Director of the Department of Human Resource Management
732 as requiring specialized and professional training;
- 733 16. Employees of the Virginia Lottery;
- 734 17. Employees of the Department for the Blind and Vision Impaired's rehabilitative manufacturing
735 and service industries who have a human resources classification of industry worker;
- 736 18. Employees of the Virginia Commonwealth University Health System Authority;

19. Employees of the University of Virginia Medical Center. Any changes in compensation plans for such employees shall be subject to the review and approval of the Board of Visitors of the University of Virginia. The University of Virginia shall ensure that its procedures for hiring University of Virginia Medical Center personnel are based on merit and fitness. Such employees shall remain subject to the provisions of the State Grievance Procedure (§ 2.2-3000 et seq.);

20. In executive branch agencies the employee who has accepted serving in the capacity of chief deputy, or equivalent, and the employee who has accepted serving in the capacity of a confidential assistant for policy or administration. An employee serving in either one of these two positions shall be deemed to serve on an employment-at-will basis. An agency may not exceed two employees who serve in this exempt capacity;

21. Employees of Virginia Correctional Enterprises. Such employees shall remain subject to the provisions of the State Grievance Procedure (§ 2.2-3000 et seq.);

22. Officers and employees of the Virginia Port Authority;

23. Employees of the Virginia College Savings Plan;

24. Directors of state facilities operated by the Department of Behavioral Health and Developmental Services employed or reemployed by the Commissioner after July 1, 1999, under a contract pursuant to § 37.2-707. Such employees shall remain subject to the provisions of the State Grievance Procedure (§ 2.2-3000 et seq.);

25. Employees of the Virginia Foundation for Healthy Youth. Such employees shall be treated as state employees for purposes of participation in the Virginia Retirement System, health insurance, and all other employee benefits offered by the Commonwealth to its classified employees;

26. Employees of the Virginia Indigent Defense Commission;

27. Any chief of a campus police department that has been designated by the governing body of a public institution of higher education as exempt, pursuant to § 23.1-809;

28. The Chief Executive Officer, agents, officers, and employees of the Virginia Alcoholic Beverage Control Authority; and

29. *The Chief Executive Officer, agents, officers, and employees of the Virginia Cannabis Control Authority; and*

30. Officers and employees of the Fort Monroe Authority.

§ 2.2-3114. Disclosure by state officers and employees.

A. In accordance with the requirements set forth in § 2.2-3118.2, the Governor, Lieutenant Governor, Attorney General, Justices of the Supreme Court, judges of the Court of Appeals, judges of any circuit court, judges and substitute judges of any district court, members of the State Corporation Commission, members of the Virginia Workers' Compensation Commission, members of the Commonwealth Transportation Board, members of the Board of Trustees of the Virginia Retirement System, members of the Board of Directors of the Virginia Alcoholic Beverage Control Authority, *members of the Board of Directors of the Virginia Cannabis Control Authority*, members of the Board of the Virginia College Savings Plan, and members of the Virginia Lottery Board and other persons occupying such offices or positions of trust or employment in state government, including members of the governing bodies of authorities, as may be designated by the Governor, or officers or employees of the legislative branch, as may be designated by the Joint Rules Committee of the General Assembly, shall file with the Council, as a condition to assuming office or employment, a disclosure statement of their personal interests and such other information as is required on the form prescribed by the Council pursuant to § 2.2-3117 and thereafter shall file such a statement annually on or before February 1.

B. In accordance with the requirements set forth in § 2.2-3118.2, nonsalaried citizen members of all policy and supervisory boards, commissions and councils in the executive branch of state government, other than the Commonwealth Transportation Board, members of the Board of Trustees of the Virginia Retirement System, members of the Board of the Virginia College Savings Plan, and the Virginia Lottery Board, shall file with the Council, as a condition to assuming office, a disclosure form of their personal interests and such other information as is required on the form prescribed by the Council pursuant to § 2.2-3118 and thereafter shall file such form annually on or before February 1. Nonsalaried citizen members of other boards, commissions and councils, including advisory boards and authorities, may be required to file a disclosure form if so designated by the Governor, in which case the form shall be that prescribed by the Council pursuant to § 2.2-3118.

C. The disclosure forms required by subsections A and B shall be made available by the Council at least 30 days prior to the filing deadline. Disclosure forms shall be filed electronically with the Council in accordance with the standards approved by it pursuant to § 30-356. All forms shall be maintained as public records for five years in the office of the Council. Such forms shall be made public no later than six weeks after the filing deadline.

D. Candidates for the offices of Governor, Lieutenant Governor or Attorney General shall file a disclosure statement of their personal interests as required by § 24.2-502.

798 E. Any officer or employee of state government who has a personal interest in any transaction before
799 the governmental or advisory agency of which he is an officer or employee and who is disqualified
800 from participating in that transaction pursuant to subsection A of § 2.2-3112, or otherwise elects to
801 disqualify himself, shall forthwith make disclosure of the existence of his interest, including the full
802 name and address of the business and the address or parcel number for the real estate if the interest
803 involves a business or real estate, and his disclosure shall also be reflected in the public records of the
804 agency for five years in the office of the administrative head of the officer's or employee's governmental
805 agency or advisory agency or, if the agency has a clerk, in the clerk's office.

806 F. An officer or employee of state government who is required to declare his interest pursuant to
807 subdivision B 1 of § 2.2-3112, shall declare his interest by stating (i) the transaction involved, (ii) the
808 nature of the officer's or employee's personal interest affected by the transaction, (iii) that he is a
809 member of a business, profession, occupation, or group the members of which are affected by the
810 transaction, and (iv) that he is able to participate in the transaction fairly, objectively, and in the public
811 interest. The officer or employee shall either make his declaration orally to be recorded in written
812 minutes for his agency or file a signed written declaration with the clerk or administrative head of his
813 governmental or advisory agency, as appropriate, who shall, in either case, retain and make available for
814 public inspection such declaration for a period of five years from the date of recording or receipt. If
815 reasonable time is not available to comply with the provisions of this subsection prior to participation in
816 the transaction, the officer or employee shall prepare and file the required declaration by the end of the
817 next business day.

818 G. An officer or employee of state government who is required to declare his interest pursuant to
819 subdivision B 2 of § 2.2-3112, shall declare his interest by stating (i) the transaction involved, (ii) that a
820 party to the transaction is a client of his firm, (iii) that he does not personally represent or provide
821 services to the client, and (iv) that he is able to participate in the transaction fairly, objectively, and in
822 the public interest. The officer or employee shall either make his declaration orally to be recorded in
823 written minutes for his agency or file a signed written declaration with the clerk or administrative head
824 of his governmental or advisory agency, as appropriate, who shall, in either case, retain and make
825 available for public inspection such declaration for a period of five years from the date of recording or
826 receipt. If reasonable time is not available to comply with the provisions of this subsection prior to
827 participation in the transaction, the officer or employee shall prepare and file the required declaration by
828 the end of the next business day.

829 H. Notwithstanding any other provision of law, chairs of departments at a public institution of higher
830 education in the Commonwealth shall not be required to file the disclosure form prescribed by the
831 Council pursuant to § 2.2-3117 or 2.2-3118.

832 **§ 2.2-3705.3. Exclusions to application of chapter; records relating to administrative**
833 **investigations.**

834 The following information contained in a public record is excluded from the mandatory disclosure
835 provisions of this chapter but may be disclosed by the custodian in his discretion, except where such
836 disclosure is prohibited by law. Redaction of information excluded under this section from a public
837 record shall be conducted in accordance with § 2.2-3704.01.

838 1. Information relating to investigations of applicants for licenses and permits, and of all licensees
839 and permittees, made by or submitted to the Virginia Alcoholic Beverage Control Authority, *the Virginia*
840 *Cannabis Control Authority*, the Virginia Lottery, the Virginia Racing Commission, the Department of
841 Agriculture and Consumer Services relating to investigations and applications pursuant to Article 1.1:1
842 (§ 18.2-340.15 et seq.) of Chapter 8 of Title 18.2, or the Private Security Services Unit of the
843 Department of Criminal Justice Services.

844 2. Records of active investigations being conducted by the Department of Health Professions or by
845 any health regulatory board in the Commonwealth pursuant to § 54.1-108.

846 3. Investigator notes, and other correspondence and information, furnished in confidence with respect
847 to an active investigation of individual employment discrimination complaints made to the Department
848 of Human Resource Management, to such personnel of any local public body, including local school
849 boards, as are responsible for conducting such investigations in confidence, or to any public institution
850 of higher education. However, nothing in this subdivision shall prevent the disclosure of information
851 taken from inactive reports in a form that does not reveal the identity of charging parties, persons
852 supplying the information, or other individuals involved in the investigation.

853 4. Records of active investigations being conducted by the Department of Medical Assistance
854 Services pursuant to Chapter 10 (§ 32.1-323 et seq.) of Title 32.1.

855 5. Investigative notes and other correspondence and information furnished in confidence with respect
856 to an investigation or conciliation process involving an alleged unlawful discriminatory practice under
857 the Virginia Human Rights Act (§ 2.2-3900 et seq.) or under any local ordinance adopted in accordance
858 with the authority specified in § 2.2-524, or adopted pursuant to § 15.2-965, or adopted prior to July 1,
859 1987, in accordance with applicable law, relating to local human rights or human relations commissions.

860 However, nothing in this subdivision shall prevent the distribution of information taken from inactive
861 reports in a form that does not reveal the identity of the parties involved or other persons supplying
862 information.

863 6. Information relating to studies and investigations by the Virginia Lottery of (i) lottery agents, (ii)
864 lottery vendors, (iii) lottery crimes under §§ 58.1-4014 through 58.1-4018, (iv) defects in the law or
865 regulations that cause abuses in the administration and operation of the lottery and any evasions of such
866 provisions, or (v) the use of the lottery as a subterfuge for organized crime and illegal gambling where
867 such information has not been publicly released, published or copyrighted. All studies and investigations
868 referred to under clauses (iii), (iv), and (v) shall be open to inspection and copying upon completion of
869 the study or investigation.

870 7. Investigative notes, correspondence and information furnished in confidence, and records otherwise
871 exempted by this chapter or any Virginia statute, provided to or produced by or for (i) the Auditor of
872 Public Accounts; (ii) the Joint Legislative Audit and Review Commission; (iii) an appropriate authority
873 as defined in § 2.2-3010 with respect to an allegation of wrongdoing or abuse under the Fraud and
874 Abuse Whistle Blower Protection Act (§ 2.2-3009 et seq.); (iv) the Office of the State Inspector General
875 with respect to an investigation initiated through the Fraud, Waste and Abuse Hotline or an investigation
876 initiated pursuant to Chapter 3.2 (§ 2.2-307 et seq.); (v) internal auditors appointed by the head of a
877 state agency or by any public institution of higher education; (vi) the committee or the auditor with
878 respect to an investigation or audit conducted pursuant to § 15.2-825; or (vii) the auditors, appointed by
879 the local governing body of any county, city, or town or a school board, who by charter, ordinance, or
880 statute have responsibility for conducting an investigation of any officer, department, or program of such
881 body. Information contained in completed investigations shall be disclosed in a form that does not reveal
882 the identity of the complainants or persons supplying information to investigators. Unless disclosure is
883 excluded by this subdivision, the information disclosed shall include the agency involved, the identity of
884 the person who is the subject of the complaint, the nature of the complaint, and the actions taken to
885 resolve the complaint. If an investigation does not lead to corrective action, the identity of the person
886 who is the subject of the complaint may be released only with the consent of the subject person. Local
887 governing bodies shall adopt guidelines to govern the disclosure required by this subdivision.

888 8. The names, addresses, and telephone numbers of complainants furnished in confidence with
889 respect to an investigation of individual zoning enforcement complaints or complaints relating to the
890 Uniform Statewide Building Code (§ 36-97 et seq.) or the Statewide Fire Prevention Code (§ 27-94 et
891 seq.) made to a local governing body.

892 9. Records of active investigations being conducted by the Department of Criminal Justice Services
893 pursuant to Article 4 (§ 9.1-138 et seq.), Article 4.1 (§ 9.1-150.1 et seq.), Article 11 (§ 9.1-185 et seq.),
894 and Article 12 (§ 9.1-186 et seq.) of Chapter 1 of Title 9.1.

895 10. Information furnished to or prepared by the Board of Education pursuant to subsection D of
896 § 22.1-253.13:3 in connection with the review or investigation of any alleged breach in security,
897 unauthorized alteration, or improper administration of tests by local school board employees responsible
898 for the distribution or administration of the tests. However, this section shall not prohibit the disclosure
899 of such information to (i) a local school board or division superintendent for the purpose of permitting
900 such board or superintendent to consider or to take personnel action with regard to an employee or (ii)
901 any requester, after the conclusion of a review or investigation, in a form that (a) does not reveal the
902 identity of any person making a complaint or supplying information to the Board on a confidential basis
903 and (b) does not compromise the security of any test mandated by the Board.

904 11. Information contained in (i) an application for licensure or renewal of a license for teachers and
905 other school personnel, including transcripts or other documents submitted in support of an application,
906 and (ii) an active investigation conducted by or for the Board of Education related to the denial,
907 suspension, cancellation, revocation, or reinstatement of teacher and other school personnel licenses
908 including investigator notes and other correspondence and information, furnished in confidence with
909 respect to such investigation. However, this subdivision shall not prohibit the disclosure of such (a)
910 application information to the applicant at his own expense or (b) investigation information to a local
911 school board or division superintendent for the purpose of permitting such board or superintendent to
912 consider or to take personnel action with regard to an employee. Information contained in completed
913 investigations shall be disclosed in a form that does not reveal the identity of any complainant or person
914 supplying information to investigators. The completed investigation information disclosed shall include
915 information regarding the school or facility involved, the identity of the person who was the subject of
916 the complaint, the nature of the complaint, and the actions taken to resolve the complaint. If an
917 investigation fails to support a complaint or does not lead to corrective action, the identity of the person
918 who was the subject of the complaint may be released only with the consent of the subject person. No
919 personally identifiable information regarding a current or former student shall be released except as
920 permitted by state or federal law.

921 12. Information provided in confidence and related to an investigation by the Attorney General under
922 Article 1 (§ 3.2-4200 et seq.) or Article 3 (§ 3.2-4204 et seq.) of Chapter 42 of Title 3.2, Article 10
923 (§ 18.2-246.6 et seq.) of Chapter 6 or Chapter 13 (§ 18.2-512 et seq.) of Title 18.2, or Article 1
924 (§ 58.1-1000) of Chapter 10 of Title 58.1. However, information related to an investigation that has been
925 inactive for more than six months shall, upon request, be disclosed provided such disclosure is not
926 otherwise prohibited by law and does not reveal the identity of charging parties, complainants, persons
927 supplying information, witnesses, or other individuals involved in the investigation.

928 13. Records of active investigations being conducted by the Department of Behavioral Health and
929 Developmental Services pursuant to Chapter 4 (§ 37.2-400 et seq.) of Title 37.2.

930 **§ 2.2-3711. Closed meetings authorized for certain limited purposes.**

931 A. Public bodies may hold closed meetings only for the following purposes:

932 1. Discussion, consideration, or interviews of prospective candidates for employment; assignment,
933 appointment, promotion, performance, demotion, salaries, disciplining, or resignation of specific public
934 officers, appointees, or employees of any public body; and evaluation of performance of departments or
935 schools of public institutions of higher education where such evaluation will necessarily involve
936 discussion of the performance of specific individuals. Any teacher shall be permitted to be present
937 during a closed meeting in which there is a discussion or consideration of a disciplinary matter that
938 involves the teacher and some student and the student involved in the matter is present, provided the
939 teacher makes a written request to be present to the presiding officer of the appropriate board. Nothing
940 in this subdivision, however, shall be construed to authorize a closed meeting by a local governing body
941 or an elected school board to discuss compensation matters that affect the membership of such body or
942 board collectively.

943 2. Discussion or consideration of admission or disciplinary matters or any other matters that would
944 involve the disclosure of information contained in a scholastic record concerning any student of any
945 public institution of higher education in the Commonwealth or any state school system. However, any
946 such student, legal counsel and, if the student is a minor, the student's parents or legal guardians shall
947 be permitted to be present during the taking of testimony or presentation of evidence at a closed
948 meeting, if such student, parents, or guardians so request in writing and such request is submitted to the
949 presiding officer of the appropriate board.

950 3. Discussion or consideration of the acquisition of real property for a public purpose, or of the
951 disposition of publicly held real property, where discussion in an open meeting would adversely affect
952 the bargaining position or negotiating strategy of the public body.

953 4. The protection of the privacy of individuals in personal matters not related to public business.

954 5. Discussion concerning a prospective business or industry or the expansion of an existing business
955 or industry where no previous announcement has been made of the ~~business'~~ business's or industry's
956 interest in locating or expanding its facilities in the community.

957 6. Discussion or consideration of the investment of public funds where competition or bargaining is
958 involved, where, if made public initially, the financial interest of the governmental unit would be
959 adversely affected.

960 7. Consultation with legal counsel and briefings by staff members or consultants pertaining to actual
961 or probable litigation, where such consultation or briefing in open meeting would adversely affect the
962 negotiating or litigating posture of the public body. For the purposes of this subdivision, "probable
963 litigation" means litigation that has been specifically threatened or on which the public body or its legal
964 counsel has a reasonable basis to believe will be commenced by or against a known party. Nothing in
965 this subdivision shall be construed to permit the closure of a meeting merely because an attorney
966 representing the public body is in attendance or is consulted on a matter.

967 8. Consultation with legal counsel employed or retained by a public body regarding specific legal
968 matters requiring the provision of legal advice by such counsel. Nothing in this subdivision shall be
969 construed to permit the closure of a meeting merely because an attorney representing the public body is
970 in attendance or is consulted on a matter.

971 9. Discussion or consideration by governing boards of public institutions of higher education of
972 matters relating to gifts, bequests and fund-raising activities, and of grants and contracts for services or
973 work to be performed by such institution. However, the terms and conditions of any such gifts, bequests,
974 grants, and contracts made by a foreign government, a foreign legal entity, or a foreign person and
975 accepted by a public institution of higher education in the Commonwealth shall be subject to public
976 disclosure upon written request to the appropriate board of visitors. For the purpose of this subdivision,
977 (i) "foreign government" means any government other than the United States government or the
978 government of a state or a political subdivision thereof, (ii) "foreign legal entity" means any legal entity
979 (a) created under the laws of the United States or of any state thereof if a majority of the ownership of
980 the stock of such legal entity is owned by foreign governments or foreign persons or if a majority of the
981 membership of any such entity is composed of foreign persons or foreign legal entities or (b) created
982 under the laws of a foreign government, and (iii) "foreign person" means any individual who is not a

983 citizen or national of the United States or a trust territory or protectorate thereof.

984 10. Discussion or consideration by the boards of trustees of the Virginia Museum of Fine Arts, the
985 Virginia Museum of Natural History, the Jamestown-Yorktown Foundation, the Fort Monroe Authority,
986 and The Science Museum of Virginia of matters relating to specific gifts, bequests, and grants from
987 private sources.

988 11. Discussion or consideration of honorary degrees or special awards.

989 12. Discussion or consideration of tests, examinations, or other information used, administered, or
990 prepared by a public body and subject to the exclusion in subdivision 4 of § 2.2-3705.1.

991 13. Discussion, consideration, or review by the appropriate House or Senate committees of possible
992 disciplinary action against a member arising out of the possible inadequacy of the disclosure statement
993 filed by the member, provided the member may request in writing that the committee meeting not be
994 conducted in a closed meeting.

995 14. Discussion of strategy with respect to the negotiation of a hazardous waste siting agreement or to
996 consider the terms, conditions, and provisions of a hazardous waste siting agreement if the governing
997 body in open meeting finds that an open meeting will have an adverse effect upon the negotiating
998 position of the governing body or the establishment of the terms, conditions and provisions of the siting
999 agreement, or both. All discussions with the applicant or its representatives may be conducted in a
1000 closed meeting.

1001 15. Discussion by the Governor and any economic advisory board reviewing forecasts of economic
1002 activity and estimating general and nongeneral fund revenues.

1003 16. Discussion or consideration of medical and mental health records subject to the exclusion in
1004 subdivision 1 of § 2.2-3705.5.

1005 17. Deliberations of the Virginia Lottery Board in a licensing appeal action conducted pursuant to
1006 subsection D of § 58.1-4007 regarding the denial or revocation of a license of a lottery sales agent; and
1007 discussion, consideration or review of Virginia Lottery matters related to proprietary lottery game
1008 information and studies or investigations excluded from disclosure under subdivision 6 of § 2.2-3705.3

1010 18. Those portions of meetings in which the State Board of Local and Regional Jails discusses or
1011 discloses the identity of, or information tending to identify, any prisoner who (i) provides information
1012 about crimes or criminal activities, (ii) renders assistance in preventing the escape of another prisoner or
1013 in the apprehension of an escaped prisoner, or (iii) voluntarily or at the instance of a prison official
1014 renders other extraordinary services, the disclosure of which is likely to jeopardize the prisoner's life or
1015 safety.

1016 19. Discussion of plans to protect public safety as it relates to terrorist activity or specific
1017 cybersecurity threats or vulnerabilities and briefings by staff members, legal counsel, or law-enforcement
1018 or emergency service officials concerning actions taken to respond to such matters or a related threat to
1019 public safety; discussion of information subject to the exclusion in subdivision 2 or 14 of § 2.2-3705.2,
1020 where discussion in an open meeting would jeopardize the safety of any person or the security of any
1021 facility, building, structure, information technology system, or software program; or discussion of reports
1022 or plans related to the security of any governmental facility, building or structure, or the safety of
1023 persons using such facility, building or structure.

1024 20. Discussion by the Board of the Virginia Retirement System, acting pursuant to § 51.1-124.30, or
1025 of any local retirement system, acting pursuant to § 51.1-803, or by a local finance board or board of
1026 trustees of a trust established by one or more local public bodies to invest funds for postemployment
1027 benefits other than pensions, acting pursuant to Article 8 (§ 15.2-1544 et seq.) of Chapter 15 of Title
1028 15.2, or by the board of visitors of the University of Virginia, acting pursuant to § 23.1-2210, or by the
1029 Board of the Virginia College Savings Plan, acting pursuant to § 23.1-706, regarding the acquisition,
1030 holding or disposition of a security or other ownership interest in an entity, where such security or
1031 ownership interest is not traded on a governmentally regulated securities exchange, to the extent that
1032 such discussion (i) concerns confidential analyses prepared for the board of visitors of the University of
1033 Virginia, prepared by the retirement system, or a local finance board or board of trustees, or the Virginia
1034 College Savings Plan or provided to the retirement system, a local finance board or board of trustees, or
1035 the Virginia College Savings Plan under a promise of confidentiality, of the future value of such
1036 ownership interest or the future financial performance of the entity, and (ii) would have an adverse
1037 effect on the value of the investment to be acquired, held, or disposed of by the retirement system, a
1038 local finance board or board of trustees, the board of visitors of the University of Virginia, or the
1039 Virginia College Savings Plan. Nothing in this subdivision shall be construed to prevent the disclosure
1040 of information relating to the identity of any investment held, the amount invested or the present value
1041 of such investment.

1042 21. Those portions of meetings in which individual child death cases are discussed by the State Child
1043 Fatality Review Team established pursuant to § 32.1-283.1, those portions of meetings in which

individual child death cases are discussed by a regional or local child fatality review team established pursuant to § 32.1-283.2, those portions of meetings in which individual death cases are discussed by family violence fatality review teams established pursuant to § 32.1-283.3, those portions of meetings in which individual adult death cases are discussed by the state Adult Fatality Review Team established pursuant to § 32.1-283.5, those portions of meetings in which individual adult death cases are discussed by a local or regional adult fatality review team established pursuant to § 32.1-283.6, those portions of meetings in which individual death cases are discussed by overdose fatality review teams established pursuant to § 32.1-283.7, those portions of meetings in which individual maternal death cases are discussed by the Maternal Mortality Review Team pursuant to § 32.1-283.8, and those portions of meetings in which individual death cases of persons with developmental disabilities are discussed by the Developmental Disabilities Mortality Review Committee established pursuant to § 37.2-314.1.

22. Those portions of meetings of the board of visitors of the University of Virginia or the Eastern Virginia Medical School Board of Visitors, as the case may be, and those portions of meetings of any persons to whom management responsibilities for the University of Virginia Medical Center or Eastern Virginia Medical School, as the case may be, have been delegated, in which there is discussed proprietary, business-related information pertaining to the operations of the University of Virginia Medical Center or Eastern Virginia Medical School, as the case may be, including business development or marketing strategies and activities with existing or future joint venturers, partners, or other parties with whom the University of Virginia Medical Center or Eastern Virginia Medical School, as the case may be, has formed, or forms, any arrangement for the delivery of health care, if disclosure of such information would adversely affect the competitive position of the Medical Center or Eastern Virginia Medical School, as the case may be.

23. Discussion or consideration by the Virginia Commonwealth University Health System Authority or the board of visitors of Virginia Commonwealth University of any of the following: the acquisition or disposition by the Authority of real property, equipment, or technology software or hardware and related goods or services, where disclosure would adversely affect the bargaining position or negotiating strategy of the Authority; matters relating to gifts or bequests to, and fund-raising activities of, the Authority; grants and contracts for services or work to be performed by the Authority; marketing or operational strategies plans of the Authority where disclosure of such strategies or plans would adversely affect the competitive position of the Authority; and members of the Authority's medical and teaching staffs and qualifications for appointments thereto.

24. Those portions of the meetings of the Health Practitioners' Monitoring Program Committee within the Department of Health Professions to the extent such discussions identify any practitioner who may be, or who actually is, impaired pursuant to Chapter 25.1 (§ 54.1-2515 et seq.) of Title 54.1.

25. Meetings or portions of meetings of the Board of the Virginia College Savings Plan wherein personal information, as defined in § 2.2-3801, which has been provided to the Board or its employees by or on behalf of individuals who have requested information about, applied for, or entered into prepaid tuition contracts or savings trust account agreements pursuant to Chapter 7 (§ 23.1-700 et seq.) of Title 23.1 is discussed.

26. Discussion or consideration, by the former Wireless Carrier E-911 Cost Recovery Subcommittee created pursuant to former § 56-484.15, of trade secrets submitted by CMRS providers, as defined in § 56-484.12, related to the provision of wireless E-911 service.

27. Those portions of disciplinary proceedings by any regulatory board within the Department of Professional and Occupational Regulation, Department of Health Professions, or the Board of Accountancy conducted pursuant to § 2.2-4019 or 2.2-4020 during which the board deliberates to reach a decision or meetings of health regulatory boards or conference committees of such boards to consider settlement proposals in pending disciplinary actions or modifications to previously issued board orders as requested by either of the parties.

28. Discussion or consideration of information subject to the exclusion in subdivision 11 of § 2.2-3705.6 by a responsible public entity or an affected locality or public entity, as those terms are defined in § 33.2-1800, or any independent review panel appointed to review information and advise the responsible public entity concerning such records.

29. Discussion of the award of a public contract involving the expenditure of public funds, including interviews of bidders or offerors, and discussion of the terms or scope of such contract, where discussion in an open session would adversely affect the bargaining position or negotiating strategy of the public body.

30. Discussion or consideration of grant or loan application information subject to the exclusion in subdivision 17 of § 2.2-3705.6 by the Commonwealth Health Research Board.

31. Discussion or consideration by the Commitment Review Committee of information subject to the exclusion in subdivision 5 of § 2.2-3705.2 relating to individuals subject to commitment as sexually violent predators under Chapter 9 (§ 37.2-900 et seq.) of Title 37.2.

32. Discussion or consideration of confidential proprietary information and trade secrets developed

and held by a local public body providing certain telecommunication services or cable television services and subject to the exclusion in subdivision 18 of § 2.2-3705.6. However, the exemption provided by this subdivision shall not apply to any authority created pursuant to the BVU Authority Act (§ 15.2-7200 et seq.).

33. Discussion or consideration by a local authority created in accordance with the Virginia Wireless Service Authorities Act (§ 15.2-5431.1 et seq.) of confidential proprietary information and trade secrets subject to the exclusion in subdivision 19 of § 2.2-3705.6.

34. Discussion or consideration by the State Board of Elections or local electoral boards of voting security matters made confidential pursuant to § 24.2-410.2 or 24.2-625.1.

35. Discussion or consideration by the Forensic Science Board or the Scientific Advisory Committee created pursuant to Article 2 (§ 9.1-1109 et seq.) of Chapter 11 of Title 9.1 of criminal investigative files.

36. Discussion or consideration by the Brown v. Board of Education Scholarship Committee of information or confidential matters subject to the exclusion in subdivision A 3 of § 2.2-3705.4, and meetings of the Committee to deliberate concerning the annual maximum scholarship award, review and consider scholarship applications and requests for scholarship award renewal, and cancel, rescind, or recover scholarship awards.

37. Discussion or consideration by the Virginia Port Authority of information subject to the exclusion in subdivision 1 of § 2.2-3705.6 related to certain proprietary information gathered by or for the Virginia Port Authority.

38. Discussion or consideration by the Board of Trustees of the Virginia Retirement System acting pursuant to § 51.1-124.30, by the Investment Advisory Committee appointed pursuant to § 51.1-124.26, by any local retirement system, acting pursuant to § 51.1-803, by the Board of the Virginia College Savings Plan acting pursuant to § 23.1-706, or by the Virginia College Savings Plan's Investment Advisory Committee appointed pursuant to § 23.1-702 of information subject to the exclusion in subdivision 24 of § 2.2-3705.7.

39. Discussion or consideration of information subject to the exclusion in subdivision 3 of § 2.2-3705.6 related to economic development.

40. Discussion or consideration by the Board of Education of information relating to the denial, suspension, or revocation of teacher licenses subject to the exclusion in subdivision 11 of § 2.2-3705.3.

41. Those portions of meetings of the Virginia Military Advisory Council or any commission created by executive order for the purpose of studying and making recommendations regarding preventing closure or realignment of federal military and national security installations and facilities located in Virginia and relocation of such facilities to Virginia, or a local or regional military affairs organization appointed by a local governing body, during which there is discussion of information subject to the exclusion in subdivision 8 of § 2.2-3705.2.

42. Discussion or consideration by the Board of Trustees of the Veterans Services Foundation of information subject to the exclusion in subdivision 28 of § 2.2-3705.7 related to personally identifiable information of donors.

43. Discussion or consideration by the Virginia Tobacco Region Revitalization Commission of information subject to the exclusion in subdivision 23 of § 2.2-3705.6 related to certain information contained in grant applications.

44. Discussion or consideration by the board of directors of the Commercial Space Flight Authority of information subject to the exclusion in subdivision 24 of § 2.2-3705.6 related to rate structures or charges for the use of projects of, the sale of products of, or services rendered by the Authority and certain proprietary information of a private entity provided to the Authority.

45. Discussion or consideration of personal and proprietary information related to the resource management plan program and subject to the exclusion in (i) subdivision 25 of § 2.2-3705.6 or (ii) subsection E of § 10.1-104.7. This exclusion shall not apply to the discussion or consideration of records that contain information that has been certified for release by the person who is the subject of the information or transformed into a statistical or aggregate form that does not allow identification of the person who supplied, or is the subject of, the information.

46. Discussion or consideration by the Board of Directors of the Virginia Alcoholic Beverage Control Authority or the Board of Directors of the Virginia Cannabis Control Authority of information subject to the exclusion in subdivision 1 of § 2.2-3705.3 related to investigations of applicants for licenses and permits and of licensees and permittees.

47. Discussion or consideration of grant, loan, or investment application records subject to the exclusion in subdivision 28 of § 2.2-3705.6 for a grant, loan, or investment pursuant to Article 11 (§ 2.2-2351 et seq.) of Chapter 22.

48. Discussion or development of grant proposals by a regional council established pursuant to Article 26 (§ 2.2-2484 et seq.) of Chapter 24 to be submitted for consideration to the Virginia Growth

1167 and Opportunity Board.

1168 49. Discussion or consideration of (i) individual sexual assault cases by a sexual assault response
1169 team established pursuant to § 15.2-1627.4, (ii) individual child abuse or neglect cases or sex offenses
1170 involving a child by a child sexual abuse response team established pursuant to § 15.2-1627.5, or (iii)
1171 individual cases involving abuse, neglect, or exploitation of adults as defined in § 63.2-1603 pursuant to
1172 §§ 15.2-1627.5 and 63.2-1605.

1173 50. Discussion or consideration by the Board of the Virginia Economic Development Partnership
1174 Authority, the Joint Legislative Audit and Review Commission, or any subcommittees thereof, of the
1175 portions of the strategic plan, marketing plan, or operational plan exempt from disclosure pursuant to
1176 subdivision 33 of § 2.2-3705.7.

1177 51. Those portions of meetings of the subcommittee of the Board of the Virginia Economic
1178 Development Partnership Authority established pursuant to subsection F of § 2.2-2237.3 to review and
1179 discuss information received from the Virginia Employment Commission pursuant to subdivision C 2 of
1180 § 60.2-114.

1181 52. Discussion or consideration by the Commonwealth of Virginia Innovation Partnership Authority
1182 (the Authority), an advisory committee of the Authority, or any other entity designated by the Authority,
1183 of information subject to the exclusion in subdivision 35 of § 2.2-3705.7.

1184 53. Deliberations of the Virginia Lottery Board conducted pursuant to § 58.1-4105 regarding the
1185 denial or revocation of a license of a casino gaming operator, or the refusal to issue, suspension of, or
1186 revocation of any license or permit related to casino gaming, and discussion, consideration, or review of
1187 matters related to investigations excluded from mandatory disclosure under subdivision 1 of
1188 § 2.2-3705.3.

1189 54. Deliberations of the Virginia Lottery Board in an appeal conducted pursuant to § 58.1-4007
1190 regarding the denial of, revocation of, suspension of, or refusal to renew any license or permit related to
1191 sports betting and any discussion, consideration, or review of matters related to investigations excluded
1192 from mandatory disclosure under subdivision 1 of § 2.2-3705.3.

1193 B. No resolution, ordinance, rule, contract, regulation or motion adopted, passed or agreed to in a
1194 closed meeting shall become effective unless the public body, following the meeting, reconvenes in open
1195 meeting and takes a vote of the membership on such resolution, ordinance, rule, contract, regulation, or
1196 motion that shall have its substance reasonably identified in the open meeting.

1197 C. Public officers improperly selected due to the failure of the public body to comply with the other
1198 provisions of this section shall be de facto officers and, as such, their official actions are valid until they
1199 obtain notice of the legal defect in their election.

1200 D. Nothing in this section shall be construed to prevent the holding of conferences between two or
1201 more public bodies, or their representatives, but these conferences shall be subject to the same
1202 procedures for holding closed meetings as are applicable to any other public body.

1203 E. This section shall not be construed to (i) require the disclosure of any contract between the
1204 Department of Health Professions and an impaired practitioner entered into pursuant to Chapter 25.1
1205 (§ 54.1-2515 et seq.) of Title 54.1 or (ii) require the board of directors of any authority created pursuant
1206 to the Industrial Development and Revenue Bond Act (§ 15.2-4900 et seq.), or any public body
1207 empowered to issue industrial revenue bonds by general or special law, to identify a business or industry
1208 to which subdivision A 5 applies. However, such business or industry shall be identified as a matter of
1209 public record at least 30 days prior to the actual date of the board's authorization of the sale or issuance
1210 of such bonds.

1211 **§ 2.2-3802. Systems to which chapter inapplicable.**

1212 The provisions of this chapter shall not apply to personal information systems:

1213 1. Maintained by any court of the Commonwealth;

1214 2. Which may exist in publications of general circulation;

1215 3. Contained in the Criminal Justice Information System as defined in §§ 9.1-126 through 9.1-137 or
1216 in the Sex Offender and Crimes Against Minors Registry maintained by the Department of State Police
1217 pursuant to Chapter 9 (§ 9.1-900 et seq.) of Title 9.1, except to the extent that information is required to
1218 be posted on the Internet pursuant to § 9.1-913;

1219 4. Contained in the Virginia Juvenile Justice Information System as defined in §§ 16.1-222 through
1220 16.1-225;

1221 5. Maintained by agencies concerning persons required by law to be licensed in the Commonwealth
1222 to engage in the practice of any profession, in which case the names and addresses of persons applying
1223 for or possessing the license may be disseminated upon written request to a person engaged in the
1224 profession or business of offering professional educational materials or courses for the sole purpose of
1225 providing the licensees or applicants for licenses with informational materials relating solely to available
1226 professional educational materials or courses, provided the disseminating agency is reasonably assured
1227 that the use of the information will be so limited;

1228 6. Maintained by the Parole Board, the Crime Commission, the Judicial Inquiry and Review

Commission, the Virginia Racing Commission, the Virginia Criminal Sentencing Commission, ~~and~~ the Virginia Alcoholic Beverage Control Authority, *and the Virginia Cannabis Control Authority*;

7. Maintained by any of the following and that deal with investigations and intelligence gathering related to criminal activity:

- a. The Department of State Police;
- b. The police department of the Chesapeake Bay Bridge and Tunnel Commission;
- c. Police departments of cities, counties, and towns;
- d. Sheriff's departments of counties and cities;
- e. Campus police departments of public institutions of higher education as established by Article 3 (§ 23.1-809 et seq.) of Chapter 8 of Title 23.1; and
- f. The Division of Capitol Police.

8. Maintained by local departments of social services regarding alleged cases of child abuse or neglect while such cases are also subject to an ongoing criminal prosecution;

9. Maintained by the Virginia Port Authority as provided in § 62.1-132.4 or 62.1-134.1;

10. Maintained by the Virginia Tourism Authority in connection with or as a result of the promotion of travel or tourism in the Commonwealth, in which case names and addresses of persons requesting information on those subjects may be disseminated upon written request to a person engaged in the business of providing travel services or distributing travel information, provided the Virginia Tourism Authority is reasonably assured that the use of the information will be so limited;

11. Maintained by the Division of Consolidated Laboratory Services of the Department of General Services and the Department of Forensic Science, which deal with scientific investigations relating to criminal activity or suspected criminal activity, except to the extent that § 9.1-1104 may apply;

12. Maintained by the Department of Corrections or the Office of the State Inspector General that deal with investigations and intelligence gathering by persons acting under the provisions of Chapter 3.2 (§ 2.2-307 et seq.);

13. Maintained by (i) the Office of the State Inspector General or internal audit departments of state agencies or institutions that deal with communications and investigations relating to the Fraud, Waste and Abuse Hotline or (ii) an auditor appointed by the local governing body of any county, city, or town or a school board that deals with local investigations required by § 15.2-2511.2;

14. Maintained by the Department of Social Services or any local department of social services relating to public assistance fraud investigations;

15. Maintained by the Department of Social Services related to child welfare or public assistance programs when requests for personal information are made to the Department of Social Services. Requests for information from these systems shall be made to the appropriate local department of social services that is the custodian of that record. Notwithstanding the language in this section, an individual shall not be prohibited from obtaining information from the central registry in accordance with the provisions of § 63.2-1515; and

16. Maintained by the Department for Aging and Rehabilitative Services related to adult services, adult protective services, or auxiliary grants when requests for personal information are made to the Department for Aging and Rehabilitative Services. Requests for information from these systems shall be made to the appropriate local department of social services that is the custodian of that record.

§ 2.2-4024. Hearing officers.

A. In all formal hearings conducted in accordance with § 2.2-4020, the hearing shall be presided over by a hearing officer selected from a list prepared by the Executive Secretary of the Supreme Court and maintained in the Office of the Executive Secretary of the Supreme Court. Parties to informal fact-finding proceedings conducted pursuant to § 2.2-4019 may agree at the outset of the proceeding to have a hearing officer preside at the proceeding, such agreement to be revoked only by mutual consent. The Executive Secretary may promulgate rules necessary for the administration of the hearing officer system and shall have the authority to establish the number of hearing officers necessary to preside over administrative hearings in the Commonwealth.

Prior to being included on the list, all hearing officers shall meet the following minimum standards:

- 1. Active membership in good standing in the Virginia State Bar;
- 2. Active practice of law for at least five years; and
- 3. Completion of a course of training approved by the Executive Secretary of the Supreme Court. In order to comply with the demonstrated requirements of the agency requesting a hearing officer, the Executive Secretary may require additional training before a hearing officer shall be assigned to a proceeding before that agency.

B. On request from the head of an agency, the Executive Secretary shall name a hearing officer from the list, selected on a rotation system administered by the Executive Secretary. Lists reflecting geographic preference and specialized training or knowledge shall be maintained by the Executive Secretary if an agency demonstrates the need.

1290 C. A hearing officer appointed in accordance with this section shall be subject to disqualification as
1291 provided in § 2.2-4024.1. If the hearing officer denies a petition for disqualification pursuant to
1292 § 2.2-4024.1, the petitioning party may request reconsideration of the denial by filing a written request
1293 with the Executive Secretary along with an affidavit, prior to the taking of evidence at a hearing, stating
1294 with particularity the grounds upon which it is claimed that a fair and impartial hearing cannot be
1295 accorded, or the applicable rule of practice requiring disqualification.

1296 The issue shall be determined not less than 10 days prior to the hearing by the Executive Secretary.

1297 D. Any hearing officer empowered by the agency to provide a recommendation or conclusion in a
1298 case decision matter shall render that recommendation or conclusion as follows:

1299 1. If the agency's written regulations or procedures require the hearing officer to render a
1300 recommendation or conclusion within a specified time period, the hearing officer shall render the
1301 recommendation or conclusion on or before the expiration of the specified period; and

1302 2. In all other cases, the hearing officer shall render the recommendation or conclusion within 90
1303 days from the date of the case decision proceeding or from a later date agreed to by the named party
1304 and the agency.

1305 If the hearing officer does not render a decision within the time required by this subsection, then the
1306 agency or the named party to the case decision may provide written notice to the hearing officer and the
1307 Executive Secretary of the Supreme Court that a decision is due. If no decision is made within 30 days
1308 from receipt by the hearing officer of the notice, then the Executive Secretary of the Supreme Court
1309 shall remove the hearing officer from the hearing officer list and report the hearing officer to the
1310 Virginia State Bar for possible disciplinary action, unless good cause is shown for the delay.

1311 E. The Executive Secretary shall remove hearing officers from the list, upon a showing of cause after
1312 written notice and an opportunity for a hearing. When there is a failure by a hearing officer to render a
1313 decision as required by subsection D, the burden shall be on the hearing officer to show good cause for
1314 the delay. Decisions to remove a hearing officer may be reviewed by a request to the Executive
1315 Secretary for reconsideration, followed by judicial review in accordance with this chapter.

1316 F. This section shall not apply to hearings conducted by (i) any commission or board where all of
1317 the members, or a quorum, are present; (ii) the Virginia Alcoholic Beverage Control Authority, *the*
1318 *Virginia Cannabis Control Authority*, the Virginia Workers' Compensation Commission, the State
1319 Corporation Commission, the Virginia Employment Commission, the Department of Motor Vehicles
1320 under Title 46.2 (§ 46.2-100 et seq.), § 58.1-2409, or Chapter 27 (§ 58.1-2700 et seq.) of Title 58.1, or
1321 the Motor Vehicle Dealer Board under Chapter 15 (§ 46.2-1500 et seq.) of Title 46.2; or (iii) any panel
1322 of a health regulatory board convened pursuant to § 54.1-2400, including any panel having members of
1323 a relevant advisory board to the Board of Medicine. All employees hired after July 1, 1986, pursuant to
1324 §§ 65.2-201 and 65.2-203 by the Virginia Workers' Compensation Commission to conduct hearings
1325 pursuant to its basic laws shall meet the minimum qualifications set forth in subsection A. Agency
1326 employees who are not licensed to practice law in the Commonwealth, and are presiding as hearing
1327 officers in proceedings pursuant to clause (ii) shall participate in periodic training courses.

1328 G. Notwithstanding the exemptions of subsection A of § 2.2-4002, this article shall apply to hearing
1329 officers conducting hearings of the kind described in § 2.2-4020 for the Department of Wildlife
1330 Resources, the Virginia Housing Development Authority, the Milk Commission, and the Virginia
1331 Resources Authority pursuant to their basic laws.

1332 **§ 3.2-1010. Enforcement of chapter; summons.**

1333 Any conservation police officer or law-enforcement officer as defined in § 9.1-101, excluding certain
1334 members of the Virginia Alcoholic Beverage Control Authority *and the Virginia Cannabis Control*
1335 *Authority*, may enforce the provisions of this chapter and the regulations adopted hereunder as well as
1336 those who are so designated by the Commissioner. Those designated by the Commissioner may issue a
1337 summons to any person who violates any provision of this chapter to appear at a time and place to be
1338 specified in such summons.

1339 **§ 3.2-3906. Board to adopt regulations.**

1340 The Board may adopt regulations pursuant to the Administrative Process Act (§ 2.2-4000 et seq.),
1341 including:

- 1342 1. Licensing of businesses that manufacture, sell, store, recommend for use, mix, or apply pesticides;
- 1343 2. Registration of pesticides for manufacture, distribution, sale, storage, or use;
- 1344 3. Requiring reporting and record keeping related to licensing and registration;
- 1345 4. Establishing training, testing and standards for certification of commercial applicators, registered
1346 technicians, and private applicators;
- 1347 5. Revoking, suspending or denying licenses (business), registration (products), and certification or
1348 certificate (applicators or technicians);
- 1349 6. Requiring licensees and certificate holders to inform the public when using pesticides in and
1350 around structures;
- 1351 7. Establishing a fee structure for licensure, registration and certification to defray the costs of

implementing this chapter;

8. Classifying or subclassifying certification or certificates to be issued under this chapter. Such classifications may include agricultural, forest, ornamental, aquatic, right-of-way or industrial, institutional, structural or health-related pest control;

9. Restricting or prohibiting the sale or use and disposal of any pesticide or pesticide container or residuals that: (i) undesirably persists in the environment or increases due to biological amplification or unreasonable adverse effects on the environment; or (ii) because of toxicity or inordinate hazard to man, animal, bird or plant may be contrary to the public interest; ~~and~~

10. *Establishing criteria for or a list of pesticides that may be used on cannabis cultivated in compliance with Chapter 41.1 (§ 3.2-4112 et seq.) or the Cannabis Control Act (§ 4.1-600 et seq.); and*

11. Other regulations necessary or convenient to carry out the purposes of this chapter.

§ 3.2-4113. Production of industrial hemp lawful.

A. It is lawful for a grower, his agent, or a federally licensed hemp producer to grow, a dealer or his agent to deal in, or a processor or his agent to process industrial hemp in the Commonwealth for any lawful purpose. No federally licensed hemp producer or grower or his agent shall be prosecuted under Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or § ~~18.2-247~~, 18.2-248, 18.2-248.01, ~~18.2-248.1~~, or 18.2-250 for the possession or growing of industrial hemp or any Cannabis sativa with a tetrahydrocannabinol concentration that does not exceed the total delta-9 tetrahydrocannabinol concentration percentage established in federal regulations applicable to negligent violations located at 7 C.F.R. 990.6(b)(3). No dealer or his agent or processor or his agent shall be prosecuted under Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or § ~~18.2-247~~, 18.2-248, 18.2-248.01, ~~18.2-248.1~~, or 18.2-250 or issued a summons or judgment for the possession, dealing, or processing of industrial hemp. In any complaint, information, or indictment, and in any action or proceeding brought for the enforcement of any provision of *Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1*, Article 1 (§ 18.2-247 et seq.) of Chapter 7 of Title 18.2 or the Drug Control Act (§ 54.1-3400 et seq.), it shall not be necessary to negate any exception, excuse, proviso, or exemption contained in this chapter or the Drug Control Act, and the burden of proof of any such exception, excuse, proviso, or exemption shall be on the defendant.

B. Nothing in this chapter shall be construed to authorize any person to violate any federal law or regulation.

C. No person shall be prosecuted under Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or § ~~18.2-247~~, 18.2-248, 18.2-248.01, ~~18.2-248.1~~, or 18.2-250 for the involuntary growth of industrial hemp through the inadvertent natural spread of seeds or pollen as a result of proximity to a production field, dealership, or process site.

§ 3.2-4116. Registration conditions.

A. A person ~~who is not a federally licensed hemp producer~~ shall obtain a registration pursuant to subsection A of § 3.2-4115 prior to growing, dealing in, or processing any industrial hemp in the Commonwealth.

B. A person issued a registration pursuant to subsection A of § 3.2-4115 shall:

1. Maintain records that reflect compliance with this chapter *and all other state and federal laws regulating the growing, dealing in, or processing of industrial hemp*;

2. Retain all industrial hemp growing, dealing, or processing records for at least three years;

3. Allow his production field, dealership, or process site to be inspected by and at the discretion of the Commissioner or his designee, the Department of State Police, or the chief law-enforcement officer of the locality in which the production field or dealership or process site exists;

4. Allow the Commissioner or his designee to monitor and test the grower's, dealer's, or processor's industrial hemp for compliance with tetrahydrocannabinol levels and for other appropriate purposes established pursuant to § 3.2-4114, at the cost of the grower, dealer, or processor; and

5. If required by the Commissioner, destroy, at the cost of the grower, dealer, or processor and in a manner approved of and verified by the Commissioner, any Cannabis sativa that the grower grows, the dealer deals in, or the processor processes that has been tested and, following any re-sampling and retesting as authorized pursuant to the provisions of § 3.2-4114.2, is found to have a concentration of tetrahydrocannabinol that is greater than that allowed by federal law, or any Cannabis sativa product that the processor produces.

Article 6.

Edible Marijuana Products and Edible Hemp Products.

§ 3.2-5145.6. Definitions.

As used in this article, unless the context requires a different meaning:

"Edible hemp product" means the same as that term is defined in § 4.1-600.

"Edible marijuana product" means the same as that term is defined in § 4.1-600.

"Food" means any article that is intended for human consumption and introduction into commerce, whether the article is simple, mixed, or compound, and all substances or ingredients used in the

1413 preparation thereof. "Food" does not mean "drug" as defined in § 54.1-3401.

1414 § 3.2-5145.7. **Edible marijuana products and edible hemp products; approved food; adulterated**
1415 **food.**

1416 A. An edible marijuana product or edible hemp product is a food and is subject to the requirements
1417 of this chapter and regulations adopted pursuant to this chapter.

1418 B. An edible marijuana product or edible hemp product that does not comply with the provisions of
1419 § 4.1-1403 or health and safety regulations adopted pursuant thereto shall be deemed to be adulterated.

1420 § 3.2-5145.8. **Manufacturer of edible marijuana products or edible hemp products.**

1421 A manufacturer of an edible marijuana product or edible hemp product shall be an approved source
1422 if the manufacturer operates:

1423 1. Under inspection by the Commissioner in the location in which such manufacturing occurs; and

1424 2. In compliance with the laws, regulations, or criteria that pertain to the manufacture of edible
1425 marijuana products or edible hemp products in the location in which such manufacturing occurs.

1426 § 3.2-5145.9. **Regulations.**

1427 A. The Board is authorized to adopt regulations for the efficient enforcement of this article.

1428 B. With the exception of § 2.2-4031, neither the provisions of the Administrative Process Act
1429 (§ 2.2-4000 et seq.) nor public participation guidelines adopted pursuant thereto shall apply to the
1430 adoption of any regulation pursuant to this section. Prior to adopting any regulation pursuant to this
1431 section, the Board shall publish a notice of opportunity to comment in the Virginia Register of
1432 Regulations and post the action on the Virginia Regulatory Town Hall. Such notice of opportunity to
1433 comment shall contain (i) a summary of the proposed regulation; (ii) the text of the proposed
1434 regulation; and (iii) the name, address, and telephone number of the agency contact person responsible
1435 for receiving public comments. Such notice shall be made at least 60 days in advance of the last date
1436 prescribed in such notice for submittals of public comment. The legislative review provisions of
1437 subsections A and B of § 2.2-4014 shall apply to the promulgation or final adoption process for
1438 regulations adopted pursuant to this section. The Board shall consider and keep on file all public
1439 comments received for any regulation adopted pursuant to this section.

1440 § 4.1-100. **Definitions.**

1441 As used in this ~~title~~ subtitle, unless the context requires a different meaning:

1442 "Alcohol" means the product known as ethyl or grain alcohol obtained by distillation of any
1443 fermented liquor, rectified either once or more often, whatever the origin, and shall include synthetic
1444 ethyl alcohol, but shall not include methyl alcohol and alcohol completely denatured in accordance with
1445 formulas approved by the government of the United States.

1446 "Alcoholic Beverage Control Act" means Subtitle I (§ 4.1-100 et seq.).

1447 "Alcohol vaporizing device" means any device, machine, or process that mixes any alcoholic
1448 beverages with pure oxygen or other gas to produce a vaporized product for the purpose of consumption
1449 by inhalation.

1450 "Alcoholic beverages" includes alcohol, spirits, wine, and beer, and any one or more of such varieties
1451 containing one-half of one percent or more of alcohol by volume, including mixed alcoholic beverages,
1452 and every liquid or solid, powder or crystal, patented or not, containing alcohol, spirits, wine, or beer
1453 and capable of being consumed by a human being. Any liquid or solid containing more than one of the
1454 four varieties shall be considered as belonging to that variety which has the higher percentage of
1455 alcohol, however obtained, according to the order in which they are set forth in this definition; except
1456 that beer may be manufactured to include flavoring materials and other nonbeverage ingredients
1457 containing alcohol, as long as no more than 49 percent of the overall alcohol content of the finished
1458 product is derived from the addition of flavors and other nonbeverage ingredients containing alcohol for
1459 products with an alcohol content of no more than six percent by volume; or, in the case of products
1460 with an alcohol content of more than six percent by volume, as long as no more than one and one-half
1461 percent of the volume of the finished product consists of alcohol derived from added flavors and other
1462 nonbeverage ingredients containing alcohol.

1463 "Arts venue" means a commercial or nonprofit establishment that is open to the public and in which
1464 works of art are sold or displayed.

1465 "Authority" means the Virginia Alcoholic Beverage Control Authority created pursuant to this ~~title~~
1466 subtitle.

1467 "Barrel" means any container or vessel having a capacity of more than 43 ounces.

1468 "Bed and breakfast establishment" means any establishment (i) having no more than 15 bedrooms;
1469 (ii) offering to the public, for compensation, transitory lodging or sleeping accommodations; and (iii)
1470 offering at least one meal per day, which may but need not be breakfast, to each person to whom
1471 overnight lodging is provided. For purposes of the licensing requirements of this ~~title~~ subtitle, "bed and
1472 breakfast establishment" includes any property offered to the public for short-term rental, as that term is
1473 defined in § 15.2-983, other than a hotel as defined in this section, regardless of whether a meal is
1474 offered to each person to whom overnight lodging is provided.

"Beer" means any alcoholic beverage obtained by the fermentation of an infusion or decoction of barley, malt, and hops or of any similar products in drinkable water and containing one-half of one percent or more of alcohol by volume.

"Board" means the Board of Directors of the Virginia Alcoholic Beverage Control Authority.

"Bottle" means any vessel intended to contain liquids and having a capacity of not more than 43 ounces.

"Bus" means a motor vehicle that (i) is operated by a common carrier licensed under Chapter 20 (§ 46.2-2000 et seq.) of Title 46.2 to transport passengers for compensation over the highways of the Commonwealth on regular or irregular routes of not less than 100 miles, (ii) seats no more than 24 passengers, (iii) is 40 feet in length or longer, (iv) offers wireless Internet services, (v) is equipped with charging stations at every seat for cellular phones or other portable devices, and (vi) during the transportation of passengers, is staffed by an attendant who has satisfied all training requirements set forth in this ~~title~~ subtitle or Board regulation.

"Club" means any private nonprofit corporation or association which is the owner, lessee, or occupant of an establishment operated solely for a national, social, patriotic, political, athletic, or other like purpose, but not for pecuniary gain, the advantages of which belong to all of the members. It also means the establishment so operated. A corporation or association shall not lose its status as a club because of the conduct of charitable gaming conducted pursuant to Article 1.1:1 (§ 18.2-340.15 et seq.) of Chapter 8 of Title 18.2 in which nonmembers participate frequently or in large numbers, provided that no alcoholic beverages are served or consumed in the room where such charitable gaming is being conducted while such gaming is being conducted and that no alcoholic beverages are made available upon the premises to any person who is neither a member nor a bona fide guest of a member.

Any such corporation or association which has been declared exempt from federal and state income taxes as one which is not organized and operated for pecuniary gain or profit shall be deemed a nonprofit corporation or association.

"Commercial lifestyle center" means a mixed-use commercial development covering a minimum of 10 acres of land and having at least 100,000 square feet of retail space featuring national specialty chain stores and a combination of dining, entertainment, office, residential, or hotel establishments located in a physically integrated outdoor setting that is pedestrian friendly and that is governed by a commercial owners' association that is responsible for the management, maintenance, and operation of the common areas thereof.

"Container" means any barrel, bottle, carton, keg, vessel, or other receptacle used for holding alcoholic beverages.

"Contract winemaking facility" means the premises of a licensed winery or farm winery that obtains grapes, fruits, and other agricultural products from a person holding a farm winery license and crushes, processes, ferments, bottles, or provides any combination of such services pursuant to an agreement with the farm winery licensee. For all purposes of this ~~title~~ subtitle, wine produced by a contract winemaking facility for a farm winery shall be considered to be wine owned and produced by the farm winery that supplied the grapes, fruits, or other agricultural products used in the production of the wine. The contract winemaking facility shall have no right to sell the wine so produced, unless the terms of payment have not been fulfilled in accordance with the contract. The contract winemaking facility may charge the farm winery for its services.

"Convenience grocery store" means an establishment that (i) has an enclosed room in a permanent structure where stock is displayed and offered for sale and (ii) maintains an inventory of edible items intended for human consumption consisting of a variety of such items of the types normally sold in grocery stores.

"Culinary lodging resort" means a facility (i) having not less than 13 overnight guest rooms in a building that has at least 20,000 square feet of indoor floor space; (ii) located on a farm in the Commonwealth with at least 1,000 acres of land zoned agricultural; (iii) equipped with a full-service kitchen; and (iv) offering to the public, for compensation, at least one meal per day, lodging, and recreational and educational activities related to farming, livestock, and other rural activities.

"Delicatessen" means an establishment that sells a variety of prepared foods or foods requiring little preparation, such as cheeses, salads, cooked meats, and related condiments.

"Designated area" means a room or area approved by the Board for on-premises licensees.

"Dining area" means a public room or area in which meals are regularly served.

"Drugstore" means an establishment that sells medicines prepared by a licensed pharmacist pursuant to a prescription and other medicines and items for home and general use.

"Establishment" means any place where alcoholic beverages of one or more varieties are lawfully manufactured, sold, or used.

"Farm winery" means (i) an establishment (a) located on a farm in the Commonwealth on land zoned agricultural with a producing vineyard, orchard, or similar growing area and with facilities for

1536 fermenting and bottling wine on the premises where the owner or lessee manufactures wine that contains
1537 not more than 21 percent alcohol by volume or (b) located in the Commonwealth on land zoned
1538 agricultural with a producing vineyard, orchard, or similar growing area or agreements for purchasing
1539 grapes or other fruits from agricultural growers within the Commonwealth, and with facilities for
1540 fermenting and bottling wine on the premises where the owner or lessee manufactures wine that contains
1541 not more than 21 percent alcohol by volume or (ii) an accredited public or private institution of higher
1542 education, provided that (a) no wine manufactured by the institution shall be sold, (b) the wine
1543 manufactured by the institution shall be used solely for research and educational purposes, (c) the wine
1544 manufactured by the institution shall be stored on the premises of such farm winery that shall be
1545 separate and apart from all other facilities of the institution, and (d) such farm winery is operated in
1546 strict conformance with the requirements of this clause (ii) and Board regulations. As used in this
1547 definition, the terms "owner" and "lessee" shall include a cooperative formed by an association of
1548 individuals for the purpose of manufacturing wine. In the event that such cooperative is licensed as a
1549 farm winery, the term "farm" as used in this definition includes all of the land owned or leased by the
1550 individual members of the cooperative as long as such land is located in the Commonwealth. For
1551 purposes of this definition, "land zoned agricultural" means (1) land zoned as an agricultural district or
1552 classification or (2) land otherwise permitted by a locality for farm winery use. For purposes of this
1553 definition, "land zoned agricultural" does not include land zoned "residential conservation." Except for
1554 the limitation on land zoned "residential conservation," nothing in the definition of "land zoned
1555 agricultural" shall otherwise limit or affect local zoning authority.

1556 "Gift shop" means any bona fide retail store selling, predominantly, gifts, books, souvenirs, specialty
1557 items relating to history, original and handmade arts and products, collectibles, crafts, and floral
1558 arrangements, which is open to the public on a regular basis. Such shop shall be a permanent structure
1559 where stock is displayed and offered for sale and which has facilities to properly secure any stock of
1560 wine or beer. Such shop may be located (i) on the premises or grounds of a government registered
1561 national, state or local historic building or site or (ii) within the premises of a museum. The Board shall
1562 consider the purpose, characteristics, nature, and operation of the shop in determining whether it shall be
1563 considered a gift shop.

1564 "Gourmet brewing shop" means an establishment which sells to persons to whom wine or beer may
1565 lawfully be sold, ingredients for making wine or brewing beer, including packaging, and rents to such
1566 persons facilities for manufacturing, fermenting and bottling such wine or beer.

1567 "Gourmet oyster house" means an establishment that (i) is located on the premises of a commercial
1568 marina, (ii) is permitted by the Department of Health to serve oysters and other fresh seafood for
1569 consumption on the premises, and (iii) offers to the public events for the purpose of featuring and
1570 educating the consuming public about local oysters and other seafood products.

1571 "Gourmet shop" means an establishment provided with adequate inventory, shelving, and storage
1572 facilities, where, in consideration of payment, substantial amounts of domestic and imported wines and
1573 beers of various types and sizes and related products such as cheeses and gourmet foods are habitually
1574 furnished to persons.

1575 "Government store" means a store established by the Authority for the sale of alcoholic beverages.

1576 "Grocery store" means an establishment that sells food and other items intended for human
1577 consumption, including a variety of ingredients commonly used in the preparation of meals.

1578 "Historic cinema house" means a nonprofit establishment exempt from taxation under § 501(c)(3) of
1579 the Internal Revenue Code that was built prior to 1970 and that exists for the primary purpose of
1580 showing motion pictures to the public.

1581 "Hotel" means any duly licensed establishment, provided with special space and accommodation,
1582 where, in consideration of payment, food and lodging are habitually furnished to persons, and which has
1583 four or more bedrooms. It shall also mean the person who operates such hotel.

1584 "Interdicted person" means a person to whom the sale of alcoholic beverages is prohibited by order
1585 pursuant to this ~~title~~ subtitle.

1586 "Internet wine and beer retailer" means a person who owns or operates an establishment with
1587 adequate inventory, shelving, and storage facilities, where, in consideration of payment, Internet or
1588 telephone orders are taken and shipped directly to consumers and which establishment is not a retail
1589 store open to the public.

1590 "Intoxicated" means a condition in which a person has drunk enough alcoholic beverages to
1591 observably affect his manner, disposition, speech, muscular movement, general appearance, or behavior.

1592 "Licensed" means the holding of a valid license granted by the Authority.

1593 "Licensee" means any person to whom a license has been granted by the Authority.

1594 "Liqueur" means any of a class of highly flavored alcoholic beverages that do not exceed an alcohol
1595 content of 25 percent by volume.

1596 "Low alcohol beverage cooler" means a drink containing one-half of one percent or more of alcohol
1597 by volume, but not more than seven and one-half percent alcohol by volume, and consisting of spirits

1598 mixed with nonalcoholic beverages or flavoring or coloring materials; it may also contain water, fruit
 1599 juices, fruit adjuncts, sugar, carbon dioxide, preservatives or other similar products manufactured by
 1600 fermenting fruit or fruit juices. Low alcohol beverage coolers shall be treated as wine for all purposes of
 1601 this ~~title~~ *subtitle*, except that low alcohol beverage coolers may be manufactured by a licensed distiller
 1602 or a distiller located outside the Commonwealth.

1603 "Marina store" means an establishment that is located on the same premises as a marina, is operated
 1604 by the owner of such marina, and sells food and nautical and fishing supplies.

1605 "Meals" means, for a mixed beverage license, an assortment of foods commonly ordered in bona
 1606 fide, full-service restaurants as principal meals of the day. Such restaurants shall include establishments
 1607 specializing in full course meals with a single substantial entree.

1608 "Member of a club" means (i) a person who maintains his membership in the club by the payment of
 1609 monthly, quarterly, or annual dues in the manner established by the rules and regulations thereof or (ii)
 1610 a person who is a member of a bona fide auxiliary, local chapter, or squadron composed of direct lineal
 1611 descendants of a bona fide member, whether alive or deceased, of a national or international
 1612 organization to which an individual lodge holding a club license is an authorized member in the same
 1613 locality. It shall also mean a lifetime member whose financial contribution is not less than 10 times the
 1614 annual dues of resident members of the club, the full amount of such contribution being paid in advance
 1615 in a lump sum.

1616 "Mixed beverage" or "mixed alcoholic beverage" means a drink composed in whole or in part of
 1617 spirits.

1618 "Mixer" means any prepackaged ingredients containing beverages or flavoring or coloring materials,
 1619 and which may also contain water, fruit juices, fruit adjuncts, sugar, carbon dioxide, or preservatives
 1620 which are not commonly consumed unless combined with alcoholic beverages, whether or not such
 1621 ingredients contain alcohol. Such specialty beverage product shall be manufactured or distributed by a
 1622 Virginia corporation.

1623 "Municipal golf course" means any golf course that is owned by any town incorporated in 1849 and
 1624 which is the county seat of Smyth County.

1625 "Place or premises" means the real estate, together with any buildings or other improvements thereon,
 1626 designated in the application for a license as the place at which the manufacture, bottling, distribution,
 1627 use or sale of alcoholic beverages shall be performed, except that portion of any such building or other
 1628 improvement actually and exclusively used as a private residence.

1629 "Principal stockholder" means any person who individually or in concert with his spouse and
 1630 immediate family members beneficially owns or controls, directly or indirectly, five percent or more of
 1631 the equity ownership of any person that is a licensee of the Authority, or who in concert with his spouse
 1632 and immediate family members has the power to vote or cause the vote of five percent or more of any
 1633 such equity ownership. "Principal stockholder" does not include a broker-dealer registered under the
 1634 Securities Exchange Act of 1934, as amended, that holds in inventory shares for sale on the financial
 1635 markets for a publicly traded corporation holding, directly or indirectly, a license from the Authority.

1636 "Public place" means any place, building, or conveyance to which the public has, or is permitted to
 1637 have, access, including restaurants, soda fountains, hotel dining areas, lobbies and corridors of hotels,
 1638 and any park, place of public resort or amusement, highway, street, lane, or sidewalk adjoining any
 1639 highway, street, or lane.

1640 "Public place" does not include (i) hotel or restaurant dining areas or ballrooms while in use for
 1641 private meetings or private parties limited in attendance to members and guests of a particular group,
 1642 association or organization; (ii) restaurants licensed by the Authority in office buildings or industrial or
 1643 similar facilities while such restaurant is closed to the public and in use for private meetings or parties
 1644 limited in attendance to employees and nonpaying guests of the owner or a lessee of all or part of such
 1645 building or facility; (iii) offices, office buildings or industrial facilities while closed to the public and in
 1646 use for private meetings or parties limited in attendance to employees and nonpaying guests of the
 1647 owner or a lessee of all or part of such building or facility; or (iv) private recreational or chartered boats
 1648 which are not licensed by the Board and on which alcoholic beverages are not sold.

1649 "Residence" means any building or part of a building or structure where a person resides, but does
 1650 not include any part of a building that is not actually and exclusively used as a private residence, nor
 1651 any part of a hotel or club other than a private guest room thereof.

1652 "Resort complex" means a facility (i) with a hotel owning year-round sports and recreational facilities
 1653 located contiguously on the same property; (ii) owned by a nonstock, nonprofit, taxable corporation with
 1654 voluntary membership which, as its primary function, makes available golf, ski, and other recreational
 1655 facilities both to its members and to the general public; or (iii) operated by a corporation that operates
 1656 as a management company which, as its primary function, makes available (a) vacation accommodations,
 1657 guest rooms, or dwelling units and (b) golf, ski, and other recreational facilities to members of the
 1658 managed entities and the general public. The hotel or corporation shall have or manage a minimum of

1659 140 private guest rooms or dwelling units contained on not less than 50 acres, whether or not
1660 contiguous to the licensed premises; if the guest rooms or dwelling units are located on property that is
1661 not contiguous to the licensed premises, such guest rooms and dwelling units shall be located within the
1662 same locality. The Authority may consider the purpose, characteristics, and operation of the applicant
1663 establishment in determining whether it shall be considered as a resort complex. All other pertinent
1664 qualifications established by the Board for a hotel operation shall be observed by such licensee.

1665 "Restaurant" means, for a wine and beer license or a limited mixed beverage restaurant license, any
1666 establishment provided with special space and accommodation, where, in consideration of payment,
1667 meals or other foods prepared on the premises are regularly sold.

1668 "Restaurant" means, for a mixed beverage license other than a limited mixed beverage restaurant
1669 license, an established place of business (i) where meals with substantial entrees are regularly sold and
1670 (ii) which has adequate facilities and sufficient employees for cooking, preparing, and serving such
1671 meals for consumption at tables in dining areas on the premises, and includes establishments specializing
1672 in full course meals with a single substantial entree.

1673 "Sale" and "sell" includes soliciting or receiving an order for; keeping, offering or exposing for sale;
1674 peddling, exchanging or bartering; or delivering otherwise than gratuitously, by any means, alcoholic
1675 beverages.

1676 "Sangria" means a drink consisting of red or white wine mixed with some combination of
1677 sweeteners, fruit, fruit juice, soda, or soda water that may also be mixed with brandy, triple sec, or other
1678 similar spirits.

1679 "Special agent" means an employee of the Virginia Alcoholic Beverage Control Authority whom the
1680 Board has designated as a law-enforcement officer pursuant to § 4.1-105.

1681 "Special event" means an event sponsored by a duly organized nonprofit corporation or association
1682 and conducted for an athletic, charitable, civic, educational, political, or religious purpose.

1683 "Spirits" means any beverage that contains alcohol obtained by distillation mixed with drinkable
1684 water and other substances, in solution, and includes, among other things, brandy, rum, whiskey, and
1685 gin, or any one or more of the last four named ingredients, but shall not include any such liquors
1686 completely denatured in accordance with formulas approved by the United States government.

1687 "Wine" means any alcoholic beverage, including cider, obtained by the fermentation of the natural
1688 sugar content of fruits or other agricultural products containing (i) sugar, including honey and milk,
1689 either with or without additional sugar; (ii) one-half of one percent or more of alcohol by volume; and
1690 (iii) no product of distillation. "Wine" includes any wine to which wine spirits have been added, as
1691 provided in the Internal Revenue Code, to make products commonly known as "fortified wine" which do
1692 not exceed an alcohol content of 21 percent by volume.

1693 "Wine cooler" means a drink containing one-half of one percent or more of alcohol by volume, and
1694 not more than three and two-tenths percent of alcohol by weight or four percent by volume consisting of
1695 wine mixed with nonalcoholic beverages or flavoring or coloring materials, and which may also contain
1696 water, fruit juices, fruit adjuncts, sugar, carbon dioxide, or preservatives and shall include other similar
1697 products manufactured by fermenting fruit or fruit juices. Wine coolers and similar fermented fruit juice
1698 beverages shall be treated as wine for all purposes except for taxation under § 4.1-236.

1699 "With or without meals" means the selling and serving of alcoholic beverages by retail licensees for
1700 on-premises consumption whether or not accompanied by food so long as the total food-beverage ratio
1701 required by § 4.1-206.3, or the monthly food sale requirement established by Board regulation, is met by
1702 such retail licensee.

1703 **§ 4.1-101.02. Appointment, salary, and powers of Chief Executive Officer; appointment of**
1704 **confidential assistant to the Chief Executive Officer.**

1705 A. The Chief Executive Officer of the Authority shall be appointed by the Governor and confirmed
1706 by the affirmative vote of a majority of those voting in each house of the General Assembly. The Chief
1707 Executive Officer shall not be a member of the Board; shall hold, at a minimum, a baccalaureate degree
1708 in business or a related field of study; and shall possess a minimum of seven years of demonstrated
1709 experience or expertise in the direct management, supervision, or control of a business or legal affairs.
1710 The Chief Executive Officer shall receive such compensation as determined by the Board and approved
1711 by the Governor, including any performance bonuses or incentives as the Board deems advisable. The
1712 Chief Executive Officer shall be subject to a background check in accordance with § 4.1-101.03. The
1713 Chief Executive Officer shall (i) carry out the powers and duties conferred upon him by the Board or
1714 imposed upon him by law and (ii) meet performance measures or targets set by the Board and approved
1715 by the Governor. The Chief Executive Officer may be removed from office by the Governor for cause,
1716 including the improper use of the Authority's police powers, malfeasance, misfeasance, incompetence,
1717 misconduct, neglect of duty, absenteeism, conflict of interests, failure to meet performance measures or
1718 targets as set by the Board and approved by the Governor, failure to carry out the policies of the
1719 Commonwealth as established in the Constitution or by the General Assembly, or refusal to carry out a
1720 lawful directive of the Governor.

B. The Chief Executive Officer shall devote his full time to the performance of his official duties and shall not be engaged in any other profession or occupation.

C. The Chief Executive Officer shall supervise and administer the operations of the Authority in accordance with this ~~title~~ *subtitle*.

D. The Chief Executive Officer shall:

1. Serve as the secretary to the Board and keep a true and full record of all proceedings of the Authority and preserve at the Authority's general office all books, documents, and papers of the Authority;

2. Exercise and perform such powers and duties as may be delegated to him by the Board or as may be conferred or imposed upon him by law;

3. Employ or retain such special agents or employees subordinate to the Chief Executive Officer as may be necessary to fulfill the duties of the Authority conferred upon the Chief Executive Officer, subject to the Board's approval; and

4. Make recommendations to the Board for legislative and regulatory changes.

E. Neither the Chief Executive Officer nor the spouse or any member of the immediate family of the Chief Executive Officer shall make any contribution to a candidate for office or officeholder at the local or state level or cause such a contribution to be made on his behalf.

F. To assist the Chief Executive Officer in the performance of his duties, the Governor shall also appoint one confidential assistant for administration who shall be deemed to serve on an employment-at-will basis.

§ 4.1-101.07. Forms of accounts and records; audit; annual report.

A. The accounts and records of the Authority showing the receipt and disbursement of funds from whatever source derived shall be in a form prescribed by the Auditor of Public Accounts. The Auditor of Public Accounts or his legally authorized representatives shall annually examine the accounts and books of the Authority. The Authority shall submit an annual report to the Governor and General Assembly on or before December 15 of each year. Such report shall contain the audited annual financial statements of the Authority for the year ending the previous June 30. The Authority shall also submit a six-year plan detailing its assumed revenue forecast, assumed operating costs, number of retail facilities, capital costs, including lease payments, major acquisitions of services and tangible or intangible property, any material changes to the policies and procedures issued by the Authority related to procurement or personnel, and any proposed marketing activities.

B. Notwithstanding any other provision of law, in exercising any power conferred under this ~~title~~ *subtitle*, the Authority may implement and maintain independent payroll and nonpayroll disbursement systems. These systems and related procedures shall be subject to review and approval by the State Comptroller. Upon agreement with the State Comptroller, the Authority may report summary level detail on both payroll and nonpayroll transactions to the State Comptroller through the Department of Accounts' financial management system or its successor system. Such reports shall be made in accordance with policies, procedures, and directives as prescribed by the State Comptroller. A nonpayroll disbursement system shall include all disbursements and expenditures, other than payroll. Such disbursements and expenditures shall include travel reimbursements, revenue refunds, disbursements for vendor payments, petty cash, and interagency payments.

§ 4.1-101.09. Exemptions from taxes or assessments.

The exercise of the powers granted by this ~~title~~ *subtitle* shall be in all respects for the benefit of the people of the Commonwealth, for the increase of their commerce and prosperity, and for the improvement of their living conditions, and as the undertaking of activities in the furtherance of the purposes of the Authority constitutes the performance of essential governmental functions, the Authority shall not be required to pay any taxes or assessments upon any property acquired or used by the Authority under the provisions of this ~~title~~ *subtitle* or upon the income therefrom, including sales and use taxes on the tangible personal property used in the operations of the Authority. The exemption granted in this section shall not be construed to extend to persons conducting on the premises of any property of the Authority businesses for which local or state taxes would otherwise be required.

§ 4.1-101.010. Exemption of Authority from personnel and procurement procedures; information systems; etc.

A. The provisions of the Virginia Personnel Act (§ 2.2-2900 et seq.) and the Virginia Public Procurement Act (§ 2.2-4300 et seq.) shall not apply to the Authority in the exercise of any power conferred under this ~~title~~ *subtitle*. Nor shall the provisions of Chapter 20.1 (§ 2.2-2005 et seq.) of Title 2.2 or Article 2 (§ 51.1-1104 et seq.) of Chapter 11 of Title 51.1 apply to the Authority in the exercise of any power conferred under this ~~title~~ *subtitle*.

B. To effect its implementation, the Authority's procurement of goods, services, insurance, and construction and the disposition of surplus materials shall be exempt from:

1. State agency requirements regarding disposition of surplus materials and distribution of proceeds

from the sale or recycling of surplus materials under §§ 2.2-1124 and 2.2-1125;

2. The requirement to purchase from the Department for the Blind and Vision Impaired under § 2.2-1117; and

3. Any other state statutes, rules, regulations, or requirements relating to the procurement of goods, services, insurance, and construction, including Article 3 (§ 2.2-1109 et seq.) of Chapter 11 of Title 2.2, regarding the duties, responsibilities, and authority of the Division of Purchases and Supply of the Virginia Department of General Services, and Article 4 (§ 2.2-1129 et seq.) of Chapter 11 of Title 2.2, regarding the review and the oversight by the Division of Engineering and Buildings of the Department of General Services of contracts for the construction of the Authority's capital projects and construction-related professional services under § 2.2-1132.

C. The Authority (i) may purchase from and participate in all statewide contracts for goods and services, including information technology goods and services; (ii) shall use directly or by integration or interface the Commonwealth's electronic procurement system subject to the terms and conditions agreed upon between the Authority and the Department of General Services; and (iii) shall post on the Department of General Services' central electronic procurement website all Invitations to Bid, Requests for Proposal, sole source award notices, and emergency award notices to ensure visibility and access to the Authority's procurement opportunities on one website.

§ 4.1-101.1. Certified mail; subsequent mail or notices may be sent by regular mail; electronic communications as alternative to regular mail; limitation.

A. Whenever in this ~~title~~ *subtitle* the Board is required to send any mail or notice by certified mail and such mail or notice is sent certified mail, return receipt requested, then any subsequent, identical mail or notice that is sent by the Board may be sent by regular mail.

B. Except as provided in subsection C, whenever in this ~~title~~ *subtitle* the Board is required or permitted to send any mail, notice, or other official communication by regular mail to persons licensed under Chapter 2 (§ 4.1-200 et seq.), upon the request of a licensee, the Board may instead send such mail, notice, or official communication by email, text message, or other electronic means to the email address, telephone number, or other contact information provided to the Board by the licensee, provided that the Board retains sufficient proof of the electronic delivery, which may be an electronic receipt of delivery or a certificate of service prepared by the Board confirming the electronic delivery.

C. No notice required by § 4.1-227 to (i) a licensee of a hearing that may result in the suspension or revocation of his license or the imposition of a civil penalty or (ii) a person holding a permit shall be sent by the Board by email, text message, or other electronic means, nor shall any decision by the Board to suspend or revoke a license or permit or impose a civil penalty be sent by the Board by email, text message, or other electronic means.

§ 4.1-103. General powers of Board.

The Board shall have the power to:

1. Sue and be sued, implead and be impleaded, and complain and defend in all courts;

2. Adopt, use, and alter at will a common seal;

3. Fix, alter, charge, and collect rates, rentals, fees, and other charges for the use of property of, the sale of products of, or services rendered by the Authority at rates to be determined by the Authority for the purpose of providing for the payment of the expenses of the Authority;

4. Make and enter into all contracts and agreements necessary or incidental to the performance of its duties, the furtherance of its purposes, and the execution of its powers under this ~~title~~ *subtitle*, including agreements with any person or federal agency;

5. Employ, at its discretion, consultants, researchers, architects, engineers, accountants, financial experts, investment bankers, superintendents, managers, and such other employees and special agents as may be necessary and fix their compensation to be payable from funds made available to the Authority. Legal services for the Authority shall be provided by the Attorney General in accordance with Chapter 5 (§ 2.2-500 et seq.) of Title 2.2;

6. Receive and accept from any federal or private agency, foundation, corporation, association, or person grants or other aid to be expended in accomplishing the objectives of the Authority, and receive and accept from the Commonwealth or any state and any municipality, county, or other political subdivision thereof or from any other source aid or contributions of either money, property, or other things of value, to be held, used, and applied only for the purposes for which such grants and contributions may be made. All federal moneys accepted under this section shall be accepted and expended by the Authority upon such terms and conditions as are prescribed by the United States and as are consistent with state law, and all state moneys accepted under this section shall be expended by the Authority upon such terms and conditions as are prescribed by the Commonwealth;

7. Adopt, alter, and repeal bylaws, rules, and regulations governing the manner in which its business shall be transacted and the manner in which the powers of the Authority shall be exercised and its duties performed. The Board may delegate or assign any duty or task to be performed by the Authority to any officer or employee of the Authority. The Board shall remain responsible for the performance of

any such duties or tasks. Any delegation pursuant to this subdivision shall, where appropriate, be accompanied by written guidelines for the exercise of the duties or tasks delegated. Where appropriate, the guidelines shall require that the Board receive summaries of actions taken. Such delegation or assignment shall not relieve the Board of the responsibility to ensure faithful performance of the duties and tasks;

8. Conduct or engage in any lawful business, activity, effort, or project consistent with the Authority's purposes or necessary or convenient to exercise its powers;

9. Develop policies and procedures generally applicable to the procurement of goods, services, and construction, based upon competitive principles;

10. Develop policies and procedures consistent with Article 4 (§ 2.2-4347 et seq.) of Chapter 43 of Title 2.2;

11. Buy, import and sell alcoholic beverages other than beer and wine not produced by farm wineries, and to have alcoholic beverages other than beer and wine not produced by farm wineries in its possession for sale;

12. Buy and sell any mixers;

13. Buy and sell products licensed by the Virginia Tourism Corporation that are within international trademark classes 16 (paper goods and printer matters), 18 (leather goods), 21 (housewares and glass), and 25 (clothing);

14. Control the possession, sale, transportation, and delivery of alcoholic beverages;

15. Determine, subject to § 4.1-121, the localities within which government stores shall be established or operated and the location of such stores;

16. Maintain warehouses for alcoholic beverages and control the storage and delivery of alcoholic beverages to and from such warehouses;

17. Acquire, purchase, hold, use, lease, or otherwise dispose of any property, real, personal or mixed, tangible or intangible, or any interest therein necessary or desirable for carrying out the purposes of the Authority; lease as lessee any property, real, personal or mixed, tangible or intangible, or any interest therein, at such annual rental and on such terms and conditions as may be determined by the Board; lease as lessor to any person any property, real, personal or mixed, tangible or intangible, or any interest therein, at any time acquired by the Authority, whether wholly or partially completed, at such annual rental and on such terms and conditions as may be determined by the Board; sell, transfer, or convey any property, real, personal or mixed, tangible or intangible, or any interest therein, at any time acquired or held by the Authority on such terms and conditions as may be determined by the Board; and occupy and improve any land or building required for the purposes of this ~~title~~ subtitle;

18. Purchase, lease, or acquire the use of, by any manner, any plant or equipment that may be considered necessary or useful in carrying into effect the purposes of this ~~title~~ subtitle, including rectifying, blending, and processing plants. The Board may purchase, build, lease, and operate distilleries and manufacture alcoholic beverages;

19. Determine the nature, form and capacity of all containers used for holding alcoholic beverages to be kept or sold under this ~~title~~ subtitle, and prescribe the form and content of all labels and seals to be placed thereon; however, no container sold in or shipped into the Commonwealth shall include powdered or crystalline alcohol;

20. Appoint every agent and employee required for its operations; require any or all of them to give bonds payable to the Commonwealth in such penalty as shall be fixed by the Board; and engage the services of experts and professionals;

21. Hold and conduct hearings; issue subpoenas requiring the attendance of witnesses and the production of records, memoranda, papers and other documents before the Board or any agent of the Board; and administer oaths and take testimony thereunder. The Board may authorize any Board member or agent of the Board to hold and conduct hearings, issue subpoenas, administer oaths and take testimony thereunder, and decide cases, subject to final decision by the Board, on application of any party aggrieved. The Board may enter into consent agreements and may request and accept from any applicant or licensee a consent agreement in lieu of proceedings on (i) objections to the issuance of a license or (ii) disciplinary action. Any such consent agreement shall include findings of fact and may include an admission or a finding of a violation. A consent agreement shall not be considered a case decision of the Board and shall not be subject to judicial review under the provisions of the Administrative Process Act (§ 2.2-4000 et seq.), but may be considered by the Board in future disciplinary proceedings;

22. Make a reasonable charge for preparing and furnishing statistical information and compilations to persons other than (i) officials, including court and police officials, of the Commonwealth and of its subdivisions if the information requested is for official use and (ii) persons who have a personal or legal interest in obtaining the information requested if such information is not to be used for commercial or trade purposes;

1905 23. Promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.)
1906 and § 4.1-111;
1907 24. Grant, suspend, and revoke licenses for the manufacture, bottling, distribution, importation, and
1908 sale of alcoholic beverages;
1909 25. Assess and collect civil penalties and civil charges for violations of this ~~title~~ subtitle and Board
1910 regulations;
1911 26. Maintain actions to enjoin common nuisances as defined in § 4.1-317;
1912 27. Establish minimum food sale requirements for all retail licensees;
1913 28. Review and approve any proposed legislative or regulatory changes suggested by the Chief
1914 Executive Officer as the Board deems appropriate;
1915 29. Report quarterly to the Secretary of Public Safety and Homeland Security on the law-enforcement
1916 activities undertaken to enforce the provisions of this ~~title~~ subtitle;
1917 30. Establish and collect fees for all permits set forth in this ~~title~~ subtitle, including fees associated

1920 operated by a casino gaming establishment pay for any cost incurred by the Board to enforce such
1921 license in excess of the applicable state license fee; and
1922 32. Do all acts necessary or advisable to carry out the purposes of this ~~title~~ subtitle.

1923 **§ 4.1-104. Purchases by the Board.**
1924 The purchasing of alcoholic beverages and mixers, products used in connection with distilled spirits
1925 intended for resale, or products licensed by the Virginia Tourism Corporation as specified in § 4.1-103
1926 intended for resale, the making of leases, and the purchasing of real estate by the Board under the
1927 provisions of this ~~title~~ subtitle are exempt from the Virginia Public Procurement Act (§ 2.2-4300 et
1928 seq.).

1929 **§ 4.1-105. Police power of members, agents and employees of Board.**
1930 Members of the Board are vested, and such agents and employees of the Board designated by it shall
1931 be vested, with like power to enforce the provisions of (i) this ~~title~~ subtitle and the criminal laws of the
1932 Commonwealth as is vested in the chief law-enforcement officer of a county, city, or town; (ii)
1933 § 3.2-4207; (iii) § 18.2-371.2; and (iv) § 58.1-1037.

1934 **§ 4.1-106. Liability of Board members; suits by and against Board.**
1935 A. No Board member may be sued civilly for doing or omitting to do any act in the performance of
1936 his duties as prescribed by this ~~title~~ subtitle, except by the Commonwealth, and then only in the Circuit
1937 Court of the City of Richmond. Such proceedings by the Commonwealth shall be instituted and
1938 conducted by the Attorney General.

1939 B. The Board may, in the name of the Commonwealth, be sued in the Circuit Court of the City of
1940 Richmond to enforce any contract made by it or to recover damages for any breach thereof. The Board
1941 may defend the proceedings and may institute proceedings in any court. No such proceedings shall be
1942 taken against, or in the names of, the members of the Board.

1943 **§ 4.1-107. Counsel for members, agents and employees of Board.**
1944 If any member, agent, or employee of the Board shall be arrested, indicted or otherwise prosecuted
1945 on any charge arising out of any act committed in the discharge of his official duties, the Board
1946 chairman may employ special counsel approved by the Attorney General to defend such member, agent,
1947 or employee. The compensation for special counsel employed pursuant to this section, shall, subject to
1948 the approval of the Attorney General, be paid in the same manner as other expenses incident to the
1949 administration of this ~~title~~ subtitle are paid.

1950 **§ 4.1-111. Regulations of Board.**
1951 A. The Board may promulgate reasonable regulations, not inconsistent with this ~~title~~ subtitle or the
1952 general laws of the Commonwealth, which it deems necessary to carry out the provisions of this ~~title~~
1953 subtitle and to prevent the illegal manufacture, bottling, sale, distribution, and transportation of alcoholic
1954 beverages. The Board may amend or repeal such regulations. Such regulations shall be promulgated,
1955 amended or repealed in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) and shall
1956 have the effect of law.

1957 B. The Board shall promulgate regulations that:
1958 1. Prescribe what hours and on what days alcoholic beverages shall not be sold by licensees or
1959 consumed on any licensed premises, including a provision that mixed beverages may be sold only at
1960 such times as wine and beer may be sold.
1961 2. Require mixed beverage caterer licensees to notify the Board in advance of any event to be served
1962 by such licensee.
1963 3. Maintain the reasonable separation of retailer interests from those of the manufacturers, bottlers,
1964 brokers, importers and wholesalers in accordance with § 4.1-216 and in consideration of the established
1965 trade customs, quantity and value of the articles or services involved; prevent undue competitive
1966 domination of any person by any other person engaged in the manufacture, distribution and sale at retail

or wholesale of alcoholic beverages in the Commonwealth; and promote reasonable accommodation of arm's length business transactions.

4. Establish requirements for the form, content, and retention of all records and accounts, including the (i) reporting and collection of taxes required by § 4.1-236 and (ii) the sale of alcoholic beverages in kegs, by all licensees.

5. Require retail licensees to file an appeal from any hearing decision rendered by a hearing officer within 30 days of the date the notice of the decision is sent. The notice shall be sent to the licensee at the address on record with the Board by certified mail, return receipt requested, and by regular mail.

6. Prescribe the terms and conditions under which persons who collect or trade designer or vintage spirit bottles may sell such bottles at auction, provided that (i) the auction is conducted in accordance with the provisions of Chapter 6 (§ 54.1-600 et seq.) of Title 54.1 and (ii) the bottles are unopened and the manufacturers' seals, marks, or stamps affixed to the bottles are intact.

7. Prescribe the terms and conditions under which credit or debit cards may be accepted from licensees for purchases at government stores, including provision for the collection, where appropriate, of related fees, penalties, and service charges.

8. Require that banquet licensees in charge of public events as defined by Board regulations report to the Board the income and expenses associated with the public event on a form prescribed by the Board when the banquet licensee engages another person to organize, conduct, or operate the event on behalf of the banquet licensee. Such regulations shall be applicable only to public events where alcoholic beverages are being sold.

9. Provide alternative methods for licensees to maintain and store business records that are subject to Board inspection, including methods for Board-approved electronic and off-site storage.

10. Require off-premises retail licensees to place any premixed alcoholic energy drinks containing one-half of one percent or more of alcohol by volume in the same location where wine and beer are available for sale within the licensed premises.

11. Prescribe the terms and conditions under which mixed beverage licensees may infuse, store, and sell flavored distilled spirits, including a provision that limits infusion containers to a maximum of 20 liters.

12. Prescribe the schedule of proration for refunded license taxes to licensees who qualify pursuant to subsection C of § 4.1-232.

13. Establish reasonable time, place, and manner restrictions on outdoor advertising of alcoholic beverages, not inconsistent with the provisions of this ~~title~~ subtitle, so that such advertising does not encourage or otherwise promote the consumption of alcoholic beverages by persons to whom alcoholic beverages may not be lawfully sold. Such regulations shall:

a. Restrict outdoor advertising of alcoholic beverages in publicly visible locations consistent with (i) the general prohibition against tied interests between retail licensees and manufacturers or wholesale licensees as provided in §§ 4.1-215 and 4.1-216; (ii) the prohibition against manufacturer control of wholesale licensees as set forth in § 4.1-223 and Board regulations adopted pursuant thereto; and (iii) the general prohibition against cooperative advertising between manufacturers, wholesalers, or importers and retail licensees as set forth in Board regulation; and

b. Permit (i) any outdoor signage or advertising not otherwise prohibited by this ~~title~~ subtitle and (ii) the display of outdoor alcoholic beverage advertising on lawfully erected billboard signs regulated under Chapter 12 (§ 33.2-1200 et seq.) of Title 33.2 where such signs are located on commercial real estate as defined in § 55.1-1100, but only in accordance with this ~~title~~ subtitle.

14. Prescribe the terms and conditions under which a licensed brewery may manufacture beer pursuant to an agreement with a brand owner not under common control with the manufacturing brewery and sell and deliver the beer so manufactured to the brand owner. The regulations shall require that (i) the brand owner be an entity appropriately licensed as a brewery or beer wholesaler, (ii) a written agreement be entered into by the parties, and (iii) records as deemed appropriate by the Board are maintained by the parties.

15. Prescribe the terms for any "happy hour" conducted by on-premises licensees. Such regulations shall permit on-premises licensees to advertise any alcoholic beverage products featured during a happy hour and any pricing related to such happy hour. Such regulations shall not prohibit on-premises licensees from using creative marketing techniques in such advertisements, provided that such techniques do not tend to induce overconsumption or consumption by minors.

16. Permit retail on-premises licensees to give a gift of one alcoholic beverage to a patron or one bottle of wine to a group of two or more patrons, provided that (i) such gifts only are made to individuals to whom such products may lawfully be sold and (ii) only one such gift is given during any 24-hour period and subject to any Board limitations on the frequency of such gifts.

17. Permit the sale of beer and cider for off-premises consumption in resealable growlers made of glass, ceramic, metal, or other materials approved by the Board, or other resealable containers approved

2028 by the Board, with a maximum capacity of 128 fluid ounces or, for metric-sized containers, four liters.

2029 18. Permit the sale of wine for off-premises consumption in resealable growlers made of glass,
2030 ceramic, metal, or other materials approved by the Board, or other resealable containers approved by the
2031 Board, with a maximum capacity of 64 fluid ounces or, for metric-sized containers, two liters. Wine
2032 growlers may be used only by persons licensed to sell wine for both on-premises and off-premises
2033 consumption or by gourmet shops granted a retail off-premises wine and beer license. Growlers sold by
2034 gourmet shops shall be labeled with (i) the manufacturer's name or trade name, (ii) the place of
2035 production, (iii) the net contents in fluid ounces, and (iv) the name and address of the retailer.

2036 19. Permit the sale of wine, cider, and beer by retailers licensed to sell beer and wine for both
2037 on-premises and off-premises consumption, or by gourmet shops granted a retail off-premises wine and
2038 beer license for off-premises consumption in sealed containers made of metal or other materials
2039 approved by the Board with a maximum capacity of 32 fluid ounces or, for metric-sized containers, one
2040 liter, provided that the alcoholic beverage is placed in the container following an order from the
2041 consumer.

2042 20. Permit mixed beverage licensees to premix containers of sangria and other mixed alcoholic
2043 beverages and to serve such alcoholic beverages in pitchers, subject to size and quantity limitations
2044 established by the Board.

2045 21. Establish and make available to all licensees and permittees for which on-premises consumption
2046 of alcoholic beverages is allowed and employees of such licensees and permittees who serve as a
2047 bartender or otherwise sell, serve, or dispense alcoholic beverages for on-premises consumption a bar
2048 bystander training module, which shall include (i) information that enables licensees, permittees, and
2049 their employees to recognize situations that may lead to sexual assault and (ii) intervention strategies to
2050 prevent such situations from culminating in sexual assault.

2051 22. Require mixed beverage licensees to have food, cooked or prepared on the licensed premises,
2052 available for on-premises consumption until at least 30 minutes prior to an establishment's closing. Such
2053 food shall be available in all areas of the licensed premises in which spirits are sold or served.

2054 23. Prescribe the terms and conditions under which the Board may suspend the privilege of a mixed
2055 beverage licensee to purchase spirits from the Board upon such licensee's failure to submit any records
2056 or other documents necessary to verify the licensee's compliance with applicable minimum food sale
2057 requirements within 30 days of the date such records or documents are due.

2058 C. The Board may promulgate regulations that:

2059 1. Provide for the waiver of the license tax for an applicant for a banquet license, such waiver to be
2060 based on (i) the amount of alcoholic beverages to be provided by the applicant, (ii) the not-for-profit
2061 status of the applicant, and (iii) the condition that no profits are to be generated from the event. For the
2062 purposes of clause (ii), the applicant shall submit with the application, an affidavit certifying its
2063 not-for-profit status. The granting of such waiver shall be limited to two events per year for each
2064 applicant.

2065 2. Establish limitations on the quantity and value of any gifts of alcoholic beverages made in the
2066 course of any business entertainment pursuant to subdivision A 22 of § 4.1-325 or subsection C of
2067 § 4.1-325.2.

2068 3. Provide incentives to licensees with a proven history of compliance with state and federal laws
2069 and regulations to encourage licensees to conduct their business and related activities in a manner that is
2070 beneficial to the Commonwealth.

2071 D. Board regulations shall be uniform in their application, except those relating to hours of sale for
2072 licensees.

2073 E. Courts shall take judicial notice of Board regulations.

2074 F. The Board's power to regulate shall be broadly construed.

2075 **§ 4.1-112.2. Outdoor advertising; limitations; variances; compliance with Title 33.2.**

2076 A. No outdoor alcoholic beverage advertising shall be placed within 500 linear feet on the same side
2077 of the road, and parallel to such road, measured from the nearest edge of the sign face upon which the
2078 advertisement is placed to the nearest edge of a building or structure located on the real property of (i) a
2079 church, synagogue, mosque or other place of religious worship; (ii) a public, private, or parochial school
2080 or an institution of higher education; (iii) a public or private playground or similar recreational facility;
2081 or (iv) a dwelling used for residential use.

2082 B. However, (i) if there is no building or structure on a playground or similar recreational facility,
2083 the measurement shall be from the nearest edge of the sign face upon which the advertisement is placed
2084 to the property line of such playground or similar recreational facility and (ii) if a public or private
2085 school providing grade K through 12 education is located across the road from a sign, the measurement
2086 shall be from the nearest edge of the sign face upon which the advertisement is placed to the nearest
2087 edge of a building or structure located on such real property across the road.

2088 C. If, at the time the advertisement was displayed, the advertisement was more than 500 feet from (i)
2089 a church, synagogue, mosque or other place of religious worship; (ii) a public, private, or parochial

school or an institution of higher education; (iii) a public or private playground or similar recreational facility; or (iv) a dwelling used for residential use, but the circumstances change such that the advertiser would otherwise be in violation of subsection A, the Board shall permit the advertisement to remain as displayed for the remainder of the term of any written advertising contract, but in no event more than one year from the date of the change in circumstances.

D. The Board may grant a permit authorizing a variance from the distance requirements of this section upon a finding that the placement of alcoholic beverage advertising on a sign will not unduly expose children to alcoholic beverage advertising.

E. Provided such signs are in compliance with local ordinances, the distance and zoning restrictions contained in this section shall not apply to:

1. Signs placed by licensees upon the property on which the licensed premises are located; or
2. Directional signs placed by manufacturers or wholesalers with advertising limited to trade names, brand names, the terms "distillery," "brewery," "farm winery," or "winery," and tour information.

F. The distance and zoning restrictions contained in this section shall not apply to any sign that is included in the Integrated Directional Sign Program administered by the Virginia Department of Transportation or its agents.

G. Nothing in this section shall be construed to authorize billboard signs containing outdoor alcoholic beverage advertising on property zoned agricultural or residential, or on any unzoned property. Nor shall this section be construed to authorize the erection of new billboard signs containing outdoor advertising that would be prohibited under state law or local ordinance.

H. All lawfully erected outdoor alcoholic beverage signs shall comply with the provisions of this ~~title~~ *subtitle*, Board regulations, and Chapter 12 (§ 33.2-1200 et seq.) of Title 33.2 and regulations adopted pursuant thereto by the Commonwealth Transportation Board. Further, any outdoor alcoholic beverage directional sign located or to be located on highway rights of way shall also be governed by and comply with the Integrated Directional Sign Program administered by the Virginia Department of Transportation or its agents.

§ 4.1-113.1. Outdoor advertising; compliance with Title 33.2.

All lawfully erected outdoor alcoholic beverage signs shall comply with the provisions of this ~~title~~ *subtitle*, Board regulations, and Chapter 12 (§ 33.2-1200 et seq.) of Title 33.2 and regulations adopted pursuant thereto by the Commonwealth Transportation Board. Further, any outdoor alcoholic beverage directional sign located or to be located on highway rights-of-way shall also be governed by and comply with the Integrated Directional Sign Program administered by the Virginia Department of Transportation or its agents.

§ 4.1-115. Reports and accounting systems of Board; auditing books and records.

A. The Board shall make reports to the Governor as he may require covering the administration and enforcement of this ~~title~~ *subtitle*. Additionally, the Board shall submit an annual report to the Governor and General Assembly on or before December 15 each year, which shall contain:

1. A statement of the nature and amount of the business transacted by each government store during the year;
2. A statement of the assets and liabilities of the Board, including a statement of income and expenses and such other financial statements and matters as may be necessary to show the result of the operations of the Board for the year;
3. A statement showing the taxes collected under this ~~title~~ *subtitle* during the year;
4. General information and remarks about the working of the alcoholic beverage control laws within the Commonwealth; and

5. Any other information requested by the Governor.

B. The Board shall maintain an accounting system in compliance with generally accepted accounting principles and approved in accordance with § 2.2-803.

C. A regular postaudit shall be conducted of all accounts and transactions of the Board. An annual audit of a fiscal and compliance nature of the accounts and transactions of the Board shall be conducted by the Auditor of Public Accounts on or before October 1. The cost of the annual audit and postaudit examinations shall be borne by the Board. The Board may order such other audits as it deems necessary.

§ 4.1-116. Disposition of moneys collected by Board; creation of Enterprise Fund; reserve fund.

A. All moneys collected by the Board shall be paid directly and promptly into the state treasury, or shall be deposited to the credit of the State Treasurer in a state depository, without any deductions on account of salaries, fees, costs, charges, expenses, refunds or claims of any description whatever, as required by § 2.2-1802.

All moneys so paid into the state treasury, less the net profits determined pursuant to subsection C, shall be set aside as and constitute an Enterprise Fund, subject to appropriation, for the payment of (i) the salaries and remuneration of the members, agents, and employees of the Board and (ii) all costs and expenses incurred in establishing and maintaining government stores and in the administration of the

2151 provisions of this ~~title subtitle~~, including the purchasing, building, leasing and operation of distilleries
2152 and the manufacture of alcoholic beverages.

2153 B. The net profits derived under the provisions of this ~~title subtitle~~ shall be transferred by the
2154 Comptroller to the general fund of the state treasury quarterly, within ~~forty~~ 50 days after the close of
2155 each quarter or as otherwise provided in the appropriation act. As allowed by the Governor, the Board
2156 may deduct from the net profits quarterly a sum for the creation of a reserve fund not exceeding the
2157 sum of \$2.5 million in connection with the administration of this ~~title subtitle~~ and to provide for the
2158 depreciation on the buildings, plants and equipment owned, held or operated by the Board.

2159 C. The term "net profits" as used in this section means the total of all moneys collected by the Board
2160 less all costs, expenses and charges authorized by this section.

2161 **§ 4.1-118. Certain information not to be made public.**

2162 Neither the Board nor its employees shall divulge any information regarding (i) financial reports or
2163 records required pursuant to § 4.1-114; (ii) the purchase orders and invoices for beer and wine filed with
2164 the Board by wholesale beer and wine licensees; or (iii) beer and wine taxes collected from, refunded to,
2165 or adjusted for any person. The provisions of § 58.1-3 shall apply, mutatis mutandis, to beer and wine
2166 taxes collected pursuant to this ~~title subtitle~~ and to purchase orders and invoices for beer and wine filed
2167 with the Board by wholesale beer and wine licensees.

2168 Nothing contained in this section shall prohibit the use or release of such information or documents
2169 by the Board to any governmental or law-enforcement agency, or when considering the granting, denial,
2170 revocation, or suspension of a license or permit, or the assessment of any penalty against a licensee or
2171 permittee.

2172 Nor shall this section prohibit the Board or its employees from compiling and disseminating to any
2173 member of the public aggregate statistical information pertaining to (i) malt beverage excise tax
2174 collection as long as such information does not reveal or disclose excise tax collection from any
2175 identified licensee; (ii) the total quantities of wine sold or shipped into the Commonwealth by each
2176 out-of-state winery, distributor, or importer for resale in the Commonwealth by wholesale wine licensees
2177 collectively; (iii) the total amount of wine sales in the Commonwealth by wholesale wine licensees
2178 collectively; or (iv) the total amount of purchases or sales submitted by licensees as required pursuant to
2179 § 4.1-114, provided such information does not identify the licensee.

2180 **§ 4.1-119. (Effective until July 1, 2022) Operation of government stores.**

2181 A. Subject to the provisions of §§ 4.1-121 and 4.1-122, the Board may establish, maintain, and
2182 operate government stores for the sale of spirits, wine produced by farm wineries, low alcohol beverage
2183 coolers produced by licensed distillers, vermouth, mixers, products used in connection with distilled
2184 spirits, including any garnish or garnishment applied to the rim of a glass of distilled spirits, as may be
2185 approved by the Board from time to time, and products licensed by the Virginia Tourism Corporation as
2186 specified in § 4.1-103 in such counties, cities, and towns considered advisable by the Board. The Board
2187 may discontinue any such store.

2188 B. With respect to the sale of wine or cider produced by farm wineries, the Board may give
2189 preference to farm wineries that produce 2,500 cases or less of wine or cider per year.

2190 C. The Board shall fix the wholesale and retail prices at which the various classes, varieties and
2191 brands of alcoholic beverages and other Board-approved products that are sold in government stores.
2192 Differences in the cost of operating stores, and market competition and conditions may be reflected in
2193 the sale price of alcoholic beverages sold at government stores. The Board may sell alcoholic beverages
2194 to federal instrumentalities (i) authorized and operating under the laws of the United States and
2195 regulations of the United States Department of Defense and (ii) located within the boundaries of federal
2196 enclaves or reservations over which the United States has acquired jurisdiction, at prices which may be
2197 greater or less than the wholesale price charged other authorized purchasers. Nothing in this subsection
2198 shall be construed to limit the authority of the Board to fix the retail price of alcoholic beverages sold at
2199 government stores, which retail price may include promotional, volume, or other discounts deemed
2200 appropriate by the Board.

2201 D. Alcoholic beverages at government stores shall be sold by employees of the Authority who shall
2202 carry out the provisions of this ~~title subtitle~~ and Board regulations governing the operation of
2203 government stores and the sale of alcoholic beverages, except that the Board may appoint the holder of
2204 a distiller's license or its officers and employees as agents of the Board for the sale of spirits and low
2205 alcohol beverage coolers, manufactured by or for, or blended by such licensee on the licensed premises,
2206 at government stores established by the Board (i) on the distiller's licensed premises or (ii) at the site of
2207 an event licensed by the Board and conducted for the purpose of featuring and educating the consuming
2208 public about spirits products.

2209 Such agents shall sell the spirits and low alcohol beverage coolers in accordance with the provisions
2210 of this ~~title subtitle~~, Board regulations, and the terms of the agency agreement between the Authority
2211 and the licensed distiller. The Authority shall pay a licensed distiller making sales pursuant to an
2212 agreement authorized by this subsection a commission of not less than 20 percent of the retail price of

the goods sold. If the licensed distiller makes application and meets certain requirements established by the Board, such agreement shall allow monthly revenue transfers from the licensed distiller to the Board to be submitted electronically and, notwithstanding the provisions of §§ 2.2-1802 and 4.1-116, to be limited to the amount due to the Board in applicable taxes and markups.

For the purposes of this subsection, "blended" means the receipt by a licensed distiller of deliveries and shipments of alcoholic beverages, other than wine and beer, in accordance with subdivision A 6 of § 4.1-201 to be (a) (1) additionally aged by the receiving distillery in order to increase the quality and flavor of such alcoholic beverages or (2) used in a low alcohol beverage cooler and (b) bottled by the receiving distillery.

E. No Class 1 neutral grain spirit or alcohol, as defined by federal regulations, that is without distinctive character, aroma, taste or color shall be sold in government stores at a proof greater than 151 except upon permits issued by the Board for industrial, commercial, culinary, or medical use.

F. All alcoholic beverages sold in government stores, except for tasting samples pursuant to subsection G sold in government stores established by the Board on a distiller's licensed premises, shall be in closed containers, sealed and affixed with labels prescribed by the Board.

G. No alcoholic beverages shall be consumed in a government store by any person unless it is part of an organized tasting event conducted by (i) an employee of a manufacturer of distilled spirits or farm winery or (ii) an authorized representative of a manufacturer of distilled spirits or farm winery with a permit issued by the Board pursuant to subdivision A 14 of § 4.1-212, at which the samples of alcoholic beverages provided to any consumer do not exceed the limits for spirits or wine set forth in subdivision A 5 of § 4.1-201.1. No sample may be consumed by any individual to whom alcoholic beverages may not lawfully be sold pursuant to § 4.1-304.

Notwithstanding the provision of this subsection to the contrary, an agent of the Board appointed pursuant to subsection D may give samples of spirits, beer, wine, or cider to persons to whom alcoholic beverages may be lawfully sold for on-premises or off-premises consumption, provided that (i) the spirits, beer, wine, or cider samples are manufactured within the same licensed premises or on contiguous premises of such agent licensed as a distillery, brewery, or winery; (ii) no single sample shall exceed four ounces of beer, two ounces of wine or cider, or one-half ounce of spirits, unless served as a mixed beverage, in which case a single sample of spirits may contain up to one and one-half ounces of spirits; (iii) no more than 12 ounces of beer, five ounces of wine, or three ounces of spirits shall be given or sold to any person per day; and (iv) in the case of spirits samples, a method is used to track the consumption of each consumer. Nothing in this paragraph shall prohibit such agent from serving samples of spirits as part of a mixed beverage. Such mixed beverage samples may contain spirits or vermouth not manufactured on the licensed premises or on contiguous premises of the licensed distillery, provided that at least 75 percent of the alcohol used in such samples is manufactured on the licensed premises or on contiguous premises of the licensed distillery. An agent of the Board appointed pursuant to subsection D may keep on the licensed premises no more than 10 varieties of spirits or vermouth not manufactured on the licensed premises or on contiguous premises of the licensed distillery. Any spirits or vermouth used in such samples that are not manufactured on the licensed premises or on contiguous premises of the licensed distillery shall be purchased from the Board.

The Board shall establish guidelines governing tasting events conducted pursuant to this subsection.

Any case fee charged to a licensed distiller by the Board for moving spirits from the production and bailment area to the tasting area of a government store established by the Board on the distiller's licensed premises shall be waived if such spirits are moved by employees of the licensed distiller.

H. With respect to purchases by licensees at government stores, the Authority shall (i) accept in payment for any purchase or series of purchases cash, electronic fund transfer, credit or debit card, or check payable to the Authority, in the exact amount of any such purchase or series of purchases and (ii) provide notice to licensees on Board policies relating to the assignment of government stores from which licensees may purchase products and any procedure for the licensee to elect to make purchases from an alternative government store.

I. With respect to purchases by consumers at government stores, the Authority shall accept cash in payment for any purchase or series of purchases. The Board may adopt regulations which provide for accepting a credit card or debit card as payment. Such regulations may provide for the collection, where appropriate, of related fees, penalties and service charges for the use of a credit card or debit card by any consumer.

J. Before the Authority implements any increase in the markup on distilled spirits or any change to the markup formula for distilled spirits pursuant to § 4.1-235 that would result in an increase in the retail price of distilled spirits sold to the public, the Authority shall (i) provide at least 45 days' public notice before such a price increase takes effect; (ii) provide the opportunity for submission of written comments regarding the proposed price increase; (iii) conduct a public meeting for the purpose of receiving verbal comment regarding the proposed price increase; and (iv) consider any written or verbal

2274 comments before implementing such a price increase.

2275 **§ 4.1-119. (Effective July 1, 2022) Operation of government stores.**

2276 A. Subject to the provisions of §§ 4.1-121 and 4.1-122, the Board may establish, maintain, and
2277 operate government stores for the sale of spirits, wine produced by farm wineries, low alcohol beverage
2278 coolers produced by licensed distillers, vermouth, mixers, products used in connection with distilled
2279 spirits, including any garnish or garnishment applied to the rim of a glass of distilled spirits, as may be

2314 § 4.1-201 to be (a) (1) additionally aged by the receiving distillery in order to increase the quality and
2315 flavor of such alcoholic beverages or (2) used in a low alcohol beverage cooler and (b) bottled by the
2316 receiving distillery.

2317 E. No Class 1 neutral grain spirit or alcohol, as defined by federal regulations, that is without
2318 distinctive character, aroma, taste or color shall be sold in government stores at a proof greater than 101
2319 except upon permits issued by the Board for industrial, commercial, culinary, or medical use.

2320 F. All alcoholic beverages sold in government stores, except for tasting samples pursuant to
2321 subsection G sold in government stores established by the Board on a distiller's licensed premises, shall
2322 be in closed containers, sealed and affixed with labels prescribed by the Board.

2323 G. No alcoholic beverages shall be consumed in a government store by any person unless it is part
2324 of an organized tasting event conducted by (i) an employee of a manufacturer of distilled spirits or farm
2325 winery or (ii) an authorized representative of a manufacturer of distilled spirits or farm winery with a
2326 permit issued by the Board pursuant to subdivision A 14 of § 4.1-212, at which the samples of alcoholic
2327 beverages provided to any consumer do not exceed the limits for spirits or wine set forth in subdivision
2328 A 5 of § 4.1-201.1. No sample may be consumed by any individual to whom alcoholic beverages may

Any spirits or vermouth used in such samples that are not manufactured on the licensed premises or on contiguous premises of the licensed distillery shall be purchased from the Board.

The Board shall establish guidelines governing tasting events conducted pursuant to this subsection.

Any case fee charged to a licensed distiller by the Board for moving spirits from the production and bailment area to the tasting area of a government store established by the Board on the distiller's licensed premises shall be waived if such spirits are moved by employees of the licensed distiller.

H. With respect to purchases by licensees at government stores, the Authority shall (i) accept in payment for any purchase or series of purchases cash, electronic fund transfer, credit or debit card, or check payable to the Authority, in the exact amount of any such purchase or series of purchases and (ii) provide notice to licensees on Board policies relating to the assignment of government stores from which licensees may purchase products and any procedure for the licensee to elect to make purchases from an alternative government store.

I. With respect to purchases by consumers at government stores, the Authority shall accept cash in payment for any purchase or series of purchases. The Board may adopt regulations which provide for accepting a credit card or debit card as payment. Such regulations may provide for the collection, where appropriate, of related fees, penalties and service charges for the use of a credit card or debit card by any consumer.

J. Before the Authority implements any increase in the markup on distilled spirits or any change to the markup formula for distilled spirits pursuant to § 4.1-235 that would result in an increase in the retail price of distilled spirits sold to the public, the Authority shall (i) provide at least 45 days' public notice before such a price increase takes effect; (ii) provide the opportunity for submission of written comments regarding the proposed price increase; (iii) conduct a public meeting for the purpose of receiving verbal comment regarding the proposed price increase; and (iv) consider any written or verbal comments before implementing such a price increase.

§ 4.1-122. Effect of local option referenda.

A. If in any referendum held under the provisions of § 4.1-121 in any county, city, or town a majority of the qualified voters vote "Yes" on the question, then on and after 60 days from the date on which the order of the court, setting forth the results of such referendum was entered of record, none of the alcoholic beverages voted against shall be sold in such county, city, or town except for delivery or shipment to persons outside of such county, city, or town authorized under this ~~title~~ subtitle to acquire the alcoholic beverages for resale. This subsection shall not apply to common carriers of passengers by train, boat or airplane selling wine and beer to bona fide passengers.

B. If in any such referendum held in any county, city, or town in which a majority of the qualified voters have previously voted to prohibit the sale of alcoholic beverages by the Board and in a subsequent election a majority of the voters of the county, city, or town vote "No" on the question stated in § 4.1-121, then such alcoholic beverages may, in accordance with this ~~title~~ subtitle, be sold within the county, city, or town on and after 60 days from the day on which the order of the court setting forth the results of such election is entered of record.

C. If any referendum is held under the provisions of § 4.1-124 in any county, town, or supervisor's election district of a county and the majority of voters voting in such referendum voted "Yes," the sale by the Board of alcoholic beverages, other than beer and wine not produced by farm wineries, shall be prohibited in such county, town, or supervisor's election district of a county. Notwithstanding this section and any referendum held under § 4.1-121 to the contrary, persons licensed to sell mixed beverages in such county, town, or supervisor's election district of a county shall also be permitted to sell wine and beer for on-premises consumption, provided the appropriate license fees are paid for the privilege.

D. The provisions of this section shall not prevent in any county, city, or town, the sale and delivery or shipment of alcoholic beverages specified in § 4.1-200 to and by persons therein authorized to sell alcoholic beverages, nor prevent the delivery or shipment of alcoholic beverages under Board regulations into any county, city, or town, except as otherwise prohibited by this ~~title~~ subtitle.

E. For the purpose of this section, when any referendum is held in any town, separate and apart from

the county in which such town or a part thereof is located, such town shall be treated as being separate and apart from such county.

§ 4.1-124. Referendum on the sale of mixed beverages.

A. The provisions of this ~~title~~ *subtitle* relating to the sale of mixed beverages shall be effective in any town, county, or supervisor's election district of a county unless a majority of the voters voting in a referendum vote "Yes" on the question of whether the sale of mixed alcoholic beverages by restaurants licensed under this ~~title~~ *subtitle* should be prohibited. The qualified voters of a town, county, or supervisor's election district of a county may file a petition with the circuit court of the county asking that a referendum be held on the question of whether the sale of mixed beverages by restaurants licensed by the Board should be prohibited within that jurisdiction. The petition shall be signed by qualified voters equal in number to at least 10 percent of the number registered in the town, county, or supervisor's election district on January 1 preceding its filing or at least 100 qualified voters, whichever is greater.

Petition requirements for any county shall be based on the number of registered voters in the county, including the number of registered voters in any town having a population in excess of 1,000 located within such county. Upon the filing of a petition, and under no other circumstances, the court shall order the election officials of the county to conduct a referendum on the question.

The clerk of the circuit court of the county shall publish notice of the referendum in a newspaper of general circulation in the town, county, or supervisor's election district once a week for three consecutive weeks prior to the referendum.

The question on the ballot shall be:

"Shall the sale of mixed alcoholic beverages by restaurants licensed by the Virginia Alcoholic Beverage Control Authority be prohibited in _____ (name of town, county, or supervisor's election district of county)?"

The referendum shall be ordered and held and the results certified as provided in Article 5 (§ 24.2-681 et seq.) of Chapter 6 of Title 24.2. Thereupon the court shall enter of record an order certified by the clerk of the court to be transmitted to the Board and to the governing body of the town or county. Mixed beverages prohibited from sale by such referendum shall not be sold by restaurants within the town, county, or supervisor's election district of a county on or after 30 days following the entry of the order if a majority of the voters voting in the referendum have voted "Yes."

The provisions of this section shall be applicable to towns having a population in excess of 1,000 to the same extent and subject to the same conditions and limitations as are otherwise applicable to counties under this section. Such towns shall be treated as separate local option units, and only residents of any such town shall be eligible to vote in any referendum held pursuant to this section for any such town. Residents of towns having a population in excess of 1,000, however, shall also be eligible to vote in any referendum held pursuant to this section for any county in which the town is located.

Notwithstanding the provisions of this section, the sale of mixed beverages by restaurants shall be prohibited in any town created as a result of a city-to-town reversion pursuant to Chapter 41 (§ 15.2-4100 et seq.) of Title 15.2 if a referendum on the question of whether the sale of mixed beverages by restaurants licensed under this ~~title~~ *subtitle* should be prohibited was previously held in the former city and a majority of the voters voting in such referendum voted "Yes."

B. Once a referendum has been held, no other referendum on the same question shall be held in the town, county, or supervisor's election district of a county for a period of 23 months.

C. Notwithstanding the provisions of subsection A, the sale of mixed beverages shall be allowed on property dedicated for industrial or commercial development and controlled through the provision of public utilities and covenanting of the land by any multijurisdictional industrial development authority, as set forth under Chapter 49 (§ 15.2-4900 et seq.) of Title 15.2, provided that (i) such authority operates under a partnership agreement between three or more counties, cities, or towns and such jurisdictions participate administratively and financially in the authority and (ii) the sale of mixed beverages is permitted in one of the member counties, cities, towns, or a supervisor's election district of one of the counties and that the governing board of the authority authorizes an establishment located within the confines of such property to apply to the Board for such license. The appropriate license fees shall be paid for this privilege.

D. Notwithstanding the provisions of subsection A of this section and subsection C of § 4.1-122, the sale of mixed beverages by licensees, and the sale of alcoholic beverages other than beer and wine not produced by farm wineries by the Board, shall be allowed in any city in the Commonwealth.

E. Notwithstanding the provisions of subsection A, the Board may grant a mixed beverage restaurant license to a restaurant located on the premises of and operated by a private club exclusively for its members and their guests, subject to the qualifications and restrictions on the issuance of such license imposed by § 4.1-206.3. However, no license authorized by this subsection shall be granted if the private club restricts its membership on the basis of race, color, creed, national origin, or sex.

§ 4.1-128. Local ordinances or resolutions regulating or taxing alcoholic beverages.

A. No county, city, or town shall, except as provided in § 4.1-205 or 4.1-129, adopt any ordinance or resolution which regulates or prohibits the manufacture, bottling, possession, sale, wholesale distribution, handling, transportation, drinking, use, advertising or dispensing of alcoholic beverages in the Commonwealth. Nor shall any county, city, or town adopt an ordinance or resolution that prohibits or regulates the storage, warehousing, and wholesaling of wine in accordance with Title 4.1, regulations of the Board, and federal law at a licensed farm winery.

No provision of law, general or special, shall be construed to authorize any county, city or town to adopt any ordinance or resolution that imposes a sales or excise tax on alcoholic beverages, other than the taxes authorized by § 58.1-605, 58.1-3833 or 58.1-3840. The foregoing limitation shall not affect the authority of any county, city or town to impose a license or privilege tax or fee on a business engaged in whole or in part in the sale of alcoholic beverages if the license or privilege tax or fee (i) is based on an annual or per event flat fee specifically authorized by general law or (ii) is an annual license or privilege tax specifically authorized by general law, which includes alcoholic beverages in its taxable measure and treats alcoholic beverages the same as if they were nonalcoholic beverages.

B. However, the governing body of any county, city, or town may adopt an ordinance that (i) prohibits the acts described in subsection A of § 4.1-308 subject to the provisions of subsections B and E of § 4.1-308, or the acts described in § 4.1-309, and may provide a penalty for violation thereof and (ii) subject to subsection C of § 4.1-308, regulates or prohibits the possession of opened alcoholic beverage containers in its local public parks, playgrounds, public streets, and any sidewalk adjoining any public street.

C. Except as provided in this section, all local acts, including charter provisions and ordinances of cities and towns, inconsistent with any of the provisions of this ~~title~~ subtitle, are repealed to the extent of such inconsistency.

§ 4.1-200. Exemptions from licensure.

The licensure requirements of this chapter shall not apply to:

1. A person in charge of an institution regularly conducted as a hospital or sanatorium for the care of persons in ill health, or as a home devoted exclusively to the care of aged people, who administers or causes to be administered alcoholic beverages to any bona fide patient or inmate of the institution who is in need of the same, either by way of external application or otherwise for emergency medicinal purposes. Such person may charge for the alcoholic beverages so administered, and carry such stock as may be necessary for this purpose. No charge shall be made of any patient for the alcoholic beverages so administered to him where the same have been supplied to the institution by the Board free of charge.

2. The manufacture, sale and delivery or shipment by persons authorized under existing laws to engage in such business of any medicine containing sufficient medication to prevent it from being used as a beverage.

3. The manufacture, sale and delivery or shipment by persons authorized under existing laws to engage in such business of any medicinal preparations manufactured in accordance with formulas prescribed by the United States pharmacopoeia; national formulary, patent and proprietary preparations; and other bona fide medicinal and technical preparations; which contain no more alcohol than is necessary to extract the medicinal properties of the drugs contained in such preparations, and no more alcohol than is necessary to hold the medicinal agents in solution and to preserve the same, and which are manufactured and sold to be used exclusively as medicine and not as beverages.

4. The manufacture, sale and delivery or shipment of toilet, medicinal and antiseptic preparations and solutions not intended for internal human use nor to be sold as beverages.

5. The manufacture and sale of food products known as flavoring extracts which are manufactured and sold for cooking and culinary purposes only and not sold as beverages.

6. Any person who manufactures at his residence or at a gourmet brewing shop for domestic consumption at his residence, but not to be sold, dispensed or given away, except as hereinafter provided, wine or beer or both, in an amount not to exceed the limits permitted by federal law.

Any person who manufactures wine or beer in accordance with this subdivision may remove from his residence an amount not to exceed ~~forty~~ 50 liters of such wine or ~~fifteen~~ 15 gallons of such beer on any one occasion for (i) personal or family use, provided such use does not violate the provisions of this ~~title~~ subtitle or Board regulations; (ii) giving to any person to whom wine or beer may be lawfully sold an amount not to exceed (a) one liter of wine per person per year or (b) ~~seventy-two~~ 72 ounces of beer per person per year, provided such gift is for noncommercial purposes; or (iii) giving to any person to whom beer may lawfully be sold a sample of such wine or beer, not to exceed (a) one ounce of wine by volume or (b) two ounces of beer by volume for on-premises consumption at events organized for judging or exhibiting such wine or beer, including events held on the premises of a retail licensee. Nothing in this paragraph shall be construed to authorize the sale of such wine or beer.

The provision of this subdivision shall not apply to any person who resides on property on which a

2520 winery, farm winery, or brewery is located.

2521 7. Any person who keeps and possesses lawfully acquired alcoholic beverages in his residence for his
2522 personal use or that of his family. However, such alcoholic beverages may be served or given to guests
2523 in such residence by such person, his family or servants when (i) such guests are 21 years of age or
2524 older or are accompanied by a parent, guardian, or spouse who is 21 years of age or older, (ii) the
2525 consumption or possession of such alcoholic beverages by family members or such guests occurs only in
2526 such residence where the alcoholic beverages are allowed to be served or given pursuant to this
2527 subdivision, and (iii) such service or gift is in no way a shift or device to evade the provisions of this
2528 ~~title subtitle~~. The provisions of this subdivision shall not apply when a person serves or provides
2529 alcoholic beverages to a guest occupying the residence as the lessee of a short-term rental, as that term
2530 is defined in § 15.2-983, regardless of whether the person who permanently resides in the residence is
2531 present during the short-term rental.

2532 8. Any person who manufactures and sells cider to distillery licensees, or any person who
2533 manufactures wine from grapes grown by such person and sells it to winery licensees.

2534 9. The sale of wine and beer in or through canteens or post exchanges on United States reservations
2535 when permitted by the proper authority of the United States.

2536 10. The keeping and consumption of any lawfully acquired alcoholic beverages at a private meeting
2537 or private party limited in attendance to members and guests of a particular group, association or
2538 organization at a banquet or similar affair, or at a special event, if a banquet license has been granted.
2539 However, no banquet license shall be required for private meetings or private parties limited in
2540 attendance to the members of a common interest community as defined in § 54.1-2345 and their guests,
2541 provided (i) the alcoholic beverages shall not be sold or charged for in any way, (ii) the premises where
2542 the alcoholic beverages are consumed is limited to the common area regularly occupied and utilized for
2543 such private meetings or private parties, and (iii) such meetings or parties are not open to the public.

2544 **§ 4.1-201. Conduct not prohibited by this subtitle; limitation.**

2545 A. Nothing in this ~~title subtitle~~ or any Board regulation adopted pursuant thereto shall prohibit:

2546 1. Any club licensed under this chapter from keeping for consumption by its members any alcoholic
2547 beverages lawfully acquired by such members, provided the alcoholic beverages are not sold, dispensed
2548 or given away in violation of this ~~title subtitle~~.

2549 2. Any person from having grain, fruit or fruit products and any other substance, when grown or
2550 lawfully produced by him, distilled by any distillery licensee, and selling the distilled alcoholic
2551 beverages to the Board or selling or shipping them to any person outside of the Commonwealth in
2552 accordance with Board regulations. However, no alcoholic beverages so distilled shall be withdrawn
2553 from the place where distilled except in accordance with Board regulations.

2554 3. Any person licensed to manufacture and sell, or either, in the Commonwealth or elsewhere,
2555 alcoholic beverages other than wine or beer, from soliciting and taking orders from the Board for such
2556 alcoholic beverages.

2557 4. The receipt by a person operating a licensed brewery of deliveries and shipments of beer in closed
2558 containers or the sale, delivery or shipment of such beer, in accordance with Board regulations to (i)
2559 persons licensed to sell beer at wholesale, (ii) persons licensed to sell beer at retail for the purpose of
2560 resale only as provided in subdivision B 4 of § 4.1-216, (iii) owners of boats registered under the laws
2561 of the United States sailing for ports of call of a foreign country or another state, and (iv) persons
2562 outside the Commonwealth for resale outside the Commonwealth.

2563 5. The granting of any retail license to a brewery, distillery, or winery licensee, or to an applicant for
2564 such license, or to a lessee of such person, a wholly owned subsidiary of such person, or its lessee,
2565 provided the places of business or establishments for which the retail licenses are desired are located
2566 upon the premises occupied or to be occupied by such distillery, winery, or brewery, or upon property
2567 of such person contiguous to such premises, or in a development contiguous to such premises owned
2568 and operated by such person or a wholly owned subsidiary.

2569 6. The receipt by a distillery licensee of deliveries and shipments of alcoholic beverages, other than
2570 wine and beer, in closed containers from other distilleries, or the sale, delivery or shipment of such
2571 alcoholic beverages, in accordance with Board regulations, to the Board and to persons outside the
2572 Commonwealth for resale outside the Commonwealth.

2573 7. The receipt by a farm winery or winery licensee of deliveries and shipments of wine in closed
2574 containers from other wineries or farm wineries located inside or outside the Commonwealth, or the
2575 receipt by a winery licensee or farm winery licensee of deliveries and shipments of spirits distilled from
2576 fruit or fruit juices in closed containers from distilleries located inside or outside the Commonwealth to
2577 be used only for the fortification of wine produced by the licensee in accordance with Board regulations,
2578 or the sale, delivery or shipment of such wine, in accordance with Board regulations, to persons licensed
2579 to sell wine at wholesale for the purpose of resale, and to persons outside the Commonwealth for resale
2580 outside the Commonwealth.

2581 8. Any farm winery or winery licensee from shipping or delivering its wine in closed containers to

another farm winery or winery licensee for the purpose of additional bottling in accordance with Board regulations and the return of the wine so bottled to the manufacturing farm winery or winery licensee.

9. Any farm winery or winery licensee from selling and shipping or delivering its wine in closed containers to another farm winery or winery licensee, the wine so sold and shipped or delivered to be used by the receiving licensee in the manufacture of wine. Any wine received under this subsection shall be deemed an agricultural product produced in the Commonwealth for the purposes of § 4.1-219, to the extent it is produced from fresh fruits or agricultural products grown or produced in the Commonwealth. The selling licensee shall provide to the receiving licensee, and both shall maintain complete and accurate records of, the source of the fresh fruits or agricultural products used to produce the wine so transferred.

10. Any retail on-and-off-premises wine and beer licensee, his agent or employee, from giving a sample of wine or beer to persons to whom alcoholic beverages may be lawfully sold for on-premises consumption, or any mixed beverage licensee, his agent or employee, from giving a sample of wine, beer, or spirits to persons to whom alcoholic beverages may be lawfully sold for on-premises consumption. Samples of wine shall not exceed two ounces, samples of beer shall not exceed four ounces, and samples of spirits shall not exceed one-half ounce, unless served as a mixed beverage, in which case a sample of spirits may contain up to one and one-half ounces of spirits. No more than 12 ounces of beer, five ounces of wine, or three ounces of spirits shall be given to any person per day.

11. Any manufacturer, including any vendor authorized by any such manufacturer, whether or not licensed in the Commonwealth, from selling service items bearing alcoholic brand references to on-premises retail licensees or prohibit any such retail licensee from displaying the service items on the premises of his licensed establishment. Each such retail licensee purchasing such service items shall retain a copy of the evidence of his payment to the manufacturer or authorized vendor for a period of not less than two years from the date of each sale of the service items. As used in this subdivision, "service items" mean articles of tangible personal property normally used by the employees of on-premises retail licensees to serve alcoholic beverages to customers including, but not limited to, glasses, napkins, buckets, and coasters.

12. Any employee of an alcoholic beverage wholesaler or manufacturer, whether or not licensed in the Commonwealth, from distributing to retail licensees and their employees novelties and specialties, including wearing apparel, having a wholesale value of \$10 or less and that bear alcoholic beverage advertising. Such items may be distributed to retail licensees in quantities equal to the number of employees of the retail establishment present at the time the items are delivered. Thereafter, such employees may wear or display the items on the licensed premises.

13. Any (i) retail on-premises wine and beer licensee, his agent or employee from offering for sale or selling for one price to any person to whom alcoholic beverages may be lawfully sold a flight of wines or beers consisting of samples of not more than five different wines or beers and (ii) mixed beverage licensee, his agent or employee from offering for sale or selling for one price to any person to whom alcoholic beverages may be lawfully sold a flight of distilled spirits consisting of samples of not more than five different spirits products.

14. Any restaurant licensed under this chapter from permitting the consumption of lawfully acquired wine, beer, or cider by bona fide customers on the premises in all areas and locations covered by the license, provided that (i) all such wine, beer, or cider shall have been acquired by the customer from a retailer licensed to sell such alcoholic beverages and (ii) no such wine, beer, or cider shall be brought onto the licensed premises by the customer except in sealed, nonresealable bottles or cans. The licensee may charge a corkage fee to such customer for the wine, beer, or cider so consumed; however, the licensee shall not charge any other fee to such customer.

15. Any winery, farm winery, wine importer, wine wholesaler, brewery, limited brewery, beer importer, beer wholesaler, or distiller licensee from providing to adult customers of licensed retail establishments information about wine, beer, or spirits being consumed on such premises.

16. Any private swim club operated by a duly organized nonprofit corporation or association from allowing members to bring lawfully acquired alcoholic beverages onto the premises of such club and consume such alcoholic beverages on the premises of such club.

B. No deliveries or shipments of alcoholic beverages to persons outside the Commonwealth for resale outside the Commonwealth shall be made into any state the laws of which prohibit the consignee from receiving or selling the same.

§ 4.1-202. To whom privileges conferred by licenses extend; liability for violations of law.

The privilege of any licensee to sell or serve alcoholic beverages shall extend to such licensee and to all agents or employees of such licensee for the purpose of selling or serving alcoholic beverages under such license. The licensee may be held liable for any violation of this ~~title~~ *subsection* or any Board regulation committed by such agents or employees in connection with their employment.

§ 4.1-205. Local licenses.

A. In addition to the state licenses provided for in this chapter, the governing body of each county, city or town in the Commonwealth may provide by ordinance for the issuance of county, city or town licenses and to charge and collect license taxes therefor, to persons licensed by the Board to manufacture, bottle or sell alcoholic beverages within such county, city or town, except for temporary licenses authorized by § 4.1-211. Subject to § 4.1-233.1, the governing body of a county, city or town may classify licenses and graduate the license taxes therefor in the manner it deems proper.

B. No county, city, or town shall issue a local license to any person who does not hold or secure simultaneously the proper state license. If any person holds any local license without at the same time holding the proper state license, the local license, during the period when such person does not hold the proper state license, shall confer no privileges under the provisions of this ~~title~~ subtitle.

§ 4.1-206.1. (Effective until July 1, 2022) Manufacturer licenses.

The Board may grant the following manufacturer licenses:

1. Distiller's licenses, which shall authorize the licensee to manufacture alcoholic beverages other than wine and beer, and to sell and deliver or ship the same, in accordance with Board regulations, in closed containers, to the Board and to persons outside the Commonwealth for resale outside the Commonwealth. When the Board has established a government store on the distiller's licensed premises pursuant to subsection D of § 4.1-119, such license shall also authorize the licensee to make a charge to consumers to participate in an organized tasting event conducted in accordance with subsection G of § 4.1-119 and Board regulations.

2. Limited distiller's licenses, to distilleries that (i) are located on a farm in the Commonwealth on land zoned agricultural and owned or leased by such distillery or its owner and (ii) use agricultural products that are grown on the farm in the manufacture of their alcoholic beverages. Limited distiller's licensees shall be treated as distillers for all purposes of this ~~title~~ subtitle except as otherwise provided in this subdivision. For purposes of this subdivision, "land zoned agricultural" means (a) land zoned as an agricultural district or classification or (b) land otherwise permitted by a locality for limited distillery use. For purposes of this subdivision, "land zoned agricultural" does not include land zoned "residential conservation." Except for the limitation on land zoned "residential conservation," nothing in this definition shall otherwise limit or affect local zoning authority.

3. Brewery licenses, which shall authorize the licensee to manufacture beer and to sell and deliver or ship the beer so manufactured, in accordance with Board regulations, in closed containers to (i) persons licensed to sell the beer at wholesale and (ii) persons outside the Commonwealth for resale outside the Commonwealth. Such license shall also authorize the licensee to sell at retail at premises described in the brewery license (a) the brands of beer that the brewery owns for on-premises consumption, provided that not less than 20 percent of the volume of beer sold for on-premises consumption in any calendar year is manufactured on the licensed premises, and (b) beer in closed containers, which shall include growlers and other reusable containers, for off-premises consumption.

4. Limited brewery licenses, to breweries that manufacture no more than 15,000 barrels of beer per calendar year, provided that (i) the brewery is located on a farm in the Commonwealth on land zoned agricultural and owned or leased by such brewery or its owner and (ii) agricultural products, including barley, other grains, hops, or fruit, used by such brewery in the manufacture of its beer are grown on the farm. The licensed premises shall be limited to the portion of the farm on which agricultural products, including barley, other grains, hops, or fruit, used by such brewery in the manufacture of its beer are grown and that is contiguous to the premises of such brewery where the beer is manufactured, exclusive of any residence and the curtilage thereof. However, the Board may, with notice to the local governing body in accordance with the provisions of § 4.1-230, also approve other portions of the farm to be included as part of the licensed premises. For purposes of this subdivision, "land zoned agricultural" means (a) land zoned as an agricultural district or classification or (b) land otherwise permitted by a locality for limited brewery use. For purposes of this subdivision, "land zoned agricultural" does not include land zoned "residential conservation." Except for the limitation on land zoned "residential conservation," nothing in this definition shall otherwise limit or affect local zoning authority.

Limited brewery licensees shall be treated as breweries for all purposes of this ~~title~~ subtitle except as otherwise provided in this subdivision.

5. Winery licenses, which shall authorize the licensee to manufacture wine and to sell and deliver or ship the wine, in accordance with Board regulations, in closed containers, to persons licensed to sell the wine so manufactured at wholesale for the purpose of resale, and to persons outside the Commonwealth for resale outside the Commonwealth. In addition, such license shall authorize the licensee to (i) operate distilling equipment on the premises of the licensee in the manufacture of spirits from fruit or fruit juices only, which shall be used only for the fortification of wine produced by the licensee; (ii) operate a contract winemaking facility on the premises of the licensee in accordance with Board regulations; (iii) store wine in bonded warehouses on or off the licensed premises upon permit issued by the Board; and (iv) sell wine at retail at the place of business designated in the winery license for on-premises

consumption or in closed containers for off-premises consumption, provided that any brand of wine not owned by the winery licensee is purchased from a wholesale wine licensee and any wine sold for on-premises consumption is manufactured on the licensed premises.

6. Farm winery licenses, which shall authorize the licensee to manufacture wine containing 21 percent or less of alcohol by volume and to sell, deliver, or ship the wine, in accordance with Board regulations, in closed containers, to (i) the Board, (ii) persons licensed to sell the wine so manufactured at wholesale for the purpose of resale, or (iii) persons outside the Commonwealth. In addition, the licensee may (a) acquire and receive deliveries and shipments of wine and sell and deliver or ship this wine, in accordance with Board regulations, to the Board, persons licensed to sell wine at wholesale for the purpose of resale, or persons outside the Commonwealth; (b) operate a contract winemaking facility on the premises of the licensee in accordance with Board regulations; and (c) store wine in bonded warehouses located on or off the licensed premises upon permits issued by the Board. For the purposes of this ~~title~~ *subtitle*, a farm winery license shall be designated either as a Class A or Class B farm winery license in accordance with the limitations set forth in § 4.1-219. A farm winery may enter into an agreement in accordance with Board regulations with a winery or farm winery licensee operating a contract winemaking facility.

Such licenses shall also authorize the licensee to sell wine at retail at the places of business designated in the licenses, which may include no more than five additional retail establishments of the licensee. Wine may be sold at these business places for on-premises consumption and in closed containers for off-premises consumption, provided that any brand of wine not owned by the farm winery licensee is purchased from a wholesale wine licensee. In addition, wine may be pre-mixed by the licensee to be served and sold for on-premises or off-premises consumption at these business places.

7. Wine importer's licenses, which shall authorize persons located within or outside the Commonwealth to sell and deliver or ship wine, in accordance with Board regulations, in closed containers, to persons in the Commonwealth licensed to sell such wine at wholesale for the purpose of resale, and to persons outside the Commonwealth for resale outside the Commonwealth.

8. Beer importer's licenses, which shall authorize persons located within or outside the Commonwealth to sell and deliver or ship beer, in accordance with Board regulations, in closed containers, to persons in the Commonwealth licensed to sell such beer at wholesale for the purpose of resale and to persons outside the Commonwealth for resale outside the Commonwealth.

§ 4.1-206.1. (Effective July 1, 2022) Manufacturer licenses.

The Board may grant the following manufacturer licenses:

1. Distiller's licenses, which shall authorize the licensee to manufacture alcoholic beverages other than wine and beer, and to sell and deliver or ship the same, in accordance with Board regulations, in closed containers, to the Board and to persons outside the Commonwealth for resale outside the Commonwealth. When the Board has established a government store on the distiller's licensed premises pursuant to subsection D of § 4.1-119, such license shall also authorize the licensee to make a charge to consumers to participate in an organized tasting event conducted in accordance with subsection G of § 4.1-119 and Board regulations.

2. Limited distiller's licenses, to distilleries that (i) are located on a farm in the Commonwealth on land zoned agricultural and owned or leased by such distillery or its owner and (ii) use agricultural products that are grown on the farm in the manufacture of their alcoholic beverages. Limited distiller's licensees shall be treated as distillers for all purposes of this ~~title~~ *subtitle* except as otherwise provided in this subdivision. For purposes of this subdivision, "land zoned agricultural" means (a) land zoned as an agricultural district or classification or (b) land otherwise permitted by a locality for limited distillery use. For purposes of this subdivision, "land zoned agricultural" does not include land zoned "residential conservation." Except for the limitation on land zoned "residential conservation," nothing in this definition shall otherwise limit or affect local zoning authority.

3. Brewery licenses, which shall authorize the licensee to manufacture beer and to sell and deliver or ship the beer so manufactured, in accordance with Board regulations, in closed containers to (i) persons licensed to sell the beer at wholesale and (ii) persons outside the Commonwealth for resale outside the Commonwealth. Such license shall also authorize the licensee to sell at retail at premises described in the brewery license (a) the brands of beer that the brewery owns for on-premises consumption, provided that not less than 20 percent of the volume of beer sold for on-premises consumption in any calendar year is manufactured on the licensed premises, and (b) beer in closed containers, which shall include growlers and other reusable containers, for off-premises consumption.

4. Limited brewery licenses, to breweries that manufacture no more than 15,000 barrels of beer per calendar year, provided that (i) the brewery is located on a farm in the Commonwealth on land zoned agricultural and owned or leased by such brewery or its owner and (ii) agricultural products, including barley, other grains, hops, or fruit, used by such brewery in the manufacture of its beer are grown on the farm. The licensed premises shall be limited to the portion of the farm on which agricultural

2766 products, including barley, other grains, hops, or fruit, used by such brewery in the manufacture of its
2767 beer are grown and that is contiguous to the premises of such brewery where the beer is manufactured,
2768 exclusive of any residence and the curtilage thereof. However, the Board may, with notice to the local
2769 governing body in accordance with the provisions of § 4.1-230, also approve other portions of the farm
2770 to be included as part of the licensed premises. For purposes of this subdivision, "land zoned
2771 agricultural" means (a) land zoned as an agricultural district or classification or (b) land otherwise
2772 permitted by a locality for limited brewery use. For purposes of this subdivision, "land zoned
2773 agricultural" does not include land zoned "residential conservation." Except for the limitation on land
2774 zoned "residential conservation," nothing in this definition shall otherwise limit or affect local zoning
2775 authority.

2776 Limited brewery licensees shall be treated as breweries for all purposes of this ~~title~~ subtitle except as
2777 otherwise provided in this subdivision.

2778 5. Winery licenses, which shall authorize the licensee to manufacture wine and to sell and deliver or
2779 ship the wine, in accordance with Board regulations, in closed containers, to persons licensed to sell the
2780 wine so manufactured at wholesale for the purpose of resale, and to persons outside the Commonwealth
2781 for resale outside the Commonwealth. In addition, such license shall authorize the licensee to (i) operate
2782 distilling equipment on the premises of the licensee in the manufacture of spirits from fruit or fruit
2783 juices only, which shall be used only for the fortification of wine produced by the licensee; (ii) operate
2784 a contract winemaking facility on the premises of the licensee in accordance with Board regulations; (iii)
2785 store wine in bonded warehouses on or off the licensed premises upon permit issued by the Board; and
2786 (iv) sell wine at retail at the place of business designated in the winery license for on-premises
2787 consumption or in closed containers for off-premises consumption, provided that any brand of wine not
2788 owned by the winery licensee is purchased from a wholesale wine licensee and any wine sold for
2789 on-premises consumption is manufactured on the licensed premises.

2790 6. Farm winery licenses, which shall authorize the licensee to manufacture wine containing 21
2791 percent or less of alcohol by volume and to sell, deliver, or ship the wine, in accordance with Board
2792 regulations, in closed containers, to (i) the Board, (ii) persons licensed to sell the wine so manufactured
2793 at wholesale for the purpose of resale, or (iii) persons outside the Commonwealth. In addition, the
2794 licensee may (a) acquire and receive deliveries and shipments of wine and sell and deliver or ship this
2795 wine, in accordance with Board regulations, to the Board, persons licensed to sell wine at wholesale for
2796 the purpose of resale, or persons outside the Commonwealth; (b) operate a contract winemaking facility
2797 on the premises of the licensee in accordance with Board regulations; and (c) store wine in bonded
2798 warehouses located on or off the licensed premises upon permits issued by the Board. For the purposes
2799 of this ~~title~~ subtitle, a farm winery license shall be designated either as a Class A or Class B farm
2800 winery license in accordance with the limitations set forth in § 4.1-219. A farm winery may enter into
2801 an agreement in accordance with Board regulations with a winery or farm winery licensee operating a
2802 contract winemaking facility.

2803 Such licenses shall also authorize the licensee to sell wine at retail at the places of business
2804 designated in the licenses, which may include no more than five additional retail establishments of the
2805 licensee. Wine may be sold at these business places for on-premises consumption and in closed
2806 containers for off-premises consumption, provided that any brand of wine not owned by the farm winery
2807 licensee is purchased from a wholesale wine licensee. In addition, wine may be pre-mixed by the
2808 licensee to be served and sold for on-premises consumption at these business places.

2809 7. Wine importer's licenses, which shall authorize persons located within or outside the
2810 Commonwealth to sell and deliver or ship wine, in accordance with Board regulations, in closed
2811 containers, to persons in the Commonwealth licensed to sell such wine at wholesale for the purpose of
2812 resale, and to persons outside the Commonwealth for resale outside the Commonwealth.

2813 8. Beer importer's licenses, which shall authorize persons located within or outside the
2814 Commonwealth to sell and deliver or ship beer, in accordance with Board regulations, in closed
2815 containers, to persons in the Commonwealth licensed to sell such beer at wholesale for the purpose of
2816 resale and to persons outside the Commonwealth for resale outside the Commonwealth.

2817 **§ 4.1-206.2. Wholesale licenses.**

2818 The Board may grant the following wholesale licenses:

2819 1. Wholesale beer licenses, which shall authorize the licensee to acquire and receive deliveries and
2820 shipments of beer and to sell and deliver or ship the beer from one or more premises identified in the
2821 license, in accordance with Board regulations, in closed containers to (i) persons licensed under this
2822 chapter to sell such beer at wholesale or retail for the purpose of resale, (ii) owners of boats registered
2823 under the laws of the United States sailing for ports of call of a foreign country or another state, and
2824 (iii) persons outside the Commonwealth for resale outside the Commonwealth.

2825 No wholesale beer licensee shall purchase beer for resale from a person outside the Commonwealth
2826 who does not hold a beer importer's license unless such wholesale beer licensee holds a beer importer's
2827 license and purchases beer for resale pursuant to the privileges of such beer importer's license.

2. Wholesale wine licenses, including those granted pursuant to subdivision 3, which shall authorize the licensee to acquire and receive deliveries and shipments of wine and to sell and deliver or ship the wine from one or more premises identified in the license, in accordance with Board regulations, in closed containers, to (i) persons licensed to sell such wine in the Commonwealth, (ii) persons outside the Commonwealth for resale outside the Commonwealth, (iii) religious congregations for use only for sacramental purposes, and (iv) owners of boats registered under the laws of the United States sailing for ports of call of a foreign country or another state.

No wholesale wine licensee shall purchase wine for resale from a person outside the Commonwealth who does not hold a wine importer's license unless such wholesale wine licensee holds a wine importer's license and purchases wine for resale pursuant to the privileges of such wine importer's license.

3. Restricted wholesale wine licenses, which shall authorize a nonprofit, nonstock corporation created in accordance with subdivision B 2 of § 3.2-102 to provide wholesale wine distribution services to winery and farm winery licensees, provided that no more than 3,000 cases of wine produced by a winery or farm winery licensee shall be distributed by the corporation in any one year. The corporation shall provide such distribution services in accordance with the terms of a written agreement approved by the corporation between it and the winery or farm winery licensee, which shall comply with the provisions of this ~~title~~ *subtitle* and Board regulations. The corporation shall receive all of the privileges of, and be subject to, all laws and regulations governing wholesale wine licenses granted under subdivision 2.

§ 4.1-206.3. (Effective until July 1, 2022) Retail licenses.

A. The Board may grant the following mixed beverages licenses:

1. Mixed beverage restaurant licenses, which shall authorize the licensee to sell and serve mixed beverages for on-premises consumption in dining areas and other designated areas of such restaurant or off-premises consumption. Such license may be granted only to persons (i) who operate a restaurant and (ii) whose gross receipts from the sale of food cooked, or prepared, and consumed on the premises and nonalcoholic beverages served on the premises, after issuance of such license, amount to at least 45 percent of the gross receipts from the sale of mixed beverages and food. For the purposes of this subdivision, other designated areas shall include outdoor dining areas, whether or not contiguous to the licensed premises, which outdoor dining areas may have more than one means of ingress and egress to an adjacent public thoroughfare, provided such areas are under the control of the licensee and approved by the Board. Such noncontiguous designated areas shall not be approved for any retail license issued pursuant to subdivision A 5 of § 4.1-201.

If the restaurant is located on the premises of a hotel or motel with no fewer than four permanent bedrooms where food and beverage service is customarily provided by the restaurant in designated areas, bedrooms, and other private rooms of such hotel or motel, such licensee may (a) sell and serve mixed beverages for on-premises consumption in such designated areas, bedrooms, and other private rooms or off-premises consumption and (b) sell spirits packaged in original closed containers purchased from the Board for on-premises consumption to registered guests and at scheduled functions of such hotel or motel only in such bedrooms or private rooms. However, with regard to a hotel classified as a resort complex, the Board may authorize the sale and on-premises consumption of alcoholic beverages in all areas within the resort complex deemed appropriate by the Board. Nothing herein shall prohibit any person from keeping and consuming his own lawfully acquired spirits in bedrooms or private rooms.

If the restaurant is located on the premises of and operated by a private, nonprofit, or profit club exclusively for its members and their guests, or members of another private, nonprofit, or profit club in another city with which it has an agreement for reciprocal dining privileges, such license shall also authorize the licensees to (1) sell and serve mixed beverages for on-premises or off-premises consumption and (2) sell spirits that are packaged in original closed containers with a maximum capacity of two fluid ounces or 50 milliliters and purchased from the Board for on-premises consumption. Where such club prepares no food in its restaurant but purchases its food requirements from a restaurant licensed by the Board and located on another portion of the premises of the same hotel or motel building, this fact shall not prohibit the granting of a license by the Board to such club qualifying in all other respects. The club's gross receipts from the sale of nonalcoholic beverages consumed on the premises and food resold to its members and guests and consumed on the premises shall amount to at least 45 percent of its gross receipts from the sale of mixed beverages and food. The food sales made by a restaurant to such a club shall be excluded in any consideration of the qualifications of such restaurant for a license from the Board.

If the restaurant is located on the premises of and operated by a municipal golf course, the Board shall recognize the seasonal nature of the business and waive any applicable monthly food sales requirements for those months when weather conditions may reduce patronage of the golf course, provided that prepared food, including meals, is available to patrons during the same months. The gross receipts from the sale of food cooked, or prepared, and consumed on the premises and nonalcoholic

2889 beverages served on the premises, after the issuance of such license, shall amount to at least 45 percent
2890 of the gross receipts from the sale of mixed beverages and food on an annualized basis.

2891 If the restaurant is located on the premises of and operated by a culinary lodging resort, such license
2892 shall authorize the licensee to (A) sell alcoholic beverages, without regard to the amount of gross
2893 receipts from the sale of food prepared and consumed on the premises, for off-premises consumption or
2894 for on-premises consumption in areas upon the licensed premises approved by the Board and other
2895 designated areas of the resort, including outdoor areas under the control of the licensee, and (B) permit
2896 the possession and consumption of lawfully acquired alcoholic beverages by persons to whom overnight
2897 lodging is being provided in bedrooms and private guest rooms.

2898 The granting of a license pursuant to this subdivision shall automatically authorize the licensee to
2899 obtain a license to sell and serve wine and beer for on-premises consumption and in closed containers
2900 for off-premises consumption; however, the licensee shall be required to pay the local fee required for
2901 such additional license pursuant to § 4.1-233.1.

2902 2. Mixed beverage caterer's licenses, which may be granted only to a person regularly engaged in the
2903 business of providing food and beverages to others for service at private gatherings or at special events,
2904 which shall authorize the licensee to sell and serve alcoholic beverages for on-premises consumption.
2905 The annual gross receipts from the sale of food cooked and prepared for service and nonalcoholic
2906 beverages served at gatherings and events referred to in this subdivision shall amount to at least 45
2907 percent of the gross receipts from the sale of mixed beverages and food.

2908 3. Mixed beverage limited caterer's licenses, which may be granted only to a person regularly
2909 engaged in the business of providing food and beverages to others for service at private gatherings or at
2910 special events, not to exceed 12 gatherings or events per year, which shall authorize the licensee to sell
2911 and serve alcoholic beverages for on-premises consumption. The annual gross receipts from the sale of
2912 food cooked and prepared for service and nonalcoholic beverages served at gatherings and events
2913 referred to in this subdivision shall amount to at least 45 percent of the gross receipts from the sale of
2914 mixed beverages and food.

2915 4. Mixed beverage carrier licenses to persons operating a common carrier of passengers by train,
2916 boat, bus, or airplane, which shall authorize the licensee to sell and serve mixed beverages anywhere in
2917 the Commonwealth to passengers while in transit aboard any such common carrier, and in designated
2918 rooms of establishments of air carriers at airports in the Commonwealth. For purposes of supplying its
2919 airplanes, as well as any airplanes of a licensed express carrier flying under the same brand, an air
2920 carrier licensee may appoint an authorized representative to load alcoholic beverages onto the same
2921 airplanes and to transport and store alcoholic beverages at or in close proximity to the airport where the
2922 alcoholic beverages will be delivered onto airplanes of the air carrier and any such licensed express
2923 carrier. The air carrier licensee shall (i) designate for purposes of its license all locations where the
2924 inventory of alcoholic beverages may be stored and from which the alcoholic beverages will be
2925 delivered onto airplanes of the air carrier and any such licensed express carrier and (ii) maintain records
2926 of all alcoholic beverages to be transported, stored, and delivered by its authorized representative. The
2927 granting of a license pursuant to this subdivision shall automatically authorize the licensee to obtain a
2928 license to sell and serve wine and beer for on-premises consumption or in closed containers for
2929 off-premises consumption; however, the licensee shall be required to pay the local fee required for such
2930 additional license pursuant to § 4.1-233.1.

2931 5. Annual mixed beverage motor sports facility licenses, which shall authorize the licensee to sell
2932 mixed beverages, in paper, plastic, or similar disposable containers or in single original metal cans,
2933 during scheduled events, as well as events or performances immediately subsequent thereto, to patrons in
2934 all dining facilities, seating areas, viewing areas, walkways, concession areas, or similar facilities, for
2935 on-premises consumption. Such license may be granted to persons operating food concessions at an
2936 outdoor motor sports facility that (i) is located on 1,200 acres of rural property bordering the Dan River
2937 and has a track surface of 3.27 miles in length or (ii) hosts a NASCAR national touring race. Upon
2938 authorization of the licensee, any person may keep and consume his own lawfully acquired alcoholic
2939 beverages on the premises in all areas and locations covered by the license. The granting of a license
2940 pursuant to this subdivision shall automatically authorize the licensee to obtain a license to sell and
2941 serve wine and beer for on-premises consumption or in closed containers for off-premises consumption;
2942 however, the licensee shall be required to pay the local fee required for such additional license pursuant
2943 to § 4.1-233.1.

2944 6. Limited mixed beverage restaurant licenses, which shall authorize the licensee to sell and serve
2945 dessert wines as defined by Board regulation and no more than six varieties of liqueurs, which liqueurs
2946 shall be combined with coffee or other nonalcoholic beverages, for on-premises consumption in dining
2947 areas of the restaurant or off-premises consumption. Such license may be granted only to persons who
2948 operate a restaurant and in no event shall the sale of such wine or liqueur-based drinks, together with
2949 the sale of any other alcoholic beverages, exceed 10 percent of the total annual gross sales of all food
2950 and alcoholic beverages. The granting of a license pursuant to this subdivision shall automatically

authorize the licensee to obtain a license to sell and serve wine and beer for on-premises consumption or in closed containers for off-premises consumption; however, the licensee shall be required to pay the local fee required for such additional license pursuant to § 4.1-233.1.

7. Annual mixed beverage performing arts facility licenses, which shall (i) authorize the licensee to sell, on the dates of performances or events, alcoholic beverages in paper, plastic, or similar disposable containers or in single original metal cans for on-premises consumption in all seating areas, concourses, walkways, concession areas, similar facilities, and other areas upon the licensed premises approved by the Board and (ii) automatically authorize the licensee to obtain a license to sell and serve wine and beer for on-premises consumption or in closed containers for off-premises consumption; however, the licensee shall be required to pay the local fee required for such additional license pursuant to § 4.1-233.1. Such licenses may be granted to the following:

a. Corporations or associations operating a performing arts facility, provided the performing arts facility (i) is owned by a governmental entity; (ii) is occupied by a for-profit entity under a bona fide lease, the original term of which was for more than one year's duration; and (iii) has been rehabilitated in accordance with historic preservation standards;

b. Persons operating food concessions at any performing arts facility located in the City of Norfolk or the City of Richmond, provided that the performing arts facility (i) is occupied under a bona fide long-term lease or concession agreement, the original term of which was more than five years; (ii) has a capacity in excess of 1,400 patrons; (iii) has been rehabilitated in accordance with historic preservation standards; and (iv) has monthly gross receipts from the sale of food cooked, or prepared, and consumed on the premises and nonalcoholic beverages served on the premises that meet or exceed the monthly minimum established by Board regulations for mixed beverage restaurants;

c. Persons operating food concessions at any performing arts facility located in the City of Waynesboro, provided that the performing arts facility (i) is occupied under a bona fide long-term lease or concession agreement, the original term of which was more than five years; (ii) has a total capacity in excess of 550 patrons; and (iii) has been rehabilitated in accordance with historic preservation standards;

d. Persons operating food concessions at any performing arts facility located in the arts and cultural district of the City of Harrisonburg, provided that the performing arts facility (i) is occupied under a bona fide long-term lease or concession agreement, the original term of which was more than five years; (ii) has been rehabilitated in accordance with historic preservation standards; (iii) has monthly gross receipts from the sale of food cooked, or prepared, and consumed on the premises and nonalcoholic beverages served on the premises that meet or exceed the monthly minimum established by Board regulations for mixed beverage restaurants; and (iv) has a total capacity in excess of 900 patrons;

e. Persons operating food concessions at any multipurpose theater located in the historical district of the Town of Bridgewater, provided that the theater (i) is owned and operated by a governmental entity and (ii) has a total capacity in excess of 100 patrons;

f. Persons operating food concessions at any outdoor performing arts amphitheater, arena, or similar facility that has seating for more than 20,000 persons and is located in Prince William County or the City of Virginia Beach;

g. Persons operating food concessions at any outdoor performing arts amphitheater, arena, or similar facility that has seating for more than 5,000 persons and is located in the City of Alexandria or the City of Portsmouth; or

h. Persons operating food concessions at any corporate and performing arts facility located in Fairfax County, provided that the corporate and performing arts facility (i) is occupied under a bona fide long-term lease, management, or concession agreement, the original term of which was more than one year and (ii) has a total capacity in excess of 1,400 patrons. Such license shall authorize the sale, on the dates of performances or events, of alcoholic beverages for on-premises consumption in areas upon the licensed premises approved by the Board.

8. Combined mixed beverage restaurant and caterer's licenses, which may be granted to any restaurant or hotel that meets the qualifications for both a mixed beverage restaurant pursuant to subdivision 1 and mixed beverage caterer pursuant to subdivision 2 for the same business location, and which license shall authorize the licensee to operate as both a mixed beverage restaurant and mixed beverage caterer at the same business premises designated in the license, with a common alcoholic beverage inventory for purposes of the restaurant and catering operations. Such licensee shall meet the separate food qualifications established for the mixed beverage restaurant license pursuant to subdivision 1 and mixed beverage caterer's license pursuant to subdivision 2. The granting of a license pursuant to this subdivision shall automatically authorize the licensee to obtain a license to sell and serve wine and beer for on-premises consumption or in closed containers for off-premises consumption; however, the licensee shall be required to pay the local fee required for such additional license pursuant to § 4.1-233.1.

3012 9. Bed and breakfast licenses, which shall authorize the licensee to (i) serve alcoholic beverages in
3013 dining areas, private guest rooms, and other designated areas to persons to whom overnight lodging is
3014 being provided, with or without meals, for on-premises consumption only in such rooms and areas, and
3015 without regard to the amount of gross receipts from the sale of food prepared and consumed on the
3016 premises and (ii) permit the consumption of lawfully acquired alcoholic beverages by persons to whom
3017 overnight lodging is being provided in (a) bedrooms or private guest rooms or (b) other designated areas
3018 of the bed and breakfast establishment. For purposes of this subdivision, "other designated areas"
3019 includes outdoor dining areas, whether or not contiguous to the licensed premises, which may have more
3020 than one means of ingress and egress to an adjacent public thoroughfare, provided that such outdoor
3021 dining areas are under the control of the licensee and approved by the Board. Such noncontiguous
3022 designated areas shall not be approved for any retail license issued pursuant to subdivision A 5 of
3023 § 4.1-201.

3024 10. Museum licenses, which may be issued to nonprofit museums exempt from taxation under
3025 § 501(c)(3) of the Internal Revenue Code, which shall authorize the licensee to (i) permit the
3026 consumption of lawfully acquired alcoholic beverages on the premises of the licensee by any bona fide
3027 member and guests thereof and (ii) serve alcoholic beverages on the premises of the licensee to any
3028 bona fide member and guests thereof. However, alcoholic beverages shall not be sold or charged for in
3029 any way by the licensee. The privileges of this license shall be limited to the premises of the museum,
3030 regularly occupied and utilized as such.

3031 11. Motor car sporting event facility licenses, which shall authorize the licensee to permit the
3032 consumption of lawfully acquired alcoholic beverages on the premises of the licensee by patrons thereof
3033 during such events. However, alcoholic beverages shall not be sold or charged for in any way, directly
3034 or indirectly, by the licensee. The privileges of this license shall be limited to those areas of the
3035 licensee's premises designated by the Board that are regularly occupied and utilized for motor car
3036 sporting events.

3037 12. Commercial lifestyle center licenses, which may be issued only to a commercial owners'
3038 association governing a commercial lifestyle center, which shall authorize any retail on-premises
3039 restaurant licensee that is a tenant of the commercial lifestyle center to sell alcoholic beverages to any
3040 bona fide customer to whom alcoholic beverages may be lawfully sold for consumption on that portion
3041 of the licensed premises of the commercial lifestyle center designated by the Board, including (i) plazas,
3042 seating areas, concourses, walkways, or such other similar areas and (ii) the premises of any tenant
3043 location of the commercial lifestyle center that is not a retail licensee of the Board, upon approval of
3044 such tenant, but excluding any parking areas. Only alcoholic beverages purchased from such retail
3045 on-premises restaurant licensees may be consumed on the licensed premises of the commercial lifestyle
3046 center, and such alcoholic beverages shall be contained in paper, plastic, or similar disposable containers
3047 with the name or logo of the restaurant licensee that sold the alcoholic beverage clearly displayed.
3048 Alcoholic beverages shall not be sold or charged for in any way by the commercial lifestyle center
3049 licensee. The licensee shall post appropriate signage clearly demarcating for the public the boundaries of
3050 the licensed premises; however, no physical barriers shall be required for this purpose. The licensee shall
3051 provide adequate security for the licensed premises to ensure compliance with the applicable provisions
3052 of this ~~title~~ subtitle and Board regulations.

3053 13. Mixed beverage port restaurant licenses, which shall authorize the licensee to sell and serve
3054 mixed beverages for consumption in dining areas and other designated areas of such restaurant. Such
3055 license may be granted only to persons operating a business (i) that is primarily engaged in the sale of
3056 meals; (ii) that is located on property owned by the United States government or an agency thereof and
3057 used as a port of entry to or egress from the United States; and (iii) whose gross receipts from the sale
3058 of food cooked, or prepared, and consumed on the premises and nonalcoholic beverages served on the
3059 premises, after issuance of such license, amount to at least 45 percent of the gross receipts from the sale
3060 of mixed beverages and food. For the purposes of this subdivision, other designated areas shall include
3061 outdoor dining areas, whether or not contiguous to the licensed premises, which outdoor dining areas
3062 may have more than one means of ingress and egress to an adjacent public thoroughfare, provided such
3063 areas are under the control of the licensee and approved by the Board. Such noncontiguous designated
3064 areas shall not be approved for any retail license issued pursuant to subdivision A 5 of § 4.1-201. The
3065 granting of a license pursuant to this subdivision shall automatically authorize the licensee to obtain a
3066 license to sell and serve wine and beer for on-premises consumption or in closed containers for
3067 off-premises consumption; however, the licensee shall be required to pay the local fee required for such
3068 additional license pursuant to § 4.1-233.1.

3069 14. Annual mixed beverage special events licenses to (i) a duly organized nonprofit corporation or
3070 association operating either a performing arts facility or an art education and exhibition facility; (ii) a
3071 nonprofit corporation or association chartered by Congress for the preservation of sites, buildings, and
3072 objects significant in American history and culture; (iii) persons operating an agricultural event and
3073 entertainment park or similar facility that has a minimum of 50,000 square feet of indoor exhibit space

and equine and other livestock show areas, which includes barns, pavilions, or other structures equipped with roofs, exterior walls, and open-door or closed-door access; or (iv) a locality for special events conducted on the premises of a museum for historic interpretation that is owned and operated by the locality. The operation in all cases shall be upon premises owned by such licensee or occupied under a bona fide lease, the original term of which was for more than one year's duration. Such license shall authorize the licensee to sell alcoholic beverages during scheduled events and performances for on-premises consumption in areas upon the licensed premises approved by the Board.

B. The Board may grant an on-and-off-premises wine and beer license to the following:

1. Hotels, restaurants, and clubs, which shall authorize the licensee to sell wine and beer (i) in closed containers for off-premises consumption or (ii) for on-premises consumption, either with or without meals, in dining areas and other designated areas of such restaurants, or in dining areas, private guest rooms, and other designated areas of such hotels or clubs, for consumption only in such rooms and areas. However, with regard to a hotel classified by the Board as (a) a resort complex, the Board may authorize the sale and consumption of alcoholic beverages in all areas within the resort complex deemed appropriate by the Board or (b) a limited service hotel, the Board may authorize the sale and consumption of alcoholic beverages in dining areas, private guest rooms, and other designated areas to persons to whom overnight lodging is being provided, for on-premises consumption in such rooms or areas, and without regard to the amount of gross receipts from the sale of food prepared and consumed on the premises, provided that at least one meal is provided each day by the hotel to such guests. With regard to facilities registered in accordance with Chapter 49 (§ 38.2-4900 et seq.) of Title 38.2 as continuing care communities that are also licensed by the Board under this subdivision, any resident may, upon authorization of the licensee, keep and consume his own lawfully acquired alcoholic beverages on the premises in all areas covered by the license. For purposes of this subdivision, "other designated areas" includes outdoor dining areas, whether or not contiguous to the licensed premises, which may have more than one means of ingress and egress to an adjacent public thoroughfare, provided that such outdoor dining areas are under the control of the licensee and approved by the Board. Such noncontiguous designated areas shall not be approved for any retail license issued pursuant to subdivision A 5 of § 4.1-201.

2. Hospitals, which shall authorize the licensee to sell wine and beer (i) in the rooms of patients for their on-premises consumption only in such rooms, provided the consent of the patient's attending physician is first obtained or (ii) in closed containers for off-premises consumption.

3. Rural grocery stores, which shall authorize the licensee to sell wine and beer for on-premises consumption or in closed containers for off-premises consumption. No license shall be granted unless (i) the grocery store is located in any town or in a rural area outside the corporate limits of any city or town and (ii) it appears affirmatively that a substantial public demand for such licensed establishment exists and that public convenience and the purposes of this ~~title~~ *subtitle* will be promoted by granting the license.

4. Coliseums, stadiums, and racetracks, which shall authorize the licensee to sell wine and beer during any event and immediately subsequent thereto to patrons within all seating areas, concourses, walkways, concession areas, and additional locations designated by the Board (i) in closed containers for off-premises consumption or (ii) in paper, plastic, or similar disposable containers or in single original metal cans for on-premises consumption. Upon authorization of the licensee, any person may keep and consume his own lawfully acquired alcoholic beverages on the premises in all areas and locations covered by the license. Such licenses may be granted to persons operating food concessions at coliseums, stadiums, racetracks, or similar facilities.

5. Performing arts food concessionaires, which shall authorize the licensee to sell wine and beer during the performance of any event to patrons within all seating areas, concourses, walkways, or concession areas, or other areas approved by the Board (i) in closed containers for off-premises consumption or (ii) in paper, plastic, or similar disposable containers or in single original metal cans for on-premises consumption. Upon authorization of the licensee, any person may keep and consume his own lawfully acquired alcoholic beverages on the premises in all areas and locations covered by the license. Such licenses may be granted to persons operating food concessions at any outdoor performing arts amphitheater, arena, or similar facility that (a) has seating for more than 20,000 persons and is located in Prince William County or the City of Virginia Beach; (b) has seating or capacity for more than 3,500 persons and is located in the County of Albemarle, Alleghany, Augusta, Nelson, Pittsylvania, or Rockingham or the City of Charlottesville, Danville, or Roanoke; or (c) has capacity for more than 9,500 persons and is located in Henrico County.

6. Exhibition halls, which shall authorize the licensee to sell wine and beer during the event to patrons or attendees within all seating areas, exhibition areas, concourses, walkways, concession areas, and such additional locations designated by the Board in such facilities (i) in closed containers for off-premises consumption or (ii) in paper, plastic, or similar disposable containers or in single original

3135 metal cans for on-premises consumption. Upon authorization of the licensee, any person may keep and
3136 consume his own lawfully acquired alcoholic beverages on the premises in all areas and locations
3137 covered by the license. Such licenses may be granted to persons operating food concessions at exhibition
3138 or exposition halls, convention centers, or similar facilities located in any county operating under the
3139 urban county executive form of government or any city that is completely surrounded by such county.
3140 For purposes of this subdivision, "exhibition or exposition hall" and "convention centers" mean facilities
3141 conducting private or public trade shows or exhibitions in an indoor facility having in excess of 100,000
3142 square feet of floor space.

3143 7. Concert and dinner-theaters, which shall authorize the licensee to sell wine and beer during events
3144 to patrons or attendees within all seating areas, exhibition areas, concourses, walkways, concession areas,
3145 dining areas, and such additional locations designated by the Board in such facilities, for on-premises
3146 consumption or in closed containers for off-premises consumption. Persons licensed pursuant to this
3147 subdivision shall serve food, prepared on or off premises, whenever wine or beer is served. Such
3148 licenses may be granted to persons operating concert or dinner-theater venues on property fronting
3149 Natural Bridge School Road in Natural Bridge Station and formerly operated as Natural Bridge High
3150 School.

3151 8. Historic cinema houses, which shall authorize the licensee to sell wine and beer, either with or
3152 without meals, during any showing of a motion picture to patrons to whom alcoholic beverages may be
3153 lawfully sold, for on-premises consumption or in closed containers for off-premises consumption. The
3154 privileges of this license shall be limited to the premises of the historic cinema house regularly occupied
3155 and utilized as such.

3156 9. Nonprofit museums, which shall authorize the licensee to sell wine and beer for on-premises
3157 consumption or in closed containers for off-premises consumption in areas approved by the Board. Such
3158 licenses may be granted to persons operating a nonprofit museum exempt from taxation under
3159 § 501(c)(3) of the Internal Revenue Code, located in the Town of Front Royal, and dedicated to
3160 educating the consuming public about historic beer products. The privileges of this license shall be
3161 limited to the premises of the museum, regularly occupied and utilized as such.

3162 C. The Board may grant the following off-premises wine and beer licenses:

3163 1. Retail off-premises wine and beer licenses, which may be granted to a convenience grocery store,
3164 delicatessen, drugstore, gift shop, gourmet oyster house, gourmet shop, grocery store, or marina store as
3165 defined in § 4.1-100 and Board regulations. Such license shall authorize the licensee to sell wine and
3166 beer in closed containers for off-premises consumption and, notwithstanding the provisions of § 4.1-308,
3167 to give to any person to whom wine or beer may be lawfully sold a sample of wine or beer for
3168 on-premises consumption; however, no single sample shall exceed four ounces of beer or two ounces of
3169 wine and no more than 12 ounces of beer or five ounces of wine shall be served to any person per day.
3170 The licensee may also give samples of wine and beer in designated areas at events held by the licensee
3171 for the purpose of featuring and educating the consuming public about the alcoholic beverages being
3172 tasted. With the consent of the licensee, farm wineries, wineries, breweries, distillers, and wholesale
3173 licensees or authorized representatives of such licensees may participate in such tastings, including the
3174 pouring of samples. The licensee shall comply with any food inventory and sales volume requirements
3175 established by Board regulation.

3176 2. Gourmet brewing shop licenses, which shall authorize the licensee to sell to any person to whom
3177 wine or beer may be lawfully sold, ingredients for making wine or brewing beer, including packaging,
3178 and to rent to such persons facilities for manufacturing, fermenting, and bottling such wine or beer, for
3179 off-premises consumption in accordance with subdivision 6 of § 4.1-200.

3180 3. Confectionery licenses, which shall authorize the licensee to prepare and sell on the licensed
3181 premises for off-premises consumption confectionery that contains five percent or less alcohol by
3182 volume. Any alcohol contained in such confectionery shall not be in liquid form at the time such
3183 confectionery is sold.

3184 D. The Board may grant the following banquet, special event, and tasting licenses:

3185 1. Per-day event licenses.

3186 a. Banquet licenses to persons in charge of banquets, and to duly organized nonprofit corporations or
3187 associations in charge of special events, which shall authorize the licensee to sell or give wine and beer
3188 in rooms or areas approved by the Board for the occasion for on-premises consumption in such rooms
3189 or areas. Licensees who are nonprofit corporations or associations conducting fundraisers (i) shall also
3190 be authorized to sell wine, as part of any fundraising activity, in closed containers for off-premises
3191 consumption to persons to whom wine may be lawfully sold; (ii) shall be limited to no more than one
3192 such fundraiser per year; and (iii) if conducting such fundraiser through an online meeting platform, may
3193 ship such wine, in accordance with Board regulations, in closed containers to persons located within the
3194 Commonwealth. Except as provided in § 4.1-215, a separate license shall be required for each day of
3195 each banquet or special event. For the purposes of this subdivision, when the location named in the
3196 original application for a license is outdoors, the application may also name an alternative location in the

event of inclement weather. However, no such license shall be required of any hotel, restaurant, or club holding a retail wine and beer license.

b. Mixed beverage special events licenses to a duly organized nonprofit corporation or association in charge of a special event, which shall authorize the licensee to sell and serve mixed beverages for on-premises consumption in areas approved by the Board on the premises of the place designated in the license. A separate license shall be required for each day of each special event.

c. Mixed beverage club events licenses to a club holding a wine and beer club license, which shall authorize the licensee to sell and serve mixed beverages for on-premises consumption by club members and their guests in areas approved by the Board on the club premises. A separate license shall be required for each day of each club event. No more than 12 such licenses shall be granted to a club in any calendar year. The granting of a license pursuant to this subdivision shall automatically authorize the licensee to obtain a license to sell and serve wine and beer for on-premises consumption; however, the licensee shall be required to pay the local fee required for such additional license pursuant to § 4.1-233.1.

d. Tasting licenses, which shall authorize the licensee to sell or give samples of alcoholic beverages of the type specified in the license in designated areas at events held by the licensee. A tasting license shall be issued for the purpose of featuring and educating the consuming public about the alcoholic beverages being tasted. A separate license shall be required for each day of each tasting event. No tasting license shall be required for conduct authorized by § 4.1-201.1.

2. Annual licenses.

a. Annual banquet licenses to duly organized private nonprofit fraternal, patriotic, or charitable membership organizations that are exempt from state and federal taxation and in charge of banquets conducted exclusively for members and their guests, which shall authorize the licensee to serve wine and beer in rooms or areas approved by the Board for the occasion for on-premises consumption in such rooms or areas. Such license shall authorize the licensee to conduct no more than 12 banquets per calendar year. For the purposes of this subdivision, when the location named in the original application for a license is outdoors, the application may also name an alternative location in the event of inclement weather. However, no such license shall be required of any hotel, restaurant, or club holding a retail wine and beer license.

b. Banquet facility licenses to volunteer fire departments and volunteer emergency medical services agencies, which shall authorize the licensee to permit the consumption of lawfully acquired alcoholic beverages on the premises of the licensee by any person, and bona fide members and guests thereof, otherwise eligible for a banquet license. However, lawfully acquired alcoholic beverages shall not be purchased or sold by the licensee or sold or charged for in any way by the person permitted to use the premises. Such premises shall be a volunteer fire or volunteer emergency medical services agency station or both, regularly occupied as such and recognized by the governing body of the county, city, or town in which it is located. Under conditions as specified by Board regulation, such premises may be other than a volunteer fire or volunteer emergency medical services agency station, provided such other premises are occupied and under the control of the volunteer fire department or volunteer emergency medical services agency while the privileges of its license are being exercised.

c. Designated outdoor refreshment area licenses to a locality, business improvement district, or nonprofit organization, which shall authorize (i) the licensee to permit the consumption of alcoholic beverages within the area designated by the Board for the designated outdoor refreshment area and (ii) any permanent retail on-premises licensee that is located within the area designated by the Board for the designated outdoor refreshment area to sell alcoholic beverages within the permanent retail location for consumption in the area designated for the designated outdoor refreshment area, including sidewalks and the premises of businesses not licensed to sell alcoholic beverages at retail, upon approval of such businesses. In determining the designated area for the designated outdoor refreshment area, the Board shall consult with the locality. Designated outdoor refreshment area licensees shall be limited to 16 events per year, and the duration of any event shall not exceed three consecutive days. However, the Board may increase the frequency and duration of events after adoption of an ordinance by a locality requesting such increase in frequency and duration. Such ordinance shall include the size and scope of the area within which such events will be held, a public safety plan, and any other considerations deemed necessary by the Board. Such limitations on the number of events that may be held shall not apply during the effective dates of any rule, regulation, or order that is issued by the Governor or State Health Commissioner to meet a public health emergency and that effectively reduces allowable restaurant seating capacity; however, designated outdoor refreshment area licensees shall be subject to all other applicable provisions of this ~~title~~ subtitle and Board regulations and shall provide notice to the Board regarding the days and times during which the privileges of the license will be exercised. Only alcoholic beverages purchased from permanent retail on-premises licensees located within the designated area may be consumed at the event, and such alcoholic beverages shall be contained in paper, plastic, or

3258 similar disposable containers that clearly display the name or logo of the retail on-premises licensee
3259 from which the alcoholic beverage was purchased. Alcoholic beverages shall not be sold or charged for
3260 in any way by the designated outdoor refreshment area licensee. The designated outdoor refreshment
3261 area licensee shall post appropriate signage clearly demarcating for the public the boundaries of the
3262 event; however, no physical barriers shall be required for this purpose. The designated outdoor
3263 refreshment area licensee shall provide adequate security for the event to ensure compliance with the
3264 applicable provisions of this ~~title~~ *subtitle* and Board regulations.

3265 d. Annual mixed beverage banquet licenses to duly organized private nonprofit fraternal, patriotic, or
3266 charitable membership organizations that are exempt from state and federal taxation and in charge of
3267 banquets conducted exclusively for members and their guests, which shall authorize the licensee to serve
3268 mixed beverages for on-premises consumption in areas approved by the Board on the premises of the
3269 place designated in the license. Such license shall authorize the licensee to conduct no more than 12
3270 banquets per calendar year. The granting of a license pursuant to this subdivision shall automatically
3271 authorize the licensee to obtain a license to sell and serve wine and beer for on-premises consumption;
3272 however, the licensee shall be required to pay the local fee required for such additional license pursuant
3273 to § 4.1-233.1.

3274 e. Equine sporting event licenses, which may be issued to organizations holding equestrian, hunt, and
3275 steeplechase events, which shall authorize the licensee to permit the consumption of lawfully acquired
3276 alcoholic beverages on the premises of the licensee by patrons thereof during such event. However,
3277 alcoholic beverages shall not be sold or charged for in any way by the licensee. The privileges of this
3278 license shall be (i) limited to the premises of the licensee, regularly occupied and utilized for equestrian,
3279 hunt, and steeplechase events, and (ii) exercised on no more than four calendar days per year.

3280 f. Annual arts venue event licenses, to persons operating an arts venue, which shall authorize the
3281 licensee participating in a community art walk that is open to the public to serve lawfully acquired wine
3282 or beer on the premises of the licensee to adult patrons thereof during such events. However, alcoholic
3283 beverages shall not be sold or charged for in any way, directly or indirectly, by the licensee, and the
3284 licensee shall not give more than two five-ounce glasses of wine or two 12-ounce glasses of beer to any
3285 one adult patron. The privileges of this license shall be (i) limited to the premises of the arts venue
3286 regularly occupied and used as such and (ii) exercised on no more than 12 calendar days per year.

3287 E. The Board may grant a marketplace license to persons operating a business enterprise of which
3288 the primary function is not the sale of alcoholic beverages, which shall authorize the licensee to serve
3289 complimentary wine or beer to bona fide customers on the licensed premises subject to any limitations
3290 imposed by the Board; however, the licensee shall not give more than two five-ounce glasses of wine or
3291 two 12-ounce glasses of beer to any customer per day, nor shall it sell or otherwise charge a fee to such
3292 customer for the wine or beer served or consumed. In order to be eligible for and retain a marketplace
3293 license, the applicant's business enterprise must (i) provide a single category of goods or services in a
3294 manner intended to create a personalized experience for the customer; (ii) employ staff with expertise in
3295 such goods or services; (iii) be ineligible for any other license granted by the Board; (iv) have an
3296 alcoholic beverage control manager on the licensed premises at all times alcohol is served; (v) ensure
3297 that all employees satisfy any training requirements imposed by the Board; and (vi) purchase all wine
3298 and beer to be served from a licensed wholesaler or the Authority and retain purchase records as
3299 prescribed by the Board. In determining whether to grant a marketplace license, the Board shall consider
3300 (a) the average amount of time customers spend at the business; (b) the business's hours of operation;
3301 (c) the amount of time that the business has been in operation; and (d) any other requirements deemed
3302 necessary by the Board to protect the public health, safety, and welfare.

3303 F. The Board may grant the following shipper, bottler, and related licenses:

3304 1. Wine and beer shipper licenses, which shall carry the privileges and limitations set forth in
3305 § 4.1-209.1.

3306 2. Internet wine and beer retailer licenses, which shall authorize persons located within or outside the
3307 Commonwealth to sell and ship wine and beer, in accordance with § 4.1-209.1 and Board regulations, in
3308 closed containers to persons in the Commonwealth to whom wine and beer may be lawfully sold for
3309 off-premises consumption. Such licensee shall not be required to comply with the monthly food sale
3310 requirement established by Board regulations.

3311 3. Bottler licenses, which shall authorize the licensee to acquire and receive deliveries and shipments
3312 of beer in closed containers and to bottle, sell, and deliver or ship it, in accordance with Board
3313 regulations to (i) wholesale beer licensees for the purpose of resale, (ii) owners of boats registered under
3314 the laws of the United States sailing for ports of call of a foreign country or another state, and (iii)
3315 persons outside the Commonwealth for resale outside the Commonwealth.

3316 4. Fulfillment warehouse licenses, which shall authorize associations as defined in § 13.1-313 with a
3317 place of business located in the Commonwealth to (i) receive deliveries and shipments of wine or beer
3318 owned by holders of wine and beer shipper's licenses; (ii) store such wine or beer on behalf of the
3319 owner; and (iii) pick, pack, and ship such wine or beer as directed by the owner, all in accordance with

Board regulations. No wholesale wine or wholesale beer licensee, whether licensed in the Commonwealth or not, or any person under common control of such licensee, shall acquire or hold any financial interest, direct or indirect, in the business for which any fulfillment warehouse license is issued.

5. Marketing portal licenses, which shall authorize agricultural cooperative associations organized under the provisions of the Agricultural Cooperative Association Act (§ 13.1-312 et seq.), with a place of business located in the Commonwealth, in accordance with Board regulations, to solicit and receive orders for wine or beer through the use of the Internet from persons in the Commonwealth to whom wine or beer may be lawfully sold, on behalf of holders of wine and beer shipper's licenses. Upon receipt of an order for wine or beer, the licensee shall forward it to a holder of a wine and beer shipper's license for fulfillment. Marketing portal licensees may also accept payment on behalf of the shipper.

§ 4.1-206.3. (Effective July 1, 2022) Retail licenses.

A. The Board may grant the following mixed beverages licenses:

1. Mixed beverage restaurant licenses, which shall authorize the licensee to sell and serve mixed beverages for consumption in dining areas and other designated areas of such restaurant. Such license may be granted only to persons (i) who operate a restaurant and (ii) whose gross receipts from the sale of food cooked, or prepared, and consumed on the premises and nonalcoholic beverages served on the premises, after issuance of such license, amount to at least 45 percent of the gross receipts from the sale of mixed beverages and food. For the purposes of this subdivision, other designated areas shall include outdoor dining areas, whether or not contiguous to the licensed premises, which outdoor dining areas may have more than one means of ingress and egress to an adjacent public thoroughfare, provided such areas are under the control of the licensee and approved by the Board. Such noncontiguous designated areas shall not be approved for any retail license issued pursuant to subdivision A 5 of § 4.1-201.

If the restaurant is located on the premises of a hotel or motel with no fewer than four permanent bedrooms where food and beverage service is customarily provided by the restaurant in designated areas, bedrooms, and other private rooms of such hotel or motel, such licensee may (a) sell and serve mixed beverages for consumption in such designated areas, bedrooms, and other private rooms and (b) sell spirits packaged in original closed containers purchased from the Board for on-premises consumption to registered guests and at scheduled functions of such hotel or motel only in such bedrooms or private rooms. However, with regard to a hotel classified as a resort complex, the Board may authorize the sale and on-premises consumption of alcoholic beverages in all areas within the resort complex deemed appropriate by the Board. Nothing herein shall prohibit any person from keeping and consuming his own lawfully acquired spirits in bedrooms or private rooms.

If the restaurant is located on the premises of and operated by a private, nonprofit, or profit club exclusively for its members and their guests, or members of another private, nonprofit, or profit club in another city with which it has an agreement for reciprocal dining privileges, such license shall also authorize the licensees to (1) sell and serve mixed beverages for on-premises consumption and (2) sell spirits that are packaged in original closed containers with a maximum capacity of two fluid ounces or 50 milliliters and purchased from the Board for on-premises consumption. Where such club prepares no food in its restaurant but purchases its food requirements from a restaurant licensed by the Board and located on another portion of the premises of the same hotel or motel building, this fact shall not prohibit the granting of a license by the Board to such club qualifying in all other respects. The club's gross receipts from the sale of nonalcoholic beverages consumed on the premises and food resold to its members and guests and consumed on the premises shall amount to at least 45 percent of its gross receipts from the sale of mixed beverages and food. The food sales made by a restaurant to such a club shall be excluded in any consideration of the qualifications of such restaurant for a license from the Board.

If the restaurant is located on the premises of and operated by a municipal golf course, the Board shall recognize the seasonal nature of the business and waive any applicable monthly food sales requirements for those months when weather conditions may reduce patronage of the golf course, provided that prepared food, including meals, is available to patrons during the same months. The gross receipts from the sale of food cooked, or prepared, and consumed on the premises and nonalcoholic beverages served on the premises, after the issuance of such license, shall amount to at least 45 percent of the gross receipts from the sale of mixed beverages and food on an annualized basis.

If the restaurant is located on the premises of and operated by a culinary lodging resort, such license shall authorize the licensee to (A) sell alcoholic beverages for on-premises consumption, without regard to the amount of gross receipts from the sale of food prepared and consumed on the premises, in areas upon the licensed premises approved by the Board and other designated areas of the resort, including outdoor areas under the control of the licensee, and (B) permit the possession and consumption of lawfully acquired alcoholic beverages by persons to whom overnight lodging is being provided in

3381 bedrooms and private guest rooms.

3382 The granting of a license pursuant to this subdivision shall automatically authorize the licensee to
3383 obtain a license to sell and serve wine and beer for on-premises consumption and in closed containers
3384 for off-premises consumption; however, the licensee shall be required to pay the local fee required for
3385 such additional license pursuant to § 4.1-233.1.

3386 2. Mixed beverage caterer's licenses, which may be granted only to a person regularly engaged in the
3387 business of providing food and beverages to others for service at private gatherings or at special events,
3388 which shall authorize the licensee to sell and serve alcoholic beverages for on-premises consumption.
3389 The annual gross receipts from the sale of food cooked and prepared for service and nonalcoholic
3390 beverages served at gatherings and events referred to in this subdivision shall amount to at least 45
3391 percent of the gross receipts from the sale of mixed beverages and food.

3392 3. Mixed beverage limited caterer's licenses, which may be granted only to a person regularly
3393 engaged in the business of providing food and beverages to others for service at private gatherings or at
3394 special events, not to exceed 12 gatherings or events per year, which shall authorize the licensee to sell
3395 and serve alcoholic beverages for on-premises consumption. The annual gross receipts from the sale of
3396 food cooked and prepared for service and nonalcoholic beverages served at gatherings and events
3397 referred to in this subdivision shall amount to at least 45 percent of the gross receipts from the sale of
3398 mixed beverages and food.

3399 4. Mixed beverage carrier licenses to persons operating a common carrier of passengers by train,
3400 boat, bus, or airplane, which shall authorize the licensee to sell and serve mixed beverages anywhere in
3401 the Commonwealth to passengers while in transit aboard any such common carrier, and in designated
3402 rooms of establishments of air carriers at airports in the Commonwealth. For purposes of supplying its
3403 airplanes, as well as any airplanes of a licensed express carrier flying under the same brand, an air
3404 carrier licensee may appoint an authorized representative to load alcoholic beverages onto the same
3405 airplanes and to transport and store alcoholic beverages at or in close proximity to the airport where the
3406 alcoholic beverages will be delivered onto airplanes of the air carrier and any such licensed express
3407 carrier. The air carrier licensee shall (i) designate for purposes of its license all locations where the
3408 inventory of alcoholic beverages may be stored and from which the alcoholic beverages will be
3409 delivered onto airplanes of the air carrier and any such licensed express carrier and (ii) maintain records
3410 of all alcoholic beverages to be transported, stored, and delivered by its authorized representative. The
3411 granting of a license pursuant to this subdivision shall automatically authorize the licensee to obtain a
3412 license to sell and serve wine and beer for on-premises consumption or in closed containers for
3413 off-premises consumption; however, the licensee shall be required to pay the local fee required for such
3414 additional license pursuant to § 4.1-233.1.

3415 5. Annual mixed beverage motor sports facility licenses, which shall authorize the licensee to sell
3416 mixed beverages, in paper, plastic, or similar disposable containers or in single original metal cans,
3417 during scheduled events, as well as events or performances immediately subsequent thereto, to patrons in
3418 all dining facilities, seating areas, viewing areas, walkways, concession areas, or similar facilities, for
3419 on-premises consumption. Such license may be granted to persons operating food concessions at an
3420 outdoor motor sports facility that (i) is located on 1,200 acres of rural property bordering the Dan River
3421 and has a track surface of 3.27 miles in length or (ii) hosts a NASCAR national touring race. Upon
3422 authorization of the licensee, any person may keep and consume his own lawfully acquired alcoholic
3423 beverages on the premises in all areas and locations covered by the license. The granting of a license
3424 pursuant to this subdivision shall automatically authorize the licensee to obtain a license to sell and
3425 serve wine and beer for on-premises consumption or in closed containers for off-premises consumption;
3426 however, the licensee shall be required to pay the local fee required for such additional license pursuant
3427 to § 4.1-233.1.

3428 6. Limited mixed beverage restaurant licenses, which shall authorize the licensee to sell and serve
3429 dessert wines as defined by Board regulation and no more than six varieties of liqueurs, which liqueurs
3430 shall be combined with coffee or other nonalcoholic beverages, for consumption in dining areas of the
3431 restaurant. Such license may be granted only to persons who operate a restaurant and in no event shall
3432 the sale of such wine or liqueur-based drinks, together with the sale of any other alcoholic beverages,
3433 exceed 10 percent of the total annual gross sales of all food and alcoholic beverages. The granting of a
3434 license pursuant to this subdivision shall automatically authorize the licensee to obtain a license to sell
3435 and serve wine and beer for on-premises consumption or in closed containers for off-premises
3436 consumption; however, the licensee shall be required to pay the local fee required for such additional
3437 license pursuant to § 4.1-233.1.

3438 7. Annual mixed beverage performing arts facility licenses, which shall (i) authorize the licensee to
3439 sell, on the dates of performances or events, alcoholic beverages in paper, plastic, or similar disposable
3440 containers or in single original metal cans for on-premises consumption in all seating areas, concourses,
3441 walkways, concession areas, similar facilities, and other areas upon the licensed premises approved by
3442 the Board and (ii) automatically authorize the licensee to obtain a license to sell and serve wine and

beer for on-premises consumption or in closed containers for off-premises consumption; however, the licensee shall be required to pay the local fee required for such additional license pursuant to § 4.1-233.1. Such licenses may be granted to the following:

a. Corporations or associations operating a performing arts facility, provided the performing arts facility (i) is owned by a governmental entity; (ii) is occupied by a for-profit entity under a bona fide lease, the original term of which was for more than one year's duration; and (iii) has been rehabilitated in accordance with historic preservation standards;

b. Persons operating food concessions at any performing arts facility located in the City of Norfolk or the City of Richmond, provided that the performing arts facility (i) is occupied under a bona fide long-term lease or concession agreement, the original term of which was more than five years; (ii) has a capacity in excess of 1,400 patrons; (iii) has been rehabilitated in accordance with historic preservation standards; and (iv) has monthly gross receipts from the sale of food cooked, or prepared, and consumed on the premises and nonalcoholic beverages served on the premises that meet or exceed the monthly minimum established by Board regulations for mixed beverage restaurants;

c. Persons operating food concessions at any performing arts facility located in the City of Waynesboro, provided that the performing arts facility (i) is occupied under a bona fide long-term lease or concession agreement, the original term of which was more than five years; (ii) has a total capacity in excess of 550 patrons; and (iii) has been rehabilitated in accordance with historic preservation standards;

d. Persons operating food concessions at any performing arts facility located in the arts and cultural district of the City of Harrisonburg, provided that the performing arts facility (i) is occupied under a bona fide long-term lease or concession agreement, the original term of which was more than five years; (ii) has been rehabilitated in accordance with historic preservation standards; (iii) has monthly gross receipts from the sale of food cooked, or prepared, and consumed on the premises and nonalcoholic beverages served on the premises that meet or exceed the monthly minimum established by Board regulations for mixed beverage restaurants; and (iv) has a total capacity in excess of 900 patrons;

e. Persons operating food concessions at any multipurpose theater located in the historical district of the Town of Bridgewater, provided that the theater (i) is owned and operated by a governmental entity and (ii) has a total capacity in excess of 100 patrons;

f. Persons operating food concessions at any outdoor performing arts amphitheater, arena, or similar facility that has seating for more than 20,000 persons and is located in Prince William County or the City of Virginia Beach;

g. Persons operating food concessions at any outdoor performing arts amphitheater, arena, or similar facility that has seating for more than 5,000 persons and is located in the City of Alexandria or the City of Portsmouth; or

h. Persons operating food concessions at any corporate and performing arts facility located in Fairfax County, provided that the corporate and performing arts facility (i) is occupied under a bona fide long-term lease, management, or concession agreement, the original term of which was more than one year and (ii) has a total capacity in excess of 1,400 patrons. Such license shall authorize the sale, on the dates of performances or events, of alcoholic beverages for on-premises consumption in areas upon the licensed premises approved by the Board.

8. Combined mixed beverage restaurant and caterer's licenses, which may be granted to any restaurant or hotel that meets the qualifications for both a mixed beverage restaurant pursuant to subdivision 1 and mixed beverage caterer pursuant to subdivision 2 for the same business location, and which license shall authorize the licensee to operate as both a mixed beverage restaurant and mixed beverage caterer at the same business premises designated in the license, with a common alcoholic beverage inventory for purposes of the restaurant and catering operations. Such licensee shall meet the separate food qualifications established for the mixed beverage restaurant license pursuant to subdivision 1 and mixed beverage caterer's license pursuant to subdivision 2. The granting of a license pursuant to this subdivision shall automatically authorize the licensee to obtain a license to sell and serve wine and beer for on-premises consumption or in closed containers for off-premises consumption; however, the licensee shall be required to pay the local fee required for such additional license pursuant to § 4.1-233.1.

9. Bed and breakfast licenses, which shall authorize the licensee to (i) serve alcoholic beverages in dining areas, private guest rooms, and other designated areas to persons to whom overnight lodging is being provided, with or without meals, for on-premises consumption only in such rooms and areas, and without regard to the amount of gross receipts from the sale of food prepared and consumed on the premises and (ii) permit the consumption of lawfully acquired alcoholic beverages by persons to whom overnight lodging is being provided in (a) bedrooms or private guest rooms or (b) other designated areas of the bed and breakfast establishment. For purposes of this subdivision, "other designated areas" includes outdoor dining areas, whether or not contiguous to the licensed premises, which may have more

3504 than one means of ingress and egress to an adjacent public thoroughfare, provided that such outdoor
3505 dining areas are under the control of the licensee and approved by the Board. Such noncontiguous
3506 designated areas shall not be approved for any retail license issued pursuant to subdivision A 5 of
3507 § 4.1-201.

3508 10. Museum licenses, which may be issued to nonprofit museums exempt from taxation under
3509 § 501(c)(3) of the Internal Revenue Code, which shall authorize the licensee to (i) permit the
3510 consumption of lawfully acquired alcoholic beverages on the premises of the licensee by any bona fide
3511 member and guests thereof and (ii) serve alcoholic beverages on the premises of the licensee to any
3512 bona fide member and guests thereof. However, alcoholic beverages shall not be sold or charged for in
3513 any way by the licensee. The privileges of this license shall be limited to the premises of the museum,
3514 regularly occupied and utilized as such.

3515 11. Motor car sporting event facility licenses, which shall authorize the licensee to permit the
3516 consumption of lawfully acquired alcoholic beverages on the premises of the licensee by patrons thereof
3517 during such events. However, alcoholic beverages shall not be sold or charged for in any way, directly
3518 or indirectly, by the licensee. The privileges of this license shall be limited to those areas of the
3519 licensee's premises designated by the Board that are regularly occupied and utilized for motor car
3520 sporting events.

3521 12. Commercial lifestyle center licenses, which may be issued only to a commercial owners'
3522 association governing a commercial lifestyle center, which shall authorize any retail on-premises
3523 restaurant licensee that is a tenant of the commercial lifestyle center to sell alcoholic beverages to any
3524 bona fide customer to whom alcoholic beverages may be lawfully sold for consumption on that portion
3525 of the licensed premises of the commercial lifestyle center designated by the Board, including (i) plazas,
3526 seating areas, concourses, walkways, or such other similar areas and (ii) the premises of any tenant
3527 location of the commercial lifestyle center that is not a retail licensee of the Board, upon approval of
3528 such tenant, but excluding any parking areas. Only alcoholic beverages purchased from such retail
3529 on-premises restaurant licensees may be consumed on the licensed premises of the commercial lifestyle
3530 center, and such alcoholic beverages shall be contained in paper, plastic, or similar disposable containers
3531 with the name or logo of the restaurant licensee that sold the alcoholic beverage clearly displayed.
3532 Alcoholic beverages shall not be sold or charged for in any way by the commercial lifestyle center
3533 licensee. The licensee shall post appropriate signage clearly demarcating for the public the boundaries of
3534 the licensed premises; however, no physical barriers shall be required for this purpose. The licensee shall
3535 provide adequate security for the licensed premises to ensure compliance with the applicable provisions
3536 of this ~~title~~ *subtitle* and Board regulations.

3537 13. Mixed beverage port restaurant licenses, which shall authorize the licensee to sell and serve
3538 mixed beverages for consumption in dining areas and other designated areas of such restaurant. Such
3539 license may be granted only to persons operating a business (i) that is primarily engaged in the sale of
3540 meals; (ii) that is located on property owned by the United States government or an agency thereof and
3541 used as a port of entry to or egress from the United States; and (iii) whose gross receipts from the sale
3542 of food cooked, or prepared, and consumed on the premises and nonalcoholic beverages served on the
3543 premises, after issuance of such license, amount to at least 45 percent of the gross receipts from the sale
3544 of mixed beverages and food. For the purposes of this subdivision, other designated areas shall include
3545 outdoor dining areas, whether or not contiguous to the licensed premises, which outdoor dining areas
3546 may have more than one means of ingress and egress to an adjacent public thoroughfare, provided such
3547 areas are under the control of the licensee and approved by the Board. Such noncontiguous designated
3548 areas shall not be approved for any retail license issued pursuant to subdivision A 5 of § 4.1-201. The
3549 granting of a license pursuant to this subdivision shall automatically authorize the licensee to obtain a
3550 license to sell and serve wine and beer for on-premises consumption or in closed containers for
3551 off-premises consumption; however, the licensee shall be required to pay the local fee required for such
3552 additional license pursuant to § 4.1-233.1.

3553 14. Annual mixed beverage special events licenses to (i) a duly organized nonprofit corporation or
3554 association operating either a performing arts facility or an art education and exhibition facility; (ii) a
3555 nonprofit corporation or association chartered by Congress for the preservation of sites, buildings, and
3556 objects significant in American history and culture; (iii) persons operating an agricultural event and
3557 entertainment park or similar facility that has a minimum of 50,000 square feet of indoor exhibit space
3558 and equine and other livestock show areas, which includes barns, pavilions, or other structures equipped
3559 with roofs, exterior walls, and open-door or closed-door access; or (iv) a locality for special events
3560 conducted on the premises of a museum for historic interpretation that is owned and operated by the
3561 locality. The operation in all cases shall be upon premises owned by such licensee or occupied under a
3562 bona fide lease, the original term of which was for more than one year's duration. Such license shall
3563 authorize the licensee to sell alcoholic beverages during scheduled events and performances for
3564 on-premises consumption in areas upon the licensed premises approved by the Board.

3565 B. The Board may grant an on-and-off-premises wine and beer license to the following:

1. Hotels, restaurants, and clubs, which shall authorize the licensee to sell wine and beer (i) in closed containers for off-premises consumption or (ii) for on-premises consumption, either with or without meals, in dining areas and other designated areas of such restaurants, or in dining areas, private guest rooms, and other designated areas of such hotels or clubs, for consumption only in such rooms and areas. However, with regard to a hotel classified by the Board as (a) a resort complex, the Board may authorize the sale and consumption of alcoholic beverages in all areas within the resort complex deemed appropriate by the Board or (b) a limited service hotel, the Board may authorize the sale and consumption of alcoholic beverages in dining areas, private guest rooms, and other designated areas to persons to whom overnight lodging is being provided, for on-premises consumption in such rooms or areas, and without regard to the amount of gross receipts from the sale of food prepared and consumed on the premises, provided that at least one meal is provided each day by the hotel to such guests. With regard to facilities registered in accordance with Chapter 49 (§ 38.2-4900 et seq.) of Title 38.2 as continuing care communities that are also licensed by the Board under this subdivision, any resident may, upon authorization of the licensee, keep and consume his own lawfully acquired alcoholic beverages on the premises in all areas covered by the license. For purposes of this subdivision, "other designated areas" includes outdoor dining areas, whether or not contiguous to the licensed premises, which may have more than one means of ingress and egress to an adjacent public thoroughfare, provided that such outdoor dining areas are under the control of the licensee and approved by the Board. Such noncontiguous designated areas shall not be approved for any retail license issued pursuant to subdivision A 5 of § 4.1-201.

2. Hospitals, which shall authorize the licensee to sell wine and beer (i) in the rooms of patients for their on-premises consumption only in such rooms, provided the consent of the patient's attending physician is first obtained or (ii) in closed containers for off-premises consumption.

3. Rural grocery stores, which shall authorize the licensee to sell wine and beer for on-premises consumption or in closed containers for off-premises consumption. No license shall be granted unless (i) the grocery store is located in any town or in a rural area outside the corporate limits of any city or town and (ii) it appears affirmatively that a substantial public demand for such licensed establishment exists and that public convenience and the purposes of this ~~title~~ *substitute* will be promoted by granting the license.

4. Coliseums, stadiums, and racetracks, which shall authorize the licensee to sell wine and beer during any event and immediately subsequent thereto to patrons within all seating areas, concourses, walkways, concession areas, and additional locations designated by the Board (i) in closed containers for off-premises consumption or (ii) in paper, plastic, or similar disposable containers or in single original metal cans for on-premises consumption. Upon authorization of the licensee, any person may keep and consume his own lawfully acquired alcoholic beverages on the premises in all areas and locations covered by the license. Such licenses may be granted to persons operating food concessions at coliseums, stadiums, racetracks, or similar facilities.

5. Performing arts food concessionaires, which shall authorize the licensee to sell wine and beer during the performance of any event to patrons within all seating areas, concourses, walkways, or concession areas, or other areas approved by the Board (i) in closed containers for off-premises consumption or (ii) in paper, plastic, or similar disposable containers or in single original metal cans for on-premises consumption. Upon authorization of the licensee, any person may keep and consume his own lawfully acquired alcoholic beverages on the premises in all areas and locations covered by the license. Such licenses may be granted to persons operating food concessions at any outdoor performing arts amphitheater, arena, or similar facility that (a) has seating for more than 20,000 persons and is located in Prince William County or the City of Virginia Beach; (b) has seating or capacity for more than 3,500 persons and is located in the County of Albemarle, Alleghany, Augusta, Nelson, Pittsylvania, or Rockingham or the City of Charlottesville, Danville, or Roanoke; or (c) has capacity for more than 9,500 persons and is located in Henrico County.

6. Exhibition halls, which shall authorize the licensee to sell wine and beer during the event to patrons or attendees within all seating areas, exhibition areas, concourses, walkways, concession areas, and such additional locations designated by the Board in such facilities (i) in closed containers for off-premises consumption or (ii) in paper, plastic, or similar disposable containers or in single original metal cans for on-premises consumption. Upon authorization of the licensee, any person may keep and consume his own lawfully acquired alcoholic beverages on the premises in all areas and locations covered by the license. Such licenses may be granted to persons operating food concessions at exhibition or exposition halls, convention centers, or similar facilities located in any county operating under the urban county executive form of government or any city that is completely surrounded by such county. For purposes of this subdivision, "exhibition or exposition hall" and "convention centers" mean facilities conducting private or public trade shows or exhibitions in an indoor facility having in excess of 100,000 square feet of floor space.

3627 7. Concert and dinner-theaters, which shall authorize the licensee to sell wine and beer during events
3628 to patrons or attendees within all seating areas, exhibition areas, concourses, walkways, concession areas,
3629 dining areas, and such additional locations designated by the Board in such facilities, for on-premises
3630 consumption or in closed containers for off-premises consumption. Persons licensed pursuant to this
3631 subdivision shall serve food, prepared on or off premises, whenever wine or beer is served. Such
3632 licenses may be granted to persons operating concert or dinner-theater venues on property fronting
3633 Natural Bridge School Road in Natural Bridge Station and formerly operated as Natural Bridge High
3634 School.

3635 8. Historic cinema houses, which shall authorize the licensee to sell wine and beer, either with or
3636 without meals, during any showing of a motion picture to patrons to whom alcoholic beverages may be
3637 lawfully sold, for on-premises consumption or in closed containers for off-premises consumption. The
3638 privileges of this license shall be limited to the premises of the historic cinema house regularly occupied
3639 and utilized as such.

3640 9. Nonprofit museums, which shall authorize the licensee to sell wine and beer for on-premises
3641 consumption or in closed containers for off-premises consumption in areas approved by the Board. Such
3642 licenses may be granted to persons operating a nonprofit museum exempt from taxation under
3643 § 501(c)(3) of the Internal Revenue Code, located in the Town of Front Royal, and dedicated to
3644 educating the consuming public about historic beer products. The privileges of this license shall be
3645 limited to the premises of the museum, regularly occupied and utilized as such.

3646 C. The Board may grant the following off-premises wine and beer licenses:

3647 1. Retail off-premises wine and beer licenses, which may be granted to a convenience grocery store,
3648 delicatessen, drugstore, gift shop, gourmet oyster house, gourmet shop, grocery store, or marina store as
3649 defined in § 4.1-100 and Board regulations. Such license shall authorize the licensee to sell wine and
3650 beer in closed containers for off-premises consumption and, notwithstanding the provisions of § 4.1-308,
3651 to give to any person to whom wine or beer may be lawfully sold a sample of wine or beer for
3652 on-premises consumption; however, no single sample shall exceed four ounces of beer or two ounces of
3653 wine and no more than 12 ounces of beer or five ounces of wine shall be served to any person per day.
3654 The licensee may also give samples of wine and beer in designated areas at events held by the licensee
3655 for the purpose of featuring and educating the consuming public about the alcoholic beverages being
3656 tasted. With the consent of the licensee, farm wineries, wineries, breweries, distillers, and wholesale
3657 licensees or authorized representatives of such licensees may participate in such tastings, including the
3658 pouring of samples. The licensee shall comply with any food inventory and sales volume requirements
3659 established by Board regulation.

3660 2. Gourmet brewing shop licenses, which shall authorize the licensee to sell to any person to whom
3661 wine or beer may be lawfully sold, ingredients for making wine or brewing beer, including packaging,
3662 and to rent to such persons facilities for manufacturing, fermenting, and bottling such wine or beer, for
3663 off-premises consumption in accordance with subdivision 6 of § 4.1-200.

3664 3. Confectionery licenses, which shall authorize the licensee to prepare and sell on the licensed
3665 premises for off-premises consumption confectionery that contains five percent or less alcohol by
3666 volume. Any alcohol contained in such confectionery shall not be in liquid form at the time such
3667 confectionery is sold.

3668 D. The Board may grant the following banquet, special event, and tasting licenses:

3669 1. Per-day event licenses.

3670 a. Banquet licenses to persons in charge of banquets, and to duly organized nonprofit corporations or
3671 associations in charge of special events, which shall authorize the licensee to sell or give wine and beer
3672 in rooms or areas approved by the Board for the occasion for on-premises consumption in such rooms
3673 or areas. Licensees who are nonprofit corporations or associations conducting fundraisers (i) shall also
3674 be authorized to sell wine, as part of any fundraising activity, in closed containers for off-premises
3675 consumption to persons to whom wine may be lawfully sold; (ii) shall be limited to no more than one
3676 such fundraiser per year; and (iii) if conducting such fundraiser through an online meeting platform, may
3677 ship such wine, in accordance with Board regulations, in closed containers to persons located within the
3678 Commonwealth. Except as provided in § 4.1-215, a separate license shall be required for each day of
3679 each banquet or special event. For the purposes of this subdivision, when the location named in the
3680 original application for a license is outdoors, the application may also name an alternative location in the
3681 event of inclement weather. However, no such license shall be required of any hotel, restaurant, or club
3682 holding a retail wine and beer license.

3683 b. Mixed beverage special events licenses to a duly organized nonprofit corporation or association in
3684 charge of a special event, which shall authorize the licensee to sell and serve mixed beverages for
3685 on-premises consumption in areas approved by the Board on the premises of the place designated in the
3686 license. A separate license shall be required for each day of each special event.

3687 c. Mixed beverage club events licenses to a club holding a wine and beer club license, which shall
3688 authorize the licensee to sell and serve mixed beverages for on-premises consumption by club members

and their guests in areas approved by the Board on the club premises. A separate license shall be required for each day of each club event. No more than 12 such licenses shall be granted to a club in any calendar year. The granting of a license pursuant to this subdivision shall automatically authorize the licensee to obtain a license to sell and serve wine and beer for on-premises consumption; however, the licensee shall be required to pay the local fee required for such additional license pursuant to § 4.1-233.1.

d. Tasting licenses, which shall authorize the licensee to sell or give samples of alcoholic beverages of the type specified in the license in designated areas at events held by the licensee. A tasting license shall be issued for the purpose of featuring and educating the consuming public about the alcoholic beverages being tasted. A separate license shall be required for each day of each tasting event. No tasting license shall be required for conduct authorized by § 4.1-201.1.

2. Annual licenses.

a. Annual banquet licenses to duly organized private nonprofit fraternal, patriotic, or charitable membership organizations that are exempt from state and federal taxation and in charge of banquets conducted exclusively for members and their guests, which shall authorize the licensee to serve wine and beer in rooms or areas approved by the Board for the occasion for on-premises consumption in such rooms or areas. Such license shall authorize the licensee to conduct no more than 12 banquets per calendar year. For the purposes of this subdivision, when the location named in the original application for a license is outdoors, the application may also name an alternative location in the event of inclement weather. However, no such license shall be required of any hotel, restaurant, or club holding a retail wine and beer license.

b. Banquet facility licenses to volunteer fire departments and volunteer emergency medical services agencies, which shall authorize the licensee to permit the consumption of lawfully acquired alcoholic beverages on the premises of the licensee by any person, and bona fide members and guests thereof, otherwise eligible for a banquet license. However, lawfully acquired alcoholic beverages shall not be purchased or sold by the licensee or sold or charged for in any way by the person permitted to use the premises. Such premises shall be a volunteer fire or volunteer emergency medical services agency station or both, regularly occupied as such and recognized by the governing body of the county, city, or town in which it is located. Under conditions as specified by Board regulation, such premises may be other than a volunteer fire or volunteer emergency medical services agency station, provided such other premises are occupied and under the control of the volunteer fire department or volunteer emergency medical services agency while the privileges of its license are being exercised.

c. Designated outdoor refreshment area licenses to a locality, business improvement district, or nonprofit organization, which shall authorize (i) the licensee to permit the consumption of alcoholic beverages within the area designated by the Board for the designated outdoor refreshment area and (ii) any permanent retail on-premises licensee that is located within the area designated by the Board for the designated outdoor refreshment area to sell alcoholic beverages within the permanent retail location for consumption in the area designated for the designated outdoor refreshment area, including sidewalks and the premises of businesses not licensed to sell alcoholic beverages at retail, upon approval of such businesses. In determining the designated area for the designated outdoor refreshment area, the Board shall consult with the locality. Designated outdoor refreshment area licensees shall be limited to 16 events per year, and the duration of any event shall not exceed three consecutive days. However, the Board may increase the frequency and duration of events after adoption of an ordinance by a locality requesting such increase in frequency and duration. Such ordinance shall include the size and scope of the area within which such events will be held, a public safety plan, and any other considerations deemed necessary by the Board. Such limitations on the number of events that may be held shall not apply during the effective dates of any rule, regulation, or order that is issued by the Governor or State Health Commissioner to meet a public health emergency and that effectively reduces allowable restaurant seating capacity; however, designated outdoor refreshment area licensees shall be subject to all other applicable provisions of this ~~title~~ *subtle* and Board regulations and shall provide notice to the Board regarding the days and times during which the privileges of the license will be exercised. Only alcoholic beverages purchased from permanent retail on-premises licensees located within the designated area may be consumed at the event, and such alcoholic beverages shall be contained in paper, plastic, or similar disposable containers that clearly display the name or logo of the retail on-premises licensee from which the alcoholic beverage was purchased. Alcoholic beverages shall not be sold or charged for in any way by the designated outdoor refreshment area licensee. The designated outdoor refreshment area licensee shall post appropriate signage clearly demarcating for the public the boundaries of the event; however, no physical barriers shall be required for this purpose. The designated outdoor refreshment area licensee shall provide adequate security for the event to ensure compliance with the applicable provisions of this ~~title~~ *subtle* and Board regulations.

d. Annual mixed beverage banquet licenses to duly organized private nonprofit fraternal, patriotic, or

3750 charitable membership organizations that are exempt from state and federal taxation and in charge of
3751 banquets conducted exclusively for members and their guests, which shall authorize the licensee to serve
3752 mixed beverages for on-premises consumption in areas approved by the Board on the premises of the
3753 place designated in the license. Such license shall authorize the licensee to conduct no more than 12
3754 banquets per calendar year. The granting of a license pursuant to this subdivision shall automatically
3755 authorize the licensee to obtain a license to sell and serve wine and beer for on-premises consumption;
3756 however, the licensee shall be required to pay the local fee required for such additional license pursuant
3757 to § 4.1-233.1.

3758 e. Equine sporting event licenses, which may be issued to organizations holding equestrian, hunt, and
3759 steeplechase events, which shall authorize the licensee to permit the consumption of lawfully acquired
3760 alcoholic beverages on the premises of the licensee by patrons thereof during such event. However,
3761 alcoholic beverages shall not be sold or charged for in any way by the licensee. The privileges of this
3762 license shall be (i) limited to the premises of the licensee, regularly occupied and utilized for equestrian,
3763 hunt, and steeplechase events, and (ii) exercised on no more than four calendar days per year.

3764 f. Annual arts venue event licenses, to persons operating an arts venue, which shall authorize the
3765 licensee participating in a community art walk that is open to the public to serve lawfully acquired wine
3766 or beer on the premises of the licensee to adult patrons thereof during such events. However, alcoholic
3767 beverages shall not be sold or charged for in any way, directly or indirectly, by the licensee, and the
3768 licensee shall not give more than two five-ounce glasses of wine or two 12-ounce glasses of beer to any
3769 one adult patron. The privileges of this license shall be (i) limited to the premises of the arts venue
3770 regularly occupied and used as such and (ii) exercised on no more than 12 calendar days per year.

3771 E. The Board may grant a marketplace license to persons operating a business enterprise of which
3772 the primary function is not the sale of alcoholic beverages, which shall authorize the licensee to serve
3773 complimentary wine or beer to bona fide customers on the licensed premises subject to any limitations
3774 imposed by the Board; however, the licensee shall not give more than two five-ounce glasses of wine or
3775 two 12-ounce glasses of beer to any customer per day, nor shall it sell or otherwise charge a fee to such
3776 customer for the wine or beer served or consumed. In order to be eligible for and retain a marketplace
3777 license, the applicant's business enterprise must (i) provide a single category of goods or services in a
3778 manner intended to create a personalized experience for the customer; (ii) employ staff with expertise in
3779 such goods or services; (iii) be ineligible for any other license granted by the Board; (iv) have an
3780 alcoholic beverage control manager on the licensed premises at all times alcohol is served; (v) ensure
3781 that all employees satisfy any training requirements imposed by the Board; and (vi) purchase all wine
3782 and beer to be served from a licensed wholesaler or the Authority and retain purchase records as
3783 prescribed by the Board. In determining whether to grant a marketplace license, the Board shall consider
3784 (a) the average amount of time customers spend at the business; (b) the business's hours of operation;
3785 (c) the amount of time that the business has been in operation; and (d) any other requirements deemed
3786 necessary by the Board to protect the public health, safety, and welfare.

3787 F. The Board may grant the following shipper, bottler, and related licenses:

3788 1. Wine and beer shipper licenses, which shall carry the privileges and limitations set forth in
3789 § 4.1-209.1.

3790 2. Internet wine and beer retailer licenses, which shall authorize persons located within or outside the
3791 Commonwealth to sell and ship wine and beer, in accordance with § 4.1-209.1 and Board regulations, in
3792 closed containers to persons in the Commonwealth to whom wine and beer may be lawfully sold for
3793 off-premises consumption. Such licensee shall not be required to comply with the monthly food sale
3794 requirement established by Board regulations.

3795 3. Bottler licenses, which shall authorize the licensee to acquire and receive deliveries and shipments
3796 of beer in closed containers and to bottle, sell, and deliver or ship it, in accordance with Board
3797 regulations to (i) wholesale beer licensees for the purpose of resale, (ii) owners of boats registered under
3798 the laws of the United States sailing for ports of call of a foreign country or another state, and (iii)
3799 persons outside the Commonwealth for resale outside the Commonwealth.

3800 4. Fulfillment warehouse licenses, which shall authorize associations as defined in § 13.1-313 with a
3801 place of business located in the Commonwealth to (i) receive deliveries and shipments of wine or beer
3802 owned by holders of wine and beer shipper's licenses; (ii) store such wine or beer on behalf of the
3803 owner; and (iii) pick, pack, and ship such wine or beer as directed by the owner, all in accordance with
3804 Board regulations. No wholesale wine or wholesale beer licensee, whether licensed in the
3805 Commonwealth or not, or any person under common control of such licensee, shall acquire or hold any
3806 financial interest, direct or indirect, in the business for which any fulfillment warehouse license is
3807 issued.

3808 5. Marketing portal licenses, which shall authorize agricultural cooperative associations organized
3809 under the provisions of the Agricultural Cooperative Association Act (§ 13.1-312 et seq.), with a place
3810 of business located in the Commonwealth, in accordance with Board regulations, to solicit and receive
3811 orders for wine or beer through the use of the Internet from persons in the Commonwealth to whom

wine or beer may be lawfully sold, on behalf of holders of wine and beer shipper's licenses. Upon receipt of an order for wine or beer, the licensee shall forward it to a holder of a wine and beer shipper's license for fulfillment. Marketing portal licensees may also accept payment on behalf of the shipper.

§ 4.1-212. Permits required in certain instances.

A. The Board may grant the following permits which shall authorize:

1. Wine and beer salesmen representing any out-of-state wholesaler engaged in the sale of wine and beer, or either, to sell or solicit the sale of wine or beer, or both in the Commonwealth.

2. Any person having any interest in the manufacture, distribution or sale of spirits or other alcoholic beverages to solicit any mixed beverage licensee, his agent, employee or any person connected with the licensee in any capacity in his licensed business to sell or offer for sale such spirits or alcoholic beverages.

3. Any person to keep upon his premises alcoholic beverages that he is not authorized by any license to sell and which shall be used for culinary purposes only.

4. Any person to transport lawfully purchased alcoholic beverages within, into or through the Commonwealth, except that no permit shall be required for any person shipping or transporting into the Commonwealth a reasonable quantity of alcoholic beverages when such person is relocating his place of residence to the Commonwealth in accordance with § 4.1-310.

5. Any person to keep, store, or possess any still or distilling apparatus for the purpose of distilling alcohol.

6. The release of alcoholic beverages not under United States custom bonds or internal revenue bonds stored in Board approved warehouses for delivery to the Board or to persons entitled to receive them within or outside of the Commonwealth.

7. The release of alcoholic beverages from United States customs bonded warehouses for delivery to the Board or to licensees and other persons enumerated in subsection B of § 4.1-131.

8. The release of alcoholic beverages from United States internal revenue bonded warehouses for delivery in accordance with subsection C of § 4.1-132.

9. A secured party or any trustee, curator, committee, conservator, receiver or other fiduciary appointed or qualified in any court proceeding, to continue to operate under the licenses previously issued to any deceased or other person licensed to sell alcoholic beverages for such period as the Board deems appropriate.

10. The one-time sale of lawfully acquired alcoholic beverages belonging to any person, or which may be a part of such person's estate, including a judicial sale, estate sale, sale to enforce a judgment lien or liquidation sale to satisfy indebtedness secured by a security interest in alcoholic beverages, by a sheriff, personal representative, receiver or other officer acting under authority of a court having jurisdiction in the Commonwealth, or by any secured party as defined in subdivision (a)(73) of § 8.9A-102 of the Virginia Uniform Commercial Code. Such sales shall be made only to persons who are licensed or hold a permit to sell alcoholic beverages in the Commonwealth or to persons outside the Commonwealth for resale outside the Commonwealth and upon such conditions or restrictions as the Board may prescribe.

11. Any person who purchases at a foreclosure, secured creditor's or judicial auction sale the premises or property of a person licensed by the Board and who has become lawfully entitled to the possession of the licensed premises to continue to operate the establishment to the same extent as a person holding such licenses for a period not to exceed 60 days or for such longer period as determined by the Board. Such permit shall be temporary and shall confer the privileges of any licenses held by the previous owner to the extent determined by the Board. Such temporary permit may be issued in advance, conditioned on the above requirements.

12. The storage of lawfully acquired alcoholic beverages not under customs bond or internal revenue bond in warehouses located in the Commonwealth.

13. The storage of wine by a licensed winery or farm winery under internal revenue bond in warehouses located in the Commonwealth.

14. Any person to conduct tastings in accordance with § 4.1-201.1, provided that such person has filed an application for a permit in which the applicant represents (i) that he or she is under contract to conduct such tastings on behalf of the alcoholic beverage manufacturer or wholesaler named in the application; (ii) that such contract grants to the applicant the authority to act as the authorized representative of such manufacturer or wholesaler; and (iii) that such contract contains an acknowledgment that the manufacturer or wholesaler named in the application may be held liable for any violation of § 4.1-201.1 by its authorized representative. A permit issued pursuant to this subdivision shall be valid for at least one year, unless sooner suspended or revoked by the Board in accordance with § 4.1-229.

15. Any person who, through contract, lease, concession, license, management or similar agreement

3873 (hereinafter referred to as the contract), becomes lawfully entitled to the use and control of the premises
3874 of a person licensed by the Board to continue to operate the establishment to the same extent as a
3875 person holding such licenses, provided such person has made application to the Board for a license at
3876 the same premises. The permit shall (i) confer the privileges of any licenses held by the previous owner
3877 to the extent determined by the Board and (ii) be valid for a period of 120 days or for such longer
3878 period as may be necessary as determined by the Board pending the completion of the processing of the
3879 permittee's license application. No permit shall be issued without the written consent of the previous
3880 licensee. No permit shall be issued under the provisions of this subdivision if the previous licensee owes
3881 any state or local taxes, or has any pending charges for violation of this ~~title~~ subtitle or any Board
3882 regulation, unless the permittee agrees to assume the liability of the previous licensee for the taxes or
3883 any penalty for the pending charges. An application for a permit may be filed prior to the effective date
3884 of the contract, in which case the permit when issued shall become effective on the effective date of the
3885 contract. Upon the effective date of the permit, (a) the permittee shall be responsible for compliance
3886 with the provisions of this ~~title~~ subtitle and any Board regulation and (b) the previous licensee shall not
3887 be held liable for any violation of this ~~title~~ subtitle or any Board regulation committed by, or any errors
3888 or omissions of, the permittee.

3889 16. Any sight-seeing carrier or contract passenger carrier as defined in § 46.2-2000 transporting
3890 individuals for compensation to a winery, brewery, or restaurant, licensed under this chapter and
3891 authorized to conduct tastings, to collect the licensee's tasting fees from tour participants for the sole
3892 purpose of remitting such fees to the licensee.

3893 17. Any tour company guiding individuals for compensation on a walking tour to one or more
3894 establishments licensed to sell alcoholic beverages at retail for on-premises consumption to collect as
3895 one fee from tour participants (i) the licensee's fee for the alcoholic beverages served as part of the tour,
3896 (ii) a fee for any food offered as part of the tour, and (iii) a fee for the walking tour service. The tour
3897 company shall remit to the licensee any fee collected for the alcoholic beverages and any food served as
3898 part of the tour. The tour company shall ensure that (a) each tour includes no more than 15 participants
3899 per tour guide and no more than three tour guides, (b) a tour guide is present with the participants
3900 throughout the duration of the tour, and (c) all participants are persons to whom alcoholic beverages
3901 may be lawfully sold.

3902 B. Nothing in subdivision 9, 10, or 11 shall authorize any brewery, winery or affiliate or a subsidiary
3903 thereof which has supplied financing to a wholesale licensee to manage and operate the wholesale
3904 licensee in the event of a default, except to the extent authorized by subdivision B 3 a of § 4.1-216.

3905 **§ 4.1-213. Manufacture and sale of cider.**

3906 A. Any winery licensee or farm winery licensee may manufacture and sell cider to (i) the Board, (ii)
3907 any wholesale wine licensee, and (iii) persons outside the Commonwealth.

3908 B. Any wholesale wine licensee may acquire and receive shipments of cider, and sell and deliver and
3909 ship the cider in accordance with Board regulations to (i) the Board, (ii) any wholesale wine licensee,
3910 (iii) any retail licensee approved by the Board for the purpose of selling cider, and (iv) persons outside
3911 the Commonwealth for resale outside the Commonwealth.

3912 C. Any licensee authorized to sell alcoholic beverages at retail may sell cider in the same manner
3913 and to the same persons, and subject to the same limitations and conditions, as such license authorizes
3914 him to sell other alcoholic beverages.

3915 D. Cider containing less than seven percent of alcohol by volume may be sold in any containers that
3916 comply with federal regulations for wine or beer, provided such containers are labeled in accordance
3917 with Board regulations. Cider containing seven percent or more of alcohol by volume may be sold in
3918 any containers that comply with federal regulations for wine, provided such containers are labeled in
3919 accordance with Board regulations.

3920 E. No additional license fees shall be charged for the privilege of handling cider.

3921 F. The Board shall collect such markup as it deems appropriate on all cider manufactured or sold, or
3922 both, in the Commonwealth.

3923 G. The Board shall adopt regulations relating to the manufacture, possession, transportation and sale
3924 of cider as it deems necessary to prevent any unlawful manufacture, possession, transportation or sale of
3925 cider and to ensure that the markup required to be paid will be collected.

3926 H. For the purposes of this section:

3927 "Chaptalization" means a method of increasing the alcohol in a wine by adding sugar to the must
3928 before or during fermentation.

3929 "Cider" means any beverage, carbonated or otherwise, obtained by the fermentation of the natural
3930 sugar content of apples or pears (i) containing not more than 10 percent of alcohol by volume without
3931 chaptalization or (ii) containing not more than seven percent of alcohol by volume regardless of
3932 chaptalization. Cider shall be treated as wine for all purposes of this ~~title~~ subtitle, except as otherwise
3933 provided in this ~~title~~ subtitle or Board regulations.

3934 I. This section shall not limit the privileges set forth in subdivision 8 of § 4.1-200, nor shall any

person be denied the privilege of manufacturing and selling sweet cider.

§ 4.1-215. Limitation on manufacturers, bottlers, and wholesalers; exemptions.

A. 1. Unless exempted pursuant to subsection B, no retail license for the sale of alcoholic beverages shall be granted to any (i) manufacturer, bottler, or wholesaler of alcoholic beverages, whether licensed in the Commonwealth or not; (ii) officer or director of any such manufacturer, bottler, or wholesaler; (iii) partnership or corporation, where any partner or stockholder is an officer or director of any such manufacturer, bottler, or wholesaler; (iv) corporation which is a subsidiary of a corporation which owns or has interest in another subsidiary corporation which is a manufacturer, bottler, or wholesaler of alcoholic beverages; or (v) manufacturer, bottler, or wholesaler of alcoholic beverages who has a financial interest in a corporation which has a retail license as a result of a holding company, which owns or has an interest in such manufacturer, bottler, or wholesaler of alcoholic beverages. Nor shall such licenses be granted in any instances where such manufacturer, bottler, or wholesaler and such retailer are under common control, by stock ownership or otherwise.

2. Notwithstanding any other provision of this ~~title~~ subtitle, a manufacturer of wine or malt beverages, or two or more of such manufacturers together, whether licensed in the Commonwealth or not, may obtain a banquet license as provided in § 4.1-206.3 upon application to the Board, provided that the event for which a banquet license is obtained is (i) at a place approved by the Board and (ii) conducted for the purposes of featuring and educating the consuming public about wine or malt beverage products. Such manufacturer shall be limited to eight banquet licenses, whether or not jointly obtained, for such events per year without regard to the number of wineries or breweries owned or operated by such manufacturer or by any parent, subsidiary, or company under common control with such manufacturer. Where the event occurs on no more than three consecutive days, a manufacturer need only obtain one such license for the event.

3. Notwithstanding any other provision of this ~~title~~ subtitle, a manufacturer of distilled spirits, whether licensed in the Commonwealth or not, may obtain a banquet license for a special event as provided in subdivision D 1 b of § 4.1-206.3 upon application to the Board, provided that such event is (i) at a place approved by the Board and (ii) conducted for the purposes of featuring and educating the consuming public about the manufacturer's spirits products. Such manufacturer shall be limited to no more than eight banquet licenses for such special events per year. Where the event occurs on no more than three consecutive days, a manufacturer need only obtain one such license for the event. Such banquet license shall authorize the manufacturer to sell or give samples of spirits to any person to whom alcoholic beverages may be lawfully sold in designated areas at the special event, provided that (a) no single sample shall exceed one-half ounce per spirits product offered, unless served as a mixed beverage, in which case a single sample may contain up to one and one-half ounces of spirits, and (b) no more than three ounces of spirits may be offered to any patron per day. Nothing in this paragraph shall prohibit such manufacturer from serving such samples as part of a mixed beverage.

B. This section shall not apply to:

1. Corporations operating dining cars, buffet cars, club cars, or boats;

2. Brewery, distillery, or winery licensees engaging in conduct authorized by subdivision A 5 of § 4.1-201;

3. Farm winery licensees engaging in conduct authorized by subdivision 6 of § 4.1-206.1;

4. Manufacturers, bottlers, or wholesalers of alcoholic beverages who do not (i) sell or otherwise furnish, directly or indirectly, alcoholic beverages or other merchandise to persons holding a retail license or banquet license as described in subsection A and (ii) require, by agreement or otherwise, such person to exclude from sale at his establishment alcoholic beverages of other manufacturers, bottlers, or wholesalers;

5. Wineries, farm wineries, or breweries engaging in conduct authorized by subsection F of § 4.1-206.3 or § 4.1-209.1 or 4.1-212.1; or

6. One out-of-state winery, not under common control or ownership with any other winery, that is under common ownership or control with one restaurant licensed to sell wine at retail in Virginia, so long as any wine produced by that winery is purchased from a Virginia wholesale wine licensee by the restaurant before it is offered for sale to consumers.

C. The General Assembly finds that it is necessary and proper to require a separation between manufacturing interests, wholesale interests, and retail interests in the production and distribution of alcoholic beverages in order to prevent suppliers from dominating local markets through vertical integration and to prevent excessive sales of alcoholic beverages caused by overly aggressive marketing techniques. The exceptions established by this section to the general prohibition against tied interests shall be limited to their express terms so as not to undermine the general prohibition and shall therefore be construed accordingly.

§ 4.1-216. Further limitations on manufacturers, bottlers, importers, brokers or wholesalers; ownership interests prohibited; exceptions; prohibited trade practices.

3996 A. As used in this section:

3997 "Broker" means any person, other than a manufacturer or a licensed beer or wine importer, who
3998 regularly engages in the business of bringing together sellers and purchasers of alcoholic beverages for
3999 resale and arranges for or consummates such transactions with persons in the Commonwealth to whom
4000 such alcoholic beverages may lawfully be sold and shipped into the Commonwealth pursuant to the
4001 provisions of this ~~title~~ subtitle.

4002 "Manufacturer, bottler, importer, broker or wholesaler of alcoholic beverages" includes any officers
4003 or directors of any such manufacturer, bottler, importer, broker or wholesaler.

4004 B. Except as provided in this ~~title~~ subtitle, no manufacturer, importer, bottler, broker or wholesaler of
4005 alcoholic beverages, whether licensed in the Commonwealth or not, shall acquire or hold any financial
4006 interest, direct or indirect, (i) in the business for which any retail license is issued or (ii) in the premises
4007 where the business of a retail licensee is conducted.

4008 1. Subdivision B (ii) shall not apply so long as such manufacturer, bottler, importer, broker or
4009 wholesaler does not sell or otherwise furnish, directly or indirectly, alcoholic beverages or other
4010 merchandise to such retail licensee and such retailer is not required by agreement or otherwise to
4011 exclude from sale at his establishment alcoholic beverages of other manufacturers, bottlers, importers,
4012 brokers or wholesalers.

4013 2. Service as a member of the board of directors of a corporation licensed as a retailer, the shares of
4014 stock of which are sold to the general public on any national or local stock exchange, shall not be
4015 deemed to be a financial interest, direct or indirect, in the business or the premises of the retail licensee.

4016 3. A brewery, winery or subsidiary or affiliate thereof, hereinafter collectively referred to as a
4017 financing corporation, may participate in financing the business of a wholesale licensee in the
4018 Commonwealth by providing debt or equity capital or both but only if done in accordance with the
4019 provisions of this subsection.

4020 a. In order to assist a proposed new owner of an existing wholesale licensee, a financing corporation
4021 may provide debt or equity capital, or both, if prior approval of the Board has been obtained pursuant to
4022 subdivision 3 b of subsection B. A financing corporation which proposes to provide equity capital shall
4023 cause the proposed new owner to form a Virginia limited partnership in which the new owner is the
4024 general partner and the financing corporation is a limited partner. If the general partner defaults on any
4025 financial obligation to the limited partner, which default has been specifically defined in the partnership
4026 agreement, or, if the new owner defaults on its obligation to pay principal and interest when due to the
4027 financing corporation as specifically defined in the loan documents, then, and only then, shall such
4028 financing corporation be allowed to take title to the business of the wholesale licensee. Notwithstanding
4029 any other law to the contrary and provided written notice has been given to the Board within two
4030 business days after taking title, the wholesale licensee may be managed and operated by such financing
4031 corporation pursuant to the existing wholesale license for a period of time not to exceed 180 days as if
4032 the license had been issued in the name of the financing corporation. On or before the expiration of
4033 such 180-day period, the financing corporation shall cause ownership of the wholesale licensee's
4034 business to be transferred to a new owner. Otherwise, on the 181st day, the license shall be deemed
4035 terminated. The financing corporation may not participate in financing the transfer of ownership to the
4036 new owner or to any other subsequent owner for a period of ~~twenty~~ 20 years following the effective
4037 date of the original financing transaction; except where a transfer takes place before the expiration of the
4038 eighth full year following the effective date of the original financing transaction in which case the
4039 financing corporation may finance such transfer as long as the new owner is required to return such debt
4040 or equity capital within the originally prescribed eight-year period. The financing corporation may
4041 exercise its right to take title to, manage and operate the business of, the wholesale licensee only once
4042 during such eight-year period.

4043 b. In any case in which a financing corporation proposes to provide debt or equity capital in order to
4044 assist in a change of ownership of an existing wholesale licensee, the parties to the transaction shall first
4045 submit an application for a wholesale license in the name of the proposed new owner to the Board.

4046 The Board shall be provided with all documents that pertain to the transaction at the time of the
4047 license application and shall ensure that the application complies with all requirements of law pertaining
4048 to the issuance of wholesale licenses except that if the financing corporation proposes to provide equity
4049 capital and thereby take a limited partnership interest in the applicant entity, the financing corporation
4050 shall not be required to comply with any Virginia residency requirement applicable to the issuance of
4051 wholesale licenses. In addition to the foregoing, the applicant entity shall certify to the Board and
4052 provide supporting documentation that the following requirements are met prior to issuance of the
4053 wholesale license: (i) the terms and conditions of any debt financing which the financing corporation
4054 proposes to provide are substantially the same as those available in the financial markets to other
4055 wholesale licensees who will be in competition with the applicant, (ii) the terms of any proposed equity
4056 financing transaction are such that future profits of the applicant's business shall be distributed annually
4057 to the financing corporation in direct proportion to its percentage of ownership interest received in return

for its investment of equity capital, (iii) if the financing corporation proposes to provide equity capital, it shall hold an ownership interest in the applicant entity through a limited partnership interest and no other arrangement and (iv) the applicant entity shall be contractually obligated to return such debt or equity capital to the financing corporation not later than the end of the eighth full year following the effective date of the transaction thereby terminating any ownership interest or right thereto of the financing corporation.

Once the Board has issued a wholesale license pursuant to an application filed in accordance with this subdivision 3 b, any subsequent change in the partnership agreement or the financing documents shall be subject to the prior approval of the Board. In accordance with the previous paragraph, the Board may require the licensee to resubmit certifications and documentation.

c. If a financing corporation wishes to provide debt financing, including inventory financing, but not equity financing, to an existing wholesale licensee or a proposed new owner of an existing wholesale licensee, it may do so without regard to the provisions of subdivisions 3 a and 3 b of subsection B under the following circumstances and subject to the following conditions: (i) in order to secure such debt financing, a wholesale licensee or a proposed new owner thereof may grant a security interest in any of its assets, including inventory, other than the wholesale license itself or corporate stock of the wholesale licensee; in the event of default, the financing corporation may take title to any assets pledged to secure such debt but may not take title to the business of the wholesale licensee and may not manage or operate such business; (ii) debt capital may be supplied by such financing corporation to an existing wholesale licensee or a proposed new owner of an existing wholesale licensee so long as debt capital is provided on terms and conditions which are substantially the same as those available in the financial markets to other wholesale licensees in competition with the wholesale licensee which is being so financed; and (iii) the licensee or proposed new owner shall certify to the Board and provide supporting documentation that the requirements of (i) and (ii) of this subdivision 3 c have been met.

Nothing in this section shall eliminate, affect or in any way modify the requirements of law pertaining to issuance and retention of a wholesale license as they may apply to existing wholesale licensees or new owners thereof which have received debt financing prior to the enactment of this subdivision 3 c.

4. Except for holders of retail licenses issued pursuant to subdivision A 5 of § 4.1-201, brewery licensees may sell beer to retail licensees for resale only under the following conditions: If such brewery or an affiliate or subsidiary thereof has taken title to the business of a wholesale licensee pursuant to the provisions of subdivision 3 a of subsection B, direct sale to retail licensees may be made during the 180-day period of operation allowed under that subdivision. Moreover, the holder of a brewery license may make sales of alcoholic beverages directly to retail licensees for a period not to exceed ~~thirty~~ 30 days in the event that such retail licensees are normally serviced by a wholesale licensee representing that brewery which has been forced to suspend wholesale operations as a result of a natural disaster or other act of God or which has been terminated by the brewery for fraud, loss of license or assignment of assets for the benefit of creditors not in the ordinary course of business.

5. Notwithstanding any provision of this section, including but not limited to those provisions whereby certain ownership or lease arrangements may be permissible, no manufacturer, bottler, importer, broker or wholesaler of alcoholic beverages shall make an agreement, or attempt to make an agreement, with a retail licensee pursuant to which any products sold by a competitor are excluded in whole or in part from the premises on which the retail licensee's business is conducted.

6. Nothing in this section shall prohibit a winery, brewery, or distillery licensee from paying a royalty to a historical preservation entity pursuant to a bona fide intellectual property agreement that (i) authorizes the winery, brewery, or distillery licensee to manufacture wine, beer, or spirits based on authentic historical recipes and identified with brand names owned and trademarked by the historical preservation entity; (ii) provides for royalties to be paid based solely on the volume of wine, beer, or spirits manufactured using such recipes and trademarks, rather than on the sales revenues generated from such wine, beer, or spirits; and (iii) has been approved by the Board.

For purposes of this subdivision, "historical preservation entity" means an entity (a) that is exempt from income taxation under § 501(c)(3) of the Internal Revenue Code; (b) whose declared purposes include the preservation, restoration, and protection of a historic community in the Commonwealth that is the site of at least 50 historically significant houses, shops, and public buildings dating to the eighteenth century; and (c) that owns not more than 12 retail establishments in the Commonwealth for which retail licenses have been issued by the Board.

C. Subject to such exceptions as may be provided by statute or Board regulations, no manufacturer, bottler, importer, broker or wholesaler of alcoholic beverages, whether licensed in the Commonwealth or not, shall sell, rent, lend, buy for or give to any retail licensee, or to the owner of the premises in which the business of any retail licensee is conducted, any (i) money, equipment, furniture, fixtures, property, services or anything of value with which the business of such retail licensee is or may be conducted, or

4119 for any other purpose; (ii) advertising materials; and (iii) business entertainment, provided that no
4120 transaction permitted under this section or by Board regulation shall be used to require the retail licensee
4121 to partially or totally exclude from sale at its establishment alcoholic beverages of other manufacturers
4122 or wholesalers.

4123 The provisions of this subsection shall apply to manufacturers, bottlers, importers, brokers and
4124 wholesalers selling alcoholic beverages to any governmental instrumentality or employee thereof selling
4125 alcoholic beverages at retail within the exterior limits of the Commonwealth, including all territory
4126 within these limits owned by or ceded to the United States of America.

4127 The provisions of this subsection shall not apply to any commercial lifestyle center licensee.

4128 **§ 4.1-216.1. Point-of-sale advertising materials authorized under certain conditions; civil**
4129 **penalties.**

4130 A. As used in this section:

4131 "Alcoholic beverage advertising material" or "advertising material" means any item, other than an
4132 illuminated device, which contains one or more references to a brand of alcoholic beverage and which is
4133 used to promote the sale of alcoholic beverages within the interior of a licensed retail establishment and
4134 which otherwise complies with Board regulations.

4135 "Authorized vendor" or "vendor" means any person, other than a wholesale wine or beer licensee,
4136 that a manufacturer has authorized to engage in a business consisting in whole or in part of the sale and
4137 distribution of any articles of tangible personal property bearing any of the manufacturer's alcoholic
4138 beverage trademarks.

4139 "Manufacturer" means any brewery, winery, distillery, bottler, broker, importer and any person that a
4140 brewery, winery, or distiller has authorized to sell or arrange for the sale of its products to wholesale
4141 wine and beer licensees in Virginia or, in the case of spirits, to the Board.

4142 B. Notwithstanding the provisions of § 4.1-215 or 4.1-216 and Board regulations adopted thereunder,
4143 a manufacturer or its authorized vendor and a wholesale wine and beer licensee may lend, buy for, or
4144 give to a retail licensee any alcoholic beverage advertising material made of paper, cardboard, canvas,
4145 rubber, foam, or plastic, provided the advertising materials have a wholesale value of \$40 or less per
4146 item.

4147 C. Alcoholic beverage advertising materials, other than those authorized by subsection B to be given
4148 to a retailer, may be displayed by a retail licensee in the interior of its licensed establishment provided:

4149 1. The wholesale value of the advertising material does not exceed \$250 per item, and

4150 2. The advertising material is not obtained from a manufacturer, its authorized vendor, or any
4151 wholesale wine or beer licensee.

4152 A retail licensee shall retain for at least two years a record of its procurement of, including any
4153 payments for, such advertising materials along with an invoice or sales ticket containing a description of
4154 the item so purchased or otherwise procured.

4155 D. Except as otherwise provided in this ~~title~~ subtitle, a retail licensee shall not display in the interior
4156 of its licensed establishment any alcoholic beverage advertising materials, other than those that may be
4157 lawfully obtained and displayed in accordance with this section or Board regulation.

4158 E. Nothing in this section shall be construed to prohibit any advertising materials permitted under
4159 Board regulations in effect on January 1, 2007.

4160 **§ 4.1-222. Conditions under which Board may refuse to grant licenses.**

4161 The Board may refuse to grant any license if it has reasonable cause to believe that:

4162 1. The applicant, or if the applicant is a partnership, any general partner thereof, or if the applicant is
4163 an association, any member thereof, or limited partner of 10 percent or more with voting rights, or if the
4164 applicant is a corporation, any officer, director, or shareholder owning 10 percent or more of its capital
4165 stock, or if the applicant is a limited liability company, any member-manager or any member owning 10
4166 percent or more of the membership interest of the limited liability company:

4167 a. Is not 21 years of age or older;

4168 b. Has been convicted in any court of a felony or any crime or offense involving moral turpitude
4169 under the laws of any state, or of the United States;

4170 c. Has been convicted, within the five years immediately preceding the date of the application for
4171 such license, of a violation of any law applicable to the manufacture, transportation, possession, use or
4172 sale of alcoholic beverages;

4173 d. Is not a person of good moral character and repute;

4174 e. Is not the legitimate owner of the business proposed to be licensed, or other persons have
4175 ownership interests in the business which have not been disclosed;

4176 f. Has not demonstrated financial responsibility sufficient to meet the requirements of the business
4177 proposed to be licensed;

4178 g. Has maintained a noisy, lewd, disorderly or unsanitary establishment;

4179 h. Has demonstrated, either by his police record or by his record as a former licensee of the Board, a
4180 lack of respect for law and order;

- 4181 i. Is unable to speak, understand, read and write the English language in a reasonably satisfactory
 4182 manner;
- 4183 j. Is a person to whom alcoholic beverages may not be sold under § 4.1-304;
- 4184 k. Has the general reputation of drinking alcoholic beverages to excess or is addicted to the use of
 4185 narcotics;
- 4186 l. Has misrepresented a material fact in applying to the Board for a license;
- 4187 m. Has defrauded or attempted to defraud the Board, or any federal, state or local government or
 4188 governmental agency or authority, by making or filing any report, document or tax return required by
 4189 statute or regulation which is fraudulent or contains a false representation of a material fact; or has
 4190 willfully deceived or attempted to deceive the Board, or any federal, state or local government, or
 4191 governmental agency or authority, by making or maintaining business records required by statute or
 4192 regulation which are false and fraudulent;
- 4193 n. Is violating or allowing the violation of any provision of this ~~title~~ subtitle in his establishment at
 4194 the time his application for a license is pending;
- 4195 o. Is a police officer with police authority in the political subdivision within which the establishment
 4196 designated in the application is located;
- 4197 p. Is physically unable to carry on the business for which the application for a license is filed or has
 4198 been adjudicated incapacitated; or
- 4199 q. Is a member, agent or employee of the Board.
- 4200 2. The place to be occupied by the applicant:
- 4201 a. Does not conform to the requirements of the governing body of the county, city or town in which
 4202 such place is located with respect to sanitation, health, construction or equipment, or to any similar
 4203 requirements established by the laws of the Commonwealth or by Board regulation;
- 4204 b. Is so located that granting a license and operation thereunder by the applicant would result in
 4205 violations of this ~~title~~ subtitle, Board regulations, or violation of the laws of the Commonwealth or local
 4206 ordinances relating to peace and good order;
- 4207 c. Is so located with respect to any church; synagogue; hospital; public, private, or parochial school
 4208 or an institution of higher education; public or private playground or other similar recreational facility;
 4209 or any state, local, or federal government-operated facility, that the operation of such place under such
 4210 license will adversely affect or interfere with the normal, orderly conduct of the affairs of such facilities
 4211 or institutions;
- 4212 d. Is so located with respect to any residence or residential area that the operation of such place
 4213 under such license will adversely affect real property values or substantially interfere with the usual
 4214 quietude and tranquility of such residence or residential area; or
- 4215 e. Under a retail on-premises license is so constructed, arranged or illuminated that law-enforcement
 4216 officers and special agents of the Board are prevented from ready access to and reasonable observation
 4217 of any room or area within which alcoholic beverages are to be sold or consumed.
- 4218 3. The number of licenses existent in the locality is such that the granting of a license is detrimental
 4219 to the interest, morals, safety or welfare of the public. In reaching such conclusion the Board shall
 4220 consider the (i) character of, population of, the number of similar licenses and the number of all licenses
 4221 existent in the particular county, city or town and the immediate neighborhood concerned; (ii) effect
 4222 which a new license may have on such county, city, town or neighborhood in conforming with the
 4223 purposes of this ~~title~~ subtitle; and (iii) objections, if any, which may have been filed by a local
 4224 governing body or local residents.
- 4225 4. There exists any law, ordinance, or regulation of the United States, the Commonwealth or any
 4226 political subdivision thereof, which warrants refusal by the Board to grant any license.
- 4227 5. The Board is not authorized under this chapter to grant such license.
- 4228 **§ 4.1-224. Notice and hearings for refusal to grant licenses; Administrative Process Act;**
 4229 **exceptions.**
- 4230 A. The action of the Board in granting or in refusing to grant any license shall be subject to review
 4231 in accordance with the Administrative Process Act (§ 2.2-4000 et seq.), except as provided in
 4232 subsections B and C. Review shall be limited to the evidential record of the proceedings provided by the
 4233 Board. Both the petitioner and the Board shall have the right to appeal to the Court of Appeals from
 4234 any order of the court.
- 4235 B. The Board may refuse a hearing on any application for the granting of any retail alcoholic
 4236 beverage or mixed beverage license, including a banquet license, provided such:
- 4237 1. License for the applicant has been refused or revoked within a period of ~~twelve~~ 12 months;
- 4238 2. License for any premises has been refused or revoked at that location within a period of ~~twelve~~ 12
 4239 months;
- 4240 3. Applicant, within a period of ~~twelve~~ 12 months immediately preceding, has permitted a license
 4241 granted by the Board to expire for nonpayment of license tax, and at the time of expiration of such

license, there was a pending and unadjudicated charge, either before the Board or in any court, against the licensee alleging a violation of this ~~title~~ subtitle; or

4. Applicant has received a restricted license and reapplies for a lesser-restricted license at the same location within ~~twelve~~ 12 months of the date of the issuance of the restricted license.

C. If an applicant has permitted a license to expire for nonpayment of license tax, and at the time of expiration there remained unexecuted any period of suspension imposed upon the licensee by the Board, the Board may refuse a hearing on an application for a new license until after the date on which the suspension period would have been executed had the license not have been permitted to expire.

§ 4.1-225. Grounds for which Board may suspend or revoke licenses.

The Board may suspend or revoke any license other than a brewery license, in which case the Board may impose penalties as provided in § 4.1-227, if it has reasonable cause to believe that:

1. The licensee, or if the licensee is a partnership, any general partner thereof, or if the licensee is an association, any member thereof, or a limited partner of 10 percent or more with voting rights, or if the licensee is a corporation, any officer, director, or shareholder owning 10 percent or more of its capital stock, or if the licensee is a limited liability company, any member-manager or any member owning 10 percent or more of the membership interest of the limited liability company:

a. Has misrepresented a material fact in applying to the Board for such license;

b. Within the five years immediately preceding the date of the hearing held in accordance with § 4.1-227, has (i) been convicted of a violation of any law, ordinance, or regulation of the Commonwealth, of any county, city, or town in the Commonwealth, of any state, or of the United States, applicable to the manufacture, transportation, possession, use, or sale of alcoholic beverages; (ii) violated any provision of Chapter 3 (§ 4.1-300 et seq.); (iii) committed a violation of the Wine Franchise Act (§ 4.1-400 et seq.) or the Beer Franchise Act (§ 4.1-500 et seq.) in bad faith; (iv) violated or failed or refused to comply with any regulation, rule, or order of the Board; or (v) failed or refused to comply with any of the conditions or restrictions of the license granted by the Board;

c. Has been convicted in any court of a felony or of any crime or offense involving moral turpitude under the laws of any state; or of the United States;

d. Is not the legitimate owner of the business conducted under the license granted by the Board, or other persons have ownership interests in the business ~~which~~ that have not been disclosed;

e. Cannot demonstrate financial responsibility sufficient to meet the requirements of the business conducted under the license granted by the Board;

f. Has been intoxicated or under the influence of some self-administered drug while upon the licensed premises;

g. Has maintained the licensed premises in an unsanitary condition, or allowed such premises to become a meeting place or rendezvous for members of a criminal street gang as defined in § 18.2-46.1 or persons of ill repute, or has allowed any form of illegal gambling to take place upon such premises;

h. Knowingly employs in the business conducted under such license, as agent, servant, or employee, other than a busboy, cook, or other kitchen help, any person who has been convicted in any court of a felony or of any crime or offense involving moral turpitude; or who has violated the laws of the Commonwealth, of any other state, or of the United States; applicable to the manufacture, transportation, possession, use, or sale of alcoholic beverages;

i. Subsequent to the granting of his original license, has demonstrated by his police record a lack of respect for law and order;

j. Has allowed the consumption of alcoholic beverages upon the licensed premises by any person whom he knew or had reason to believe was (i) less than 21 years of age, (ii) interdicted, or (iii) intoxicated, or has allowed any person whom he knew or had reason to believe was intoxicated to loiter upon such licensed premises;

k. Has allowed any person to consume upon the licensed premises any alcoholic beverages except as provided under this ~~title~~ subtitle;

l. Is physically unable to carry on the business conducted under such license or has been adjudicated incapacitated;

m. Has allowed any obscene literature, pictures, or materials upon the licensed premises;

n. Has possessed any illegal gambling apparatus, machine, or device upon the licensed premises;

o. Has upon the licensed premises (i) illegally possessed, distributed, sold, or used, or has knowingly allowed any employee or agent, or any other person, to illegally possess, distribute, sell, or use marijuana, controlled substances, imitation controlled substances, drug paraphernalia, or controlled paraphernalia as those terms are defined in Articles 1 (§ 18.2-247 et seq.) and 1.1 (§ 18.2-265.1 et seq.) of Chapter 7 of Title 18.2 and the Drug Control Act (§ 54.1-3400 et seq.); (ii) laundered money in violation of § 18.2-246.3; or (iii) conspired to commit any drug-related offense in violation of Article 1 or 1.1 of Chapter 7 of Title 18.2 or the Drug Control Act. The provisions of this subdivision shall also apply to any conduct related to the operation of the licensed business that facilitates the commission of any of the offenses set forth herein;

p. Has failed to take reasonable measures to prevent (i) the licensed premises, (ii) any premises immediately adjacent to the licensed premises that are owned or leased by the licensee, or (iii) any portion of public property immediately adjacent to the licensed premises from becoming a place where patrons of the establishment commit criminal violations of Article 1 (§ 18.2-30 et seq.), 2 (§ 18.2-38 et seq.), 2.1 (§ 18.2-46.1 et seq.), 2.2 (§ 18.2-46.4 et seq.), 3 (§ 18.2-47 et seq.), 4 (§ 18.2-51 et seq.), 5 (§ 18.2-58 et seq.), 6 (§ 18.2-59 et seq.), or 7 (§ 18.2-61 et seq.) of Chapter 4 of Title 18.2; Article 2 (§ 18.2-266 et seq.) of Chapter 7 of Title 18.2; Article 3 (§ 18.2-346 et seq.) or 5 (§ 18.2-372 et seq.) of Chapter 8 of Title 18.2; or Article 1 (§ 18.2-404 et seq.), 2 (§ 18.2-415), or 3 (§ 18.2-416 et seq.) of Chapter 9 of Title 18.2 and such violations lead to arrests that are so frequent and serious as to reasonably be deemed a continuing threat to the public safety; or

q. Has failed to take reasonable measures to prevent an act of violence resulting in death or serious bodily injury, or a recurrence of such acts, from occurring on (i) the licensed premises, (ii) any premises immediately adjacent to the licensed premises that is owned or leased by the licensee, or (iii) any portion of public property immediately adjacent to the licensed premises.

2. The place occupied by the licensee:

a. Does not conform to the requirements of the governing body of the county, city, or town in which such establishment is located, with respect to sanitation, health, construction, or equipment, or to any similar requirements established by the laws of the Commonwealth or by Board regulations;

b. Has been adjudicated a common nuisance under the provisions of this ~~title~~ subtitle or § 18.2-258; or

c. Has become a meeting place or rendezvous for illegal gambling, illegal users of narcotics, drunks, prostitutes, pimps, panderers, or habitual law violators or has become a place where illegal drugs are regularly used or distributed. The Board may consider the general reputation in the community of such establishment in addition to any other competent evidence in making such determination.

3. The licensee or any employee of the licensee discriminated against any member of the armed forces of the United States by prices charged or otherwise.

4. The licensee, his employees, or any entertainer performing on the licensed premises has been convicted of a violation of a local public nudity ordinance for conduct occurring on the licensed premises and the licensee allowed such conduct to occur.

5. Any cause exists for which the Board would have been entitled to refuse to grant such license had the facts been known.

6. The licensee is delinquent for a period of 90 days or more in the payment of any taxes, or any penalties or interest related thereto, lawfully imposed by the locality where the licensed business is located, as certified by the treasurer, commissioner of the revenue, or finance director of such locality, unless (i) the outstanding amount is de minimis; (ii) the licensee has pending a bona fide application for correction or appeal with respect to such taxes, penalties, or interest; or (iii) the licensee has entered into a payment plan approved by the same locality to settle the outstanding liability.

7. Any other cause authorized by this ~~title~~ subtitle.

§ 4.1-227. Suspension or revocation of licenses; notice and hearings; imposition of penalties.

A. Except for temporary licenses, before the Board may impose a civil penalty against a brewery licensee or suspend or revoke any license, reasonable notice of such proposed or contemplated action shall be given to the licensee in accordance with the provisions of § 2.2-4020 of the Administrative Process Act (§ 2.2-4000 et seq.).

Notwithstanding the provisions of § 2.2-4022, the Board shall, upon written request by the licensee, permit the licensee to inspect and copy or photograph all (i) written or recorded statements made by the licensee or copies thereof or the substance of any oral statements made by the licensee or a previous or present employee of the licensee to any law-enforcement officer, the existence of which is known by the Board and upon which the Board intends to rely as evidence in any adversarial proceeding under this chapter against the licensee, and (ii) designated books, papers, documents, tangible objects, buildings, or places, or copies or portions thereof, that are within the possession, custody, or control of the Board and upon which the Board intends to rely as evidence in any adversarial proceeding under this chapter against the licensee. In addition, any subpoena for the production of documents issued to any person at the request of the licensee or the Board pursuant to § 4.1-103 shall provide for the production of the documents sought within ~~ten~~ 10 working days, notwithstanding anything to the contrary in § 4.1-103.

If the Board fails to provide for inspection or copying under this section for the licensee after a written request, the Board shall be prohibited from introducing into evidence any items the licensee would have lawfully been entitled to inspect or copy under this section.

The action of the Board in suspending or revoking any license or in imposing a civil penalty against the holder of a brewery license shall be subject to judicial review in accordance with the Administrative Process Act (§ 2.2-4000 et seq.). Such review shall extend to the entire evidential record of the proceedings provided by the Board in accordance with the Administrative Process Act. An appeal shall

lie to the Court of Appeals from any order of the court. Notwithstanding § 8.01-676.1, the final judgment or order of the circuit court shall not be suspended, stayed, or modified by such circuit court pending appeal to the Court of Appeals. Neither mandamus nor injunction shall lie in any such case.

B. In suspending any license, the Board may impose, as a condition precedent to the removal of such suspension or any portion thereof, a requirement that the licensee pay the cost incurred by the Board in investigating the licensee and in holding the proceeding resulting in such suspension, or it may impose and collect such civil penalties as it deems appropriate. In no event shall the Board impose a civil penalty exceeding \$2,000 for the first violation occurring within five years immediately preceding the date of the violation or \$5,000 for the second violation occurring within five years immediately preceding the date of the second violation. However, if the violation involved selling alcoholic beverages to a person prohibited from purchasing alcoholic beverages or allowing consumption of alcoholic beverages by underage, intoxicated, or interdicted persons, the Board may impose a civil penalty not to exceed \$3,000 for the first violation occurring within five years immediately preceding the date of the violation and \$6,000 for a second violation occurring within five years immediately preceding the date of the second violation in lieu of such suspension or any portion thereof, or both. The Board may also impose a requirement that the licensee pay for the cost incurred by the Board not exceeding \$25,000 in investigating the licensee and in holding the proceeding resulting in the violation in addition to any suspension or civil penalty incurred.

C. Following notice to (i) the licensee of a hearing that may result in the suspension or revocation of his license or (ii) the applicant of a hearing to resolve a contested application, the Board may accept a consent agreement as authorized in subdivision 21 of § 4.1-103. The notice shall advise the licensee or applicant of the option to (a) admit the alleged violation or the validity of the objection; (b) waive any right to a hearing or an appeal under the Virginia Administrative Process Act (§ 2.2-4000 et seq.); and (c) (1) accept the proposed restrictions for operating under the license, (2) accept the period of suspension of the licensed privileges within the Board's parameters, (3) pay a civil penalty in lieu of the period of suspension, or any portion of the suspension as applicable, or (4) proceed to a hearing.

D. In case of an offense by the holder of a brewery license, the Board may (i) require that such holder pay the costs incurred by the Board in investigating the licensee, (ii) suspend or revoke the on-premises privileges of the brewery, and (iii) impose a civil penalty not to exceed \$25,000 for the first violation, \$50,000 for the second violation, and for the third or any subsequent violation, suspend or revoke such license or, in lieu of any suspension or portion thereof, impose a civil penalty not to exceed \$100,000. Such suspension or revocation shall not prohibit the licensee from manufacturing or selling beer manufactured by it to the owners of boats registered under the laws of the United States sailing for ports of call of a foreign country or another state, and to persons outside the Commonwealth.

E. The Board shall, by regulation or written order:

1. Designate those (i) objections to an application or (ii) alleged violations that will proceed to an initial hearing;

2. Designate the violations for which a waiver of a hearing and payment of a civil charge in lieu of suspension may be accepted for a first offense occurring within three years immediately preceding the date of the violation;

3. Provide for a reduction in the length of any suspension and a reduction in the amount of any civil penalty for any retail licensee where the licensee can demonstrate that it provided to its employees alcohol server or seller training certified in advance by the Board;

4. Establish a schedule of penalties for such offenses, prescribing the appropriate suspension of a license and the civil charge acceptable in lieu of such suspension; and

5. Establish a schedule of offenses for which any penalty may be waived upon a showing that the licensee has had no prior violations within five years immediately preceding the date of the violation. No waiver shall be granted by the Board, however, for a licensee's willful and knowing violation of this ~~title subtitle~~ or Board regulations.

§ 4.1-230. Applications for licenses; publication; notice to localities; fees; permits.

A. Every person intending to apply for any license authorized by this chapter shall file with the Board an application on forms provided by the Board and a statement in writing by the applicant swearing and affirming that all of the information contained therein is true.

Applicants for retail licenses for establishments that serve food or are otherwise required to obtain a food establishment permit from the Department of Health or an inspection by the Department of Agriculture and Consumer Services shall provide a copy of such permit, proof of inspection, proof of a pending application for such permit, or proof of a pending request for such inspection. If the applicant provides a copy of such permit, proof of inspection, proof of a pending application for a permit, or proof of a pending request for an inspection, a license may be issued to the applicant. If a license is issued on the basis of a pending application or inspection, such license shall authorize the licensee to purchase alcoholic beverages in accordance with the provisions of this ~~title subtitle~~; however, the licensee shall not sell or serve alcoholic beverages until a permit is issued or an inspection is completed.

B. In addition, each applicant for a license under the provisions of this chapter, except applicants for annual banquet, banquet, tasting, special events, club events, annual mixed beverage banquet, wine and beer shipper's, delivery permit, annual arts venue, or museum licenses issued under the provisions of Chapter 2 (§ 4.1-200 et seq.), or beer or wine importer's licenses, shall post a notice of his application with the Board on the front door of the building, place or room where he proposes to engage in such business for no more than 30 days and not less than 10 days. Such notice shall be of a size and contain such information as required by the Board, including a statement that any objections shall be submitted to the Board not more than 30 days following initial publication of the notice required pursuant to this subsection.

The applicant shall also cause notice to be published at least once a week for two consecutive weeks in a newspaper published in or having a general circulation in the county, city, or town wherein such applicant proposes to engage in such business. Such notice shall contain such information as required by the Board, including a statement that any objections to the issuance of the license be submitted to the Board not later than 30 days from the date of the initial newspaper publication. In the case of wine and beer shipper's licensees, delivery permittees or operators of boats, dining cars, buffet cars, club cars, buses, and airplanes, the posting and publishing of notice shall not be required.

Except for applicants for annual banquet, banquet, tasting, mixed beverage special events, club events, annual mixed beverage banquet, wine and beer shipper's, beer or wine importer's, annual arts venue, or museum licenses, the Board shall conduct a background investigation, to include a criminal history records search, which may include a fingerprint-based national criminal history records search, on each applicant for a license. However, the Board may waive, for good cause shown, the requirement for a criminal history records search and completed personal data form for officers, directors, nonmanaging members, or limited partners of any applicant corporation, limited liability company, or limited partnership.

Except for applicants for wine and beer shipper's licenses and delivery permits, the Board shall notify the local governing body of each license application through the county or city attorney or the chief law-enforcement or administrative officer of the locality. Local governing bodies shall submit objections to the granting of a license within 30 days of the filing of the application.

C. Each applicant shall pay the required application fee at the time the application is filed. Each license application fee, including annual banquet and annual mixed beverage banquet, shall be \$195, plus the actual cost charged to the Department of State Police by the Federal Bureau of Investigation or the Central Criminal Records Exchange for processing any fingerprints through the Federal Bureau of Investigation or the Central Criminal Records Exchange for each criminal history records search required by the Board, except for banquet, tasting, or mixed beverage club events licenses, in which case the application fee shall be \$15. The application fee for banquet special event and mixed beverage special event licenses shall be \$45. Application fees shall be in addition to the state license fee required pursuant to § 4.1-231.1 and shall not be refunded.

D. Subsection A shall not apply to the continuance of licenses granted under this chapter; however, all licensees shall file and maintain with the Board a current, accurate record of the information required by the Board pursuant to subsection A and notify the Board of any changes to such information in accordance with Board regulations.

E. Every application for a permit granted pursuant to § 4.1-212 shall be on a form provided by the Board. Such permits shall confer upon their holders no authority to make solicitations in the Commonwealth as otherwise provided by law.

The fee for a temporary permit shall be one-twelfth of the combined fees required by this section for applicable licenses to sell wine, beer, or mixed beverages computed to the nearest cent and multiplied by the number of months for which the permit is granted.

F. The Board shall have the authority to increase state license fees from the amounts set forth in § 4.1-231.1 as it was in effect on January 1, 2022. The Board shall set the amount of such increases on the basis of the consumer price index and shall not increase fees more than once every three years. Prior to implementing any state license fee increase, the Board shall provide notice to all licensees and the general public of (i) the Board's intent to impose a fee increase and (ii) the new fee that would be required for any license affected by the Board's proposed fee increases. Such notice shall be provided on or before November 1 in any year in which the Board has decided to increase state license fees, and such increases shall become effective July 1 of the following year.

§ 4.1-240. Collection of taxes and fees; service charge; storage of credit card, debit card, and automated clearinghouse information.

A. The Board may accept payment by any commercially acceptable means, including checks, credit cards, debit cards, and electronic funds transfers, for the taxes, penalties, or other fees imposed on a licensee in accordance with this ~~title~~ subtitle. In addition, the Board may assess a service charge for the use of a credit or debit card. The service charge shall not exceed the amount negotiated and agreed to in

4488 a contract with the Department.

4489 B. Upon the request of a license applicant or licensee, the Board may collect and maintain a record
4490 of the applicant's or licensee's credit card, debit card, or automated clearinghouse transfer information
4491 and use such information for future payments of taxes, penalties, other fees, or amounts due for products
4492 purchased from the Board. The Board may assess a service charge as provided in subsection A for any
4493 payments made under this subsection. The Board may procure the services of a third-party vendor for
4494 the secure storage of information collected pursuant to this subsection.

4495 **§ 4.1-300. Illegal manufacture and bottling; penalty.**

4496 A. Except as otherwise provided in §§ 4.1-200 and 4.1-201, no person shall manufacture alcoholic
4497 beverages in the Commonwealth without being licensed under this ~~title~~ *subtitle* to manufacture such
4498 alcoholic beverages. Nor shall any person, other than a brewery licensee or bottler's licensee, bottle beer
4499 for sale.

4500 B. The presence of mash at an unlicensed distillery shall constitute manufacturing within the meaning
4501 of this section.

4502 C. Any person convicted of a violation of this section shall be guilty of a Class 6 felony.

4503 **§ 4.1-302. Illegal sale of alcoholic beverages in general; penalty.**

4504 If any person who is not licensed sells any alcoholic beverages except as permitted by this ~~title~~
4505 *subtitle*, he shall be guilty of a Class 1 misdemeanor.

4506 In the event of a second or subsequent conviction under this section, a jail sentence of no less than
4507 ~~thirty~~ 30 days shall be imposed and in no case be suspended.

4508 **§ 4.1-303. Purchase of alcoholic beverages from person not authorized to sell; penalty.**

4509 If any person buys alcoholic beverages from any person other than the Board, a government store or
4510 a person authorized under this ~~title~~ *subtitle* to sell alcoholic beverages, he shall be guilty of a Class 1
4511 misdemeanor.

4512 **§ 4.1-310. Illegal importation, shipment and transportation of alcoholic beverages; penalty;**
4513 **exception.**

4514 A. No alcoholic beverages, other than wine or beer, shall be imported, shipped, transported, or
4515 brought into the Commonwealth, other than to distillery licensees or winery licensees, unless consigned
4516 to the Board. However, the Board may permit such alcoholic beverages ordered by it from outside the
4517 Commonwealth for (i) persons, for industrial purposes, (ii) the manufacture of articles allowed to be
4518 manufactured under § 4.1-200, or (iii) hospitals, to be shipped or transported directly to such persons.
4519 On such orders or shipments of alcohol, the Board shall charge only a reasonable permit fee.

4520 B. Except as otherwise provided in subsection F of § 4.1-206.3 or § 4.1-209.1 or 4.1-212.1, no wine
4521 shall be imported, shipped, transported or brought into the Commonwealth unless it is consigned to a
4522 wholesale wine licensee.

4523 C. Except as otherwise provided in subsection F of § 4.1-206.3 or § 4.1-209.1 or 4.1-212.1, no beer
4524 shall be imported, shipped, transported or brought into the Commonwealth except to persons licensed to
4525 sell it.

4526 D. Any person convicted of a violation of this section shall be guilty of a Class 1 misdemeanor.

4527 E. The provisions of this chapter shall not prohibit (i) any person from bringing, in his personal
4528 possession, or through United States Customs in his accompanying baggage, into the Commonwealth not
4529 for resale, alcoholic beverages in an amount not to exceed one gallon or four liters if any part of the
4530 alcoholic beverages being transported is held in metric-sized containers, (ii) the shipment or
4531 transportation into the Commonwealth of a reasonable quantity of alcoholic beverages not for resale in
4532 the personal or household effects of a person relocating his place of residence to the Commonwealth, or
4533 (iii) the possession or storage of alcoholic beverages on passenger boats, dining cars, buffet cars and
4534 club cars, licensed under this ~~title~~ *subtitle*, or common carriers engaged in interstate or foreign
4535 commerce.

4536 **§ 4.1-310.1. Delivery of wine or beer to retail licensee.**

4537 Except as otherwise provided in this ~~title~~ *subtitle* or in Board regulation, no wine or beer may be
4538 shipped or delivered to a retail licensee for resale unless such wine or beer has first been (i) delivered to
4539 the licensed premises of a wine or beer wholesaler and unloaded, (ii) kept on the licensed premises of
4540 the wholesaler for not less than four hours prior to reloading on a vehicle, and (iii) recorded in the
4541 wholesaler's inventory. Any holder of a restricted wholesale wine license issued pursuant to subdivision
4542 3 of § 4.1-206.2 shall be exempt from the requirement set forth in clause (ii).

4543 **§ 4.1-320. Illegal advertising; penalty; exception.**

4544 A. Except in accordance with this ~~title~~ *subtitle* and Board regulations, no person shall advertise in or
4545 send any advertising matter into the Commonwealth about or concerning alcoholic beverages other than
4546 those which may legally be manufactured or sold without a license.

4547 B. Manufacturers, wholesalers, and retailers may engage in the display of outdoor alcoholic beverage
4548 advertising on lawfully erected signs provided such display is done in accordance with § 4.1-112.2 and
4549 Board regulations.

C. Except as provided in subsection D, any person convicted of a violation of this section shall be guilty of a Class 1 misdemeanor.

D. For violations of § 4.1-112.2 relating to distance and zoning restrictions on outdoor advertising, the Board shall give the advertiser written notice to take corrective action to either bring the advertisement into compliance with this ~~title~~ subtitle and Board regulations or to remove such advertisement. If corrective action is not taken within 30 days, the advertiser shall be guilty of a Class 4 misdemeanor.

E. Neither this section nor any Board regulation shall prohibit (i) the awarding of watches of a wholesale value of less than \$100 by a licensed distillery, winery or brewery, to participants in athletic contests; (ii) the exhibition or display of automobiles, boats, or aircraft regularly and normally used in racing or other competitive events and the sponsorship of an automobile, boat or aircraft racing team by a licensed distillery, winery or brewery and the display on the automobile, boat or aircraft and uniforms of the members of the racing team, the trademark or brand name of an alcoholic beverage manufactured by such distillery, winery or brewery; (iii) the sponsorship of a professional athletic event, including, but not limited to, golf, auto racing or tennis, by a licensed distillery, winery or brewery or the use of any trademark or brand name of any alcoholic beverage in connection with such sponsorship; (iv) the advertisement of beer by the display of such product's name on any airship, which advertising is paid for by the manufacturer of such product; (v) the advertisement of beer or any alcoholic beverage by the display of such product's name on any scale model, reproduction or replica of any motor vehicle, aircraft or watercraft offered for sale; (vi) the placement of billboard advertising within stadia, coliseums, or racetracks that are used primarily for professional or semiprofessional athletic or sporting events; or (vii) the sponsorship of an entertainment or cultural event.

§ 4.1-323. Attempts; aiding or abetting; penalty.

No person shall attempt to do any of the things prohibited by this ~~title~~ subtitle or to aid or abet another in doing, or attempting to do, any of the things prohibited by this ~~title~~ subtitle.

On an indictment, information or warrant for the violation of this ~~title~~ subtitle, the jury or the court may find the defendant guilty of an attempt, or being an accessory, and the punishment shall be the same as if the defendant were solely guilty of such violation.

§ 4.1-324. Illegal sale or keeping of alcoholic beverages by licensees; penalty.

A. No licensee or any agent or employee of such licensee shall:

1. Sell any alcoholic beverages of a kind other than that which such license or this ~~title~~ subtitle authorizes him to sell;

2. Sell beer to which wine, spirits or alcohol has been added, except that a mixed beverage licensee may combine wine or spirits, or both, with beer pursuant to a patron's order;

3. Sell wine to which spirits or alcohol, or both, have been added, otherwise than as required in the manufacture thereof under Board regulations, except that a mixed beverage licensee may (i) make sangria that contains brandy, triple sec, or other similar spirits and (ii) combine beer or spirits, or both, with wine pursuant to a patron's order;

4. Sell alcoholic beverages of a kind which such license or this ~~title~~ subtitle authorizes him to sell, but to any person other than to those to whom such license or this ~~title~~ subtitle authorizes him to sell;

5. Sell alcoholic beverages which such license or this ~~title~~ subtitle authorizes him to sell, but in any place or in any manner other than such license or this ~~title~~ subtitle authorizes him to sell;

6. Sell any alcoholic beverages when forbidden by this ~~title~~ subtitle;

7. Keep or allow to be kept, other than in his residence and for his personal use, any alcoholic beverages other than that which he is authorized to sell by such license or by this ~~title~~ subtitle;

8. Sell any beer to a retail licensee, except for cash, if the seller holds a brewery, bottler's or wholesale beer license;

9. Sell any beer on draft and fail to display to customers the brand of beer sold or misrepresent the brand of any beer sold;

10. Sell any wine for delivery within the Commonwealth to a retail licensee, except for cash, if the seller holds a wholesale wine or farm winery license;

11. Keep or allow to be kept or sell any vaporized form of an alcoholic beverage produced by an alcohol vaporizing device;

12. Keep any alcoholic beverage other than in the bottle or container in which it was purchased by him except: (i) for a frozen alcoholic beverage; and (ii) in the case of wine, in containers of a type approved by the Board pending automatic dispensing and sale of such wine; or

13. Establish any normal or customary pricing of its alcoholic beverages that is intended as a shift or device to evade any "happy hour" regulations adopted by the Board; however, a licensee may increase the volume of an alcoholic beverage sold to a customer if there is a commensurate increase in the normal or customary price charged for the same alcoholic beverage.

B. Any person convicted of a violation of this section shall be guilty of a Class 1 misdemeanor.

C. Neither this section nor any Board regulation shall prohibit an on-premises restaurant licensee from using alcoholic beverages that the licensee otherwise is authorized to purchase and possess for the purposes of preparing and selling for on-premises consumption food products with a final alcohol content of more than one-half of one percent by volume, as long as such food products are sold to and consumed by persons who are 21 years of age or older.

§ 4.1-325. Prohibited acts by mixed beverage licensees; penalty.

A. In addition to § 4.1-324, no mixed beverage licensee nor any agent or employee of such licensee shall:

1. Sell or serve any alcoholic beverage other than as authorized by law;
 2. Sell any authorized alcoholic beverage to any person or at any place except as authorized by law;
 3. Allow at the place described in his license the consumption of alcoholic beverages in violation of this title subtitle;
 4. Keep at the place described in his license any alcoholic beverage other than that which he is licensed to sell;
 5. Misrepresent the brand of any alcoholic beverage sold or offered for sale;
 6. Keep any alcoholic beverage other than in the bottle or container in which it was purchased by him except (i) for a frozen alcoholic beverage, which may include alcoholic beverages in a frozen drink dispenser of a type approved by the Board; (ii) in the case of wine, in containers of a type approved by the Board pending automatic dispensing and sale of such wine; and (iii) as otherwise provided by Board regulation. Neither this subdivision nor any Board regulation shall prohibit any mixed beverage licensee from premixing containers of sangria, to which spirits may be added, to be served and sold for consumption on the licensed premises;
 7. Refill or partly refill any bottle or container of alcoholic beverage or dilute or otherwise tamper with the contents of any bottle or container of alcoholic beverage, except as provided by Board regulation adopted pursuant to subdivision B 11 of § 4.1-111;
 8. Sell or serve any brand of alcoholic beverage which is not the same as that ordered by the purchaser without first advising such purchaser of the difference;
 9. Remove or obliterate any label, mark, or stamp affixed to any container of alcoholic beverages offered for sale;
 10. Deliver or sell the contents of any container if the label, mark, or stamp has been removed or obliterated;
 11. Allow any obscene conduct, language, literature, pictures, performance, or materials on the licensed premises;
 12. Allow any striptease act on the licensed premises;
 13. Allow persons connected with the licensed business to appear nude or partially nude;
 14. Consume or allow the consumption by an employee of any alcoholic beverages while on duty and in a position that is involved in the selling or serving of alcoholic beverages to customers.
- The provisions of this subdivision shall not prohibit any retail licensee or his designated employee from (i) consuming product samples or sample servings of (a) beer or wine provided by a representative of a licensed beer or wine wholesaler or manufacturer or (b) a distilled spirit provided by a permittee of the Board who represents a distiller, if such samples are provided in accordance with Board regulations and the retail licensee or his designated employee does not violate the provisions of subdivision 1 f of § 4.1-225 or (ii) tasting an alcoholic beverage that has been or will be delivered to a customer for quality control purposes;
15. Deliver to a consumer an original bottle of an alcoholic beverage purchased under such license whether the closure is broken or unbroken except in accordance with § 4.1-206.3.
- The provisions of this subdivision shall not apply to the delivery of:
- a. "Soju." For the purposes of this subdivision, "soju" means a traditional Korean alcoholic beverage distilled from rice, barley or sweet potatoes; or
 - b. Spirits, provided (i) the original container is no larger than 375 milliliters, (ii) the alcohol content is no greater than 15 percent by volume, and (iii) the contents of the container are carbonated and perishable;
 16. Be intoxicated while on duty or employ an intoxicated person on the licensed premises;
 17. Conceal any sale or consumption of any alcoholic beverages;
 18. Fail or refuse to make samples of any alcoholic beverages available to the Board upon request or obstruct special agents of the Board in the discharge of their duties;
 19. Store alcoholic beverages purchased under the license in any unauthorized place or remove any such alcoholic beverages from the premises;
 20. Knowingly employ in the licensed business any person who has the general reputation as a prostitute, panderer, habitual law violator, person of ill repute, user or peddler of narcotics, or person who drinks to excess or engages in illegal gambling;
 21. Keep on the licensed premises a slot machine or any prohibited gambling or gaming device,

machine or apparatus;

22. Make any gift of an alcoholic beverage, other than as a gift made (i) to a personal friend, as a matter of normal social intercourse, so long as the gift is in no way a shift or device to evade the restriction set forth in this subdivision; (ii) to a person responsible for the planning, preparation or conduct on any conference, convention, trade show or event held or to be held on the premises of the licensee, when such gift is made in the course of usual and customary business entertainment and is in no way a shift or device to evade the restriction set forth in this subdivision; (iii) pursuant to subsection B of § 4.1-209; (iv) pursuant to subdivision A 10 of § 4.1-201; or (v) pursuant to any Board regulation. Any gift permitted by this subdivision shall be subject to the taxes imposed by this ~~title~~ *subtitle* on sales of alcoholic beverages. The licensee shall keep complete and accurate records of gifts given in accordance with this subdivision; or

23. Establish any normal or customary pricing of its alcoholic beverages that is intended as a shift or device to evade any "happy hour" regulations adopted by the Board; however, a licensee may increase the volume of an alcoholic beverage sold to a customer if there is a commensurate increase in the normal or customary price charged for the same alcoholic beverage.

B. Any person convicted of a violation of this section shall be guilty of a Class 1 misdemeanor.

C. The provisions of subdivisions A 12 and A 13 shall not apply to persons operating theaters, concert halls, art centers, museums, or similar establishments that are devoted primarily to the arts or theatrical performances, when the performances that are presented are expressing matters of serious literary, artistic, scientific, or political value.

§ 4.1-325.2. Prohibited acts by employees of wine or beer licensees; penalty.

A. In addition to the provisions of § 4.1-324, no retail wine or beer licensee or his agent or employee shall consume any alcoholic beverages while on duty and in a position that is involved in the selling or serving of alcoholic beverages to customers.

The provisions of this subsection shall not prohibit any retail licensee or his designated employee from (i) consuming product samples or sample servings of beer or wine provided by a representative of a licensed beer or wine wholesaler or manufacturer, if such samples are provided in accordance with Board regulations and the retail licensee or his designated employee does not violate the provisions of subdivision 1 f of § 4.1-225 or (ii) tasting an alcoholic beverage that has been or will be delivered to a customer for quality control purposes.

B. For the purposes of subsection A, a wine or beer wholesaler or farm winery licensee or its employees that participate in a wine or beer tasting sponsored by a retail wine or beer licensee shall not be deemed to be agents of the retail wine or beer licensee.

C. No retail wine or beer licensee, or his agent or employee shall make any gift of an alcoholic beverage, other than as a gift made (i) to a personal friend, as a matter of normal social intercourse, so long as the gift is in no way a shift or device to evade the restriction set forth in this subsection; (ii) to a person responsible for the planning, preparation or conduct on any conference, convention, trade show or event held or to be held on the premises of the licensee, when such gift is made in the course of usual and customary business entertainment and is in no way a shift or device to evade the restriction set forth in this subsection; (iii) pursuant to subsection B of § 4.1-209; (iv) pursuant to subdivision A 10 of § 4.1-201; or (v) pursuant to any Board regulation. Any gift permitted by this subsection shall be subject to the taxes imposed by this ~~title~~ *subtitle* on sales of alcoholic beverages. The licensee shall keep complete and accurate records of gifts given in accordance with this subsection.

D. Any person convicted of a violation of this section shall be subject to a civil penalty in an amount not to exceed \$500.

§ 4.1-329. Illegal advertising materials; penalty.

No person subject to the jurisdiction of the Board shall induce, attempt to induce, or consent to, any manufacturer, as defined in § 4.1-216.1, or any wholesale licensee selling, renting, lending, buying for or giving to any person any advertising materials or decorations under circumstances prohibited by this ~~title~~ *subtitle* or Board regulations.

Any person found by the Board to have violated this section shall be subject to a civil penalty as provided in § 4.1-227.

§ 4.1-336. Contraband beverages and other articles subject to forfeiture.

All stills and distilling apparatus and materials for the manufacture of alcoholic beverages, all alcoholic beverages and materials used in their manufacture, all containers in which alcoholic beverages may be found, which are kept, stored, possessed, or in any manner used in violation of the provisions of this ~~title~~ *subtitle*, and any dangerous weapons as described in § 18.2-308, which may be used, or which may be found upon the person or in any vehicle which such person is using, to aid such person in the unlawful manufacture, transportation or sale of alcoholic beverages, or found in the possession of such person, or any horse, mule or other beast of burden, any wagon, automobile, truck or vehicle of any nature whatsoever which is found in the immediate vicinity of any place where alcoholic beverages are

being unlawfully manufactured and which such animal or vehicle is being used to aid in the unlawful manufacture, shall be deemed contraband and shall be forfeited to the Commonwealth.

Proceedings for the confiscation of the above property shall be in accordance with § 4.1-338 for all such property except motor vehicles which proceedings shall be in accordance with Chapter 22.1 (§ 19.2-386.1 et seq.) of Title 19.2.

§ 4.1-337. Search warrants.

A. If complaint on oath is made that alcoholic beverages are being manufactured, sold, kept, stored, or in any manner held, used or concealed in a particular house, or other place, in violation of law, the judge, magistrate, or other person having authority to issue criminal warrants, to whom such complaint is made, if satisfied that there is a probable cause for such belief, shall issue a warrant to search such house or other place for alcoholic beverages. Such warrants, except as herein otherwise provided, shall be issued, directed and executed in accordance with the laws of the Commonwealth pertaining to search warrants.

B. Warrants issued under this ~~title~~ subtitle for the search of any automobile, boat, conveyance or vehicle, whether of like kind or not, or for the search of any article of baggage, whether of like kind or not, for alcoholic beverages, may be executed in any part of the Commonwealth where they are overtaken and shall be made returnable before any judge within whose jurisdiction such automobile, boat, conveyance, vehicle, truck, or article of baggage, or any of them, was transported or attempted to be transported contrary to law.

§ 4.1-338. Confiscation proceedings; disposition of forfeited articles.

A. All proceedings for the confiscation of articles, except motor vehicles, declared contraband and forfeited to the Commonwealth under this chapter shall be as provided in this section.

B. Production of seized property. — Whenever any article declared contraband under the provisions of this ~~title~~ subtitle and required to be forfeited to the Commonwealth has been seized, with or without a warrant, by any officer charged with the enforcement of this ~~title~~ subtitle, he shall produce the contraband article and any person in whose possession it was found. In those cases where no person is found in possession of such articles the return shall so state and a copy of the warrant shall be posted on the door of the buildings or room where the articles were found, or if there is no door, then in any conspicuous place upon the premises.

In case of seizure of a still, doubler, worm, worm tub, mash tub, fermenting tub, or other distilling apparatus, for any offense involving their forfeiture, where it is impracticable to remove such distilling apparatus to a place of safe storage from the place where seized, the seizing officer may destroy such apparatus only as necessary to prevent use of all or any part thereof for the purpose of distilling. The destruction shall be in the presence of at least one credible witness, and such witness shall join the officer in a sworn report of the seizure and destruction, to be made to the Board. The report shall set forth the grounds of the claim of forfeiture, the reasons for seizure and destruction, an estimate of the fair cash value of the apparatus destroyed, and the materials remaining after such destruction. The report shall include a statement that, from facts within their own knowledge, the seizing officer and witness have no doubt whatever that the distilling apparatus was set up for use, or had been used in the unlawful distillation of spirits, and that it was impracticable to remove such apparatus to a place of safe storage.

In case of seizure of any quantity of mash, or of alcoholic beverages on which the tax imposed by the laws of the United States has not been paid, for any offense involving forfeiture of the same, the seizing officer may destroy them to prevent the use of all or any part thereof for the purpose of unlawful distillation of spirits or any other violation of this ~~title~~ subtitle. The destruction shall be in the presence of at least one credible witness, and such witness shall join the officer in a sworn report of the seizure and destruction, to be made to the Board. The report shall set forth the grounds of the claim of forfeiture, the reasons for seizure and destruction, and a statement that, from facts within their own knowledge, the seizing officer and witness have no doubt whatever that the mash was intended for use in the unlawful distillation of spirits, or that the alcoholic beverages were intended for use in violation of this ~~title~~ subtitle.

C. Hearing and determination. — Upon the return of the warrant as provided in this section, the court shall fix a time not less than ~~ten~~ 10 days, unless waived by the accused in writing, and not more than ~~thirty~~ 30 days thereafter, for the hearing on such return to determine whether or not the articles seized, or any part thereof, were used or in any manner kept, stored or possessed in violation of this ~~title~~ subtitle.

At such hearing if no claimant appears, the court shall declare the articles seized forfeited to the Commonwealth and, if such articles are not necessary as evidence in any pending prosecution, shall turn them over to the Board. Any person claiming an interest in any of the articles seized may appear at the hearing and file a written claim setting forth particularly the character and extent of his interest. The court shall certify the warrant and the articles seized along with any claim filed to the circuit court to hear and determine the validity of such claim.

If the evidence warrants, the court shall enter a judgment of forfeiture and order the articles seized to be turned over to the Board. Action under this section and the forfeiture of any articles hereunder shall not be a bar to any prosecution under any other provision of this ~~title~~ subtitle.

D. Disposition of forfeited beverages and other articles. — Any articles forfeited to the Commonwealth and turned over to the Board in accordance with this section shall be destroyed or sold by the Board as it deems proper. The net proceeds from such sales shall be paid into the Literary Fund. If the Board believes that any alcoholic beverages forfeited to the Commonwealth and turned over to the Board in accordance with this section cannot be sold and should not be destroyed, it may give such alcoholic beverages for medicinal purposes to any institution in the Commonwealth regularly conducted as a hospital, nursing home or sanatorium for the care of persons in ill health, or as a home devoted exclusively to the care of aged people, to supply the needs of such institution for alcoholic beverages for such purposes, provided that (i) the State Health Commissioner has issued a certificate stating that such institution has need for such alcoholic beverages and (ii) preference is accorded by the Board to institutions supported either in whole or in part by public funds. A record shall be made showing the amount issued in each case, to whom issued and the date when issued, and shall be kept in the offices of the State Health Commissioner and the Board. No charge shall be made to any patient for the alcoholic beverages supplied to him where they have been received from the Board pursuant to this section. Such alcoholic beverages shall be administered only upon approval of the patient's physician.

If the Board believes that any foodstuffs forfeited to the Commonwealth and turned over to the Board in accordance with this section are usable, should not be destroyed and cannot be sold or whose sale would be impractical, it may give such foodstuffs to any institution in the Commonwealth and shall prefer a gift to the local jail or other local correctional facility in the jurisdiction where seizure took place. A record shall be made showing the nature of the foodstuffs and amount given, to whom given and the date when given, and shall be kept in the offices of the Board.

§ 4.1-348. Beverages not licensed under this subtitle.

The provisions of §§ 4.1-339 through 4.1-348 shall not apply to alcoholic beverages ~~which~~ that may be manufactured and sold without any license under the provisions of this ~~title~~ subtitle.

§ 4.1-349. Punishment for violations of subtitle or regulations; bond.

A. Any person convicted of a misdemeanor under the provisions of this ~~title~~ subtitle without specification as to the class of offense or penalty, or convicted of violating any other provision thereof, or convicted of violating any Board regulation, shall be guilty of a Class 1 misdemeanor.

B. In addition to the penalties imposed by this ~~title~~ subtitle for violations, any court before whom any person is convicted of a violation of any provision of this ~~title~~ subtitle may require such defendant to execute bond, with approved security, in the penalty of not more than \$1,000, with the condition that the defendant will not violate any of the provisions of this ~~title~~ subtitle for the term of one year. If any such bond is required and is not given, the defendant shall be committed to jail until it is given, or until he is discharged by the court, provided he shall not be confined for a period longer than six months. If any such bond required by a court is not given during the term of the court by which conviction is had, it may be given before any judge or before the clerk of such court.

C. The provisions of this ~~title~~ subtitle shall not prevent the Board from suspending, revoking or refusing to continue the license of any person convicted of a violation of any provision of this ~~title~~ subtitle.

D. No court shall hear such a case unless the respective attorney for the Commonwealth or his assistant has been notified that such a case is pending.

§ 4.1-350. Witness not excused from testifying because of self-incrimination.

No person shall be excused from testifying for the Commonwealth as to any offense committed by another under this ~~title~~ subtitle by reason of his testimony tending to incriminate him. The testimony given by such person on behalf of the Commonwealth when called as a witness for the prosecution shall not be used against him, and he shall not be prosecuted for the offense to which he testifies.

§ 4.1-351. Previous convictions.

In any indictment, information, or warrant charging any person with a violation of any provision of this ~~title~~ subtitle, it may be alleged and evidence may be introduced at the trial of such person to prove that such person has been previously convicted of a violation of this ~~title~~ subtitle.

§ 4.1-352. Certificate of forensic scientist as evidence; requiring forensic scientist to appear.

The certificate of any forensic scientist employed by the Commonwealth on behalf of the Board or the Department of Forensic Science, when signed by him, shall be *admissible as evidence in all prosecutions for violations of this title and all controversies in any judicial proceedings touching the mixture analyzed by him of the facts therein stated and of the results of such analysis (i) in any criminal proceeding, provided the requirements of subsection A of § 19.2-187.1 have been satisfied and the accused has not objected to the admission of the certificate pursuant to subsection B of § 19.2-187.1 or (ii) in any civil proceeding.* On motion of the accused or any party in interest, the court may require

4857 the forensic scientist making the analysis to appear as a witness and be subject to cross-examination,
4858 provided such motion is made within a reasonable time prior to the day on which the case is set for
4859 trial.

4860 **§ 4.1-353. Label on sealed container prima facie evidence of alcoholic content.**

4861 In any prosecution for violations of this ~~title~~ *subtitle*, where a sealed container is labeled as
4862 containing an alcoholic beverage as defined herein, such labeling shall be prima facie evidence of the
4863 alcoholic content of the container. Nothing shall preclude the introduction of other relevant evidence to
4864 establish the alcoholic content of a container, whether sealed or not.

4865 **§ 4.1-354. No recovery for alcoholic beverages illegally sold.**

4866 No action to recover the price of any alcoholic beverages sold in contravention of this ~~title~~ *subtitle*
4867 may be maintained.

4868 **§ 4.1-600. Definitions.**

4869 As used in this subtitle, unless the context requires a different meaning:

4870 "Advertisement" or "advertising" means any written or verbal statement, illustration, or depiction
4871 that is calculated to induce sales of retail marijuana, retail marijuana products, marijuana plants, ~~or~~
4872 marijuana seeds, *or regulated hemp products*, including any written, printed, graphic, digital, electronic,
4873 or other material, billboard, sign, or other outdoor display, publication, or radio or television broadcast.

4874 "Authority" means the Virginia Cannabis Control Authority created pursuant to this subtitle.

4875 "Board" means the Board of Directors of the Virginia Cannabis Control Authority.

4876 "Cannabis Control Act" means Subtitle II (§ 4.1-600 et seq.).

4877 "*Canopy*" means any area dedicated to live marijuana plant cultivation, including areas in which
4878 plants are grown, propagated, cloned, or maintained. If any such areas are stacked vertically, each level
4879 of space shall be measured and included in the total canopy square footage.

4880 "Child-resistant" means, with respect to packaging or a container, (i) specially designed or
4881 constructed to be significantly difficult for a typical child under five years of age to open and not to be
4882 significantly difficult for a typical adult to open and reseal and (ii) for any product intended for more
4883 than a single use or that contains multiple servings, resealable.

4884 "Cultivation" or "cultivate" means the planting, propagation, growing, harvesting, drying, curing,
4885 grading, trimming, or other similar processing of marijuana for use or sale. "Cultivation" or "cultivate"
4886 does not include manufacturing or testing.

4887 "*Edible hemp product*" means a hemp product intended to be consumed orally that is or contains an
4888 industrial hemp extract.

4889 "Edible marijuana product" means a marijuana product intended to be consumed orally, including
4890 marijuana intended to be consumed orally or marijuana concentrate intended to be consumed orally.

4891 "*Hemp product*" means the same as that term is defined in § 3.2-4112.

4892 "*Hemp product intended for smoking*" means any hemp product intended to be consumed by
4893 inhalation.

4894 "Immature plant" means a nonflowering marijuana plant that is no taller than eight inches and no
4895 wider than eight inches, is produced from a cutting, clipping, or seedling, and is growing in a container.

4896 "*Industrial hemp*" means the same as that term is defined in § 3.2-4112.

4897 "*Industrial hemp extract*" means any phytochemical that has been removed from industrial hemp.
4898 "*Industrial hemp extract*" is not a hemp seed-derived ingredient that is approved by the U.S. Food and
4899 Drug Administration or the subject of a generally recognized as safe notice for which the U.S. Food
4900 and Drug Administration had no questions.

4901 "Licensed" means the holding of a valid license granted by the Authority.

4902 "Licensee" means any person to whom a license has been granted by the Authority.

4903 "Manufacturing" or "manufacture" means the production of marijuana products *or regulated hemp*
4904 *products* or the blending, infusing, compounding, or other preparation of marijuana ~~and~~ marijuana
4905 products, *or regulated hemp products*, including marijuana extraction or preparation by means of
4906 chemical synthesis. "Manufacturing" or "manufacture" does not include cultivation or testing.

4907 "Marijuana" means any part of a plant of the genus *Cannabis*, whether growing or not, its seeds or
4908 resin; and every compound, manufacture, salt, derivative, mixture, or preparation of such plant, its seeds,
4909 its resin, or any extract containing one or more cannabinoids. "Marijuana" does not include the mature
4910 stalks of such plant, fiber produced from such stalk, or oil or cake made from the seed of such plant,
4911 unless such stalks, fiber, oil, or cake is combined with other parts of plants of the genus *Cannabis*.

4912 "Marijuana" does not include (i) industrial hemp, ~~as defined in § 3.2-4112~~, that is possessed by a person
4913 registered pursuant to subsection A of § 3.2-4115 or his agent ~~or~~; (ii) *industrial hemp that is possessed*
4914 *by a person who holds a hemp producer license issued by the U.S. Department of Agriculture pursuant*
4915 *to 7 C.F.R. Part 990*; (iii) a hemp product, ~~as defined in § 3.2-4112~~, *other than a regulated hemp*
4916 *product*, containing a tetrahydrocannabinol concentration of no greater than 0.3 percent that is derived
4917 from industrial hemp, ~~as defined in § 3.2-4112~~, that is grown, dealt, or processed in compliance with
4918 state or federal law; *or (iv) a regulated hemp product that does not exceed the maximum*

4919 *tetrahydrocannabinol concentration established pursuant to § 4.1-606 and that is derived from industrial*
 4920 *hemp that is grown, dealt, or processed in compliance with state or federal law.*

4921 "Marijuana concentrate" means marijuana that has undergone a process to concentrate one or more
 4922 active cannabinoids, thereby increasing the product's potency. Resin from granular trichomes from a
 4923 marijuana plant is a concentrate for purposes of this subtitle.

4924 "Marijuana cultivation facility" means a facility licensed under this subtitle to cultivate, label, and
 4925 package retail marijuana; to purchase or take possession of marijuana plants and seeds from other
 4926 marijuana cultivation facilities; to transfer possession of and sell retail marijuana, immature marijuana
 4927 plants, and marijuana seeds to marijuana wholesalers and retail marijuana stores; to transfer possession
 4928 of and sell retail marijuana, marijuana plants, and marijuana seeds to other marijuana cultivation
 4929 facilities; to transfer possession of and sell retail marijuana to marijuana manufacturing facilities; and to
 4930 sell immature marijuana plants and marijuana seeds to consumers for the purpose of cultivating
 4931 marijuana at home for personal use.

4932 "Marijuana establishment" means a marijuana cultivation facility, a marijuana testing facility, a
 4933 marijuana manufacturing facility, a marijuana wholesaler, or a retail marijuana store.

4934 "Marijuana manufacturing facility" means a facility licensed under this subtitle to manufacture, label,
 4935 and package retail marijuana and retail marijuana products; to purchase or take possession of retail
 4936 marijuana from a marijuana cultivation facility or another marijuana manufacturing facility; and to
 4937 transfer possession of and sell retail marijuana and retail marijuana products to marijuana wholesalers,
 4938 retail marijuana stores, or other marijuana manufacturing facilities.

4939 "Marijuana paraphernalia" means all equipment, products, and materials of any kind that are either
 4940 designed for use or are intended for use in planting, propagating, cultivating, growing, harvesting,
 4941 manufacturing, compounding, converting, producing, processing, preparing, strength testing, analyzing,
 4942 packaging, repackaging, storing, containing, concealing, ingesting, inhaling, or otherwise introducing into
 4943 the human body marijuana.

4944 "Marijuana products" means (i) products that are composed of marijuana and other ingredients and
 4945 are intended for use or consumption, ointments, and tinctures or (ii) marijuana concentrate.

4946 "Marijuana testing facility" means a facility licensed under this subtitle to develop, research, or test
 4947 marijuana, marijuana products, *regulated hemp products*, and other substances.

4948 "Marijuana wholesaler" means a facility licensed under this subtitle to purchase or take possession of
 4949 retail marijuana, retail marijuana products, immature marijuana plants, and marijuana seeds from a
 4950 marijuana cultivation facility, a marijuana manufacturing facility, or another marijuana wholesaler and to
 4951 transfer possession and sell or resell retail marijuana, retail marijuana products, immature marijuana
 4952 plants, and marijuana seeds to a marijuana cultivation facility, marijuana manufacturing facility, retail
 4953 marijuana store, or another marijuana wholesaler.

4954 "Non-retail marijuana" means marijuana that is not cultivated, manufactured, or sold by a licensed
 4955 marijuana establishment.

4956 "Non-retail marijuana products" means marijuana products that are not manufactured and sold by a
 4957 licensed marijuana establishment.

4958 "Place or premises" means the real estate, together with any buildings or other improvements thereon,
 4959 designated in the application for a license as the place at which the cultivation, manufacture, sale, or
 4960 testing of retail marijuana or retail marijuana products shall be performed, except that portion of any
 4961 such building or other improvement actually and exclusively used as a private residence.

4962 "Public place" means any place, building, or conveyance to which the public has, or is permitted to
 4963 have, access, including restaurants, soda fountains, hotel dining areas, lobbies and corridors of hotels,
 4964 and any park, place of public resort or amusement, highway, street, lane, or sidewalk adjoining any
 4965 highway, street, or lane.

4966 "*Regulated hemp product*" means a hemp product intended for smoking or edible hemp products.

4967 "Residence" means any building or part of a building or structure where a person resides, but does
 4968 not include any part of a building that is not actually and exclusively used as a private residence, nor
 4969 any part of a hotel or club other than a private guest room thereof.

4970 "Retail marijuana" means marijuana that is cultivated, manufactured, or sold by a licensed marijuana
 4971 establishment.

4972 "Retail marijuana products" means marijuana products that are manufactured and sold by a licensed
 4973 marijuana establishment.

4974 "Retail marijuana store" means a facility licensed under this subtitle to purchase or take possession of
 4975 retail marijuana, retail marijuana products, immature marijuana plants, or marijuana seeds from a
 4976 marijuana cultivation facility, marijuana manufacturing facility, or marijuana wholesaler and to sell retail
 4977 marijuana, retail marijuana products, immature marijuana plants, or marijuana seeds to consumers.

4978 "Sale" and "sell" includes soliciting or receiving an order for; keeping, offering, or exposing for sale;
 4979 peddling, exchanging, or bartering; or delivering otherwise than gratuitously, by any means, retail

4980 marijuana ~~or~~, retail marijuana products, *or regulated hemp products*.

4981 "Special agent" means an employee of the Virginia Cannabis Control Authority whom the Board has
4982 designated as a law-enforcement officer pursuant to this subtitle.

4983 "Testing" or "test" means the research and analysis of marijuana, marijuana products, *regulated hemp*
4984 *products*, or other substances for contaminants, safety, or potency. "Testing" or "test" does not include
4985 cultivation or manufacturing.

4986 **§ 4.1-601. Virginia Cannabis Control Authority created; public purpose.**

4987 A. The General Assembly has determined that there exists in the Commonwealth a need to control
4988 the possession, sale, transportation, distribution, and delivery of retail marijuana ~~and~~, retail marijuana
4989 products, *and regulated hemp products* in the Commonwealth. Further, the General Assembly determines
4990 that the creation of an authority for this purpose is in the public interest, serves a public purpose, and
4991 will promote the health, safety, welfare, convenience, and prosperity of the people of the
4992 Commonwealth. To achieve this objective, there is hereby created an independent political subdivision
4993 of the Commonwealth, exclusive of the legislative, executive, or judicial branches of state government,
4994 to be known as the Virginia Cannabis Control Authority. The Authority's exercise of powers and duties
4995 conferred by this subtitle shall be deemed the performance of an essential governmental function and a
4996 matter of public necessity for which public moneys may be spent.

4997 B. The Board of Directors of the Authority is vested with control of the possession, sale,
4998 transportation, distribution, and delivery of retail marijuana ~~and~~, retail marijuana products, *and regulated*
4999 *hemp products* in the Commonwealth, with plenary power to prescribe and enforce regulations and
5000 conditions under which retail marijuana ~~and~~, retail marijuana products, *and regulated hemp products* are
5001 possessed, sold, transported, distributed, and delivered, so as to prevent any corrupt, incompetent,
5002 dishonest, or unprincipled practices and to promote the health, safety, welfare, convenience, and
5003 prosperity of the people of the Commonwealth. The exercise of the powers granted by this subtitle shall
5004 be in all respects for the benefit of the citizens of the Commonwealth and for the promotion of their
5005 safety, health, welfare, and convenience. No part of the assets or net earnings of the Authority shall
5006 inure to the benefit of, or be distributable to, any private individual, except that reasonable compensation
5007 may be paid for services rendered to or for the Authority affecting one or more of its purposes, and
5008 benefits may be conferred that are in conformity with said purposes, and no private individual shall be
5009 entitled to share in the distribution of any of the corporate assets on dissolution of the Authority.

5010 **§ 4.1-603. Cannabis Public Health Advisory Council; purpose; membership; quorum; meetings;**
5011 **compensation and expenses; duties.**

5012 A. The Cannabis Public Health Advisory Council (the Advisory Council) is established as an
5013 advisory council to the Board. The purpose of the Advisory Council is to assess and monitor public
5014 health issues, trends, and impacts related to marijuana and marijuana legalization and make
5015 recommendations regarding health warnings, retail marijuana ~~and~~, retail marijuana products, *and*
5016 *regulated hemp products* safety and product composition, and public health awareness, programming,
5017 and related resource needs.

5018 B. The Advisory Council shall have a total membership of ~~24~~ 24 members that shall consist of ~~14~~ 16
5019 nonlegislative citizen members and ~~seven~~ eight ex officio members. Nonlegislative citizen members of
5020 the Council shall be citizens of the Commonwealth and shall reflect the racial, ethnic, gender, and
5021 geographic diversity of the Commonwealth. Nonlegislative citizen members shall be appointed as
5022 follows: four to be appointed by the Senate Committee on Rules, one of whom shall be a representative
5023 from the Virginia Foundation for Healthy Youth, one of whom shall be a representative from the
5024 Virginia Chapter of the American Academy of Pediatrics, one of whom shall be a representative from
5025 the Medical Society of Virginia, and one of whom shall be a representative from the Virginia
5026 Pharmacists Association; six to be appointed by the Speaker of the House of Delegates, one of whom
5027 shall be a representative from a community services board, one of whom shall be a person or health
5028 care provider with expertise in substance use disorder treatment and recovery, one of whom shall be a
5029 person or health care provider with expertise in substance use disorder prevention, one of whom shall be
5030 a person with experience in disability rights advocacy, one of whom shall be a person with experience
5031 in veterans health care, and one of whom shall be a person with a social or health equity background;
5032 and ~~four~~ six to be appointed by the Governor, subject to confirmation by the General Assembly, one of
5033 whom shall be a representative of a local health district, one of whom shall be a person who is part of
5034 the cannabis industry, one of whom shall be an academic researcher knowledgeable about cannabis, ~~and~~
5035 one of whom shall be a registered medical cannabis patient, *one of whom shall be a person with*
5036 *expertise in marijuana consumer safety, and one of whom shall be a representative of a marijuana*
5037 *testing laboratory that has operated in the Commonwealth for no less than one year.*

5038 The Secretary of Health and Human Resources, *the Director of Diversity, Equity, and Inclusion*, the
5039 Commissioner of Health, the Commissioner of Behavioral Health and Developmental Services, the
5040 Commissioner of Agriculture and Consumer Services, the Director of the Department of Health
5041 Professions, the Director of the Department of Forensic Science, and the Chief Executive Officer of the

Virginia Cannabis Control Authority, or their designees, shall serve ex officio with voting privileges. Ex officio members of the Advisory Council shall serve terms coincident with their terms of office.

After the initial staggering of terms, nonlegislative citizen members shall be appointed for a term of four years. Appointments to fill vacancies, other than by expiration of a term, shall be for the unexpired terms. Vacancies shall be filled in the same manner as the original appointments. All members may be reappointed.

The Advisory Council shall be chaired by the Secretary of Health and Human Resources or his designee. The Advisory Council shall select a vice-chairman from among its membership. A majority of the members shall constitute a quorum. The Advisory Council shall meet at least two times each year and shall meet at the call of the chairman or whenever the majority of the members so request.

The Advisory Council shall have the authority to create subgroups with additional stakeholders, experts, and state agency representatives.

C. Members shall receive no compensation for the performance of their duties but shall be reimbursed for all reasonable and necessary expenses incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825.

D. The Advisory Council shall have the following duties, in addition to duties that may be necessary to fulfill its purpose as described in subsection A:

1. To review multi-agency efforts to support collaboration and a unified approach on public health responses related to marijuana and marijuana legalization in the Commonwealth and to develop recommendations as necessary.

2. To monitor changes in drug use data related to marijuana and marijuana legalization in the Commonwealth and the science and medical information relevant to the potential health risks associated with such drug use, and make appropriate recommendations to the Department of Health and the Board.

3. ~~Submit~~ *To submit* an annual report to the Governor and the General Assembly for publication as a report document as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents and reports. The chairman shall submit to the Governor and the General Assembly an annual executive summary of the interim activity and work of the Advisory Council no later than the first day of each regular session of the General Assembly. The executive summary shall be submitted as a report document as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents and reports and shall be posted on the General Assembly's website.

§ 4.1-604. Powers and duties of the Board.

The Board shall have the following powers and duties:

1. Promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) and § 4.1-606;

2. Control the possession, sale, transportation, and delivery of marijuana ~~and~~ marijuana products, *and regulated hemp products*;

3. Grant, suspend, and revoke licenses for the cultivation, manufacture, distribution, sale, and testing of marijuana ~~and~~ marijuana products, *and regulated hemp products* as provided by law;

4. Determine the nature, form, and capacity of all containers used for holding marijuana products *and regulated hemp products* to be kept or sold and prescribe the form and content of all labels and seals to be placed thereon;

5. Maintain actions to enjoin common nuisances as defined in § 4.1-1113;

6. Establish standards and implement an online course for employees of retail marijuana stores that trains employees on how to educate consumers on the potential risks of marijuana use;

7. Establish a plan to develop and disseminate to retail marijuana store licensees a pamphlet or similar document regarding the potential risks of marijuana use to be prominently displayed and made available to consumers;

8. Establish a position for a Cannabis Social Equity Liaison who shall lead the Cannabis Business Equity and Diversity Support Team and liaise with the Director of Diversity, Equity, and Inclusion on matters related to diversity, equity, and inclusion standards in the marijuana industry;

9. Establish a Cannabis Business Equity and Diversity Support Team, which shall (i) develop requirements for the creation and submission of diversity, equity, and inclusion plans by persons who wish to possess a license in more than one license category pursuant to subsection C of § 4.1-805, which may include a requirement that the licensee participate in social equity apprenticeship plan, and an approval process and requirements for implementation of such plans; (ii) be responsible for conducting an analysis of potential barriers to entry for small, women-owned, and minority-owned businesses and veteran-owned businesses interested in participating in the marijuana industry and recommending strategies to effectively mitigate such potential barriers; (iii) provide assistance with business planning for potential marijuana establishment licensees; (iv) spread awareness of business opportunities related to the marijuana marketplace in areas disproportionately impacted by marijuana

5103 prohibition and enforcement; (v) provide technical assistance in navigating the administrative process to
5104 potential marijuana establishment licensees; and (vi) conduct other outreach initiatives in areas
5105 disproportionately impacted by marijuana prohibition and enforcement as necessary;

5106 10. Establish a position for an individual with professional experience in a health related field who
5107 shall staff the Cannabis Public Health Advisory Council, established pursuant to § 4.1-603, liaise with
5108 the Office of the Secretary of Health and Human Resources and relevant health and human services
5109 agencies and organizations, and perform other duties as needed.

5110 11. Establish and implement a plan, in coordination with the Cannabis Social Equity Liaison and the
5111 Director of Diversity, Equity, and Inclusion to promote and encourage participation in the marijuana
5112 industry by people from communities that have been disproportionately impacted by marijuana
5113 prohibition and enforcement and to positively impact those communities;

5114 12. Sue and be sued, implead and be impleaded, and complain and defend in all courts;

5115 13. Adopt, use, and alter at will a common seal;

5116 14. Fix, alter, charge, and collect rates, rentals, fees, and other charges for the use of property of, the
5117 sale of products of, or services rendered by the Authority at rates to be determined by the Authority for
5118 the purpose of providing for the payment of the expenses of the Authority;

5119 15. Make and enter into all contracts and agreements necessary or incidental to the performance of
5120 its duties, the furtherance of its purposes, and the execution of its powers under this subtitle, including
5121 agreements with any person or federal agency;

5122 16. Employ, at its discretion, consultants, researchers, architects, engineers, accountants, financial
5123 experts, investment bankers, superintendents, managers, and such other employees and special agents as
5124 may be necessary and fix their compensation to be payable from funds made available to the Authority.
5125 Legal services for the Authority shall be provided by the Attorney General in accordance with Chapter 5
5126 (§ 2.2-500 et seq.) of Title 2.2;

5127 17. Receive and accept from any federal or private agency, foundation, corporation, association, or
5128 person grants or other aid to be expended in accomplishing the objectives of the Authority, and receive
5129 and accept from the Commonwealth or any state and any municipality, county, or other political
5130 subdivision thereof or from any other source aid or contributions of either money, property, or other
5131 things of value, to be held, used, and applied only for the purposes for which such grants and
5132 contributions may be made. All federal moneys accepted under this section shall be accepted and
5133 expended by the Authority upon such terms and conditions as are prescribed by the United States and as
5134 are consistent with state law, and all state moneys accepted under this section shall be expended by the
5135 Authority upon such terms and conditions as are prescribed by the Commonwealth;

5136 18. Adopt, alter, and repeal bylaws, rules, and regulations governing the manner in which its
5137 business shall be transacted and the manner in which the powers of the Authority shall be exercised and
5138 its duties performed. The Board may delegate or assign any duty or task to be performed by the
5139 Authority to any officer or employee of the Authority. The Board shall remain responsible for the
5140 performance of any such duties or tasks. Any delegation pursuant to this subdivision shall, where
5141 appropriate, be accompanied by written guidelines for the exercise of the duties or tasks delegated.
5142 Where appropriate, the guidelines shall require that the Board receive summaries of actions taken. Such
5143 delegation or assignment shall not relieve the Board of the responsibility to ensure faithful performance
5144 of the duties and tasks;

5145 19. Conduct or engage in any lawful business, activity, effort, or project consistent with the
5146 Authority's purposes or necessary or convenient to exercise its powers;

5147 20. Develop policies and procedures generally applicable to the procurement of goods, services, and
5148 construction, based upon competitive principles;

5149 21. Develop policies and procedures consistent with Article 4 (§ 2.2-4347 et seq.) of Chapter 43 of
5150 Title 2.2;

5151 22. Acquire, purchase, hold, use, lease, or otherwise dispose of any property, real, personal or mixed,
5152 tangible or intangible, or any interest therein necessary or desirable for carrying out the purposes of the
5153 Authority; lease as lessee any property, real, personal or mixed, tangible or intangible, or any interest
5154 therein, at such annual rental and on such terms and conditions as may be determined by the Board;
5155 lease as lessor to any person any property, real, personal or mixed, tangible or intangible, or any interest
5156 therein, at any time acquired by the Authority, whether wholly or partially completed, at such annual
5157 rental and on such terms and conditions as may be determined by the Board; sell, transfer, or convey
5158 any property, real, personal or mixed, tangible or intangible, or any interest therein, at any time acquired
5159 or held by the Authority on such terms and conditions as may be determined by the Board; and occupy
5160 and improve any land or building required for the purposes of this subtitle;

5161 23. Purchase, lease, or acquire the use of, by any manner, any plant or equipment that may be
5162 considered necessary or useful in carrying into effect the purposes of this subtitle, including rectifying,
5163 blending, and processing plants;

5164 24. Appoint every agent and employee required for its operations, require any or all of them to give

bonds payable to the Commonwealth in such penalty as shall be fixed by the Board, and engage the services of experts and professionals;

25. Hold and conduct hearings, issue subpoenas requiring the attendance of witnesses and the production of records, memoranda, papers, and other documents before the Board or any agent of the Board, and administer oaths and take testimony thereunder. The Board may authorize any Board member or agent of the Board to hold and conduct hearings, issue subpoenas, administer oaths and take testimony thereunder, and decide cases, subject to final decision by the Board, on application of any party aggrieved. The Board may enter into consent agreements and may request and accept from any applicant or licensee a consent agreement in lieu of proceedings on (i) objections to the issuance of a license or (ii) disciplinary action. Any such consent agreement shall include findings of fact and may include an admission or a finding of a violation. A consent agreement shall not be considered a case decision of the Board and shall not be subject to judicial review under the provisions of the Administrative Process Act (§ 2.2-4000 et seq.), but may be considered by the Board in future disciplinary proceedings;

26. Make a reasonable charge for preparing and furnishing statistical information and compilations to persons other than (i) officials, including court and police officials, of the Commonwealth and of its subdivisions if the information requested is for official use and (ii) persons who have a personal or legal interest in obtaining the information requested if such information is not to be used for commercial or trade purposes;

27. Assess and collect civil penalties and civil charges for violations of this subtitle and Board regulations;

28. Review and approve any proposed legislative or regulatory changes suggested by the Chief Executive Officer as the Board deems appropriate;

29. Report quarterly to the Secretary of Public Safety and Homeland Security on the law-enforcement activities undertaken to enforce the provisions of this subtitle;

30. Establish and collect fees for all permits set forth in this subtitle, including fees associated with applications for such permits;

31. Develop and make available on its website guidance documents regarding compliance and safe practices for persons who cultivate marijuana at home for personal use, which shall include information regarding cultivation practices that promote personal and public safety, including child protection, and discourage practices that create a nuisance;

32. Develop and make available on its website a resource that provides information regarding (i) responsible marijuana consumption; (ii) health risks and other dangers associated with marijuana consumption, including inability to operate a motor vehicle and other types of transportation and equipment; and (iii) ancillary effects of marijuana consumption, including ineligibility for certain employment opportunities. The Board shall require that the web address for such resource be included on the label of all retail marijuana and retail marijuana product as provided in § 4.1-1402; and

33. Do all acts necessary or advisable to carry out the purposes of this subtitle.

§ 4.1-606. Regulations of the Board.

A. The Board may promulgate reasonable regulations, not inconsistent with this subtitle or the general laws of the Commonwealth, that it deems necessary to carry out the provisions of this subtitle and to prevent the illegal cultivation, manufacture, sale, and testing of marijuana ~~and~~ marijuana products, *and regulated hemp products*. The Board may amend or repeal such regulations. Such regulations shall be promulgated, amended, or repealed in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) and shall have the effect of law.

B. The Board shall promulgate regulations that:

1. Govern the outdoor cultivation of marijuana by a marijuana cultivation facility licensee, including security requirements to include lighting, physical security, and alarm requirements, provided that such requirements do not prohibit the cultivation of marijuana outdoors or in a greenhouse;

2. Establish requirements for securely transporting marijuana between marijuana establishments;

3. Establish sanitary standards for retail marijuana product *and regulated hemp product* preparation;

4. Establish a testing program for retail marijuana ~~and~~ retail marijuana products, *and regulated hemp products* pursuant to Chapter 14 (§ 4.1-1400 et seq.);

5. Establish an application process for licensure as a marijuana establishment pursuant to this subtitle in a way that, when possible, prevents disparate impacts on historically disadvantaged communities;

6. Establish requirements for health and safety warning labels to be placed on retail marijuana and retail marijuana products to be sold or offered for sale by a licensee to a consumer *and on regulated hemp products to be sold or offered for sale by a person* in accordance with the provisions of this subtitle;

7. Establish a maximum tetrahydrocannabinol level for retail marijuana products, ~~which~~ *and regulated hemp products*. Such tetrahydrocannabinol level for retail marijuana products shall not exceed

5226 (i) five milligrams per serving for edible marijuana products and where practicable an equivalent amount
5227 for other marijuana products or (ii) 50 milligrams per package for edible marijuana products and where
5228 practicable an equivalent amount for other marijuana products. Such regulations may include other
5229 product and dispensing limitations on tetrahydrocannabinol;

5230 8. Establish requirements for the form, content, and retention of all records and accounts by all
5231 licensees *and by any person selling a regulated hemp product*;

5232 9. Provide alternative methods for licensees *and any person selling a regulated hemp product* to
5233 maintain and store business records that are subject to Board inspection, including methods for
5234 Board-approved electronic and offsite storage;

5235 10. Establish (i) criteria by which to evaluate new licensees based on the density of retail marijuana
5236 stores in the community and (ii) metrics that have similarly shown an association with negative
5237 community-level health outcomes or health disparities. In promulgating such regulations, the Board shall
5238 coordinate with the Cannabis Public Health Advisory Council established pursuant to § 4.1-603;

5239 11. Require retail licensees to file an appeal from any hearing decision rendered by a hearing officer
5240 within 30 days of the date the notice of the decision is sent. The notice shall be sent to the licensee at
5241 the address on record with the Board by certified mail, return receipt requested, and by regular mail;

5242 12. Prescribe the schedule of proration for refunded license fees to licensees who qualify pursuant to
5243 subsection C of § 4.1-1002;

5244 13. Establish criteria by which to evaluate social equity license applicants, which shall be an
5245 applicant who has lived or been domiciled for at least 12 months in the Commonwealth and is either (i)
5246 an applicant with at least 66 percent ownership by a person or persons who have been convicted of or
5247 adjudicated delinquent for any misdemeanor violation of *former* § 18.2-248.1, *former* § 18.2-250.1, or
5248 subsection A of § 18.2-265.3 as it relates to marijuana, *including any such violation that was deferred*
5249 *and dismissed*; (ii) an applicant with at least 66 percent ownership by a person or persons who ~~is the~~
5250 ~~parent, child, sibling, or spouse of a person~~ (a) *has a family member* who has been convicted of or
5251 adjudicated delinquent for any misdemeanor violation of *former* § 18.2-248.1, *former* § 18.2-250.1, or
5252 subsection A of § 18.2-265.3 as it relates to marijuana, *including any such violation that was deferred*
5253 *and dismissed, and (b) was a dependent of such family member at the time such offense was committed*
5254 *or was significantly impacted, as determined by the Board, by such conviction, adjudication, or*
5255 *disposition; or (iii) an applicant with at least 66 percent ownership by a person or persons who have*
5256 *meet two or more of the following: (a) resided for at least three of the past five years in a jurisdiction*
5257 *that is determined by the Board after utilizing census tract data made available by the United States*
5258 *Census Bureau to have been disproportionately policed for marijuana crimes; (iv) an applicant with at*
5259 *least 66 percent ownership by a person or persons who have, (b) resided for at least three of the last*
5260 *five years in a jurisdiction determined by the Board after utilizing census tract data made available by*
5261 *the United States Census Bureau to be economically distressed; or (v) an applicant with at least 66*
5262 *percent ownership by a person or persons who, or (c) graduated from a historically black college or*
5263 *university located in the Commonwealth;*

5264 14. For the purposes of establishing criteria by which to evaluate social equity license applicants,
5265 establish standards by which to determine (i) which jurisdictions have been disproportionately policed
5266 for marijuana crimes ~~and~~, (ii) which jurisdictions are economically distressed, *and (iii) whether a person*
5267 *was significantly impacted by a family member's conviction, adjudication of delinquency, or deferred*
5268 *disposition for any misdemeanor violation of former § 18.2-248.1, former § 18.2-250.1, or subsection A*
5269 *of § 18.2-265.3 as it relates to marijuana;*

5270 15. Establish standards and requirements for (i) any preference in the licensing process for qualified
5271 social equity applicants, (ii) what percentage of application or license fees are waived for a qualified
5272 social equity applicant, and (iii) a low-interest business loan program for qualified social equity
5273 applicants;

5274 16. Establish guidelines, in addition to requirements set forth in this subtitle, for the personal
5275 cultivation *and manufacturing* of marijuana that promote personal and public safety, including child
5276 protection, and discourage personal cultivation practices that create a nuisance, including a nuisance
5277 caused by odor;

5278 17. Establish reasonable time, place, and manner restrictions on outdoor advertising of retail
5279 marijuana ~~or~~, retail marijuana products, *or regulated hemp products*, not inconsistent with the provisions
5280 of this chapter, so that such advertising displaces the illicit market and notifies the public of the location
5281 of marijuana establishments. Such regulations shall be promulgated in accordance with § 4.1-1404;

5282 18. Establish restrictions on the number of licenses that a person may be granted to operate a
5283 marijuana establishment in single locality or region; and

5284 19. Establish restrictions on pharmaceutical processors ~~and industrial hemp processors~~ that have been
5285 granted a license in more than one license category pursuant to subsection C of § 4.1-805 that ensure all
5286 licensees have an equal and meaningful opportunity to participate in the market. Such regulations (i)
5287 *shall limit such pharmaceutical processors to a total canopy of 80,000 square feet and (ii) may limit the*

amount of products cultivated or manufactured by the pharmaceutical processor or industrial hemp processor that such processor may offer for sale in its retail marijuana stores.

C. The Board may promulgate regulations that:

1. ~~Limit~~ *Establish classes within any license category or limit* the number of licenses issued by type or class to operate a marijuana establishment; however, ~~the number of licenses issued shall not exceed the following limits:~~

a. ~~Retail marijuana stores, 400;~~

b. ~~Marijuana wholesalers, 25;~~

c. ~~Marijuana manufacturing facilities, 60; and~~

d. ~~Marijuana cultivation facilities, 450~~ *the Board may not issue more than 400 retail marijuana store licenses.*

In determining the number of licenses issued pursuant to this subdivision, the Board shall not consider any license granted pursuant to subsection C of § 4.1-805 to (i) a pharmaceutical processor that has been issued a permit by the Board of Pharmacy pursuant to Article 4.2 (§ 54.1-3442.5 et seq.) of the Drug Control Act or (ii) ~~an industrial hemp processor registered with the Commissioner of Agriculture and Consumer Services pursuant to Chapter 41.1 (§ 3.2-4112 et seq.) of Title 3.2.~~

2. Prescribe any requirements deemed appropriate for the administration of taxes under §§ 4.1-1003 and 4.1-1004, including method of filing a return, information required on a return, and form of payment.

3. Limit the allowable square footage of a retail marijuana store, which shall not exceed 1,500 square feet.

4. Allow certain persons to be granted or have interest in a license in more than one of the following license categories: marijuana cultivation facility license, marijuana manufacturing facility license, marijuana wholesaler license, or retail marijuana store license. Such regulations shall (i) be drawn narrowly to limit vertical integration to small businesses and ensure that all licensees have an equal and meaningful opportunity to participate in the market and (ii) *limit such vertically integrated licensees to a total canopy of 8,000 square feet.*

D. Board regulations shall be uniform in their application, except those relating to hours of sale for licensees.

E. Courts shall take judicial notice of Board regulations.

F. The Board shall consult with the Cannabis Public Health Advisory Council in promulgating any regulations relating to public health, including regulations promulgated pursuant to subdivision B 3, 4, 6, 7, 10, or 16, and shall not promulgate any such regulation that has not been approved by a majority of the members of the Cannabis Public Health Advisory Council.

G. With regard to regulations governing licensees that have been issued a permit by the Board of Pharmacy to operate as a pharmaceutical processor or cannabis dispensing facility pursuant to Article 4.2 (§ 54.1-3442.5 et seq.) of the Drug Control Act, the Board shall make reasonable efforts (i) to align such regulations with any applicable regulations promulgated by the Board of Pharmacy that establish health, safety, and security requirements for pharmaceutical processors and cannabis dispensing facilities and (ii) to deem in compliance with applicable regulations promulgated pursuant to this subtitle such pharmaceutical processors and cannabis dispensing facilities that have been found to be in compliance with regulations promulgated by the Board of Pharmacy that mirror or are more extensive in scope than similar regulations promulgated pursuant to this subtitle.

H. The Board's power to regulate shall be broadly construed.

§ 4.1-611. Seed-to-sale tracking system.

To ensure that no retail marijuana or retail marijuana products grown or processed by a marijuana establishment are sold or otherwise transferred except as authorized by law, the Board shall develop and maintain a seed-to-sale tracking system that tracks *at every stage* retail marijuana from either the seed or immature plant stage until the retail marijuana or retail marijuana product is sold to a customer at a retail marijuana store.

§ 4.1-629. Local referendum on prohibition of marijuana establishments.

A. *The governing body of a locality may, by resolution, petition the circuit court for the locality for a referendum on the question of whether marijuana establishments should be prohibited in the locality.*

Upon the filing of a petition, the circuit court shall order the election officials to conduct a referendum on the question on the date fixed in the order. The date set by the order shall comply with the provisions of § 24.2-682, but in no event shall such date be more than 90 days from the date the order is issued. The clerk of the circuit court shall publish notice of the referendum in a newspaper of general circulation in the locality once a week for three consecutive weeks prior to the referendum.

The question on the ballot shall be:

"Shall the operation of marijuana establishments be prohibited in _____ (name of county, city, or town)?"

The referendum shall be held and the results certified as provided in § 24.2-684. In addition to the certifications required by such section, the secretary of the local electoral board shall certify the results of the referendum to the Board of Directors of the Virginia Cannabis Control Authority and to the governing body of the locality.

B. If a majority of the qualified voters voting in such referendum vote "No" on the question of whether marijuana establishments shall be prohibited in the locality, marijuana establishments shall be permitted to operate within the locality 60 days after the results are certified or on January 1, 2024, whichever is later, and no subsequent referendum may be held pursuant to this section within such locality.

If a majority of the qualified voters voting in such referendum vote "Yes" on the question of whether marijuana establishments shall be prohibited in the locality, marijuana establishments shall be prohibited in the locality effective January 1 of the year immediately following the referendum. A referendum on the same question may be held subsequent to a vote to prohibit marijuana establishments but not earlier than the fourth November following the date of the previous referendum. Any subsequent referendum shall be held pursuant to the provisions of this section.

C. When any referendum is held pursuant to this section in a town, separate and apart from the county in which such town or a part thereof is located, such town shall be treated as being separate and apart from such county. When any referendum is held pursuant to this section in a county, any town located within such county shall be treated as being separate and apart from such county.

D. The legality of any referendum held pursuant to this section shall be subject to the inquiry, determination, and judgment of the circuit court that ordered the referendum. The court shall proceed upon the complaint of 15 or more qualified voters of the county, city, or town, filed within 30 days after the date the results of the referendum are certified and setting out fully the grounds of contest. The complaint and the proceedings shall conform as nearly as practicable to the provisions of § 15.2-1654, and the judgment of the court entered of record shall be a final determination of the legality of the referendum.

§ 4.1-630. Local ordinances or resolutions regulating retail marijuana or retail marijuana products.

A. No county, city, or town shall, except as provided in § 4.1-629, adopt any ordinance or resolution that regulates or prohibits the cultivation, manufacture, possession, sale, wholesale distribution, handling, transportation, consumption, use, advertising, or dispensing of retail marijuana or retail marijuana products in the Commonwealth.

B. However, the governing body of any county, city, or town may adopt an ordinance (i) that prohibits the acts described in § 4.1-1108, or the acts described in § 4.1-1109, and may provide a penalty for violation thereof and (ii) that regulates or prohibits the possession of opened retail marijuana or retail marijuana products containers in its local public parks, playgrounds, public streets, and any sidewalk adjoining any public street.

C. Nothing in this chapter shall be construed to supersede or limit the authority of a locality to adopt and enforce local ordinances to regulate businesses licensed pursuant to this chapter, including local zoning and land use requirements and business license requirements; however, a locality shall not adopt any local ordinance, zoning requirement, land use requirement, or business license requirement that regulates marijuana establishments unless such ordinance or requirement applies with equal force and effect to similarly situated businesses.

D. Except as provided in this section, all local acts, including charter provisions and ordinances of counties, cities, and towns, inconsistent with any of the provisions of this subtitle, are repealed to the extent of such inconsistency.

CHAPTER 7.

ADMINISTRATION OF LICENSES; GENERAL PROVISIONS.

§ 4.1-700. Exemptions from licensure.

The licensure requirements of this subtitle shall not apply to (i) a cannabis dispensing facility or pharmaceutical processor that has been issued a permit by the Board of Pharmacy pursuant to Article 4.2 (§ 54.1-3442.5 et seq.) of the Drug Control Act; (ii) a dealer, grower, or processor of industrial hemp registered with the Commissioner of Agriculture and Consumer Services pursuant to Chapter 41.1 (§ 3.2-4112 et seq.) of Title 3.2; (iii) a manufacturer of an edible hemp product operating in accordance with Article 6 (§ 3.2-5145.6 et seq.) Chapter 51 of Title 3.2; or (iv) a person who cultivates marijuana at home for personal use pursuant to § 4.1-1101. Nothing in this subtitle shall be construed to (a) prevent any person described in clause (i), (ii), or (iii) from obtaining a license pursuant to this subtitle, provided such person satisfies applicable licensing requirements; (b) prevent a licensee from acquiring hemp products from an industrial hemp processor in accordance with the provisions of Chapter 41.1 of Title 3.2; or (c) prevent a cultivation, manufacturing, wholesale, or retail licensee from operating on the licensed premises of a pharmaceutical processing facility in accordance with Article 4.2 of the Drug Control Act or an industrial hemp processing facility in accordance with Chapter 41.1 of Title 3.2.

§ 4.1-701. To whom privileges conferred by licenses extend; liability for violations of law.

The privilege of any licensee to cultivate, manufacture, transport, sell, or test retail marijuana or retail marijuana products shall extend to such licensee and to all agents or employees of such licensee for the purpose of operating under such license. The licensee may be held liable for any violation of this subtitle or any Board regulation committed by such agents or employees in connection with their employment.

§ 4.1-702. Separate license for each place of business; transfer or amendment; posting; expiration; civil penalties.

A. Each license granted by the Board shall designate the place where the business of the licensee will be carried on. A separate license shall be required for each separate place of business.

B. No license shall be transferable from one person to another or from one location to another. The Board may permit a licensee to amend the classification of an existing license without complying with the posting and publishing procedures required by § 4.1-1000 if the effect of the amendment is to reduce materially the privileges of an existing license. However, if (i) the Board determines that the amendment is a device to evade the provisions of this subtitle, (ii) a majority of the corporate stock of a retail marijuana store licensee is sold to a new entity, or (iii) there is a change of business at the premises of a retail marijuana store licensee, the Board may, within 30 days of receipt of written notice by the licensee of a change in ownership or a change of business, require the licensee to comply with any or all of the requirements of § 4.1-1000. If the Board fails to exercise its authority within the 30-day period, the licensee shall not be required to reapply for a license. The licensee shall submit such written notice to the secretary of the Board.

C. Each license shall be posted in a location conspicuous to the public at the place where the licensee carries on the business for which the license is granted.

D. The privileges conferred by any license granted by the Board shall continue until the last day of the twelfth month next ensuing or the last day of the designated month and year of expiration, except the license may be sooner terminated for any cause for which the Board would be entitled to refuse to grant a license or by operation of law, voluntary surrender, or order of the Board.

The Board may grant licenses for one year or for multiple years, not to exceed three years, based on the fees set by the Board pursuant to § 4.1-1001. Qualification for a multiyear license shall be determined on the basis of criteria established by the Board. Fees for multiyear licenses shall not be refundable except as provided in § 4.1-1002. The Board may provide a discount for two-year or three-year licenses, not to exceed five percent of the applicable license fee, which extends for one fiscal year and shall not be altered or rescinded during such period.

E. The Board may permit a licensee who fails to pay:

1. The required license fee covering the continuation or reissuance of his license by midnight of the fifteenth day of the twelfth month or of the designated month of expiration, whichever is applicable, to pay the fee in lieu of posting and publishing notice and reapplying, provided payment of the fee is made within 30 days following that date and is accompanied by a civil penalty of \$25 or 10 percent of such fee, whichever is greater; and

2. The fee and civil penalty pursuant to subdivision 1 to pay the fee in lieu of posting and publishing notice and reapplying, provided payment of the fee is made within 45 days following the 30 days specified in subdivision 1 and is accompanied by a civil penalty of \$100 or 25 percent of such fee, whichever is greater.

Such civil penalties collected by the Board shall be deposited in accordance with § 4.1-614.

§ 4.1-703. Records of licensees; inspection of records and places of business.

A. Every licensed marijuana manufacturing facility or marijuana wholesaler shall keep complete, accurate, and separate records in accordance with Board regulations of all retail marijuana and retail marijuana products it purchased, manufactured, sold, or shipped.

B. Every licensed retail marijuana store shall keep complete, accurate, and separate records in accordance with Board regulations of all purchases of retail marijuana products, the prices charged such licensee therefor, and the names and addresses of the persons from whom purchased. Every licensed retail marijuana store shall also preserve all invoices showing its purchases for a period as specified by Board regulations. The licensee shall also keep an accurate account of daily sales, showing quantities of retail marijuana products sold and the total price charged by it therefor. Except as otherwise provided in subsections D and E, such account need not give the names or addresses of the purchasers thereof, except as may be required by Board regulation.

Notwithstanding the provisions of subsection E, electronic records of licensed retail marijuana stores may be stored off site, provided that such records are readily retrievable and available for electronic inspection by the Board or its special agents at the licensed premises. However, in the case that such electronic records are not readily available for electronic inspection on the licensed premises, the licensee may obtain Board approval, for good cause shown, to permit the licensee to provide the

5472 records to a special agent of the Board within three business days or less, as determined by the Board,
5473 after a request is made to inspect the records.

5474 C. Every licensed marijuana cultivation facility shall keep complete, accurate, and separate records
5475 in accordance with Board regulations of all retail marijuana and retail marijuana products it
5476 purchased, manufactured, sold, or shipped.

5477 D. Every licensed marijuana testing facility shall keep complete, accurate, and separate records in
5478 accordance with Board regulations of all retail marijuana and retail marijuana products it developed,
5479 researched, or tested and the names and addresses of the licensees or persons who submitted the retail
5480 marijuana or retail marijuana product to the marijuana testing facility.

5481 E. The Board and its special agents shall be allowed free access during reasonable hours to every
5482 place in the Commonwealth and to the premises of every licensee or for the purpose of examining and
5483 inspecting such place and all records, invoices, and accounts therein.

5484 For the purposes of a Board inspection of the records of any retail marijuana store licensees,
5485 "reasonable hours" means the hours between 9 a.m. and 5 p.m.; however, if the licensee generally is not
5486 open to the public substantially during the same hours, "reasonable hours" means the business hours
5487 when the licensee is open to the public. At any other time of day, if the retail marijuana store licensee's
5488 records are not available for inspection, the licensee shall provide the records to a special agent of the
5489 Board within 24 hours after a request is made to inspect the records.

5490 CHAPTER 8.

5491 ADMINISTRATION OF LICENSES; LICENSES GRANTED BY BOARD.

5492 § 4.1-800. Marijuana cultivation facility license.

5493 A. The Board may issue marijuana cultivation facility licenses, which shall authorize the licensee to
5494 cultivate, label, and package retail marijuana; to purchase or take possession of marijuana plants and
5495 seeds from other marijuana cultivation facilities; to transfer possession of and sell retail marijuana,
5496 immature marijuana plants, and marijuana seeds to marijuana wholesalers and retail marijuana stores;
5497 to transfer possession of and sell retail marijuana, marijuana plants, and marijuana seeds to other
5498 marijuana cultivation facilities; to transfer possession of and sell retail marijuana to marijuana
5499 manufacturing facilities; and to sell immature marijuana plants and marijuana seeds to consumers for
5500 the purpose of cultivating marijuana at home for personal use.

5501 B. In accordance with the requirements of § 4.1-611, a marijuana cultivation facility licensee shall
5502 track the retail marijuana it cultivates from seed or immature marijuana plant to the point at which the
5503 marijuana plant or the marijuana produced by the marijuana plant is delivered or transferred to a
5504 marijuana testing facility, a marijuana wholesaler, another marijuana cultivation facility, a marijuana
5505 manufacturer, a retail marijuana store, or a consumer or is disposed of or destroyed.

5506 § 4.1-801. Marijuana manufacturing facility license.

5507 A. The Board may issue marijuana manufacturing facility licenses, which shall authorize the licensee
5508 to manufacture, label, and package retail marijuana and retail marijuana products; to purchase or take
5509 possession of retail marijuana from a marijuana cultivation facility or another marijuana manufacturing
5510 facility; and to transfer possession of and sell retail marijuana and retail marijuana products to
5511 marijuana wholesalers, retail marijuana stores, or other marijuana manufacturing facilities.

5512 B. Except as otherwise provided in this subtitle, retail marijuana products shall be prepared on a
5513 licensed premises that is used exclusively for the manufacture and preparation of retail marijuana or
5514 retail marijuana products and using equipment that is used exclusively for the manufacture and
5515 preparation of retail marijuana or retail marijuana products.

5516 C. All areas within the licensed premises of a marijuana manufacturing facility in which retail
5517 marijuana and retail marijuana products are manufactured shall meet all sanitary standards specified in
5518 regulations adopted by the Board. A marijuana manufacturing facility that manufactures an edible
5519 marijuana product shall comply with the requirements of Chapter 51 (§ 3.2-5100 et seq.) of Title 3.2
5520 and any regulations adopted pursuant thereto.

5521 D. In accordance with the requirements of § 4.1-611, a marijuana manufacturing facility licensee
5522 shall track the retail marijuana it uses in its manufacturing processes from the point the retail
5523 marijuana is delivered or transferred to the marijuana manufacturing facility by a marijuana wholesaler
5524 licensee to the point the retail marijuana or retail marijuana products produced using the retail
5525 marijuana are delivered or transferred to another marijuana manufacturing facility, a marijuana testing
5526 facility, or a marijuana wholesaler or are disposed of or destroyed.

5527 § 4.1-802. Marijuana testing facility license.

5528 A. The Board may issue marijuana testing facility licenses, which shall authorize the licensee to
5529 develop, research, or test retail marijuana, retail marijuana products, regulated hemp products, and
5530 other substances.

5531 B. A marijuana testing facility may develop, research, or test retail marijuana and retail marijuana
5532 products for (i) that facility, (ii) another licensee, or (iii) a person who intends to use the retail
5533 marijuana or retail marijuana product for personal use as authorized under § 4.1-1100.

C. Neither this subtitle nor the regulations adopted pursuant to this subtitle shall prevent a marijuana testing facility from developing, researching, or testing substances that are not marijuana, marijuana products, or regulated hemp products for that facility or for another person.

D. To obtain licensure from the Board, a marijuana testing facility shall be required to obtain and maintain accreditation pursuant to standard ISO/IEC 17025 of the International Organization for Standardization by a third-party accrediting body.

E. In accordance with the requirements of § 4.1-611, a marijuana testing facility licensee shall track all retail marijuana and retail marijuana products it receives from a licensee for testing purposes from the point at which the retail marijuana or retail marijuana products are delivered or transferred to the marijuana testing facility to the point at which the retail marijuana or retail marijuana products are disposed of or destroyed.

F. A person that has an interest in a marijuana testing facility license shall not have any interest in a licensed marijuana cultivation facility, a licensed marijuana manufacturing facility, a licensed marijuana wholesaler, or a licensed retail marijuana store.

§ 4.1-803. Marijuana wholesaler license.

A. The Board may issue marijuana wholesaler licenses, which shall authorize the licensee to purchase or take possession of retail marijuana, retail marijuana products, immature marijuana plants, and marijuana seeds from a marijuana cultivation facility, a marijuana manufacturing facility, or another marijuana wholesaler and to transfer possession and sell or resell retail marijuana, retail marijuana products, immature marijuana plants, and marijuana seeds to a marijuana cultivation facility, marijuana manufacturing facility, retail marijuana store, or another marijuana wholesaler.

B. All areas within the licensed premises of a marijuana wholesaler in which retail marijuana and retail marijuana products are stored shall meet all sanitary standards specified in regulations adopted by the Board.

C. In accordance with the requirements of § 4.1-611, a marijuana wholesaler licensee shall track the retail marijuana, retail marijuana products, immature marijuana plants, or marijuana seeds from the point at which the retail marijuana, retail marijuana products, plants, or seeds are delivered or transferred to the marijuana wholesaler to the point at which the retail marijuana, retail marijuana products, plants, or seeds are transferred or sold to a marijuana manufacturer, marijuana wholesaler, retail marijuana store, or marijuana testing facility or are disposed of or destroyed.

§ 4.1-804. Retail marijuana store license.

A. The Board may issue retail marijuana store licenses, which shall authorize the licensee to purchase or take possession of retail marijuana, retail marijuana products, immature marijuana plants, or marijuana seeds from a marijuana cultivation facility, marijuana manufacturing facility, or marijuana wholesaler and to sell retail marijuana, retail marijuana products, immature marijuana plants, or marijuana seeds to consumers on premises approved by the Board.

B. Retail marijuana stores shall be operated in accordance with the following provisions:

1. A person shall be 21 years of age or older to make a purchase in a retail marijuana store.

2. A retail marijuana store shall be permitted to sell retail marijuana, retail marijuana products, immature marijuana plants, or marijuana seeds to consumers only in a direct, face-to-face exchange. Such store shall not be permitted to sell retail marijuana, retail marijuana products, immature marijuana plants, or marijuana seeds using:

a. An automated dispensing or vending machine;

b. A drive-through sales window;

c. An Internet-based sales platform; or

d. A delivery service.

3. A retail marijuana store shall not be permitted to sell more than one ounce of retail marijuana or an equivalent amount of retail marijuana products as determined by regulation promulgated by the Board during a single transaction to one person.

4. A retail marijuana store shall not:

a. Give away any retail marijuana or retail marijuana products, except as otherwise permitted by this subtitle;

b. Sell retail marijuana, retail marijuana products, immature marijuana plants, or marijuana seeds to any person when at the time of such sale he knows or has reason to believe that the person attempting to purchase the retail marijuana, retail marijuana product, immature marijuana plant, or marijuana seeds is intoxicated or is attempting to purchase retail marijuana for someone younger than 21 years of age;

c. Sell retail marijuana, retail marijuana products, immature marijuana plants, or marijuana seeds between the hours of 9:00 p.m. and 8:00 a.m.; or

d. Employ or allow to volunteer any person younger than 21 years of age.

5. In accordance with the requirements of § 4.1-611, a retail marijuana store licensee shall track all

5595 retail marijuana, retail marijuana products, immature marijuana plants, or marijuana seeds from the
5596 point at which the retail marijuana, retail marijuana products, immature marijuana plants, or marijuana
5597 seeds are delivered or transferred to the retail marijuana store to the point at which the retail
5598 marijuana, retail marijuana products, immature marijuana plants, or marijuana seeds are sold to a
5599 consumer, delivered or transferred to a marijuana testing facility, or disposed of or destroyed.

5600 6. A retail marijuana store shall not be subject to the requirements of Chapter 51 (§ 3.2-5100 et
5601 seq.) of Title 3.2.

5602 C. Each retail marijuana store licensee shall post in each retail marijuana store notice of the
5603 existence of a human trafficking hotline to alert possible witnesses or victims of human trafficking to the
5604 availability of a means to report crimes or gain assistance. The notice required by this subsection shall
5605 (i) be posted in a place readily visible and accessible to the public and (ii) meet the requirements
5606 specified in subsection C of § 40.1-11.3.

5607 D. Each retail marijuana store licensee shall prominently display and make available for
5608 dissemination to consumers Board-approved information regarding the potential risks of marijuana use.

5609 E. Each retail marijuana store licensee shall provide training, established by the Board, to all
5610 employees educating them on how to discuss the potential risks of marijuana use with consumers.

5611 F. Any retail marijuana store license granted to a pharmaceutical processor that has been issued a
5612 permit by the Board of Pharmacy pursuant to Article 4.2 (§ 54.1-3442.5 et seq.) of the Drug Control
5613 Act shall authorize the licensee to exercise any privileges set forth in subsection A at the place of
5614 business designated in the license, which, notwithstanding subsection A of § 4.1-702, may include, upon
5615 request by the licensee, up to five additional retail establishments of the licensee. Such additional retail
5616 establishments shall be located at the five cannabis dispensing facilities for which the Board of
5617 Pharmacy has issued a permit pursuant to subsection B of § 54.1-3442.6 in the health service area in
5618 which the pharmaceutical processing facility is located.

5619 **§ 4.1-805. Multiple licenses awarded to one person prohibited.**

5620 A. As used in this section, "interest" means an equity ownership interest or a partial equity
5621 ownership interest or any other type of financial interest, including but not limited to being an investor
5622 or serving in a management position.

5623 B. Except as otherwise permitted by Board regulation promulgated pursuant to subdivision C 4 of
5624 § 4.1-606, no person shall be granted or have interest in a license in more than one of the following
5625 license categories: marijuana cultivation facility license, marijuana manufacturing facility license,
5626 marijuana wholesaler license, retail marijuana store license, or marijuana testing facility license.

5627 C. Notwithstanding subsection B and any other provision of law to the contrary, any pharmaceutical
5628 processor that has been issued a permit by the Board of Pharmacy pursuant to Article 4.2
5629 (§ 54.1-3442.5 et seq.) of the Drug Control Act shall be permitted to possess one or any combination of
5630 the following licenses: marijuana cultivation facility license, marijuana manufacturing facility license,
5631 marijuana wholesaler license, or retail marijuana store license. However, no pharmaceutical processor
5632 that has been issued a marijuana cultivation facility license, marijuana manufacturing facility license,
5633 marijuana wholesaler license, or retail marijuana store license shall be issued a marijuana testing
5634 facility license or have any interest in a marijuana testing facility licensee. Any pharmaceutical
5635 processor that wishes to possess a license in more than one license category pursuant to this subsection
5636 shall (a) pay a \$6 million fee to the Board, unless the processor has already paid a \$6 million fee to
5637 the Board to engage in the lawful sale of cannabis products prior to January 1, 2024, and (b) submit a
5638 diversity, equity, and inclusion plan to the Cannabis Business Equity and Diversity Support Team (the
5639 Support Team) for approval and, upon approval, implement such plan in accordance with the
5640 requirements set by the Support Team. Fees collected by the Board pursuant to this subsection shall be
5641 allocated to (1) the Virginia Cannabis Equity Loan Fund or (2) the Virginia Cannabis Equity
5642 Reinvestment Fund.

5643 **§ 4.1-806. Temporary permits required in certain instances.**

5644 A. The Board may grant a permit that shall authorize any person who purchases at a foreclosure,
5645 secured creditor's, or judicial auction sale the premises or property of a person licensed by the Board
5646 and who has become lawfully entitled to the possession of the licensed premises to continue to operate
5647 the marijuana establishment to the same extent as the license holder for a period not to exceed 60 days
5648 or for such longer period as determined by the Board. Such permit shall be temporary and shall confer
5649 the privileges of any licenses held by the previous owner to the extent determined by the Board. Such
5650 temporary permit may be issued in advance, conditioned on the requirements in this subsection.

5651 B. A temporary permit granted pursuant to subsection A may be revoked summarily by the Board for
5652 any cause set forth in § 4.1-900 without complying with subsection A of § 4.1-903. Revocation of a
5653 temporary permit shall be effective upon service of the order of revocation upon the permittee or upon
5654 the expiration of three business days after the order of the revocation has been mailed to the permittee
5655 at either his residence or the address given for the business in the permit application. No further notice
5656 shall be required.

§ 4.1-807. Licensee shall maintain possession of premises.

As a condition of licensure, a licensee shall at all times maintain possession of the licensed premises of the marijuana establishment that the licensee is licensed to operate, whether pursuant to a lease, rental agreement, or other arrangement for possession of the premises or by virtue of ownership of the premises. If the licensee fails to maintain possession of the licensed premises, the license shall be revoked by the Board.

§ 4.1-808. Use or consumption of marijuana or marijuana products on premises of licensee by licensee, agent, or employee.

No marijuana or marijuana products may be used or consumed on the premises of a licensee by the licensee or any agent or employee of the licensee, except for certain sampling for quality control purposes that may be permitted by Board regulation.

§ 4.1-809. Conditions under which the Board may refuse to grant licenses.

The Board may refuse to grant any license if it has reasonable cause to believe that:

1. The applicant, or if the applicant is a partnership, any general partner thereof, or if the applicant is an association, any member thereof, or a limited partner of 10 percent or more with voting rights, or if the applicant is a corporation, any officer, director, or shareholder owning 10 percent or more of its capital stock, or if the applicant is a limited liability company, any member-manager or any member owning 10 percent or more of the membership interest of the limited liability company:

a. Is not 21 years of age or older;

b. Is not a resident of the Commonwealth;

c. Has been convicted in any court of any crime or offense involving moral turpitude under the laws of any state or of the United States within seven years of the date of the application or has not completed all terms of sentencing and probation resulting from any such felony conviction;

d. Knowingly employs someone younger than 21 years of age;

e. Is not the legitimate owner of the business proposed to be licensed, or other persons have ownership interests in the business that have not been disclosed;

f. Has not demonstrated financial responsibility sufficient to meet the requirements of the business proposed to be licensed;

g. Has misrepresented a material fact in applying to the Board for a license;

h. Has defrauded or attempted to defraud the Board, or any federal, state, or local government or governmental agency or authority, by making or filing any report, document, or tax return required by statute or regulation that is fraudulent or contains a false representation of a material fact; or has willfully deceived or attempted to deceive the Board, or any federal, state, or local government or governmental agency or authority, by making or maintaining business records required by statute or regulation that are false or fraudulent;

i. Is violating or allowing the violation of any provision of this subtitle in his establishment at the time his application for a license is pending;

j. Is a police officer with police authority in the political subdivision within which the establishment designated in the application is located;

k. Is a manufacturer, distributor, or retailer of alcoholic beverages licensed under this chapter or a retailer of tobacco or tobacco products;

l. Has been sanctioned by the Board of Pharmacy pursuant to § 54.1-3316 and regulations promulgated by the Board of Pharmacy for a violation pursuant to Article 4.2 (§ 54.1-3442.5 et seq.) of the Drug Control Act; or

m. Is physically unable to carry on the business for which the application for a license is filed or has been adjudicated incapacitated.

2. The place to be occupied by the applicant:

a. Does not conform to the requirements of the governing body of the county, city, or town in which such place is located with respect to sanitation, health, construction, or equipment, or to any similar requirements established by the laws of the Commonwealth or by Board regulation;

b. Is so located that granting a license and operation thereunder by the applicant would result in violations of this subtitle or Board regulations or violation of the laws of the Commonwealth or local ordinances relating to peace and good order;

c. Is so located with respect to any place of religious worship; hospital; public, private, or parochial school or institution of higher education; public or private playground or other similar recreational facility; child day program; substance use disorder treatment facility; or federal, state, or local government-operated facility that the operation of such place under such license will adversely affect or interfere with the normal, orderly conduct of the affairs of such facilities, programs, or institutions;

d. Is so located with respect to any residence or residential area that the operation of such place under such license will adversely affect real property values or substantially interfere with the usual quietude and tranquility of such residence or residential area;

5718 e. When the applicant is applying for a retail marijuana store license, is located within 1,000 feet of
5719 an existing retail marijuana store; or

5720 f. Under a retail marijuana store license, is so constructed, arranged, or illuminated that
5721 law-enforcement officers and special agents of the Board are prevented from ready access to and
5722 reasonable observation of any room or area within which retail marijuana or retail marijuana products
5723 are to be sold.

5724 Nothing in this subdivision 2 shall be construed to require an applicant to have secured a place or
5725 premises until the final stage of the license approval process.

5726 3. The number of licenses existing in the locality is such that the granting of a license is detrimental
5727 to the interest, morals, safety, or welfare of the public. In reaching such conclusion, the Board shall
5728 consider (i) the criteria established by the Board to evaluate new licensees based on the density of retail
5729 marijuana stores in the community; (ii) the character of, population of, number of similar licenses, and
5730 number of all licenses existent in the particular county, city, or town and the immediate neighborhood
5731 concerned; (iii) the effect that a new license may have on such county, city, town, or neighborhood in
5732 conforming with the purposes of this subtitle; and (iv) the objections, if any, that may have been filed by
5733 a local governing body or local residents.

5734 4. There exists any law, ordinance, or regulation of the United States, the Commonwealth, or any
5735 political subdivision thereof that warrants refusal by the Board to grant any license.

5736 5. The Board is not authorized under this subtitle to grant such license.

5737 **§ 4.1-810. Conditions under which the Board shall refuse to grant licenses.**

5738 The Board shall refuse to grant any license to any member or employee of the Board or to any
5739 corporation or other business entity in which such member or employee is a stockholder or has any
5740 other economic interest.

5741 Whenever any other elected or appointed official of the Commonwealth or any political subdivision
5742 thereof applies for such a license or continuance thereof, he shall state on the application the official
5743 position he holds, and whenever a corporation or other business entity in which any such official is a
5744 stockholder or has any other economic interest applies for such a license, it shall state on the
5745 application the full economic interests of each such official in such corporation or other business entity.

5746 **§ 4.1-811. Notice and hearings for refusal to grant licenses; Administrative Process Act; exceptions.**

5748 A. The action of the Board in granting or in refusing to grant any license shall be subject to judicial
5749 review in accordance with the Administrative Process Act (§ 2.2-4000 et seq.), except as provided in
5750 subsection B or C. Such review shall extend to the entire evidential record of the proceedings provided
5751 by the Board in accordance with the Administrative Process Act. An appeal shall lie to the Court of
5752 Appeals from any order of the court. Notwithstanding § 8.01-676.1, the final judgment or order of the
5753 circuit court shall not be suspended, stayed, or modified by such circuit court pending appeal to the
5754 Court of Appeals. Neither mandamus nor injunction shall lie in any such case.

5755 B. The Board may refuse a hearing on any application for the granting of any retail marijuana store
5756 license, provided that such:

5757 1. License for the applicant has been refused or revoked within a period of 12 months;

5758 2. License for any premises has been refused or revoked at that location within a period of 12
5759 months; or

5760 3. Applicant, within a period of 12 months immediately preceding, has permitted a license granted by
5761 the Board to expire for nonpayment of license fee, and at the time of expiration of such license, there
5762 was a pending and unadjudicated charge, either before the Board or in any court, against the licensee
5763 alleging a violation of this subtitle.

5764 C. If an applicant has permitted a license to expire for nonpayment of license fee, and at the time of
5765 expiration there remained unexecuted any period of suspension imposed upon the licensee by the Board,
5766 the Board may refuse a hearing on an application for a new license until after the date on which the
5767 suspension period would have been executed had the license not have been permitted to expire.

5768 **CHAPTER 9.**

5769 **ADMINISTRATION OF LICENSES; SUSPENSION AND REVOCATION.**

5770 **§ 4.1-900. Grounds for which Board may suspend or revoke licenses.**

5771 The Board may suspend or revoke any license if it has reasonable cause to believe that:

5772 1. The licensee, or if the licensee is a partnership, any general partner thereof, or if the licensee is
5773 an association, any member thereof, or a limited partner of 10 percent or more with voting rights, or if
5774 the licensee is a corporation, any officer, director, or shareholder owning 10 percent or more of its
5775 capital stock, or if the licensee is a limited liability company, any member-manager or any member
5776 owning 10 percent or more of the membership interest of the limited liability company:

5777 a. Has misrepresented a material fact in applying to the Board for such license;

5778 b. Within the five years immediately preceding the date of the hearing held in accordance with
5779 § 4.1-903, has (i) violated any provision of Chapter 11 (§ 4.1-1100 et seq.), Chapter 12 (§ 4.1-1200 et

seq.), or Chapter 13 (§ 4.1-1300 et seq.); (ii) committed a violation of this subtitle in bad faith; (iii) violated or failed or refused to comply with any regulation, rule, or order of the Board; or (iv) failed or refused to comply with any of the conditions or restrictions of the license granted by the Board;

c. Has been convicted in any court of a felony or of any crime or offense involving moral turpitude under the laws of any state or of the United States;

d. Is not the legitimate owner of the business conducted under the license granted by the Board, or other persons have ownership interests in the business that have not been disclosed;

e. Cannot demonstrate financial responsibility sufficient to meet the requirements of the business conducted under the license granted by the Board;

f. Has been intoxicated or under the influence of some self-administered drug while upon the licensed premises;

g. Has maintained the licensed premises in an unsanitary condition, or allowed such premises to become a meeting place or rendezvous for members of a criminal street gang as defined in § 18.2-46.1 or persons of ill repute, or has allowed any form of illegal gambling to take place upon such premises;

h. Has allowed any person whom he knew or had reason to believe was intoxicated to loiter upon such licensed premises;

i. Has allowed any person to consume upon the licensed premises any marijuana or marijuana product except as provided under this subtitle;

j. Is physically unable to carry on the business conducted under such license or has been adjudicated incapacitated;

k. Has possessed any illegal gambling apparatus, machine, or device upon the licensed premises;

l. Has upon the licensed premises (i) illegally possessed, distributed, sold, or used, or has knowingly allowed any employee or agent, or any other person, to illegally possess, distribute, sell, or use, controlled substances, imitation controlled substances, drug paraphernalia, or controlled paraphernalia as those terms are defined in Articles 1 (§ 18.2-247 et seq.) and 1.1 (§ 18.2-265.1 et seq.) of Chapter 7 of Title 18.2 and the Drug Control Act (§ 54.1-3400 et seq.); (ii) laundered money in violation of § 18.2-246.3; or (iii) conspired to commit any drug-related offense in violation of Article 1 or 1.1 of Chapter 7 of Title 18.2 or the Drug Control Act. The provisions of this subdivision l shall also apply to any conduct related to the operation of the licensed business that facilitates the commission of any of the offenses set forth herein;

m. Has failed to take reasonable measures to prevent (i) the licensed premises, (ii) any premises immediately adjacent to the licensed premises that is owned or leased by the licensee, or (iii) any portion of public property immediately adjacent to the licensed premises from becoming a place where patrons of the establishment commit criminal violations of Article 1 (§ 18.2-30 et seq.), 2 (§ 18.2-38 et seq.), 2.1 (§ 18.2-46.1 et seq.), 2.2 (§ 18.2-46.4 et seq.), 3 (§ 18.2-47 et seq.), 4 (§ 18.2-51 et seq.), 5 (§ 18.2-58 et seq.), 6 (§ 18.2-59 et seq.), or 7 (§ 18.2-61 et seq.) of Chapter 4 of Title 18.2; Article 2 (§ 18.2-266 et seq.) of Chapter 7 of Title 18.2; Article 3 (§ 18.2-346 et seq.) or 5 (§ 18.2-372 et seq.) of Chapter 8 of Title 18.2; or Article 1 (§ 18.2-404 et seq.), 2 (§ 18.2-415), or 3 (§ 18.2-416 et seq.) of Chapter 9 of Title 18.2 and such violations lead to arrests that are so frequent and serious as to reasonably be deemed a continuing threat to the public safety;

n. Has failed to take reasonable measures to prevent an act of violence resulting in death or serious bodily injury, or a recurrence of such acts, from occurring on (i) the licensed premises, (ii) any premises immediately adjacent to the licensed premises that is owned or leased by the licensee, or (iii) any portion of public property immediately adjacent to the licensed premises;

o. Has been sanctioned by the Board of Pharmacy pursuant to § 54.1-3316 and regulations promulgated by the Board of Pharmacy for a violation pursuant to Article 4.2 (§ 54.1-3442.5 et seq.) of the Drug Control Act; or

p. Has refused to (i) remain neutral regarding any union organizing efforts by employees, including card check recognition and union access to employees; (ii) pay employees prevailing wages as determined by the U.S. Department of Labor; or (iii) classify no more than 10 percent of its workers as independent contractors and such workers are not owners in a worker-owned cooperative.

2. The place occupied by the licensee:

a. Does not conform to the requirements of the governing body of the county, city, or town in which such establishment is located, with respect to sanitation, health, construction, or equipment, or to any similar requirements established by the laws of the Commonwealth or by Board regulations;

b. Has been adjudicated a common nuisance under the provisions of this subtitle or § 18.2-258; or

c. Has become a meeting place or rendezvous for illegal gambling, illegal users of narcotics, drunks, prostitutes, pimps, panderers, or habitual law violators or has become a place where illegal drugs are regularly used or distributed. The Board may consider the general reputation in the community of such establishment in addition to any other competent evidence in making such determination.

3. The licensee or any employee of the licensee discriminated against any member of the Armed

5841 *Forces of the United States by prices charged or otherwise.*

5842 4. Any cause exists for which the Board would have been entitled to refuse to grant such license had
5843 the facts been known.

5844 5. The licensee is delinquent for a period of 90 days or more in the payment of any taxes, or any
5845 penalties or interest related thereto, lawfully imposed by the locality where the licensed business is
5846 located, as certified by the treasurer, commissioner of the revenue, or finance director of such locality,
5847 unless (i) the outstanding amount is de minimis; (ii) the licensee has pending a bona fide application for
5848 correction or appeal with respect to such taxes, penalties, or interest; or (iii) the licensee has entered
5849 into a payment plan approved by the same locality to settle the outstanding liability.

5850 6. The licensee has been convicted for a violation of 8 U.S.C. § 1324a(f), as amended, for actions of
5851 its agents or employees constituting a pattern or practice of employing unauthorized aliens on the
5852 licensed premises in the Commonwealth.

5853 7. Any other cause authorized by this subtitle.

5854 **§ 4.1-901. Summary suspension in emergency circumstances; grounds; notice and hearing.**

5855 A. Notwithstanding any provisions to the contrary in Article 3 (§ 2.2-4018 et seq.) of the
5856 Administrative Process Act or § 4.1-806 or 4.1-903, the Board may summarily suspend any license or
5857 permit if it has reasonable cause to believe that an act of violence resulting in death or serious bodily
5858 injury, or a recurrence of such acts, has occurred on (i) the licensed premises, (ii) any premises
5859 immediately adjacent to the licensed premises that is owned or leased by the licensee, or (iii) any
5860 portion of public property immediately adjacent to the licensed premises, and the Board finds that there
5861 exists a continuing threat to public safety and that summary suspension of the license or permit is
5862 justified to protect the health, safety, or welfare of the public.

5863 B. Prior to issuing an order of suspension pursuant to this section, special agents of the Board shall
5864 conduct an initial investigation and submit all findings to the Secretary of the Board within 48 hours of
5865 any such act of violence. If the Board determines suspension is warranted, it shall immediately notify
5866 the licensee of its intention to temporarily suspend his license pending the outcome of a formal
5867 investigation. Such temporary suspension shall remain effective for a minimum of 48 hours. After the
5868 48-hour period, the licensee may petition the Board for a restricted license pending the results of the
5869 formal investigation and proceedings for disciplinary review. If the Board determines that a restricted
5870 license is warranted, the Board shall have discretion to impose appropriate restrictions based on the
5871 facts presented.

5872 C. Upon a determination to temporarily suspend a license, the Board shall immediately commence a
5873 formal investigation. The formal investigation shall be completed within 10 days of its commencement
5874 and the findings reported immediately to the Secretary of the Board. If, following the formal
5875 investigation, the Secretary of the Board determines that suspension of the license is warranted, a
5876 hearing shall be held within five days of the completion of the formal investigation. A decision shall be
5877 rendered within 10 days of the conclusion of the hearing. If a decision is not rendered within 10 days of
5878 the conclusion of the hearing, the order of suspension shall be vacated and the license reinstated. Any
5879 appeal by the licensee shall be filed within 10 days of the decision and heard by the Board within 20
5880 days of the decision. The Board shall render a decision on the appeal within 10 days of the conclusion
5881 of the appeal hearing.

5882 D. Service of any order of suspension issued pursuant to this section shall be made by a special
5883 agent of the Board in person and by certified mail to the licensee. The order of suspension shall take
5884 effect immediately upon service.

5885 E. This section shall not apply to temporary permits granted under § 4.1-806.

5886 **§ 4.1-902. Grounds for which Board shall suspend or revoke licenses.**

5887 The Board shall suspend or revoke any license if it finds that:

5888 1. A licensee has violated or permitted the violation of § 18.2-331, relating to the illegal possession
5889 of a gambling device, upon the premises for which the Board has granted a retail marijuana store
5890 license.

5891 2. A licensee has defrauded or attempted to defraud the Board, or any federal, state, or local
5892 government or governmental agency or authority, by making or filing any report, document, or tax
5893 return required by statute or regulation that is fraudulent or contains a willful or knowing false
5894 representation of a material fact or has willfully deceived or attempted to deceive the Board, or any
5895 federal, state, or local government or governmental agency or authority, by making or maintaining
5896 business records required by statute or regulation that are false or fraudulent.

5897 **§ 4.1-903. Suspension or revocation of licenses; notice and hearings; imposition of civil penalties.**

5898 A. Before the Board may suspend or revoke any license, reasonable notice of such proposed or
5899 contemplated action shall be given to the licensee in accordance with the provisions of § 2.2-4020 of the
5900 Administrative Process Act (§ 2.2-4000 et seq.).

5901 Notwithstanding the provisions of § 2.2-4022, the Board shall, upon written request by the licensee,
5902 permit the licensee to inspect and copy or photograph all (i) written or recorded statements made by the

licensee or copies thereof or the substance of any oral statements made by the licensee or a previous or present employee of the licensee to any law-enforcement officer, the existence of which is known by the Board and upon which the Board intends to rely as evidence in any adversarial proceeding under this subtitle against the licensee, and (ii) designated books, papers, documents, tangible objects, buildings, or places, or copies or portions thereof, that are within the possession, custody, or control of the Board and upon which the Board intends to rely as evidence in any adversarial proceeding under this subtitle against the licensee. In addition, any subpoena for the production of documents issued to any person at the request of the licensee or the Board pursuant to § 4.1-604 shall provide for the production of the documents sought within 10 working days, notwithstanding anything to the contrary in § 4.1-604.

If the Board fails to provide for inspection or copying under this section for the licensee after a written request, the Board shall be prohibited from introducing into evidence any items the licensee would have lawfully been entitled to inspect or copy under this section.

The action of the Board in suspending or revoking any license or in imposing a civil penalty shall be subject to judicial review in accordance with the Administrative Process Act (§ 2.2-4000 et seq.). Such review shall extend to the entire evidential record of the proceedings provided by the Board in accordance with the Administrative Process Act. An appeal shall lie to the Court of Appeals from any order of the court. Notwithstanding § 8.01-676.1, the final judgment or order of the circuit court shall not be suspended, stayed, or modified by such circuit court pending appeal to the Court of Appeals. Neither mandamus nor injunction shall lie in any such case.

B. In suspending any license, the Board may impose, as a condition precedent to the removal of such suspension or any portion thereof, a requirement that the licensee pay the cost incurred by the Board in investigating the licensee and in holding the proceeding resulting in such suspension, or it may impose and collect such civil penalties as it deems appropriate. In no event shall the Board impose a civil penalty exceeding \$2,000 for the first violation occurring within five years immediately preceding the date of the violation or \$5,000 for the second or subsequent violation occurring within five years immediately preceding the date of the second or subsequent violation. However, if the violation involved selling retail marijuana or retail marijuana products to a person prohibited from purchasing retail marijuana or retail marijuana products or allowing consumption of retail marijuana or retail marijuana products, the Board may impose a civil penalty not to exceed \$3,000 for the first violation occurring within five years immediately preceding the date of the violation and \$6,000 for a second or subsequent violation occurring within five years immediately preceding the date of the second or subsequent violation in lieu of such suspension or any portion thereof, or both. The Board may also impose a requirement that the licensee pay for the cost incurred by the Board not exceeding \$25,000 in investigating the licensee and in holding the proceeding resulting in the violation in addition to any suspension or civil penalty incurred.

C. Following notice to (i) the licensee of a hearing that may result in the suspension or revocation of his license or (ii) the applicant of a hearing to resolve a contested application, the Board may accept a consent agreement as authorized in § 4.1-604. The notice shall advise the licensee or applicant of the option to (a) admit the alleged violation or the validity of the objection; (b) waive any right to a hearing or an appeal under the Administrative Process Act (§ 2.2-4000 et seq.); and (c) (1) accept the proposed restrictions for operating under the license, (2) accept the period of suspension of the licensed privileges within the Board's parameters, (3) pay a civil penalty in lieu of the period of suspension, or any portion of the suspension as applicable, or (4) proceed to a hearing.

D. The Board shall, by regulation or written order:

1. Designate those (i) objections to an application or (ii) alleged violations that will proceed to an initial hearing;

2. Designate the violations for which a waiver of a hearing and payment of a civil charge in lieu of suspension may be accepted for a first offense occurring within three years immediately preceding the date of the violation;

3. Provide for a reduction in the length of any suspension and a reduction in the amount of any civil penalty for any retail marijuana store licensee where the licensee can demonstrate that it provided to its employees marijuana seller training certified in advance by the Board;

4. Establish a schedule of penalties for such offenses, prescribing the appropriate suspension of a license and the civil charge acceptable in lieu of such suspension; and

5. Establish a schedule of offenses for which any penalty may be waived upon a showing that the licensee has had no prior violations within five years immediately preceding the date of the violation. No waiver shall be granted by the Board, however, for a licensee's willful and knowing violation of this subtitle or Board regulations.

§ 4.1-904. Suspension or revocation; disposition of retail marijuana or retail marijuana products on hand; termination.

A. Retail marijuana or retail marijuana products owned by or in the possession of or for sale by any

5964 licensee at the time the license of such person is suspended or revoked may be disposed of as follows:

5965 1. Sold to persons in the Commonwealth licensed to sell such retail marijuana or retail marijuana
5966 products upon permits granted by the Board in accordance with § 4.1-806 and conditions specified by
5967 the Board; or

5968 2. Destroyed by the Board or its designee.

5969 B. All retail marijuana or retail marijuana products owned by or in the possession of any person
5970 whose license is suspended or revoked shall be disposed of by such person in accordance with the
5971 provisions of this section within 60 days from the date of such suspension or revocation.

5972 C. Retail marijuana or retail marijuana products owned by or in the possession of or for sale by
5973 persons whose licenses have been terminated other than by suspension or revocation may be disposed of
5974 in accordance with subsection A within such time as the Board deems proper. Such period shall not be
5975 less than 60 days.

5976 D. All retail marijuana or retail marijuana products owned by or remaining in the possession of any
5977 person described in subsection A or C after the expiration of such period shall be deemed contraband
5978 and forfeited to the Commonwealth in accordance with the provisions of § 4.1-1304.

5979 CHAPTER 10.

5980 ADMINISTRATION OF LICENSES; APPLICATIONS FOR LICENSES; FEES; TAXES.

5981 § 4.1-1000. Applications for licenses; publication; notice to localities; fees; permits.

5982 A. Every person intending to apply for any license authorized by this subtitle shall file with the
5983 Board an application on forms provided by the Board and a statement in writing by the applicant
5984 swearing and affirming that all of the information contained therein is true.

5985 Applicants for licenses for establishments that are otherwise required to obtain an inspection by the
5986 Department of Agriculture and Consumer Services shall provide proof of inspection or proof of a
5987 pending request for such inspection. If the applicant provides proof of inspection or proof of a pending
5988 request for an inspection, a license may be issued to the applicant. If a license is issued on the basis of
5989 a pending application or inspection, such license shall authorize the licensee to purchase retail
5990 marijuana, retail marijuana products, immature marijuana plants, or marijuana seeds in accordance
5991 with the provisions of this subtitle; however, the licensee shall not sell retail marijuana, retail marijuana
5992 products, immature marijuana plants, or marijuana seeds until an inspection is completed.

5993 B. In addition, each applicant for a license under the provisions of this subtitle shall post a notice of
5994 his application with the Board on the front door of the building, place, or room where he proposes to
5995 engage in such business for no more than 30 days and not less than 10 days. Such notice shall be of a
5996 size and contain such information as required by the Board, including a statement that any objections
5997 shall be submitted to the Board not more than 30 days following initial posting of the notice required
5998 pursuant to this subsection.

5999 The applicant shall also cause notice to be published at least once a week for two consecutive weeks
6000 in a newspaper published in or having a general circulation in the county, city, or town wherein such
6001 applicant proposes to engage in such business. Such notice shall contain such information as required
6002 by the Board, including a statement that any objections to the issuance of the license be submitted to
6003 the Board not later than 30 days from the date of the initial newspaper publication.

6004 The Board shall conduct a background investigation, to include a criminal history records search,
6005 which may include a fingerprint-based national criminal history records search, on each applicant for a
6006 license. However, the Board may waive, for good cause shown, the requirement for a criminal history
6007 records search and completed personal data form for officers, directors, nonmanaging members, or
6008 limited partners of any applicant corporation, limited liability company, or limited partnership. In
6009 considering criminal history record information, the Board shall not disqualify an applicant because of
6010 a past conviction for a marijuana-related offense.

6011 The Board shall notify the local governing body of each license application through the town
6012 manager, city manager, county administrator, or other designee of the locality. Local governing bodies
6013 shall submit objections to the granting of a license within 30 days of the filing of the application.

6014 C. Each applicant shall pay the required application fee at the time the application is filed, except
6015 that such fee shall be waived or discounted for qualified social equity applicants pursuant to regulations
6016 promulgated by the Board. The license application fee shall be determined by the Board and shall be in
6017 addition to the actual cost charged to the Department of State Police by the Federal Bureau of
6018 Investigation or the Central Criminal Records Exchange for processing any fingerprints through the
6019 Federal Bureau of Investigation or the Central Criminal Records Exchange for each criminal history
6020 records search required by the Board. Application fees shall be in addition to the state license fee
6021 required pursuant to § 4.1-1001 and shall not be refunded.

6022 D. Subsection A shall not apply to the continuance of licenses granted under this subtitle; however,
6023 all licensees shall file and maintain with the Board a current, accurate record of the information
6024 required by the Board pursuant to subsection A and notify the Board of any changes to such
6025 information in accordance with Board regulations.

E. Every application for a permit granted pursuant to § 4.1-806 shall be on a form provided by the Board. Such permits shall confer upon their holders no authority to make solicitations in the Commonwealth as otherwise provided by law.

The fee for a temporary permit shall be one-twelfth of the combined fees required by this section for applicable licenses to sell retail marijuana or retail marijuana products computed to the nearest cent and multiplied by the number of months for which the permit is granted.

F. The Board shall have the authority to increase state license fees. The Board shall set the amount of such increases on the basis of the consumer price index and shall not increase fees more than once every three years. Prior to implementing any state license fee increase, the Board shall provide notice to all licensees and the general public of (i) the Board's intent to impose a fee increase and (ii) the new fee that would be required for any license affected by the Board's proposed fee increases. Such notice shall be provided on or before November 1 in any year in which the Board has decided to increase state license fees, and such increases shall become effective July 1 of the following year.

§ 4.1-1001. Fees for state licenses.

A. The annual fees on state licenses shall be determined by the Board.

B. The fee on each license granted or reissued for a period other than 12, 24, or 36 months shall be equal to one-twelfth of the fees required by subsection A computed to the nearest cent, multiplied by the number of months in the license period, and then increased by five percent. Such fee shall not be refundable, except as provided in § 4.1-1002.

C. Nothing in this subtitle shall exempt any licensee from any state merchants' license or state restaurant license or any other state tax. Every licensee, in addition to the taxes and fees imposed by this subtitle, shall be liable to state merchants' license taxation and other state taxation.

D. In addition to the fees set forth in this section, a fee of \$5 may be imposed on any license purchased in person from the Board if such license is available for purchase online.

§ 4.1-1002. Refund of state license fee.

A. The Board may correct erroneous assessments made by it against any person and make refunds of any amounts collected pursuant to erroneous assessments, or collected as fees on licenses, that are subsequently refused or application therefor withdrawn, and to allow credit for any license fees paid by any licensee for any license that is subsequently merged or changed into another license during the same license period. No refund shall be made of any such amount, however, unless made within three years from the date of collection of the same.

B. In any case where a licensee has changed its name or form of organization during a license period without any change being made in its ownership, and because of such change is required to pay an additional license fee for such period, the Board shall refund to such licensee the amount of such fee so paid in excess of the required license fee for such period.

C. The Board shall make refunds, prorated according to a schedule of its prescription, to licensees of state license fees paid pursuant to subsection A of § 4.1-1001 if the place of business designated in the license is destroyed by an act of God, including but not limited to fire, earthquake, hurricane, storm, or similar natural disaster or phenomenon.

D. Any amount required to be refunded under this section shall be paid by the State Treasurer out of moneys appropriated to the Board and in the manner prescribed in § 4.1-614.

§ 4.1-1003. Marijuana tax; exceptions.

A. A tax of 21 percent is levied on the sale in the Commonwealth of any retail marijuana, retail marijuana products, marijuana paraphernalia sold by a retail marijuana store, non-retail marijuana, and non-retail marijuana products. The tax shall be in addition to any tax imposed under the Virginia Retail Sales and Use Tax Act (§ 58.1-600 et seq.) or any other provision of federal, state, or local law.

B. The tax shall not apply to any sale:

1. From a marijuana establishment to another marijuana establishment.

2. Of cannabis oil for treatment under the provisions of § 54.1-3408.3 and Article 4.2 (§ 54.1-3442.5 et seq.) of the Drug Control Act.

3. Of industrial hemp by a grower, processor, or dealer under the provisions of Chapter 41.1 (§ 3.2-4112 et seq.) of Title 3.2.

4. Of a hemp product or regulated hemp product.

C. All revenues remitted to the Authority under this section shall be disposed of as provided in § 4.1-614.

§ 4.1-1004. Optional local marijuana tax.

A. Any locality may by ordinance levy a three percent tax on any sale taxable under § 4.1-1003. The tax shall be in addition to any local sales tax imposed under the Virginia Retail Sales and Use Tax Act (§ 58.1-600 et seq.), any food and beverage tax imposed under Article 7.1 (§ 58.1-3833 et seq.) of Chapter 38 of Title 58.1, and any excise tax imposed on meals under § 58.1-3840. Other than the taxes authorized and identified in this subsection, a locality shall not impose any other tax on a sale taxable

6087 under § 4.1-1003.

6088 B. If a town imposes a tax under this section, any tax imposed by its surrounding county under this
6089 section shall not apply within the limits of the town.

6090 C. Nothing in this section shall be construed to prohibit a locality from imposing any tax authorized
6091 by law on a person or property regulated under this subtitle. Nothing in this section shall be construed
6092 to limit the authority of any locality to impose a license or privilege tax or fee on a business engaged in
6093 whole or in part in sales taxable under § 4.1-1003 if such tax or fee is (i) based on an annual or
6094 per-event flat fee authorized by law or (ii) is an annual license or privilege tax authorized by law, and
6095 such tax includes sales or receipts taxable under § 4.1-1003 in its taxable measure.

6096 D. Any locality that enacts an ordinance pursuant to subsection A shall, within 30 days, notify the
6097 Authority and any retail marijuana store in such locality of the ordinance's enactment. The ordinance
6098 shall take effect on the first day of the second month following its enactment.

6099 E. Any tax levied under this section shall be administered and collected by the Authority in the same
6100 manner as provided for the tax imposed under § 4.1-1003.

6101 F. All revenues remitted to the Authority under this section shall be disposed of as provided in
6102 § 4.1-614.

6103 **§ 4.1-1005. Tax returns and payments; commissions; interest.**

6104 A. For any sale taxable under §§ 4.1-1003 and 4.1-1004, the seller shall be liable for collecting any
6105 taxes due. All taxes collected by a seller shall be deemed to be held in trust for the Commonwealth. The
6106 buyer shall not be liable for collecting or remitting the taxes or filing a return.

6107 B. On or before the tenth day of each month, any person liable for a tax due under § 4.1-1003 or
6108 4.1-1004 shall file a return under oath with the Authority and pay any taxes due. Upon written
6109 application by a person filing a return, the Authority may, if it determines good cause exists, grant an
6110 extension to the end of the calendar month in which the tax is due, or for a period not exceeding 30
6111 days. Any extension shall toll the accrual of any interest or penalties under § 4.1-1008.

6112 C. The Authority may accept payment by any commercially acceptable means, including cash, checks,
6113 credit cards, debit cards, and electronic funds transfers, for any taxes, interest, or penalties due under
6114 this subtitle. The Board may assess a service charge for the use of a credit or debit card.

6115 D. Upon request, the Authority may collect and maintain a record of a person's credit card, debit
6116 card, or automated clearinghouse transfer information and use such information for future payments of
6117 taxes, interest, or penalties due under this subtitle. The Authority may assess a service charge for any
6118 payments made under this subsection. The Authority may procure the services of a third-party vendor
6119 for the secure storage of information collected pursuant to this subsection.

6120 E. If any person liable for tax under §§ 4.1-1003 and 4.1-1004 sells out his business or stock of
6121 goods or quits the business, such person shall make a final return and payment within 15 days after the
6122 date of selling or quitting the business. Such person's successors or assigns, if any, shall withhold
6123 sufficient of the purchase money to cover the amount of such taxes, interest, and penalties due and
6124 unpaid until such former owner produces a receipt from the Authority showing payment or a certificate
6125 stating that no taxes, penalties, or interest are due. If the buyer of a business or stock of goods fails to
6126 withhold the purchase money as provided in this subsection, such buyer shall be liable for the payment
6127 of the taxes, interest, and penalties due and unpaid on account of the operation of the business by any
6128 former owner.

6129 F. When any person fails to timely pay the full amount of tax due under § 4.1-1003 or 4.1-1004,
6130 interest at a rate determined in accordance with § 58.1-15 shall accrue on the tax until it is paid. Any
6131 taxes due under §§ 4.1-1003 and 4.1-1004 shall, if applicable, be subject to penalties as provided in
6132 §§ 4.1-1206 and 4.1-1207.

6133 **§ 4.1-1006. Bonds.**

6134 The Authority may, when deemed necessary and advisable to do so in order to secure the collection
6135 of the taxes levied under §§ 4.1-1003 and 4.1-1004, require any person subject to such tax to file a
6136 bond, with such surety as it determines is necessary to secure the payment of any tax, penalty, or
6137 interest due or that may become due from such person. In lieu of such bond, securities approved by the
6138 Authority may be deposited with the State Treasurer, which securities shall be kept in the custody of the
6139 State Treasurer, and shall be sold by the State Treasurer at the request of the Authority at public or
6140 private sale if it becomes necessary to do so in order to recover any tax, interest, or penalty due the
6141 Commonwealth. Upon any such sale, the surplus, if any, above the amounts due shall be returned to the
6142 person who deposited the securities.

6143 **§ 4.1-1007. Refunds.**

6144 A. Whenever it is proved to the satisfaction of the Authority that any taxes levied pursuant to
6145 § 4.1-1003 or 4.1-1004 have been paid and that the taxable items were or are (i) damaged, destroyed,
6146 or otherwise deemed to be unsalable by reason of fire or any other providential cause before sale to the
6147 consumer; (ii) destroyed voluntarily because the taxable items were defective and after notice to and
6148 approval by the Authority of such destruction; or (iii) destroyed in any manner while in the possession

of a common, private, or contract carrier, the Authority shall certify such facts to the Comptroller for approval of a refund payment from the state treasury to such extent as may be proper.

B. Whenever it is proved to the satisfaction of the Authority that any person has purchased taxable items that have been sold by such person in such manner as to be exempt from the tax, the Authority shall certify such facts to the Comptroller for approval of a refund payment from the state treasury to such extent as may be proper.

C. In the event purchases are returned to the seller by the buyer after a tax imposed under § 4.1-1003 or 4.1-1004 has been collected or charged to the account of the buyer, the seller shall be entitled to a refund of the amount of tax so collected or charged in the manner prescribed by the Authority. The amount of tax so refunded to the seller shall not, however, include the tax paid upon any amount retained by the seller after such return of merchandise. In case the tax has not been remitted by the seller, the seller may deduct the same in submitting his return.

§ 4.1-1008. Statute of limitations; civil remedies for collecting past-due taxes, interest, and penalties.

A. The taxes imposed under §§ 4.1-1003 and 4.1-1004 shall be assessed within three years from the date on which such taxes became due and payable. In the case of a false or fraudulent return with intent to defraud the Commonwealth, or a failure to file a return, the taxes may be assessed, or a proceeding in court for the collection of such taxes may be begun without assessment, at any time within six years from such date. The Authority shall not examine any person's records beyond the three-year period of limitations unless it has reasonable evidence of fraud or reasonable cause to believe that such person was required by law to file a return and failed to do so.

B. If any person fails to file a return as required by this section, or files a return that is false or fraudulent, the Authority may make an estimate for the taxable period of the taxable sales of such person and assess the tax, plus any applicable interest and penalties. The Authority shall give such person 10 days' notice requiring such person to provide any records as it may require relating to the business of such person for the taxable period. The Authority may require such person or the agents and employees of such person to give testimony or to answer interrogatories under oath administered by the Authority respecting taxable sales, the filing of the return, and any other relevant information. If any person fails to file a required return, refuses to provide required records, or refuses to answer interrogatories from the Authority, the Authority may make an estimated assessment based upon the information available to it and issue a memorandum of lien under subsection C for the collection of any taxes, interest, or penalties. The estimated assessment shall be deemed prima facie correct.

C. 1. If the Authority assesses taxes, interest, or penalties on a person and such person does not pay within 30 days after the due date, taking into account any extensions granted by the Authority, the Authority may file a memorandum of lien in the circuit court clerk's office of the county or city in which the person's place of business is located or in which the person resides. If the person has no place of business or residence within the Commonwealth, the memorandum may be filed in the Circuit Court of the City of Richmond. A copy of the memorandum may also be filed in the clerk's office of all counties and cities in which the person owns real estate. Such memorandum shall be recorded in the judgment docket book and shall have the effect of a judgment in favor of the Commonwealth, to be enforced as provided in Article 19 (§ 8.01-196 et seq.) of Chapter 3 of Title 8.01, except that a writ of fieri facias may issue at any time after the memorandum is filed. The lien on real estate shall become effective at the time the memorandum is filed in the jurisdiction in which the real estate is located. No memorandum of lien shall be filed unless the person is first given 10 or more days' prior notice of intent to file a lien; however, in those instances where the Authority determines that the collection of any tax, penalties, or interest required to be paid pursuant to law will be jeopardized by the provision of such notice, notification may be provided to the person concurrent with the filing of the memorandum of lien. Such notice shall be given to the person at his last known address.

2. Recordation of a memorandum of lien under this subsection shall not affect a person's right to appeal under § 4.1-1009.

3. If after filing a memorandum of lien the Authority determines that it is in the best interest of the Commonwealth, it may place padlocks on the doors of any business enterprise that is delinquent in filing or paying any tax owed to the Commonwealth. The Authority shall also post notices of distraint on each of the doors so padlocked. If, after three business days, the tax deficiency has not been satisfied or satisfactory arrangements for payment made, the Authority may cause a writ of fieri facias to be issued. It shall be a Class 1 misdemeanor for anyone to enter the padlocked premises without prior approval of the Authority. In the event that the person against whom the distraint has been applied subsequently appeals under § 4.1-1009, the person shall have the right to post bond equaling the amount of liability in lieu of payment until the appeal is resolved.

4. A person may petition the Authority after a memorandum of lien has been filed under this subsection if the person alleges an error in the filing of the lien. The Authority shall make a

6210 *determination on such petition within 14 days. If the Authority determines that the filing was erroneous,*
6211 *it shall issue a certificate of release of the lien within seven days after such determination is made.*

6212 **§ 4.1-1009. Appeals.**

6213 *Any tax imposed under § 4.1-1003 or 4.1-1004, any interest imposed under § 4.1-1008, any action of*
6214 *the Authority under § 4.1-1204, and any penalty imposed under § 4.1-1206 or 4.1-1207 shall be subject*
6215 *to review under the Administrative Process Act (§ 2.2-4000 et seq.). Such review shall extend to the*
6216 *entire evidential record of the proceedings provided by the Authority in accordance with the*
6217 *Administrative Process Act. An appeal shall lie to the Court of Appeals from any order of a circuit*
6218 *court. Notwithstanding § 8.01-676.1, the final judgment or order of a circuit court shall not be*
6219 *suspended, stayed, or modified by such circuit court pending appeal to the Court of Appeals. Neither*
6220 *mandamus nor injunction shall lie in any such case.*

6221 **§ 4.1-1100. Possession, etc., of marijuana and marijuana products by persons 21 years of age or**
6222 **older lawful; penalties.**

6223 A. Except as otherwise provided in this subtitle and notwithstanding any other provision of law, a
6224 person 21 years of age or older may lawfully possess on his person or in any public place not more
6225 than one ounce of marijuana or an equivalent amount of marijuana product as determined by regulation
6226 promulgated by the Board.

6227 B. Any person who possesses on his person or in any public place marijuana or marijuana products
6228 in excess of the amounts set forth in subsection A is subject to a civil penalty of no more than \$25. The
6229 penalty for any violations of this section by an adult shall be prepayable according to the procedures in
6230 § 16.1-69.40:2.

6231 C. With the exception of a licensee in the course of his duties related to such licensee's marijuana
6232 establishment, any person who possesses on his person or in any public place (i) *more than four ounces*
6233 *but not more than one pound of marijuana or an equivalent amount of marijuana product as determined*
6234 *by regulation promulgated by the Board is guilty of a Class 3 misdemeanor and, for a second or*
6235 *subsequent offense, a Class 2 misdemeanor and (ii) more than one pound of marijuana or an equivalent*
6236 *amount of marijuana product as determined by regulation promulgated by the Board is guilty of a felony*
6237 *punishable by a term of imprisonment of not less than one year nor more than 10 years and a fine of*
6238 *not more than \$250,000, or both.*

6239 D. *With the exception of a licensee in the course of his duties related to such licensee's marijuana*
6240 *establishment, any person who possesses in his residence or in any place other than a public place*
6241 *more than four pounds of marijuana or an equivalent amount of marijuana product as determined by*
6242 *regulation promulgated by the Board is guilty of a felony punishable by a term of imprisonment of not*
6243 *less than one year nor more than 10 years and a fine of not more than \$250,000, or both.*

6244 E. The provisions of this section shall not apply to members of federal, state, county, city, or town
6245 law-enforcement agencies, jail officers, or correctional officers, as defined in § 53.1-1, certified as
6246 handlers of dogs trained in the detection of controlled substances when possession of marijuana is
6247 necessary for the performance of their duties.

6248 **§ 4.1-1101. Home cultivation of marijuana for personal use; penalties.**

6249 A. Notwithstanding the provisions of subdivision e (c) of § 18.2-248.1, a person 21 years of age or
6250 older may cultivate up to four marijuana plants for personal use at their place of residence; however, at
6251 no point shall a household contain more than four marijuana plants. For purposes of this section, a
6252 "household" means those individuals, whether related or not, who live in the same house or other place
6253 of residence.

6254 A person may only cultivate marijuana plants pursuant to this section at such person's main place of
6255 residence.

6256 *A violation of this subsection shall be punishable as follows:*

6257 1. *For possession of more than four marijuana plants but no more than 10 marijuana plants, (i) a*
6258 *civil penalty of \$250 for a first offense, (ii) a Class 3 misdemeanor for a second offense, and (iii) a*
6259 *Class 2 misdemeanor for a third and any subsequent offense;*

6260 2. *For possession of more than 10 but no more than 49 marijuana plants, a Class 1 misdemeanor;*

6261 3. *For possession of more than 49 but no more than 100 marijuana plants, a Class 6 felony; and*

6262 4. *For possession of more than 100 marijuana plants, a felony punishable by a term of imprisonment*
6263 *of not less than one year nor more than 10 years and a fine of not more than \$250,000, or both.*

6264 B. A person who cultivates marijuana for personal use pursuant to this section shall:

6265 1. Ensure that no marijuana plant is visible from a public way without the use of aircraft, binoculars,
6266 or other optical aids;

6267 2. Take precautions to prevent unauthorized access by persons younger than 21 years of age; and

6268 3. Attach to each marijuana plant a legible tag that includes the person's name, driver's license or
6269 identification number, and a notation that the marijuana plant is being grown for personal use as
6270 authorized under this section.

6271 *Any person who violates this subsection is subject to a civil penalty of no more than \$25. The*

penalty for any violations of this section by an adult shall be prepayable according to the procedures in § 16.1-69.40:2.

C. A person shall not manufacture marijuana concentrate from home-cultivated marijuana. The owner of a property or parcel or tract of land may not intentionally or knowingly allow another person to manufacture marijuana concentrate from home-cultivated marijuana within or on that property or land.

D. The following penalties or punishments shall be imposed on any person convicted of a violation of this section:

1. For possession of more than four marijuana plants but no more than 10 marijuana plants, (i) a civil penalty of \$250 for a first offense, (ii) a Class 3 misdemeanor for a second offense, and (iii) a Class 2 misdemeanor for a third and any subsequent offense;

2. For possession of more than 10 but no more than 49 marijuana plants, a Class 1 misdemeanor;

3. For possession of more than 49 but no more than 100 marijuana plants, a Class 6 felony; and

4. For possession of more than 100 marijuana plants, a felony punishable by a term of imprisonment of not less than one year nor more than 10 years and a fine of not more than \$250,000, or both.

§ 4.1-1102. Illegal cultivation or manufacture of marijuana or marijuana products; conspiracy; penalties.

A. Except as otherwise provided in §§ 4.1-700 and 4.1-1101, no person shall cultivate or manufacture marijuana or marijuana products in the Commonwealth without being licensed under this subtitle to cultivate or manufacture such marijuana or marijuana products.

B. Any person convicted of a violation of this section is guilty of a Class 6 felony.

C. If two or more persons conspire together to do any act that is in violation of subsection A, and one or more of such persons does any act to effect the object of the conspiracy, each of the parties to such conspiracy is guilty of a Class 6 felony.

§ 4.1-1103. Illegal sale of marijuana or marijuana products in general; penalties.

A. For the purposes of this section, "adult sharing" means transferring marijuana between persons who are 21 years of age or older without remuneration. "Adult sharing" does not include instances in which (i) marijuana is given away contemporaneously with another reciprocal transaction between the same parties; (ii) a gift of marijuana is offered or advertised in conjunction with an offer for the sale of goods or services; or (iii) a gift of marijuana is contingent upon a separate reciprocal transaction for goods or services.

B. If any person who is not licensed sells, gives, or distributes or possesses with intent to sell, give, or distribute any marijuana or marijuana products except as permitted by this chapter or provided in subsection C, he is guilty of a Class 2 misdemeanor.

A second or subsequent conviction under this section shall constitute a Class 1 misdemeanor.

C. No civil or criminal penalty may be imposed for adult sharing of an amount of marijuana that does not exceed one ounce or of an equivalent amount of marijuana products.

§ 4.1-1104. Persons to whom marijuana or marijuana products may not be sold; proof of legal age; penalties.

A. No person shall, except pursuant to § 4.1-700, sell, give, or distribute any marijuana or marijuana products to any individual when at the time of such sale he knows or has reason to believe that the individual to whom the sale is made is (i) younger than 21 years of age or (ii) intoxicated. Any person convicted of a violation of this subsection is guilty of a Class 1 misdemeanor.

B. It is unlawful for any person 21 years of age or older to sell or distribute, or possess with the intent to sell or distribute, marijuana paraphernalia to any person younger than 21 years of age. Any person who violates this subsection is guilty of a Class 1 misdemeanor.

C. It is unlawful for any person 21 years of age or older to place in any newspaper, magazine, handbill, or other publication any advertisement, knowing or under circumstances where one reasonably should know, that the purpose of the advertisement, in whole or in part, is to promote the sale of marijuana paraphernalia to persons younger than 21 years of age. Any person who violates this subsection is guilty of a Class 1 misdemeanor.

D. Any person who sells, except pursuant to § 4.1-700, any marijuana or marijuana products to an individual who is younger than 21 years of age and at the time of the sale does not require the individual to present bona fide evidence of legal age indicating that the individual is 21 years of age or older is guilty of a violation of this subsection. Bona fide evidence of legal age is limited to any evidence that is or reasonably appears to be an unexpired driver's license issued by any state of the United States or the District of Columbia, military identification card, United States passport or foreign government visa, unexpired special identification card issued by the Department of Motor Vehicles, or any other valid government-issued identification card bearing the individual's photograph, signature, height, weight, and date of birth, or which bears a photograph that reasonably appears to match the appearance of the purchaser. A student identification card shall not constitute bona fide evidence of legal age for purposes of this subsection. Any person convicted of a violation of this subsection is guilty

6333 of a Class 3 misdemeanor. Notwithstanding the provisions of § 4.1-701, the Board shall not take
6334 administrative action against a licensee for the conduct of his employee who violates this subsection.

6335 E. No person shall be convicted of both subsections A and D for the same sale.

6336 **§ 4.1-1105. Purchasing of marijuana or marijuana products unlawful in certain cases; venue;**
6337 **exceptions; penalties; forfeiture; treatment and education programs and services.**

6338 A. No person to whom retail marijuana or retail marijuana products may not lawfully be sold under
6339 § 4.1-1104 shall consume, purchase, or possess, or attempt to consume, purchase, or possess, any
6340 marijuana or marijuana products, except (i) pursuant to § 4.1-700 or (ii) by any federal, state, or local
6341 law-enforcement officer or his agent when possession of marijuana or marijuana products is necessary
6342 in the performance of his duties. Such person may be prosecuted either in the county or city in which
6343 the marijuana or marijuana products were possessed or consumed or in the county or city in which the
6344 person exhibits evidence of physical indicia of consumption of marijuana or marijuana products.

6345 B. Any person 18 years of age or older who violates subsection A is subject to a civil penalty of no
6346 more than \$25 and shall be ordered to enter a substance abuse treatment or education program or
6347 both, if available, that in the opinion of the court best suits the needs of the accused.

6348 C. Unless the juvenile is proceeded against informally pursuant to § 16.1-260, any juvenile who
6349 violates subsection A is subject to a civil penalty of no more than \$25 and the court shall require the
6350 accused to enter a substance abuse treatment or education program or both, if available, that in the
6351 opinion of the court best suits the needs of the accused. For purposes of §§ 16.1-266, 16.1-273,
6352 16.1-278.8, 16.1-278.8:01, and 16.1-278.9, the court shall treat the child as delinquent.

6353 D. Any such substance abuse treatment or education program to which a juvenile is ordered
6354 pursuant to this section shall be provided by (i) a program licensed by the Department of Behavioral
6355 Health and Developmental Services or (ii) a similar program available through a facility or program
6356 operated by or under contract with the Department of Juvenile Justice or a locally operated court
6357 services unit or a program funded through the Virginia Juvenile Community Crime Control Act
6358 (§ 16.1-309.2 et seq.). Any such substance abuse treatment or education program to which a person 18
6359 years of age or older is ordered pursuant to this section shall be provided by (a) a program licensed by
6360 the Department of Behavioral Health and Developmental Services or (b) a program or services made
6361 available through a community-based probation services agency established pursuant to Article 9
6362 (§ 9.1-173 et seq.) of Chapter 1 of Title 9.1, if one has been established for the locality. When an
6363 offender is ordered to a local community-based probation services agency, the local community-based
6364 probation services agency shall be responsible for providing for services or referring the offender to
6365 education or treatment services as a condition of probation.

6366 E. Any civil penalties collected pursuant to this section shall be deposited into the Drug Offender
6367 Assessment and Treatment Fund established pursuant to § 18.2-251.02. No person younger than 21
6368 years of age shall use or attempt to use any (i) altered, fictitious, facsimile, or simulated license to
6369 operate a motor vehicle; (ii) altered, fictitious, facsimile, or simulated document, including but not
6370 limited to a birth certificate or student identification card; or (iii) motor vehicle driver's license or other
6371 document issued under Chapter 3 (§ 46.2-300 et seq.) of Title 46.2 or the comparable law of another
6372 jurisdiction, birth certificate, or student identification card of another person in order to establish a
6373 false identification or false age for himself to consume, purchase, or attempt to consume or purchase
6374 retail marijuana or retail marijuana products. Any person convicted of a violation of this subsection is
6375 guilty of a Class 1 misdemeanor.

6376 F. Any marijuana or marijuana product purchased or possessed in violation of this section shall be
6377 deemed contraband and forfeited to the Commonwealth in accordance with § 4.1-1304.

6378 G. Any retail marijuana store licensee who in good faith promptly notifies the Board or any state or
6379 local law-enforcement agency of a violation or suspected violation of this section shall be accorded
6380 immunity from an administrative penalty for a violation of § 4.1-1104.

6381 **§ 4.1-1105.1. Possession of marijuana or marijuana products unlawful in certain cases; venue;**
6382 **exceptions; penalties; treatment and education programs and services.**

6383 A. No person younger than 21 years of age shall consume or possess, or attempt to consume or
6384 possess, any marijuana or marijuana products, except by any federal, state, or local law-enforcement
6385 officer or his agent when possession of marijuana or marijuana products is necessary in the performance
6386 of his duties. Such person may be prosecuted either in the county or city in which the marijuana or
6387 marijuana products were possessed or consumed or in the county or city in which the person exhibits
6388 evidence of physical indicia of consumption of marijuana or marijuana products.

6389 B. Any person 18 years of age or older who violates subsection A is subject to a civil penalty of no
6390 more than \$25 and shall be ordered to enter a substance abuse treatment or education program or both,
6391 if available, that in the opinion of the court best suits the needs of the accused.

6392 C. ~~Any~~ Unless the juvenile is proceeded against informally pursuant to § 16.1-260, any juvenile who
6393 violates subsection A is subject to a civil penalty of no more than \$25 and the court shall require the
6394 accused to enter a substance abuse treatment or education program or both, if available, that in the

opinion of the court best suits the needs of the accused. For purposes of §§ 16.1-266, 16.1-273, 16.1-278.8, 16.1-278.8:01, and 16.1-278.9, the court shall treat the child as delinquent.

D. Any such substance abuse treatment or education program to which a person is ordered pursuant to this section shall be provided by (i) a program licensed by the Department of Behavioral Health and Developmental Services or (ii) a program or services made available through a community-based probation services agency established pursuant to Article 9 (§ 9.1-173 et seq.) of Chapter 1 of Title 9.1, if one has been established for the locality. When an offender is ordered to a local community-based probation services agency, the local community-based probation services agency shall be responsible for providing for services or referring the offender to education or treatment services as a condition of probation.

E. Any civil penalties collected pursuant to this section shall be deposited into the Drug Offender Assessment and Treatment Fund established pursuant to § 18.2-251.02.

§ 4.1-1106. Purchasing retail marijuana or retail marijuana products for one to whom they may not be sold; penalties; forfeiture.

A. Any person who purchases retail marijuana or retail marijuana products for another person and at the time of such purchase knows or has reason to believe that the person for whom the retail marijuana or retail marijuana products were purchased was intoxicated is guilty of a Class 1 misdemeanor.

B. Any person who purchases for, or otherwise gives, provides, or assists in the provision of retail marijuana or retail marijuana products to, another person when he knows or has reason to know that such person is younger than 21 years of age, except by any federal, state, or local law-enforcement officer when possession of marijuana or marijuana products is necessary in the performance of his duties, is guilty of a Class 1 misdemeanor.

C. Any marijuana or marijuana products purchased in violation of this section shall be deemed contraband and forfeited to the Commonwealth in accordance with § 4.1-1304.

§ 4.1-1107. Using or consuming marijuana or marijuana products while in a motor vehicle being driven upon a public highway; penalty.

A. For the purposes of this section:

"Open container" means any vessel containing marijuana or marijuana products, except the originally sealed manufacturer's container.

"Passenger area" means the area designed to seat the driver of any motor vehicle, any area within the reach of the driver, including an unlocked glove compartment, and the area designed to seat passengers. "Passenger area" does not include the trunk of any passenger vehicle; the area behind the last upright seat of a passenger van, station wagon, hatchback, sport utility vehicle or any similar vehicle; the living quarters of a motor home; or the passenger area of a motor vehicle designed, maintained, or used primarily for the transportation of persons for compensation, including a bus, taxi, or limousine, while engaged in the transportation of such persons.

B. It is unlawful for any person to use or consume marijuana or marijuana products while driving a motor vehicle upon a public highway of the Commonwealth or while being a passenger in a motor vehicle being driven upon a public highway of the Commonwealth.

C. B. A judge or jury may make a permissive inference that a person has consumed marijuana or marijuana products in violation of this section if (i) ~~an open container is the marijuana or marijuana products~~ are located within the reach of the driver or passenger area of the motor vehicle, (ii) the marijuana or marijuana products in the open container have been at least partially removed ~~are not secured in a closed container, compartment, or vessel~~, and (iii) the appearance, conduct, speech, or other physical characteristic of such person, excluding odor, is consistent with the consumption of marijuana or marijuana products. Such person may be prosecuted either in the county or city in which the marijuana was used or consumed, or in the county or city in which the person exhibits evidence of physical indicia of use or consumption of marijuana.

D. C. Any person who violates this section is guilty of a Class 4 misdemeanor.

§ 4.1-1108. Consuming marijuana or marijuana products, or offering to another, in public place; penalty.

A. No person shall consume marijuana or a marijuana product or offer marijuana or a marijuana product to another, whether accepted or not, at or in any public place.

B. Any person who violates this section is subject to a civil penalty of no more than \$25 for a first offense. A person who is convicted under this section of a second offense is subject to a \$25 civil penalty and shall be ordered to enter a substance abuse treatment or education program or both, if available, that in the opinion of the court best suits the needs of the accused. A person convicted under this section of a third or subsequent offense is guilty of a Class 4 misdemeanor.

§ 4.1-1111. Illegal importation, shipment, and transportation of marijuana or marijuana products; penalty; exception.

6456 A. No marijuana or marijuana products shall be imported, shipped, transported, or brought into the
6457 Commonwealth.

6458 B. Any person convicted of a violation of this section shall be subject to a civil penalty of no more
6459 than \$25. The penalty for any violations of this section by an adult shall be prepayable according to the
6460 procedures in § 16.1-69.40:2.

6461 **§ 4.1-1113. Maintaining common nuisances; penalties.**

6462 A. All houses, boathouses, buildings, club or fraternity or lodge rooms, boats, cars, and places of
6463 every description where marijuana or marijuana products are manufactured, stored, sold, dispensed,
6464 given away, or used contrary to law, by any scheme or device whatsoever, shall be deemed common
6465 nuisances.

6466 No person shall maintain, aid, abet, or knowingly associate with others in maintaining a common
6467 nuisance.

6468 Any person convicted of a violation of this subsection is guilty of a Class 1 misdemeanor.

6469 B. In addition, after due notice and opportunity to be heard on the part of any owner or lessor not
6470 involved in the original offense, by a proceeding analogous to that provided in §§ 4.1-1304 and
6471 4.1-1305 and upon proof of guilty knowledge, judgment may be given that such house, boathouse,
6472 building, boat, car, or other place, or any room or part thereof, be closed. The court may, upon the
6473 owner or lessor giving bond in the penalty of not less than \$500 and with security to be approved by
6474 the court, conditioned that the premises shall not be used for unlawful purposes, or in violation of the
6475 provisions of this subtitle for a period of five years, turn the same over to its owner or lessor, or
6476 proceeding may be had in equity as provided in § 4.1-1305.

6477 C. In a proceeding under this section, judgment shall not be entered against the owner, lessor, or
6478 lienholder of the property unless it is proved that he (i) knew of the unlawful use of the property and
6479 (ii) had the right, because of such unlawful use, to enter and repossess the property.

6480 **§ 4.1-1114. Maintaining a fortified drug house; penalty.**

6481 Any office, store, shop, restaurant, dance hall, theater, poolroom, clubhouse, storehouse, warehouse,
6482 dwelling house, apartment, or building or structure of any kind that is (i) substantially altered from its
6483 original status by means of reinforcement with the intent to impede, deter, or delay lawful entry by a
6484 law-enforcement officer into such structure; (ii) being used for the purpose of illegally manufacturing or
6485 distributing marijuana; and (iii) the object of a valid search warrant shall be considered a fortified drug
6486 house. Any person who maintains or operates a fortified drug house is guilty of a Class 5 felony.

6487 **§ 4.1-1115. Disobeying subpoena; hindering conduct of hearing; penalty.**

6488 No person shall (i) fail or refuse to obey any subpoena issued by the Board, any Board member, or
6489 any agent authorized by the Board to issue such subpoena or (ii) hinder the orderly conduct and
6490 decorum of any hearing held and conducted by the Board, any Board member, or any agent authorized
6491 by the Board to hold and conduct such hearing.

6492 Any person convicted of a violation of this section is guilty of a Class 1 misdemeanor.

6493 **§ 4.1-1116. Illegal advertising; penalty; exception.**

6494 A. Except in accordance with this title and Board regulations, no person shall advertise in or send
6495 any advertising matter into the Commonwealth about or concerning marijuana other than such that may
6496 legally be manufactured or sold without a license.

6497 B. Marijuana cultivation facility licensees, marijuana manufacturing facility licensees, marijuana
6498 wholesaler licensees, and retail marijuana store licensees may engage in the display of outdoor retail
6499 marijuana or retail marijuana products advertising on lawfully erected signs, provided that such display
6500 is done in accordance with § 4.1-1405 and Board regulations.

6501 C. Except as provided in subsection D, any person convicted of a violation of this section is guilty of
6502 a Class 1 misdemeanor.

6503 D. For violations of § 4.1-1405 relating to distance and zoning restrictions on outdoor advertising,
6504 the Board shall give the advertiser written notice to take corrective action to either bring the
6505 advertisement into compliance with this title and Board regulations or to remove such advertisement. If
6506 corrective action is not taken within 30 days, the advertiser is guilty of a Class 4 misdemeanor.

6507 **§ 4.1-1117. Delivery of marijuana or marijuana products to prisoners; penalty.**

6508 No person shall deliver, or cause to be delivered, to any prisoner in any state, local, or regional
6509 correctional facility or any person committed to the Department of Juvenile Justice in any juvenile
6510 correctional center any marijuana or marijuana products.

6511 Any person convicted of a violation of this section is guilty of a Class 1 misdemeanor.

6512 **§ 4.1-1118. Separation of plant resin by butane extraction; penalty.**

6513 A. No person shall separate plant resin by butane extraction or another method that utilizes a
6514 substance with a flashpoint below 100 degrees Fahrenheit in any public place, motor vehicle, or within
6515 the curtilage of any residential structure.

6516 B. Any person convicted of a violation of this section is guilty of a Class 1 misdemeanor.

6517 **§ 4.1-1119. Attempts; aiding or abetting; penalty.**

No person shall attempt to do any of the things prohibited by this subtitle or to aid or abet another in doing, or attempting to do, any of the things prohibited by this subtitle.

On an indictment, information, or warrant for the violation of this subtitle, the jury or the court may find the defendant guilty of an attempt, or being an accessory, and the punishment shall be the same as if the defendant were solely guilty of such violation.

§ 4.1-1121. Issuance of summonses for certain offenses; civil penalties.

Any violation under this subtitle that is subject to a civil penalty is a civil offense and, except in the case of a violation alleged to have been committed by a juvenile, in which case the juvenile shall be proceeded against pursuant to § 16.1-260, shall be charged by summons. A summons for a violation under this subtitle that is subject to a civil penalty may be executed by a law-enforcement officer when such violation is observed by such officer. The summons used by a law-enforcement officer pursuant to this section shall be in a form the same as the uniform summons for motor vehicle law violations as prescribed pursuant to § 46.2-388. Any civil penalties collected pursuant to this subtitle shall be deposited into the Drug Offender Assessment and Treatment Fund established pursuant to § 18.2-251.02.

CHAPTER 12.

PROHIBITED PRACTICES BY LICENSEES.

§ 4.1-1200. Illegal cultivation, etc., of marijuana or marijuana products by licensees; penalty.

A. No licensee or any agent or employee of such licensee shall:

1. Cultivate, manufacture, transport, sell, or test any retail marijuana or retail marijuana products of a kind other than that which such license or this subtitle authorizes him to cultivate, manufacture, transport, sell, or test;

2. Sell retail marijuana or retail marijuana products to any person other than a person to whom such license or this subtitle authorizes him to sell;

3. Cultivate, manufacture, transport, sell, or test retail marijuana or retail marijuana products that such license or this subtitle authorizes him to sell, but in any place or in any manner other than such license or this subtitle authorizes him to cultivate, manufacture, transport, sell, or test;

4. Cultivate, manufacture, transport, sell, or test any retail marijuana or retail marijuana products when forbidden by this subtitle;

5. Keep or allow to be kept, other than in his residence and for his personal use, any retail marijuana or retail marijuana products other than that which he is authorized to cultivate, manufacture, transport, sell, or test by such license or by this subtitle;

6. Keep any retail marijuana or retail marijuana product other than in the container in which it was purchased by him; or

7. Allow a person younger than 21 years of age to be employed by or volunteer for such licensee at a retail marijuana store.

B. Any person convicted of a violation of this section is guilty of a Class 1 misdemeanor.

§ 4.1-1201. Prohibited acts by employees of retail marijuana store licensees; civil penalty.

A. In addition to the provisions of § 4.1-1200, no retail marijuana store licensee or his agent or employee shall consume any retail marijuana or retail marijuana products while on duty and in a position that is involved in the selling of retail marijuana or retail marijuana products to consumers.

B. No retail marijuana store licensee or his agent or employee shall make any gift of any retail marijuana or retail marijuana products.

C. Any person convicted of a violation of this section shall be subject to a civil penalty in an amount not to exceed \$500.

§ 4.1-1202. Sale of; purchase for resale; retail marijuana or retail marijuana products from a person without a license; penalty.

Except as otherwise provided in § 4.1-805, no retail marijuana store licensee shall purchase for resale or sell any retail marijuana, retail marijuana products, immature marijuana plants, or marijuana seeds purchased from anyone other than a marijuana cultivation facility, marijuana manufacturing facility, or marijuana wholesaler licensee.

Any person convicted of a violation of this section is guilty of a Class 1 misdemeanor.

§ 4.1-1203. Prohibiting transfer of retail marijuana or retail marijuana products by licensees; penalty.

A. No retail marijuana store licensee shall transfer any retail marijuana or retail marijuana products from one licensed place of business to another licensed place of business, whether or not such places of business are under the same ownership.

B. Any person convicted of a violation of this section is guilty of a Class 1 misdemeanor.

§ 4.1-1204. Illegal advertising materials; civil penalty.

No person subject to the jurisdiction of the Board shall induce, attempt to induce, or consent to any licensee selling, renting, lending, buying for, or giving to any person any advertising materials or decorations under circumstances prohibited by this title or Board regulations.

6579 Any person found by the Board to have violated this section shall be subject to a civil penalty as
6580 authorized in § 4.1-903.

6581 **§ 4.1-1205. Solicitation by persons interested in manufacture, etc., of retail marijuana or retail**
6582 **marijuana products; penalty.**

6583 A. No person having any interest, direct or indirect, in the manufacture, distribution, or sale of retail
6584 marijuana or retail marijuana products shall, without a permit granted by the Board and upon such
6585 conditions as the Board may prescribe, solicit either directly or indirectly (i) a retail marijuana store
6586 licensee; (ii) any agent or employee of such licensee; or (iii) any person connected with the licensee in
6587 any capacity whatsoever in his licensed business to sell or offer for sale the retail marijuana or retail
6588 marijuana products in which such person may be so interested.

6589 The Board, upon proof of any solicitation in violation of this subsection, may suspend or terminate
6590 the sale of the retail marijuana or retail marijuana products that were the subject matter of the
6591 unlawful solicitation or promotion. In addition, the Board may suspend or terminate the sale of all retail
6592 marijuana or retail marijuana products manufactured or distributed by either the employer or principal
6593 of such solicitor, the broker, or by the owner of the brand unlawfully solicited or promoted. The Board
6594 may impose a civil penalty not to exceed \$250,000 in lieu of such suspension or termination of sales, or
6595 both.

6596 Any person convicted of a violation of this subsection is guilty of a Class 1 misdemeanor.

6597 B. No retail marijuana store licensee or any agent or employee of such licensee, or any person
6598 connected with the licensee in any capacity whatsoever in his licensed business shall, either directly or
6599 indirectly, be a party to, consent to, solicit, or aid or abet another in a violation of subsection A.

6600 The Board may suspend or revoke the license granted to such licensee or may impose a civil penalty
6601 not to exceed \$25,000 in lieu of such suspension or any portion thereof, or both.

6602 Any person convicted of a violation of this subsection is guilty of a Class 1 misdemeanor.

6603 **§ 4.1-1206. Failure of licensee to pay tax or to deliver, keep, and preserve records and accounts or**
6604 **to allow examination and inspection; penalty.**

6605 A. No licensee shall fail or refuse to (i) pay any tax provided for in § 4.1-1003 or 4.1-1004; (ii)
6606 deliver, keep, and preserve such records, invoices, and accounts as are required by § 4.1-703 or Board
6607 regulation; or (iii) allow such records, invoices, and accounts or his place of business to be examined
6608 and inspected in accordance with § 4.1-703. Any person convicted of a violation of this subsection is
6609 guilty of a Class 1 misdemeanor.

6610 B. After reasonable notice to a licensee that failed to make a return or pay taxes due, the Authority
6611 may suspend or revoke any license of such licensee that was issued by the Authority.

6612 **§ 4.1-1207. Nonpayment of marijuana tax; penalties.**

6613 A. No person shall make a sale taxable under § 4.1-1003 or 4.1-1004 without paying all applicable
6614 taxes due under §§ 4.1-1003 and 4.1-1004. No retail marijuana store licensee shall purchase, receive,
6615 transport, store, or sell any retail marijuana or retail marijuana products on which such retailer has
6616 reason to know such tax has not been paid and may not be paid. Any person convicted of a violation of
6617 this subsection is guilty of a Class 1 misdemeanor.

6618 B. Any person who fails to file a return required for a tax due under § 4.1-1003 or 4.1-1004 is
6619 subject to a civil penalty to be added to the tax in the amount of five percent of the proper tax due if
6620 the failure is for not more than 30 days, with an additional five percent for each additional 30 days, or
6621 fraction thereof, during which the failure continues. Such civil penalty shall not exceed 25 percent in the
6622 aggregate.

6623 C. In the case of a false or fraudulent return, where willful intent exists to defraud the
6624 Commonwealth of any tax due on retail marijuana or retail marijuana products, a civil penalty of 50
6625 percent of the amount of the proper tax due shall be assessed. Such penalty shall be in addition to any
6626 penalty imposed under subsection B. It shall be prima facie evidence of willful intent to defraud the
6627 Commonwealth when any person reports its taxable sales to the Authority at 50 percent or less of the
6628 actual amount.

6629 D. If any check tendered for any amount due under § 4.1-1003 or 4.1-1004 or this section is not
6630 paid by the bank on which it is drawn, and the person that tendered the check fails to pay the Authority
6631 the amount due within five days after the Authority gives it notice that such check was returned unpaid,
6632 the person that tendered the check is guilty of a violation of § 18.2-182.1.

6633 E. All penalties shall be payable to the Authority and if not so paid shall be collectible in the same
6634 manner as if they were a part of the tax imposed.

6635 **§ 4.1-1300. Enjoining nuisances.**

6636 A. In addition to the penalties imposed by § 4.1-1113, the Board, its special agents, the attorney for
6637 the Commonwealth, or any citizen of the county, city, or town where a common nuisance as defined in
6638 § 4.1-1113 exists may maintain a suit in equity in the name of the Commonwealth to enjoin the common
6639 nuisance.

6640 B. The courts of equity shall have jurisdiction, and in every case where the bill charges, on the

knowledge or belief of the complainant, and is sworn to by two reputable citizens, that marijuana or marijuana products are cultivated, manufactured, stored, sold, dispensed, given away, or used in such house, building, or other place described in § 4.1-1113 contrary to the laws of the Commonwealth, an injunction shall be granted as soon as the bill is presented to the court. The injunction shall enjoin and restrain the owners and tenants and their agents and employees, and any person connected with such house, building, or other place, and all persons whomsoever from cultivating, manufacturing, storing, selling, dispensing, giving away, or using marijuana or marijuana products on such premises. The injunction shall also restrain all persons from removing any marijuana or marijuana products then on such premises until the further order of the court. If the court is satisfied that the material allegations of the bill are true, although the premises complained of may not then be unlawfully used, it shall continue the injunction against such place for a period of time as the court deems proper. The injunction may be dissolved if a proper case is shown for dissolution.

§ 4.1-1301. Contraband marijuana or marijuana products and other articles subject to forfeiture.

A. All apparatus and materials for the cultivation or manufacture of marijuana or marijuana products, all marijuana or marijuana products and materials used in their manufacture, all containers in which marijuana or marijuana products may be found, that are kept, stored, possessed, or in any manner used in violation of the provisions of this subtitle, and any dangerous weapons as described in § 18.2-308 that may be used or that may be found upon the person, or in any vehicle that such person is using, to aid such person in the unlawful cultivation, manufacture, transportation, or sale of marijuana or marijuana products, or found in the possession of such person, or any horse, mule, or other beast of burden or any wagon, automobile, truck, or vehicle of any nature whatsoever that is found in the immediate vicinity of any place where marijuana or marijuana products are being unlawfully manufactured and where such animal or vehicle is being used to aid in the unlawful manufacture, shall be deemed contraband and shall be forfeited to the Commonwealth.

B. Proceedings for the confiscation of the property in subsection A shall be in accordance with § 4.1-1304 for all such property except motor vehicles, which proceedings shall be in accordance with Chapter 22.1 (§ 19.2-386.1 et seq.) of Title 19.2.

§ 4.1-1303. Search warrants.

A. If complaint on oath is made that marijuana or marijuana products are being cultivated, manufactured, sold, kept, stored, or in any manner held, used, or concealed in a particular house, or other place, in violation of law, the judge, magistrate, or other person having authority to issue criminal warrants, to whom such complaint is made, if satisfied that there is a probable cause for such belief, shall issue a warrant to search such house or other place for marijuana or marijuana products. Such warrants, except as herein otherwise provided, shall be issued, directed, and executed in accordance with the laws of the Commonwealth pertaining to search warrants.

B. Warrants issued under this subtitle for the search of any automobile, boat, conveyance, or vehicle, whether of like kind or not, or for the search of any article of baggage, whether of like kind or not, for marijuana or marijuana products may be executed in any part of the Commonwealth where they are overtaken and shall be made returnable before any judge within whose jurisdiction such automobile, boat, conveyance, vehicle, truck, or article of baggage, or any of them, was transported or attempted to be transported contrary to law.

§ 4.1-1304. Confiscation proceedings; disposition of forfeited articles.

A. All proceedings for the confiscation of articles, except motor vehicles, declared contraband and forfeited to the Commonwealth under this subtitle shall be as provided in this section.

B. Production of seized property. Whenever any article declared contraband under the provisions of this subtitle and required to be forfeited to the Commonwealth has been seized, with or without a warrant, by any officer charged with the enforcement of this subtitle, he shall produce the contraband article and any person in whose possession it was found. In those cases where no person is found in possession of such articles, the return shall so state and a copy of the warrant shall be posted on the door of the buildings or room where the articles were found, or if there is no door, then in any conspicuous place upon the premises.

In case of seizure of any item for any offense involving its forfeiture where it is impracticable to remove such item to a place of safe storage from the place where seized, the seizing officer may destroy such item only as necessary to prevent use of all or any part thereof. The destruction shall be in the presence of at least one credible witness, and such witness shall join the officer in a sworn report of the seizure and destruction to be made to the Board. The report shall set forth the grounds of the claim of forfeiture, the reasons for seizure and destruction, an estimate of the fair cash value of the item destroyed, and the materials remaining after such destruction. The report shall include a statement that, from facts within their own knowledge, the seizing officer and witness have no doubt whatever that the item was set up for use, or had been used in the unlawful cultivation or manufacture of marijuana, and that it was impracticable to remove such apparatus to a place of safe storage.

6702 *In case of seizure of any quantity of marijuana or marijuana products for any offense involving*
6703 *forfeiture of the same, the seizing officer may destroy them to prevent the use of all or any part thereof*
6704 *for the purpose of unlawful cultivation or manufacture of marijuana or marijuana products or any other*
6705 *violation of this subtitle. The destruction shall be in the presence of at least one credible witness, and*
6706 *such witness shall join the officer in a sworn report of the seizure and destruction to be made to the*
6707 *Board. The report shall set forth the grounds of the claim of forfeiture, the reasons for seizure and*
6708 *destruction, and a statement that, from facts within their own knowledge, the seizing officer and witness*
6709 *have no doubt whatever that the marijuana or marijuana products were intended for use in the unlawful*
6710 *cultivation or manufacture of marijuana or marijuana products or were intended for use in violation of*
6711 *this subtitle.*

6712 *C. Hearing and determination. Upon the return of the warrant as provided in this section, the court*
6713 *shall fix a time not less than 10 days, unless waived by the accused in writing, and not more than 30*
6714 *days thereafter, for the hearing on such return to determine whether or not the articles seized, or any*
6715 *part thereof, were used or in any manner kept, stored, or possessed in violation of this subtitle.*

6716 *At such hearing, if no claimant appears, the court shall declare the articles seized forfeited to the*
6717 *Commonwealth and, if such articles are not necessary as evidence in any pending prosecution, shall*
6718 *turn them over to the Board. Any person claiming an interest in any of the articles seized may appear*
6719 *at the hearing and file a written claim setting forth particularly the character and extent of his interest.*
6720 *The court shall certify the warrant and the articles seized along with any claim filed to the circuit court*
6721 *to hear and determine the validity of such claim.*

6722 *If the evidence warrants, the court shall enter a judgment of forfeiture and order the articles seized*
6723 *to be turned over to the Board. Action under this section and the forfeiture of any articles hereunder*
6724 *shall not be a bar to any prosecution under any other provision of this subtitle.*

6725 *D. Disposition of forfeited articles. Any articles forfeited to the Commonwealth and turned over to*
6726 *the Board in accordance with this section shall be destroyed or sold by the Board as it deems proper.*
6727 *The net proceeds from such sales shall be paid into the Literary Fund.*

6728 *If the Board believes that any foodstuffs forfeited to the Commonwealth and turned over to the Board*
6729 *in accordance with this section are usable, should not be destroyed, and cannot be sold or whose sale*
6730 *would be impractical, it may give such foodstuffs to any institution in the Commonwealth and shall*
6731 *prefer a gift to the local jail or other local correctional facility in the jurisdiction where seizure took*
6732 *place. A record shall be made showing the nature of the foodstuffs and amount given, to whom given,*
6733 *and the date when given and shall be kept in the offices of the Board.*

6734 **§ 4.1-1305. Search and seizure of conveyances or vehicles used in violation of law; arrests.**

6735 *A. When any officer charged with the enforcement of the cannabis control laws of the*
6736 *Commonwealth has reason to believe that retail marijuana or retail marijuana products illegally*
6737 *acquired, or being illegally transported, are in any conveyance or vehicle of any kind, either on land or*
6738 *on water, except a conveyance or vehicle owned or operated by a railroad, express, sleeping, or parlor*
6739 *car or a steamboat company, other than barges, tugs, or small craft, he shall obtain a search warrant*
6740 *and search such conveyance or vehicle. If illegally acquired retail marijuana or retail marijuana*
6741 *products or retail marijuana or retail marijuana products being illegally transported in amounts in*
6742 *excess of two and one-half ounces of retail marijuana, 16 ounces of solid retail marijuana product, or*
6743 *72 ounces of liquid retail marijuana product, the officer shall seize the retail marijuana or retail*
6744 *marijuana product, seize and take possession of such conveyance or vehicle, and deliver them to the*
6745 *chief law-enforcement officer of the locality in which such seizure was made, taking his receipt therefor*
6746 *in duplicate.*

6747 *B. The officer making such seizure shall forthwith report in writing such seizure and arrest to the*
6748 *attorney for the Commonwealth for the county or city in which the seizure and arrest were made.*

6749 **§ 4.1-1306. Contraband retail marijuana or retail marijuana products.**

6750 *Retail marijuana or retail marijuana products seized pursuant to § 4.1-1305 shall be deemed*
6751 *contraband and disposed of accordingly. Failure to maintain on a conveyance or vehicle a permit or*
6752 *other indicia of permission issued by the Board authorizing the transportation of retail marijuana or*
6753 *retail marijuana products within the Commonwealth when other Board regulations applicable to such*
6754 *transportation have been complied with shall not be cause for deeming such retail marijuana or retail*
6755 *marijuana products contraband.*

6756 **§ 4.1-1307. Punishment for violations of title or regulations; bond.**

6757 *A. Any person convicted of a misdemeanor under the provisions of this subtitle without specification*
6758 *as to the class of offense or penalty, or convicted of violating any other provision thereof, or convicted*
6759 *of violating any Board regulation is guilty of a Class 1 misdemeanor.*

6760 *B. In addition to the penalties imposed by this subtitle for violations, any court before whom any*
6761 *person is convicted of a violation of any provision of this subtitle may require such defendant to execute*
6762 *bond based upon his ability to pay, with approved security, in the penalty of not more than \$1,000, with*
6763 *the condition that the defendant will not violate any of the provisions of this subtitle for the term of one*

year. If any such bond is required and is not given, the defendant shall be committed to jail until it is given, or until he is discharged by the court, provided that he shall not be confined for a period longer than six months. If any such bond required by a court is not given during the term of the court by which conviction is had, it may be given before any judge or before the clerk of such court.

C. The provisions of this subtitle shall not prevent the Board from suspending, revoking, or refusing to continue the license of any person convicted of a violation of any provision of this subtitle.

D. No court shall hear such a case unless the respective attorney for the Commonwealth or his assistant has been notified that such a case is pending.

§ 4.1-1308. Witness not excused from testifying because of self-incrimination.

No person shall be excused from testifying for the Commonwealth as to any offense committed by another under this subtitle by reason of his testimony tending to incriminate him. The testimony given by such person on behalf of the Commonwealth when called as a witness for the prosecution shall not be used against him and he shall not be prosecuted for the offense to which he testifies.

§ 4.1-1309. Previous convictions.

In any indictment, information, or warrant charging any person with a violation of any provision of this subtitle, it may be alleged and evidence may be introduced at the trial of such person to prove that such person has been previously convicted of a violation of this subtitle.

§ 4.1-1310. Certificate of forensic scientist as evidence; requiring forensic scientist to appear.

The certificate of any forensic scientist employed by the Commonwealth on behalf of the Board or the Department of Forensic Science, when signed by him, shall be admissible as evidence of the facts therein stated and of the results of such analysis (i) in any criminal proceeding, provided the requirements of subsection A of § 19.2-187.1 have been satisfied and the accused has not objected to the admission of the certificate pursuant to subsection B of § 19.2-187.1 or (ii) in any civil proceeding. On motion of the accused or any party in interest, the court may require the forensic scientist making the analysis to appear as a witness and be subject to cross-examination, provided such motion is made within a reasonable time prior to the day on which the case is set for trial.

§ 4.1-1311. Label on sealed container prima facie evidence of marijuana content.

In any prosecution for violations of this subtitle, where a sealed container is labeled as containing retail marijuana or retail marijuana products, such labeling shall be prima facie evidence of the marijuana content of the container. Nothing shall preclude the introduction of other relevant evidence to establish the marijuana content of a container, whether sealed or not.

§ 4.1-1312. No recovery for retail marijuana or retail marijuana products illegally sold.

No action to recover the price of any retail marijuana or retail marijuana products sold in contravention of this subtitle may be maintained.

CHAPTER 14.

CANNABIS AND REGULATED HEMP PRODUCT CONTROL, TESTING, AND ADVERTISING.

§ 4.1-1400. Board to establish regulations for marijuana and regulated hemp product testing.

The Board shall establish a testing program for marijuana, marijuana products, and regulated hemp products. Except as otherwise provided in this subtitle or otherwise provided by law, the program shall require a licensee, prior to selling or distributing retail marijuana or a retail marijuana product to a consumer or to another licensee, or any persons, prior to selling a regulated hemp product, to submit a representative sample of the retail marijuana, retail marijuana product, or regulated hemp product, not to exceed 10 percent of the total harvest or batch, to a licensed marijuana testing facility for testing to ensure that the retail marijuana, retail marijuana product, or regulated hemp product does not exceed the maximum level of allowable contamination for any contaminant that is injurious to health and for which testing is required and to ensure correct labeling. The Board shall adopt regulations (i) establishing a testing program pursuant to this section; (ii) establishing acceptable testing and research practices, including regulations relating to testing practices, methods, and standards; quality control analysis; equipment certification and calibration; marijuana testing facility recordkeeping, documentation, and business practices; disposal of used, unused, and waste retail marijuana, retail marijuana products, and regulated hemp products; and reporting of test results; (iii) identifying the types of contaminants that are injurious to health for which retail marijuana, retail marijuana products, and regulated hemp products shall be tested under this subtitle; and (iv) establishing the maximum level of allowable contamination for each contaminant.

§ 4.1-1401. Mandatory testing; scope; recordkeeping; notification; additional testing not required; required destruction; random testing.

A. A licensee may not sell or distribute retail marijuana or a retail marijuana product to a consumer or to another licensee under this subtitle and a person may not sell a regulated hemp product unless a representative sample of the retail marijuana, retail marijuana product, or regulated hemp product has been tested pursuant to this subtitle and the regulations adopted pursuant to this subtitle and that mandatory testing has demonstrated that (i) the retail marijuana, retail marijuana product, or regulated

6825 *hemp product does not exceed the maximum level of allowable contamination for any contaminant that*
6826 *is injurious to health and for which testing is required and (ii) the labeling on the retail marijuana,*
6827 *retail marijuana product, or regulated hemp product is correct.*

6828 *B. Mandatory testing of retail marijuana, retail marijuana products, and regulated hemp products*
6829 *under this section shall include testing for:*

6830 *1. Residual solvents, poisons, and toxins;*

6831 *2. Harmful chemicals;*

6832 *3. Dangerous molds and mildew;*

6833 *4. Harmful microbes, including but not limited to Escherichia coli and Salmonella;*

6834 *5. Pesticides, fungicides, and insecticides; and*

6835 *6. Tetrahydrocannabinol (THC) potency, homogeneity, and cannabinoid profiles to ensure correct*
6836 *labeling.*

6837 *Testing shall be performed on the final form in which the retail marijuana, retail marijuana product,*
6838 *or regulated hemp product will be consumed.*

6839 *C. A licensee shall maintain a record of all mandatory testing that includes a description of the*
6840 *retail marijuana or retail marijuana product provided to the marijuana testing facility, the identity of*
6841 *the marijuana testing facility, and the results of the mandatory test. A person who sells a regulated*
6842 *hemp product shall maintain a record of all mandatory testing that includes a description of the*
6843 *regulated hemp product that person sells, the identity of the marijuana testing facility, and the results of*
6844 *the mandatory test.*

6845 *D. If the results of a mandatory test conducted pursuant to this section indicate that the tested retail*
6846 *marijuana, retail marijuana product, or regulated hemp product exceeds the maximum level of allowable*
6847 *tetrahydrocannabinol (THC) or contamination for any contaminant that is injurious to health and for*
6848 *which testing is required, the marijuana testing facility shall immediately quarantine, document, and*
6849 *properly destroy the retail marijuana, retail marijuana product, or regulated hemp product and within*
6850 *seven days of completing the test shall notify the Board of the test results.*

6851 *A marijuana testing facility is not required to notify the Board of the results of any test:*

6852 *1. Conducted on retail marijuana or a retail marijuana product at the direction of a licensee or*
6853 *conducted on a regulated hemp product at the direction of any person pursuant to this section that*
6854 *demonstrates that the retail marijuana or retail marijuana product does not exceed the maximum level*
6855 *of allowable tetrahydrocannabinol (THC) or contamination for any contaminant that is injurious to*
6856 *health and for which testing is required;*

6857 *2. Conducted on retail marijuana or a retail marijuana product at the direction of a licensee or*
6858 *conducted on a regulated hemp product at the direction of any person for research and development*
6859 *purposes only, so long as the licensee or person notifies the marijuana testing facility prior to the*
6860 *performance of the test that the testing is for research and development purposes only; or*

6861 *3. Conducted on retail marijuana or a retail marijuana product at the direction of a person who is*
6862 *not a licensee.*

6863 *E. Notwithstanding the foregoing, a licensee may sell or furnish to a consumer or to another licensee*
6864 *retail marijuana or a retail marijuana product or a person may sell a regulated hemp product that the*
6865 *licensee or person has not submitted for testing in accordance with this subtitle and regulations adopted*
6866 *pursuant to this subtitle if the following conditions are met:*

6867 *1. The retail marijuana or retail marijuana product has previously undergone testing in accordance*
6868 *with this subtitle and regulations adopted pursuant to this subtitle at the direction of another licensee or*
6869 *the regulated hemp product has previously undergone testing in accordance with this subtitle and*
6870 *regulations adopted pursuant to this subtitle at the direction of another person and that testing*
6871 *demonstrated that the retail marijuana, retail marijuana product, or regulated hemp product does not*
6872 *exceed the maximum level of allowable tetrahydrocannabinol (THC) or contamination for any*
6873 *contaminant that is injurious to health and for which testing is required;*

6874 *2. The mandatory testing process and the test results for the retail marijuana, retail marijuana*
6875 *product, or regulated hemp product are documented in accordance with the requirements of this subtitle*
6876 *and all applicable regulations adopted pursuant to this subtitle;*

6877 *3. Tracking from immature marijuana plant to the point of retail sale has been maintained for the*
6878 *retail marijuana or retail marijuana product and transfers of the retail marijuana or retail marijuana*
6879 *product to another licensee or to a consumer can be easily identified; and*

6880 *4. The retail marijuana, retail marijuana product, or regulated hemp product has not undergone any*
6881 *further processing, manufacturing, or alteration subsequent to the performance of the prior testing under*
6882 *subsection A.*

6883 *F. Licensees shall be required to destroy harvested batches of retail marijuana or batches of retail*
6884 *marijuana products and any person shall be required to destroy any batch of a regulated hemp product*
6885 *whose testing samples indicate noncompliance with the health and safety standards required by this*
6886 *subtitle and the regulations adopted by the Board pursuant to this subtitle, unless remedial measures*

can bring the retail marijuana, retail marijuana products, or regulated hemp products into compliance with such required health and safety standards.

G. A licensee shall comply with all requests for samples of retail marijuana and retail marijuana products and a person shall comply with all requests for samples of regulated hemp products for the purpose of random testing by a state-owned laboratory or state-approved private laboratory.

§ 4.1-1402. Labeling and packaging requirements; prohibitions.

A. Retail marijuana and retail marijuana products to be sold or offered for sale by a licensee to a consumer or regulated hemp products to be sold or offered for sale by a person in accordance with the provisions of this subtitle shall be labeled with the following information:

1. Identification of the type of retail marijuana, retail marijuana product, or regulated hemp product and the date of cultivation, manufacturing, and packaging;

2. The license numbers of the marijuana cultivation facility, the marijuana manufacturing facility, and the retail marijuana store where the retail marijuana or retail marijuana product was cultivated, manufactured, and offered for sale, as applicable;

3. A statement of the net weight of the retail marijuana, retail marijuana product, or regulated hemp product;

4. Information concerning (i) pharmacologically active ingredients, including tetrahydrocannabinol (THC), cannabidiol (CBD), and other cannabinoid content; (ii) the THC and other cannabinoid amount in milligrams per serving, the total servings per package, and the THC and other cannabinoid amount in milligrams for the total package; and (iii) the potency of the THC and other cannabinoid content;

5. Information on gases, solvents, and chemicals used in marijuana extraction or the processing of a regulated hemp product, if applicable;

6. Instructions on usage;

7. For retail marijuana products and regulated hemp product, (i) a list of ingredients and possible allergens and (ii) a recommended use by date or expiration date;

8. For edible marijuana products and edible hemp products, a nutritional fact panel;

9. The following statement, prominently displayed in bold print and in a clear and legible fashion: "GOVERNMENT WARNING: THIS PACKAGE CONTAINS MARIJUANA. MARIJUANA IS FOR USE BY ADULTS 21 YEARS OF AGE AND OLDER. KEEP OUT OF REACH OF CHILDREN. CONSUMPTION OF MARIJUANA IMPAIRS COGNITION AND YOUR ABILITY TO DRIVE AND MAY BE HABIT FORMING. MARIJUANA SHOULD NOT BE USED WHILE PREGNANT OR BREASTFEEDING. PLEASE USE CAUTION AND VISIT _____ (website maintained by the Board pursuant to § 4.1-604) FOR MORE INFORMATION.";

10. A universal symbol stamped or embossed on the packaging of any retail marijuana and retail marijuana products; and

11. Any other information required by Board regulations.

B. Retail marijuana and retail marijuana products to be sold or offered for sale by a licensee to a consumer in accordance with the provisions of this subtitle and regulated hemp products to be sold or offered for sale by a person in accordance with the provisions of this subtitle shall be packaged in the following manner:

1. Retail marijuana, retail marijuana products, and regulated hemp products shall be prepackaged in child-resistant, tamper-evident, and resealable packaging that is opaque or shall be placed at the final point of sale to a consumer in child-resistant, tamper-evident, and resealable packaging that is opaque;

2. Packaging for multiserving liquid marijuana products shall include an integral measurement component; and

3. Packaging shall comply with any other requirements imposed by Board regulations.

C. Retail marijuana and retail marijuana products to be sold or offered for sale by a licensee to a consumer in accordance with the provisions of this subtitle shall not:

1. Be labeled or packaged in violation of a federal trademark law or regulation;

2. Be labeled or packaged in a manner that appeals particularly to persons younger than 21 years of age;

3. Be labeled or packaged in a manner that obscures identifying information on the label;

4. Be labeled or packaged using a false or misleading label;

5. Be sold or offered for sale using a label or packaging that depicts a human, an animal, a vehicle, or fruit; and

6. Be labeled or packaged in violation of any other labeling or packaging requirements imposed by Board regulations.

§ 4.1-1403. Other health and safety requirements for edible marijuana products, edible hemp products, and other retail marijuana products deemed applicable by the Authority; health and safety regulations.

A. Requirements and restrictions for edible marijuana products, edible hemp products, and other

6948 retail marijuana products deemed applicable by the Authority. In addition to all other applicable
6949 provisions of this subtitle, edible marijuana products and other retail marijuana products deemed
6950 applicable by the Authority to be sold or offered for sale by a licensee to a consumer and edible hemp
6951 products deemed applicable by the Authority to be sold or offered for sale by a person in accordance
6952 with this subtitle:

- 6953 1. Shall be manufactured by an approved source, as determined by § 3.2-5145.8;
- 6954 2. Shall comply with the provisions of Chapter 51 (§ 3.2-5100 et seq.) of Title 3.2;
- 6955 3. Shall be manufactured in a manner that results in the cannabinoid content within the product
6956 being homogeneous throughout the product or throughout each element of the product that has a
6957 cannabinoid content;
- 6958 4. Shall be manufactured in a manner that results in the amount of marijuana concentrate or
6959 industrial hemp extract, as appropriate, within the product being homogeneous throughout the product
6960 or throughout each element of the product that contains marijuana concentrate or industrial hemp
6961 extract, as appropriate;
- 6962 5. Shall have a universal symbol stamped or embossed on the packaging of each product;
- 6963 6. Shall not contain more than five milligrams of tetrahydrocannabinol (THC) per serving of the
6964 product and shall not contain more than 50 milligrams of THC per package of the product, except for
6965 edible hemp products, which shall not exceed the maximum tetrahydrocannabinol level established for a
6966 regulated hemp product pursuant to § 4.1-606;
- 6967 7. Shall not contain additives that (i) are toxic or harmful to human beings, (ii) are specifically
6968 designed to make the product more addictive, (iii) contain alcohol or nicotine, (iv) are misleading to
6969 consumers, or (v) are specifically designed to make the product appeal particularly to persons younger
6970 than 21 years of age; and
- 6971 8. Shall not involve the addition of marijuana to a trademarked food or drink product, except when
6972 the trademarked product is used as a component of or ingredient in the edible marijuana product and
6973 the edible marijuana product is not advertised or described for sale as containing the trademarked
6974 product.

6975 B. Health and safety regulations. The Board shall adopt any additional labeling, packaging, or other
6976 health and safety regulations that it deems necessary for retail marijuana and retail marijuana products
6977 to be sold or offered for sale by a licensee to a consumer in accordance with this subtitle or regulated
6978 hemp products to be sold or offered for sale by a person in accordance with this subtitle. Regulations
6979 adopted pursuant to this subsection shall establish mandatory health and safety standards applicable to
6980 the cultivation of retail marijuana, the manufacture of retail marijuana products, the processing of
6981 regulated hemp products, the packaging and labeling of retail marijuana and retail marijuana products
6982 sold by a licensee to a consumer, and the packaging and labeling of regulated hemp products sold by a
6983 person to any other person. Such regulations shall address:

- 6984 1. Requirements for the storage, warehousing, and transportation of retail marijuana and retail
6985 marijuana products by licensees;
- 6986 2. Sanitary standards for marijuana establishments, including sanitary standards for the manufacture
6987 of retail marijuana, retail marijuana products, and regulated hemp products; and
- 6988 3. Limitations on the display of retail marijuana and retail marijuana products at retail marijuana
6989 stores.

6990 **§ 4.1-1404. Advertising and marketing restrictions.**

6991 A. As used in this section, unless the context requires a different meaning, "health-related statement"
6992 means any statement related to health and includes statements of a curative or therapeutic nature that,
6993 expressly or by implication, suggest a relationship between the consumption of retail marijuana or retail
6994 marijuana products and health benefits or effects on health.

6995 B. No person shall advertise in or send any advertising matter into the Commonwealth about or
6996 concerning retail marijuana or retail marijuana products other than those that may be legally
6997 manufactured in the Commonwealth under this subtitle or Article 4.2 (§ 54.1-3442.5 et seq.) of the Drug
6998 Control Act.

6999 C. A licensee shall not advertise (i) through any means unless at least 85 percent of the audience is
7000 reasonably expected to be 21 years of age or older, as determined by reliable, up-to-date audience
7001 composition data or (ii) on television or the radio at any time outside of regular school hours for
7002 elementary and secondary schools.

7003 D. A licensee shall not engage in the use of pop-up digital advertisements but may list their
7004 establishment in public phone books and directories.

7005 E. A licensee shall not display any retail marijuana or retail marijuana product pricing through any
7006 means of advertisement other than their establishment website, which shall be registered with the
7007 Authority, or an opt-in subscription-based service, provided that the licensee utilizes proper age
7008 verification techniques to confirm that the person attempting to access the website or sign up for a
7009 subscription-based service is 21 years of age or older.

F. Advertising or marketing used by or on behalf of a licensee:

1. Shall accurately and legibly identify the licensee responsible for its content by adding, at a minimum, the licensee's license number and shall include the following statement: "For use by adults 21 years of age and older";

2. Shall not be misleading, deceptive, or false;

3. Shall not appeal particularly to persons younger than 21 years of age, including by using cartoons in any way;

4. Shall not imply that marijuana or marijuana products enhance athletic prowess; imply that any marijuana or marijuana product is government endorsed; make any reference to the intoxicating effects of marijuana or marijuana products; depict a person consuming marijuana or marijuana products; or depict any person younger than 21 years of age; and

5. Shall comply with any other provisions imposed by Board regulations.

G. Any advertising or marketing involving direct, individualized communication or dialogue controlled by the licensee shall utilize a method of age affirmation to verify that the recipient is 21 years of age or older before engaging in that communication or dialogue controlled by the licensee. For the purposes of this subsection, such method of age affirmation may include user confirmation, birth date disclosure, or any other similar registration method.

H. A licensee shall not (i) give away any amount of retail marijuana, retail marijuana products, or marijuana accessories as part of a business promotion or other commercial activity, (ii) create any contest or sweepstakes that conditions entry on the purchase of retail marijuana, retail marijuana products, or marijuana accessories, or (iii) offer to provide anything of value conditioned on the purchase of retail marijuana, retail marijuana products, or marijuana accessories.

I. A licensee shall not include on the label of any retail marijuana or retail marijuana product or publish or disseminate advertising or marketing containing any health-related statement that is untrue in any particular manner or tends to create a misleading impression as to the effects on health of marijuana consumption.

J. The provisions of this section shall not apply to noncommercial speech.

K. The purpose of the advertising limitations set forth in this subtitle is to displace the illicit market and notify the public of the location of marijuana establishments.

§ 4.1-1405. Outdoor advertising; limitations; variances; compliance with Title 33.2.

A. No outdoor retail marijuana or retail marijuana products advertising shall be placed (i) on property zoned exclusively for agricultural or residential uses or on unzoned property or (ii) within 1,000 linear feet of (a) a public, private, or parochial school or an institution of higher education; (b) a public or private playground or similar recreational or child-centered facility; (c) a substance use disorder treatment facility; (d) a place of religious worship; or (e) a residential dwelling. Measurements pursuant to this section shall be taken from the nearest edge of the sign face upon which the advertisement is placed to the nearest edge of the closest building or structure located on the real property of the entity set forth above; however, if there is no building or structure, the measurement shall be taken from the nearest edge of the sign face upon which the advertisement is placed to the nearest property line.

B. If at the time the advertisement was displayed, the advertisement was more than 1,000 feet from an entity set forth in subsection A but the circumstances change such that the advertisement would otherwise be in violation of subsection A, the Board shall permit the advertisement to remain as displayed for the remainder of the term of any written advertising contract, but in no event more than one year from the date of the change in circumstances.

C. Provided that such signs are in compliance with local ordinances, the distance and zoning restrictions contained in this section shall not apply to:

1. Signs placed by licensees upon the property on which the licensed premises are located so long as such signs do not display imagery of marijuana or the use of marijuana or utilize long luminous gas-discharge tubes that contain rarefied neon or other gases; or

2. Directional signs placed by marijuana manufacturing facility licensees or marijuana wholesaler licensees with advertising limited to trade names and brand names.

D. The distance and zoning restrictions contained in this section shall not apply to any sign that is included in the Integrated Directional Sign Program administered by the Virginia Department of Transportation or its agents.

E. A marijuana licensee shall not advertise at any sporting event or use any billboard advertisements in the Commonwealth.

F. All lawfully erected outdoor retail marijuana or retail marijuana products signs shall comply with the provisions of this subtitle, Board regulations, Chapter 12 (§ 33.2-1200 et seq.) of Title 33.2 and regulations adopted pursuant thereto by the Commonwealth Transportation Board, and federal laws and regulations. Further, any outdoor retail marijuana products directional sign located or to be located on

7378 "Disabled person" means any individual who has been determined to be mentally or physically

incapacitated so as to prevent the further performance of his duties at the time of his disability where such incapacity is likely to be permanent, and whose incapacity occurs in the line of duty as the direct or proximate result of the performance of his duty, including the presumptions under §§ 27-40.1, 27-40.2, 51.1-813, 65.2-402, and 65.2-402.1 if his position is covered by the applicable statute, in any position listed in the definition of deceased person in this section. "Disabled person" does not include any individual who has been determined to be no longer disabled pursuant to subdivision A 2 of § 9.1-404. "Disabled person" includes any state employee included in the definition of a deceased person who was disabled on or after January 1, 1966.

"Eligible dependent" for purposes of continued health insurance pursuant to § 9.1-401 means the natural or adopted child or children of a deceased person or disabled person or of a deceased or disabled person's eligible spouse, provided that any such natural child is born as the result of a pregnancy that occurred prior to the time of the employee's death or disability and that any such adopted child is (i) adopted prior to the time of the employee's death or disability or (ii) adopted after the employee's death or disability if the adoption is pursuant to a preadoptive agreement entered into prior to the death or disability. Notwithstanding the foregoing, "eligible dependent" ~~shall also include~~ *includes* the natural or adopted child or children of a deceased person or disabled person born as the result of a pregnancy or adoption that occurred after the time of the employee's death or disability, but prior to July 1, 2017. Eligibility will continue until the end of the year in which the eligible dependent reaches age 26 or when the eligible dependent ceases to be eligible based on the Virginia Administrative Code or administrative guidance as determined by the Department of Human Resource Management.

"Eligible spouse" for purposes of continued health insurance pursuant to § 9.1-401 means the spouse of a deceased person or a disabled person at the time of the death or disability. Eligibility will continue until the eligible spouse dies, ceases to be married to a disabled person, or in the case of the spouse of a deceased person, dies, remarries on or after July 1, 2017, or otherwise ceases to be eligible based on the Virginia Administrative Code or administrative guidance as determined by the Department of Human Resource Management.

"Employee" means any person who would be covered or whose spouse, dependents, or beneficiaries would be covered under the benefits of this chapter if the person became a disabled person or a deceased person.

"Employer" means (i) the employer of a person who is a covered employee or (ii) in the case of a volunteer who is a member of any fire company or department or rescue squad described in the definition of "deceased person," the county, city, or town that by ordinance or resolution recognized such fire company or department or rescue squad as an integral part of the official safety program of such locality.

"Fund" means the Line of Duty Death and Health Benefits Trust Fund established pursuant to § 9.1-400.1.

"Line of duty" means any action the deceased or disabled person was obligated or authorized to perform by rule, regulation, condition of employment or service, or law.

"LODA Health Benefit Plans" means the separate health benefits plans established pursuant to § 9.1-401.

"Nonparticipating employer" means any employer that is a political subdivision of the Commonwealth that elected to directly fund the cost of benefits provided under this chapter and not participate in the Fund.

"Participating employer" means any employer that is a state agency or is a political subdivision of the Commonwealth that did not make an election to become a nonparticipating employer.

"VRS" means the Virginia Retirement System.

§ 9.1-500. Definitions.

As used in this chapter, unless the context requires a different meaning:

"Agency" means the Department of State Police, the Division of Capitol Police, the Virginia Marine Resources Commission, the Virginia Port Authority, the Department of Wildlife Resources, the Virginia Alcoholic Beverage Control Authority, *the Virginia Cannabis Control Authority*, the Department of Conservation and Recreation, or the Department of Motor Vehicles; or the political subdivision or the campus police department of any public institution of higher education of the Commonwealth employing the law-enforcement officer.

"Law-enforcement officer" means any person, other than a Chief of Police or the Superintendent of the Department of State Police, who, in his official capacity, is (i) authorized by law to make arrests and (ii) a nonprobationary officer of one of the following agencies:

The Department of State Police, the Division of Capitol Police, the Virginia Marine Resources Commission, the Virginia Port Authority, the Department of Wildlife Resources, the Virginia Alcoholic Beverage Control Authority, *the Virginia Cannabis Control Authority*, the Department of Motor Vehicles, or the Department of Conservation and Recreation;

7440 b. 2. The police department, bureau or force of any political subdivision or the campus police
7441 department of any public institution of higher education of the Commonwealth where such department,
7442 bureau or force has three or more law-enforcement officers; or

7443 e. 3. Any conservation police officer as defined in § 9.1-101.

7444 For the purposes of this chapter, "law-enforcement officer" ~~shall~~ *does* not include the sheriff's

7446 **§ 9.1-801. Public safety officer defined.**

7447 As used in this chapter, the term "public safety officer" includes a law-enforcement officer of the

7449 correctional officer employed at a juvenile correctional facility as the term is defined in § 66-25.3; a jail
7450 officer; a regional jail or jail farm superintendent; a member of any fire company or department or

7452 resolution of the governing body of any county, city, or town of the Commonwealth as an integral part
7453 of the official safety program of such county, city, or town; an arson investigator; a member of the

7455 National Guard or the Virginia Defense Force on official state duty or federal duty under Title 32 of the
7456 United States Code; ~~any a~~ special agent of the Virginia Alcoholic Beverage Control Authority *or the*
7457 *Virginia Cannabis Control Authority*; ~~any a~~ police agent appointed under the provisions of § 56-353;
7458 ~~any a~~ regular or special conservation police officer who receives compensation from a county, city, or
7459 town or from the Commonwealth appointed pursuant to § 29.1-200; ~~any a~~ commissioned forest warden
7460 appointed pursuant to § 10.1-1135; ~~any a~~ member or employee of the Virginia Marine Resources

7468 Conservation and Recreation commissioned pursuant to § 10.1-115.

7469 **§ 9.1-1101. Powers and duties of the Department.**

7470 A. It shall be the responsibility of the Department to provide forensic laboratory services upon
7471 request of the Superintendent of State Police; the Chief Medical Examiner, the Assistant Chief Medical
7472 Examiners, and local medical examiners; any attorney for the Commonwealth; any chief of police,
7473 sheriff, or sergeant responsible for law enforcement in the jurisdiction served by him; any local fire
7474 department; the head of any private police department that has been designated as a criminal justice
7475 agency by the Department of Criminal Justice Services as defined by § 9.1-101; or any state agency in

7483 seq.) of Chapter 18 of Title 19.2 to determine identification characteristics specific to an individual; ~~and~~

7484 3. Test the accuracy of equipment used to test the blood alcohol content of breath at least once every
7485 six months. Only equipment found to be accurate shall be used to test the blood alcohol content of
7486 breath; *and*

7487 4. *Determine the proper methods for detecting the concentration of tetrahydrocannabinol (THC) in*
7488 *substances for the purposes of Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 and §§ 54.1-3401 and*
7489 *54.1-3446. The testing methodology shall use post-decarboxylation testing or other equivalent method*
7490 *and shall consider the potential conversion of tetrahydrocannabinol acid (THC-A) into THC. The test*
7491 *result shall include the total available THC derived from the sum of the THC and THC-A content.*

7492 C. The Department shall have the power and duty to:

7493 1. Receive, administer, and expend all funds and other assistance available for carrying out the
7494 purposes of this chapter;

7495 2. Make and enter into all contracts and agreements necessary or incidental to the performance of its
7496 duties and execution of its powers under this chapter including, but not limited to, contracts with the
7497 United States, units of general local government or combinations thereof in Virginia or other states, and
7498 with agencies and departments of the Commonwealth; and

7499 3. Perform such other acts as may be necessary or convenient for the effective performance of its
7500 duties.

7501 D. The Director may appoint and employ a deputy director and such other personnel as are needed

to carry out the duties and responsibilities conferred by this chapter.

§ 15.2-2820. Definitions.

As used in this chapter, unless the context requires a different meaning:

"Bar or lounge area" means any establishment or portion of an establishment devoted to the sale and service of alcoholic beverages for consumption on the premises and where the sale or service of food or meals is incidental to the consumption of the alcoholic beverages.

"Educational facility" means any building used for instruction of enrolled students, including but not limited to any day-care center, nursery school, public or private school, institution of higher education, medical school, law school, or career and technical education school.

"Health care facility" means any institution, place, building, or agency required to be licensed under Virginia law, including but not limited to any hospital, nursing facility or nursing home, boarding home, assisted living facility, supervised living facility, or ambulatory medical and surgical center.

"Private club" means an organization, whether incorporated or not, that (i) is the owner, lessee, or occupant of a building or portion thereof used exclusively for club purposes, including club or member sponsored events; (ii) is operated solely for recreational, fraternal, social, patriotic, political, benevolent, or athletic purposes, and only sells alcoholic beverages incidental to its operation; (iii) has established bylaws, a constitution, or both that govern its activities; and (iv) the affairs and management of which are conducted by a board of directors, executive committee, or similar body chosen by the members at an annual meeting.

"Private function" means any gathering of persons for the purpose of deliberation, education, instruction, entertainment, amusement, or dining that is not intended to be open to the public and for which membership or specific invitation is a prerequisite to entry.

"Private work place" means any office or work area that is not open to the public in the normal course of business except by individual invitation.

"Proprietor" means the owner or lessee of the public place, who ultimately controls the activities within the public place. The term "proprietor" includes corporations, associations, or partnerships as well as individuals.

"Public conveyance" or "public vehicle" means any air, land, or water vehicle used for the mass transportation of persons in intrastate travel for compensation, including but not limited to any airplane, train, bus, or boat that is not subject to federal smoking regulations.

"Public place" means any enclosed, indoor area used by the general public, including but not limited to any building owned or leased by the Commonwealth or any agency thereof or any locality, public conveyance or public vehicle, educational facility, hospital, nursing facility or nursing home, other health care facility, library, retail store of 15,000 square feet or more, auditorium, arena, theater, museum, concert hall, or other area used for a performance or an exhibit of the arts or sciences, or any meeting room.

"Recreational facility" means any enclosed, indoor area used by the general public and used as a stadium, arena, skating rink, video game facility, or senior citizen recreational facility.

"Restaurant" means any place where food is prepared for service to the public on or off the premises, or any place where food is served. Examples of such places include but are not limited to lunchrooms, short order places, cafeterias, coffee shops, cafes, taverns, delicatessens, dining accommodations of public or private clubs, kitchen facilities of hospitals and nursing homes, dining accommodations of public and private schools and colleges, and kitchen areas of local correctional facilities subject to standards adopted under § 53.1-68. "Restaurant" shall not include (i) places where packaged or canned foods are manufactured and then distributed to grocery stores or other similar food retailers for sale to the public, (ii) mobile points of service to the general public that are outdoors, or (iii) mobile points of service where such service and consumption occur in a private residence or in any location that is not a public place. "Restaurant" shall include any bar or lounge area that is part of such restaurant.

"Smoke" or "smoking" means the carrying or holding of any lighted pipe, cigar, or cigarette of any kind, *including marijuana*, or any other lighted smoking equipment, or the lighting, inhaling, or exhaling of smoke from a pipe, cigar, or cigarette of any kind, *including marijuana*.

"Theater" means any indoor facility or auditorium, open to the public, which is primarily used or designed for the purpose of exhibiting any motion picture, stage production, musical recital, dance, lecture, or other similar performance.

§ 16.1-69.40:1. Traffic infractions within authority of traffic violations clerk; schedule of fines; prepayment of local ordinances.

A. The Supreme Court shall by rule, which may from time to time be amended, supplemented or repealed, but which shall be uniform in its application throughout the Commonwealth, designate the traffic infractions for which a pretrial waiver of appearance, plea of guilty and fine payment may be accepted. Such designated infractions shall include violations of §§ 46.2-830.1, 46.2-878.2 and 46.2-1242 or any parallel local ordinances. Notwithstanding any rule of the Supreme Court, a person charged with

7563 a traffic offense that is listed as prepayable in the Uniform Fine Schedule may prepay his fines and
7564 costs without court appearance whether or not he was involved in an accident. The prepayable fine
7565 amount for a violation of § 46.2-878.2 shall be \$200 plus an amount per mile-per-hour in excess of
7566 posted speed limits, as authorized in § 46.2-878.3.

7567 Such infractions shall not include:

7568 1. Indictable offenses;

7569 2. [Repealed.]

7570 3. Operation of a motor vehicle while under the influence of intoxicating liquor, *marijuana*, or a
7571 narcotic or habit-producing drug, or permitting another person, who is under the influence of
7572 intoxicating liquor, *marijuana*, or a narcotic or habit-producing drug, to operate a motor vehicle owned
7573 by the defendant or in his custody or control;

7574 4. Reckless driving;

7575 5. Leaving the scene of an accident;

7576 6. Driving while under suspension or revocation of driving privileges;

7577 7. Driving without being licensed to drive.

7578 8. [Repealed.]

7579 B. An appearance may be made in person or in writing by mail to a clerk of court or in person
7580 before a magistrate, prior to any date fixed for trial in court. Any person so appearing may enter a
7581 waiver of trial and a plea of guilty and pay the fine and any civil penalties established for the offense
7582 charged, with costs. He shall, prior to the plea, waiver, and payment, be informed of his right to stand
7583 trial, that his signature to a plea of guilty will have the same force and effect as a judgment of court,
7584 and that the record of conviction will be sent to the Commissioner of the Department of Motor
7585 Vehicles.

7586 C. The Supreme Court, upon the recommendation of the Committee on District Courts, shall
7587 establish a schedule, within the limits prescribed by law, of the amounts of fines and any civil penalties
7588 to be imposed, designating each infraction specifically. The schedule, which may from time to time be
7589 amended, supplemented or repealed, shall be uniform in its application throughout the Commonwealth.
7590 Such schedule shall not be construed or interpreted so as to limit the discretion of any trial judge trying
7591 individual cases at the time fixed for trial. The rule of the Supreme Court establishing the schedule shall
7592 be prominently posted in the place where the fines are paid. Fines and costs shall be paid in accordance
7593 with the provisions of this Code or any rules or regulations promulgated thereunder.

7594 D. Fines imposed under local traffic infraction ordinances that do not parallel provisions of state law
7595 and fulfill the criteria set out in subsection A may be prepayable in the manner set forth in subsection B
7596 if such ordinances appear in a schedule entered by order of the local circuit courts. The chief judge of
7597 each circuit may establish a schedule of the fines, within the limits prescribed by local ordinances, to be
7598 imposed for prepayment of local ordinances designating each offense specifically. Upon the entry of
7599 such order it shall be forwarded within 10 days to the Supreme Court of Virginia by the clerk of the
7600 local circuit court. The schedule, which from time to time may be amended, supplemented or repealed,
7601 shall be uniform in its application throughout the circuit. Such schedule shall not be construed or
7602 interpreted so as to limit the discretion of any trial judge trying individual cases at the time fixed for
7603 trial. This schedule shall be prominently posted in the place where fines are paid. Fines and costs shall
7604 be paid in accordance with the provisions of this Code or any rules or regulations promulgated
7605 thereunder.

7606 **§ 16.1-260. Intake; petition; investigation.**

7607 A. All matters alleged to be within the jurisdiction of the court shall be commenced by the filing of
7608 a petition, except as provided in subsection H and in § 16.1-259. The form and content of the petition
7609 shall be as provided in § 16.1-262. No individual shall be required to obtain support services from the
7610 Department of Social Services prior to filing a petition seeking support for a child. Complaints, requests,
7611 and the processing of petitions to initiate a case shall be the responsibility of the intake officer.
7612 However, (i) the attorney for the Commonwealth of the city or county may file a petition on his own
7613 motion with the clerk; (ii) designated nonattorney employees of the Department of Social Services may
7614 complete, sign, and file petitions and motions relating to the establishment, modification, or enforcement
7615 of support on forms approved by the Supreme Court of Virginia with the clerk; (iii) designated
7616 nonattorney employees of a local department of social services may complete, sign, and file with the
7617 clerk, on forms approved by the Supreme Court of Virginia, petitions for foster care review, petitions
7618 for permanency planning hearings, petitions to establish paternity, motions to establish or modify
7619 support, motions to amend or review an order, and motions for a rule to show cause; and (iv) any
7620 attorney may file petitions on behalf of his client with the clerk except petitions alleging that the subject
7621 of the petition is a child alleged to be in need of services, in need of supervision, or delinquent.
7622 Complaints alleging abuse or neglect of a child shall be referred initially to the local department of
7623 social services in accordance with the provisions of Chapter 15 (§ 63.2-1500 et seq.) of Title 63.2.
7624 Motions and other subsequent pleadings in a case shall be filed directly with the clerk. The intake

officer or clerk with whom the petition or motion is filed shall inquire whether the petitioner is receiving child support services or public assistance. No individual who is receiving support services or public assistance shall be denied the right to file a petition or motion to establish, modify, or enforce an order for support of a child. If the petitioner is seeking or receiving child support services or public assistance, the clerk, upon issuance of process, shall forward a copy of the petition or motion, together with notice of the court date, to the Division of Child Support Enforcement. If a petitioner is seeking to establish child support, the intake officer shall provide the petitioner information on the possible availability of medical assistance through the Family Access to Medical Insurance Security (FAMIS) plan or other government-sponsored coverage through the Department of Medical Assistance Services.

B. The appearance of a child before an intake officer may be by (i) personal appearance before the intake officer or (ii) use of two-way electronic video and audio communication. If two-way electronic video and audio communication is used, an intake officer may exercise all powers conferred by law. All communications and proceedings shall be conducted in the same manner as if the appearance were in person, and any documents filed may be transmitted by facsimile process. The facsimile may be served or executed by the officer or person to whom sent, and returned in the same manner, and with the same force, effect, authority, and liability as an original document. All signatures thereon shall be treated as original signatures. Any two-way electronic video and audio communication system used for an appearance shall meet the standards as set forth in subsection B of § 19.2-3.1.

When the court service unit of any court receives a complaint alleging facts which may be sufficient to invoke the jurisdiction of the court pursuant to § 16.1-241, the unit, through an intake officer, may proceed informally to make such adjustment as is practicable without the filing of a petition or may authorize a petition to be filed by any complainant having sufficient knowledge of the matter to establish probable cause for the issuance of the petition.

An intake officer may proceed informally on a complaint alleging a child is in need of services, in need of supervision, or delinquent only if the juvenile (a) is not alleged to have committed a violent juvenile felony or (b) has not previously been proceeded against informally or adjudicated delinquent for an offense that would be a felony if committed by an adult. A petition alleging that a juvenile committed a violent juvenile felony shall be filed with the court. A petition alleging that a juvenile is delinquent for an offense that would be a felony if committed by an adult shall be filed with the court if the juvenile had previously been proceeded against informally by intake or had been adjudicated delinquent for an offense that would be a felony if committed by an adult.

If a juvenile is alleged to be a truant pursuant to a complaint filed in accordance with § 22.1-258 and the attendance officer has provided documentation to the intake officer that the relevant school division has complied with the provisions of § 22.1-258, then the intake officer shall file a petition with the court. The intake officer may defer filing the petition and proceed informally by developing a truancy plan, provided that (1) the juvenile has not previously been proceeded against informally or adjudicated in need of supervision on more than two occasions for failure to comply with compulsory school attendance as provided in § 22.1-254 and (2) the immediately previous informal action or adjudication occurred at least three calendar years prior to the current complaint. The juvenile and his parent or parents, guardian, or other person standing in loco parentis must agree, in writing, for the development of a truancy plan. The truancy plan may include requirements that the juvenile and his parent or parents, guardian, or other person standing in loco parentis participate in such programs, cooperate in such treatment, or be subject to such conditions and limitations as necessary to ensure the juvenile's compliance with compulsory school attendance as provided in § 22.1-254. The intake officer may refer the juvenile to the appropriate public agency for the purpose of developing a truancy plan using an interagency interdisciplinary team approach. The team may include qualified personnel who are reasonably available from the appropriate department of social services, community services board, local school division, court service unit, and other appropriate and available public and private agencies and may be the family assessment and planning team established pursuant to § 2.2-5207. If at the end of the deferral period the juvenile has not successfully completed the truancy plan or the truancy program, then the intake officer shall file the petition.

Whenever informal action is taken as provided in this subsection on a complaint alleging that a child is in need of services, in need of supervision, or delinquent, the intake officer shall (A) develop a plan for the juvenile, which may include restitution, the performance of community service, or on a complaint alleging that a child has committed a delinquent act other than an act that would be a felony or a Class 1 misdemeanor if committed by an adult and with the consent of the juvenile's parent or legal guardian, referral to a youth justice diversion program established pursuant to § 16.1-309.11, based upon community resources and the circumstances which resulted in the complaint, (B) create an official record of the action taken by the intake officer and file such record in the juvenile's case file, and (C) advise the juvenile and the juvenile's parent, guardian, or other person standing in loco parentis and the complainant that any subsequent complaint alleging that the child is in need of supervision or delinquent

7686 based upon facts which may be sufficient to invoke the jurisdiction of the court pursuant to § 16.1-241,
7687 or in the case of a referral to a youth justice diversion program established pursuant to § 16.1-309.11,
7688 that any subsequent report from the youth justice diversion program alleging that the juvenile failed to
7689 comply with the youth justice diversion program's sentence within 180 days of the sentencing date, may
7690 result in the filing of a petition with the court.

7691 C. The intake officer shall accept and file a petition in which it is alleged that (i) the custody,
7692 visitation, or support of a child is the subject of controversy or requires determination, (ii) a person has
7693 deserted, abandoned, or failed to provide support for any person in violation of law, (iii) a child or such
7694 child's parent, guardian, legal custodian, or other person standing in loco parentis is entitled to treatment,
7695 rehabilitation, or other services which are required by law, (iv) family abuse has occurred and a
7696 protective order is being sought pursuant to § 16.1-253.1, 16.1-253.4, or 16.1-279.1, or (v) an act of
7697 violence, force, or threat has occurred, a protective order is being sought pursuant to § 19.2-152.8,
7698 19.2-152.9, or 19.2-152.10, and either the alleged victim or the respondent is a juvenile. If any such
7699 complainant does not file a petition, the intake officer may file it. In cases in which a child is alleged to
7700 be abused, neglected, in need of services, in need of supervision, or delinquent, if the intake officer
7701 believes that probable cause does not exist, or that the authorization of a petition will not be in the best
7702 interest of the family or juvenile or that the matter may be effectively dealt with by some agency other
7703 than the court, he may refuse to authorize the filing of a petition. The intake officer shall provide to a
7704 person seeking a protective order pursuant to § 16.1-253.1, 16.1-253.4, or 16.1-279.1 a written
7705 explanation of the conditions, procedures and time limits applicable to the issuance of protective orders
7706 pursuant to § 16.1-253.1, 16.1-253.4, or 16.1-279.1. If the person is seeking a protective order pursuant
7707 to § 19.2-152.8, 19.2-152.9, or 19.2-152.10, the intake officer shall provide a written explanation of the
7708 conditions, procedures, and time limits applicable to the issuance of protective orders pursuant to
7709 § 19.2-152.8, 19.2-152.9, or 19.2-152.10.

7710 D. Prior to the filing of any petition alleging that a child is in need of supervision, the matter shall
7711 be reviewed by an intake officer who shall determine whether the petitioner and the child alleged to be
7712 in need of supervision have utilized or attempted to utilize treatment and services available in the
7713 community and have exhausted all appropriate nonjudicial remedies which are available to them. When
7714 the intake officer determines that the parties have not attempted to utilize available treatment or services
7715 or have not exhausted all appropriate nonjudicial remedies which are available, he shall refer the
7716 petitioner and the child alleged to be in need of supervision to the appropriate agency, treatment facility,
7717 or individual to receive treatment or services, and a petition shall not be filed. Only after the intake
7718 officer determines that the parties have made a reasonable effort to utilize available community
7719 treatment or services may he permit the petition to be filed.

7720 E. If the intake officer refuses to authorize a petition relating to an offense that if committed by an
7721 adult would be punishable as a Class 1 misdemeanor or as a felony, when such refusal is based solely
7722 upon a finding that no probable cause exists, the complainant shall be notified in writing at that time of
7723 the complainant's right to apply to a magistrate for a warrant. The application for a warrant to the
7724 magistrate shall be filed within 10 days of the issuance of the written notification. The written
7725 notification shall indicate that the intake officer made a finding that no probable cause exists and shall
7726 provide notice that the complainant has 10 days to apply for a warrant to the magistrate. The
7727 complainant shall provide the magistrate with a copy of the written notification upon application to the
7728 magistrate. If a magistrate determines that probable cause exists, he shall issue a warrant returnable to
7729 the juvenile and domestic relations district court. The warrant shall be delivered forthwith to the juvenile
7730 court, and the intake officer shall accept and file a petition founded upon the warrant. If the court is
7731 closed and the magistrate finds that the criteria for detention or shelter care set forth in § 16.1-248.1
7732 have been satisfied, the juvenile may be detained pursuant to the warrant issued in accordance with this
7733 subsection. If the intake officer refuses to authorize a petition relating to a child in need of services or
7734 in need of supervision, a status offense, or a misdemeanor other than Class 1, his decision is final. If the
7735 intake officer refuses to authorize a petition relating to an offense that if committed by an adult would
7736 be punishable as a Class 1 misdemeanor or as a felony when such refusal is based upon a finding that
7737 (i) probable cause exists, but that (ii) the matter is appropriate for diversion, his decision is final and the
7738 complainant shall not have a right to apply to a magistrate for a warrant.

7739 Upon delivery to the juvenile court of a warrant issued pursuant to subdivision 2 of § 16.1-256, the
7740 intake officer shall accept and file a petition founded upon the warrant.

7741 F. The intake officer shall notify the attorney for the Commonwealth of the filing of any petition
7742 which alleges facts of an offense which would be a felony if committed by an adult.

7743 G. Notwithstanding the provisions of Article 12 (§ 16.1-299 et seq.), the intake officer shall file a
7744 report with the division superintendent of the school division in which any student who is the subject of
7745 a petition alleging that such student who is a juvenile has committed an act, wherever committed, which
7746 would be a crime if committed by an adult, or that such student who is an adult has committed a crime
7747 and is alleged to be within the jurisdiction of the court. The report shall notify the division

superintendent of the filing of the petition and the nature of the offense, if the violation involves:

1. A firearm offense pursuant to Article 4 (§ 18.2-279 et seq.), 5 (§ 18.2-288 et seq.), 6 (§ 18.2-299 et seq.), 6.1 (§ 18.2-307.1 et seq.), or 7 (§ 18.2-308.1 et seq.) of Chapter 7 of Title 18.2;

2. Homicide, pursuant to Article 1 (§ 18.2-30 et seq.) of Chapter 4 of Title 18.2;

3. Felonious assault and bodily wounding, pursuant to Article 4 (§ 18.2-51 et seq.) of Chapter 4 of Title 18.2;

4. Criminal sexual assault, pursuant to Article 7 (§ 18.2-61 et seq.) of Chapter 4 of Title 18.2;

5. Manufacture, sale, gift, distribution or possession of Schedule I or II controlled substances, pursuant to Article 1 (§ 18.2-247 et seq.) of Chapter 7 of Title 18.2;

6. Manufacture, sale or distribution of marijuana pursuant to ~~Article 4 Chapter 11~~ (§ 18.2-247 4.1-1100 et seq.) of Chapter 7 of Title 18.2 4.1;

7. Arson and related crimes, pursuant to Article 1 (§ 18.2-77 et seq.) of Chapter 5 of Title 18.2;

8. Burglary and related offenses, pursuant to §§ 18.2-89 through 18.2-93;

9. Robbery pursuant to § 18.2-58;

10. Prohibited criminal street gang activity pursuant to § 18.2-46.2;

11. Recruitment of other juveniles for a criminal street gang activity pursuant to § 18.2-46.3;

12. An act of violence by a mob pursuant to § 18.2-42.1;

13. Abduction of any person pursuant to § 18.2-47 or 18.2-48; or

14. A threat pursuant to § 18.2-60.

The failure to provide information regarding the school in which the student who is the subject of the petition may be enrolled shall not be grounds for refusing to file a petition.

The information provided to a division superintendent pursuant to this section may be disclosed only as provided in § 16.1-305.2.

H. The filing of a petition shall not be necessary:

1. In the case of violations of the traffic laws, including offenses involving bicycles, hitchhiking and other pedestrian offenses, game and fish laws, or a violation of the ordinance of any city regulating surfing or any ordinance establishing curfew violations, animal control violations, or littering violations. In such cases the court may proceed on a summons issued by the officer investigating the violation in the same manner as provided by law for adults. Additionally, an officer investigating a motor vehicle accident may, at the scene of the accident or at any other location where a juvenile who is involved in such an accident may be located, proceed on a summons in lieu of filing a petition.

2. In the case of seeking consent to apply for the issuance of a work permit pursuant to subsection H of § 16.1-241.

3. In the case of a misdemeanor violation of § 4.1-1104, 18.2-266, 18.2-266.1, or 29.1-738 or the commission of any other alcohol-related offense, provided that the juvenile is released to the custody of a parent or legal guardian pending the initial court date. The officer releasing a juvenile to the custody of a parent or legal guardian shall issue a summons to the juvenile and shall also issue a summons requiring the parent or legal guardian to appear before the court with the juvenile. Disposition of the charge shall be in the manner provided in § 16.1-278.8, 16.1-278.8:01, or 16.1-278.9. If the juvenile so charged with a violation of § 18.2-51.4, 18.2-266, 18.2-266.1, 18.2-272, or 29.1-738 refuses to provide a sample of blood or breath or samples of both blood and breath for chemical analysis pursuant to §§ 18.2-268.1 through 18.2-268.12 or 29.1-738.2, the provisions of these sections shall be followed except that the magistrate shall authorize execution of the warrant as a summons. The summons shall be served on a parent or legal guardian and the juvenile, and a copy of the summons shall be forwarded to the court in which the violation is to be tried. When a violation of § 4.1-305 or 4.1-1104 is charged by summons, the juvenile shall be entitled to have the charge referred to intake for consideration of informal proceedings pursuant to subsection B, provided that such right is exercised by written notification to the clerk not later than 10 days prior to trial. At the time such summons alleging a violation of § 4.1-305 or 4.1-1104 is served, the officer shall also serve upon the juvenile written notice of the right to have the charge referred to intake on a form approved by the Supreme Court and make return of such service to the court. If the officer fails to make such service or return, the court shall dismiss the summons without prejudice.

4. In the case of offenses, *other than marijuana-related offenses*, which, if committed by an adult, would be punishable as a Class 3 or Class 4 misdemeanor. In such cases the court may direct that an intake officer proceed as provided in § 16.1-237 on a summons issued by the officer investigating the violation in the same manner as provided by law for adults provided that notice of the summons to appear is mailed by the investigating officer within five days of the issuance of the summons to a parent or legal guardian of the juvenile.

I. Failure to comply with the procedures set forth in this section shall not divest the juvenile court of the jurisdiction granted it in § 16.1-241.

§ 16.1-273. Court may require investigation of social history and preparation of victim impact

7809 statement.

7810 A. When a juvenile and domestic relations district court or circuit court has adjudicated any case
7811 involving a child subject to the jurisdiction of the court hereunder, except for a traffic violation, a
7812 violation of the game and fish law, or a violation of any city ordinance regulating surfing or establishing
7813 curfew violations, the court before final disposition thereof may require an investigation, which (i) shall
7814 include a drug screening and (ii) may, and for the purposes of subdivision A 14 or 17 of § 16.1-278.8
7815 shall, include a social history of the physical, mental, and social conditions, including an assessment of
7816 any affiliation with a criminal street gang as defined in § 18.2-46.1, and personality of the child and the
7817 facts and circumstances surrounding the violation of law. However, in the case of a juvenile adjudicated
7818 delinquent on the basis of an act committed on or after January 1, 2000, which would be (a) a felony if
7819 committed by an adult, ~~or~~ (b) a violation under Article 1 (§ 18.2-247 et seq.) or Article 1.1
7820 (§ 18.2-265.1 et seq.) of Chapter 7 of Title 18.2 and such offense would be punishable as a Class 1 or
7821 Class 2 misdemeanor if committed by an adult, *or (c) a violation of § 4.1-1104*, the court shall order the
7822 juvenile to undergo a drug screening. If the drug screening indicates that the juvenile has a substance
7823 abuse or dependence problem, an assessment shall be completed by a certified substance abuse counselor
7824 as defined in § 54.1-3500 employed by the Department of Juvenile Justice or by a locally operated court
7825 services unit or by an individual employed by or currently under contract to such agencies and who is
7826 specifically trained to conduct such assessments under the supervision of such counselor.

7827 B. The court also shall, on motion of the attorney for the Commonwealth with the consent of the
7828 victim, or may in its discretion, require the preparation of a victim impact statement in accordance with
7829 the provisions of § 19.2-299.1 if the court determines that the victim may have suffered significant
7830 physical, psychological, or economic injury as a result of the violation of law.

7831 § 16.1-278.9. **Delinquent children; loss of driving privileges for alcohol, firearm, and drug**
7832 **offenses; truancy.**

7833 A. If a court has found facts which would justify a finding that a child at least 13 years of age at the
7834 time of the offense is delinquent and such finding involves (i) a violation of § 18.2-266 or of a similar
7835 ordinance of any county, city, or town; (ii) a refusal to take a breath test in violation of § 18.2-268.2;
7836 (iii) a felony violation of Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or § 18.2-248; ~~18.2-248.1~~, or
7837 18.2-250; (iv) a misdemeanor violation of Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or § 18.2-248;
7838 ~~18.2-248.1~~, or 18.2-250 *or a violation of § 4.1-1105*; (v) the unlawful purchase, possession, or
7839 consumption of alcohol in violation of § 4.1-305 or the unlawful drinking or possession of alcoholic
7840 beverages in or on public school grounds in violation of § 4.1-309; (vi) public intoxication in violation
7841 of § 18.2-388 or a similar ordinance of a county, city, or town; (vii) the unlawful use or possession of a
7842 handgun or possession of a "streetsweeper" as defined below; or (viii) a violation of § 18.2-83, the court
7843 shall order, in addition to any other penalty that it may impose as provided by law for the offense, that
7844 the child be denied a driver's license. In addition to any other penalty authorized by this section, if the
7845 offense involves a violation designated under clause (i) and the child was transporting a person 17 years
7846 of age or younger, the court shall impose the additional fine and order community service as provided in
7847 § 18.2-270. If the offense involves a violation designated under clause (i), (ii), (iii), or (viii), the denial
7848 of a driver's license shall be for a period of one year or until the juvenile reaches the age of 17,
7849 whichever is longer, for a first such offense or for a period of one year or until the juvenile reaches the
7850 age of 18, whichever is longer, for a second or subsequent such offense. If the offense involves a
7851 violation designated under clause (iv), (v), or (vi) the denial of driving privileges shall be for a period of
7852 six months unless the offense is committed by a child under the age of 16 years and three months, in
7853 which case the child's ability to apply for a driver's license shall be delayed for a period of six months
7854 following the date he reaches the age of 16 and three months. If the offense involves a first violation
7855 designated under clause (v) or (vi), the court shall impose the license sanction and may enter a judgment
7856 of guilt or, without entering a judgment of guilt, may defer disposition of the delinquency charge until
7857 such time as the court disposes of the case pursuant to subsection F. If the offense involves a violation
7858 designated under clause (iii) or (iv), the court shall impose the license sanction and shall dispose of the
7859 delinquency charge pursuant to the provisions of this chapter or § 18.2-251. If the offense involves a
7860 violation designated under clause (vii), the denial of driving privileges shall be for a period of not less
7861 than 30 days, except when the offense involves possession of a concealed handgun or a striker 12,
7862 commonly called a "streetsweeper," or any semi-automatic folding stock shotgun of like kind with a
7863 spring tension drum magazine capable of holding 12 shotgun shells, in which case the denial of driving
7864 privileges shall be for a period of two years unless the offense is committed by a child under the age of
7865 16 years and three months, in which event the child's ability to apply for a driver's license shall be
7866 delayed for a period of two years following the date he reaches the age of 16 and three months.

7867 A1. If a court finds that a child at least 13 years of age has failed to comply with school attendance
7868 and meeting requirements as provided in § 22.1-258, the court shall order the denial of the child's
7869 driving privileges for a period of not less than 30 days. If such failure to comply involves a child under
7870 the age of 16 years and three months, the child's ability to apply for a driver's license shall be delayed

for a period of not less than 30 days following the date he reaches the age of 16 and three months.

If the court finds a second or subsequent such offense, it may order the denial of a driver's license for a period of one year or until the juvenile reaches the age of 18, whichever is longer, or delay the child's ability to apply for a driver's license for a period of one year following the date he reaches the age of 16 and three months, as may be appropriate.

A2. If a court finds that a child at least 13 years of age has refused to take a blood test in violation of § 18.2-268.2, the court shall order that the child be denied a driver's license for a period of one year or until the juvenile reaches the age of 17, whichever is longer, for a first such offense or for a period of one year or until the juvenile reaches the age of 18, whichever is longer, for a second or subsequent such offense.

B. Any child who has a driver's license at the time of the offense or at the time of the court's finding as provided in subsection A1 or A2 shall be ordered to surrender his driver's license, which shall be held in the physical custody of the court during any period of license denial.

C. The court shall report any order issued under this section to the Department of Motor Vehicles, which shall preserve a record thereof. The report and the record shall include a statement as to whether the child was represented by or waived counsel or whether the order was issued pursuant to subsection A1 or A2. Notwithstanding the provisions of Article 12 (§ 16.1-299 et seq.) or the provisions of Title 46.2, this record shall be available only to all law-enforcement officers, attorneys for the Commonwealth and courts. No other record of the proceeding shall be forwarded to the Department of Motor Vehicles unless the proceeding results in an adjudication of guilt pursuant to subsection F.

The Department of Motor Vehicles shall refuse to issue a driver's license to any child denied a driver's license until such time as is stipulated in the court order or until notification by the court of withdrawal of the order of denial under subsection E.

D. If the finding as to the child involves a violation designated under clause (i), (ii), (iii) or (vi) of subsection A or a violation designated under subsection A2, the child may be referred to a certified alcohol safety action program in accordance with § 18.2-271.1 upon such terms and conditions as the court may set forth. If the finding as to such child involves a violation designated under clause (iii), (iv), (v), (vii) or (viii) of subsection A, such child may be referred to appropriate rehabilitative or educational services upon such terms and conditions as the court may set forth.

The court, in its discretion and upon a demonstration of hardship, may authorize the use of a restricted permit to operate a motor vehicle by any child who has a driver's license at the time of the offense or at the time of the court's finding as provided in subsection A1 or A2 for any of the purposes set forth in subsection E of § 18.2-271.1 or for travel to and from school, except that no restricted license shall be issued for travel to and from home and school when school-provided transportation is available and no restricted license shall be issued if the finding as to such child involves a violation designated under clause (iii) or (iv) of subsection A, or if it involves a second or subsequent violation of any offense designated in subsection A, a second finding by the court of failure to comply with school attendance and meeting requirements as provided in subsection A1, or a second or subsequent finding by the court of a refusal to take a blood test as provided in subsection A2. The issuance of the restricted permit shall be set forth within the court order, a copy of which shall be provided to the child, and shall specifically enumerate the restrictions imposed and contain such information regarding the child as is reasonably necessary to identify him. The child may operate a motor vehicle under the court order in accordance with its terms. Any child who operates a motor vehicle in violation of any restrictions imposed pursuant to this section is guilty of a violation of § 46.2-301.

E. Upon petition made at least 90 days after issuance of the order, the court may review and withdraw any order of denial of a driver's license if for a first such offense or finding as provided in subsection A1 or A2. For a second or subsequent such offense or finding, the order may not be reviewed and withdrawn until one year after its issuance.

F. If the finding as to such child involves a first violation designated under clause (vii) of subsection A, upon fulfillment of the terms and conditions prescribed by the court and after the child's driver's license has been restored, the court shall or, in the event the violation resulted in the injury or death of any person or if the finding involves a violation designated under clause (i), (ii), (v), or (vi) of subsection A, may discharge the child and dismiss the proceedings against him. Discharge and dismissal under these provisions shall be without an adjudication of guilt but a record of the proceeding shall be retained for the purpose of applying this section in subsequent proceedings. Failure of the child to fulfill such terms and conditions shall result in an adjudication of guilt. If the finding as to such child involves a violation designated under clause (iii) or (iv) of subsection A, the charge shall not be dismissed pursuant to this subsection but shall be disposed of pursuant to the provisions of this chapter or § 18.2-251. If the finding as to such child involves a second violation under clause (v), (vi) or (vii) of subsection A, the charge shall not be dismissed pursuant to this subsection but shall be disposed of under § 16.1-278.8.

7932 § 17.1-276. Fee allowed for providing secure remote access to land records.

7933 A. A clerk of the circuit court who provides secure remote access to land records pursuant to
7934 § 17.1-294 may charge a fee as provided in this section. The fee shall be paid to the clerk's office and
7935 deposited by the clerk into the clerk's nonreverting local fund to be used to cover operational expenses
7936 as defined in § 17.1-295. The clerk may charge a flat clerk's fee to be assessed for each subscriber, as
7937 defined in § 17.1-295, in an amount not to exceed \$50 per month and a separate fee per image
7938 downloaded in an amount not to exceed the fee provided in subdivision A 8 of § 17.1-275. The clerk's
7939 fees shall be used to cover operational expenses as defined in § 17.1-295.

7940 The Office of the Attorney General, the Division of Debt Collection, the Department of
7941 Transportation, the Virginia Outdoors Foundation, the Department of Historic Resources, the Department
7942 of General Services, the Department of Conservation and Recreation, the Department of Forestry, the
7943 Virginia Alcoholic Beverage Control Authority, *the Virginia Cannabis Control Authority*, the
7944 Department of Rail and Public Transportation, and the State Corporation Commission shall be exempt
7945 from paying any fee for remote access to land records. If any clerk contracts with an outside vendor to
7946 provide remote access to land records to subscribers, such contract shall contain a provision exempting
7947 the Office of the Attorney General, the Division of Debt Collection, the Department of Transportation,
7948 the Virginia Outdoors Foundation, the Department of Historic Resources, the Department of General
7949 Services, the Department of Conservation and Recreation, the Department of Forestry, the Virginia
7950 Alcoholic Beverage Control Authority, *the Virginia Cannabis Control Authority*, the Department of Rail
7951 and Public Transportation, and the State Corporation Commission from paying any access or
7952 subscription fee.

7953 B. The circuit court clerk shall enter into an agreement with each person whom the clerk authorizes
7954 to have remote access, in accordance with the security standards established by the Virginia Information
7955 Technologies Agency. Any such agreement between a state agency or employee thereof acting in the
7956 employee's official capacity and the clerk or an outside vendor contracted by the clerk to provide remote
7957 access to land records to subscribers, or such an agreement between a state agency or employee thereof
7958 acting in the employee's official capacity and both the clerk and the outside vendor, shall not contain
7959 any provision requiring the state agency or employee thereof acting in the employee's official capacity to
7960 indemnify the clerk or the vendor. Any such agreement between a state agency and the clerk or an
7961 outside vendor shall provide that the state agency is required to monitor its employees' activity under
7962 such agreement to ensure compliance with its terms.

7963 C. The clerk may establish a program under which the clerk assesses a reasonable convenience fee
7964 that shall not exceed \$2 per transaction for remote access to land records and a separate fee per image
7965 downloaded in an amount not to exceed the fee provided in subdivision A 8 of § 17.1-275.

7966 D. Nothing herein shall be construed to require the use by the general public of the secure remote
7967 access to land records made available by the clerk, and such records may continue to be accessed in
7968 person in the clerk's office.

7969 § 18.2-46.1. Definitions.

7970 As used in this article unless the context requires otherwise or it is otherwise provided:

7971 "Act of violence" means those felony offenses described in subsection A of § 19.2-297.1.

7972 "Criminal street gang" means any ongoing organization, association, or group of three or more
7973 persons, whether formal or informal, (i) which has as one of its primary objectives or activities the
7974 commission of one or more criminal activities; (ii) which has an identifiable name or identifying sign or
7975 symbol; and (iii) whose members individually or collectively have engaged in the commission of,
7976 attempt to commit, conspiracy to commit, or solicitation of two or more predicate criminal acts, at least
7977 one of which is an act of violence, provided such acts were not part of a common act or transaction.

7978 "Predicate criminal act" means (i) an act of violence; (ii) any violation of § 18.2-31, 18.2-42,
7979 18.2-46.3, 18.2-51, 18.2-51.1, 18.2-51.2, 18.2-51.3, 18.2-51.6, 18.2-52, 18.2-52.1, 18.2-53, 18.2-53.1,

8078 B. The term "imitation controlled substance" when used in this article means (i) a counterfeit
8079 controlled substance or (ii) a pill, capsule, tablet, or substance in any form whatsoever ~~which~~ *that* is not
8080 a controlled substance subject to abuse; and:

8081 1. Which by overall dosage unit appearance, including color, shape, size, marking, and packaging, or
8082 by representations made, would cause the likelihood that such a pill, capsule, tablet, or substance in any
8083 other form whatsoever will be mistaken for a controlled substance unless such substance was introduced
8084 into commerce prior to the initial introduction into commerce of the controlled substance which it is
8085 alleged to imitate; or

8086 2. Which by express or implied representations purports to act like a controlled substance as a
8087 stimulant or depressant of the central nervous system and which is not commonly used or recognized for
8088 use in that particular formulation for any purpose other than for such stimulant or depressant effect,
8089 unless marketed, promoted, or sold as permitted by the U.S. Food and Drug Administration.

8090 C. In determining whether a pill, capsule, tablet, or substance in any other form whatsoever; is an
8091 "imitation controlled substance," there shall be considered, in addition to all other relevant factors,
8092 comparisons with accepted methods of marketing for legitimate nonprescription drugs for medicinal
8093 purposes rather than for drug abuse or any similar nonmedicinal use, including consideration of the
8094 packaging of the drug and its appearance in overall finished dosage form, promotional materials or
8095 representations, oral or written, concerning the drug, and the methods of distribution of the drug and
8096 where and how it is sold to the public.

8097 D. The term "marijuana" when used in this article means any part of a plant of the genus *Cannabis*,
8098 whether growing or not, its seeds or resin; and every compound, manufacture, salt, derivative, mixture,
8099 or preparation of such plant, its seeds, its resin, or any extract containing one or more cannabinoids.
8100 Marijuana does not include the mature stalks of such plant, fiber produced from such stalk, oil or cake
8101 made from the seed of such plant, unless such stalks, fiber, oil or cake is combined with other parts of
8102 plants of the genus *Cannabis*. Marijuana does not include (i) industrial hemp, as defined in § 3.2-4112,

8109 E. The term "counterfeit controlled substance" means a controlled substance that, without
8110 authorization, bears, is packaged in a container or wrapper that bears, or is otherwise labeled to bear, the
8111 trademark, trade name, or other identifying mark, imprint, or device, or any likeness thereof, of a drug
8112 manufacturer, processor, packer, or distributor other than the manufacturer, processor, packer, or

§ 18.2-248. Manufacturing, selling, giving, distributing, or possessing with intent to manufacture, sell, give, or distribute a controlled substance or an imitation controlled substance prohibited; penalties.

A. Except as authorized in the Drug Control Act (§ 54.1-3400 et seq.), it shall be unlawful for any person to manufacture, sell, give, distribute, or possess with intent to manufacture, sell, give, or distribute a controlled substance or an imitation controlled substance.

B. In determining whether any person intends to manufacture, sell, give, or distribute an imitation controlled substance, the court may consider, in addition to all other relevant evidence, whether any distribution or attempted distribution of such pill, capsule, tablet, or substance in any other form whatsoever included an exchange of or a demand for money or other property as consideration, and, if so, whether the amount of such consideration was substantially greater than the reasonable value of such pill, capsule, tablet, or substance in any other form whatsoever, considering the actual chemical composition of such pill, capsule, tablet, or substance in any other form whatsoever and, where applicable, the price at which over-the-counter substances of like chemical composition sell.

C. Except as provided in subsection C1, any person who violates this section with respect to a controlled substance classified in Schedule I or II shall upon conviction be imprisoned for not less than five nor more than 40 years and fined not more than \$500,000. Upon a second conviction of such a violation, and it is alleged in the warrant, indictment, or information that the person has been before convicted of such an offense or of a substantially similar offense in any other jurisdiction, which offense would be a felony if committed in the Commonwealth, and such prior conviction occurred before the date of the offense alleged in the warrant, indictment, or information, any such person may, in the discretion of the court or jury imposing the sentence, be sentenced to imprisonment for life or for any period not less than five years, three years of which shall be a mandatory minimum term of imprisonment to be served consecutively with any other sentence, and he shall be fined not more than \$500,000.

When a person is convicted of a third or subsequent offense under this subsection and it is alleged in the warrant, indictment, or information that he has been before convicted of two or more such offenses or of substantially similar offenses in any other jurisdiction which offenses would be felonies if committed in the Commonwealth and such prior convictions occurred before the date of the offense alleged in the warrant, indictment, or information, he shall be sentenced to imprisonment for life or for a period of not less than 10 years, 10 years of which shall be a mandatory minimum term of imprisonment to be served consecutively with any other sentence, and he shall be fined not more than \$500,000.

Any person who manufactures, sells, gives, distributes, or possesses with the intent to manufacture, sell, give, or distribute the following is guilty of a felony punishable by a fine of not more than \$1 million and imprisonment for five years to life, five years of which shall be a mandatory minimum term of imprisonment to be served consecutively with any other sentence:

1. 100 grams or more of a mixture or substance containing a detectable amount of heroin;
2. 500 grams or more of a mixture or substance containing a detectable amount of:
 - a. Coca leaves, except coca leaves and extracts of coca leaves from which cocaine, ecgonine, and derivatives of ecgonine or their salts have been removed;
 - b. Cocaine, its salts, optical and geometric isomers, and salts of isomers;
 - c. Ecgonine, its derivatives, their salts, isomers, and salts of isomers; or
 - d. Any compound, mixture, or preparation that contains any quantity of any of the substances referred to in subdivisions 2a through 2e a, b, and c;
3. 250 grams or more of a mixture or substance described in subdivisions 2a 2 a through 2d 2 d that contain cocaine base; or
4. 10 grams or more of methamphetamine, its salts, isomers, or salts of its isomers or 20 grams or more of a mixture or substance containing a detectable amount of methamphetamine, its salts, isomers, or salts of its isomers.

The mandatory minimum term of imprisonment to be imposed for a violation of this subsection shall not be applicable if the court finds that:

- a. The person does not have a prior conviction for an offense listed in subsection C of § 17.1-805;
- b. The person did not use violence or credible threats of violence or possess a firearm or other dangerous weapon in connection with the offense or induce another participant in the offense to do so;
- c. The offense did not result in death or serious bodily injury to any person;
- d. The person was not an organizer, leader, manager, or supervisor of others in the offense; and was not engaged in a continuing criminal enterprise as defined in subsection I; and

8178 e. Not later than the time of the sentencing hearing, the person has truthfully provided to the
8179 Commonwealth all information and evidence the person has concerning the offense or offenses that were
8180 part of the same course of conduct or of a common scheme or plan, but the fact that the person has no
8181 relevant or useful other information to provide or that the Commonwealth already is aware of the
8182 information shall not preclude a determination by the court that the defendant has complied with this

8184 C1. Any person who violates this section with respect to the manufacturing of methamphetamine, its
8185 salts, isomers, or salts of its isomers or less than 200 grams of a mixture or substance containing a
8186 detectable amount of methamphetamine, its salts, isomers, or salts of its isomers shall, upon conviction,
8187 be imprisoned for not less than 10 nor more than 40 years and fined not more than \$500,000. Upon a
8188 second conviction of such a violation, any such person may, in the discretion of the court or jury
8189 imposing the sentence, be sentenced to imprisonment for life or for any period not less than 10 years;
8190 and be fined not more than \$500,000. When a person is convicted of a third or subsequent offense
8191 under this subsection and it is alleged in the warrant, indictment, or information that he has been
8192 previously convicted of two or more such offenses or of substantially similar offenses in any other

In any prosecution brought under this subsection, it is not a defense to a violation of this subsection that the defendant believed the imitation controlled substance to actually be a controlled substance.

 - b. Cocaine, its salts, optical and geometric isomers, and salts of isomers;
 - c. Ecgonine, its derivatives, their salts, isomers, and salts of isomers; or
 - d. Any compound, mixture, or preparation ~~which that~~ contains any quantity of any of the substances referred to in subdivisions a ~~through~~, *b, and c*;
3. 2.5 kilograms or more of a mixture or substance described in subdivision 2 ~~which that~~ contains cocaine base; *or*

4. ~~100 kilograms or more of a mixture or substance containing a detectable amount of marijuana; or~~
 5. 100 grams or more of methamphetamine, its salts, isomers, or salts of its isomers or 200 grams or more of a mixture or substance containing a detectable amount of methamphetamine, its salts, isomers, or salts of its isomers ~~shall be~~ *is* guilty of a felony punishable by a fine of not more than \$1 million and imprisonment for 20 years to life, 20 years of which shall be a mandatory minimum sentence. Such mandatory minimum sentence shall not be applicable if the court finds that (i) the person does not have a prior conviction for an offense listed in subsection C of § 17.1-805; (ii) the person did not use violence or credible threats of violence or possess a firearm or other dangerous weapon in connection with the offense or induce another participant in the offense to do so; (iii) the offense did not result in death or serious bodily injury to any person; (iv) the person was not an organizer, leader, manager, or supervisor of others in the offense, and was not engaged in a continuing criminal enterprise as defined in subsection I of ~~this section~~; and (v) not later than the time of the sentencing hearing, the person has truthfully provided to the Commonwealth all information and evidence the person has concerning the offense or offenses that were part of the same course of conduct or of a common scheme or plan, but the fact that the person has no relevant or useful other information to provide or that the Commonwealth already is aware of the information shall not preclude a determination by the court that the defendant has complied with this requirement.

H1. Any person who was the principal or one of several principal administrators, organizers, or leaders of a continuing criminal enterprise ~~shall be~~ *is* guilty of a felony if (i) the enterprise received at least \$100,000 but less than \$250,000 in gross receipts during any 12-month period of its existence from the manufacture, importation, or distribution of heroin or cocaine or ecgonine or methamphetamine or the derivatives, salts, isomers, or salts of isomers thereof ~~or marijuana~~ or (ii) the person engaged in the enterprise to manufacture, sell, give, distribute, or possess with the intent to manufacture, sell, give, or distribute the following during any 12-month period of its existence:

1. At least 1.0 kilograms but less than 5.0 kilograms of a mixture or substance containing a detectable amount of heroin;
2. At least 5.0 kilograms but less than 10 kilograms of a mixture or substance containing a detectable amount of:
 - a. Coca leaves, except coca leaves and extracts of coca leaves from which cocaine, ecgonine, and derivatives of ecgonine or their salts have been removed;
 - b. Cocaine, its salts, optical and geometric isomers, and salts of isomers;

A conviction under this section shall be punishable by a fine of not more than \$1 million and imprisonment for 20 years to life, 20 years of which shall be a mandatory minimum sentence.

8301 H2. Any person who was the principal or one of several principal administrators, organizers, or
 8302 leaders of a continuing criminal enterprise if (i) the enterprise received \$250,000 or more in gross
 8303 receipts during any 12-month period of its existence from the manufacture, importation, or distribution
 8304 of heroin or cocaine or ecgonine or methamphetamine or the derivatives, salts, isomers, or salts of
 8305 isomers thereof ~~or marijuana~~ or (ii) the person engaged in the enterprise to manufacture, sell, give,
 8306 distribute, or possess with the intent to manufacture, sell, give, or distribute the following during any
 8307 12-month period of its existence:

- 8308 1. At least 5.0 kilograms of a mixture or substance containing a detectable amount of heroin;
- 8309 2. At least 10 kilograms of a mixture or substance containing a detectable amount of:
 - 8310 a. Coca leaves, except coca leaves and extracts of coca leaves from which cocaine, ecgonine, and
 - 8311 derivatives of ecgonine or their salts have been removed;
 - 8312 b. Cocaine, its salts, optical and geometric isomers, and salts of isomers;
 - 8313 c. Ecgonine, its derivatives, their salts, isomers, and salts of isomers; or
 - 8314 d. Any compound, mixture, or preparation ~~which~~ *that* contains any quantity of any of the substances
 - 8315 referred to in subdivisions a ~~through~~ *through, b, and c*;

8316 3. At least 5.0 kilograms of a mixture or substance described in subdivision 2 ~~which~~ *that* contains
 8317 cocaine base; *or*

- 8318 4. ~~At least 250 kilograms of a mixture or substance containing a detectable amount of marijuana; or~~
- 8319 ~~5. At least 250 grams of methamphetamine, its salts, isomers, or salts of its isomers or at least 1.0~~
 8320 ~~kilograms of a mixture or substance containing a detectable amount of methamphetamine, its salts,~~
 8321 ~~isomers, or salts of its isomers~~ *shall be is guilty of a felony punishable by a fine of not more than \$1*
 8322 *million and imprisonment for life, which shall be served with no suspension in whole or in part. Such*
 8323 *punishment shall be made to run consecutively with any other sentence. However, the court may impose*
 8324 *a mandatory minimum sentence of 40 years if the court finds that the defendant substantially cooperated*
 8325 *with law-enforcement authorities.*

8326 I. For purposes of this section, a person is engaged in a continuing criminal enterprise if (i) he
 8327 violates any provision of this section, the punishment for which is a felony, and either (ii) such violation
 8328 is a part of a continuing series of violations of this section which are undertaken by such person in
 8329 concert with five or more other persons with respect to whom such person occupies a position of
 8330 organizer, a supervisory position, or any other position of management; and from which such person
 8331 obtains substantial income or resources or (iii) such violation is committed, with respect to
 8332 methamphetamine or other controlled substance classified in Schedule I or II, for the benefit of, at the
 8333 direction of, or in association with any criminal street gang as defined in § 18.2-46.1.

8334 J. Except as authorized in the Drug Control Act (§ 54.1-3400 et seq.), any person who possesses any
 8335 two or more different substances listed below with the intent to manufacture methamphetamine,
 8336 methcathinone, or amphetamine is guilty of a Class 6 felony: liquefied ammonia gas, ammonium nitrate,
 8337 ether, hypophosphorus acid solutions, hypophosphite salts, hydrochloric acid, iodine crystals or tincture
 8338 of iodine, phenylacetone, phenylacetic acid, red phosphorus, methylamine, methyl formamide, lithium,
 8339 sodium metal, sulfuric acid, sodium hydroxide, potassium dichromate, sodium dichromate, potassium
 8340 permanganate, chromium trioxide, methylbenzene, methamphetamine precursor drugs, trichloroethane, or
 8341 2-propanone.

8342 K. The term "methamphetamine precursor drug," when used in this article, means a drug or product
 8343 containing ephedrine, pseudoephedrine, or phenylpropanolamine or any of their salts, optical isomers, or
 8344 salts of optical isomers.

8345 **§ 18.2-248.01. Transporting controlled substances into the Commonwealth; penalty.**

8346 Except as authorized in the Drug Control Act (§ 54.1-3400 et seq.), it is unlawful for any person to
 8347 transport into the Commonwealth by any means with intent to sell or distribute one ounce or more of
 8348 cocaine, coca leaves, or any salt, compound, derivative, or preparation thereof as described in Schedule
 8349 II of the Drug Control Act or one ounce or more of any other Schedule I or II controlled substance ~~or~~
 8350 ~~five or more pounds of marijuana~~. A violation of this section shall constitute a separate and distinct
 8351 felony. Upon conviction, the person shall be sentenced to not less than five years nor more than 40
 8352 years imprisonment, three years of which shall be a mandatory minimum term of imprisonment, and a
 8353 fine not to exceed ~~\$1,000,000~~ *\$1 million*. A second or subsequent conviction hereunder shall be
 8354 punishable by a mandatory minimum term of imprisonment of 10 years, which shall be served
 8355 consecutively with any other sentence.

8356 **§ 18.2-251. Persons charged with first offense may be placed on probation; conditions;** 8357 **substance abuse screening, assessment treatment and education programs or services; drug tests;** 8358 **costs and fees; violations; discharge.**

8359 Whenever any person who has not previously been convicted of any criminal offense under this
 8360 article or under any statute of the United States or of any state relating to narcotic drugs, ~~marijuana~~, or
 8361 stimulant, depressant, or hallucinogenic drugs, or has not previously had a proceeding against him for
 8362 violation of such an offense dismissed as provided in this section, or pleads guilty to or enters a plea of

not guilty to possession of a controlled substance under § 18.2-250, the court, upon such plea if the facts found by the court would justify a finding of guilt, without entering a judgment of guilt and with the consent of the accused, may defer further proceedings and place him on probation upon terms and conditions. If the court defers further proceedings, at that time the court shall determine whether the clerk of court has been provided with the fingerprint identification information or fingerprints of the person, taken by a law-enforcement officer pursuant to § 19.2-390, and, if not, shall order that the fingerprints and photograph of the person be taken by a law-enforcement officer.

As a term or condition, the court shall require the accused to undergo a substance abuse assessment pursuant to § 18.2-251.01 or 19.2-299.2, as appropriate, and enter treatment and/or education program or services, if available, such as, in the opinion of the court, may be best suited to the needs of the accused based upon consideration of the substance abuse assessment. The program or services may be located in the judicial district in which the charge is brought or in any other judicial district as the court may provide. The services shall be provided by (i) a program licensed by the Department of Behavioral Health and Developmental Services, by a similar program which is made available through the Department of Corrections, (ii) a local community-based probation services agency established pursuant to § 9.1-174, or (iii) an ASAP program certified by the Commission on VASAP.

The court shall require the person entering such program under the provisions of this section to pay all or part of the costs of the program, including the costs of the screening, assessment, testing, and treatment, based upon the accused's ability to pay unless the person is determined by the court to be indigent.

As a condition of probation, the court shall require the accused (a) to successfully complete treatment or education program or services, (b) to remain drug and alcohol free during the period of probation and submit to such tests during that period as may be necessary and appropriate to determine if the accused is drug and alcohol free, (c) to make reasonable efforts to secure and maintain employment, and (d) to comply with a plan of at least 100 hours of community service for a felony and up to 24 hours of community service for a misdemeanor. Such testing shall be conducted by personnel of the supervising probation agency or personnel of any program or agency approved by the supervising probation agency.

Upon violation of a term or condition, the court may enter an adjudication of guilt and proceed as otherwise provided. Upon fulfillment of the terms and conditions, and upon determining that the clerk of court has been provided with the fingerprint identification information or fingerprints of such person, the court shall discharge the person and dismiss the proceedings against him. Discharge and dismissal under this section shall be without adjudication of guilt and is a conviction only for the purposes of applying this section in subsequent proceedings.

Notwithstanding any other provision of this section, whenever a court places an individual on probation upon terms and conditions pursuant to this section, such action shall be treated as a conviction for purposes of § 22.1-315. The provisions of this paragraph shall not be applicable to any offense for which a juvenile has had his license suspended or denied pursuant to § 16.1-278.9 for the same offense.

§ 18.2-251.03. Arrest and prosecution when experiencing or reporting overdoses.

A. For purposes of this section, "overdose" means a life-threatening condition resulting from the consumption or use of a controlled substance, alcohol, or any combination of such substances.

B. No individual shall be subject to arrest or prosecution for the unlawful purchase, possession, or consumption of alcohol pursuant to § 4.1-305, unlawful purchase, possession, or consumption of marijuana pursuant to ~~§ 4.1-1105.1~~ 4.1-1104 or 4.1-1105, possession of a controlled substance pursuant to § 18.2-250, intoxication in public pursuant to § 18.2-388, or possession of controlled paraphernalia pursuant to § 54.1-3466 if:

1. Such individual (i) in good faith, seeks or obtains emergency medical attention (a) for himself, if he is experiencing an overdose, or (b) for another individual, if such other individual is experiencing an overdose; (ii) is experiencing an overdose and another individual, in good faith, seeks or obtains emergency medical attention for such individual, by contemporaneously reporting such overdose to a firefighter, as defined in § 65.2-102, emergency medical services personnel, as defined in § 32.1-111.1, a law-enforcement officer, as defined in § 9.1-101, or an emergency 911 system; or (iii) in good faith, renders emergency care or assistance, including cardiopulmonary resuscitation (CPR) or the administration of naloxone or other opioid antagonist for overdose reversal, to an individual experiencing an overdose while another individual seeks or obtains emergency medical attention in accordance with this subdivision;

2. Such individual remains at the scene of the overdose or at any alternative location to which he or the person requiring emergency medical attention has been transported until a law-enforcement officer responds to the report of an overdose. If no law-enforcement officer is present at the scene of the overdose or at the alternative location, then such individual shall cooperate with law enforcement as otherwise set forth herein;

3. Such individual identifies himself to the law-enforcement officer who responds to the report of the

8424 overdose; and

8425 4. The evidence for the prosecution of an offense enumerated in this subsection was obtained as a
8426 result of the individual seeking or obtaining emergency medical attention or rendering emergency care or
8427 assistance.

8428 C. The provisions of this section shall not apply to any person who seeks or obtains emergency
8429 medical attention for himself or another individual, to a person experiencing an overdose when another
8430 individual seeks or obtains emergency medical attention for him, or to a person who renders emergency
8431 care or assistance to an individual experiencing an overdose while another person seeks or obtains
8432 emergency medical attention during the execution of a search warrant or during the conduct of a lawful
8433 search or a lawful arrest.

8434 D. This section does not establish protection from arrest or prosecution for any individual or offense
8435 other than those listed in subsection B.

8436 E. No law-enforcement officer acting in good faith shall be found liable for false arrest if it is later
8437 determined that the person arrested was immune from prosecution under this section.

8438 **§ 18.2-251.1:1. Possession or distribution of cannabis oil; public schools.**

8439 No school nurse employed by a local school board, person employed by a local health department
8440 who is assigned to the public school pursuant to an agreement between the local health department and
8441 the school board, or other person employed by or contracted with a local school board to deliver
8442 health-related services shall be prosecuted under Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or
8443 § 18.2-248, ~~18.2-248.1~~, 18.2-250, or 18.2-255 for the possession or distribution of cannabis oil for
8444 storing, dispensing, or administering cannabis oil, in accordance with a policy adopted by the local
8445 school board, to a student who has been issued a valid written certification for the use of cannabis oil in
8446 accordance with subsection B of § 54.1-3408.3.

8447 **§ 18.2-251.1:2. Possession or distribution of cannabis oil; nursing homes and certified nursing**
8448 **facilities; hospice and hospice facilities; assisted living facilities.**

8449 No person employed by a nursing home, hospice, hospice facility, or assisted living facility and
8450 authorized to possess, distribute, or administer medications to patients or residents shall be prosecuted
8451 under Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or § 18.2-248, ~~18.2-248.1~~, or 18.2-250 for the
8452 possession or distribution of cannabis oil for the purposes of storing, dispensing, or administering
8453 cannabis oil to a patient or resident who has been issued a valid written certification for the use of
8454 cannabis oil in accordance with subsection B of § 54.1-3408.3 and has registered with the Board of
8455 Pharmacy.

8456 **§ 18.2-251.1:3. Possession or distribution of cannabis oil, or industrial hemp; laboratories;**
8457 **Department of Agriculture and Consumer Services employees.**

8458 A. No person employed by an analytical laboratory to retrieve, deliver, or possess cannabis oil or
8459 industrial hemp samples from a permitted pharmaceutical processor, a registered industrial hemp grower,
8460 a federally licensed hemp producer, or a registered industrial hemp processor for the purpose of
8461 performing required testing shall be prosecuted under Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or
8462 § 18.2-248, ~~18.2-248.1~~, 18.2-250, or 18.2-255 for the possession or distribution of cannabis oil or
8463 industrial hemp or for storing cannabis oil or industrial hemp for testing purposes in accordance with
8464 regulations promulgated by the Board of Pharmacy and the Board of Agriculture and Consumer
8465 Services.

8466 B. No employee of the Department of Agriculture and Consumer Services shall be prosecuted under
8467 *Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or § 18.2-247*, 18.2-248, 18.2-248.01, ~~18.2-248.1~~, or
8468 18.2-250 for the possession or distribution of industrial hemp when possession of industrial hemp is
8469 necessary in the performance of his duties.

8470 **§ 18.2-252. Suspended sentence conditioned upon substance abuse screening, assessment, testing,**
8471 **and treatment or education.**

8472 The trial judge or court trying the case of any person found guilty of a criminal violation of any law
8473 concerning the use, in any manner, of drugs, controlled substances, narcotics, ~~marijuana~~, noxious
8474 chemical substances and like substances shall condition any suspended sentence by first requiring such
8475 person to agree to undergo a substance abuse screening pursuant to § 18.2-251.01 and to submit to such
8476 periodic substance abuse testing, to include alcohol testing, as may be directed by the court. Such testing
8477 shall be conducted by the supervising probation agency or by personnel of any program or agency
8478 approved by the supervising probation agency. The cost of such testing ordered by the court shall be
8479 paid by the Commonwealth and taxed as a part of the costs of such proceedings. The judge or court
8480 shall order the person, as a condition of any suspended sentence, to undergo such treatment or education
8481 for substance abuse, if available, as the judge or court deems appropriate based upon consideration of
8482 the substance abuse assessment. The treatment or education shall be provided by a program or agency
8483 licensed by the Department of Behavioral Health and Developmental Services, by a similar program or
8484 services available through the Department of Corrections if the court imposes a sentence of one year or
8485 more or, if the court imposes a sentence of 12 months or less, by a similar program or services available

through a local or regional jail, a local community-based probation services agency established pursuant to § 9.1-174, or an ASAP program certified by the Commission on VASAP.

§ 18.2-254. Commitment of convicted person for treatment for substance abuse.

A. Whenever any person who has not previously been convicted of any criminal offense under this article or under any statute of the United States or of any state relating to narcotic drugs, ~~marijuana~~, stimulant, depressant, or hallucinogenic drugs or has not previously had a proceeding against him for violation of such an offense dismissed as provided in § 18.2-251 is found guilty of violating any law concerning the use, in any manner, of drugs, controlled substances, narcotics, ~~marijuana~~, noxious chemical substances, and like substances, the judge or court shall require such person to undergo a substance abuse screening pursuant to § 18.2-251.01 and to submit to such periodic substance abuse testing, to include alcohol testing, as may be directed by the court. The cost of such testing ordered by the court shall be paid by the Commonwealth and taxed as a part of the costs of the criminal proceedings. The judge or court shall also order the person to undergo such treatment or education for substance abuse, if available, as the judge or court deems appropriate based upon consideration of the substance abuse assessment. The treatment or education shall be provided by a program or agency licensed by the Department of Behavioral Health and Developmental Services or by a similar program or services available through the Department of Corrections if the court imposes a sentence of one year or more or, if the court imposes a sentence of 12 months or less, by a similar program or services available through a local or regional jail, a local community-based probation services agency established pursuant to § 9.1-174, or an ASAP program certified by the Commission on VASAP.

B. The court trying the case of any person alleged to have committed any criminal offense designated by this article or by the Drug Control Act (§ 54.1-3400 et seq.) or in any other criminal case in which the commission of the offense was motivated by or closely related to the use of drugs and determined by the court, pursuant to a substance abuse screening and assessment, to be in need of treatment for the use of drugs may commit, based upon a consideration of the substance abuse assessment, such person, upon his conviction, to any facility for the treatment of persons with substance abuse, licensed by the Department of Behavioral Health and Developmental Services, if space is available in such facility, for a period of time not in excess of the maximum term of imprisonment specified as the penalty for conviction of such offense or, if sentence was determined by a jury, not in excess of the term of imprisonment as set by such jury. Confinement under such commitment shall be, in all regards, treated as confinement in a penal institution and the person so committed may be convicted of escape if he leaves the place of commitment without authority. A charge of escape may be prosecuted in either the jurisdiction where the treatment facility is located or the jurisdiction where the person was sentenced to commitment. The court may revoke such commitment at any time and transfer the person to an appropriate state or local correctional facility. Upon presentation of a certified statement from the director of the treatment facility to the effect that the confined person has successfully responded to treatment, the court may release such confined person prior to the termination of the period of time for which such person was confined and may suspend the remainder of the term upon such conditions as the court may prescribe.

C. The court trying a case in which commission of the criminal offense was related to the defendant's habitual abuse of alcohol and in which the court determines, pursuant to a substance abuse screening and assessment, that such defendant is in need of treatment, may commit, based upon a consideration of the substance abuse assessment, such person, upon his conviction, to any facility for the treatment of persons with substance abuse licensed by the Department of Behavioral Health and Developmental Services, if space is available in such facility, for a period of time not in excess of the maximum term of imprisonment specified as the penalty for conviction. Confinement under such commitment shall be, in all regards, treated as confinement in a penal institution and the person so committed may be convicted of escape if he leaves the place of commitment without authority. The court may revoke such commitment at any time and transfer the person to an appropriate state or local correctional facility. Upon presentation of a certified statement from the director of the treatment facility to the effect that the confined person has successfully responded to treatment, the court may release such confined person prior to the termination of the period of time for which such person was confined and may suspend the remainder of the term upon such conditions as the court may prescribe.

§ 18.2-255. Distribution of certain drugs to persons under 18 prohibited; penalty.

A. Except as authorized in the Drug Control Act, ~~Chapter 34~~ (§ 54.1-3400 et seq.) of Title 54.1, it ~~shall be~~ is unlawful for any person who is at least 18 years of age to knowingly or intentionally (i) distribute any drug classified in Schedule I, II, III, or IV ~~or marijuana~~ to any person under 18 years of age who is at least three years his junior or (ii) cause any person under 18 years of age to assist in such distribution of any drug classified in Schedule I, II, III, or IV ~~or marijuana~~. Any person violating this provision shall upon conviction be imprisoned in a state correctional facility for a period not less than 10 nor more than 50 years, and fined not more than \$100,000. Five years of the sentence imposed for a

8547 conviction under this section involving a Schedule I or II controlled substance ~~or one ounce or more of~~
8548 ~~marijuana~~ shall be a mandatory minimum sentence. ~~Two years of the sentence imposed for a conviction~~
8549 ~~under this section involving less than one ounce of marijuana shall be a mandatory minimum sentence.~~

8550 B. It ~~shall be~~ *is* unlawful for any person who is at least 18 years of age to knowingly or intentionally
8551 (i) distribute any imitation controlled substance to a person under 18 years of age who is at least three
8552 years his junior or (ii) cause any person under 18 years of age to assist in such distribution of any
8553 imitation controlled substance. Any person violating this provision ~~shall be~~ *is* guilty of a Class 6 felony.

8554 **§ 18.2-255.1. Distribution, sale, or display to a minor of printed material advertising**
8555 **instruments for use in administering a controlled substance; penalty.**

8556 It ~~shall be~~ *is* a Class 1 misdemeanor for any person knowingly to sell, distribute, or display for sale
8557 to a minor any book, pamphlet, periodical, or other printed matter ~~which~~ *that* he knows advertises for
8558 sale any instrument, device, article, or contrivance for advertised use in unlawfully ingesting, smoking,
8559 administering, preparing, or growing ~~marijuana~~ *or* a controlled substance.

8560 **§ 18.2-255.2. Prohibiting the sale or manufacture of drugs on or near certain properties;**
8561 **penalty.**

8562 A. It ~~shall be~~ *is* unlawful for any person to manufacture, sell, or distribute or possess with intent to
8563 sell, give, or distribute any controlled substance, *or* imitation controlled substance, ~~or marijuana~~ while:

8564 1. Upon the property, including buildings and grounds, of any public or private elementary or
8565 secondary school, any institution of higher education, or any clearly marked licensed child day center as
8566 defined in § 22.1-289.02;

8567 2. Upon public property or any property open to public use within 1,000 feet of the property
8568 described in subdivision 1;

8569 3. On any school bus as defined in § 46.2-100;

8570 4. Upon a designated school bus stop, or upon either public property or any property open to public
8571 use which is within 1,000 feet of such school bus stop, during the time when school children are
8572 waiting to be picked up and transported to or are being dropped off from school or a school-sponsored
8573 activity;

8574 5. Upon the property, including buildings and grounds, of any publicly owned or publicly operated
8575 recreation or community center facility or any public library; or

8576 6. Upon the property of any state facility as defined in § 37.2-100 or upon public property or
8577 property open to public use within 1,000 feet of such ~~an institution~~ *facility*.

8578 It is a violation of the provisions of this section if the person possessed the controlled substance, *or*
8579 imitation controlled substance, ~~or marijuana~~ on the property described in subdivisions 1 through 6,
8580 regardless of where the person intended to sell, give, or distribute the controlled substance, *or* imitation
8581 controlled substance, ~~or marijuana~~. Nothing in this section shall prohibit the authorized distribution of
8582 controlled substances.

8583 B. Violation of this section shall constitute a separate and distinct felony. Any person violating the
8584 provisions of this section shall, upon conviction, be imprisoned for a term of not less than one year nor
8585 more than five years and fined not more than \$100,000. A second or subsequent conviction hereunder
8586 for an offense involving a controlled substance classified in Schedule I, II, or III of the Drug Control
8587 Act (§ 54.1-3400 et seq.) ~~or more than one-half ounce of marijuana~~ shall be punished by a mandatory
8588 minimum term of imprisonment of one year to be served consecutively with any other sentence.
8589 However, if such person proves that he sold such controlled substance ~~or marijuana~~ only as an

8598 **§ 18.2-258. Certain premises deemed common nuisance; penalty.**

8599 Any office, store, shop, restaurant, dance hall, theater, poolroom, clubhouse, storehouse, warehouse,
8600 dwelling house, apartment, building of any kind, vehicle, vessel, boat, or aircraft, which with the
8601 knowledge of the owner, lessor, agent of any such lessor, manager, chief executive officer, operator, or

8606 Any such owner, lessor, agent of any such lessor, manager, chief executive officer, operator, or tenant
8607 who knowingly permits, establishes, keeps, or maintains such a common nuisance is guilty of a Class 1
8608 misdemeanor and, for a second or subsequent offense, a Class 6 felony.

§ 18.2-258.02. Maintaining a fortified drug house; penalty.

Any office, store, restaurant, dance hall, theater, poolroom, clubhouse, storehouse, warehouse, dwelling house, apartment or building, or structure of any kind ~~which~~ *that* is (i) substantially altered from its original status by means of reinforcement with the intent to impede, deter, or delay lawful entry by a law-enforcement officer into such structure, (ii) being used for the purpose of manufacturing or distributing controlled substances ~~or marijuana~~, and (iii) the object of a valid search warrant; shall be considered a fortified drug house. Any person who maintains or operates a fortified drug house is guilty of a Class 5 felony.

§ 18.2-258.1. Obtaining drugs, procuring administration of controlled substances, etc., by fraud, deceit, or forgery.

A. It ~~shall be~~ *is* unlawful for any person to obtain or attempt to obtain any drug or procure or attempt to procure the administration of any controlled substance ~~or marijuana~~: (i) by fraud, deceit, misrepresentation, embezzlement, or subterfuge; (ii) by the forgery or alteration of a prescription or of any written order; (iii) by the concealment of a material fact; or (iv) by the use of a false name or the giving of a false address.

B. It ~~shall be~~ *is* unlawful for any person to furnish false or fraudulent information in ~~or~~, omit any information from, or willfully make a false statement in, any prescription, order, report, record, or other document required by ~~Chapter 34~~ *the Drug Control Act* (§ 54.1-3400 et seq.) ~~of Title 54.1~~.

C. It ~~shall be~~ *is* unlawful for any person to use in the course of the manufacture or distribution of a controlled substance ~~or marijuana~~ a license number ~~which~~ *that* is fictitious, revoked, suspended, or issued to another person.

D. It ~~shall be~~ *is* unlawful for any person, for the purpose of obtaining any controlled substance ~~or marijuana~~ to falsely assume the title of, or represent himself to be, a manufacturer, wholesaler, pharmacist, physician, dentist, veterinarian, or other authorized person.

E. It ~~shall be~~ *is* unlawful for any person to make or utter any false or forged prescription or false or forged written order.

F. It ~~shall be~~ *is* unlawful for any person to affix any false or forged label to a package or receptacle containing any controlled substance.

G. This section shall not apply to officers and employees of the United States, of this Commonwealth, or of a political subdivision of this Commonwealth, acting in the course of their employment, who obtain such drugs for investigative, research, or analytical purposes, or to the agents or duly authorized representatives of any pharmaceutical manufacturer who obtain such drugs for investigative, research, or analytical purposes and who are acting in the course of their employment, provided that such manufacturer is licensed under the provisions of the Federal Food, Drug and Cosmetic Act, and provided further, that such pharmaceutical manufacturer, its agents, and duly authorized representatives file with the Board such information as the Board may deem appropriate.

H. Except as otherwise provided in this subsection, any person who shall violate any provision herein ~~shall be~~ *is* guilty of a Class 6 felony.

Whenever any person who has not previously been convicted of any offense under this article or under any statute of the United States or of any state relating to narcotic drugs, ~~marijuana~~, or stimulant, depressant, or hallucinogenic drugs, or has not previously had a proceeding against him for violation of such an offense dismissed, or reduced as provided in this section, pleads guilty to or enters a plea of not guilty to the court for violating this section, upon such plea if the facts found by the court would justify a finding of guilt, the court may place him on probation upon terms and conditions.

As a term or condition, the court shall require the accused to be evaluated and enter a treatment and/or education program, if available, such as, in the opinion of the court, may be best suited to the needs of the accused. This program may be located in the judicial circuit in which the charge is brought or in any other judicial circuit as the court may provide. The services shall be provided by a program certified or licensed by the Department of Behavioral Health and Developmental Services. The court shall require the person entering such program under the provisions of this section to pay all or part of the costs of the program, including the costs of the screening, evaluation, testing, and education, based upon the person's ability to pay unless the person is determined by the court to be indigent.

As a condition of supervised probation, the court shall require the accused to remain drug free during the period of probation and submit to such tests during that period as may be necessary and appropriate to determine if the accused is drug free. Such testing may be conducted by the personnel of any screening, evaluation, and education program to which the person is referred or by the supervising agency.

Unless the accused was fingerprinted at the time of arrest, the court shall order the accused to report to the original arresting law-enforcement agency to submit to fingerprinting.

Upon violation of a term or condition, the court may enter an adjudication of guilt upon the felony and proceed as otherwise provided. Upon fulfillment of the terms and conditions of probation, the court

8670 shall find the defendant guilty of a Class 1 misdemeanor.

8671 **§ 18.2-265.1. Definition.**

8672 As used in this article, the term "drug paraphernalia" means all equipment, products, and materials of
 8673 any kind which are either designed for use or which are intended by the person charged with violating
 8674 § 18.2-265.3 for use in planting, propagating, cultivating, growing, harvesting, manufacturing,
 8675 compounding, converting, producing, processing, preparing, strength testing, analyzing, packaging,
 8676 repackaging, storing, containing, concealing, injecting, ingesting, inhaling, or otherwise introducing into
 8677 the human body ~~marijuana~~ or a controlled substance. It includes, but is not limited to:

8678 1. Kits intended for use or designed for use in planting, propagating, cultivating, growing, or
 8679 harvesting of ~~marijuana~~ or any species of plant which is a controlled substance or from which a
 8680 controlled substance can be derived;

8681 2. Kits intended for use or designed for use in manufacturing, compounding, converting, producing,
 8682 processing, or preparing ~~marijuana~~ or controlled substances;

8683 3. Isomerization devices intended for use or designed for use in increasing the potency of ~~marijuana~~
 8684 or any species of plant ~~which~~ *that* is a controlled substance;

8685 4. Testing equipment intended for use or designed for use in identifying or in analyzing the strength
 8686 or effectiveness of ~~marijuana~~ or controlled substances, other than narcotic testing products used to
 8687 determine whether a controlled substance contains fentanyl or a fentanyl analog;

8688 5. Scales and balances intended for use or designed for use in weighing or measuring ~~marijuana~~ or
 8689 controlled substances;

8690 6. Diluents and adulterants, such as quinine hydrochloride, mannitol, or mannite, intended for use or
 8691 designed for use in cutting controlled substances;

8692 7. ~~Separation gins and sifters intended for use or designed for use in removing twigs and seeds from,~~
 8693 ~~or in otherwise cleaning or refining, marijuana;~~

8694 8. Blenders, bowls, containers, spoons, and mixing devices intended for use or designed for use in
 8695 compounding controlled substances;

8696 9. 8. Capsules, balloons, envelopes, and other containers intended for use or designed for use in
 8697 packaging small quantities of ~~marijuana~~ or controlled substances;

8698 10. 9. Containers and other objects intended for use or designed for use in storing or concealing
 8699 ~~marijuana~~ or controlled substances;

8700 11. 10. Hypodermic syringes, needles, and other objects intended for use or designed for use in
 8701 parenterally injecting controlled substances into the human body;

8702 12. 11. Objects intended for use or designed for use in ingesting, inhaling, or otherwise introducing
 8703 ~~marijuana, cocaine, hashish, or hashish oil~~ into the human body, such as:

8704 a. Metal, wooden, acrylic, glass, stone, plastic, or ceramic pipes with or without screens, permanent
 8705 screens, ~~hashish~~ heads, or punctured metal bowls;

8706 b. Water pipes;

8707 c. Carburetion tubes and devices;

8708 d. Smoking and carburetion masks;

8709 e. Roach clips, meaning objects used to hold burning material, ~~such as a marijuana cigarette~~, that has
 8710 become too small or too short to be held in the hand;

8711 f. Miniature cocaine spoons, and cocaine vials;

8712 g. Chamber pipes;

8713 h. Carburetor pipes;

8714 i. Electric pipes;

8715 j. Air-driven pipes;

8716 k. Chillums;

8717 l. Bongs;

8718 m. Ice pipes or chillers.

8719 **§ 18.2-265.2. Evidence to be considered in cases under this article.**

8720 In determining whether an object is drug paraphernalia, the court may consider, in addition to all
 8721 other relevant evidence, the following:

8722 1. Constitutionally admissible statements by the accused concerning the use of the object;

8723 2. The proximity of the object to ~~marijuana~~ or controlled substances, which proximity is actually
 8724 known to the accused;

8725 3. Instructions, oral or written, provided with the object concerning its use;

8726 4. Descriptive materials accompanying the object ~~which~~ *that* explain or depict its use;

8727 5. National and local advertising within the actual knowledge of the accused concerning its use;

8728 6. The manner in which the object is displayed for sale;

8729 7. Whether the accused is a legitimate supplier of like or related items to the community, such as a
 8730 licensed distributor or dealer of tobacco products;

8731 8. Evidence of the ratio of sales of the objects defined in § 18.2-265.1 to the total sales of the

business enterprise;

9. The existence and scope of legitimate uses for the object in the community;

10. Expert testimony concerning its use or the purpose for which it was designed; *and*

11. Relevant evidence of the intent of the accused to deliver it to persons who he knows, or should reasonably know, intend to use the object with an illegal drug. The innocence of an owner, or of anyone in control of the object, as to a direct violation of this article shall not prevent a finding that the object is intended for use or designed for use as drug paraphernalia.

§ 18.2-265.3. Penalties for sale, etc., of drug paraphernalia.

A. Any person who sells or possesses with intent to sell drug paraphernalia, knowing, or under circumstances where one reasonably should know, that it is either designed for use or intended by such person for use to illegally plant, propagate, cultivate, grow, harvest, manufacture, compound, convert, produce, process, prepare, test, analyze, pack, repack, store, contain, conceal, inject, ingest, inhale, or otherwise introduce into the human body ~~marijuana~~ or a controlled substance, ~~shall be~~ *is* guilty of a Class 1 misdemeanor.

B. Any person ~~eighteen~~ 18 years of age or older who violates subsection A ~~hereof~~ by selling drug paraphernalia to a minor who is at least three years junior to the accused in age ~~shall be~~ *is* guilty of a Class 6 felony.

C. Any person ~~eighteen~~ 18 years of age or older who distributes drug paraphernalia to a minor ~~shall be~~ *is* guilty of a Class 1 misdemeanor.

§ 18.2-287.2. Wearing of body armor while committing a crime; penalty.

Any person who, while committing a crime of violence as defined in § 18.2-288 (2) or a felony violation of § 18.2-248 ~~or subdivision (a) 2 or 3 of § 18.2-248.1~~, has in his possession a firearm or knife and is wearing body armor designed to diminish the effect of the impact of a bullet or projectile ~~shall be~~ *is* guilty of a Class 4 felony.

§ 18.2-308.03. Fees for concealed handgun permits.

A. The clerk shall charge a fee of \$10 for the processing of an application or issuing of a permit, including his costs associated with the consultation with law-enforcement agencies. The local law-enforcement agency conducting the background investigation may charge a fee not to exceed \$35 to cover the cost of conducting an investigation pursuant to this article. The \$35 fee shall include any amount assessed by the U.S. Federal Bureau of Investigation for providing criminal history record information, and the local law-enforcement agency shall forward the amount assessed by the U.S. Federal Bureau of Investigation to the State Police with the fingerprints taken from any nonresident applicant. The State Police may charge a fee not to exceed \$5 to cover its costs associated with processing the application. The total amount assessed for processing an application for a permit shall not exceed \$50, with such fees to be paid in one sum to the person who receives the application. Payment may be made by any method accepted by that court for payment of other fees or penalties. No payment shall be required until the application is received by the court as a complete application.

B. No fee shall be charged for the issuance of such permit to a person who has retired from service (i) as a magistrate in the Commonwealth; (ii) as a special agent with the Virginia Alcoholic Beverage Control Authority *or the Virginia Cannabis Control Authority* or as a law-enforcement officer with the Department of State Police, the Department of Wildlife Resources, or a sheriff or police department, bureau, or force of any political subdivision of the Commonwealth, after completing 15 years of service or after reaching age 55; (iii) as a law-enforcement officer with the U.S. Federal Bureau of Investigation, Bureau of Alcohol, Tobacco and Firearms, Secret Service Agency, Drug Enforcement Administration, United States Citizenship and Immigration Services, U.S. Customs and Border Protection, Department of State Diplomatic Security Service, U.S. Marshals Service, or Naval Criminal Investigative Service, after completing 15 years of service or after reaching age 55; (iv) as a law-enforcement officer with any police or sheriff's department within the United States, the District of Columbia, or any of the territories of the United States, after completing 15 years of service; (v) as a law-enforcement officer with any combination of the agencies listed in clauses (ii) ~~through~~, (iii), *and* (iv), after completing 15 years of service; (vi) as a designated boarding team member or boarding officer of the United States Coast Guard, after completing 15 years of service or after reaching age 55; (vii) as a correctional officer as defined in § 53.1-1, after completing 15 years of service; or (viii) as a probation and parole officer authorized pursuant to § 53.1-143, after completing 15 years of service.

§ 18.2-308.012. Prohibited conduct.

A. Any person permitted to carry a concealed handgun who is under the influence of alcohol, *marijuana*, or illegal drugs while carrying such handgun in a public place is guilty of a Class 1 misdemeanor. Conviction of any of the following offenses shall be prima facie evidence, subject to rebuttal, that the person is "under the influence" for purposes of this section: manslaughter in violation of § 18.2-36.1, maiming in violation of § 18.2-51.4, driving while intoxicated in violation of § 18.2-266, public intoxication in violation of § 18.2-388, or driving while intoxicated in violation of § 46.2-341.24.

8793 Upon such conviction that court shall revoke the person's permit for a concealed handgun and promptly
8794 notify the issuing circuit court. A person convicted of a violation of this subsection shall be ineligible to
8795 apply for a concealed handgun permit for a period of five years.

8796 B. No person who carries a concealed handgun onto the premises of any restaurant or club as
8797 defined in § 4.1-100 for which a license to sell and serve alcoholic beverages for on-premises
8798 consumption has been granted by the Virginia Alcoholic Beverage Control Authority under Title 4.1
8799 may consume an alcoholic beverage while on the premises. A person who carries a concealed handgun
8800 onto the premises of such a restaurant or club and consumes alcoholic beverages is guilty of a Class 2
8801 misdemeanor. However, nothing in this subsection shall apply to a federal, state, or local
8802 law-enforcement officer.

8803 **§ 18.2-308.016. Retired law-enforcement officers; carrying a concealed handgun.**

8804 A. Except as provided in subsection A of § 18.2-308.012, § 18.2-308 shall not apply to:

8805 1. Any State Police officer retired from the Department of State Police, any officer retired from the
8806 Division of Capitol Police, any local law-enforcement officer, auxiliary police officer, or animal control
8807 officer retired from a police department or sheriff's office within the Commonwealth, any special agent
8808 retired from the State Corporation Commission ~~or~~, the Virginia Alcoholic Beverage Control Authority,
8809 *or the Virginia Cannabis Control Authority*, any employee with internal investigations authority
8810 designated by the Department of Corrections pursuant to subdivision 11 of § 53.1-10 retired from the
8811 Department of Corrections, any conservation police officer retired from the Department of Wildlife
8812 Resources, any conservation officer retired from the Department of Conservation and Recreation, any
8813 Virginia Marine Police officer retired from the Law Enforcement Division of the Virginia Marine
8814 Resources Commission, any campus police officer appointed under Article 3 (§ 23.1-809 et seq.) of
8815 Chapter 8 of Title 23.1 retired from a campus police department, any retired member of the enforcement
8816 division of the Department of Motor Vehicles appointed pursuant to § 46.2-217, and any retired
8817 investigator of the security division of the Virginia Lottery, other than an officer or agent terminated for
8818 cause, (i) with a service-related disability; (ii) following at least 10 years of service with any such
8819 law-enforcement agency, commission, board, or any combination thereof; (iii) who has reached 55 years
8820 of age; or (iv) who is on long-term leave from such law-enforcement agency or board due to a
8821 service-related injury, provided such officer carries with him written proof of consultation with and
8822 favorable review of the need to carry a concealed handgun issued by the chief law-enforcement officer
8823 of the last such agency from which the officer retired or the agency that employs the officer or, in the
8824 case of special agents, issued by the State Corporation Commission ~~or~~, the Virginia Alcoholic Beverage
8825 Control Authority, *or the Virginia Cannabis Control Authority*. A copy of the proof of consultation and
8826 favorable review shall be forwarded by the chief, Commission, or Board to the Department of State
8827 Police for entry into the Virginia Criminal Information Network. The chief law-enforcement officer shall
8828 not without cause withhold such written proof if the retired law-enforcement officer otherwise meets the
8829 requirements of this section. An officer set forth in clause (iv) who receives written proof of
8830 consultation to carry a concealed handgun shall surrender such proof of consultation upon return to work
8831 as a law-enforcement officer or upon termination of employment with the law-enforcement agency.
8832 Notice of the surrender shall be forwarded to the Department of State Police for entry into the Virginia
8833 Criminal Information Network. However, if such officer retires on disability because of the
8834 service-related injury, and would be eligible under clause (i) for written proof of consultation to carry a
8835 concealed handgun, he may retain the previously issued written proof of consultation.

8836 2. Any person who is eligible for retirement with at least 20 years of service with a law-enforcement
8837 agency, commission, or board mentioned in subdivision 1 who has resigned in good standing from such
8838 law-enforcement agency, commission, or board to accept a position covered by a retirement system that
8839 is authorized under Title 51.1, provided such person carries with him written proof of consultation with
8840 and favorable review of the need to carry a concealed handgun issued by the chief law-enforcement
8841 officer of the agency from which he resigned or, in the case of special agents, issued by the State
8842 Corporation Commission ~~or~~, the Virginia Alcoholic Beverage Control Authority, *or the Virginia*
8843 *Cannabis Control Authority*. A copy of the proof of consultation and favorable review shall be
8844 forwarded by the chief, Commission, or Board to the Department of State Police for entry into the
8845 Virginia Criminal Information Network. The chief law-enforcement officer shall not without cause
8846 withhold such written proof if the law-enforcement officer otherwise meets the requirements of this
8847 section.

8848 3. Any State Police officer who is a member of the organized reserve forces of any of the Armed
8849 Services of the United States or National Guard, while such officer is called to active military duty,
8850 provided such officer carries with him written proof of consultation with and favorable review of the
8851 need to carry a concealed handgun issued by the Superintendent of State Police. The proof of
8852 consultation and favorable review shall be valid as long as the officer is on active military duty and
8853 shall expire when the officer returns to active law-enforcement duty. The issuance of the proof of
8854 consultation and favorable review shall be entered into the Virginia Criminal Information Network. The

Superintendent of State Police shall not without cause withhold such written proof if the officer is in good standing and is qualified to carry a weapon while on active law-enforcement duty.

4. Any retired or resigned attorney for the Commonwealth or assistant attorney for the Commonwealth who (i) was not terminated for cause and served at least 10 years prior to his retirement or resignation; (ii) during the most recent 12-month period, has met, at his own expense, the standards for qualification in firearms training for active law-enforcement officers in the Commonwealth; (iii) carries with him written proof of consultation with and favorable review of the need to carry a concealed handgun issued by the attorney for the Commonwealth from whose office he retired or resigned; and (iv) meets the requirements of a "qualified retired law enforcement officer" pursuant to the federal Law Enforcement Officers Safety Act of 2004 (18 U.S.C. § 926C). A copy of the proof of consultation and favorable review shall be forwarded by the attorney for the Commonwealth to the Department of State Police for entry into the Virginia Criminal Information Network.

B. For purposes of complying with the federal Law Enforcement Officers Safety Act of 2004, a retired or resigned law-enforcement officer, including a retired or resigned attorney for the Commonwealth or assistant attorney for the Commonwealth, who receives proof of consultation and review pursuant to this section shall have the opportunity to annually participate, at the retired or resigned law-enforcement officer's expense, in the same training and testing to carry firearms as is required of active law-enforcement officers in the Commonwealth. If such retired or resigned law-enforcement officer meets the training and qualification standards, the chief law-enforcement officer shall issue the retired or resigned officer certification, valid one year from the date of issuance, indicating that the retired or resigned officer has met the standards of the agency to carry a firearm.

C. A retired or resigned law-enforcement officer, including a retired or resigned attorney for the Commonwealth or assistant attorney for the Commonwealth, who receives proof of consultation and review pursuant to this section may annually participate and meet the training and qualification standards to carry firearms as is required of active law-enforcement officers in the Commonwealth. If such retired or resigned law-enforcement officer meets the training and qualification standards, the chief law-enforcement officer shall issue the retired or resigned officer certification, valid one year from the date of issuance, indicating that the retired or resigned officer has met the standards of the Commonwealth to carry a firearm. A copy of the certification indicating that the retired or resigned officer has met the standards of the Commonwealth to carry a firearm shall be forwarded by the chief, Commission, Board, or attorney for the Commonwealth to the Department of State Police for entry into the Virginia Criminal Information Network.

D. For all purposes, including for the purpose of applying the reciprocity provisions of § 18.2-308.014, any person granted the privilege to carry a concealed handgun pursuant to this section, while carrying the proof of consultation and favorable review required, shall be deemed to have been issued a concealed handgun permit.

§ 18.2-308.4. Possession of firearms while in possession of certain substances.

A. It shall be unlawful for any person unlawfully in possession of a controlled substance classified in Schedule I or II of the Drug Control Act (§ 54.1-3400 et seq.) of Title 54.1 to simultaneously with knowledge and intent possess any firearm. A violation of this subsection is a Class 6 felony and constitutes a separate and distinct felony.

B. It shall be unlawful for any person unlawfully in possession of a controlled substance classified in Schedule I or II of the Drug Control Act (§ 54.1-3400 et seq.) to simultaneously with knowledge and intent possess any firearm on or about his person. A violation of this subsection is a Class 6 felony and constitutes a separate and distinct felony and any person convicted hereunder shall be sentenced to a mandatory minimum term of imprisonment of two years. Such punishment shall be separate and apart from, and shall be made to run consecutively with, any punishment received for the commission of the primary felony.

C. It shall be unlawful for any person to possess, use, or attempt to use any pistol, shotgun, rifle, or other firearm or display such weapon in a threatening manner while committing or attempting to commit the illegal manufacture, sale, distribution, or the possession with the intent to manufacture, sell, or distribute a controlled substance classified in Schedule I or Schedule II of the Drug Control Act (§ 54.1-3400 et seq.) or more than one pound of marijuana. A violation of this subsection is a Class 6 felony; and constitutes a separate and distinct felony and any person convicted hereunder shall be sentenced to a mandatory minimum term of imprisonment of five years. Such punishment shall be separate and apart from, and shall be made to run consecutively with, any punishment received for the commission of the primary felony.

§ 18.2-371.2. Prohibiting purchase or possession of tobacco products, nicotine vapor products, alternative nicotine products, and hemp products intended for smoking by a person under 21 years of age or sale of tobacco products, nicotine vapor products, alternative nicotine products, and hemp products intended for smoking to persons under 21 years of age.

8916 A. No person shall sell to, distribute to, purchase for, or knowingly permit the purchase by any
8917 person ~~less~~ *younger* than 21 years of age, knowing or having reason to believe that such person is ~~less~~
8918 *younger* than 21 years of age, any tobacco product, nicotine vapor product, alternative nicotine product,
8919 or hemp product intended for smoking.

8920 Tobacco products, nicotine vapor products, alternative nicotine products, and hemp products intended
8921 for smoking may be sold from a vending machine only if the machine is (i) posted with a notice, in a
8922 conspicuous manner and place, indicating that the purchase or possession of such products by persons
8923 ~~under~~ *younger than* 21 years of age is unlawful and (ii) located in a place that is not open to the general
8924 public and is not generally accessible to persons ~~under~~ *younger than* 21 years of age. An establishment
8925 that prohibits the presence of persons ~~under~~ *younger than* 21 years of age unless accompanied by a
8926 person 21 years of age or older is not open to the general public.

8927 B. No person ~~less~~ *younger* than 21 years of age shall attempt to purchase, purchase, or possess any
8928 tobacco product, nicotine vapor product, alternative nicotine product, or hemp product intended for
8929 smoking. The provisions of this subsection shall not be applicable to the possession of tobacco products,
8930 nicotine vapor products, alternative nicotine products, or hemp products intended for smoking by a
8931 person ~~less~~ *younger* than 21 years of age (i) making a delivery of tobacco products, nicotine vapor
8932 products, alternative nicotine products, or hemp products intended for smoking in pursuance of his
8933 employment or (ii) as part of a scientific study being conducted by an organization for the purpose of
8934 medical research to further efforts in cigarette and tobacco use prevention and cessation and tobacco
8935 product regulation, provided that such medical research has been approved by an institutional review
8936 board pursuant to applicable federal regulations or by a research review committee pursuant to Chapter
8937 5.1 (§ 32.1-162.16 et seq.) of Title 32.1. This subsection shall not apply to purchase, attempt to
8938 purchase, or possession by a law-enforcement officer or his agent when the same is necessary in the
8939 performance of his duties.

8940 C. No person shall sell a tobacco product, nicotine vapor product, alternative nicotine product, or
8941 hemp product intended for smoking to any individual who does not demonstrate, by producing a driver's
8942 license or similar photo identification issued by a government agency, that the individual is at least 21
8943 years of age. Such identification is not required from an individual whom the person has reason to
8944 believe is at least 21 years of age or who the person knows is at least 21 years of age. Proof that the
8945 person demanded, was shown, and reasonably relied upon a photo identification stating that the
8946 individual was at least 21 years of age shall be a defense to any action brought under this subsection. In
8947 determining whether a person had reason to believe an individual is at least 21 years of age, the trier of
8948 fact may consider, but is not limited to, proof of the general appearance, facial characteristics, behavior,
8949 and manner of the individual.

8950 This subsection shall not apply to mail order or Internet sales, provided that the person offering the
8951 tobacco product, nicotine vapor product, alternative nicotine product, or hemp product intended for
8952 smoking for sale through mail order or the Internet (i) prior to the sale of the tobacco product, nicotine
8953 vapor product, alternative nicotine product, or hemp product intended for smoking verifies that the
8954 purchaser is at least 21 years of age through a commercially available database that is regularly used by
8955 businesses or governmental entities for the purpose of age and identity verification and (ii) uses a
8956 method of mailing, shipping, or delivery that requires the signature of a person at least 21 years of age
8957 before the tobacco product, nicotine vapor product, alternative nicotine product, or hemp product
8958 intended for smoking will be released to the purchaser.

8959 D. The provisions of subsections B and C shall not apply to the sale, giving, or furnishing of any
8960 tobacco product, nicotine vapor product, alternative nicotine product, or hemp product intended for
8961 smoking to any active duty military personnel who are 18 years of age or older. An identification card
8962 issued by the Armed Forces of the United States shall be accepted as proof of age for this purpose.

8963 E. A violation of subsection A or C by an individual or by a separate retail establishment that
8964 involves a nicotine vapor product, alternative nicotine product, hemp product intended for smoking, or
8965 tobacco product other than a bidi is punishable by a civil penalty not to exceed \$100 for a first
8966 violation, a civil penalty not to exceed \$200 for a second violation, and a civil penalty not to exceed
8967 \$500 for a third or subsequent violation.

8968 A violation of subsection A or C by an individual or by a separate retail establishment that involves
8969 the sale, distribution, or purchase of a bidi is punishable by a civil penalty in the amount of \$500 for a
8970 first violation, a civil penalty in the amount of \$1,000 for a second violation, and a civil penalty in the
8971 amount of \$2,500 for a third or subsequent violation. Where a defendant retail establishment offers
8972 proof that it has trained its employees concerning the requirements of this section, the court shall
8973 suspend all of the penalties imposed hereunder. However, where the court finds that a retail
8974 establishment has failed to so train its employees, the court may impose a civil penalty not to exceed
8975 \$1,000 in lieu of any penalties imposed hereunder for a violation of subsection A or C involving a
8976 nicotine vapor product, alternative nicotine product, hemp product intended for smoking, or tobacco
8977 product other than a bidi.

A violation of subsection B is punishable by a civil penalty not to exceed \$100 for a first violation and a civil penalty not to exceed \$250 for a second or subsequent violation. A court may, as an alternative to the civil penalty, and upon motion of the defendant, prescribe the performance of up to 20 hours of community service for a first violation of subsection B and up to 40 hours of community service for a second or subsequent violation. If the defendant fails or refuses to complete the community service as prescribed, the court may impose the civil penalty. Upon a violation of subsection B, the judge may enter an order pursuant to subdivision A 9 of § 16.1-278.8.

Any attorney for the Commonwealth of the county or city in which an alleged violation occurred may bring an action to recover the civil penalty, which shall be paid into the state treasury. Any law-enforcement officer may issue a summons for a violation of subsection A, B, or C.

F. 1. Cigarettes and hemp products intended for smoking shall be sold only in sealed packages provided by the manufacturer, with the required health warning. The proprietor of every retail establishment that offers for sale any tobacco product, nicotine vapor product, alternative nicotine product, or hemp product intended for smoking shall post in a conspicuous manner and place a sign or signs indicating that the sale of tobacco products, nicotine vapor products, alternative nicotine products, or hemp products intended for smoking to any person ~~under~~ *younger than* 21 years of age is prohibited by law. Any attorney for the county, city, or town in which an alleged violation of this subsection occurred may enforce this subsection by civil action to recover a civil penalty not to exceed \$50. The civil penalty shall be paid into the local treasury. No filing fee or other fee or cost shall be charged to the county, city, or town which instituted the action.

2. For the purpose of compliance with regulations of the Substance Abuse and Mental Health Services Administration published at 61 Federal Register 1492, the Department of Agriculture and Consumer Services may promulgate regulations which allow the Department to undertake the activities necessary to comply with such regulations.

3. Any attorney for the county, city, or town in which an alleged violation of this subsection occurred may enforce this subsection by civil action to recover a civil penalty not to exceed \$100. The civil penalty shall be paid into the local treasury. No filing fee or other fee or cost shall be charged to the county, city, or town which instituted the action.

G. Nothing in this section shall be construed to create a private cause of action.

H. Agents of the Virginia Alcoholic Beverage Control Authority designated pursuant to § 4.1-105 may issue a summons for any violation of this section.

I. As used in this section:

"Alternative nicotine product" means any noncombustible product containing nicotine that is intended for human consumption, whether chewed, absorbed, dissolved, or ingested by any other means. "Alternative nicotine product" does not include any nicotine vapor product, tobacco product, or product regulated as a drug or device by the U.S. Food and Drug Administration (FDA) under Chapter V (21 U.S.C. § 351 et seq.) of the Federal Food, Drug, and Cosmetic Act.

"Bidi" means a product containing tobacco that is wrapped in temburni leaf (*diospyros melanoxylon*) or tendu leaf (*diospyros exculpra*), or any other product that is offered to, or purchased by, consumers as a bidi or beedie.

"Hemp product *intended for smoking*" means the same as that term is defined in § 3.2-4112 4.1-600.

"Nicotine vapor product" means any noncombustible product containing nicotine that employs a heating element, power source, electronic circuit, or other electronic, chemical, or mechanical means, regardless of shape or size, that can be used to produce vapor from nicotine in a solution or other form. "Nicotine vapor product" includes any electronic cigarette, electronic cigar, electronic cigarillo, electronic pipe, or similar product or device and any cartridge or other container of nicotine in a solution or other form that is intended to be used with or in an electronic cigarette, electronic cigar, electronic cigarillo, electronic pipe, or similar product or device. "Nicotine vapor product" does not include any product regulated by the FDA under Chapter V (21 U.S.C. § 351 et seq.) of the Federal Food, Drug, and Cosmetic Act.

"Tobacco product" means any product made of tobacco and includes cigarettes, cigars, smokeless tobacco, pipe tobacco, bidis, and wrappings. "Tobacco product" does not include any nicotine vapor product, alternative nicotine product, or product that is regulated by the FDA under Chapter V (21 U.S.C. § 351 et seq.) of the Federal Food, Drug, and Cosmetic Act.

"Wrappings" includes papers made or sold for covering or rolling tobacco or other materials for smoking in a manner similar to a cigarette or cigar.

§ 18.2-460. Obstructing justice; resisting arrest; fleeing from a law-enforcement officer; penalties.

A. If any person without just cause knowingly obstructs a judge, magistrate, justice, juror, attorney for the Commonwealth, witness, ~~any~~ law-enforcement officer, or animal control officer employed pursuant to § 3.2-6555 in the performance of his duties as such or fails or refuses without just cause to

9039 cease such obstruction when requested to do so by such judge, magistrate, justice, juror, attorney for the
9040 Commonwealth, witness, law-enforcement officer, or animal control officer employed pursuant to
9041 § 3.2-6555, he is guilty of a Class 1 misdemeanor.

9042 B. Except as provided in subsection C, any person who, by threats or force, knowingly attempts to
9043 intimidate or impede a judge, magistrate, justice, juror, attorney for the Commonwealth, witness, ~~any~~
9044 law-enforcement officer, or ~~an~~ animal control officer employed pursuant to § 3.2-6555 lawfully engaged
9045 in his duties as such, or to obstruct or impede the administration of justice in any court, is guilty of a
9046 Class 1 misdemeanor.

9047 C. If any person by threats of bodily harm or force knowingly attempts to intimidate or impede a
9048 judge, magistrate, justice, juror, attorney for the Commonwealth, witness, ~~any~~ or law-enforcement
9049 officer, lawfully engaged in the discharge of his duty, or to obstruct or impede the administration of
9050 justice in any court relating to a violation of or conspiracy to violate § 18.2-248 or subdivision (a)(3),
9051 (b) or (c) of § 18.2-248.1, or § 18.2-46.2, or § 18.2-46.3, or relating to the violation of or conspiracy to
9052 violate any violent felony offense listed in subsection C of § 17.1-805, he is guilty of a Class 5 felony.

9053 D. Any person who knowingly and willfully makes any materially false statement or representation
9054 to a law-enforcement officer or an animal control officer employed pursuant to § 3.2-6555 who is in the
9055 course of conducting an investigation of a crime by another is guilty of a Class 1 misdemeanor.

9056 E. Any person who intentionally prevents or attempts to prevent a law-enforcement officer from
9057 lawfully arresting him, with or without a warrant, is guilty of a Class 1 misdemeanor. For purposes of
9058 this subsection, intentionally preventing or attempting to prevent a lawful arrest means fleeing from a
9059 law-enforcement officer when (i) the officer applies physical force to the person; or (ii) the officer
9060 communicates to the person that he is under arrest and (a) the officer has the legal authority and the
9061 immediate physical ability to place the person under arrest; and (b) a reasonable person who receives
9062 such communication knows or should know that he is not free to leave.

9063 **§ 18.2-474.1. Delivery of drugs, firearms, explosives, etc., to prisoners or committed persons.**

9064 Notwithstanding the provisions of § 18.2-474, any person who shall willfully in any manner deliver,
9065 attempt to deliver, or conspire with another to deliver to any prisoner confined under authority of the
9066 Commonwealth of Virginia, or of any political subdivision thereof, or to any person committed to the
9067 Department of Juvenile Justice in any juvenile correctional center, any drug ~~which~~ *that* is a controlled
9068 substance regulated by the Drug Control Act in Chapter 34 (§ 54.1-3400 et seq.) of Title 54.1 or
9069 ~~marijuana~~ is guilty of a Class 5 felony. Any person who shall willfully in any manner so deliver or
9070 attempt to deliver or conspire to deliver to any such prisoner or confined or committed person; firearms,
9071 ~~ammunitions~~ *ammunition*, or explosives of any nature is guilty of a Class 3 felony.

9072 Nothing herein contained shall be construed to repeal or amend § 18.2-473.

9073 **§ 19.2-66. When Attorney General or Chief Deputy Attorney General may apply for order**
9074 **authorizing interception of communications.**

9075 A. The Attorney General or Chief Deputy Attorney General, if the Attorney General so designates in
9076 writing, in any case where the Attorney General is authorized by law to prosecute or pursuant to a
9077 request in his official capacity of an attorney for the Commonwealth in any city or county, may apply to
9078 a judge of competent jurisdiction for an order authorizing the interception of wire, electronic or oral
9079 communications by the Department of State Police, when such interception may reasonably be expected
9080 to provide evidence of the commission of a felonious offense of extortion, bribery, kidnapping, murder,
9081 any felony violation of § 18.2-248 or ~~18.2-248.1~~, any felony violation of Chapter 29 (§ 59.1-364 et seq.)
9082 of Title 59.1, any felony violation of Article 2 (§ 18.2-38 et seq.), Article 2.1 (§ 18.2-46.1 et seq.),
9083 Article 2.2 (§ 18.2-46.4 et seq.), Article 5 (§ 18.2-58 et seq.), Article 6 (§ 18.2-59 et seq.) or any
9084 felonies that are not Class 6 felonies in Article 7 (§ 18.2-61 et seq.) of Chapter 4 of Title 18.2, or any
9085 conspiracy to commit any of the foregoing offenses. The Attorney General or Chief Deputy Attorney
9086 General may apply for authorization for the observation or monitoring of the interception by a police
9087 department of a county or city, by a sheriff's office, or by law-enforcement officers of the United States.
9088 Such application shall be made, and such order may be granted, in conformity with the provisions of
9089 § 19.2-68.

9090 B. The application for an order under subsection B of § 19.2-68 shall be made as follows:

9091 1. In the case of an application for a wire or electronic interception, a judge of competent jurisdiction
9092 shall have the authority to issue an order under subsection B of § 19.2-68 if there is probable cause to
9093 believe that an offense was committed, is being committed, or will be committed or the person or
9094 persons whose communications are to be intercepted live, work, subscribe to a wire or electronic
9095 communication system, maintain an address or a post office box, or are making the communication
9096 within the territorial jurisdiction of the court.

9097 2. In the case of an application for an oral intercept, a judge of competent jurisdiction shall have the
9098 authority to issue an order under subsection B of § 19.2-68 if there is probable cause to believe that an
9099 offense was committed, is being committed, or will be committed or the physical location of the oral
9100 communication to be intercepted is within the territorial jurisdiction of the court.

C. For the purposes of an order entered pursuant to subsection B of § 19.2-68 for the interception of a wire or electronic communication, such communication shall be deemed to be intercepted in the jurisdiction where the order is entered, regardless of the physical location or the method by which the communication is captured or routed to the monitoring location.

§ 19.2-81. Arrest without warrant authorized in certain cases.

A. The following officers shall have the powers of arrest as provided in this section:

1. Members of the State Police force of the Commonwealth;
2. Sheriffs of the various counties and cities, and their deputies;
3. Members of any county police force or any duly constituted police force of any city or town of the Commonwealth;
4. The Commissioner, members, and employees of the Marine Resources Commission granted the power of arrest pursuant to § 28.2-900;
5. Regular conservation police officers appointed pursuant to § 29.1-200;
6. United States Coast Guard and United States Coast Guard Reserve commissioned, warrant, and petty officers authorized under § 29.1-205 to make arrests;
7. Conservation officers appointed pursuant to § 10.1-115;
8. Full-time sworn members of the enforcement division of the Department of Motor Vehicles appointed pursuant to § 46.2-217;
9. Special agents of the Virginia Alcoholic Beverage Control Authority *or the Virginia Cannabis Control Authority*;
10. Campus police officers appointed under Article 3 (§ 23.1-809 et seq.) of Chapter 8 of Title 23.1; and
11. Members of the Division of Capitol Police.

B. Such officers may arrest without a warrant any person who commits any crime in the presence of the officer and any person whom he has reasonable grounds or probable cause to suspect of having committed a felony not in his presence.

Such officers may arrest without a warrant any person whom the officer has probable cause to suspect of operating any watercraft or motorboat while (i) intoxicated in violation of subsection B of § 29.1-738 or a substantially similar ordinance of any county, city, or town in the Commonwealth or (ii) in violation of an order issued pursuant to § 29.1-738.4 and may thereafter transfer custody of the person arrested to another officer, who may obtain a warrant based upon statements made to him by the arresting officer.

C. Any such officer may, at the scene of any accident involving a motor vehicle, watercraft as defined in § 29.1-733.2 or motorboat, or at any hospital or medical facility to which any person involved in such accident has been transported, or in the apprehension of any person charged with the theft of any motor vehicle, on any of the highways or waters of the Commonwealth, upon reasonable grounds to believe, based upon personal investigation, including information obtained from eyewitnesses, that a crime has been committed by any person then and there present, apprehend such person without a warrant of arrest. For purposes of this section, "the scene of any accident" shall include a reasonable location where a vehicle or person involved in an accident has been moved at the direction of a law-enforcement officer to facilitate the clearing of the highway or to ensure the safety of the motoring public.

D. Such officers may, within three hours of the alleged offense, arrest without a warrant at any location any person whom the officer has probable cause to suspect of driving or operating a motor vehicle, watercraft or motorboat while intoxicated in violation of § 18.2-266, 18.2-266.1, *or* 46.2-341.24; or subsection B of § 29.1-738; or a substantially similar ordinance of any county, city, or town in the Commonwealth, whether or not the offense was committed in such officer's presence. Such officers may, within three hours of the alleged offense, arrest without a warrant at any location any person whom the officer has probable cause to suspect of operating a watercraft or motorboat in violation of an order issued pursuant to § 29.1-738.4, whether or not the offense was committed in such officer's presence.

E. Such officers may arrest, without a warrant or a *capias*, persons duly charged with a crime in another jurisdiction upon receipt of a photocopy of a warrant or a *capias*, telegram, computer printout, facsimile printout, a radio, telephone or teletype message, in which photocopy of a warrant, telegram, computer printout, facsimile printout, radio, telephone or teletype message shall be given the name or a reasonably accurate description of such person wanted and the crime alleged.

F. Such officers may arrest, without a warrant or a *capias*, for an alleged misdemeanor not committed in his presence when the officer receives a radio message from his department or other law-enforcement agency within the Commonwealth that a warrant or *capias* for such offense is on file.

G. Such officers may also arrest without a warrant for an alleged misdemeanor not committed in their presence involving (i) shoplifting in violation of § 18.2-96 or 18.2-103 or a similar local ordinance, (ii) carrying a weapon on school property in violation of § 18.2-308.1, (iii) assault and battery, (iv)

brandishing a firearm in violation of § 18.2-282, or (v) destruction of property in violation of § 18.2-137, when such property is located on premises used for business or commercial purposes, or a similar local ordinance, when any such arrest is based on probable cause upon reasonable complaint of the person who observed the alleged offense. The arresting officer may issue a summons to any person arrested under this section for a misdemeanor violation involving shoplifting.

§ 19.2-81.1. Arrest without warrant by correctional officers in certain cases.

Any correctional officer, as defined in § 53.1-1, may arrest, in the same manner as provided in § 19.2-81, persons for crimes involving:

- (a) 1. The escape of an inmate from a correctional institution, as defined in § 53.1-1;
- (b) 2. Assisting an inmate to escape from a correctional institution, as defined in § 53.1-1;
- (c) 3. The delivery of contraband to an inmate in violation of § 4.1-1117, 18.2-474, or § 18.2-474.1; and
- (d) 4. Any other criminal offense which that may contribute to the disruption of the safety, welfare, or security of the population of a correctional institution.

§ 19.2-83.1. Report of arrest of school employees and adult students for certain offenses.

A. Every state official or agency and every sheriff, police officer, or other local law-enforcement officer or conservator of the peace having the power to arrest for a felony, upon arresting a person who is known or discovered by the arresting official to be a full-time, part-time, permanent, or temporary teacher or other employee in any public school division in this Commonwealth for a felony or a Class 1 misdemeanor or an equivalent offense in another state shall file a report of such arrest with the division superintendent of the employing division as soon as practicable. The contents of the report required pursuant to this section shall be utilized by the local school division solely to implement the provisions of subsection B of § 22.1-296.2 and § 22.1-315.

B. Every state official or agency and every sheriff, police officer, or other local law-enforcement officer or conservator of the peace having the power to arrest for a felony, shall file a report, as soon as practicable, with the division superintendent of the school division in which the student is enrolled upon arresting a person who is known or discovered by the arresting official to be a student age 18 or older in any public school division in this Commonwealth for:

- 1. A firearm offense pursuant to Article 4 (§ 18.2-279 et seq.), 5 (§ 18.2-288 et seq.), 6 (§ 18.2-299 et seq.), 6.1 (§ 18.2-307.1 et seq.), or 7 (§ 18.2-308.1 et seq.) of Chapter 7 of Title 18.2;
- 2. Homicide, pursuant to Article 1 (§ 18.2-30 et seq.) of Chapter 4 of Title 18.2;
- 3. Felonious assault and bodily wounding, pursuant to Article 4 (§ 18.2-51 et seq.) of Chapter 4 of Title 18.2;
- 4. Criminal sexual assault, pursuant to Article 7 (§ 18.2-61 et seq.) of Chapter 4 of Title 18.2;
- 5. Manufacture, sale, gift, distribution or possession of Schedule I or II controlled substances, pursuant to Article 1 (§ 18.2-247 et seq.) of Chapter 7 of Title 18.2;
- 6. Manufacture, sale or distribution of marijuana pursuant to Article 4 Chapter 11 (§ 18.2-247 4.1-1100 et seq.) of Chapter 7 of Title 18.2 4.1;
- 7. Arson and related crimes, pursuant to Article 1 (§ 18.2-77 et seq.) of Chapter 5 of Title 18.2;
- 8. Burglary and related offenses, pursuant to §§ 18.2-89 through 18.2-93;
- 9. Robbery pursuant to § 18.2-58;
- 10. Prohibited criminal street gang activity pursuant to § 18.2-46.2;
- 11. Recruitment of juveniles for criminal street gang pursuant to § 18.2-46.3;
- 12. An act of violence by a mob pursuant to § 18.2-42.1; or
- 13. Abduction of any person pursuant to § 18.2-47 or 18.2-48.

§ 19.2-188.1. Testimony regarding identification of controlled substances.

A. In any preliminary hearing on a violation of Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1, Article 1 (§ 18.2-247 et seq.) of Chapter 7 of Title 18.2, or subdivision 6 of § 53.1-203, any law-enforcement officer shall be permitted to testify as to the results of field tests that have been approved by the Department of Forensic Science pursuant to regulations adopted in accordance with the Administrative Process Act (§ 2.2-4000 et seq.), regarding whether or not any substance the identity of which is at issue in such hearing is a controlled substance, imitation controlled substance, or marijuana, as defined in § § 4.1-600 and 18.2-247.

B. In any trial for a violation of § 4.1-1105.1, any law-enforcement officer shall be permitted to testify as to the results of any marijuana field test approved as accurate and reliable by the Department of Forensic Science pursuant to regulations adopted in accordance with the Administrative Process Act (§ 2.2-4000 et seq.), regarding whether or not any plant material, the identity of which is at issue, is marijuana provided the defendant has been given written notice of his right to request a full chemical analysis. Such notice shall be on a form approved by the Supreme Court and shall be provided to the defendant prior to trial.

In any case in which the person accused of a violation of § 4.1-1105.1, or the attorney of record for the accused, desires a full chemical analysis of the alleged plant material, he may, by motion prior to

trial before the court in which the charge is pending, request such a chemical analysis. Upon such motion, the court shall order that the analysis be performed by the Department of Forensic Science in accordance with the provisions of § 18.2-247 and shall prescribe in its order the method of custody, transfer, and return of evidence submitted for chemical analysis.

§ 19.2-303.01. Reduction of sentence; substantial assistance to prosecution.

Notwithstanding any other provision of law or rule of court, upon motion of the attorney for the Commonwealth, the sentencing court may reduce the defendant's sentence if the defendant, after entry of the final judgment order, provided substantial assistance in investigating or prosecuting another person for (i) an act of violence as defined in § 19.2-297.1, an act of larceny of a firearm in violation of § 18.2-95, or any violation of § 18.2-248, 18.2-248.01, 18.2-248.02, 18.2-248.03, ~~18.2-248.1~~, 18.2-248.5, 18.2-251.2, 18.2-251.3, 18.2-255, 18.2-255.2, 18.2-258, 18.2-258.02, 18.2-258.1, or 18.2-258.2, or any substantially similar offense in any other jurisdiction, which offense would be a felony if committed in the Commonwealth; (ii) a conspiracy to commit any of the offenses listed in clause (i); or (iii) violations as a principal in the second degree or accessory before the fact of any of the offenses listed in clause (i). In determining whether the defendant has provided substantial assistance pursuant to the provisions of this section, the court shall consider (a) the court's evaluation of the significance and usefulness of the defendant's assistance, taking into consideration the Commonwealth's evaluation of the assistance rendered; (b) the truthfulness, completeness, and reliability of any information or testimony provided by the defendant; (c) the nature and extent of the defendant's assistance; (d) any injury suffered or any danger or risk of injury to the defendant or his family resulting from his assistance; and (e) the timeliness of the defendant's assistance. If the motion is made more than one year after entry of the final judgment order, the court may reduce a sentence only if the defendant's substantial assistance involved (1) information not known to the defendant until more than one year after entry of the final judgment order, (2) information provided by the defendant within one year of entry of the final judgment order but that did not become useful to the Commonwealth until more than one year after entry of the final judgment order, or (3) information the usefulness of which could not reasonably have been anticipated by the defendant until more than one year after entry of the final judgment order and which was promptly provided to the Commonwealth by the defendant after its usefulness was reasonably apparent.

§ 19.2-303.03. Modification of sentence for marijuana-related convictions.

A. Notwithstanding other provisions of law or rule of court, if a person who (i) was convicted of a felony offense in violation of § 18.2-248, 18.2-248.01, 18.2-248.1, 18.2-250, 18.2-255, 18.2-255.2, 18.2-256, 18.2-257, 18.2-258, 18.2-258.1, 18.2-258.02, 18.2-265.3, or 18.2-474.1 as it relates to marijuana committed prior to July 1, 2021; (ii) was sentenced to jail or to the Department of Corrections or placed on community supervision as defined in § 53.1-1 for such conviction; and (iii) remains incarcerated in a state or local correctional facility or secure facility, as defined in § 16.1-228, serving the sentence for such conviction or a combination of such convictions or remains on community supervision as defined in § 53.1-1 for such conviction or a combination of such convictions on July 1, 2022, the circuit court that entered the original judgment or order shall schedule a hearing by July 1, 2023, to consider modification of such person's sentence. The Commonwealth shall be made party to the proceeding and receive notice of such hearing.

B. Notwithstanding other provisions of law or rule of court, a person who remains incarcerated in the custody of Department of Corrections on July 1, 2022, for a felony conviction and who is not serving a sentence for a conviction of an act of violence as defined in § 19.2-297.1 and who may have had such felony conviction sentence enhanced because of a prior felony conviction under § 18.2-248, 18.2-248.01, 18.2-248.1, 18.2-250, 18.2-255, 18.2-255.2, 18.2-256, 18.2-257, 18.2-258, 18.2-258.02, 18.2-258.1, 18.2-265.3, or 18.2-474.1 as it relates to marijuana shall be eligible for parole pursuant to §§ 53.1-151, 53.1-152, and 53.1-165.1.

C. Any person eligible for modification of a sentence under subsection A may file a petition for the assistance of counsel and a statement of indigency with the court on a form provided by the Supreme Court of Virginia. The court may summarily dismiss the petition if the person is not eligible for modification of a sentence based on the criteria set forth in subsection A. If the petition is not summarily dismissed and the court finds that the person is entitled to representation by counsel subject to the provisions of Article 3 (§ 19.2-157 et seq.) of Chapter 10, the court shall appoint counsel to represent the petitioner. If a person was found to be indigent at his original sentencing, he shall be entitled to assistance of counsel for the hearing on modification of his sentence without the filing of such petition. No fee shall be charged for filing a petition under this subsection. An attorney appointed to represent a person pursuant to this subsection shall be compensated at the same rate as an attorney providing representation on a felony case pursuant to § 19.2-163.

D. Upon a hearing for modification of a sentence pursuant to subsection A, the court shall consider that marijuana has been legalized and shall reduce, including a reduction to time served, or otherwise modify the person's sentence, including removing such person from community supervision, unless the

9285 *Commonwealth demonstrates it would not be compatible with the public interest to do so. Any*
9286 *modification of sentence shall not exceed the original term imposed by the court.*

9287 *E. Notwithstanding any other provision of law, the court may modify a sentence pursuant to this*
9288 *section regardless of whether any mandatory minimum term of confinement or other minimum term of*
9289 *incarceration is required by law.*

9290 *F. The circuit court shall make a decision as to whether to modify a sentence within 60 days*
9291 *following the sentence modification hearing. If modification of a sentence is denied, the court shall file*
9292 *with the record of the case a written explanation for the denial and shall provide a copy of such written*
9293 *explanation to the person whose sentence was considered for modification, his attorney if he is*
9294 *represented, and to the attorney for the Commonwealth.*

9295 *G. Following the entry of an order to modify a sentence pursuant to this section, the clerk of the*
9296 *circuit court shall cause a copy of such order to be forwarded to the Virginia Criminal Sentencing*
9297 *Commission, the Department of State Police, and the state correctional facility where the individual is*
9298 *incarcerated within 10 days.*

9299 *H. The decision of a circuit court to modify a sentence pursuant to this section shall not form the*
9300 *basis for any relief in any habeas corpus or appellate proceeding, unless such decision was contrary to*
9301 *law.*

9302 **§ 19.2-386.22. Seizure of property used in connection with or derived from illegal drug**
9303 **transactions.**

9304 *A. The following property shall be subject to lawful seizure by any officer charged with enforcing*
9305 *the provisions of Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or Article 1 (§ 18.2-247 et seq.) of Chapter*
9306 *7 of Title 18.2: (i) all money, medical equipment, office equipment, laboratory equipment, motor*
9307 *vehicles, and all other personal and real property of any kind or character, used in substantial connection*
9308 *with (a) the illegal manufacture, sale or distribution of controlled substances or possession with intent to*
9309 *sell or distribute controlled substances in violation of § 18.2-248, (b) the sale or distribution of*
9310 *marijuana or possession with intent to distribute marijuana in violation of subdivisions (a)(2), (a)(3) and*
9311 *(e) of § 18.2-248.1 § 4.1-1103, or (c) a drug-related offense in violation of § 4.1-1117 or 18.2-474.1; (ii)*
9312 *everything of value furnished, or intended to be furnished, in exchange for a controlled substance in*
9313 *violation of § 18.2-248 or for marijuana in violation of § 18.2-248.1 4.1-1103 or for a controlled*
9314 *substance or marijuana in violation of § 4.1-1117 or 18.2-474.1; and (iii) all moneys or other property,*
9315 *real or personal, traceable to such an exchange, together with any interest or profits derived from the*
9316 *investment of such money or other property. Under the provisions of clause (i), real property shall not*
9317 *be subject to lawful seizure unless the minimum prescribed punishment for the violation is a term of not*
9318 *less than five years.*

9319 *B. All seizures and forfeitures under this section shall be governed by the procedures contained in*
9320 *Chapter 22.1 (§ 19.2-386.1 et seq.).*

9321 **§ 19.2-386.23. Disposal of seized controlled substances, marijuana, and paraphernalia.**

9322 *A. All controlled substances, imitation controlled substances, marijuana, or paraphernalia, the lawful*
9323 *possession of which is not established or the title to which cannot be ascertained, which have come into*
9324 *the custody of a peace officer or have been seized in connection with violations of Chapter 11*
9325 *(§ 4.1-1100 et seq.) of Title 4.1 or Chapter 7 (§ 18.2-247 et seq.) of Title 18.2, shall be forfeited and*
9326 *disposed of as follows:*

9327 *1. Upon written application by (i) the Department of Forensic Science, (ii) the Department of State*
9328 *Police, or (iii) any police department or sheriff's office in a locality, the court may order the forfeiture*
9329 *of any such substance or paraphernalia to the Department of Forensic Science, the Department of State*
9330 *Police, or to such police department or sheriff's office for research and training purposes and for*
9331 *destruction pursuant to regulations of the United States Department of Justice Drug Enforcement*
9332 *Administration and of the Board of Pharmacy once these purposes have been fulfilled.*

9333 *2. In the event no application is made under subdivision 1, the court shall order the destruction of all*
9334 *such substances or paraphernalia, which order shall state the existence and nature of the substance or*
9335 *paraphernalia, the quantity thereof, the location where seized, the person or persons from whom the*
9336 *substance or paraphernalia was seized, if known, and the manner whereby such item shall be destroyed.*
9337 *However, the court may order that paraphernalia identified in subdivision 5 of § 18.2-265.1 not be*
9338 *destroyed and that it be given to a person or entity that makes a showing to the court of sufficient need*
9339 *for the property and an ability to put the property to a lawful and publicly beneficial use. A return under*
9340 *oath, reporting the time, place and manner of destruction shall be made to the court by the officer to*
9341 *whom the order is directed. A copy of the order and affidavit shall be made a part of the record of any*
9342 *criminal prosecution in which the substance or paraphernalia was used as evidence and shall, thereafter,*
9343 *be prima facie evidence of its contents. In the event a law-enforcement agency recovers, seizes, finds, is*
9344 *given or otherwise comes into possession of any such substances or paraphernalia that are not evidence*
9345 *in a trial in the Commonwealth, the chief law-enforcement officer of the agency or his designee may,*
9346 *with the written consent of the appropriate attorney for the Commonwealth, order destruction of same;*

provided that a statement under oath, reporting a description of the substances and paraphernalia destroyed and the time, place and manner of destruction, is made to the chief law-enforcement officer by the officer to whom the order is directed.

B. No such substance or paraphernalia used or to be used in a criminal prosecution under *Chapter 11* (§ 4.1-1100 et seq.) of Title 4.1 or Chapter 7 (§ 18.2-247 et seq.) of Title 18.2 shall be disposed of as provided by this section until all rights of appeal have been exhausted, except as provided in § 19.2-386.24.

C. The amount of any specific controlled substance, or imitation controlled substance, retained by any law-enforcement agency pursuant to a court order issued under this section shall not exceed five pounds, or 25 pounds in the case of marijuana. Any written application to the court for controlled substances, imitation controlled substances, or marijuana, shall certify that the amount requested shall not result in the requesting agency's exceeding the limits allowed by this subsection.

D. A law-enforcement agency that retains any controlled substance, imitation controlled substance, or marijuana, pursuant to a court order issued under this section shall (i) be required to conduct an inventory of such substance on a monthly basis, which shall include a description and weight of the substance, and (ii) destroy such substance pursuant to subdivision A 1 when no longer needed for research and training purposes. A written report outlining the details of the inventory shall be made to the chief law-enforcement officer of the agency within 10 days of the completion of the inventory, and the agency shall detail the substances that were used for research and training pursuant to a court order in the immediately preceding fiscal year. Destruction of such substance shall be certified to the court along with a statement prepared under oath, reporting a description of the substance destroyed, and the time, place, and manner of destruction.

§ 19.2-386.24. Destruction of seized controlled substances or marijuana prior to trial.

Where seizures of controlled substances or marijuana are made in excess of 10 pounds in connection with any prosecution or investigation under *Chapter 11* (§ 4.1-1100 et seq.) of Title 4.1 or Chapter 7 (§ 18.2-247 et seq.) of Title 18.2, the appropriate law-enforcement agency may retain 10 pounds of the substance randomly selected from the seized substance for representative purposes as evidence and destroy the remainder of the seized substance.

Before any destruction is carried out under this section, the law-enforcement agency shall cause the material seized to be photographed with identification case numbers or other means of identification and shall prepare a report identifying the seized material. It shall also notify the accused, or other interested party, if known, or his attorney, at least five days in advance that the photography will take place and that they may be present. Prior to any destruction under this section, the law-enforcement agency shall also notify the accused or other interested party, if known, and his attorney at least seven days prior to the destruction of the time and place the destruction will occur. Any notice required under the provisions of this section shall be by first-class mail to the last known address of the person required to be notified. In addition to the substance retained for representative purposes as evidence, all photographs and records made under this section and properly identified shall be admissible in any court proceeding for any purposes for which the seized substance itself would have been admissible.

§ 19.2-386.25. Judge may order law-enforcement agency to maintain custody of controlled substances, etc.

Upon request of the clerk of any court, a judge of the court may order a law-enforcement agency to take into its custody or to maintain custody of substantial quantities of any controlled substances, imitation controlled substances, chemicals, marijuana, or paraphernalia used or to be used in a criminal prosecution under *Chapter 11* (§ 4.1-1100 et seq.) of Title 4.1 or Chapter 7 (§ 18.2-247 et seq.) of Title 18.2. The court in its order may make provision for ensuring integrity of these items until further order of the court.

§ 19.2-389. Dissemination of criminal history record information.

A. Criminal history record information shall be disseminated, whether directly or through an intermediary, only to:

1. Authorized officers or employees of criminal justice agencies, as defined by § 9.1-101, for purposes of the administration of criminal justice and the screening of an employment application or review of employment by a criminal justice agency with respect to its own employees or applicants, and dissemination to the Virginia Parole Board, pursuant to this subdivision, of such information on all state-responsible inmates for the purpose of making parole determinations pursuant to subdivisions 1, 2, 4, and 6 of § 53.1-136 shall include collective dissemination by electronic means every 30 days. For purposes of this subdivision, criminal history record information includes information sent to the Central Criminal Records Exchange pursuant to §§ 37.2-819 and 64.2-2014 when disseminated to any full-time or part-time employee of the State Police, a police department or sheriff's office that is a part of or administered by the Commonwealth or any political subdivision thereof, and who is responsible for the prevention and detection of crime and the enforcement of the penal, traffic or highway laws of the

9408 Commonwealth for the purposes of the administration of criminal justice;

9409 2. Such other individuals and agencies that require criminal history record information to implement
9410 a state or federal statute or executive order of the President of the United States or Governor that
9411 expressly refers to criminal conduct and contains requirements or exclusions expressly based upon such
9412 conduct, except that information concerning the arrest of an individual may not be disseminated to a
9413 noncriminal justice agency or individual if an interval of one year has elapsed from the date of the
9414 arrest and no disposition of the charge has been recorded and no active prosecution of the charge is
9415 pending;

9416 3. Individuals and agencies pursuant to a specific agreement with a criminal justice agency to provide
9417 services required for the administration of criminal justice pursuant to that agreement which shall
9418 specifically authorize access to data, limit the use of data to purposes for which given, and ensure the
9419 security and confidentiality of the data;

9420 4. Individuals and agencies for the express purpose of research, evaluative, or statistical activities
9421 pursuant to an agreement with a criminal justice agency that shall specifically authorize access to data,
9422 limit the use of data to research, evaluative, or statistical purposes, and ensure the confidentiality and
9423 security of the data;

9424 5. Agencies of state or federal government that are authorized by state or federal statute or executive
9425 order of the President of the United States or Governor to conduct investigations determining
9426 employment suitability or eligibility for security clearances allowing access to classified information;

9427 6. Individuals and agencies where authorized by court order or court rule;

9428 7. Agencies of any political subdivision of the Commonwealth, public transportation companies
9429 owned, operated or controlled by any political subdivision, and any public service corporation that
9430 operates a public transit system owned by a local government for the conduct of investigations of
9431 applicants for employment, permit, or license whenever, in the interest of public welfare or safety, it is
9432 necessary to determine under a duly enacted ordinance if the past criminal conduct of a person with a
9433 conviction record would be compatible with the nature of the employment, permit, or license under
9434 consideration;

9435 7a. Commissions created pursuant to the Transportation District Act of 1964 (§ 33.2-1900 et seq.) of
9436 Title 33.2 and their contractors, for the conduct of investigations of individuals who have been offered a
9437 position of employment whenever, in the interest of public welfare or safety and as authorized in the
9438 Transportation District Act of 1964, it is necessary to determine if the past criminal conduct of a person
9439 with a conviction record would be compatible with the nature of the employment under consideration;

9440 8. Public or private agencies when authorized or required by federal or state law or interstate
9441 compact to investigate (i) applicants for foster or adoptive parenthood or (ii) any individual, and the
9442 adult members of that individual's household, with whom the agency is considering placing a child or
9443 from whom the agency is considering removing a child due to abuse or neglect, on an emergency,
9444 temporary, or permanent basis pursuant to §§ 63.2-901.1 and 63.2-1505, subject to the restriction that
9445 the data shall not be further disseminated to any party other than a federal or state authority or court as
9446 may be required to comply with an express requirement of law;

9447 9. To the extent permitted by federal law or regulation, public service companies as defined in
9448 § 56-1, for the conduct of investigations of applicants for employment when such employment involves
9449 personal contact with the public or when past criminal conduct of an applicant would be incompatible
9450 with the nature of the employment under consideration;

9451 10. The appropriate authority for purposes of granting citizenship and for purposes of international
9452 travel, including, but not limited to, issuing visas and passports;

9453 11. A person requesting a copy of his own criminal history record information as defined in
9454 § 9.1-101 at his cost, except that criminal history record information shall be supplied at no charge to a
9455 person who has applied to be a volunteer with (i) a Virginia affiliate of Big Brothers/Big Sisters of
9456 America; (ii) a volunteer fire company; (iii) the Volunteer Emergency Families for Children; (iv) any
9457 affiliate of Prevent Child Abuse, Virginia; (v) any Virginia affiliate of Compeer; or (vi) any board
9458 member or any individual who has been offered membership on the board of a Crime Stoppers, Crime
9459 Solvers or Crime Line program as defined in § 15.2-1713.1;

9460 12. Administrators and board presidents of and applicants for licensure or registration as a child
9461 welfare agency as defined in § 63.2-100 for dissemination to the Commissioner of Social Services'
9462 representative pursuant to § 63.2-1702 for the conduct of investigations with respect to employees of and
9463 volunteers at such facilities, caretakers, and foster and adoptive parent applicants of private child-placing
9464 agencies, pursuant to §§ 63.2-1719, 63.2-1720, and 63.2-1721, subject to the restriction that the data
9465 shall not be further disseminated by the facility or agency to any party other than the data subject, the
9466 Commissioner of Social Services' representative or a federal or state authority or court as may be
9467 required to comply with an express requirement of law for such further dissemination; however, nothing
9468 in this subdivision shall be construed to prohibit the Commissioner of Social Services' representative
9469 from issuing written certifications regarding the results of a background check that was conducted before

July 1, 2021, in accordance with subsection J of § 22.1-289.035 or § 22.1-289.039;

13. The school boards of the Commonwealth for the purpose of screening individuals who are offered or who accept public school employment and those current school board employees for whom a report of arrest has been made pursuant to § 19.2-83.1;

14. The Virginia Lottery for the conduct of investigations as set forth in the Virginia Lottery Law (§ 58.1-4000 et seq.) and casino gaming as set forth in Chapter 41 (§ 58.1-4100 et seq.) of Title 58.1, and the Department of Agriculture and Consumer Services for the conduct of investigations as set forth in Article 1.1:1 (§ 18.2-340.15 et seq.) of Chapter 8 of Title 18.2;

15. Licensed nursing homes, hospitals and home care organizations for the conduct of investigations of applicants for compensated employment in licensed nursing homes pursuant to § 32.1-126.01, hospital pharmacies pursuant to § 32.1-126.02, and home care organizations pursuant to § 32.1-162.9:1, subject to the limitations set out in subsection E;

16. Licensed assisted living facilities and licensed adult day care centers for the conduct of investigations of applicants for compensated employment in licensed assisted living facilities and licensed adult day care centers pursuant to § 63.2-1720, subject to the limitations set out in subsection F;

17. The Virginia Alcoholic Beverage Control Authority for the conduct of investigations as set forth in § 4.1-103.1 or the Virginia Cannabis Control Authority for the conduct of investigations as set forth in § 4.1-622;

18. The State Board of Elections and authorized officers and employees thereof and general registrars appointed pursuant to § 24.2-110 in the course of conducting necessary investigations with respect to voter registration, limited to any record of felony convictions;

19. The Commissioner of Behavioral Health and Developmental Services for those individuals who are committed to the custody of the Commissioner pursuant to §§ 19.2-169.2, 19.2-169.6, 19.2-182.2, 19.2-182.3, 19.2-182.8, and 19.2-182.9 for the purpose of placement, evaluation, and treatment planning;

20. Any alcohol safety action program certified by the Commission on the Virginia Alcohol Safety Action Program for (i) interventions with first offenders under § 18.2-251 or (ii) services to offenders under § 18.2-51.4, 18.2-266, or 18.2-266.1;

21. Residential facilities for juveniles regulated or operated by the Department of Social Services, the Department of Education, or the Department of Behavioral Health and Developmental Services for the purpose of determining applicants' fitness for employment or for providing volunteer or contractual services;

22. The Department of Behavioral Health and Developmental Services and facilities operated by the Department for the purpose of determining an individual's fitness for employment pursuant to departmental instructions;

23. Pursuant to § 22.1-296.3, the governing boards or administrators of private elementary or secondary schools which are accredited pursuant to § 22.1-19 or a private organization coordinating such records information on behalf of such governing boards or administrators pursuant to a written agreement with the Department of State Police;

24. Public institutions of higher education and nonprofit private institutions of higher education for the purpose of screening individuals who are offered or accept employment;

25. Members of a threat assessment team established by a local school board pursuant to § 22.1-79.4, by a public institution of higher education pursuant to § 23.1-805, or by a private nonprofit institution of higher education, for the purpose of assessing or intervening with an individual whose behavior may present a threat to safety; however, no member of a threat assessment team shall redisclose any criminal history record information obtained pursuant to this section or otherwise use any record of an individual beyond the purpose that such disclosure was made to the threat assessment team;

26. Executive directors of community services boards or the personnel director serving the community services board for the purpose of determining an individual's fitness for employment, approval as a sponsored residential service provider, permission to enter into a shared living arrangement with a person receiving medical assistance services pursuant to a waiver, or permission for any person under contract with the community services board to serve in a direct care position on behalf of the community services board pursuant to §§ 37.2-506 and 37.2-607;

27. Executive directors of behavioral health authorities as defined in § 37.2-600 for the purpose of determining an individual's fitness for employment, approval as a sponsored residential service provider, permission to enter into a shared living arrangement with a person receiving medical assistance services pursuant to a waiver, or permission for any person under contract with the behavioral health authority to serve in a direct care position on behalf of the behavioral health authority pursuant to §§ 37.2-506 and 37.2-607;

28. The Commissioner of Social Services for the purpose of locating persons who owe child support or who are alleged in a pending paternity proceeding to be a putative father, provided that only the name, address, demographics and social security number of the data subject shall be released;

- 9531 29. Authorized officers or directors of agencies licensed pursuant to Article 2 (§ 37.2-403 et seq.) of
9532 Chapter 4 of Title 37.2 by the Department of Behavioral Health and Developmental Services for the
9533 purpose of determining if any applicant who accepts employment in any direct care position or requests
9534 approval as a sponsored residential service provider, permission to enter into a shared living arrangement
9535 with a person receiving medical assistance services pursuant to a waiver, or permission for any person
9536 under contract with the provider to serve in a direct care position has been convicted of a crime that
9537 affects his fitness to have responsibility for the safety and well-being of individuals with mental illness,
9538 intellectual disability, or substance abuse pursuant to §§ 37.2-416, 37.2-506, and 37.2-607;
- 9539 30. The Commissioner of the Department of Motor Vehicles, for the purpose of evaluating applicants
9540 for and holders of a motor carrier certificate or license subject to the provisions of Chapters 20
9541 (§ 46.2-2000 et seq.) and 21 (§ 46.2-2100 et seq.) of Title 46.2;
- 9542 31. The Chairman of the Senate Committee on the Judiciary or the Chairman of the House
9543 Committee for Courts of Justice for the purpose of determining if any person being considered for
9544 election to any judgeship has been convicted of a crime;
- 9545 32. Heads of state agencies in which positions have been identified as sensitive for the purpose of
9546 determining an individual's fitness for employment in positions designated as sensitive under Department
9547 of Human Resource Management policies developed pursuant to § 2.2-1201.1;
- 9548 33. The Office of the Attorney General, for all criminal justice activities otherwise permitted under
9549 subdivision A 1 and for purposes of performing duties required by the Civil Commitment of Sexually
9550 Violent Predators Act (§ 37.2-900 et seq.);
- 9551 34. Shipyards, to the extent permitted by federal law or regulation, engaged in the design,
9552 construction, overhaul, or repair of nuclear vessels for the United States Navy, including their subsidiary
9553 companies, for the conduct of investigations of applications for employment or for access to facilities,
9554 by contractors, leased laborers, and other visitors;
- 9555 35. Any employer of individuals whose employment requires that they enter the homes of others, for

9570 Chapter 16 (§ 6.2-1600 et seq.), Chapter 19 (§ 6.2-1900 et seq.), or Chapter 26 (§ 6.2-2600 et seq.) of
9571 Title 6.2. Notwithstanding any other provision of law, if an application is denied based in whole or in
9572 part on information obtained from the Central Criminal Records Exchange pursuant to Chapter 16, 19,
9573 or 26 of Title 6.2, the Commissioner of Financial Institutions or his designee may disclose such

 9861 any finding that a person is not guilty by reason of insanity in accordance with Chapter 11.1
 9862 (§ 19.2-182.2 et seq.) of Title 19.2 of an offense set forth in § 9.1-902 that results in the person's
 9863 requirement to register with the Sex Offender and Crimes Against Minors Registry pursuant to
 9864 § 9.1-901; any substantially similar offense under the laws of another jurisdiction; or any offense for
 9865 which registration in a sex offender and crimes against minors registry is required under the laws of the
 9866 jurisdiction where the offender was convicted; or (vi) any other felony not included in clause (i), (ii),
 9867 (iii), (iv), or (v) unless five years have elapsed from the date of the conviction.
 9868 "Barrier crime information" means the following facts concerning a person who has been arrested for,
 9869 or has been convicted of, a barrier crime, regardless of whether the person was a juvenile or adult at the
 9870 time of the arrest or conviction: full name, race, sex, date of birth, height, weight, fingerprints, a brief
 9871 description of the barrier crime or offenses for which the person has been arrested or has been
 9872 convicted, the disposition of the charge, and any other information that may be useful in identifying
 9873 persons arrested for or convicted of a barrier crime.
 9874 "Care" means the provision of care, treatment, education, training, instruction, supervision, or
 9875 recreation to children or the elderly or disabled.
 9876 "Department" means the Department of State Police.
 9877 "Employed by" means any person who is employed by, volunteers for, seeks to be employed by, or
 9878 seeks to volunteer for a qualified entity.
 9879 "Identification document" means a document made or issued by or under the authority of the United
 9880 States government, a state, a political subdivision of a state, a foreign government, political subdivision
 9881 of a foreign government, an international governmental or an international quasi-governmental
 9882 organization that, when completed with information concerning a particular individual, is of a type
 9883 intended or commonly accepted for the purpose of identification of individuals.
 9884 "Provider" means a person who (i) is employed by a qualified entity and has, seeks to have, or may
 9885 have unsupervised access to a child or to an elderly or disabled person to whom the qualified entity
 9886 provides care; (ii) is a volunteer of a qualified entity and has, seeks to have, or may have unsupervised
 9887 access to a child to whom the qualified entity provides care; or (iii) owns, operates, or seeks to own or
 9888 operate a qualified entity.
 9889 "Qualified entity" means a business or organization that provides care to children or the elderly or
 9890 disabled, whether governmental, private, for profit, nonprofit, or voluntary, except organizations exempt
 9891 pursuant to subdivision A 7 of § 22.1-289.030.
 9892 B. A qualified entity may request the Department of State Police to conduct a national criminal
 9893 background check on any provider who is employed by such entity. No qualified entity may request a
 9894 national criminal background check on a provider until such provider has:
 9895 1. Been fingerprinted; and
 9896 2. Completed and signed a statement, furnished by the entity, that includes (i) his name, address, and
 9897 date of birth as it appears on a valid identification document; (ii) a disclosure of whether or not the
 9898 provider has ever been convicted of or is the subject of pending charges for a criminal offense within or
 9899 outside the Commonwealth, and if the provider has been convicted of a crime, a description of the crime

9900 and the particulars of the conviction; (iii) a notice to the provider that the entity may request a
9901 background check; (iv) a notice to the provider that he is entitled to obtain a copy of any background
9902 check report, to challenge the accuracy and completeness of any information contained in any such
9903 report, and to obtain a prompt determination as to the validity of such challenge before a final
9904 determination is made by the Department; and (v) a notice to the provider that prior to the completion
9905 of the background check the qualified entity may choose to deny the provider unsupervised access to
9906 children or the elderly or disabled for whom the qualified entity provides care.

9907 C. Upon receipt of (i) a qualified entity's written request to conduct a background check on a
9908 provider, (ii) the provider's fingerprints, and (iii) a completed, signed statement as described in
9909 subsection B, the Department shall make a determination whether the provider has been convicted of or
9910 is the subject of charges of a barrier crime. To conduct its determination regarding the provider's barrier
9911 crime information, the Department shall access the national criminal history background check system,
9912 which is maintained by the Federal Bureau of Investigation and is based on fingerprints and other
9913 methods of identification, and shall access the Central Criminal Records Exchange maintained by the
9914 Department. If the Department receives a background report lacking disposition data, the Department
9915 shall conduct research in whatever state and local recordkeeping systems are available in order to obtain
9916 complete data. The Department shall make reasonable efforts to respond to a qualified entity's inquiry
9917 within 15 business days.

9918 D. Any background check conducted pursuant to this section for a provider employed by a private
9919 entity shall be screened by the Department of State Police. If the provider has been convicted of or is
9920 under indictment for a barrier crime, the qualified entity shall be notified that the provider is not
9921 qualified to work or volunteer in a position that involves unsupervised access to children or the elderly
9922 or disabled.

9923 E. Any background check conducted pursuant to this section for a provider employed by a
9924 governmental entity shall be provided to that entity.

9925 F. In the case of a provider who desires to volunteer at a qualified entity and who is subject to a
9926 national criminal background check, the Department and the Federal Bureau of Investigation may each
9927 charge the provider the lesser of \$18 or the actual cost to the entity of the background check conducted
9928 with the fingerprints.

9929 G. The failure to request a criminal background check pursuant to subsection B shall not be
9930 considered negligence per se in any civil action.

9931 **§ 19.2-392.2:1. (For contingent effective date, see Acts 2021, Sp. Sess. I, cc. 550 and 551, cl. 9)**
9932 **Former marijuana offenses; automatic expungement.**

9933 A. Records relating to the arrest, criminal charge, conviction, or civil offense of a person for a
9934 misdemeanor violation of former § 18.2-248.1 or a violation of former § 18.2-250.1, including any
9935 violation charged under either section and the charge was deferred and dismissed, shall be ordered to be
9936 automatically expunged in accordance with the provisions of this section.

9937 B. No later than July 1, 2025, the Department of State Police shall determine which offenses in the
9938 Central Criminal Records Exchange meet the criteria for automatic expungement set forth in subsection
9939 A. The Department of State Police shall provide an electronic list of all offenses that meet the criteria
9940 for automatic expungement to the Executive Secretary of the Supreme Court and to any circuit court
9941 clerk who maintains a case management system that interfaces with the Department of State Police
9942 under subsection B of § 17.1-502.

9943 C. Upon receipt of the electronic list from the Department of State Police provided under subsection
9944 B, the Executive Secretary of the Supreme Court shall provide an electronic list of all offenses that meet
9945 the criteria for automatic expungement set forth in subsection A to the clerk of each circuit court in the
9946 jurisdiction where the case was finalized, if such circuit court clerk participates in the case management
9947 system maintained by the Executive Secretary.

9948 D. Upon receipt of the electronic list provided under subsection B or C, the clerk of each circuit
9949 court shall prepare an order and the chief judge of that circuit court shall enter such order directing that
9950 the offenses that meet the criteria for automatic expungement set forth in subsection A be automatically
9951 expunged under the process set forth in subsections E, F, and G. Such order shall contain the names of
9952 the persons charged with or convicted of such offenses.

9953 E. The clerk of each circuit court shall provide an electronic copy of any order entered under
9954 subsection D to the Department of State Police. Upon receipt of such order, the Department of State
9955 Police (i) shall not disseminate any criminal history record information contained in the Central Criminal
9956 Records Exchange, including any records relating to an arrest, charge, or conviction, that was ordered to
9957 be expunged, except for purposes set forth in this section and pursuant to rules and regulations adopted

9966 F. Records relating to an arrest, charge, or conviction that was ordered to be expunged pursuant to
 9967 this section shall not be open for public inspection or otherwise disclosed, provided that such records
 9968 may be disseminated and used for the following purposes: (i) to make the determination as provided in
 9969 § 18.2-308.2:2 of eligibility to possess or purchase a firearm; (ii) for fingerprint comparison utilizing the
 9970 fingerprints maintained in the Automated Fingerprint Information System; (iii) to the Virginia Criminal
 9971 Sentencing Commission for its research purposes; (iv) to any full-time or part-time employee of the
 9972 State Police or a police department or sheriff's office that is a part of or administered by the
 9973 Commonwealth or any political subdivision thereof for the purpose of screening any person for full-time
 9974 employment or part-time employment with, or to be a volunteer with, the State Police or a police
 9975 department or sheriff's office that is a part of or administered by the Commonwealth or any political
 9976 subdivision thereof; (v) to the State Health Commissioner or his designee for the purpose of screening
 9977 any person who applies to be a volunteer with or an employee of an emergency medical services agency
 9978 as provided in § 32.1-111.5; (vi) to any full-time or part-time employee of the Department of Forensic
 9979 Science for the purpose of screening any person for full-time or part-time employment with the
 9980 Department of Forensic Science; (vii) to the chief law-enforcement officer of a locality, or his designee
 9981 who shall be an individual employed as a public safety official of the locality, that has adopted an
 9982 ordinance in accordance with §§ 15.2-1503.1 and 19.2-389 for the purpose of screening any person who
 9983 applies to be a volunteer with or an employee of an emergency medical services agency as provided in
 9984 § 32.1-111.5; (viii) to any full-time or part-time employee of the Department of Motor Vehicles, any
 9985 employer as defined in § 46.2-341.4, or any medical examiner as defined in 49 C.F.R. § 390.5 for the
 9986 purpose of complying with the regulations of the Federal Motor Carrier Safety Administration; (ix) to
 9987 any employer or prospective employer or its designee where federal law requires the employer to inquire
 9988 about prior criminal charges or convictions; (x) to any employer or prospective employer or its designee
 9989 where the position that a person is applying for, or where access to the premises in or upon which any
 9990 part of the duties of such position is performed or is to be performed, is subject to any requirement
 9991 imposed in the interest of the national security of the United States under any security program in effect
 9992 pursuant to or administered under any contract with, or statute or regulation of, the United States or any
 9993 Executive Order of the President; (xi) to any person authorized to engage in the collection of court
 9994 costs, fines, or restitution under subsection C of § 19.2-349 for purposes of collecting such court costs,
 9995 fines, or restitution; (xii) to administer and utilize the DNA Analysis and Data Bank set forth in Article
 9996 1.1 (§ 19.2-310.2 et seq.) of Chapter 18; (xiii) to publish decisions of the Supreme Court, Court of
 9997 Appeals, or any circuit court; (xiv) to any full-time or part-time employee of a court, the Office of the
 9998 Executive Secretary, the Division of Legislative Services, or the Chairs of the House Committee for
 9999 Courts of Justice and the Senate Committee on the Judiciary for the purpose of screening any person for
 10000 full-time or part-time employment as a clerk, magistrate, or judge with a court or the Office of the
 10001 Executive Secretary; (xv) to any employer or prospective employer or its designee where this Code or a
 10002 local ordinance requires the employer to inquire about prior criminal charges or convictions; (xvi) to any
 10003 employer or prospective employer or its designee that is allowed access to such expunged records in
 10004 accordance with the rules and regulations adopted pursuant to § 9.1-128 and procedures adopted
 10005 pursuant to § 9.1-134; (xvii) to any business screening service for purposes of complying with
 10006 § 19.2-392.16; (xviii) to any attorney for the Commonwealth and any person accused of a violation of
 10007 law, or counsel for the accused, in order to comply with any constitutional and statutory duties to
 10008 provide exculpatory, mitigating, and impeachment evidence to an accused; (xix) to any party in a
 10009 criminal or civil proceeding for use as authorized by law in such proceeding; (xx) to any party for use
 10010 in a protective order hearing as authorized by law; (xxi) to the Department of Social Services or any
 10011 local department of social services for purposes of performing any statutory duties as required under
 10012 Title 63.2; (xxii) to any party in a proceeding relating to the care and custody of a child for use as
 10013 authorized by law in such proceeding; (xxiii) to the attorney for the Commonwealth and the court for
 10014 purposes of determining eligibility for expungement pursuant to the provisions of § 19.2-392.12; (xxiv)
 10015 to determine a person's eligibility to be empaneled as a juror; ~~and~~ (xxv) *to any full-time or part-time*
 10016 *employee of the Virginia Cannabis Control Authority for the purpose of determining whether a person*
 10017 *qualifies as a social equity applicant; and* (xxvi) to the person arrested, charged, or convicted of the
 10018 offense that was expunged.

10019 G. The Department of Motor Vehicles shall not expunge any conviction or any charge that was
 10020 deferred and dismissed after a finding of facts sufficient to justify a finding of guilt (i) in violation of
 10021 federal regulatory record retention requirements or (ii) in violation of federal program requirements if
 10022 the Department of Motor Vehicles is required to suspend a person's driving privileges as a result of a

conviction or deferral and dismissal ordered to be expunged. Upon receipt of an order directing that an offense be expunged, the Department of Motor Vehicles shall expunge all records if the federal regulatory record retention period has run and all federal program requirements associated with a suspension have been satisfied. However, if the Department of Motor Vehicles cannot expunge an offense pursuant to this subsection at the time it is ordered, the Department of Motor Vehicles shall (a) notify the Department of State Police of the reason the record cannot be expunged and cite the authority prohibiting expungement at the time it is ordered; (b) notify the Department of State Police of the date, if known at the time when the expungement is ordered, on which such record can be expunged; (c) expunge such record on that date; and (d) notify the Department of State Police when such record has been expunged within the Department of Motor Vehicles' records.

H. All electronic lists created in accordance with this section are not subject to further dissemination unless explicitly provided for by this section. Any expungement order issued pursuant to this section shall be sealed and may only be disseminated for the purposes set forth in this section and pursuant to rules and regulations adopted pursuant to § 9.1-128 and procedures adopted pursuant to § 9.1-134. Any willful and intentional unlawful dissemination is punishable as an unlawful dissemination of criminal history record information in violation of § 9.1-136.

§ 19.2-392.2:2. (For contingent effective date, see Acts 2021, Sp. Sess. I, cc. 550 and 551, cl. 9) Former marijuana offenses; petition for expungement.

A. A person who has been convicted or adjudicated delinquent of a felony violation of former § 18.2-248.1 or a violation of subsection A of § 18.2-265.3 as it relates to marijuana, or charged under either section and the charge is deferred and dismissed, may file a petition setting forth the relevant facts and requesting expungement of the police records and the court records relating to the arrest, charge, conviction, or adjudication.

B. The petition with a copy of the warrant, summons, or indictment if reasonably available shall be filed in the circuit court of the county or city in which the case was disposed of and shall contain, except where not reasonably available, the date of arrest and the name of the arresting agency. Where this information is not reasonably available, the petition shall state the reason for such unavailability. The petition shall further state the specific criminal charge, conviction, or adjudication to be expunged, the date of final disposition of the charge, conviction, or adjudication as set forth in the petition, the petitioner's date of birth, and the full name used by the petitioner at the time of arrest.

C. A copy of the petition shall be served on the attorney for the Commonwealth of the city or county in which the petition is filed. The attorney for the Commonwealth may file an objection or answer to the petition or may give written notice to the court that he does not object to the petition within 21 days after it is served on him.

D. The petitioner shall obtain from a law-enforcement agency one complete set of the petitioner's fingerprints and shall provide that agency with a copy of the petition for expungement. The law-enforcement agency shall submit the set of fingerprints to the Central Criminal Records Exchange (CCRE) with a copy of the petition for expungement attached. The CCRE shall forward under seal to the court a copy of the petitioner's criminal history, a copy of the source documents that resulted in the CCRE entry that the petitioner wishes to expunge, if applicable, and the set of fingerprints. Upon completion of the hearing, the court shall return the fingerprint card to the petitioner. If no hearing was conducted, upon the entry of an order of expungement or an order denying the petition for expungement, the court shall cause the fingerprint card to be destroyed unless, within 30 days of the date of the entry of the order, the petitioner requests the return of the fingerprint card in person from the clerk of the court or provides the clerk of the court a self-addressed, stamped envelope for the return of the fingerprint card.

E. After receiving the criminal history record information from the CCRE, the court shall conduct a hearing on the petition. If the court finds that the continued existence and possible dissemination of information relating to the arrest, charge, conviction, or adjudication of the petitioner causes or may cause circumstances that constitute a manifest injustice to the petitioner, it shall enter an order requiring the expungement of the police and court records, including electronic records, relating to the arrest, charge, conviction, or adjudication. Otherwise, it shall deny the petition. However, if the petitioner has no prior criminal record and the arrest, charge, conviction, or adjudication was for a misdemeanor violation of subsection A of § 18.2-265.3, the petitioner shall be entitled, in the absence of good cause shown to the contrary by the Commonwealth, to expungement of the police and court records relating to the arrest, charge, conviction, or adjudication and the court shall enter an order of expungement. If the attorney for the Commonwealth of the county or city in which the petition is filed (i) gives written notice to the court pursuant to subsection C that he does not object to the petition and (ii) when the arrest, charge, conviction, or adjudication to be expunged is a felony violation of former § 18.2-248.1, stipulates in such written notice that the continued existence and possible dissemination of information relating to the arrest, charge, conviction, or adjudication of the petitioner causes or may cause circumstances that constitute a manifest injustice to the petitioner, the court may enter an order of

expungement without conducting a hearing.

F. The Commonwealth shall be made party defendant to the proceeding. Any party aggrieved by the decision of the court may appeal, as provided by law in civil cases.

G. Upon the entry of an order of expungement, the clerk of the court shall cause a copy of such order to be forwarded to the Department of State Police, which shall, pursuant to rules and regulations adopted pursuant to § 9.1-134, direct the manner by which the appropriate expungement or removal of such records shall be effected.

H. Records relating to an arrest, charge, conviction, or adjudication that was ordered to be expunged pursuant to this section shall not be open for public inspection or otherwise disclosed, provided that such records may be disseminated and used for the following purposes: (i) to make the determination as provided in § 18.2-308.2:2 of eligibility to possess or purchase a firearm; (ii) for fingerprint comparison utilizing the fingerprints maintained in the Automated Fingerprint Information System; (iii) to the Virginia Criminal Sentencing Commission for its research purposes; (iv) to any full-time or part-time employee of the State Police or a police department or sheriff's office that is a part of or administered by the Commonwealth or any political subdivision thereof for the purpose of screening any person for full-time employment or part-time employment with, or to be a volunteer with, the State Police or a police department or sheriff's office that is a part of or administered by the Commonwealth or any political subdivision thereof; (v) to the State Health Commissioner or his designee for the purpose of screening any person who applies to be a volunteer with or an employee of an emergency medical services agency as provided in § 32.1-111.5; (vi) to any full-time or part-time employee of the Department of Forensic Science for the purpose of screening any person for full-time or part-time employment with the Department of Forensic Science; (vii) to the chief law-enforcement officer of a locality, or his designee who shall be an individual employed as a public safety official of the locality, that has adopted an ordinance in accordance with §§ 15.2-1503.1 and 19.2-389 for the purpose of screening any person who applies to be a volunteer with or an employee of an emergency medical services agency as provided in § 32.1-111.5; (viii) to any full-time or part-time employee of the Department of Motor Vehicles, any employer as defined in § 46.2-341.4, or any medical examiner as defined in 49 C.F.R. § 390.5 for the purpose of complying with the regulations of the Federal Motor Carrier Safety Administration; (ix) to any employer or prospective employer or its designee where federal law requires the employer to inquire about prior criminal charges or convictions; (x) to any employer or prospective employer or its designee where the position that a person is applying for, or where access to the premises in or upon which any part of the duties of such position is performed or is to be performed, is subject to any requirement imposed in the interest of the national security of the United States under any security program in effect pursuant to or administered under any contract with, or statute or regulation of, the United States or any Executive Order of the President; (xi) to any person authorized to engage in the collection of court costs, fines, or restitution under subsection C of § 19.2-349 for purposes of collecting such court costs, fines, or restitution; (xii) to administer and utilize the DNA Analysis and Data Bank set forth in Article 1.1 (§ 19.2-310.2 et seq.) of Chapter 18; (xiii) to publish decisions of the Supreme Court, Court of Appeals, or any circuit court; (xiv) to any full-time or part-time employee of a court, the Office of the Executive Secretary, the Division of Legislative Services, or the Chairs of the House Committee for Courts of Justice and the Senate Committee on the Judiciary for the purpose of screening any person for full-time or part-time employment as a clerk, magistrate, or judge with a court or the Office of the Executive Secretary; (xv) to any employer or prospective employer or its designee where this Code or a local ordinance requires the employer to inquire about prior criminal charges or convictions; (xvi) to any employer or prospective employer or its designee that is allowed access to such expunged records in accordance with the rules and regulations adopted pursuant to § 9.1-128 and procedures adopted pursuant to § 9.1-134; (xvii) to any business screening service for purposes of complying with § 19.2-392.16; (xviii) to any attorney for the Commonwealth and any person accused of a violation of law, or counsel for the accused, in order to comply with any constitutional and statutory duties to provide exculpatory, mitigating, and impeachment evidence to an accused; (xix) to any party in a criminal or civil proceeding for use as authorized by law in such proceeding; (xx) to any party for use in a protective order hearing as authorized by law; (xxi) to the Department of Social Services or any local department of social services for purposes of performing any statutory duties as required under Title 63.2; (xxii) to any party in a proceeding relating to the care and custody of a child for use as authorized by law in such proceeding; (xxiii) to the attorney for the Commonwealth and the court for purposes of determining eligibility for expungement pursuant to the provisions of § 19.2-392.12; (xxiv) to determine a person's eligibility to be empaneled as a juror; and (xxv) to any full-time or part-time employee of the Virginia Cannabis Control Authority for the purpose of determining whether a person qualifies as a social equity applicant; and (xxvi) to the person arrested, charged, convicted, or adjudicated delinquent of the offense that was expunged.

I. The Department of Motor Vehicles shall not expunge any conviction, adjudication, or any charge

that was deferred and dismissed after a finding of facts sufficient to justify a finding of guilt (i) in violation of federal regulatory record retention requirements or (ii) in violation of federal program requirements if the Department of Motor Vehicles is required to suspend a person's driving privileges as a result of a conviction, adjudication, or deferral and dismissal ordered to be expunged. Upon receipt of an order directing that an offense be expunged, the Department of Motor Vehicles shall expunge all records if the federal regulatory record retention period has run and all federal program requirements associated with a suspension have been satisfied. However, if the Department of Motor Vehicles cannot expunge an offense pursuant to this subsection at the time it is ordered, the Department of Motor Vehicles shall (a) notify the Department of State Police of the reason the record cannot be expunged and cite the authority prohibiting expungement at the time it is ordered; (b) notify the Department of State Police of the date, if known at the time when the expungement is ordered, on which such record can be expunged; (c) expunge such record on that date; and (d) notify the Department of State Police when such record has been expunged within the Department of Motor Vehicles' records.

J. Costs shall be as provided by § 17.1-275, but shall not be recoverable against the Commonwealth. If the court enters an order of expungement, the clerk of the court shall refund to the petitioner such costs paid by the petitioner.

K. Any order entered where (i) the court or parties failed to strictly comply with the procedures set forth in this section or (ii) the court enters an order of expungement contrary to law, shall be voidable upon motion and notice made within three years of the entry of such order.

§ 19.2-392.2:3. Automatic expungement; certain former marijuana offenses.

A. *Records relating to the arrest, criminal charge, conviction, or civil offense of a person for a misdemeanor violation of former § 18.2-248.1 or a violation of former § 18.2-250.1, including any violation charged under either section and the charge was deferred and dismissed, shall be ordered to be automatically expunged in accordance with the provisions of this section.*

B. *No later than July 1, 2025, the Department of State Police shall determine which offenses in the Central Criminal Records Exchange meet the criteria for automatic expungement set forth in subsection A. The Department of State Police shall provide an electronic list of all offenses that meet the criteria for automatic expungement to the Executive Secretary of the Supreme Court and to any circuit court clerk who maintains a case management system that interfaces with the Department of State Police under subsection B of § 17.1-502.*

C. *Upon receipt of the electronic list from the Department of State Police provided under subsection B, the Executive Secretary of the Supreme Court shall provide an electronic list of all offenses that meet the criteria for automatic expungement set forth in subsection A to the clerk of each circuit court in the jurisdiction where the case was finalized, if such circuit court clerk participates in the case management system maintained by the Executive Secretary.*

D. *Upon receipt of the electronic list provided under subsection B or C, the clerk of each circuit court shall prepare an order and the chief judge of that circuit court shall enter such order directing that the offenses that meet the criteria for automatic expungement set forth in subsection A be automatically expunged under the process set forth in this section. Such order shall contain the names of the persons charged with or convicted of such offenses.*

E. *The clerk of each circuit court shall provide an electronic copy of any order entered under subsection D to the Department of State Police. Upon electronic notification that a court order for expungement has been entered pursuant to subsection D, the Department of State Police shall, pursuant to the rules and regulations adopted pursuant to § 9.1-134, direct the manner by which the appropriate expungement or removal of any records relating to the offenses ordered to be expunged shall be effected and shall electronically notify those agencies and individuals known to maintain or to have obtained such a record that such record has been ordered to be expunged.*

F. *The Department of Motor Vehicles shall not expunge any conviction or any charge that was deferred and dismissed after a finding of facts sufficient to justify a finding of guilt (i) in violation of federal regulatory record retention requirements or (ii) in violation of federal program requirements if the Department of Motor Vehicles is required to suspend a person's driving privileges as a result of a conviction or deferral and dismissal ordered to be expunged. Upon receipt of an order directing that an offense be expunged, the Department of Motor Vehicles shall expunge all records if the federal regulatory record retention period has run and all federal program requirements associated with a suspension have been satisfied. However, if the Department of Motor Vehicles cannot expunge an offense pursuant to this subsection at the time it is ordered, the Department of Motor Vehicles shall (a) notify the Department of State Police of the reason the record cannot be expunged and cite the authority prohibiting expungement at the time it is ordered; (b) notify the Department of State Police of the date, if known at the time when the expungement is ordered, on which such record can be expunged; (c) expunge such record on that date; and (d) notify the Department of State Police when such record has been expunged within the Department of Motor Vehicles' records.*

G. Any order entered where (i) the court or parties failed to strictly comply with the procedures set

forth in this section or (ii) the court enters an order for the expungement of records contrary to law shall be voidable upon motion and notice made within three years of the entry of such order.

§ 19.2-392.2:4. Expungement; certain former marijuana offenses.

A. A person who has been convicted of a felony violation of former § 18.2-248.1 or a violation of subsection A of § 18.2-265.3 as it relates to marijuana, or charged under either section and the charge is deferred and dismissed, may file a petition setting forth the relevant facts and requesting expungement of the police records and the court records relating to the arrest, charge, or conviction.

B. A person shall not be required to pay any fees or costs for filing a petition pursuant to this section if such person files a petition to proceed without the payment of fees and costs, and the court with which such person files his petition finds such person to be indigent pursuant to § 19.2-159.

C. The petition with a copy of the warrant, summons, or indictment, if reasonably available, shall be filed in the circuit court of the county or city in which the case was disposed of and shall contain, except where not reasonably available, the date of arrest, the name of the arresting agency, and the date of conviction. Where this information is not reasonably available, the petition shall state the reason for such unavailability. The petition shall further state the specific criminal charge or conviction to be expunged, the date of final disposition of the charge or conviction as set forth in the petition, the petitioner's date of birth, sex, race, and social security number, if available, and the full name used by the petitioner at the time of arrest or summons.

D. The Commonwealth shall be made a party to the proceeding. A copy of the petition shall be served on the attorney for the Commonwealth of the city or county in which the petition is filed. The attorney for the Commonwealth may file an objection or answer to the petition or may give written notice to the court that he does not object to the petition within 21 days after it is served on him.

E. Upon receipt of the petition, the circuit court shall order that the attorney for the Commonwealth or a law-enforcement officer, as defined in § 9.1-101, provide the court with a sealed copy of the criminal history record of the petitioner. Upon completion of the hearing, the court shall cause the criminal history record to be destroyed unless, within 30 days of the date of the entry of the final order in the matter, the petitioner or the attorney for the Commonwealth notes an appeal to the Supreme Court of Virginia.

F. After receiving the criminal history record of the petitioner, the court may conduct a hearing on the petition. The court shall enter an order requiring the expungement of the criminal history record information and court records, including electronic records, relating to the charge or conviction, if the court finds that the continued existence and possible dissemination of information relating to the arrest, charge, or conviction of the petitioner causes or may cause circumstances that constitute a manifest injustice to the petitioner. Otherwise, it shall deny the petition.

G. However, if the petitioner has no prior criminal record and the arrest, charge, or conviction was for a misdemeanor violation of subsection A of § 18.2-265.3, the petitioner shall be entitled, in absence of good cause shown to the contrary by the Commonwealth, to expungement of the police and court records relating to the arrest, charge, or conviction and the court shall enter an order of expungement. If the attorney for the Commonwealth of the county or city in which the petition is filed (i) gives written notice to the court pursuant to subsection D that he does not object to the petition and (ii) stipulates in such written notice that the petitioner is eligible to have such offense expunged, and the continued existence and possible dissemination of information relating to the charge or conviction of the petitioner causes or may cause circumstances that constitute a manifest injustice to the petitioner, the court may enter an expungement order without conducting a hearing.

H. Any party aggrieved by the decision of the court may appeal, as provided by law in civil cases.

I. Upon the entry of an order of expungement, the clerk of the court shall provide an electronic copy of such order to the Department of State Police. Upon electronic notification that a court order for expungement has been entered, the Department of State Police shall, pursuant to the rules and regulations adopted pursuant to § 9.1-134, direct the manner by which the appropriate expungement or removal of any records relating to the offenses ordered to be expunged shall be effected and electronically notify those agencies and individuals known to maintain or have obtained such a record that such record has been ordered to be expunged.

J. The Department of Motor Vehicles shall not expunge any conviction or any charge that was deferred and dismissed after a finding of facts sufficient to justify a finding of guilt (i) in violation of federal regulatory record retention requirements or (ii) in violation of federal program requirements if the Department of Motor Vehicles is required to suspend a person's driving privileges as a result of a conviction or deferral and dismissal ordered to be expunged. Upon receipt of an order directing that an offense be expunged, the Department of Motor Vehicles shall expunge all records if the federal regulatory record retention period has run and all federal program requirements associated with a suspension have been satisfied. 10277 *L. Any order entered where (i) the court or parties failed to strictly comply with the procedures set*
 10278 *forth in this section or (ii) the court enters an order for the expungement of records contrary to law*
 10279 *shall be voidable upon motion and notice made within three years of the entry of such order.*

10280 *M. If a petitioner qualifies to file a petition for expungement of records without the payment of fees*
 10281 *and costs pursuant to subsection B and has requested court-appointed counsel, the court shall then*
 10282 *appoint counsel to file the petition for expungement of records and represent the petitioner in the*
 10283 *expungement proceedings. Counsel appointed to represent such a petitioner shall be compensated for his*
 10284 *services subject to guidelines issued by the Executive Secretary of the Supreme Court of Virginia, in a*
 10285 *total amount not to exceed \$120, as determined by the court, and such compensation shall be paid from*
 10286 *the Sealing Fee Fund as provided in § 17.1-205.1.*

10287 **§ 19.2-392.3. Disclosure of expunged records.**

10288 *A. It shall be unlawful for any person having or acquiring access to an expunged court or police*
 10289 *record to open or review it or to disclose to another person any information from it without an order*
 10290 *from the court which ordered the record expunged.*

10291 *B. Upon a verified petition filed by the attorney for the Commonwealth alleging that the record is*
 10292 *needed by (i) a law-enforcement agency or the Department of Forensic Science for purposes of*

 10300 **Automatic sealing of offenses resulting in a deferred and dismissed disposition or conviction.**

10301 *A. If a person was charged with an offense in violation of § 4.1-305 or former § 18.2-250.1, and*
 10302 *such offense was deferred and dismissed as provided in § 4.1-305 or 18.2-251, such offense, including*
 10303 *any records relating to such offense, shall be ordered to be automatically sealed in the manner set forth*
 10304 *in § 19.2-392.7, subject to the provisions of subsections C and D.*

10305 *B. If a person was convicted of a violation of any of the following sections, such conviction,*
 10306 *including any records relating to such conviction, shall be ordered to be automatically sealed in the*
 10307 *manner set forth in § 19.2-392.7, subject to the provisions of subsections C and D: § 4.1-305, 18.2-96,*
 10308 *18.2-103, 18.2-119, 18.2-120, or 18.2-134; a misdemeanor violation of former § 18.2-248.1; or former*
 10309 *§ 18.2-250.1 or 18.2-415.*

10310 *C. Subject to the provisions of subsection D, any offense listed under subsection A and any*
 10311 *conviction listed under subsection B shall be ordered to be automatically sealed if seven years have*
 10312 *passed since the date of the dismissal or conviction and the person charged with or convicted of such*
 10313 *offense has not been convicted of violating any law of the Commonwealth that requires a report to the*
 10314 *Central Criminal Records Exchange under subsection A of § 19.2-390 or any other state, the District of*
 10315 *Columbia, or the United States or any territory thereof, excluding traffic infractions under Title 46.2,*
 10316 *during that time period.*

10317 *D. No offense listed under subsection A shall be automatically sealed if, on the date of the deferral*
 10318 *or dismissal, the person was convicted of another offense that is not eligible for automatic sealing under*
 10319 *subsection A or B. No conviction listed under subsection B shall be automatically sealed if, on the date*
 10320 *of the conviction, the person was convicted of another offense that is not eligible for automatic sealing*
 10321 *under subsection A or B.*

10322 *E. This section shall not be construed as prohibiting a person from seeking sealing in the circuit*
 10323 *court pursuant to the provisions of § 19.2-392.12.*

10324 **§ 22.1-206. Instruction concerning drugs, alcohol, substance abuse, and tobacco and nicotine**
 10325 **products.**

10326 *A. Instruction concerning drugs and drug abuse shall be provided by the public schools as prescribed*
 10327 *by the Board of Education.*

10328 *B. Instruction concerning the public safety hazards and dangers of alcohol abuse, underage drinking,*
 10329 *underage marijuana use, and drunk driving shall be provided in the public schools. The Virginia*
 10330 *Alcoholic Beverage Control Authority and the Virginia Cannabis Control Authority shall provide*

educational materials to the Department of Education. The Department of Education shall review and shall distribute such materials as are approved to the public schools.

C. The Virginia Foundation for Healthy Youth shall develop and the Department of Education shall distribute to each local school division educational materials concerning the health and safety risks of using tobacco products, nicotine vapor products, and alternative nicotine products, as such terms are defined in § 18.2-371.2. Instruction concerning the health and safety risks of using tobacco products, nicotine vapor products, and alternative nicotine products, as such terms are defined in § 18.2-371.2, shall be provided in each public elementary and secondary school in the Commonwealth, consistent with such educational materials.

§ 22.1-277.08. Expulsion of students for certain drug offenses.

A. School boards shall expel from school attendance any student whom such school board has determined, in accordance with the procedures set forth in this article, to have brought a controlled substance, *or* imitation controlled substance, ~~or marijuana~~ as those terms are defined in § 18.2-247 onto school property or to a school-sponsored activity. A school administrator, pursuant to school board policy, or a school board may, however, determine, based on the facts of a particular situation, that special circumstances exist and no disciplinary action or another disciplinary action or another term of expulsion is appropriate. A school board may, by regulation, authorize the division superintendent or his designee to conduct a preliminary review of such cases to determine whether a disciplinary action other than expulsion is appropriate. Such regulations shall ensure that, if a determination is made that another disciplinary action is appropriate, any such subsequent disciplinary action is to be taken in accordance with the procedures set forth in this article. Nothing in this section shall be construed to require a student's expulsion regardless of the facts of the particular situation.

B. Each school board shall revise its standards of student conduct to incorporate the requirements of this section no later than three months after the date on which this act becomes effective.

§ 23.1-609. Surviving spouses and children of certain individuals; tuition and fee waivers.

A. The surviving spouse and any child between the ages of 16 and 25 of an individual who was killed in the line of duty while employed or serving as a (i) law-enforcement officer, including as a campus police officer appointed under Article 3 (§ 23.1-809 et seq.) of Chapter 8, sworn law-enforcement officer, firefighter, special forest warden pursuant to § 10.1-1135, member of a rescue squad, special agent of the Virginia Alcoholic Beverage Control Authority *or the Virginia Cannabis Control Authority*, state correctional, regional or local jail officer, regional jail or jail farm superintendent, sheriff, or deputy sheriff; (ii) member of the Virginia National Guard while serving on official state duty or federal duty under Title 32 of the United States Code; or (iii) member of the Virginia Defense Force while serving on official state duty, and any individual whose spouse was killed in the line of duty while employed or serving in any of such occupations, is entitled to a waiver of undergraduate tuition and mandatory fees at any public institution of higher education under the following conditions:

1. The chief executive officer of the deceased individual's employer certifies that such individual was so employed and was killed in the line of duty while serving or living in the Commonwealth; and

2. The surviving spouse or child is admitted to, enrolls at, and is in attendance at such institution and applies to such institution for the waiver. Waiver recipients who make satisfactory academic progress are eligible for renewal of such waiver.

B. Institutions that grant such waivers shall waive the amounts payable for tuition, institutional charges and mandatory educational and auxiliary fees, and books and supplies but shall not waive user fees such as room and board charges.

C. Each public institution of higher education shall include in its catalog or equivalent publication a statement describing the benefits available pursuant to this section.

§ 23.1-1301. Governing boards; powers.

A. The board of visitors of each baccalaureate public institution of higher education or its designee may:

1. Make regulations and policies concerning the institution;
2. Manage the funds of the institution and approve an annual budget;
3. Appoint the chief executive officer of the institution;
4. Appoint professors and fix their salaries; and
5. Fix the rates charged to students for tuition, mandatory fees, and other necessary charges.

B. The governing board of each public institution of higher education or its designee may:

1. In addition to the powers set forth in Restructured Higher Education Financial and Administrative Operations Act (§ 23.1-1000 et seq.), lease or sell and convey its interest in any real property that it has acquired by purchase, will, or deed of gift, subject to the prior approval of the Governor and any terms and conditions of the will or deed of gift, if applicable. The proceeds shall be held, used, and administered in the same manner as all other gifts and bequests;

- 10392 2. Grant easements for roads, streets, sewers, waterlines, electric and other utility lines, or other
 10393 purposes on any property owned by the institution;
- 10394 3. Adopt regulations or institution policies for parking and traffic on property owned, leased,
 10395 maintained, or controlled by the institution;
- 10396 4. Adopt regulations or institution policies for the employment and dismissal of professors, teachers,
 10397 instructors, and other employees;
- 10398 5. Adopt regulations or institution policies for the acceptance and assistance of students in addition to
 10399 the regulations or institution policies required pursuant to § 23.1-1303;
- 10400 6. Adopt regulations or institution policies for the conduct of students in attendance and for the
 10401 rescission or restriction of financial aid, suspension, and dismissal of students who fail or refuse to abide
 10402 by such regulations or policies;
- 10403 7. Establish programs, in cooperation with the Council and the Office of the Attorney General, to
 10404 promote (i) student compliance with state laws on the use of alcoholic beverages *and marijuana* and (ii)
 10405 the awareness and prevention of sexual crimes committed upon students;
- 10406 8. Establish guidelines for the initiation or induction of students into any social fraternity or sorority
 10407 in accordance with the prohibition against hazing as defined in § 18.2-56;
- 10408 9. Assign any interest it possesses in intellectual property or in materials in which the institution
 10409 claims an interest, provided such assignment is in accordance with the terms of the institution's
 10410 intellectual property policies adopted pursuant to § 23.1-1303. The Governor's prior written approval is
 10411 required for transfers of such property (i) developed wholly or predominantly through the use of state
 10412 general funds, exclusive of capital assets and (ii)(a) developed by an employee of the institution acting
 10413 within the scope of his assigned duties or (b) for which such transfer is made to an entity other than (1)
 10414 the Innovation and Entrepreneurship Investment Authority, (2) an entity whose purpose is to manage
 10415 intellectual properties on behalf of nonprofit organizations, colleges, and universities, or (3) an entity
 10416 whose purpose is to benefit the respective institutions. The Governor may attach conditions to these
 10417 transfers as he deems necessary. In the event the Governor does not approve such transfer, the materials
 10418 shall remain the property of the respective institutions and may be used and developed in any manner

- 10426 **§ 33.2-613. Free use of toll facilities by certain state officers and employees; penalties.**
- 10427 A. Upon presentation of a toll pass issued pursuant to regulations promulgated by the Board, the
 10428 following persons may use all toll bridges, toll ferries, toll tunnels, and toll roads in the Commonwealth
 10429 without the payment of toll while in the performance of their official duties:
- 10430 1. The Commissioner of Highways;
- 10431 2. Members of the Commonwealth Transportation Board;
- 10432 3. Employees of the Department of Transportation;
- 10433 4. The Superintendent of the Department of State Police;
- 10434 5. Officers and employees of the Department of State Police;
- 10435 6. Members of the Board of Directors of the Virginia Alcoholic Beverage Control Authority *or the*
 10436 *Board of Directors of the Virginia Cannabis Control Authority*;
- 10437 7. Employees of the regulatory and hearings divisions of the Virginia Alcoholic Beverage Control
 10438 Authority *or the Virginia Cannabis Control Authority* and special agents of the Virginia Alcoholic
 10439 Beverage Control Authority *or the Virginia Cannabis Control Authority*;
- 10440 8. The Commissioner of the Department of Motor Vehicles;
- 10441 9. Employees of the Department of Motor Vehicles;
- 10442 10. Local police officers;
- 10443 11. Sheriffs and their deputies;
- 10444 12. Regional jail officials;
- 10445 13. Animal wardens;
- 10446 14. The Director and officers of the Department of Wildlife Resources;
- 10447 15. Persons operating firefighting equipment and emergency medical services vehicles as defined in
 10448 § 32.1-111.1;
- 10449 16. Operators of school buses being used to transport pupils to or from schools;
- 10450 17. Operators of (i) commuter buses having a capacity of 20 or more passengers, including the
 10451 driver, and used to regularly transport workers to and from their places of employment and (ii) public
 10452 transit buses;
- 10453 18. Employees of the Department of Rail and Public Transportation;

19. Employees of any transportation facility created pursuant to the Virginia Highway Corporation Act of 1988; and

20. Law-enforcement officers of the Virginia Marine Resources Commission.

B. Notwithstanding the provision of subsection A requiring presentation of a toll pass for toll-free use of such facilities, in cases of emergency and circumstances of concern for public safety on the highways of the Commonwealth, the Department of Transportation shall, in order to alleviate an actual or potential threat or risk to the public's safety, facilitate the flow of traffic on or within the vicinity of the toll facility by permitting the temporary suspension of toll collection operations on its facilities.

1. The assessment of the threat to public safety shall be performed and the decision temporarily to suspend toll collection operations shall be made by the Commissioner of Highways or his designee.

2. Major incidents that may require the temporary suspension of toll collection operations shall include (i) natural disasters, such as hurricanes, tornadoes, fires, and floods; (ii) accidental releases of hazardous materials, such as chemical spills; (iii) major traffic accidents, such as multivehicle collisions; and (iv) other incidents deemed to present a risk to public safety. Any mandatory evacuation during a state of emergency as defined in § 44-146.16 shall require the temporary suspension of toll collection operations in affected evacuation zones on routes designated as mass evacuation routes. The Commissioner of Highways shall reinstate toll collection when the mandatory evacuation period ends.

3. In any judicial proceeding in which a person is found to be criminally responsible or civilly liable for any incident resulting in the suspension of toll collections as provided in this subsection, the court may assess against the person an amount equal to lost toll revenue as a part of the costs of the proceeding and order that such amount, not to exceed \$2,000 for any individual incident, be paid to the Department of Transportation for deposit into the toll road fund.

C. Any tollgate keeper who refuses to permit the persons listed in subsection A to use any toll bridge, toll ferry, toll tunnel, or toll road upon presentation of such a toll pass is guilty of a misdemeanor punishable by a fine of not more than \$50 and not less than \$2.50. Any person other than those listed in subsection A who exhibits any such toll pass for the purpose of using any toll bridge, toll ferry, toll tunnel, or toll road is guilty of a Class 1 misdemeanor.

D. Any vehicle operated by the holder of a valid driver's license or other document issued under Chapter 3 (§ 46.2-300 et seq.) of Title 46.2, or the comparable law of another jurisdiction, authorizing the operation of a motor vehicle upon the highways shall be allowed free use of all toll bridges, toll roads, and other toll facilities in the Commonwealth if:

1. The vehicle is specially equipped to permit its operation by a handicapped person;

2. The driver of the vehicle has been certified, either by a physician licensed by the Commonwealth or any other state or by the Adjudication Office of the U.S. Department of Veterans Affairs, as being severely physically disabled and having permanent upper limb mobility or dexterity impairments that substantially impair his ability to deposit coins in toll baskets;

3. The driver has applied for and received from the Department of Transportation a vehicle window sticker identifying him as eligible for such free passage; and

4. Such identifying window sticker is properly displayed on the vehicle.

A copy of this subsection shall be posted at all toll bridges, toll roads, and other toll facilities in the Commonwealth. The Department of Transportation shall provide envelopes for payments of tolls by those persons exempted from tolls pursuant to this subsection and shall accept any payments made by such persons.

E. Nothing contained in this section or in § 33.2-612 or 33.2-1718 shall operate to affect the provisions of § 22.1-187.

F. Notwithstanding the provisions of subsections A, B, and C, only the following persons may use the Chesapeake Bay Bridge-Tunnel, facilities of the Richmond Metropolitan Transportation Authority, or facilities of an operator authorized to operate a toll facility pursuant to the Public-Private Transportation Act of 1995 (§ 33.2-1800 et seq.) without the payment of toll when necessary and incidental to the conduct of official business:

1. The Commissioner of Highways;

2. Members of the Commonwealth Transportation Board;

3. Employees of the Department of Transportation;

4. The Superintendent of the Department of State Police;

5. Officers and employees of the Department of State Police;

6. The Commissioner of the Department of Motor Vehicles;

7. Employees of the Department of Motor Vehicles; and

8. Sheriffs and deputy sheriffs.

However, in the event of a mandatory evacuation and suspension of tolls pursuant to subdivision B 2, the Commissioner of Highways or his designee shall order the temporary suspension of toll collection operations on facilities of all operators authorized to operate a toll facility pursuant to the Public-Private

10515 Transportation Act of 1995 (§ 33.2-1800 et seq.) that has been designated as a mass evacuation route in
10516 affected evacuation zones, to the extent such order is necessary to facilitate evacuation and is consistent
10517 with the terms of the applicable comprehensive agreement between the operator and the Department.
10518 The Commissioner of Highways shall authorize the reinstatement of toll collections suspended pursuant
10519 to this subsection when the mandatory evacuation period ends or upon the reinstatement of toll
10520 collections on other tolled facilities in the same affected area, whichever occurs first.

10521 G. Any vehicle operated by a quadriplegic driver shall be allowed free use of all toll facilities in
10522 Virginia controlled by the Richmond Metropolitan Transportation Authority, pursuant to the requirements
10523 of subdivisions D 1 through 4.

10524 H. Vehicles transporting two or more persons, including the driver, may be permitted toll-free use of
10525 the Dulles Toll Road during rush hours by the Board; however, notwithstanding the provisions of
10526 subdivision B 1 of § 56-543, such vehicles shall not be permitted toll-free use of a roadway as defined
10527 pursuant to the Virginia Highway Corporation Act of 1988 (§ 56-535 et seq.).

10528 **§ 46.2-105.2. Obtaining documents from the Department when not entitled thereto; penalty.**

10529 A. It ~~shall be~~ *is* unlawful for any person to obtain a Virginia driver's license, special identification
10530 card, vehicle registration, certificate of title, or other document issued by the Department if such person
10531 has not satisfied all legal and procedural requirements for the issuance thereof, or is otherwise not
10532 legally entitled thereto, including obtaining any document issued by the Department through the use of
10533 counterfeit, forged, or altered documents.

10534 B. It ~~shall be~~ *is* unlawful to aid any person to obtain any driver's license, special identification card,
10535 vehicle registration, certificate of title, or other document in violation of the provisions of subsection A.

10536 C. It ~~shall be~~ *is* unlawful to knowingly possess or use for any purpose any driver's license, special
10537 identification card, vehicle registration, certificate of title, or other document obtained in violation of the
10538 provisions of subsection A.

10539 D. A violation of any provision of this section shall constitute a Class 2 misdemeanor if a person is
10540 charged and convicted of a violation of this section that involved the unlawful obtaining or possession
10541 of any document issued by the Department for the purpose of engaging in any age-limited activity,
10542 including but not limited to obtaining, possessing, or consuming alcoholic beverages *or marijuana*.
10543 However, if a person is charged and convicted of any other violation of this section, such offense shall
10544 constitute a Class 6 felony.

10545 E. Whenever it appears to the satisfaction of the Commissioner that any driver's license, special
10546 identification card, vehicle registration, certificate of title, or other document issued by the Department
10547 has been obtained in violation of this section, it may be cancelled by the Commissioner, who shall mail
10548 notice of the cancellation to the address of record maintained by the Department.

10549 **§ 46.2-347. Fraudulent use of driver's license or Department of Motor Vehicles identification**
10550 **card to obtain alcoholic beverages or marijuana; penalties.**

10551 Any underage person as specified in § 4.1-304 who knowingly uses or attempts to use a forged,
10552 deceptive or otherwise nongenuine driver's license issued by any state, territory or possession of the
10553 United States, the District of Columbia, the Commonwealth of Puerto Rico or any foreign country or
10554 government; United States Armed Forces identification card; United States passport or foreign
10555 government visa; Virginia Department of Motor Vehicles special identification card; official
10556 identification issued by any other federal, state or foreign government agency; or official student
10557 identification card of an institution of higher education to obtain alcoholic beverages ~~shall be~~ *or*
10558 *marijuana* is guilty of a Class 3 misdemeanor, and upon conviction of a violation of this section, the
10559 court shall revoke such convicted person's driver's license or privilege to drive a motor vehicle for a
10560 period of not less than 30 days nor more than one year.

10561 **§ 48-17.1. Temporary injunctions against alcoholic beverage or marijuana sales.**

10562 A. Any locality by or through its mayor, chief executive, or attorney may petition a circuit court to
10563 temporarily enjoin the sale of alcohol *or marijuana* at any establishment licensed by the Virginia
10564 Alcoholic Beverage Control Authority *or the Virginia Cannabis Control Authority*. The basis for such
10565 petition shall be the operator of the establishment has allowed it to become a meeting place for persons
10566 committing serious criminal violations of the law on or immediately adjacent to the premises so frequent
10567 and serious as to be deemed a continuing threat to public safety, as represented in an affidavit by the
10568 chief law-enforcement officer of the locality, supported by records of such criminal acts. The court shall,
10569 upon the presentation of evidence at a hearing on the matter, grant a temporary injunction, without
10570 bond, enjoining the sale of alcohol *or marijuana* at the establishment, if it appears to the satisfaction of
10571 the court that the threat to public safety complained of exists and is likely to continue if such injunction
10572 is not granted. The court hearing on the petition shall be held within 10 days of service upon the
10573 respondent. The respondent shall be served with notice of the time and place of the hearing and copies
10574 of all documentary evidence to be relied upon by the complainant at such hearing. Any injunction issued
10575 by the court shall be dissolved in the event the court later finds that the threat to public safety that is
10576 the basis of the injunction has been abated by reason of a change of ownership, management, or

business operations at the establishment, or other change in circumstance.

B. The Virginia Alcoholic Beverage Control Authority *or the Virginia Cannabis Control Authority* shall be given notice of any hearing under this section. In the event an injunction is granted, the Virginia Alcoholic Beverage Control Authority *or the Virginia Cannabis Control Authority* shall initiate an investigation into the activities at the establishment complained of and conduct an administrative hearing. After the Virginia Alcoholic Beverage Control Authority *or Virginia Cannabis Control Authority* hearing and when a final determination has been issued by the Virginia Alcoholic Beverage Control Authority *or Virginia Cannabis Control Authority*, regardless of disposition, any injunction issued hereunder shall be null, without further action by the complainant, respondent, or the court.

§ 51.1-212. Definitions.

As used in this chapter, unless the context requires a different meaning:

"Employee" means any (i) member of the Capitol Police Force as described in § 30-34.2:1, (ii) campus police officer appointed under the provisions of Article 3 (§ 23.1-809 et seq.) of Chapter 8 of Title 23.1, (iii) conservation police officer in the Department of Wildlife Resources appointed under the provisions of Chapter 2 (§ 29.1-200 et seq.) of Title 29.1, (iv) special agent of the Virginia Alcoholic Beverage Control Authority appointed under the provisions of Chapter 1 (§ 4.1-100 et seq.) of Title 4.1 *or special agent of the Virginia Cannabis Control Authority appointed under the provisions of Chapter 6 (§ 4.1-600 et seq.) of Title 4.1*, (v) law-enforcement officer employed by the Virginia Marine Resources Commission as described in § 9.1-101, (vi) correctional officer as the term is defined in § 53.1-1, and including correctional officers employed at a juvenile correction facility as the term is defined in § 66-25.3, (vii) ~~any~~ parole officer appointed pursuant to § 53.1-143, and (viii) ~~any~~ commercial vehicle enforcement officer employed by the Department of State Police.

"Member" means any person included in the membership of the Retirement System as provided in this chapter.

"Normal retirement date" means a member's sixtieth birthday.

"Retirement System" means the Virginia Law Officers' Retirement System.

§ 53.1-165.1. Limitation on the application of parole statutes.

A. The provisions of this article, except §§ 53.1-160 and 53.1-160.1, shall not apply to any sentence imposed or to any prisoner incarcerated upon a conviction for a felony offense committed on or after January 1, 1995. Any person sentenced to a term of incarceration for a felony offense committed on or after January 1, 1995, shall not be eligible for parole upon that offense.

B. The provisions of this article shall apply to any person who was sentenced by a jury prior to June 9, 2000, for any felony offense committed on or after January 1, 1995, and who remained incarcerated for such offense on July 1, 2020, other than (i) a Class 1 felony or (ii) any of the following felony offenses where the victim was a minor: (a) rape in violation of § 18.2-61; (b) forcible sodomy in violation of § 18.2-67.1; (c) object sexual penetration in violation of § 18.2-67.2; (d) aggravated sexual battery in violation of § 18.2-67.3; (e) an attempt to commit a violation of clause (a), (b), (c), or (d); or (f) carnal knowledge in violation of § 18.2-63, 18.2-64.1, or 18.2-64.2.

C. The Parole Board shall establish procedures for consideration of parole of persons entitled under subsection B consistent with the provisions of § 53.1-154.

D. Any person who meets eligibility criteria for parole under subsection B and pursuant to § 53.1-151 as of July 1, 2020, shall be scheduled for a parole interview no later than July 1, 2021, allowing for extension of time for reasonable cause.

E. Notwithstanding the provisions of subsection A or any other provision of this article to the contrary, any person sentenced to a term of life imprisonment for a single felony or multiple felonies committed while the person was a juvenile and who has served at least 20 years of such sentence shall be eligible for parole and any person who has active sentences that total more than 20 years for a single felony or multiple felonies committed while the person was a juvenile and who has served at least 20 years of such sentences shall be eligible for parole. The Board shall review and decide the case of each prisoner who is eligible for parole in accordance with § 53.1-154 and rules adopted pursuant to subdivision 2 of § 53.1-136.

F. The provisions of this article shall apply to any person convicted of a felony and who is not serving a sentence for a conviction of an act of violence as defined in § 19.2-297.1, who may have had a sentence enhanced because of a felony conviction under § 18.2-248, 18.2-248.01, 18.2-248.1, 18.2-250, 18.2-255, 18.2-255.2, 18.2-256, 18.2-257, 18.2-258, 18.2-258.02, 18.2-258.1, 18.2-265.3, or 18.2-474.1 as it relates to marijuana, when such felony offense was committed on or after January 1, 1995, and who was committed by a court under the laws of the Commonwealth to the Department of Corrections and remains incarcerated for such offense on July 1, 2022.

§ 53.1-231.2. Restoration of the civil right to be eligible to register to vote to certain persons.

This section shall apply to any person who is not a qualified voter because of a felony conviction, who seeks to have his right to register to vote restored and become eligible to register to vote, and who

10638 meets the conditions and requirements set out in this section.

10639 Any person, other than a person (i) convicted of a violent felony as defined in § 19.2-297.1 or in
10640 subsection C of § 17.1-805 and any crime ancillary thereto; (ii) convicted of a felony pursuant to
10641 § 4.1-1101, 4.1-1114, 18.2-248, 18.2-248.01, ~~18.2-248.1~~, 18.2-255, 18.2-255.2, or 18.2-258.02; or (iii)
10642 convicted of a felony pursuant to § 24.2-1016, may petition the circuit court of the county or city in
10643 which he was convicted of a felony, or the circuit court of the county or city in which he presently
10644 resides, for restoration of his civil right to be eligible to register to vote through the process set out in
10645 this section. On such petition, the court may approve the petition for restoration to the person of his
10646 right if the court is satisfied from the evidence presented that the petitioner has completed, five or more
10647 years previously, service of any sentence and any modification of sentence including probation, parole,
10648 and suspension of sentence; that the petitioner has demonstrated civic responsibility through community
10649 or comparable service; and that the petitioner has been free from criminal convictions, excluding traffic
10650 infractions, for the same period.

10651 If the court approves the petition, it shall so state in an order, provide a copy of the order to the
10652 petitioner, and transmit its order to the Secretary of the Commonwealth. The order shall state that the
10653 petitioner's right to be eligible to register to vote may be restored by the date that is 90 days after the
10654 date of the order, subject to the approval or denial of restoration of that right by the Governor. The
10655 Secretary of the Commonwealth shall transmit the order to the Governor who may grant or deny the
10656 petition for restoration of the right to be eligible to register to vote approved by the court order. The
10657 Secretary of the Commonwealth shall send, within 90 days of the date of the order, to the petitioner at
10658 the address stated on the court's order, a certificate of restoration of that right or notice that the
10659 Governor has denied the restoration of that right. The Governor's denial of a petition for the restoration
10660 of voting rights shall be a final decision and the petitioner shall have no right of appeal. The Secretary
10661 shall notify the court and the State Board of Elections in each case of the restoration of the right or
10662 denial of restoration by the Governor.

10663 On receipt of the certificate of restoration of the right to register to vote from the Secretary of the
10664 Commonwealth, the petitioner, who is otherwise a qualified voter, shall become eligible to register to
10665 vote.

10666 **§ 54.1-2903. What constitutes practice; advertising in connection with medical practice.**

10667 A. Any person shall be regarded as practicing the healing arts who actually engages in such practice
10668 as defined in this chapter, or who opens an office for such purpose, or who advertises or announces to
10669 the public in any manner a readiness to practice or who uses in connection with his name the words or
10670 letters "Doctor," "Dr.," "M.D.," "D.O.," "D.P.M.," "D.C.," "Healer," "N.P.," or any other title, word,
10671 letter or designation intending to designate or imply that he is a practitioner of the healing arts or that
10672 he is able to heal, cure or relieve those suffering from any injury, deformity or disease.

10673 Signing a birth or death certificate, or signing any statement certifying that the person so signing has
10674 rendered professional service to the sick or injured, or signing or issuing a prescription for drugs or
10675 other remedial agents, shall be prima facie evidence that the person signing or issuing such writing is
10676 practicing the healing arts within the meaning of this chapter except where persons other than physicians
10677 are required to sign birth certificates.

10678 B. No person regulated under this chapter shall use the title "Doctor" or the abbreviation "Dr." in
10679 writing or in advertising in connection with his practice unless he simultaneously uses words, initials, an
10680 abbreviation or designation, or other language that identifies the type of practice for which he is
10681 licensed. No person regulated under this chapter shall include in any advertisement a reference to
10682 marijuana, as defined in § ~~48.2-247~~ 54.1-3401, unless such advertisement is for the treatment of
10683 addiction or substance abuse. However, nothing in this subsection shall prevent a person from including
10684 in any advertisement that such person is registered with the Board of Pharmacy to issue written
10685 certifications for the use of cannabis products, as defined in § 54.1-3408.3.

10686 **§ 54.1-3401. Definitions.**

10687 As used in this chapter, unless the context requires a different meaning:

10688 "Administer" means the direct application of a controlled substance, whether by injection, inhalation,
10689 ingestion, or any other means, to the body of a patient or research subject by (i) a practitioner or by his
10690 authorized agent and under his direction or (ii) the patient or research subject at the direction and in the
10691 presence of the practitioner.

10692 "Advertisement" means all representations disseminated in any manner or by any means, other than
10693 by labeling, for the purpose of inducing, or which are likely to induce, directly or indirectly, the
10694 purchase of drugs or devices.

10695 "Agent" means an authorized person who acts on behalf of or at the direction of a manufacturer,
10696 distributor, or dispenser. It does not include a common or contract carrier, public warehouseman, or
10697 employee of the carrier or warehouseman.

10698 "Anabolic steroid" means any drug or hormonal substance, chemically and pharmacologically related
10699 to testosterone, other than estrogens, progestins, corticosteroids, and dehydroepiandrosterone.

10700 "Animal" means any nonhuman animate being endowed with the power of voluntary action.

10701 "Automated drug dispensing system" means a mechanical or electronic system that performs
 10702 operations or activities, other than compounding or administration, relating to pharmacy services,
 10703 including the storage, dispensing, or distribution of drugs and the collection, control, and maintenance of
 10704 all transaction information, to provide security and accountability for such drugs.

10705 "Biological product" means a virus, therapeutic serum, toxin, antitoxin, vaccine, blood, blood
 10706 component or derivative, allergenic product, protein other than a chemically synthesized polypeptide, or
 10707 analogous product, or arsphenamine or any derivative of arsphenamine or any other trivalent organic
 10708 arsenic compound, applicable to the prevention, treatment, or cure of a disease or condition of human
 10709 beings.

10710 "Biosimilar" means a biological product that is highly similar to a specific reference biological
 10711 product, notwithstanding minor differences in clinically inactive compounds, such that there are no
 10712 clinically meaningful differences between the reference biological product and the biological product that
 10713 has been licensed as a biosimilar pursuant to 42 U.S.C. § 262(k) in terms of safety, purity, and potency
 10714 of the product.

10715 "Board" means the Board of Pharmacy.

10716 "Bulk drug substance" means any substance that is represented for use, and that, when used in the
 10717 compounding, manufacturing, processing, or packaging of a drug, becomes an active ingredient or a
 10718 finished dosage form of the drug; however, "bulk drug substance" shall not include intermediates that
 10719 are used in the synthesis of such substances.

10720 "Change of ownership" of an existing entity permitted, registered, or licensed by the Board means (i)
 10721 the sale or transfer of all or substantially all of the assets of the entity or of any corporation that owns
 10722 or controls the entity; (ii) the creation of a partnership by a sole proprietor, the dissolution of a
 10723 partnership, or change in partnership composition; (iii) the acquisition or disposal of 50 percent or more
 10724 of the outstanding shares of voting stock of a corporation owning the entity or of the parent corporation
 10725 of a wholly owned subsidiary owning the entity, except that this shall not apply to any corporation the
 10726 voting stock of which is actively traded on any securities exchange or in any over-the-counter market;
 10727 (iv) the merger of a corporation owning the entity or of the parent corporation of a wholly-owned
 10728 subsidiary owning the entity with another business or corporation; or (v) the expiration or forfeiture of a
 10729 corporation's charter.

10730 "Co-licensed partner" means a person who, with at least one other person, has the right to engage in
 10731 the manufacturing or marketing of a prescription drug, consistent with state and federal law.

10732 "Compounding" means the combining of two or more ingredients to fabricate such ingredients into a
 10733 single preparation and includes the mixing, assembling, packaging, or labeling of a drug or device (i) by
 10734 a pharmacist, or within a permitted pharmacy, pursuant to a valid prescription issued for a medicinal or
 10735 therapeutic purpose in the context of a bona fide practitioner-patient-pharmacist relationship, or in
 10736 expectation of receiving a valid prescription based on observed historical patterns of prescribing and
 10737 dispensing; (ii) by a practitioner of medicine, osteopathy, podiatry, dentistry, or veterinary medicine as
 10738 an incident to his administering or dispensing, if authorized to dispense, a controlled substance in the
 10739 course of his professional practice; or (iii) for the purpose of, or as incident to, research, teaching, or
 10740 chemical analysis and not for sale or for dispensing. The mixing, diluting, or reconstituting of a
 10741 manufacturer's product drugs for the purpose of administration to a patient, when performed by a
 10742 practitioner of medicine or osteopathy licensed under Chapter 29 (§ 54.1-2900 et seq.), a person
 10743 supervised by such practitioner pursuant to subdivision A 6 or 19 of § 54.1-2901, or a person supervised
 10744 by such practitioner or a licensed nurse practitioner or physician assistant pursuant to subdivision A 4 of
 10745 § 54.1-2901 shall not be considered compounding.

10746 "Controlled substance" means a drug, substance, or immediate precursor in Schedules I through VI of
 10747 this chapter. The term shall not include distilled spirits, wine, malt beverages, or tobacco as those terms
 10748 are defined or used in Title 3.2 or Title 4.1. The term "controlled substance" includes a controlled
 10749 substance analog that has been placed into Schedule I or II by the Board pursuant to the regulatory
 10750 authority in subsection D of § 54.1-3443.

10751 "Controlled substance analog" means a substance the chemical structure of which is substantially
 10752 similar to the chemical structure of a controlled substance in Schedule I or II and either (i) which has a
 10753 stimulant, depressant, or hallucinogenic effect on the central nervous system that is substantially similar
 10754 to or greater than the stimulant, depressant, or hallucinogenic effect on the central nervous system of a
 10755 controlled substance in Schedule I or II or (ii) with respect to a particular person, which such person
 10756 represents or intends to have a stimulant, depressant, or hallucinogenic effect on the central nervous
 10757 system that is substantially similar to or greater than the stimulant, depressant, or hallucinogenic effect
 10758 on the central nervous system of a controlled substance in Schedule I or II. "Controlled substance
 10759 analog" does not include (a) any substance for which there is an approved new drug application as
 10760 defined under § 505 of the federal Food, Drug, and Cosmetic Act (21 U.S.C. § 355) or that is generally

10761 recognized as safe and effective pursuant to §§ 501, 502, and 503 of the federal Food, Drug, and
10762 Cosmetic Act (21 U.S.C. §§ 351, 352, and 353) and 21 C.F.R. Part 330; (b) with respect to a particular
10763 person, any substance for which an exemption is in effect for investigational use for that person under
10764 § 505 of the federal Food, Drug, and Cosmetic Act to the extent that the conduct with respect to that
10765 substance is pursuant to such exemption; or (c) any substance to the extent not intended for human
10766 consumption before such an exemption takes effect with respect to that substance.

10767 "DEA" means the Drug Enforcement Administration, U.S. Department of Justice, or its successor
10768 agency.

10769 "Deliver" or "delivery" means the actual, constructive, or attempted transfer of any item regulated by
10770 this chapter, whether or not there exists an agency relationship, including delivery of a Schedule VI
10771 prescription device to an ultimate user or consumer on behalf of a medical equipment supplier by a
10772 manufacturer, nonresident manufacturer, wholesale distributor, nonresident wholesale distributor,
10773 warehouse, nonresident warehouse, third-party logistics provider, or nonresident third-party logistics
10774 provider at the direction of a medical equipment supplier in accordance with § 54.1-3415.1.

10775 "Device" means instruments, apparatus, and contrivances, including their components, parts, and
10776 accessories, intended for use in the diagnosis, cure, mitigation, treatment, or prevention of disease in
10777 man or animals or to affect the structure or any function of the body of man or animals.

10778 "Dialysis care technician" or "dialysis patient care technician" means an individual who is certified
10779 by an organization approved by the Board of Health Professions pursuant to Chapter 27.01
10780 (§ 54.1-2729.1 et seq.) and who, under the supervision of a licensed physician, nurse practitioner,
10781 physician assistant, or a registered nurse, assists in the care of patients undergoing renal dialysis
10782 treatments in a Medicare-certified renal dialysis facility.

10783 "Dialysis solution" means either the commercially available, unopened, sterile solutions whose
10784 purpose is to be instilled into the peritoneal cavity during the medical procedure known as peritoneal
10785 dialysis, or commercially available solutions whose purpose is to be used in the performance of
10786 hemodialysis not to include any solutions administered to the patient intravenously.

10787 "Dispense" means to deliver a drug to an ultimate user or research subject by or pursuant to the
10788 lawful order of a practitioner, including the prescribing and administering, packaging, labeling, or
10789 compounding necessary to prepare the substance for that delivery. However, dispensing shall not include
10790 the transportation of drugs mixed, diluted, or reconstituted in accordance with this chapter to other sites
10791 operated by such practitioner or that practitioner's medical practice for the purpose of administration of
10792 such drugs to patients of the practitioner or that practitioner's medical practice at such other sites. For
10793 practitioners of medicine or osteopathy, "dispense" shall only include the provision of drugs by a
10794 practitioner to patients to take with them away from the practitioner's place of practice.

10795 "Dispenser" means a practitioner who dispenses.

10796 "Distribute" means to deliver other than by administering or dispensing a controlled substance.

10797 "Distributor" means a person who distributes.

10798 "Drug" means (i) articles or substances recognized in the official United States Pharmacopoeia
10799 National Formulary or official Homeopathic Pharmacopoeia of the United States, or any supplement to
10800 any of them; (ii) articles or substances intended for use in the diagnosis, cure, mitigation, treatment, or
10801 prevention of disease in man or animals; (iii) articles or substances, other than food, intended to affect
10802 the structure or any function of the body of man or animals; (iv) articles or substances intended for use
10803 as a component of any article specified in clause (i), (ii), or (iii); or (v) a biological product. "Drug"
10804 does not include devices or their components, parts, or accessories.

10805 "Drug product" means a specific drug in dosage form from a known source of manufacture, whether
10806 by brand or therapeutically equivalent drug product name.

10807 "Electronic prescription" means a written prescription that is generated on an electronic application
10808 and is transmitted to a pharmacy as an electronic data file; Schedule II through V prescriptions shall be
10809 transmitted in accordance with 21 C.F.R. Part 1300.

10810 "Facsimile (FAX) prescription" means a written prescription or order that is transmitted by an
10811 electronic device over telephone lines that sends the exact image to the receiving pharmacy in hard copy
10812 form.

10813 "FDA" means the U.S. Food and Drug Administration.

10814 "Immediate precursor" means a substance which the Board of Pharmacy has found to be and by
10815 regulation designates as being the principal compound commonly used or produced primarily for use,
10816 and which is an immediate chemical intermediary used or likely to be used in the manufacture of a
10817 controlled substance, the control of which is necessary to prevent, curtail, or limit manufacture.

10818 "Interchangeable" means a biosimilar that meets safety standards for determining interchangeability
10819 pursuant to 42 U.S.C. § 262(k)(4).

10820 "Label" means a display of written, printed, or graphic matter upon the immediate container of any
10821 article. A requirement made by or under authority of this chapter that any word, statement, or other
10822 information appear on the label shall not be considered to be complied with unless such word,

statement, or other information also appears on the outside container or wrapper, if any, of the retail package of such article or is easily legible through the outside container or wrapper.

"Labeling" means all labels and other written, printed, or graphic matter on an article or any of its containers or wrappers, or accompanying such article.

"Manufacture" means the production, preparation, propagation, conversion, or processing of any item regulated by this chapter, either directly or indirectly by extraction from substances of natural origin, or independently by means of chemical synthesis, or by a combination of extraction and chemical synthesis, and includes any packaging or repackaging of the substance or labeling or relabeling of its container. This term does not include compounding.

"Manufacturer" means every person who manufactures, a manufacturer's co-licensed partner, or a repackager.

"Marijuana" means any part of a plant of the genus *Cannabis* whether growing or not, its seeds, or its resin; and every compound, manufacture, salt, derivative, mixture, or preparation of such plant, its seeds, its resin, or any extract containing one or more cannabinoids. Marijuana does not include the mature stalks of such plant, fiber produced from such stalk, or oil or cake made from the seeds of such plant, unless such stalks, fiber, oil, or cake is combined with other parts of plants of the genus *Cannabis*. Marijuana does not include (i) industrial hemp, as defined in § 3.2-4112, that is possessed by a person registered pursuant to subsection A of § 3.2-4115 or his agent, (ii) industrial hemp, as defined in § 3.2-4112, that is possessed by a person who holds a hemp producer license issued by the U.S. Department of Agriculture pursuant to 7 C.F.R. Part 990, or (iii) a hemp product, *other than a regulated hemp product*, as defined in § 3.2-4112, containing a tetrahydrocannabinol concentration of no greater than 0.3 percent that is derived from industrial hemp, as defined in § 3.2-4112, that is grown, dealt, or processed in compliance with state or federal law, *or (iv) a regulated hemp product that does not exceed the maximum tetrahydrocannabinol concentration established pursuant to § 4.1-606 and that is derived from industrial hemp, as defined in § 3.2-4112, that is grown, dealt, or processed in compliance with state or federal law.*

"Medical equipment supplier" means any person, as defined in § 1-230, engaged in the delivery to the ultimate consumer, pursuant to the lawful order of a practitioner, of hypodermic syringes and needles, medicinal oxygen, Schedule VI controlled devices, those Schedule VI controlled substances with no medicinal properties that are used for the operation and cleaning of medical equipment, solutions for peritoneal dialysis, and sterile water or saline for irrigation.

"Narcotic drug" means any of the following, whether produced directly or indirectly by extraction from substances of vegetable origin, or independently by means of chemical synthesis, or by a combination of extraction and chemical synthesis: (i) opium, opiates, and any salt, compound, derivative, or preparation of opium or opiates; (ii) any salt, compound, isomer, derivative, or preparation thereof which is chemically equivalent or identical with any of the substances referred to in clause (i), but not including the isoquinoline alkaloids of opium; (iii) opium poppy and poppy straw; (iv) coca leaves and any salt, compound, derivative, or preparation of coca leaves, and any salt, compound, isomer, derivative, or preparation thereof which is chemically equivalent or identical with any of these substances, but not including decocainized coca leaves or extraction of coca leaves which do not contain cocaine or ecgonine.

"New drug" means (i) any drug, except a new animal drug or an animal feed bearing or containing a new animal drug, the composition of which is such that such drug is not generally recognized, among experts qualified by scientific training and experience to evaluate the safety and effectiveness of drugs, as safe and effective for use under the conditions prescribed, recommended, or suggested in the labeling, except that such a drug not so recognized shall not be deemed to be a "new drug" if at any time prior to the enactment of this chapter it was subject to the Food and Drugs Act of June 30, 1906, as amended, and if at such time its labeling contained the same representations concerning the conditions of its use, or (ii) any drug, except a new animal drug or an animal feed bearing or containing a new animal drug, the composition of which is such that such drug, as a result of investigations to determine its safety and effectiveness for use under such conditions, has become so recognized, but which has not, otherwise than in such investigations, been used to a material extent or for a material time under such conditions.

"Nuclear medicine technologist" means an individual who holds a current certification with the American Registry of Radiological Technologists or the Nuclear Medicine Technology Certification Board.

"Official compendium" means the official United States Pharmacopoeia National Formulary, official Homeopathic Pharmacopoeia of the United States, or any supplement to any of them.

"Official written order" means an order written on a form provided for that purpose by the U.S. Drug Enforcement Administration, under any laws of the United States making provision therefor, if such order forms are authorized and required by federal law, and if no such order form is provided then on

- 10884 an official form provided for that purpose by the Board of Pharmacy.
- 10885 "Opiate" means any substance having an addiction-forming or addiction-sustaining liability similar to
- 10886 morphine or being capable of conversion into a drug having such addiction-forming or
- 10887 addiction-sustaining liability. It does not include, unless specifically designated as controlled under
- 10888 Article 4 (§ 54.1-3437 et seq.), the dextrorotatory isomer of 3-methoxy-n-methylmorphinan and its salts
- 10889 (dextromethorphan). It does include its racemic and levorotatory forms.
- 10890 "Opium poppy" means the plant of the species *Papaver somniferum* L., except the seeds thereof.
- 10891 "Original package" means the unbroken container or wrapping in which any drug or medicine is
- 10892 enclosed together with label and labeling, put up by or for the manufacturer, wholesaler, or distributor
- 10893 for use in the delivery or display of such article.
- 10894 "Outsourcing facility" means a facility that is engaged in the compounding of sterile drugs and is
- 10895 currently registered as an outsourcing facility with the U.S. Secretary of Health and Human Services and
- 10896 that complies with all applicable requirements of federal and state law, including the Federal Food,
- 10897 Drug, and Cosmetic Act.
- 10898 "Person" means both the plural and singular, as the case demands, and includes an individual,
- 10899 partnership, corporation, association, governmental agency, trust, or other institution or entity.
- 10900 "Pharmacist-in-charge" means the person who, being licensed as a pharmacist, signs the application
- 10901 for a pharmacy permit and assumes full legal responsibility for the operation of the relevant pharmacy in
- 10902 a manner complying with the laws and regulations for the practice of pharmacy and the sale and
- 10903 dispensing of controlled substances; the "pharmacist-in-charge" shall personally supervise the pharmacy
- 10904 and the pharmacy's personnel as required by § 54.1-3432.
- 10905 "Poppy straw" means all parts, except the seeds, of the opium poppy, after mowing.
- 10906 "Practitioner" means a physician, dentist, licensed nurse practitioner pursuant to § 54.1-2957.01,
- 10907 licensed physician assistant pursuant to § 54.1-2952.1, pharmacist pursuant to § 54.1-3300, TPA-certified
- 10908 optometrist pursuant to Article 5 (§ 54.1-3222 et seq.) of Chapter 32, veterinarian, scientific investigator,
- 10909 or other person licensed, registered, or otherwise permitted to distribute, dispense, prescribe and
- 10910 administer, or conduct research with respect to a controlled substance in the course of professional
- 10911 practice or research in the Commonwealth.
- 10912 "Prescriber" means a practitioner who is authorized pursuant to §§ 54.1-3303 and 54.1-3408 to issue
- 10913 a prescription.
- 10914 "Prescription" means an order for drugs or medical supplies, written or signed or transmitted by word
- 10915 of mouth, telephone, telegraph, or other means of communication to a pharmacist by a duly licensed
- 10916 physician, dentist, veterinarian, or other practitioner authorized by law to prescribe and administer such
- 10917 drugs or medical supplies.
- 10918 "Prescription drug" means any drug required by federal law or regulation to be dispensed only
- 10919 pursuant to a prescription, including finished dosage forms and active ingredients subject to § 503(b) of
- 10920 the Federal Food, Drug, and Cosmetic Act (21 U.S.C. § 353(b)).
- 10921 "Production" or "produce" includes the manufacture, planting, cultivation, growing, or harvesting of a
- 10922 controlled substance or marijuana.
- 10923 "Proprietary medicine" means a completely compounded nonprescription drug in its unbroken,
- 10924 original package which does not contain any controlled substance or marijuana as defined in this chapter
- 10925 and is not in itself poisonous, and which is sold, offered, promoted, or advertised directly to the general
- 10926 public by or under the authority of the manufacturer or primary distributor, under a trademark, trade
- 10927 name, or other trade symbol privately owned, and the labeling of which conforms to the requirements of
- 10928 this chapter and applicable federal law. However, this definition shall not include a drug that is only
- 10929 advertised or promoted professionally to licensed practitioners, a narcotic or drug containing a narcotic,
- 10930 a drug that may be dispensed only upon prescription or the label of which bears substantially the
- 10931 statement "Warning — may be habit-forming," or a drug intended for injection.
- 10932 "Radiopharmaceutical" means any drug that exhibits spontaneous disintegration of unstable nuclei
- 10933 with the emission of nuclear particles or photons and includes any non-radioactive reagent kit or
- 10934 radionuclide generator that is intended to be used in the preparation of any such substance, but does not
- 10935 include drugs such as carbon-containing compounds or potassium-containing salts that include trace
- 10936 quantities of naturally occurring radionuclides. The term also includes any biological product that is
- 10937 labeled with a radionuclide or intended solely to be labeled with a radionuclide.
- 10938 "Reference biological product" means the single biological product licensed pursuant to 42 U.S.C.
- 10939 § 262(a) against which a biological product is evaluated in an application submitted to the U.S. Food
- 10940 and Drug Administration for licensure of biological products as biosimilar or interchangeable pursuant to
- 10941 42 U.S.C. § 262(k).
- 10942 "Sale" includes barter, exchange, or gift, or offer therefor, and each such transaction made by any
- 10943 person, whether as an individual, proprietor, agent, servant, or employee.
- 10944 "Therapeutically equivalent drug products" means drug products that contain the same active
- 10945 ingredients and are identical in strength or concentration, dosage form, and route of administration and

that are classified as being therapeutically equivalent by the U.S. Food and Drug Administration pursuant to the definition of "therapeutically equivalent drug products" set forth in the most recent edition of the Approved Drug Products with Therapeutic Equivalence Evaluations, otherwise known as the "Orange Book."

"Third-party logistics provider" means a person that provides or coordinates warehousing of or other logistics services for a drug or device in interstate commerce on behalf of a manufacturer, wholesale distributor, or dispenser of the drug or device but does not take ownership of the product or have responsibility for directing the sale or disposition of the product.

"USP-NF" means the current edition of the United States Pharmacopeia-National Formulary.

"Warehouser" means any person, other than a wholesale distributor, manufacturer, or third-party logistics provider, engaged in the business of (i) selling or otherwise distributing prescription drugs or devices to any person who is not the ultimate user or consumer and (ii) delivering Schedule VI prescription devices to the ultimate user or consumer pursuant to § 54.1-3415.1. No person shall be subject to any state or local tax by reason of this definition.

"Wholesale distribution" means (i) distribution of prescription drugs to persons other than consumers or patients and (ii) delivery of Schedule VI prescription devices to the ultimate user or consumer pursuant to § 54.1-3415.1, subject to the exemptions set forth in the federal Drug Supply Chain Security Act.

"Wholesale distributor" means any person other than a manufacturer, a manufacturer's co-licensed partner, a third-party logistics provider, or a repackager that engages in wholesale distribution.

The words "drugs" and "devices" as used in Chapter 33 (§ 54.1-3300 et seq.) and in this chapter shall not include surgical or dental instruments, physical therapy equipment, X-ray apparatus, or glasses or lenses for the eyes.

The terms "pharmacist," "pharmacy," and "practice of pharmacy" as used in this chapter shall be defined as provided in Chapter 33 (§ 54.1-3300 et seq.) unless the context requires a different meaning.

§ 54.1-3408.3. Certification for use of cannabis oil for treatment.

A. As used in this section:

"Botanical cannabis" means cannabis that is composed wholly of usable cannabis from the same parts of the same chemovar of cannabis plant.

"Cannabis oil" means any formulation of processed Cannabis plant extract, which may include ~~oil~~ ~~from~~ industrial hemp extract acquired by a pharmaceutical processor pursuant to § 54.1-3442.6, or a dilution of the resin of the Cannabis plant that contains at least five milligrams of cannabidiol (CBD) or tetrahydrocannabinolic acid (THC-A) and no more than 10 milligrams of delta-9-tetrahydrocannabinol per dose. "Cannabis oil" does not include industrial hemp, as defined in § 3.2-4112, that is grown, dealt, or processed in compliance with state or federal law, unless it has been acquired and formulated with cannabis plant extract by a pharmaceutical processor.

"Cannabis product" means a product that is (i) produced by a pharmaceutical processor, registered with the Board, and compliant with testing requirements and (ii) composed of cannabis oil or botanical cannabis.

"Designated caregiver facility" means any hospice or hospice facility licensed pursuant to § 32.1-162.3, or home care organization as defined in § 32.1-162.7 that provides pharmaceutical services or home health services, private provider licensed by the Department of Behavioral Health and Developmental Services pursuant to Article 2 (§ 37.2-403 et seq.) of Chapter 4 of Title 37.2, assisted living facility licensed pursuant to § 63.2-1701, or adult day care center licensed pursuant to § 63.2-1701.

"Practitioner" means a practitioner of medicine or osteopathy licensed by the Board of Medicine, a physician assistant licensed by the Board of Medicine, or a nurse practitioner jointly licensed by the Board of Medicine and the Board of Nursing.

"Registered agent" means an individual designated by a patient who has been issued a written certification, or, if such patient is a minor or an incapacitated adult as defined in § 18.2-369, designated by such patient's parent or legal guardian, and registered with the Board pursuant to subsection G.

"Usable cannabis" means any cannabis plant material, including seeds, but not (i) resin that has been extracted from any part of the cannabis plant, its seeds, or its resin; (ii) the mature stalks, fiber produced from the stalks, or any other compound, manufacture, salt, or derivative, mixture, or preparation of the mature stalks; or (iii) oil or cake made from the seeds of the plant.

B. A practitioner in the course of his professional practice may issue a written certification for the use of cannabis products for treatment or to alleviate the symptoms of any diagnosed condition or disease determined by the practitioner to benefit from such use. The practitioner shall use his professional judgment to determine the manner and frequency of patient care and evaluation and may employ the use of telemedicine, provided that the use of telemedicine includes the delivery of patient care through real-time interactive audio-visual technology. If a practitioner determines it is consistent

11007 with the standard of care to dispense botanical cannabis to a minor, the written certification shall
11008 specifically authorize such dispensing. If not specifically included on the initial written certification,
11009 authorization for botanical cannabis may be communicated verbally or in writing to the pharmacist at
11010 the time of dispensing.

11011 C. The written certification shall be on a form provided by the Office of the Executive Secretary of
11012 the Supreme Court developed in consultation with the Board of Medicine. Such written certification
11013 shall contain the name, address, and telephone number of the practitioner, the name and address of the
11014 patient issued the written certification, the date on which the written certification was made, and the
11015 signature or authentic electronic signature of the practitioner. Such written certification issued pursuant
11016 to subsection B shall expire no later than one year after its issuance unless the practitioner provides in
11017 such written certification an earlier expiration.

11018 D. No practitioner shall be prosecuted under *Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or*
11019 *§ 18.2-248 or 18.2-248.1* for the issuance of a certification for the use of cannabis products for the
11020 treatment or to alleviate the symptoms of a patient's diagnosed condition or disease pursuant to a written
11021 certification issued pursuant to subsection B. Nothing in this section shall preclude the Board of
11022 Medicine from sanctioning a practitioner for failing to properly evaluate or treat a patient's medical
11023 condition or otherwise violating the applicable standard of care for evaluating or treating medical
11024 conditions.

11025 E. A practitioner who issues a written certification to a patient pursuant to this section shall register
11026 with the Board and shall hold sufficient education and training to exercise appropriate professional
11027 judgment in the certification of patients. The Board shall not limit the number of patients to whom a
11028 practitioner may issue a written certification. The Board may report information to the applicable
11029 licensing board on unusual patterns of certifications issued by a practitioner.

11030 F. A patient who has been issued a written certification shall register with the Board or, if such
11031 patient is a minor or an incapacitated adult as defined in § 18.2-369, a patient's parent or legal guardian
11032 shall register and shall register such patient with the Board. No patient shall be required to physically
11033 present the written certification after the initial dispensing by any pharmaceutical processor or cannabis
11034 dispensing facility under each written certification, provided that the pharmaceutical processor or
11035 cannabis dispensing facility maintains an electronic copy of the written certification.

11036 G. A patient, or, if such patient is a minor or an incapacitated adult as defined in § 18.2-369, such
11037 patient's parent or legal guardian, may designate an individual to act as his registered agent for the
11038 purposes of receiving cannabis products pursuant to a valid written certification. Such designated
11039 individual shall register with the Board. The Board may set a limit on the number of patients for whom
11040 any individual is authorized to act as a registered agent.

11041 H. Upon delivery of cannabis oil by a pharmaceutical processor or cannabis dispensing facility to a
11042 designated caregiver facility, any employee or contractor of a designated caregiver facility, who is
11043 licensed or registered by a health regulatory board and who is authorized to possess, distribute, or
11044 administer medications, may accept delivery of the cannabis oil on behalf of a patient or resident for
11045 subsequent delivery to the patient or resident and may assist in the administration of the cannabis oil to
11046 the patient or resident as necessary.

11047 I. The Board shall promulgate regulations to implement the registration process. Such regulations
11048 shall include (i) a mechanism for sufficiently identifying the practitioner issuing the written certification,
11049 the patient being treated by the practitioner, his registered agent, and, if such patient is a minor or an
11050 incapacitated adult as defined in § 18.2-369, the patient's parent or legal guardian; (ii) a process for
11051 ensuring that any changes in the information are reported in an appropriate timeframe; and (iii) a
11052 prohibition for the patient to be issued a written certification by more than one practitioner during any
11053 given time period.

11054 J. Information obtained under the registration process shall be confidential and shall not be subject to
11055 the disclosure provisions of the Virginia Freedom of Information Act (§ 2.2-3700 et seq.). However,
11056 reasonable access to registry information shall be provided to (i) the Chairmen of the House Committee
11057 for Courts of Justice and the Senate Committee on the Judiciary, (ii) state and federal agencies or local
11058 law enforcement for the purpose of investigating or prosecuting a specific individual for a specific
11059 violation of law, (iii) licensed practitioners or pharmacists, or their agents, for the purpose of providing
11060 patient care and drug therapy management and monitoring of drugs obtained by a registered patient, (iv)
11061 a pharmaceutical processor or cannabis dispensing facility involved in the treatment of a registered
11062 patient, or (v) a registered patient, his registered agent, or, if such patient is a minor or an incapacitated
11063 adult as defined in § 18.2-369, the patient's parent or legal guardian, but only with respect to
11064 information related to such registered patient.

11065 **§ 54.1-3442.8. Criminal liability; exceptions.**

11066 No agent or employee of a pharmaceutical processor or cannabis dispensing facility shall be
11067 prosecuted under Chapter 11 (§ 4.1-1100 et seq.) of Title 4.1 or § 18.2-248, ~~18.2-248.1~~, or 18.2-250 for
11068 possession or manufacture of marijuana or for possession, manufacture, or distribution of cannabis

11069 products, subject to any civil penalty, denied any right or privilege, or subject to any disciplinary action
 11070 by a professional licensing board if such agent or employee (i) possessed or manufactured such
 11071 marijuana for the purposes of producing cannabis products in accordance with the provisions of this
 11072 article and Board regulations or (ii) possessed, manufactured, or distributed such cannabis products that
 11073 are consistent with generally accepted cannabis industry standards in accordance with the provisions of
 11074 this article and Board regulations.

11554 **§ 58.1-3. Secrecy of information; penalties.**
11555 A. Except in accordance with a proper judicial order or as otherwise provided by law, the Tax
11556 Commissioner or agent, clerk, commissioner of the revenue, treasurer, or any other state or local tax or
11557 revenue officer or employee, or any person to whom tax information is divulged pursuant to this section
11558 or § 58.1-512 or 58.1-2712.2, or any former officer or employee of any of the aforementioned offices
11559 shall not divulge any information acquired by him in the performance of his duties with respect to the
11560 transactions, property, including personal property, income or business of any person, firm or

corporation. Such prohibition specifically includes any copy of a federal return or federal return information required by Virginia law to be attached to or included in the Virginia return. This prohibition shall apply to any reports, returns, financial documents or other information filed with the Attorney General pursuant to the provisions of Article 3 (§ 3.2-4204 et seq.) of Chapter 42 of Title 3.2. Any person violating the provisions of this section is guilty of a Class 1 misdemeanor. The provisions of this subsection shall not be applicable, however, to:

1. Matters required by law to be entered on any public assessment roll or book;

2. Acts performed or words spoken, published, or shared with another agency or subdivision of the Commonwealth in the line of duty under state law;

3. Inquiries and investigations to obtain information as to the process of real estate assessments by a duly constituted committee of the General Assembly, or when such inquiry or investigation is relevant to its study, provided that any such information obtained shall be privileged;

4. The sales price, date of construction, physical dimensions or characteristics of real property, or any information required for building permits;

5. Copies of or information contained in an estate's probate tax return, filed with the clerk of court pursuant to § 58.1-1714, when requested by a beneficiary of the estate or an heir at law of the decedent or by the commissioner of accounts making a settlement of accounts filed in such estate;

6. Information regarding nonprofit entities exempt from sales and use tax under § 58.1-609.11, when requested by the General Assembly or any duly constituted committee of the General Assembly;

7. Reports or information filed with the Attorney General by a Stamping Agent pursuant to the provisions of Article 3 (§ 3.2-4204 et seq.), when such reports or information are provided by the Attorney General to a tobacco products manufacturer who is required to establish a qualified escrow fund pursuant to § 3.2-4201 and are limited to the brand families of that manufacturer as listed in the Tobacco Directory established pursuant to § 3.2-4206 and are limited to the current or previous two calendar years or in any year in which the Attorney General receives Stamping Agent information that potentially alters the required escrow deposit of the manufacturer. The information shall only be provided in the following manner: the manufacturer may make a written request, on a quarterly or yearly basis or when the manufacturer is notified by the Attorney General of a potential change in the amount of a required escrow deposit, to the Attorney General for a list of the Stamping Agents who reported stamping or selling its products and the amount reported. The Attorney General shall provide the list within 15 days of receipt of the request. If the manufacturer wishes to obtain actual copies of the reports the Stamping Agents filed with the Attorney General, it must first request them from the Stamping Agents pursuant to subsection C of § 3.2-4209. If the manufacturer does not receive the reports pursuant to subsection C of § 3.2-4209, the manufacturer may make a written request to the Attorney General, including a copy of the prior written request to the Stamping Agent and any response received, for copies of any reports not received. The Attorney General shall provide copies of the reports within 45 days of receipt of the request.

B. 1. Nothing contained in this section shall be construed to prohibit the publication of statistics so classified as to prevent the identification of particular reports or returns and the items thereof or the publication of delinquent lists showing the names of taxpayers who are currently delinquent, together with any relevant information which in the opinion of the Department may assist in the collection of such delinquent taxes. Notwithstanding any other provision of this section or other law, the Department, upon request by the General Assembly or any duly constituted committee of the General Assembly, shall disclose the total aggregate amount of an income tax deduction or credit taken by all taxpayers, regardless of (i) how few taxpayers took the deduction or credit or (ii) any other circumstances. This section shall not be construed to prohibit a local tax official from disclosing whether a person, firm or corporation is licensed to do business in that locality and divulging, upon written request, the name and address of any person, firm or corporation transacting business under a fictitious name. Additionally, notwithstanding any other provision of law, the commissioner of revenue is authorized to provide, upon written request stating the reason for such request, the Tax Commissioner with information obtained from local tax returns and other information pertaining to the income, sales and property of any person, firm or corporation licensed to do business in that locality.

2. This section shall not prohibit the Department from disclosing whether a person, firm, or corporation is registered as a retail sales and use tax dealer pursuant to Chapter 6 (§ 58.1-600 et seq.) or whether a certificate of registration number relating to such tax is valid. Additionally, notwithstanding any other provision of law, the Department is hereby authorized to make available the names and certificate of registration numbers of dealers who are currently registered for retail sales and use tax.

3. This section shall not prohibit the Department from disclosing information to nongovernmental entities with which the Department has entered into a contract to provide services that assist it in the administration of refund processing or other services related to its administration of taxes.

4. This section shall not prohibit the Department from disclosing information to taxpayers regarding

11622 whether the taxpayer's employer or another person or entity required to withhold on behalf of such

11625 5. This section shall not prohibit the commissioner of the revenue, treasurer, director of finance, or
11626 other similar local official who collects or administers taxes for a county, city, or town from disclosing
11627 information to nongovernmental entities with which the locality has entered into a contract to provide
11628 services that assist it in the administration of refund processing or other non-audit services related to its
11629 administration of taxes. The commissioner of the revenue, treasurer, director of finance, or other similar
11630 local official who collects or administers taxes for a county, city, or town shall not disclose information
11631 to such entity unless he has obtained a written acknowledgement by such entity that the confidentiality
11632 and nondisclosure obligations of and penalties set forth in subsection A apply to such entity and that
11633 such entity agrees to abide by such obligations.

11634 C. Notwithstanding the provisions of subsection A or B or any other provision of this title, the Tax
11635 Commissioner is authorized to (i) divulge tax information to any commissioner of the revenue, director
11636 of finance, or other similar collector of county, city, or town taxes who, for the performance of his
11637 official duties, requests the same in writing setting forth the reasons for such request; (ii) provide to the
11638 Commissioner of the Department of Social Services, upon entering into a written agreement, the amount
11639 of income, filing status, number and type of dependents, whether a federal earned income tax credit as
11640 authorized in § 32 of the Internal Revenue Code and an income tax credit for low-income taxpayers as
11641 authorized in § 58.1-339.8 have been claimed, and Forms W-2 and 1099 to facilitate the administration
11642 of public assistance or social services benefits as defined in § 63.2-100 or child support services
11643 pursuant to Chapter 19 (§ 63.2-1900 et seq.) of Title 63.2, or as may be necessary to facilitate the
11644 administration of outreach and enrollment related to the federal earned income tax credit authorized in
11645 § 32 of the Internal Revenue Code and the income tax credit for low-income taxpayers authorized in
11646 § 58.1-339.8; (iii) provide to the chief executive officer of the designated student loan guarantor for the
11647 Commonwealth of Virginia, upon written request, the names and home addresses of those persons
11648 identified by the designated guarantor as having delinquent loans guaranteed by the designated
11649 guarantor; (iv) provide current address information upon request to state agencies and institutions for
11650 their confidential use in facilitating the collection of accounts receivable, and to the clerk of a circuit or
11651 district court for their confidential use in facilitating the collection of fines, penalties, and costs imposed
11652 in a proceeding in that court; (v) provide to the Commissioner of the Virginia Employment Commission,
11653 after entering into a written agreement, such tax information as may be necessary to facilitate the
11654 collection of unemployment taxes and overpaid benefits; (vi) provide to the Virginia Alcoholic Beverage
11655 Control Authority *or the Virginia Cannabis Control Authority*, upon entering into a written agreement,
11656 such tax information as may be necessary to facilitate the collection of state and local taxes and the
11657 administration of the alcoholic beverage *or cannabis* control laws; (vii) provide to the Director of the
11658 Virginia Lottery such tax information as may be necessary to identify those lottery ticket retailers who
11659 owe delinquent taxes; (viii) provide to the Department of the Treasury for its confidential use such tax
11660 information as may be necessary to facilitate the location of owners and holders of unclaimed property,
11661 as defined in § 55.1-2500; (ix) provide to the State Corporation Commission, upon entering into a
11662 written agreement, such tax information as may be necessary to facilitate the collection of taxes and fees
11663 administered by the Commission; (x) provide to the Executive Director of the Potomac and
11664 Rappahannock Transportation Commission for his confidential use such tax information as may be
11665 necessary to facilitate the collection of the motor vehicle fuel sales tax; (xi) provide to the
11666 Commissioner of the Department of Agriculture and Consumer Services such tax information as may be
11667 necessary to identify those applicants for registration as a supplier of charitable gaming supplies who
11668 have not filed required returns or who owe delinquent taxes; (xii) provide to the Department of Housing
11669 and Community Development for its confidential use such tax information as may be necessary to
11670 facilitate the administration of the remaining effective provisions of the Enterprise Zone Act (§ 59.1-270
11671 et seq.), and the Enterprise Zone Grant Program (§ 59.1-538 et seq.); (xiii) provide current name and
11672 address information to private collectors entering into a written agreement with the Tax Commissioner,
11673 for their confidential use when acting on behalf of the Commonwealth or any of its political
11674 subdivisions; however, the Tax Commissioner is not authorized to provide such information to a private
11675 collector who has used or disseminated in an unauthorized or prohibited manner any such information
11676 previously provided to such collector; (xiv) provide current name and address information as to the
11677 identity of the wholesale or retail dealer that affixed a tax stamp to a package of cigarettes to any
11678 person who manufactures or sells at retail or wholesale cigarettes and who may bring an action for
11679 injunction or other equitable relief for violation of Chapter 10.1, Enforcement of Illegal Sale or
11680 Distribution of Cigarettes Act; (xv) provide to the Commissioner of Labor and Industry, upon entering
11681 into a written agreement, such tax information as may be necessary to facilitate the collection of unpaid
11682 wages under § 40.1-29; (xvi) provide to the Director of the Department of Human Resource
11683 Management, upon entering into a written agreement, such tax information as may be necessary to

11684 identify persons receiving workers' compensation indemnity benefits who have failed to report earnings
 11685 as required by § 65.2-712; (xvii) provide to any commissioner of the revenue, director of finance, or any
 11686 other officer of any county, city, or town performing any or all of the duties of a commissioner of the
 11687 revenue and to any dealer registered for the collection of the Communications Sales and Use Tax, a list
 11688 of the names, business addresses, and dates of registration of all dealers registered for such tax; (xviii)
 11689 provide to the Executive Director of the Northern Virginia Transportation Commission for his
 11690 confidential use such tax information as may be necessary to facilitate the collection of the motor
 11691 vehicle fuel sales tax; (xix) provide to the Commissioner of Agriculture and Consumer Services the
 11692 name and address of the taxpayer businesses licensed by the Commonwealth that identify themselves as
 11693 subject to regulation by the Board of Agriculture and Consumer Services pursuant to § 3.2-5130; (xx)
 11694 provide to the developer or the economic development authority of a tourism project authorized by
 11695 § 58.1-3851.1, upon entering into a written agreement, tax information facilitating the repayment of gap
 11696 financing; (xxi) provide to the Virginia Retirement System and the Department of Human Resource
 11697 Management, after entering into a written agreement, such tax information as may be necessary to
 11698 facilitate the enforcement of subdivision C 4 of § 9.1-401; (xxii) provide to the Department of Medical
 11699 Assistance Services and the Department of Social Services, upon entering into a written agreement, the
 11700 name, address, social security number, email address, dependent information provided pursuant to
 11701 subdivision B 2 of § 58.1-341.1, number and type of personal exemptions, tax-filing status, adjusted
 11702 gross income, and any additional information voluntarily provided by the taxpayer for disclosure
 11703 pursuant to subdivisions B 1 and 2 of § 58.1-341.1, of an individual, or spouse in the case of a married
 11704 taxpayer filing jointly, who has voluntarily consented to such disclosure for purposes of identifying
 11705 persons who would like to newly enroll in medical assistance; (xxiii) provide to the Commissioner of
 11706 the Department of Motor Vehicles information sufficient to verify that an applicant for a driver privilege
 11707 card or permit under § 46.2-328.3 or an applicant for an identification privilege card under § 46.2-345.3
 11708 reported income and deductions from Virginia sources, as defined in § 58.1-302, or was claimed as a
 11709 dependent, on an individual income tax return filed with the Commonwealth within the preceding 12
 11710 months; and (xxiv) provide to the Virginia Health Benefit Exchange, upon entering into a written
 11711 agreement, for taxable years starting on January 1, 2023, or as soon thereafter as practicable, as
 11712 determined by the Department of Taxation and the Virginia Health Benefit Exchange, the name, address,
 11713 social security number, email address, dependent information provided pursuant to subdivision B 2 of
 11714 § 58.1-341.1, number and type of personal exemptions, tax-filing status, adjusted gross income, and any
 11715 additional information voluntarily provided by the taxpayer for disclosure pursuant to subdivision B 3 of
 11716 § 58.1-341.1, of an individual, or spouse in the case of a married taxpayer filing jointly, who has
 11717 voluntarily consented to such disclosure for purposes of identifying persons who do not meet the income
 11718 eligibility requirements for medical assistance and would like to newly enroll in a qualified health plan.
 11719 The Tax Commissioner is further authorized to enter into written agreements with duly constituted tax
 11720 officials of other states and of the United States for the inspection of tax returns, the making of audits,
 11721 and the exchange of information relating to any tax administered by the Department of Taxation. Any
 11722 person to whom tax information is divulged pursuant to this section shall be subject to the prohibitions
 11723 and penalties prescribed herein as though he were a tax official.

11724 D. Notwithstanding the provisions of subsection A or B or any other provision of this title, the
 11725 commissioner of revenue or other assessing official is authorized to (i) provide, upon written request
 11726 stating the reason for such request, the chief executive officer of any county or city with information
 11727 furnished to the commissioner of revenue by the Tax Commissioner relating to the name and address of
 11728 any dealer located within the county or city who paid sales and use tax, for the purpose of verifying the
 11729 local sales and use tax revenues payable to the county or city; (ii) provide to the Department of
 11730 Professional and Occupational Regulation for its confidential use the name, address, and amount of gross
 11731 receipts of any person, firm or entity subject to a criminal investigation of an unlawful practice of a
 11732 profession or occupation administered by the Department of Professional and Occupational Regulation,
 11733 only after the Department of Professional and Occupational Regulation exhausts all other means of
 11734 obtaining such information; and (iii) provide to any representative of a condominium unit owners'
 11735 association, property owners' association or real estate cooperative association, or to the owner of
 11736 property governed by any such association, the names and addresses of parties having a security interest
 11737 in real property governed by any such association; however, such information shall be released only
 11738 upon written request stating the reason for such request, which reason shall be limited to proposing or
 11739 opposing changes to the governing documents of the association, and any information received by any
 11740 person under this subsection shall be used only for the reason stated in the written request. The treasurer
 11741 or other local assessing official may require any person requesting information pursuant to clause (iii) of
 11742 this subsection to pay the reasonable cost of providing such information. Any person to whom tax
 11743 information is divulged pursuant to this subsection shall be subject to the prohibitions and penalties
 11744 prescribed herein as though he were a tax official.

11745 Notwithstanding the provisions of subsection A or B or any other provisions of this title, the
11746 treasurer or other collector of taxes for a county, city or town is authorized to provide information
11747 relating to any motor vehicle, trailer or semitrailer obtained by such treasurer or collector in the course
11748 of performing his duties to the commissioner of the revenue or other assessing official for such
11749 jurisdiction for use by such commissioner or other official in performing assessments.

11750 This section shall not be construed to prohibit a local tax official from imprinting or displaying on a
11751 motor vehicle local license decal the year, make, and model and any other legal identification
11752 information about the particular motor vehicle for which that local license decal is assigned.

11753 E. Notwithstanding any other provisions of law, state agencies and any other administrative or
11754 regulatory unit of state government shall divulge to the Tax Commissioner or his authorized agent, upon
11755 written request, the name, address, and social security number of a taxpayer, necessary for the
11756 performance of the Commissioner's official duties regarding the administration and enforcement of laws
11757 within the jurisdiction of the Department of Taxation. The receipt of information by the Tax
11758 Commissioner or his agent that may be deemed taxpayer information shall not relieve the Commissioner
11759 of the obligations under this section.

11760 F. Additionally, it is unlawful for any person to disseminate, publish, or cause to be published any
11761 confidential tax document that he knows or has reason to know is a confidential tax document. A
11762 confidential tax document is any correspondence, document, or tax return that is prohibited from being
11763 divulged by subsection A, B, C, or D and includes any document containing information on the
11764 transactions, property, income, or business of any person, firm, or corporation that is required to be filed
11765 with any state official by § 58.1-512. This prohibition shall not apply if such confidential tax document
11766 has been divulged or disseminated pursuant to a provision of law authorizing disclosure. Any person
11767 violating the provisions of this subsection is guilty of a Class 1 misdemeanor.

11768 **§ 59.1-148.3. Purchase of handguns or other weapons of certain officers.**

11769 A. The Department of State Police, the Department of Wildlife Resources, the Virginia Alcoholic
11770 Beverage Control Authority, *the Virginia Cannabis Control Authority*, the Virginia Lottery, the Marine
11771 Resources Commission, the Capitol Police, the Department of Conservation and Recreation, the
11772 Department of Forestry, any sheriff, any regional jail board or authority, and any local police department
11773 may allow any full-time sworn law-enforcement officer, deputy, or regional jail officer, a local fire
11774 department may allow any full-time sworn fire marshal, the Department of Motor Vehicles may allow
11775 any law-enforcement officer, any institution of higher learning named in § 23.1-1100 may allow any
11776 campus police officer appointed pursuant to Article 3 (§ 23.1-809 et seq.) of Chapter 8 of Title 23.1,
11777 retiring on or after July 1, 1991, and the Department of Corrections may allow any employee with
11778 internal investigations authority designated by the Department of Corrections pursuant to subdivision 11
11779 of § 53.1-10 who retires (i) after at least 10 years of service, (ii) at 70 years of age or older, or (iii) as a
11780 result of a service-incurred disability or who is receiving long-term disability payments for a
11781 service-incurred disability with no expectation of returning to the employment where he incurred the
11782 disability to purchase the service handgun issued or previously issued to him by the agency or institution
11783 at a price of \$1. If the previously issued weapon is no longer available, a weapon of like kind may be
11784 substituted for that weapon. This privilege shall also extend to any former Superintendent of the
11785 Department of State Police who leaves service after a minimum of five years. This privilege shall also
11786 extend to any person listed in this subsection who is eligible for retirement with at least 10 years of
11787 service who resigns on or after July 1, 1991, in good standing from one of the agencies listed in this
11788 section to accept a position covered by the Virginia Retirement System. Other weapons issued by the
11789 agencies listed in this subsection for personal duty use of an officer may, with approval of the agency
11790 head, be sold to the officer subject to the qualifications of this section at a fair market price determined
11791 as in subsection B, so long as the weapon is a type and configuration that can be purchased at a regular
11792 hardware or sporting goods store by a private citizen without restrictions other than the instant
11793 background check.

11794 B. The agencies listed in subsection A may allow any full-time sworn law-enforcement officer who
11795 retires with five or more years of service, but less than 10, to purchase the service handgun issued to
11796 him by the agency at a price equivalent to the weapon's fair market value on the date of the officer's
11797 retirement. Any full-time sworn law-enforcement officer employed by any of the agencies listed in
11798 subsection A who is retired for disability as a result of a nonservice-incurred disability may purchase the
11799 service handgun issued to him by the agency at a price equivalent to the weapon's fair market value on
11800 the date of the officer's retirement. Determinations of fair market value may be made by reference to a
11801 recognized pricing guide.

11802 C. The agencies listed in subsection A may allow the immediate survivor of any full-time sworn
11803 law-enforcement officer (i) who is killed in the line of duty or (ii) who dies in service and has at least
11804 10 years of service to purchase the service handgun issued to the officer by the agency at a price of \$1.

11805 D. The governing board of any institution of higher learning education named in § 23.1-1100 may
11806 allow any campus police officer appointed pursuant to Article 3 (§ 23.1-809 et seq.) of Chapter 8 of

Title 23.1 who retires on or after July 1, 1991, to purchase the service handgun issued to him at a price equivalent to the weapon's fair market value on the date of the officer's retirement. Determinations of fair market value may be made by reference to a recognized pricing guide.

E. Any officer who at the time of his retirement is a full-time sworn law-enforcement officer with a state agency listed in subsection A, when the agency allows purchases of service handguns, and who retires after 10 years of state service, even if a portion of his service was with another state agency, may purchase the service handgun issued to him by the agency from which he retires at a price of \$1.

F. The sheriff of Hanover County may allow any auxiliary or volunteer deputy sheriff with a minimum of 10 years of service, upon leaving office, to purchase for \$1 the service handgun issued to him.

G. Any sheriff or local police department may allow any auxiliary law-enforcement officer with more than 10 years of service to purchase the service handgun issued to him by the agency at a price that is equivalent to or less than the weapon's fair market value on the date of purchase by the officer.

H. The agencies listed in subsection A may allow any full-time sworn law-enforcement officer currently employed by the agency to purchase his service handgun, with the approval of the chief law-enforcement officer of the agency, at a fair market price. This subsection shall only apply when the agency has purchased new service handguns for its officers, and the handgun subject to the sale is no longer used by the agency or officer in the course of duty.

§ 65.2-107. Post-traumatic stress disorder incurred by law-enforcement officers and firefighters.

A. As used in this section:

"Firefighter" means any (i) salaried firefighter, including special forest wardens designated pursuant to § 10.1-1135, emergency medical services personnel, and local or state fire scene investigator and (ii) volunteer firefighter and volunteer emergency medical services personnel.

"In the line of duty" means any action that a law-enforcement officer or firefighter was obligated or authorized to perform by rule, regulation, written condition of employment service, or law.

"Law-enforcement officer" means any (i) member of the State Police Officers' Retirement System; (ii) member of a county, city, or town police department; (iii) sheriff or deputy sheriff; (iv) Department of Emergency Management hazardous materials officer; (v) city sergeant or deputy city sergeant of the City of Richmond; (vi) Virginia Marine Police officer; (vii) conservation police officer who is a full-time sworn member of the enforcement division of the Department of Wildlife Resources; (viii) Capitol Police officer; (ix) special agent of the Virginia Alcoholic Beverage Control Authority appointed under the provisions of Chapter 1 (§ 4.1-100 et seq.) of Title 4.1 or *special agent of the Virginia Cannabis Control Authority appointed under the provisions of Chapter 6 (§ 4.1-600 et seq.) of Title 4.1*; (x) for such period that the Metropolitan Washington Airports Authority voluntarily subjects itself to the provisions of this chapter as provided in § 65.2-305, officer of the police force established and maintained by the Metropolitan Washington Airports Authority; (xi) officer of the police force established and maintained by the Norfolk Airport Authority; (xii) sworn officer of the police force established and maintained by the Virginia Port Authority; or (xiii) campus police officer appointed under Article 3 (§ 23.1-809 et seq.) of Chapter 8 of Title 23.1 and employed by any public institution of higher education.

"Mental health professional" means a board-certified psychiatrist or a psychologist licensed pursuant to Title 54.1 who has experience diagnosing and treating post-traumatic stress disorder.

"Post-traumatic stress disorder" means a disorder that meets the diagnostic criteria for post-traumatic stress disorder as specified in the most recent edition of the American Psychiatric Association's Diagnostic and Statistical Manual of Mental Disorders.

"Qualifying event" means an incident or exposure occurring in the line of duty on or after July 1, 2020:

1. Resulting in serious bodily injury or death to any person or persons;
2. Involving a minor who has been injured, killed, abused, or exploited;
3. Involving an immediate threat to life of the claimant or another individual;
4. Involving mass casualties; or
5. Responding to crime scenes for investigation.

B. Post-traumatic stress disorder incurred by a law-enforcement officer or firefighter is compensable under this title if:

1. A mental health professional examines a law-enforcement officer or firefighter and diagnoses the law-enforcement officer or firefighter as suffering from post-traumatic stress disorder as a result of the individual's undergoing a qualifying event;
2. The post-traumatic stress disorder resulted from the law-enforcement officer's or firefighter's acting in the line of duty and, in the case of a firefighter, such firefighter complied with federal Occupational Safety and Health Act standards adopted pursuant to 29 C.F.R. 1910.134 and 29 C.F.R. 1910.156;
3. The law-enforcement officer's or firefighter's undergoing a qualifying event was a substantial

11868 factor in causing his post-traumatic stress disorder;

11869 4. Such qualifying event, and not another event or source of stress, was the primary cause of the
11870 post-traumatic stress disorder; and

11871 5. The post-traumatic stress disorder did not result from any disciplinary action, work evaluation, job
11872 transfer, layoff, demotion, promotion, termination, retirement, or similar action of the law-enforcement
11873 officer or firefighter.

11874 Any such mental health professional shall comply with any workers' compensation guidelines for
11875 approved medical providers, including guidelines on release of past or contemporaneous medical records.

11876 C. Notwithstanding any provision of this title, workers' compensation benefits for any
11877 law-enforcement officer or firefighter payable pursuant to this section shall (i) include any combination
11878 of medical treatment prescribed by a board-certified psychiatrist or a licensed psychologist, temporary
11879 total incapacity benefits under § 65.2-500, and temporary partial incapacity benefits under § 65.2-502
11880 and (ii) be provided for a maximum of 52 weeks from the date of diagnosis. No medical treatment,
11881 temporary total incapacity benefits under § 65.2-500, or temporary partial incapacity benefits under
11882 § 65.2-502 shall be awarded beyond four years from the date of the qualifying event that formed the
11883 basis for the claim for benefits under this section. The weekly benefits received by a law-enforcement
11884 officer or a firefighter pursuant to § 65.2-500 or 65.2-502, when combined with other benefits, including
11885 contributory and noncontributory retirement benefits, Social Security benefits, and benefits under a
11886 long-term or short-term disability plan, but not including payments for medical care, shall not exceed the
11887 average weekly wage paid to such law-enforcement officer or firefighter.

11888 D. No later than January 1, 2021, each employer of law-enforcement officers or firefighters shall (i)
11889 make peer support available to such law-enforcement officers and firefighters and (ii) refer a
11890 law-enforcement officer or firefighter seeking mental health care services to a mental health professional.

11891 E. Each fire basic training program conducted or administered by the Department of Fire Programs
11892 or a municipal fire department in the Commonwealth shall provide, in consultation with the Department
11893 of Behavioral Health and Developmental Services, resilience and self-care technique training for any
11894 individual who begins basic training as a firefighter on or after July 1, 2021.

11895 **§ 65.2-402. Presumption as to death or disability from respiratory disease, hypertension or**
11896 **heart disease, cancer.**

11897 A. Respiratory diseases that cause (i) the death of volunteer or salaried firefighters or Department of
11898 Emergency Management hazardous materials officers or (ii) any health condition or impairment of such
11899 firefighters or Department of Emergency Management hazardous materials officers resulting in total or
11900 partial disability shall be presumed to be occupational diseases, suffered in the line of duty, that are
11901 covered by this title unless such presumption is overcome by a preponderance of competent evidence to
11902 the contrary.

11903 B. Hypertension or heart disease causing the death of, or any health condition or impairment
11904 resulting in total or partial disability of any of the following persons who have completed five years of
11905 service in their position as (i) salaried or volunteer firefighters, (ii) members of the State Police Officers'
11906 Retirement System, (iii) members of county, city or town police departments, (iv) sheriffs and deputy
11907 sheriffs, (v) Department of Emergency Management hazardous materials officers, (vi) city sergeants or
11908 deputy city sergeants of the City of Richmond, (vii) Virginia Marine Police officers, (viii) conservation
11909 police officers who are full-time sworn members of the enforcement division of the Department of
11910 Wildlife Resources, (ix) Capitol Police officers, (x) special agents of the Virginia Alcoholic Beverage
11911 Control Authority appointed under the provisions of Chapter 1 (§ 4.1-100 et seq.) of Title 4.1 or *special*
11912 *agents of the Virginia Cannabis Control Authority appointed under the provisions of Chapter 6*
11913 *(§ 4.1-600 et seq.) of Title 4.1*, (xi) for such period that the Metropolitan Washington Airports Authority
11914 voluntarily subjects itself to the provisions of this chapter as provided in § 65.2-305, officers of the
11915 police force established and maintained by the Metropolitan Washington Airports Authority, (xii)
11916 officers of the police force established and maintained by the Norfolk Airport Authority, (xiii) sworn
11917 officers of the police force established and maintained by the Virginia Port Authority, (xiv) campus
11918 police officers appointed under Article 3 (§ 23.1-809 et seq.) of Chapter 8 of Title 23.1 and employed
11919 by any public institution of higher education, and (xv) salaried or volunteer emergency medical services
11920 personnel, as defined in § 32.1-111.1, when such emergency medical services personnel is operating in a
11921 locality that has legally adopted a resolution declaring that it will provide one or more of the
11922 presumptions under this subsection, shall be presumed to be occupational diseases, suffered in the line of
11923 duty, that are covered by this title unless such presumption is overcome by a preponderance of
11924 competent evidence to the contrary.

11925 C. Leukemia or pancreatic, prostate, rectal, throat, ovarian, breast, colon, brain, or testicular cancer
11926 causing the death of, or any health condition or impairment resulting in total or partial disability of, any
11927 volunteer or salaried firefighter, Department of Emergency Management hazardous materials officer,
11928 commercial vehicle enforcement officer or motor carrier safety trooper employed by the Department of
11929 State Police, or full-time sworn member of the enforcement division of the Department of Motor

Vehicles having completed five years of service shall be presumed to be an occupational disease, suffered in the line of duty, that is covered by this title, unless such presumption is overcome by a preponderance of competent evidence to the contrary. For colon, brain, or testicular cancer, the presumption shall not apply for any individual who was diagnosed with such a condition before July 1, 2020.

D. The presumptions described in subsections A, B, and C shall only apply if persons entitled to invoke them have, if requested by the private employer, appointing authority or governing body employing them, undergone preemployment physical examinations that (i) were conducted prior to the making of any claims under this title that rely on such presumptions, (ii) were performed by physicians whose qualifications are as prescribed by the private employer, appointing authority or governing body employing such persons, (iii) included such appropriate laboratory and other diagnostic studies as the private employer, appointing authorities or governing bodies may have prescribed, and (iv) found such persons free of respiratory diseases, hypertension, cancer or heart disease at the time of such examinations.

E. Persons making claims under this title who rely on such presumptions shall, upon the request of private employers, appointing authorities or governing bodies employing such persons, submit to physical examinations (i) conducted by physicians selected by such employers, authorities, bodies or their representatives and (ii) consisting of such tests and studies as may reasonably be required by such physicians. However, a qualified physician, selected and compensated by the claimant, may, at the election of such claimant, be present at such examination.

F. Whenever a claim for death benefits is made under this title and the presumptions of this section are invoked, any person entitled to make such claim shall, upon the request of the appropriate private employer, appointing authority or governing body that had employed the deceased, submit the body of the deceased to a postmortem examination as may be directed by the Commission. A qualified physician, selected and compensated by the person entitled to make the claim, may, at the election of such claimant, be present at such postmortem examination.

G. Volunteer law-enforcement chaplains, auxiliary and reserve deputy sheriffs, and auxiliary and reserve police are not included within the coverage of this section.

H. For purposes of this section, "firefighter" includes special forest wardens designated pursuant to § 10.1-1135 and any persons who are employed by or contract with private employers primarily to perform firefighting services.

§ 65.2-402.1. Presumption as to death or disability from infectious disease.

A. Hepatitis, meningococcal meningitis, tuberculosis or HIV causing the death of, or any health condition or impairment resulting in total or partial disability of, any (i) salaried or volunteer firefighter, or salaried or volunteer emergency medical services personnel; (ii) member of the State Police Officers' Retirement System; (iii) member of county, city, or town police departments; (iv) sheriff or deputy sheriff; (v) Department of Emergency Management hazardous materials officer; (vi) city sergeant or deputy city sergeant of the City of Richmond; (vii) Virginia Marine Police officer; (viii) conservation police officer who is a full-time sworn member of the enforcement division of the Department of Wildlife Resources; (ix) Capitol Police officer; (x) special agent of the Virginia Alcoholic Beverage Control Authority appointed under the provisions of Chapter 1 (§ 4.1-100 et seq.) of Title 4.1 or *special agent of the Virginia Cannabis Control Authority appointed under the provisions of Chapter 6 (§ 4.1-600 et seq.) of Title 4.1*; (xi) for such period that the Metropolitan Washington Airports Authority voluntarily subjects itself to the provisions of this chapter as provided in § 65.2-305, officer of the police force established and maintained by the Metropolitan Washington Airports Authority; (xii) officer of the police force established and maintained by the Norfolk Airport Authority; (xiii) conservation officer of the Department of Conservation and Recreation commissioned pursuant to § 10.1-115; (xiv) sworn officer of the police force established and maintained by the Virginia Port Authority; (xv) campus police officer appointed under Article 3 (§ 23.1-809 et seq.) of Chapter 8 of Title 23.1 and employed by any public institution of higher education; (xvi) correctional officer as defined in § 53.1-1; or (xvii) full-time sworn member of the enforcement division of the Department of Motor Vehicles who has a documented occupational exposure to blood or body fluids shall be presumed to be occupational diseases, suffered in the line of government duty, that are covered by this title unless such presumption is overcome by a preponderance of competent evidence to the contrary. For purposes of this subsection, an occupational exposure occurring on or after July 1, 2002, shall be deemed "documented" if the person covered under this subsection gave notice, written or otherwise, of the occupational exposure to his employer, and an occupational exposure occurring prior to July 1, 2002, shall be deemed "documented" without regard to whether the person gave notice, written or otherwise, of the occupational exposure to his employer. For any correctional officer as defined in § 53.1-1 or full-time sworn member of the enforcement division of the Department of Motor Vehicles, the presumption shall not apply if such individual was diagnosed with hepatitis, meningococcal meningitis, or HIV before July

11991 1, 2020.

11992 B. 1. COVID-19 causing the death of, or any health condition or impairment resulting in total or
11993 partial disability of, any health care provider, as defined in § 8.01-581.1, who as part of the provider's
11994 employment is directly involved in diagnosing or treating persons known or suspected to have
11995 COVID-19, shall be presumed to be an occupational disease that is covered by this title unless such
11996 presumptions are overcome by a preponderance of competent evidence to the contrary. For the purposes
11997 of this section, the COVID-19 virus shall be established by a positive diagnostic test for COVID-19 and
11998 signs and symptoms of COVID-19 that require medical treatment, as described in ~~subsection~~ *subdivision*
11999 F 2.

12000 2. COVID-19 causing the death of, or any health condition or impairment resulting in total or partial
12001 disability of, any (i) firefighter, as defined in § 65.2-102; (ii) law-enforcement officer, as defined in
12002 § 9.1-101; (iii) correctional officer, as defined in § 53.1-1; or (iv) regional jail officer shall be presumed
12003 to be an occupational disease, suffered in the line of duty, as applicable, that is covered by this title
12004 unless such presumption is overcome by a preponderance of competent evidence to the contrary. For the
12005 purposes of this section, the COVID-19 virus shall be established by a positive diagnostic test for
12006 COVID-19, an incubation period consistent with COVID-19, and signs and symptoms of COVID-19 that
12007 require medical treatment.

12008 C. As used in this section:

12009 "Blood or body fluids" means blood and body fluids containing visible blood and other body fluids
12010 to which universal precautions for prevention of occupational transmission of blood-borne pathogens, as
12011 established by the Centers for Disease Control *and Prevention*, apply. For purposes of potential
12012 transmission of hepatitis, meningococcal meningitis, tuberculosis, or HIV the term "blood or body
12013 fluids" includes respiratory, salivary, and sinus fluids, including droplets, sputum, saliva, mucous, and
12014 any other fluid through which infectious airborne or blood-borne organisms can be transmitted between
12015 persons.

12016 "Hepatitis" means hepatitis A, hepatitis B, hepatitis non-A, hepatitis non-B, hepatitis C, or any other
12017 strain of hepatitis generally recognized by the medical community.

12018 "HIV" means the medically recognized retrovirus known as human immunodeficiency virus, type I or
12019 type II, causing immunodeficiency syndrome.

12020 "Occupational exposure," in the case of hepatitis, meningococcal meningitis, tuberculosis or HIV,
12021 means an exposure that occurs during the performance of job duties that places a covered employee at
12022 risk of infection.

12023 D. Persons covered under this section who test positive for exposure to the enumerated occupational
12024 diseases, but have not yet incurred the requisite total or partial disability, shall otherwise be entitled to
12025 make a claim for medical benefits pursuant to § 65.2-603, including entitlement to an annual medical
12026 examination to measure the progress of the condition, if any, and any other medical treatment,
12027 prophylactic or otherwise.

12028 E. 1. Whenever any standard, medically-recognized vaccine or other form of immunization or
12029 prophylaxis exists for the prevention of a communicable disease for which a presumption is established
12030 under this section, if medically indicated by the given circumstances pursuant to immunization policies
12031 established by the Advisory Committee on Immunization Practices of the United States Public Health
12032 Service, a person subject to the provisions of this section may be required by such person's employer to
12033 undergo the immunization or prophylaxis unless the person's physician determines in writing that the
12034 immunization or prophylaxis would pose a significant risk to the person's health. Absent such written
12035 declaration, failure or refusal by a person subject to the provisions of this section to undergo such
12036 immunization or prophylaxis shall disqualify the person from any presumption established by this
12037 section.

12038 2. The presumptions described in ~~subsection~~ *subdivision* B 1 shall not apply to any person offered by
12039 such person's employer a vaccine for the prevention of COVID-19 with an Emergency Use
12040 Authorization issued by the U.S. Food and Drug Administration, unless the person is immunized or the
12041 person's physician determines in writing that the immunization would pose a significant risk to the
12042 person's health. Absent such written declaration, failure or refusal by a person subject to the provisions
12043 of this section to undergo such immunization shall disqualify the person from the presumptions
12044 described in ~~subsection~~ *subdivision* B 1.

12045 F. 1. The presumptions described in subsection A shall only apply if persons entitled to invoke them
12046 have, if requested by the appointing authority or governing body employing them, undergone
12047 preemployment physical examinations that (i) were conducted prior to the making of any claims under
12048 this title that rely on such presumptions; (ii) were performed by physicians whose qualifications are as
12049 prescribed by the appointing authority or governing body employing such persons; (iii) included such
12050 appropriate laboratory and other diagnostic studies as the appointing authorities or governing bodies may
12051 have prescribed; and (iv) found such persons free of hepatitis, meningococcal meningitis, tuberculosis or
12052 HIV at the time of such examinations. The presumptions described in subsection A shall not be effective

until six months following such examinations, unless such persons entitled to invoke such presumption can demonstrate a documented exposure during the six-month period.

2. The presumptions described in ~~subsection~~ *subdivision B 1* shall apply to any person entitled to invoke them for any death or disability occurring on or after March 12, 2020, caused by infection from the COVID-19 virus, provided that for any such death or disability that occurred on or after March 12, 2020, and prior to December 31, 2021, and;

a. Prior to July 1, 2020, the claimant received a positive diagnosis of COVID-19 from a licensed physician, nurse practitioner, or physician assistant after either (i) a presumptive positive test or a laboratory-confirmed test for COVID-19 and presenting with signs and symptoms of COVID-19 that required medical treatment, or (ii) presenting with signs and symptoms of COVID-19 that required medical treatment absent a presumptive positive test or a laboratory-confirmed test for COVID-19; or

b. On or after July 1, 2020, and prior to December 31, 2021, the claimant received a positive diagnosis of COVID-19 from a licensed physician, nurse practitioner, or physician assistant after a presumptive positive test or a laboratory-confirmed test for COVID-19 and presented with signs and symptoms of COVID-19 that required medical treatment.

3. The presumptions described in subdivision B 2 shall apply to any person entitled to invoke them for any death or disability occurring on or after July 1, 2020, caused by infection from the COVID-19 virus, provided that for any such death or disability that occurred on or after July 1, 2020, and prior to December 31, 2021, the claimant received a diagnosis of COVID-19 from a licensed physician, after either a presumptive positive test or a laboratory confirmed test for COVID-19, and presented with signs and symptoms of COVID-19 that required medical treatment.

G. Persons making claims under this title who rely on such presumption shall, upon the request of appointing authorities or governing bodies employing such persons, submit to physical examinations (i) conducted by physicians selected by such appointing authorities or governing bodies or their representatives and (ii) consisting of such tests and studies as may reasonably be required by such physicians. However, a qualified physician, selected and compensated by the claimant, may, at the election of such claimant, be present at such examination.

2. That Article 5 (§§ 3.2-5145.1 through 3.2-5145.5) of Chapter 51 of Title 3.2 and §§ 4.1-1101.1, 4.1-1105.1, 18.2-248.1, and 18.2-251.1 of the Code of Virginia are repealed.

3. That the sixteenth enactment of Chapter 550 and the sixteenth enactment of Chapter 551 of the Acts of Assembly of 2021, Special Session I, are repealed.

4. That, except as provided in the fifth, sixth, seventh, eighth, ninth, tenth, and eleventh enactments of this act, the provisions of this act shall become effective on January 1, 2024.

5. That the provisions of §§ 2.2-2499.8, 4.1-603, 4.1-629, as created by this act, 4.1-1100, 4.1-1101, 4.1-1105.1, as amended in the first enactment, 4.1-1107, 4.1-1108, and 4.1-1121 of the Code of Virginia; subdivisions B 13, 14, and 16 and subsection C of § 4.1-606 of the Code of Virginia; the seventh enactment of this act; and the repeal of the sixteenth enactment of Chapter 550 and the sixteenth enactment of Chapter 551 of the Acts of Assembly of 2021, Special Session I, shall become effective in due course.

6. That, subject to the provisions of the eighth enactment of this act, the provisions of § 4.1-630 and Chapter 7 (§ 4.1-700 et seq.), Chapter 8 (§ 4.1-800 et seq.), Chapter 9 (§ 4.1-900 et seq.), Chapter 10 (§ 4.1-1000 et seq.), Chapter 12 (§ 4.1-1200 et seq.), and Chapter 14 (§ 4.1-1400 et seq.) of Title 4.1 of the Code of Virginia, as created by this act, shall become effective on January 1, 2023.

7. That the tenth and twenty-third enactments of Chapter 550 and the tenth and twenty-third enactments of Chapter 551 of the Acts of Assembly of 2021, Special Session I, are amended as follows:

10. That the Board of Directors of the Virginia Cannabis Control Authority (the Board) shall promulgate regulations to implement the provisions of this act by ~~July~~ *January* 1, 2023; however, the Board shall not adopt such regulations prior to July 1, 2022, and shall present such regulations to the Cannabis Oversight Commission for review prior to adoption. With the exception of § 2.2-4031 of the Code of Virginia, neither the provisions of the Administrative Process Act (§ 2.2-4000 et seq. of the Code of Virginia) nor public participation guidelines adopted pursuant thereto shall apply to the initial adoption of any regulations pursuant to this act. Prior to adopting any regulations pursuant to this act, the Board shall publish a notice of opportunity to comment in the Virginia Register of Regulations and post the action on the Virginia Regulatory Town Hall. Such notice of opportunity to comment shall contain (i) a summary of the proposed regulations; (ii) the text of the proposed regulations; and (iii) the name, address, and telephone number of the agency contact person responsible for receiving public comments. Such notice shall be made at least 60 days in advance of the last date prescribed in such notice for submittals of public comment. The legislative review provisions of subsections A and B of § 2.2-4014 of the Code

12114 of Virginia shall apply to the promulgation or final adoption process for regulations pursuant to
12115 this act. The Board shall consider and keep on file all public comments received for any
12116 regulations adopted pursuant to this act. The provisions of this enactment shall become effective in
12117 due course.

12118 23. That the initial referendum authorized by § 4.1-629 of the Code of Virginia, as created by
12119 this act, on the question of whether the operation of ~~retail~~ marijuana stores *establishments* shall be
12120 prohibited in a particular locality shall be held and results certified by December 31, 2022. A
12121 referendum on such question shall not be permitted in a locality after January 1, 2023, unless such
12122 referendum follows a referendum held prior to December 31, 2022, and any subsequent
12123 referendum, in which a majority of the qualified voters voting in such referendum voted "Yes" to
12124 prohibit the operation of ~~retail~~ marijuana stores *establishments*. The provisions of this enactment
12125 shall become effective July 1, 2022.

12126 8. That the Virginia Cannabis Control Authority (the Authority) may start accepting applications
12127 for licenses pursuant to the provision of § 4.1-1000 of the Code of Virginia, as created by this act,
12128 on January 1, 2023, and shall, from January 1, 2023, until January 1, 2024, give preference to
12129 qualified social equity applicants, as determined by regulations promulgated by the Board of
12130 Directors of the Authority in accordance with this act. The Authority may issue any license
12131 authorized by this act to any applicant that meets the requirements for licensure established by
12132 this act. Notwithstanding the fourth enactment of this act, any applicant issued a license by the
12133 Authority may operate in accordance with the provisions of this act prior to January 1, 2024;
12134 however, prior to January 1, 2024, (i) no retail marijuana store licensee may sell retail marijuana,
12135 retail marijuana products, immature marijuana plants, or marijuana seeds and (ii) no marijuana
12136 cultivation facility licensee may sell immature marijuana plants or marijuana seeds to a consumer.
12137 Notwithstanding any other provision of law, on or after January 1, 2023, and prior to January 1,
12138 2024, no marijuana cultivation facility licensee, marijuana manufacturing facility licensee,
12139 marijuana wholesaler licensee, retail marijuana store licensee, or marijuana testing facility licensee
12140 or agent or employee thereof shall be subject to arrest or prosecution for a violation of Chapter 11
12141 (§ 4.1-1100 et seq.) of Title 4.1 of the Code of Virginia, § 18.2-248, 18.2-248.01, 18.2-255,
12142 18.2-255.1, 18.2-255.2, 18.2-258, 18.2-258.02, 18.2-265.3, or 18.2-308.4 of the Code of Virginia, as
12143 amended by this act, or § 18.2-248.1 of the Code of Virginia, as repealed by this act, involving
12144 marijuana if such violation is related to acts committed within the scope of the licensure or
12145 employment and in accordance with the provisions of the Cannabis Control Act (§ 4.1-600 et seq.
12146 of the Code of Virginia). From January 1, 2023, to January 1, 2028, the Authority shall (a) reserve
12147 a license slot for a qualified social equity applicant for very license that was initially granted to a
12148 social equity applicant and was subsequently surrendered and (b) reserve license slots for all
12149 pharmaceutical processors that have been issued a permit by the Board of Pharmacy pursuant to
12150 Article 4.2 (§ 54.1-3442.5 et seq. of the Code of Virginia) of the Drug Control Act and issue a
12151 cultivation, manufacturing, wholesale, and retail license to any such pharmaceutical processor that
12152 meets the applicable licensing requirements. The Authority shall ensure that geographic dispersion
12153 is achieved regarding the issuance of retail marijuana store licenses and shall reassess the issuance
12154 of retail marijuana store licenses at the following intervals to ensure that geographic dispersion is
12155 maintained: after issuance of 100 licenses, 200 licenses, and 300 licenses. The provisions of this
12156 enactment shall become effective in due course.

12157 9. That the repeal of Article 5 (§§ 3.2-5145.1 through 3.2-5145.5) of Chapter 51 of Title 3.2 of the
12158 Code of Virginia shall become effective on the earlier of (i) the promulgation by the Board of
12159 Directors of the Virginia Cannabis Control Authority of final regulations governing regulated
12160 hemp products pursuant to § 4.1-606 of the Code of Virginia, as amended by this act, or (ii) July
12161 1, 2023. Any regulation promulgated by the Department of Agriculture and Consumer Services
12162 pursuant to Article 5 of Chapter 51 of Title 3.2 of the Code of Virginia, as repealed by this act,
12163 shall remain in full force and effect and continue to be administered by the Department of
12164 Agriculture and Consumer Services until the effective date of the repeal of Article 5 of Chapter 51
12165 of Title 3.2 of the Code of Virginia.

12166 10. That the provisions of §§ 19.2-392.2:3 and 19.2-392.2:4 of the Code of Virginia, as created by
12167 this act, shall become effective on the earlier of (i) the first day of the fourth month following
12168 notification to the Chairman of the Virginia Code Commission and the Chairmen of the Senate
12169 Committee on the Judiciary and the House Committee for Courts of Justice by the Superintendent
12170 of State Police that the Executive Secretary of the Supreme Court of Virginia, the Department of
12171 State Police, and any circuit court clerk who maintains a case management system that interfaces
12172 with the Department of State Police under subsection B of § 17.1-502 of the Code of Virginia have
12173 automated systems to exchange information or (ii) July 1, 2025. The Executive Secretary of the
12174 Supreme Court of Virginia, the Department of State Police, and any circuit court clerk who
12175 maintains a case management system that interfaces with the Department of State Police under

12176 subsection B of § 17.1-502 of the Code of Virginia, shall automate systems to exchange information
12177 as required by § 19.2-392.2:3 of the Code of Virginia, as created by this act, no later than July 1,
12178 2025.

12179 11. That on or before September 1, 2022, pursuant to subsection A of § 19.2-303.03 of the Code of
12180 Virginia, as created by this act, the Department of Corrections, sheriff of a local jail, regional
12181 director of a regional jail, and the Department of Juvenile Justice, respectively, shall determine
12182 which individuals currently incarcerated in such state correctional facility, local correctional
12183 facility, or secure facility, or placed on community supervision, respectively, meet the criteria for a
12184 hearing on the modification of their sentence as set forth in subsection A of § 19.2-303.03 of the
12185 Code of Virginia, as created by this act, and shall (i) provide an electronic list of such individuals
12186 to the clerk of each circuit court in the jurisdiction where the individual was sentenced and (ii)
12187 notify all such individuals that they may be eligible for modification of their sentence, that a
12188 hearing will be scheduled for such determination, that they may file a petition for assistance of
12189 counsel and a statement of indigency, and that if they were determined to be indigent at their
12190 original sentencing, they shall be entitled to assistance of counsel for the hearing on modification
12191 of their sentence without the filing of such petition. Within 60 days of receiving the electronic list,
12192 the clerk of each circuit court shall notify the chief judge of that circuit court who shall
12193 subsequently set a hearing for each eligible individual within the timeframes required pursuant to
12194 subsection A of § 19.2-303.03 of the Code of Virginia, as created by this act, to determine whether
12195 to modify such individual's sentence. The provisions of this enactment and the provisions of this
12196 act creating § 19.2-303.03 and amending § 53.1-165.1 of the Code of Virginia shall become effective
12197 in due course and shall expire on July 1, 2025.

12198 12. That the provisions of this act may result in a net increase in periods of imprisonment or
12199 commitment. Pursuant to § 30-19.1:4 of the Code of Virginia, the estimated amount of the
12200 necessary appropriation cannot be determined for periods of imprisonment in state adult
12201 correctional facilities; therefore, Chapter 552 of the Acts of Assembly of 2021, Special Session I,
12202 requires the Virginia Criminal Sentencing Commission to assign a minimum fiscal impact of
12203 \$50,000. Pursuant to § 30-19.1:4 of the Code of Virginia, the estimated amount of the necessary
12204 appropriation cannot be determined for periods of commitment to the custody of the Department
12205 of Juvenile Justice.
