6	A BILL to amend and reenact § 65.2-107 of the Code of Virginia, relating to workers' compensation;
7 8	post-traumatic stress disorder, anxiety disorder, or depressive disorder; law-enforcement officers and firefighters.
9	Be it enacted by the General Assembly of Virginia:
10	1. That § 65.2-107 of the Code of Virginia is amended and reenacted as follows:
11	§ 65.2-107. Post-traumatic stress disorder, anxiety disorder, or depressive disorder incurred by
12	law-enforcement officers and firefighters.
13	A. As used in this section:
14	"Anxiety disorder" means a disorder that meets the diagnostic criteria for one or more of the anxiety
15	disorders specified in the most recent edition of the Diagnostic and Statistical Manual of Mental
16	Disorders published by the American Psychiatric Association.
17 18	"Depressive disorder" means a disorder that meets the diagnostic criteria for one or more of the depressive disorders specified in the most recent edition of the Diagnostic and Statistical Manual of
19	Mental Disorders published by the American Psychiatric Association.
20	"Firefighter" means any (i) salaried firefighter, including special forest wardens designated pursuant
21	to § 10.1-1135, emergency medical services personnel, and local or state fire scene investigator and (ii)
22	volunteer firefighter and volunteer emergency medical services personnel.
23	"In the line of duty" means any action that a law-enforcement officer or firefighter was obligated or
24	authorized to perform by rule, regulation, written condition of employment service, or law.
25	"Law-enforcement officer" means any (i) member of the State Police Officers' Retirement System;
26 27	(ii) member of a county, city, or town police department; (iii) sheriff or deputy sheriff; (iv) Department of Emergency Management hazardous materials officer; (v) city sergeant or deputy city sergeant of the
28	City of Richmond; (vi) Virginia Marine Police officer; (vii) conservation police officer who is a
29	full-time sworn member of the enforcement division of the Department of Wildlife Resources; (viii)
30	Capitol Police officer; (ix) special agent of the Virginia Alcoholic Beverage Control Authority appointed
31	under the provisions of Chapter 1 (§ 4.1-100 et seq.) of Title 4.1; (x) for such period that the
32	Metropolitan Washington Airports Authority voluntarily subjects itself to the provisions of this chapter
33 34	as provided in § 65.2-305, officer of the police force established and maintained by the Metropolitan
34 35	Washington Airports Authority; (xi) officer of the police force established and maintained by the Norfolk Airport Authority; (xii) sworn officer of the police force established and maintained by the
36	Virginia Port Authority; or (xiii) campus police officer appointed under Article 3 (§ 23.1-809 et seq.) of
37	Chapter 8 of Title 23.1 and employed by any public institution of higher education.
38	"Mental health professional" means a board-certified psychiatrist or a psychologist licensed pursuant
39	to Title 54.1 who has experience diagnosing and treating post-traumatic stress disorder.
40	"Post-traumatic stress disorder" means a disorder that meets the diagnostic criteria for post-traumatic
41 42	stress disorder as specified in the most recent edition of the American Psychiatric Association's Diagnostic and Statistical Manual of Mental Disorders <i>published by the American Psychiatric</i>
43	Association.
44	"Qualifying event" means an incident or exposure occurring in the line of duty on or after July 1,
45	2020, for post-traumatic stress disorder and for purposes of subdivisions one through four of this
46	definition, on or after July 1, 2023, for anxiety disorder or depressive disorder:
47	1. Resulting in serious bodily injury or death to any person or persons;
48 40	2. Involving a minor who has been injured, killed, abused, or exploited;
49 50	 Involving an immediate threat to life of the claimant or another individual; Involving mass casualties; or
51	5. Responding to crime scenes for investigation.
52	B. Post-traumatic stress disorder, anxiety disorder, or depressive disorder incurred by a
53	law-enforcement officer or firefighter is compensable under this title if:
54	1. A mental health professional examines a law-enforcement officer or firefighter and diagnoses the
55 54	law-enforcement officer or firefighter as suffering from post-traumatic stress disorder, anxiety disorder,
56 57	<i>or depressive disorder</i> as a result of the individual's undergoing a qualifying event; 2. The post-traumatic stress disorder, <i>anxiety disorder</i> , <i>or depressive disorder</i> resulted from the
57 58	law-enforcement officer's or firefighter's acting in the line of duty and, in the case of a firefighter, such
59	firefighter complied with federal Occupational Safety and Health Act standards adopted pursuant to 29

60 C.F.R. 1910.134 and 29 C.F.R. 1910.156;

61 3. The law-enforcement officer's or firefighter's undergoing a qualifying event was a substantial
 62 factor in causing his post-traumatic stress disorder, *anxiety disorder, or depressive disorder*;

4. Such qualifying event, and not another event or source of stress, was the primary cause of thepost-traumatic stress disorder, *anxiety disorder*, or *depressive disorder*; and

5. The post-traumatic stress disorder, *anxiety disorder, or depressive disorder* did not result from any disciplinary action, work evaluation, job transfer, layoff, demotion, promotion, termination, retirement, or similar action of the law-enforcement officer or firefighter.

68 Any such mental health professional shall comply with any workers' compensation guidelines for approved medical providers, including guidelines on release of past or contemporaneous medical records.

C. Notwithstanding any provision of this title, workers' compensation benefits for any law-enforcement officer or firefighter payable pursuant to this section shall (i) include any combination 70 71 of medical treatment prescribed by a board-certified psychiatrist or a licensed psychologist, temporary 72 total incapacity benefits under § 65.2-500, and temporary partial incapacity benefits under § 65.2-502 73 and (ii) be provided for a maximum of 52 weeks from the date of diagnosis. No medical treatment, 74 temporary total incapacity benefits under § 65.2-500, or temporary partial incapacity benefits under 75 § 65.2-502 shall be awarded beyond four years from the date of the qualifying event that formed the 76 77 basis for the claim for benefits under this section. The weekly benefits received by a law-enforcement 78 officer or a firefighter pursuant to § 65.2-500 or 65.2-502, when combined with other benefits, including 79 contributory and noncontributory retirement benefits, Social Security benefits, and benefits under a 80 long-term or short-term disability plan, but not including payments for medical care, shall not exceed the average weekly wage paid to such law-enforcement officer or firefighter. 81

D. No later than January 1, 2021, each employer of law-enforcement officers or firefighters shall (i)
make peer support available to such law-enforcement officers and firefighters and (ii) refer a
law-enforcement officer or firefighter seeking mental health care services to a mental health professional.
E. Each fire basic training program conducted or administered by the Department of Fire Programs

a municipal fire department in the Commonwealth shall provide, in consultation with the Department
 of Behavioral Health and Developmental Services, resilience and self-care technique training for any
 individual who begins basic training as a firefighter on or after July 1, 2021.
