6 WHEREAS, Douglas William Rogers, an honorable veteran, accomplished business executive, and 7 beloved member of the Locust Grove community, died on September 10, 2022; and

8 WHEREAS, after attending Midlothian High School in Chesterfield County and the Virginia
9 Polytechnic Institute and State University, Douglas "Doug" Rogers served his country with honor and distinction as a member of the United States Air Force; and

WHEREAS, following his time in the service, Doug Rogers earned a master's degree in business
 administration from Loyola University Maryland and embarked upon an illustrious 30-year career in the
 management division of IBM; and

WHEREAS, Doug Rogers lived throughout the country during his career and later settled in Orange
County, where he took a leading role in the community, including as president of the Lake of the
Woods Association and as chairman and interim director of the Germanna Community College Board of
Directors; and

 19 Orange County Chamber of Commerce, chairman of the Orange County Economic Development
 20 Authority, and facilitator for the Orange County East End Economic Development Group; and

WHEREAS, Doug Rogers was a dedicated advocate who was committed to his conservative values,
 serving nine years as chairman of the Orange County Republican Party; and

WHEREAS, beyond his family, Doug Rogers took immense joy in education, football, literature,
 woodworking, and cheering on the Dallas Cowboys and Virginia Tech sports teams; and

WHEREAS, guided through his life by his faith, Doug Rogers enjoyed worship and fellowship withhis community at Lake of the Woods Church in Locust Grove for many years; and

WHEREAS, Doug Rogers will be fondly remembered and dearly missed by his high school
sweetheart and loving wife of 59 years, Brenda; their children, Donna and Kelley, and their families;
and numerous other family members and friends; now, therefore, be it
