4.	Title:	Mold inspectors and mold remediators; licensure.					

- **5. Summary:** Provides for the licensure and regulation of mold inspectors and mold remediators by the Board for Asbestos, Lead, and Home Inspectors, which is renamed in the bill as the Board for Asbestos, Lead, Mold, and Home Inspectors. The bill increases the membership of the Board by one member to include a mold inspector or a mold remediator. The bill contains a delayed enactment and will become effective on July 1, 2024.

8. Fiscal Implications: This bill increases the administrative and regulatory responsibilities of the Department of Professional and Occupational Regulation (DPOR) by assigning responsibility for developing, implementing, and administering a licensing requirement for mold inspection and remediation. It is anticipated that this bill will have a nongeneral fund revenue and expenditure impact on the department.

According to DPOR, the department will need to hold four Board meetings in FY 2024 to have revised regulations reflecting the new requirements in place on July 1, 2024. DPOR estimates the four additional board meetings will have a fiscal impact of \$10,985 in FY 2024. Additionally, DPOR anticipates the need for one additional board meeting in FY 2025 and continuing in future years at a cost of \$845 per year, and two additional committee meetings are needed to review training programs.

Total costs are projected to be \$10,985 in FY2024, \$50,531 in FY25 and \$41,531 in each year thereafter.

The licensing program would be added to the Board for Asbestos, Lead, and Home Inspectors. The department estimates that approximately 1,000-1,500 individuals would be licensed through this program. DPOR estimates that one additional part time licensing specialist will be needed to process license applications, training programs, and renewals. Based on similar positions within the department, the staff cost is estimated at \$25,836 in FY 2025 and each year thereafter.

DPOR will need to purchase furniture and equipment for the new position at an estimated cost of \$9,000. This is a one-time expenditure in FY 2025 that will not continue into future years. Other anticipated operating costs beginning in FY 2025 include telephone, rent, information technology support, supplies, postage, and other operating costs, and are estimated at \$14,850 each year. These are recurring costs that will continue into future years.

In accordance with the provisions of §§ 54.1-201.4 and 54.1-113, Code of Virginia, licensing fees are established to sufficiently cover all expenses for the administration and operation of the regulatory board and a proportionate share of the expenses of DPOR. The application and renewal fees for the mold remediators and inspectors are expected to be the same as other professions within the Board. The Board's current fee for an individual initial application is \$80, and the annual renewal fee is \$45. Approximately, 750 new applications are expected in both FY 2025 and FY 2026 and 100 each year thereafter. Approximately 675 renewals are expected in FY 2026 and 1,358 in FY 2027. Similar renewal levels are expected in future years.
