3. Committee: Appropriations

4. Title: Public institutions of higher education; tuition grants; Virginia National Guard.

5. Summary: Provides that public institutions of higher education may enter into special arrangement contracts with the Virginia Department of Military Affairs for the purpose of providing reduced rate tuition charges for any member of the Virginia National Guard receiving state tuition assistance grants provided that 1) no more than 50 non-Virginia students in any year receives reduced rate tuition charges, and 2) no non-Virginia student receives reduced rate tuition unless they have been enrolled as a non-Virginia student in a public institution of higher education in the Commonwealth for at least two years prior to receiving reduced rate tuition and cannot receive it for more than two years. Additionally, the bill requires the Department of Military Affairs to develop guidelines for implementing these provisions. The bill also provides that in order to be eligible for such state tuition assistance grant a member of the Virginia National Guard must have two years remaining on his service obligation to the Virginia National Guard as of the last day of the last term or semester for which tuition assistance is requested. Current law provides that as a condition of being awarded a tuition assistance grant a member of the Virginia National Guard will incur a two-year service obligation to commence after the last day of the term or semester for which tuition assistance is requested.

7. Fiscal Impact Estimates: Indeterminate. See Item 8.

8. Fiscal Implications: The fiscal impact of this bill is indeterminate at this time.

As a result of the special arrangement contracts (SACs) between public institutions of higher education and the Virginia Department of Military Affairs (VDMA), eligible members of the Virginia National Guard may receive reduced rate tuition. Pursuant to § 23.1-508, tuition rates set by SACs cannot be less than in-state tuition rates. Any tuition revenue loss for public higher education institutions depends on the agreed upon rates and the number of eligible students. A large influx of new eligible students is not anticipated as a result of the proposed changes to service obligation under § 23.1-610.

This bill may allow VDMA to award additional tuition assistance to Virginia National Guard members pursuant to § 23.1-610, as those grants pay for the difference between the full cost of tuition and any other educational benefits for which the member is eligible. Pursuant to this bill and any established SACs, the full cost of tuition for eligible Virginia National Guard members may be a reduced rate.
