

## 1 VIRGINIA ACTS OF ASSEMBLY — CHAPTER

2 *An Act to amend and reenact § 46.2-427 of the Code of Virginia, relating to enforcement of certain*  
3 *judgments; restricted license.*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 46.2-427 of the Code of Virginia is amended and reenacted as follows:**8 **§ 46.2-427. When suspensions to remain effective; relief from furnishing proof of financial**  
9 **responsibility; prohibition against registration in name of another person.**

10 The suspension required by the provisions of § 46.2-417 shall continue except as otherwise provided  
11 by §§ 46.2-421 and 46.2-423 until the person satisfies the judgment or judgments as prescribed in  
12 § 46.2-419 and gives proof of his financial responsibility in the future. However, the judgment debtor  
13 whose driving privileges, registration certificates, and license plates have been so suspended may petition  
14 the court that entered the judgment for reinstatement of his driving privileges, registration certificates,  
15 and license plates and the court may order reinstatement if the judgment has not been satisfied, provided  
16 the judgment debtor proves by a preponderance of the evidence that the judgment debtor (i) is unable,  
17 after examination of the records of the Department and the court reflecting that suspension and the  
18 exercise of due diligence, to locate the person to whom payment is due or, if the person to whom  
19 payment is due is dead, the judgment debtor is unable to identify either who are his heirs and assignees,  
20 or where they are located, and (ii) has paid into the court an amount equal to the judgment, court costs,  
21 and all interest that has accrued up to the date payment was made to the court. Any payment made to  
22 the court under this section shall be held for one year and, if unclaimed by the judgment creditor during  
23 that period, shall be transmitted by the court to the State Treasurer or his designee to be disposed of  
24 pursuant to the Virginia Disposition of Unclaimed Property Act (§ 55.1-2500 et seq.).

25 Upon receipt of such an order, the Commissioner shall reinstate the driving privileges, registration  
26 certificates, and license plates of the judgment debtor, provided the judgment debtor has given proof of  
27 his financial responsibility in the future and satisfied all other reinstatement requirements as provided in  
28 this chapter.

29 *Notwithstanding the provisions of this article, a judgment debtor whose driving privileges have been*  
30 *suspended pursuant to this article may petition the court that entered the judgment for a restricted*  
31 *license to operate a motor vehicle during the period of suspension and the court may, for good cause*  
32 *shown, order the issuance of such restricted license for any of the purposes set forth in subsection E of*  
33 *§ 18.2-271.1. Such restricted license shall be carried at all times while operating a motor vehicle. Any*  
34 *person who operates a motor vehicle in violation of any restrictions imposed pursuant to this section*  
35 *shall be punished as provided § 46.2-301. No restricted license issued pursuant to this section shall*  
36 *permit any person to operate a commercial motor vehicle as defined in the Virginia Commercial*  
37 *Driver's License Act (§ 46.2-341.1 et seq.).*

38 The motor vehicle involved in the accident on which the suspension under § 46.2-417 is based shall  
39 not be registered in the name of any other person when the Commissioner has reasonable grounds to  
40 believe that the registration of the vehicle will have the effect of defeating the purpose of the chapter  
41 and no other motor vehicle shall be registered, and no driver's license or learner's permit shall be issued  
42 in the name of the person suspended, except as prescribed in § 46.2-437 until the suspension is  
43 terminated.

44 This section shall not relieve any person from giving or maintaining proof of his financial  
45 responsibility when he is required so to do for some reason rather than having been involved in a motor  
46 vehicle accident.
