7 Be it enacted by the General Assembly of Virginia:

8 1. That § 40.1-28.9, as it is currently effective and as it shall become effective, of the Code of 9 Virginia is amended and reenacted as follows:

10 § 40.1-28.9. (Effective until July 1, 2030) Definitions; determining wage of tipped employee. 11 A. As used in this article:

12 "Adjusted state hourly minimum wage" means the amount established by the Commissioner pursuant 13 to subsection F of \S 40.1-28.10.

"Domestic service" means services related to the care of an individual in a private home or the 14 15 maintenance of a private home or its premises, on a permanent or temporary basis, including services performed by individuals such as companions, cooks, waiters, butlers, maids, valets, and chauffeurs. 16

"Employee" includes any individual employed by an employer. "Employee" includes a home care 17 18 provider. "Employee" does not include the following:

1. Any person employed as a farm laborer or farm employee; 19

20 2. Any person engaged in the activities of an educational, charitable, religious, or nonprofit 21 organization where the relationship of employer-employee does not, in fact, exist or where the services 22 rendered to such organization are on a voluntary basis; 23

3. 2. Caddies on golf courses;

24 4. 3. Traveling salesmen or outside salesmen working on a commission basis; taxicab drivers and 25 operators; 26

5. 4. Any person under the age of 18 in the employ of his parent or legal guardian;

50 "Employer" includes any individual, partnership, association, corporation, or business trust or any person or group of persons acting directly or indirectly in the interest of an employer in relation to an 51 employee. "Employer" includes the Commonwealth, any of its agencies, institutions, or political 52 53 subdivisions, and any public body.

54 "Federal minimum wage" means the minimum wage or, if applicable, the federal training wage 55 prescribed by the U.S. Fair Labor Standards Act, 29 U.S.C. § 201 et seq.

56 "Home care provider" means an individual who provides (i) home health services, including services **HB157ER**

57 provided by or under the direct supervision of any health care professional under a medical plan of care 58 in a patient's residence on a visit or hourly basis to patients who have or are at risk of injury, illness, or 59 a disabling condition and require short-term or long-term interventions, or (ii) personal care services,

60 including assistance in personal care to include activities of a daily living provided in an individual's 61 residence on a visit or hourly basis to individuals who have or are at risk of an illness, injury, or 62 disabling condition.

63 "Tipped employee" means an employee who in the course of employment customarily and regularly 64 receives tips totaling more than \$30 each month from persons other than the employee's employer.

65 "Wages" means legal tender of the United States or checks or drafts on banks negotiable into cash on demand or upon acceptance at full value. "Wages" includes the reasonable cost to the employer of 66 67 furnishing meals and lodging to an employee if such board or lodging is customarily furnished by the 68 employer and used by the employee.

69 B. In determining the wage of a tipped employee, the amount paid such employee by his employer 70 shall be deemed to be increased on account of tips by an amount determined by the employer, except in 71 the case of an employee who establishes by clear and convincing evidence that the actual amount of tips 72 received by him was less than the amount determined by the employer. In such case, the amount paid 73 such employee by his employer shall be deemed to have been increased by such lesser amount. An 74 employer shall not classify an individual as a tipped employee if the individual is prohibited by 75 applicable federal or state law or regulation from soliciting tips. 76
