10	Be it enacted by the General Assembly of Virginia:
11	1. That the Code of Virginia is amended by adding a section numbered 22.1-23.4 as follows:
12	§ 22.1-23.4. Title IX and sexual harassment prevention training; policies.
13	A. As used in this section:
14	"High school" includes grades nine through 12.
15	"Sexual harassment" has the same meaning as described in 34 C.F.R. § 106.30(a) and includes
16	sexual assault, dating violence, domestic violence, stalking, and other gender or sex-based verbal or
17	physical misconduct.
18	B. The Department shall develop, in collaboration with organizations that serve sexual harassment
19	victims, culturally appropriate, age-appropriate, and trauma-informed Title IX and sexual harassment
20	prevention training modules and shall make such training modules available to each school board for
21	the education of high school students. Such training modules shall discuss:
22	1. Title IX (20 U.S.C. § 1681 et seq.) rights and protections;
23	2. The law and meaning of consent;
24	3. Prevention of sexual harassment; and
25	4. Reporting of sexual harassment.
2 6	C. The Department shall revise the Title IX and sexual harassment prevention training modules

	developed pursuant to subsection B and make such revised modules available to each school board no
28	later than December 31 of each year to ensure that the such training modules conform to the standards
29	pursuant to subsection B and comply with applicable state and federal law.
30	D. Each school board shall adopt policies to require all high school students to complete the sexual
31	harassment modules developed by the Department pursuant to subsection B within 31 days of the start
32	of each school year. Each school board shall also:
33	1. [Set aside instructional time during school hours for all high school students to complete such
34	training modules developed pursuant to subsection B;
35	2.] Allow all high school students to opt-out of participating in the completion of such training
36	modules by request of the student's parents if such student is under the age of 18, or by request of the
37	student if such student is 18 years of age or older; and
38	[3. 2.] Ensure all high school students are aware of any school counseling services available to
39	them before such students begin the training modules developed pursuant to subsection B.
40	2. That the Department of Education shall develop and make available to each school board no
41	later than [December 31, 2024 July 1, 2025], the training modules described in subsection B of
42	§ 22.1-23.4 of the Code of Virginia, as created by this act.
43	3. That each school board shall adopt policies pursuant to subsection E of § 22.1-23.4 of the Code
44	of Virginia, as created by this act, no later than the beginning of the 2025-2026 school year.
