A BILL to amend the Code of Virginia by adding in Chapter 37 of Title 54.1 an article numbered 3, consisting of a section numbered 54.1-3709.4, relating to Social Work Licensure Compact.

Be it enacted by the General Assembly of Virginia:

1. That the Code of Virginia is amended by adding in Chapter 37 of Title 54.1 an article numbered 3, consisting of a section numbered 54.1-3709.4, as follows:

Article 3.

Social Work Licensure Compact.

§ 54.1-3709.4. Social Work Licensure Compact.

The General Assembly hereby enacts, and the Commonwealth of Virginia hereby enters into, the Social Work Licensure Compact with any and all states legally joining therein according to its terms, in the form substantially as follows:

SOCIAL WORK LICENSURE COMPACT.

Section 1.

Purpose.

The purpose of this Compact is to facilitate interstate practice of Regulated Social Workers by improving public access to competent Social Work Services. The Compact preserves the regulatory authority of States to protect public health and safety through the current system of State licensure.

This Compact is designed to achieve the following objectives:

1. Increase public access to Social Work Services;
2. Reduce overly burdensome and duplicative requirements associated with holding multiple licenses;
3. Enhance the Member States' ability to protect the public's health and safety;
4. Encourage the cooperation of Member States in regulating multistate practice;
5. Promote mobility and address workforce shortages by eliminating the necessity for licenses in multiple States by providing for the mutual recognition of other Member State licenses;
6. Support military families;
7. Facilitate the exchange of licensure and disciplinary information among Member States;
8. Authorize all Member States to hold a Regulated Social Worker accountable for abiding by a Member State's laws, regulations, and applicable professional standards in the Member State in which the client is located at the time care is rendered; and
9. Allow for the use of telehealth to facilitate increased access to regulated Social Work Services.

Section 2.

Definitions.

As used in this Compact, and except as otherwise provided, the following definitions shall apply:

"Active Military Member" means any individual with full-time duty status in the active armed forces of the United States including members of the National Guard and Reserve.

"Adverse Action" means any administrative, civil, equitable, or criminal action permitted by a State's laws which is imposed by a Licensing Authority or other authority against a Regulated Social Worker, including actions against an individual's license or Multistate Authorization to Practice such as revocation, suspension, probation, monitoring of the Licensee, limitation on the Licensee's practice, or any other Encumbrance on licensure affecting a Regulated Social Worker's authorization to practice, including issuance of a cease and desist action.

"Alternative Program" means a non-disciplinary monitoring or practice remediation process approved by a Licensing Authority to address practitioners with an Impairment.

"Charter Member States" means Member States who have enacted legislation to adopt this Compact where such legislation predates the effective date of this Compact as described in Section 14.

"Compact Commission" or "Commission" means the government agency whose membership consists of all States that have enacted this Compact, which is known as the Social Work Licensure Compact Commission, as described in Section 10, and which shall operate as an instrumentality of the Member States.

"Current Significant Investigative Information" means:

1. Investigative information that a Licensing Authority, after a preliminary inquiry that includes

59 notification and an opportunity for the Regulated Social Worker to respond has reason to believe is not
 60 groundless and, if proved true, would indicate more than a minor infraction as may be defined by the
 61 Commission; or

62 2. Investigative information that indicates that the Regulated Social Worker represents an immediate
 63 threat to public health and safety, as may be defined by the Commission, regardless of whether the
 64 Regulated Social Worker has been notified and has had an opportunity to respond.

65 "Data System" means a repository of information about Licensees, including, continuing education,
 66 examination, licensure, Current Significant Investigative Information, Disqualifying Event, Multistate
 67 License(s), and Adverse Action information or other information as required by the Commission.

68 "Domicile" means the jurisdiction in which the Licensee resides and intends to remain indefinitely.

69 "Disqualifying Event" means any Adverse Action or incident which results in an Encumbrance that
 70 disqualifies or makes the Licensee ineligible to either obtain, retain, or renew a Multistate License.

71 "Encumbrance" means a revocation or suspension of, or any limitation on, the full and unrestricted
 72 practice of Social Work licensed and regulated by a Licensing Authority.

73 "Executive Committee" means a group of delegates elected or appointed to act on behalf of, and
 74 within the powers granted to them by, the Compact and Commission.

75 "Home State" means the Member State that is the Licensee's primary Domicile.

76 "Impairment" means a condition(s) that may impair a practitioner's ability to engage in full and
 77 unrestricted practice as a Regulated Social Worker without some type of intervention and may include
 78 alcohol and drug dependence, mental health impairment, and neurological or physical impairments.

79 "Licensee(s)" means an individual who currently holds a license from a State to practice as a
 80 Regulated Social Worker.

81 "Licensing Authority" means the board or agency of a Member State or equivalent that is responsible
 82 for the licensing and regulation of Regulated Social Workers.

83 "Member State" means a state, commonwealth, district, or territory of the United States of America
 84 that has enacted this Compact.

85 "Multistate Authorization to Practice" means a legally authorized privilege to practice, which is
 86 equivalent to a license, associated with a Multistate License permitting the practice of Social Work in a
 87 Remote State.

88 "Multistate License" means a license to practice as a Regulated Social Worker issued by a Home
 89 State Licensing Authority that authorizes the Regulated Social Worker to practice in all Member States
 90 under Multistate Authorization to Practice.

91 "Qualifying National Exam" means a national licensing examination approved by the Commission.

92 "Regulated Social Worker" means any clinical, master's or bachelor's Social Worker licensed by a
 93 Member State regardless of the title used by that Member State.

94 "Remote State" means a Member State other than the Licensee's Home State.

95 "Rule(s)" or "Rule(s) of the Commission" means a regulation or regulations duly promulgated by the
 96 Commission, as authorized by the Compact, that has the force of law.

97 "Single State License" means a Social Work license issued by any State that authorizes practice only
 98 within the issuing State and does not include Multistate Authorization to Practice in any Member State.

99 "Social Work" or "Social Work Services" means the application of social work theory, knowledge,
 100 methods, ethics, and the professional use of self to restore or enhance social, psychosocial, or
 101 biopsychosocial functioning of individuals, couples, families, groups, organizations, and communities
 102 through the care and services provided by a Regulated Social Worker as set forth in the Member State's
 103 statutes and regulations in the State where the services are being provided.

104 "State" means any state, commonwealth, district, or territory of the United States of America that
 105 regulates the practice of Social Work.

106 "Unencumbered License" means a license that authorizes a Regulated Social Worker to engage in
 107 the full and unrestricted practice of Social Work.

108 Section 3.

109 State Participation in the Compact.

110 A. To be eligible to participate in the Compact, a potential Member State must currently meet all of
 111 the following criteria:

112 1. License and regulate the practice of Social Work at either the clinical, master's, or bachelor's
 113 category.

114 2. Require applicants for licensure to graduate from a program that is:

115 a. Operated by a college or university recognized by the Licensing Authority;

116 b. Accredited, or in candidacy by an institution that subsequently becomes accredited, by an
 117 accrediting agency recognized by either:

118 (1) The Council for Higher Education Accreditation, or its successor; or

119 (2) The United States Department of Education; and

120 c. Corresponds to the licensure sought as outlined in Section 4.

- 121 3. Require applicants for clinical licensure to complete a period of supervised practice.
 122 4. Have a mechanism in place for receiving, investigating, and adjudicating complaints about
 123 Licensees.
- 124 B. To maintain membership in the Compact a Member State shall:
- 125 1. Require that applicants for a Multistate License pass a Qualifying National Exam for the
 126 corresponding category of Multistate License sought as outlined in Section 4;
 127 2. Participate fully in the Commission's Data System, including using the Commission's unique
 128 identifier as defined in Rules;
- 129 3. Notify the Commission, in compliance with the terms of the Compact and Rules, of any Adverse
 130 Action or the availability of Current Significant Investigative Information regarding a Licensee;
 131 4. Implement procedures for considering the criminal history records of applicants for a Multistate
 132 License. Such procedures shall include the submission of fingerprints or other biometric-based
 133 information by applicants for the purpose of obtaining an applicant's criminal history record
 134 information from the Federal Bureau of Investigation and the agency responsible for retaining that
 135 State's criminal records;
- 136 5. Comply with the Rules of the Commission;
- 137 6. Require an applicant to obtain or retain a license in the Home State and meet the Home State's
 138 qualifications for licensure or renewal of licensure, as well as all other applicable Home State laws;
- 139 7. Authorize a Licensee holding a Multistate License in any Member State to practice in accordance
 140 with the terms of the Compact and Rules of the Commission; and
- 141 8. Designate a delegate to participate in the Commission meetings.
- 142 C. A Member State meeting the requirements of Sections 3 A and 3 B of this Compact shall
 143 designate the categories of Social Work licensure that are eligible for issuance of a Multistate License
 144 for applicants in such Member State. To the extent that any Member State does not meet the
 145 requirements for participation in the Compact at any particular category of Social Work licensure, such
 146 Member State may choose, but is not obligated to, issue a Multistate License to applicants that
 147 otherwise meet the requirements of Section 4 for issuance of a Multistate License in such category or
 148 categories of licensure.
- 149 D. The Home State may charge a fee for granting the Multistate License.
 150 Section 4.
 151 Social Worker Participation in the Compact.
- 152 A. To be eligible for a Multistate License under the terms and provisions of the Compact, an
 153 applicant, regardless of category must:
- 154 1. Hold or be eligible for an active, Unencumbered License in the Home State.
 155 2. Pay any applicable fees, including any State fee, for the Multistate License.
 156 3. Submit, in connection with an application for a Multistate License, fingerprints or other biometric
 157 data for the purpose of obtaining criminal history record information from the Federal Bureau of
 158 Investigation and the agency responsible for retaining that State's criminal records.
 159 4. Notify the Home State of any Adverse Action, Encumbrance, or restriction on any professional
 160 license taken by any Member State or non-Member State within 30 days from the date the action is
 161 taken.
 162 5. Meet any continuing competence requirements established by the Home State.
 163 6. Abide by the laws, regulations, and applicable standards in the Member State where the client is
 164 located at the time care is rendered.
- 165 B. An applicant for a clinical-category Multistate License must meet all of the following
 166 requirements:
- 167 1. Fulfill a competency requirement, which shall be satisfied by either:
 168 a. Passage of a clinical-category Qualifying National Exam; or
 169 b. Licensure of the applicant in their Home State at the clinical category, beginning prior to such
 170 time as a Qualifying National Exam was required by the Home State and accompanied by a period of
 171 continuous Social Work licensure thereafter, all of which may be further governed by the Rules of the
 172 Commission; or
 173 c. The substantial equivalency of the foregoing competency requirements which the Commission may
 174 determine by Rule.
 175 2. Attain at least a master's degree in Social Work from a program that is:
 176 a. Operated by a college or university recognized by the Licensing Authority; and
 177 b. Accredited, or in candidacy that subsequently becomes accredited, by an accrediting agency
 178 recognized by either:
 179 (1) The Council for Higher Education Accreditation or its successor; or
 180 (2) The United States Department of Education.
 181 3. Fulfill a practice requirement, which shall be satisfied by demonstrating completion of either:

- 182 a. A period of postgraduate supervised clinical practice equal to a minimum of three thousand
 183 hours; or
- 184 b. A minimum of two years of full-time postgraduate supervised clinical practice; or
- 185 c. The substantial equivalency of the foregoing practice requirements which the Commission may
 186 determine by Rule.
- 187 C. An applicant for a master's-category Multistate License must meet all of the following
 188 requirements:
- 189 1. Fulfill a competency requirement, which shall be satisfied by either:
- 190 a. Passage of a masters-category Qualifying National Exam;
- 191 b. Licensure of the applicant in their Home State at the master's category, beginning prior to such
 192 time as a Qualifying National Exam was required by the Home State at the master's category and
 193 accompanied by a continuous period of Social Work licensure thereafter, all of which may be further
 194 governed by the Rules of the Commission; or
- 195 c. The substantial equivalency of the foregoing competency requirements which the Commission may
 196 determine by Rule.
- 197 2. Attain at least a master's degree in Social Work from a program that is:
- 198 a. Operated by a college or university recognized by the Licensing Authority; and
- 199 b. Accredited, or in candidacy that subsequently becomes accredited, by an accrediting agency
 200 recognized by either:
- 201 (1) The Council for Higher Education Accreditation or its successor; or
- 202 (2) The United States Department of Education.
- 203 D. An applicant for a bachelor's-category Multistate License must meet all of the following
 204 requirements:
- 205 1. Fulfill a competency requirement, which shall be satisfied by either:
- 206 a. Passage of a bachelor's-category Qualifying National Exam;
- 207 b. Licensure of the applicant in their Home State at the bachelor's category, beginning prior to such
 208 time as a Qualifying National Exam was required by the Home State and accompanied by a period of
 209 continuous Social Work licensure thereafter, all of which may be further governed by the Rules of the
 210 Commission; or
- 211 c. The substantial equivalency of the foregoing competency requirements which the Commission may
 212 determine by Rule.
- 213 2. Attain at least a bachelor's degree in Social Work from a program that is:
- 214 a. Operated by a college or university recognized by the Licensing Authority; and
- 215 b. Accredited, or in candidacy that subsequently becomes accredited, by an accrediting agency
 216 recognized by either:
- 217 (1) The Council for Higher Education Accreditation or its successor; or
- 218 (2) The United States Department of Education.
- 219 E. The Multistate License for a Regulated Social Worker is subject to the renewal requirements of
 220 the Home State. The Regulated Social Worker must maintain compliance with the requirements of
 221 Section 4 A to be eligible to renew a Multistate License.
- 222 F. The Regulated Social Worker's services in a Remote State are subject to that Member State's
 223 regulatory authority. A Remote State may, in accordance with due process and that Member State's
 224 laws, remove a Regulated Social Worker's Multistate Authorization to Practice in the Remote State for a
 225 specific period of time, impose fines, and take any other necessary actions to protect the health and
 226 safety of its citizens.
- 227 G. If a Multistate License is encumbered, the Regulated Social Worker's Multistate Authorization to
 228 Practice shall be deactivated in all Remote States until the Multistate License is no longer encumbered.
- 229 H. If a Multistate Authorization to Practice is encumbered in a Remote State, the regulated Social
 230 Worker's Multistate Authorization to Practice may be deactivated in that State until the Multistate
 231 Authorization to Practice is no longer encumbered.
- 232 Section 5.
- 233 Issuance of a Multistate License.
- 234 A. Upon receipt of an application for Multistate License, the Home State Licensing Authority shall
 235 determine the applicant's eligibility for a Multistate License in accordance with Section 4 of this
 236 Compact.
- 237 B. If such applicant is eligible pursuant to Section 4 of this Compact, the Home State Licensing
 238 Authority shall issue a Multistate License that authorizes the applicant or Regulated Social Worker to
 239 practice in all Member States under a Multistate Authorization to Practice.
- 240 C. Upon issuance of a Multistate License, the Home State Licensing Authority shall designate
 241 whether the Regulated Social Worker holds a Multistate License in the Bachelors, Masters, or Clinical
 242 category of Social Work.
- 243 D. A Multistate License issued by a Home State to a resident in that State shall be recognized by all

244 Compact Member States as authorizing Social Work Practice under a Multistate Authorization to
245 Practice corresponding to each category of licensure regulated in each Member State.

246 Section 6.

247 Authority of Interstate Compact Commission and Member State Licensing Authorities.

248 A. Nothing in this Compact, nor any Rule of the Commission, shall be construed to limit, restrict, or
249 in any way reduce the ability of a Member State to enact and enforce laws, regulations, or other rules
250 related to the practice of Social Work in that State, where those laws, regulations, or other rules are
251 not inconsistent with the provisions of this Compact.

252 B. Nothing in this Compact shall affect the requirements established by a Member State for the
253 issuance of a Single State License.

254 C. Nothing in this Compact, nor any Rule of the Commission, shall be construed to limit, restrict, or
255 in any way reduce the ability of a Member State to take Adverse Action against a Licensee's Single
256 State License to practice Social Work in that State.

257 D. Nothing in this Compact, nor any Rule of the Commission, shall be construed to limit, restrict, or
258 in any way reduce the ability of a Remote State to take Adverse Action against a Licensee's Multistate
259 Authorization to Practice in that State.

260 E. Nothing in this Compact, nor any Rule of the Commission, shall be construed to limit, restrict, or
261 in any way reduce the ability of a Licensee's Home State to take Adverse Action against a Licensee's
262 Multistate License based upon information provided by a Remote State.

263 Section 7.

264 Reissuance of a Multistate License by a New Home State.

265 A. A Licensee can hold a Multistate License, issued by their Home State, in only one Member State
266 at any given time.

267 B. If a Licensee changes their Home State by moving between two Member States:

268 1. The Licensee shall immediately apply for the reissuance of their Multistate License in their new
269 Home State. The Licensee shall pay all applicable fees and notify the prior Home State in accordance
270 with the Rules of the Commission.

271 2. Upon receipt of an application to reissue a Multistate License, the new Home State shall verify
272 that the Multistate License is active, unencumbered, and eligible for reissuance under the terms of the
273 Compact and the Rules of the Commission. The Multistate License issued by the prior Home State will
274 be deactivated and all Member States notified in accordance with the applicable Rules adopted by the
275 Commission.

276 3. Prior to the reissuance of the Multistate License, the new Home State shall conduct procedures for
277 considering the criminal history records of the Licensee. Such procedures shall include the submission
278 of fingerprints or other biometric-based information by applicants for the purpose of obtaining an
279 applicant's criminal history record information from the Federal Bureau of Investigation and the agency
280 responsible for retaining that State's criminal records.

281 4. If required for initial licensure, the new Home State may require completion of jurisprudence
282 requirements in the new Home State.

283 5. Notwithstanding any other provision of this Compact, if a Licensee does not meet the requirements
284 set forth in this Compact for the reissuance of a Multistate License by the new Home State, then the
285 Licensee shall be subject to the new Home State requirements for the issuance of a Single State License
286 in that State.

287 C. If a Licensee changes their primary State of residence by moving from a Member State to a
288 non-Member State, or from a non-Member State to a Member State, then the Licensee shall be subject
289 to the State requirements for the issuance of a Single State License in the new Home State.

290 D. Nothing in this Compact shall interfere with a Licensee's ability to hold a Single State License in
291 multiple States; however, for the purposes of this Compact, a Licensee shall have only one Home State,
292 and only one Multistate License.

293 E. Nothing in this Compact shall interfere with the requirements established by a Member State for
294 the issuance of a Single State License.

295 Section 8.

296 Military Families.

297 An Active Military Member or their spouse shall designate a Home State where the individual has a
298 Multistate License. The individual may retain their Home State designation during the period the service
299 member is on active duty.

300 Section 9.

301 Adverse Actions.

302 A. In addition to the other powers conferred by State law, a Remote State shall have the authority, in
303 accordance with existing State due process law, to:

304 1. Take Adverse Action against a Regulated Social Worker's Multistate Authorization to Practice only

305 within that Member State, and issue subpoenas for both hearings and investigations that require the
 306 attendance and testimony of witnesses as well as the production of evidence. Subpoenas issued by a
 307 Licensing Authority in a Member State for the attendance and testimony of witnesses or the production
 308 of evidence from another Member State shall be enforced in the latter State by any court of competent
 309 jurisdiction, according to the practice and procedure of that court applicable to subpoenas issued in
 310 proceedings pending before it. The issuing Licensing Authority shall pay any witness fees, travel
 311 expenses, mileage, and other fees required by the service statutes of the State in which the witnesses or
 312 evidence are located.

313 2. Only the Home State shall have the power to take Adverse Action against a Regulated Social
 314 Worker's Multistate License.

315 B. For purposes of taking Adverse Action, the Home State shall give the same priority and effect to
 316 reported conduct received from a Member State as it would if the conduct had occurred within the
 317 Home State. In so doing, the Home State shall apply its own State laws to determine appropriate action.

318 C. The Home State shall complete any pending investigations of a Regulated Social Worker who
 319 changes their Home State during the course of the investigations. The Home State shall also have the
 320 authority to take appropriate action(s) and shall promptly report the conclusions of the investigations to
 321 the administrator of the Data System. The administrator of the Data System shall promptly notify the
 322 new Home State of any Adverse Actions.

323 D. A Member State, if otherwise permitted by State law, may recover from the affected Regulated
 324 Social Worker the costs of investigations and dispositions of cases resulting from any Adverse Action
 325 taken against that Regulated Social Worker.

326 E. A Member State may take Adverse Action based on the factual findings of another Member State,
 327 provided that the Member State follows its own procedures for taking the Adverse Action.

328 F. Joint Investigations:

329 1. In addition to the authority granted to a Member State by its respective Social Work practice act
 330 or other applicable State law, any Member State may participate with other Member States in joint
 331 investigations of Licensees.

332 2. Member States shall share any investigative, litigation, or compliance materials in furtherance of
 333 any joint or individual investigation initiated under the Compact.

334 G. If Adverse Action is taken by the Home State against the Multistate License of a Regulated Social
 335 Worker, the Regulated Social Worker's Multistate Authorization to Practice in all other Member States
 336 shall be deactivated until all Encumbrances have been removed from the Multistate License. All Home
 337 State disciplinary orders that impose Adverse Action against the license of a Regulated Social Worker
 338 shall include a statement that the Regulated Social Worker's Multistate Authorization to Practice is
 339 deactivated in all Member States until all conditions of the decision, order, or agreement are satisfied.

340 H. If a Member State takes Adverse Action, it shall promptly notify the administrator of the Data
 341 System. The administrator of the Data System shall promptly notify the Home State and all other
 342 Member States of any Adverse Actions by Remote States.

343 I. Nothing in this Compact shall override a Member State's decision that participation in an
 344 Alternative Program may be used in lieu of Adverse Action.

345 J. Nothing in this Compact shall authorize a Member State to demand the issuance of subpoenas for
 346 attendance and testimony of witnesses or the production of evidence from another Member State for
 347 lawful actions within that Member State.

348 K. Nothing in this Compact shall authorize a Member State to impose discipline against a Regulated
 349 Social Worker who holds a Multistate Authorization to Practice for lawful actions within another
 350 Member State.

351 Section 10.

352 Establishment of Social Work Licensure Compact Commission.

353 A. The Compact Member States hereby create and establish a joint government agency whose
 354 membership consists of all Member States that have enacted the compact known as the Social Work
 355 Licensure Compact Commission. The Commission is an instrumentality of the Compact States acting
 356 jointly and not an instrumentality of any one State. The Commission shall come into existence on or
 357 after the effective date of the Compact as set forth in Section 14.

358 B. Membership, Voting, and Meetings:

359 1. Each Member State shall have and be limited to one (1) delegate selected by that Member State's
 360 State Licensing Authority.

361 2. The delegate shall be either:

362 a. A current member of the State Licensing Authority at the time of appointment, who is a Regulated
 363 Social Worker or public member of the State Licensing Authority; or

364 b. An administrator of the State Licensing Authority or their designee.

365 3. The Commission shall by Rule or bylaw establish a term of office for delegates and may by Rule
 366 or bylaw establish term limits.

- 367 4. The Commission may recommend removal or suspension any delegate from office.
- 368 5. A Member State's State Licensing Authority shall fill any vacancy of its delegate occurring on the
- 369 Commission within 60 days of the vacancy.
- 370 6. Each delegate shall be entitled to one vote on all matters before the Commission requiring a vote
- 371 by Commission delegates.
- 372 7. A delegate shall vote in person or by such other means as provided in the bylaws. The bylaws
- 373 may provide for delegates to meet by telecommunication, videoconference, or other means of
- 374 communication.
- 375 8. The Commission shall meet at least once during each calendar year. Additional meetings may be
- 376 held as set forth in the bylaws. The Commission may meet by telecommunication, video conference, or
- 377 other similar electronic means.
- 378 C. The Commission shall have the following powers:
- 379 1. Establish the fiscal year of the Commission;
- 380 2. Establish code of conduct and conflict of interest policies;
- 381 3. Establish and amend Rules and bylaws;
- 382 4. Maintain its financial records in accordance with the bylaws;
- 383 5. Meet and take such actions as are consistent with the provisions of this Compact, the
- 384 Commission's Rules, and the bylaws;
- 385 6. Initiate and conclude legal proceedings or actions in the name of the Commission, provided that
- 386 the standing of any State Licensing Board to sue or be sued under applicable law shall not be affected;
- 387 7. Maintain and certify records and information provided to a Member State as the authenticated
- 388 business records of the Commission, and designate an agent to do so on the Commission's behalf;
- 389 8. Purchase and maintain insurance and bonds;
- 390 9. Borrow, accept, or contract for services of personnel, including, but not limited to, employees of a
- 391 Member State;
- 392 10. Conduct an annual financial review;
- 393 11. Hire employees, elect or appoint officers, fix compensation, define duties, grant such individuals
- 394 appropriate authority to carry out the purposes of the Compact, and establish the Commission's
- 395 personnel policies and programs relating to conflicts of interest, qualifications of personnel, and other
- 396 related personnel matters;
- 397 12. Assess and collect fees;
- 398 13. Accept any and all appropriate gifts, donations, grants of money, other sources of revenue,
- 399 equipment, supplies, materials, and services, and receive, utilize, and dispose of the same; provided that
- 400 at all times the Commission shall avoid any appearance of impropriety or conflict of interest;
- 401 14. Lease, purchase, retain, own, hold, improve, or use any property, real, personal, or mixed, or
- 402 any undivided interest therein;
- 403 15. Sell, convey, mortgage, pledge, lease, exchange, abandon, or otherwise dispose of any property
- 404 real, personal, or mixed;
- 405 16. Establish a budget and make expenditures;
- 406 17. Borrow money;
- 407 18. Appoint committees, including standing committees, composed of members, State regulators, State
- 408 legislators or their representatives, and consumer representatives, and such other interested persons as
- 409 may be designated in this Compact and the bylaws;
- 410 19. Provide and receive information from, and cooperate with, law enforcement agencies;
- 411 20. Establish and elect an Executive Committee, including a chair and a vice chair;
- 412 21. Determine whether a State's adopted language is materially different from the model compact
- 413 language such that the State would not qualify for participation in the Compact; and
- 414 22. Perform such other functions as may be necessary or appropriate to achieve the purposes of this
- 415 Compact.
- 416 D. The Executive Committee:
- 417 1. The Executive Committee shall have the power to act on behalf of the Commission according to
- 418 the terms of this Compact. The powers, duties, and responsibilities of the Executive Committee shall
- 419 include:
- 420 a. Oversee the day-to-day activities of the administration of the compact including enforcement and
- 421 compliance with the provisions of the compact, its Rules and bylaws, and other such duties as deemed
- 422 necessary;
- 423 b. Recommend to the Commission changes to the Rules or bylaws, changes to this Compact
- 424 legislation, fees charged to Compact Member States, fees charged to Licensees, and other fees;
- 425 c. Ensure Compact administration services are appropriately provided, including by contract;
- 426 d. Prepare and recommend the budget;
- 427 e. Maintain financial records on behalf of the Commission;

428 f. Monitor Compact compliance of Member States and provide compliance reports to the
429 Commission;

430 g. Establish additional committees as necessary;

431 h. Exercise the powers and duties of the Commission during the interim between Commission
432 meetings, except for adopting or amending Rules, adopting or amending bylaws, and exercising any
433 other powers and duties expressly reserved to the Commission by Rule or bylaw; and

434 i. Other duties as provided in the Rules or bylaws of the Commission.

435 2. The Executive Committee shall be composed of up to eleven (11) members:

436 a. The chair and vice chair of the Commission shall be voting members of the Executive Committee;
437 and

438 b. The Commission shall elect five voting members from the current membership of the Commission.

439 c. Up to four (4) ex-officio, nonvoting members from four (4) recognized national Social Work
440 organizations.

441 d. The ex-officio members will be selected by their respective organizations.

442 3. The Commission may remove any member of the Executive Committee as provided in the
443 Commission's bylaws.

444 4. The Executive Committee shall meet at least annually.

445 a. Executive Committee meetings shall be open to the public, except that the Executive Committee
446 may meet in a closed, non-public meeting as provided in subsection F 2 below.

447 b. The Executive Committee shall give seven (7) days' notice of its meetings, posted on its website
448 and as determined to provide notice to persons with an interest in the business of the Commission.

449 c. The Executive Committee may hold a special meeting in accordance with subsection F.1.b. below.

450 E. The Commission shall adopt and provide to the Member States an annual report.

451 F. Meetings of the Commission:

452 1. All meetings shall be open to the public, except that the Commission may meet in a closed,
453 non-public meeting as provided in subsection F 2 below.

454 a. Public notice for all meetings of the full Commission of meetings shall be given in the same
455 manner as required under the Rulemaking provisions in Section 12, except that the Commission may
456 hold a special meeting as provided in subsection F 1 b below.

457 b. The Commission may hold a special meeting when it must meet to conduct emergency business by
458 giving 48 hours' notice to all commissioners, on the Commission's website, and other means as provided
459 in the Commission's Rules. The Commission's legal counsel shall certify that the Commission's need to
460 meet qualifies as an emergency.

461 2. The Commission or the Executive Committee or other committees of the Commission may convene
462 in a closed, non-public meeting for the Commission or Executive Committee or other committees of the
463 Commission to receive legal advice or to discuss:

464 a. Non-compliance of a Member State with its obligations under the Compact;

465 b. The employment, compensation, discipline, or other matters, practices, or procedures related to
466 specific employees;

467 c. Current or threatened discipline of a Licensee by the Commission or by a Member State's
468 Licensing Authority;

469 d. Current, threatened, or reasonably anticipated litigation;

470 e. Negotiation of contracts for the purchase, lease, or sale of goods, services, or real estate;

471 f. Accusing any person of a crime or formally censuring any person;

472 g. Trade secrets or commercial or financial information that is privileged or confidential;

473 h. Information of a personal nature where disclosure would constitute a clearly unwarranted
474 invasion of personal privacy;

475 i. Investigative records compiled for law enforcement purposes;

476 j. Information related to any investigative reports prepared by or on behalf of or for use of the
477 Commission or other committee charged with responsibility of investigation or determination of
478 compliance issues pursuant to the Compact;

479 k. Matters specifically exempted from disclosure by federal or Member State law; or

480 l. Other matters as promulgated by the Commission by Rule.

481 3. If a meeting, or portion of a meeting, is closed, the presiding officer shall state that the meeting
482 will be closed and reference each relevant exempting provision, and such reference shall be recorded in
483 the minutes.

484 4. The Commission shall keep minutes that fully and clearly describe all matters discussed in a
485 meeting and shall provide a full and accurate summary of actions taken, and the reasons therefore,
486 including a description of the views expressed. All documents considered in connection with an action
487 shall be identified in such minutes. All minutes and documents of a closed meeting shall remain under
488 seal, subject to release only by a majority vote of the Commission or order of a court of competent
489 jurisdiction.

490 *G. Financing of the Commission:*

491 *1. The Commission shall pay, or provide for the payment of, the reasonable expenses of its*
 492 *establishment, organization, and ongoing activities.*

493 *2. The Commission may accept any and all appropriate revenue sources as provided in subsection C*
 494 *13.*

495 *3. The Commission may levy on and collect an annual assessment from each Member State and*
 496 *impose fees on Licensees of Member States to whom it grants a Multistate License to cover the cost of*
 497 *the operations and activities of the Commission and its staff, which must be in a total amount sufficient*
 498 *to cover its annual budget as approved each year for which revenue is not provided by other sources.*
 499 *The aggregate annual assessment amount for Member States shall be allocated based upon a formula*
 500 *that the Commission shall promulgate by Rule.*

501 *4. The Commission shall not incur obligations of any kind prior to securing the funds adequate to*
 502 *meet the same; nor shall the Commission pledge the credit of any of the Member States, except by and*
 503 *with the authority of the Member State.*

504 *5. The Commission shall keep accurate accounts of all receipts and disbursements. The receipts and*
 505 *disbursements of the Commission shall be subject to the financial review and accounting procedures*
 506 *established under its bylaws. However, all receipts and disbursements of funds handled by the*
 507 *Commission shall be subject to an annual financial review by a certified or licensed public accountant,*
 508 *and the report of the financial review shall be included in and become part of the annual report of the*
 509 *Commission.*

510 *H. Qualified Immunity, Defense, and Indemnification:*

511 *1. The members, officers, executive director, employees, and representatives of the Commission shall*
 512 *be immune from suit and liability, both personally and in their official capacity, for any claim for*
 513 *damage to or loss of property or personal injury or other civil liability caused by or arising out of any*
 514 *actual or alleged act, error, or omission that occurred, or that the person against whom the claim is*
 515 *made had a reasonable basis for believing occurred within the scope of Commission employment, duties,*
 516 *or responsibilities; provided that nothing in this paragraph shall be construed to protect any such*
 517 *person from suit or liability for any damage, loss, injury, or liability caused by the intentional or willful*
 518 *or wanton misconduct of that person. The procurement of insurance of any type by the Commission*
 519 *shall not in any way compromise or limit the immunity granted hereunder.*

520 *2. The Commission shall defend any member, officer, executive director, employee, and*
 521 *representative of the Commission in any civil action seeking to impose liability arising out of any actual*
 522 *or alleged act, error, or omission that occurred within the scope of Commission employment, duties, or*
 523 *responsibilities, or as determined by the Commission that the person against whom the claim is made*
 524 *had a reasonable basis for believing occurred within the scope of Commission employment, duties, or*
 525 *responsibilities; provided that nothing herein shall be construed to prohibit that person from retaining*
 526 *their own counsel at their own expense; and provided further, that the actual or alleged act, error, or*
 527 *omission did not result from that person's intentional or willful or wanton misconduct.*

528 *3. The Commission shall indemnify and hold harmless any member, officer, executive director,*
 529 *employee, and representative of the Commission for the amount of any settlement or judgment obtained*
 530 *against that person arising out of any actual or alleged act, error, or omission that occurred within the*
 531 *scope of Commission employment, duties, or responsibilities, or that such person had a reasonable basis*
 532 *for believing occurred within the scope of Commission employment, duties, or responsibilities, provided*
 533 *that the actual or alleged act, error, or omission did not result from the intentional or willful or wanton*
 534 *misconduct of that person.*

535 *4. Nothing herein shall be construed as a limitation on the liability of any Licensee for professional*
 536 *malpractice or misconduct, which shall be governed solely by any other applicable State laws.*

537 *5. Nothing in this Compact shall be interpreted to waive or otherwise abrogate a Member State's*
 538 *state action immunity or state action affirmative defense with respect to antitrust claims under the*
 539 *Sherman Act, Clayton Act, or any other State or federal antitrust or anticompetitive law or regulation.*

540 *6. Nothing in this Compact shall be construed to be a waiver of sovereign immunity by the Member*
 541 *States or by the Commission.*

542 *Section 11.*
 543 *Data System.*

544 *A. The Commission shall provide for the development, maintenance, operation, and utilization of a*
 545 *coordinated Data System.*

546 *B. The Commission shall assign each applicant for a Multistate License a unique identifier, as*
 547 *determined by the Rules of the Commission.*

548 *C. Notwithstanding any other provision of State law to the contrary, a Member State shall submit a*
 549 *uniform data set to the Data System on all individuals to whom this Compact is applicable as required*
 550 *by the Rules of the Commission, including:*

- 551 1. Identifying information;
 552 2. Licensure data;
 553 3. Adverse Actions against a license and information related thereto;
 554 4. Non-confidential information related to Alternative Program participation, the beginning and
 555 ending dates of such participation, and other information related to such participation not made
 556 confidential under Member State law;
 557 5. Any denial of application for licensure, and the reason(s) for such denial;
 558 6. The presence of Current Significant Investigative Information; and
 559 7. Other information that may facilitate the administration of this Compact or the protection of the
 560 public, as determined by the Rules of the Commission.

561 D. The records and information provided to a Member State pursuant to this Compact or through
 562 the Data System, when certified by the Commission or an agent thereof, shall constitute the
 563 authenticated business records of the Commission, and shall be entitled to any associated hearsay
 564 exception in any relevant judicial, quasi-judicial or administrative proceedings in a Member State.

565 E. Current Significant Investigative Information pertaining to a Licensee in any Member State will
 566 only be available to other Member States.

567 It is the responsibility of the Member States to report any Adverse Action against a Licensee and to
 568 monitor the database to determine whether Adverse Action has been taken against a Licensee. Adverse
 569 Action information pertaining to a Licensee in any Member State will be available to any other Member
 570 State.

571 F. Member States contributing information to the Data System may designate information that may
 572 not be shared with the public without the express permission of the contributing State. Any information
 573 submitted to the Data System that is subsequently expunged pursuant to federal law or the laws of the
 574 Member State contributing the information shall be removed from the Data System.

575 Section 12.

576 Rulemaking.

577 A. The Commission shall promulgate reasonable Rules in order to effectively and efficiently
 578 implement and administer the purposes and provisions of the Compact. A Rule shall be invalid and have
 579 no force or effect only if a court of competent jurisdiction holds that the Rule is invalid because the
 580 Commission exercised its rulemaking authority in a manner that is beyond the scope and purposes of
 581 the Compact, or the powers granted hereunder, or based upon another applicable standard of review.

582 B. The Rules of the Commission shall have the force of law in each Member State, provided however
 583 that where the Rules of the Commission conflict with the laws of the Member State that establish the
 584 Member State's laws, regulations, and applicable standards that govern the practice of Social Work as
 585 held by a court of competent jurisdiction, the Rules of the Commission shall be ineffective in that State
 586 to the extent of the conflict.

587 C. The Commission shall exercise its Rulemaking powers pursuant to the criteria set forth in this
 588 Section and the Rules adopted thereunder. Rules shall become binding on the day following adoption or
 589 the date specified in the rule or amendment, whichever is later.

590 D. If a majority of the legislatures of the Member States rejects a Rule or portion of a Rule, by
 591 enactment of a statute or resolution in the same manner used to adopt the Compact within four (4)
 592 years of the date of adoption of the Rule, then such Rule shall have no further force and effect in any
 593 Member State.

594 E. Rules shall be adopted at a regular or special meeting of the Commission.

595 F. Prior to adoption of a proposed Rule, the Commission shall hold a public hearing and allow
 596 persons to provide oral and written comments, data, facts, opinions, and arguments.

597 G. Prior to adoption of a proposed Rule by the Commission, and at least thirty (30) days in advance
 598 of the meeting at which the Commission will hold a public hearing on the proposed Rule, the
 599 Commission shall provide a Notice of Proposed Rulemaking:

- 600 1. On the website of the Commission or other publicly accessible platform;
 601 2. To persons who have requested notice of the Commission's notices of proposed rulemaking; and
 602 3. In such other way(s) as the Commission may by Rule specify.

603 H. The Notice of Proposed Rulemaking shall include:

604 1. The time, date, and location of the public hearing at which the Commission will hear public
 605 comments on the proposed Rule and, if different, the time, date, and location of the meeting where the
 606 Commission will consider and vote on the proposed Rule;

607 2. If the hearing is held via telecommunication, video conference, or other electronic means, the
 608 Commission shall include the mechanism for access to the hearing in the Notice of Proposed
 609 Rulemaking;

610 3. The text of the proposed Rule and the reason therefor;

611 4. A request for comments on the proposed Rule from any interested person; and

612 5. The manner in which interested persons may submit written comments.

613 I. All hearings will be recorded. A copy of the recording and all written comments and documents
614 received by the Commission in response to the proposed Rule shall be available to the public.

615 J. Nothing in this Section shall be construed as requiring a separate hearing on each Rule. Rules
616 may be grouped for the convenience of the Commission at hearings required by this Section.

617 K. The Commission shall, by majority vote of all members, take final action on the proposed Rule
618 based on the Rulemaking record and the full text of the Rule.

619 1. The Commission may adopt changes to the proposed Rule provided the changes do not enlarge
620 the original purpose of the proposed Rule.

621 2. The Commission shall provide an explanation of the reasons for substantive changes made to the
622 proposed Rule as well as reasons for substantive changes not made that were recommended by
623 commenters.

624 3. The Commission shall determine a reasonable effective date for the Rule. Except for an emergency
625 as provided in Section 12 L, the effective date of the Rule shall be no sooner than 30 days after issuing
626 the notice that it adopted or amended the Rule.

627 L. Upon determination that an emergency exists, the Commission may consider and adopt an
628 emergency Rule with 48 hours' notice, with opportunity to comment, provided that the usual Rulemaking
629 procedures provided in the Compact and in this Section shall be retroactively applied to the Rule as
630 soon as reasonably possible, in no event later than ninety (90) days after the effective date of the Rule.
631 For the purposes of this provision, an emergency Rule is one that must be adopted immediately in order
632 to:

633 1. Meet an imminent threat to public health, safety, or welfare;

634 2. Prevent a loss of Commission or Member State funds;

635 3. Meet a deadline for the promulgation of a Rule that is established by federal law or rule; or

636 4. Protect public health and safety.

637 M. The Commission or an authorized committee of the Commission may direct revisions to a
638 previously adopted Rule for purposes of correcting typographical errors, errors in format, errors in
639 consistency, or grammatical errors. Public notice of any revisions shall be posted on the website of the
640 Commission. The revision shall be subject to challenge by any person for a period of thirty (30) days
641 after posting. The revision may be challenged only on grounds that the revision results in a material
642 change to a Rule. A challenge shall be made in writing and delivered to the Commission prior to the
643 end of the notice period. If no challenge is made, the revision will take effect without further action. If
644 the revision is challenged, the revision may not take effect without the approval of the Commission.

645 N. No Member State's rulemaking requirements shall apply under this compact.

646 Section 13.

647 Oversight, Dispute Resolution, And Enforcement.

648 A. Oversight:

649 1. The executive and judicial branches of State government in each Member State shall enforce this
650 Compact and take all actions necessary and appropriate to implement the Compact.

651 2. Except as otherwise provided in this Compact, venue is proper and judicial proceedings by or
652 against the Commission shall be brought solely and exclusively in a court of competent jurisdiction
653 where the principal office of the Commission is located. The Commission may waive venue and
654 jurisdictional defenses to the extent it adopts or consents to participate in alternative dispute resolution
655 proceedings. Nothing herein shall affect or limit the selection or propriety of venue in any action
656 against a Licensee for professional malpractice, misconduct, or any such similar matter.

657 3. The Commission shall be entitled to receive service of process in any proceeding regarding the
658 enforcement or interpretation of the Compact and shall have standing to intervene in such a proceeding
659 for all purposes. Failure to provide the Commission service of process shall render a judgment or order
660 void as to the Commission, this Compact, or promulgated Rules.

661 B. Default, Technical Assistance, and Termination:

662 1. If the Commission determines that a Member State has defaulted in the performance of its
663 obligations or responsibilities under this Compact or the promulgated Rules, the Commission shall
664 provide written notice to the defaulting State. The notice of default shall describe the default, the
665 proposed means of curing the default, and any other action that the Commission may take, and shall
666 offer training and specific technical assistance regarding the default.

667 2. The Commission shall provide a copy of the notice of default to the other Member States.

668 C. If a State in default fails to cure the default, the defaulting State may be terminated from the
669 Compact upon an affirmative vote of a majority of the delegates of the Member States, and all rights,
670 privileges, and benefits conferred on that State by this Compact may be terminated on the effective date
671 of termination. A cure of the default does not relieve the offending State of obligations or liabilities
672 incurred during the period of default.

673 D. Termination of membership in the Compact shall be imposed only after all other means of

674 *securing compliance have been exhausted. Notice of intent to suspend or terminate shall be given by the*
 675 *Commission to the governor, the majority and minority leaders of the defaulting State's legislature, the*
 676 *defaulting State's State Licensing Authority and each of the Member States' State Licensing Authority.*

677 *E. A State that has been terminated is responsible for all assessments, obligations, and liabilities*
 678 *incurred through the effective date of termination, including obligations that extend beyond the effective*
 679 *date of termination.*

680 *F. Upon the termination of a State's membership from this Compact, that State shall immediately*
 681 *provide notice to all Licensees within that State of such termination. The terminated State shall continue*
 682 *to recognize all licenses granted pursuant to this Compact for a minimum of six (6) months after the*
 683 *date of said notice of termination.*

684 *G. The Commission shall not bear any costs related to a State that is found to be in default or that*
 685 *has been terminated from the Compact, unless agreed upon in writing between the Commission and the*
 686 *defaulting State.*

687 *H. The defaulting State may appeal the action of the Commission by petitioning the U.S. District*
 688 *Court for the District of Columbia or the federal district where the Commission has its principal offices.*
 689 *The prevailing party shall be awarded all costs of such litigation, including reasonable attorney fees.*

690 *I. Dispute Resolution:*

691 *1. Upon request by a Member State, the Commission shall attempt to resolve disputes related to the*
 692 *Compact that arise among Member States and between Member and non-Member States.*

693 *2. The Commission shall promulgate a Rule providing for both mediation and binding dispute*
 694 *resolution for disputes as appropriate.*

695 *J. Enforcement:*

696 *1. By majority vote as provided by Rule, the Commission may initiate legal action against a Member*
 697 *State in default in the United States District Court for the District of Columbia or the federal district*
 698 *where the Commission has its principal offices to enforce compliance with the provisions of the*
 699 *Compact and its promulgated Rules. The relief sought may include both injunctive relief and damages.*
 700 *In the event judicial enforcement is necessary, the prevailing party shall be awarded all costs of such*
 701 *litigation, including reasonable attorney fees. The remedies herein shall not be the exclusive remedies of*
 702 *the Commission. The Commission may pursue any other remedies available under federal or the*
 703 *defaulting Member State's law.*

704 *2. A Member State may initiate legal action against the Commission in the U.S. District Court for*
 705 *the District of Columbia or the federal district where the Commission has its principal offices to enforce*
 706 *compliance with the provisions of the Compact and its promulgated Rules. The relief sought may include*
 707 *both injunctive relief and damages. In the event judicial enforcement is necessary, the prevailing party*
 708 *shall be awarded all costs of such litigation, including reasonable attorney fees.*

709 *3. No person other than a Member State shall enforce this compact against the Commission.*

710 *Section 14.*

711 *Effective Date, Withdrawal, And Amendment.*

712 *A. The Compact shall come into effect on the date on which the Compact statute is enacted into law*
 713 *in the seventh Member State.*

714 *1. On or after the effective date of the Compact, the Commission shall convene and review the*
 715 *enactment of each of the first seven Member States ("Charter Member States") to determine if the*
 716 *statute enacted by each such Charter Member State is materially different than the model Compact*
 717 *statute.*

718 *a. A Charter Member State whose enactment is found to be materially different from the model*
 719 *Compact statute shall be entitled to the default process set forth in Section 13.*

720 *b. If any Member State is later found to be in default, or is terminated or withdraws from the*
 721 *Compact, the Commission shall remain in existence and the Compact shall remain in effect even if the*
 722 *number of Member States should be less than seven.*

723 *2. Member States enacting the Compact subsequent to the seven initial Charter Member States shall*
 724 *be subject to the process set forth in Section 10 C 21 to determine if their enactments are materially*
 725 *different from the model Compact statute and whether they qualify for participation in the Compact.*

726 *3. All actions taken for the benefit of the Commission or in furtherance of the purposes of the*
 727 *administration of the Compact prior to the effective date of the Compact or the Commission coming into*
 728 *existence shall be considered to be actions of the Commission unless specifically repudiated by the*
 729 *Commission.*

730 *4. Any State that joins the Compact subsequent to the Commission's initial adoption of the Rules and*
 731 *bylaws shall be subject to the Rules and bylaws as they exist on the date on which the Compact*
 732 *becomes law in that State. Any Rule that has been previously adopted by the Commission shall have the*
 733 *full force and effect of law on the day the Compact becomes law in that State.*

734 *B. Any Member State may withdraw from this Compact by enacting a statute repealing the same.*

735 *1. A Member State's withdrawal shall not take effect until 180 days after enactment of the repealing*

736 statute.

737 2. Withdrawal shall not affect the continuing requirement of the withdrawing State's Licensing
738 Authority to comply with the investigative and Adverse Action reporting requirements of this Compact
739 prior to the effective date of withdrawal.

740 3. Upon the enactment of a statute withdrawing from this compact, a State shall immediately provide
741 notice of such withdrawal to all Licensees within that State. Notwithstanding any subsequent statutory
742 enactment to the contrary, such withdrawing State shall continue to recognize all licenses granted
743 pursuant to this compact for a minimum of 180 days after the date of such notice of withdrawal.

744 C. Nothing contained in this Compact shall be construed to invalidate or prevent any licensure
745 agreement or other cooperative arrangement between a Member State and a non-Member State that
746 does not conflict with the provisions of this Compact.

747 D. This Compact may be amended by the Member States. No amendment to this Compact shall
748 become effective and binding upon any Member State until it is enacted into the laws of all Member
749 States.

750 Section 15.

751 Construction and Severability.

752 A. This Compact and the Commission's rulemaking authority shall be liberally construed so as to
753 effectuate the purposes, and the implementation and administration of the Compact. Provisions of the
754 Compact expressly authorizing or requiring the promulgation of Rules shall not be construed to limit the
755 Commission's rulemaking authority solely for those purposes.

756 B. The provisions of this Compact shall be severable and if any phrase, clause, sentence, or
757 provision of this Compact is held by a court of competent jurisdiction to be contrary to the constitution
758 of any Member State, a State seeking participation in the Compact, or of the United States, or the
759 applicability thereof to any government, agency, person, or circumstance is held to be unconstitutional
760 by a court of competent jurisdiction, the validity of the remainder of this Compact and the applicability
761 thereof to any other government, agency, person, or circumstance shall not be affected thereby.

762 C. Notwithstanding subsection B of this Section, the Commission may deny a State's participation in
763 the Compact or, in accordance with the requirements of Section 13.B, terminate a Member State's
764 participation in the Compact, if it determines that a constitutional requirement of a Member State is a
765 material departure from the Compact. Otherwise, if this Compact shall be held to be contrary to the
766 constitution of any Member State, the Compact shall remain in full force and effect as to the remaining
767 Member States and in full force and effect as to the Member State affected as to all severable matters.

768 Section 16.

769 Consistent Effect and Conflict with Other State Laws.

770 A. A Licensee providing services in a Remote State under a Multistate Authorization to Practice shall
771 adhere to the laws and regulations, including laws, regulations, and applicable standards, of the Remote
772 State where the client is located at the time care is rendered.

773 B. Nothing herein shall prevent or inhibit the enforcement of any other law of a Member State that
774 is not inconsistent with the Compact.

775 C. Any laws, statutes, regulations, or other legal requirements in a Member State in conflict with the
776 Compact are superseded to the extent of the conflict.

777 D. All permissible agreements between the Commission and the Member States are binding in
778 accordance with their terms.
