6 Be it enacted by the General Assembly of Virginia:

7 1. That § 18.2-308.014 of the Code of Virginia is amended and reenacted as follows: 8

§ 18.2-308.014. Concealed handgun permits; reciprocity.

9 A. A valid concealed handgun or concealed weapon permit or license issued by another state shall 10 authorize the holder of such permit or license who is at least 21 years of age to carry a concealed handgun in the Commonwealth, provided that (i) the issuing authority provides the means for 11 instantaneous verification of the validity of all such permits or licenses issued within that state, 12 accessible 24 hours a day if available; and (ii) the permit or license holder carries a photo identification 13 issued by a government agency of any state or by the U.S. Department of Defense or U.S. Department 14 15 of State and displays the permit or license and such identification upon demand by a law-enforcement officer; and (iii) the permit or license holder has not previously had a Virginia concealed handgun 16 17 permit revoked except for the age of the permit or license holder and the type of weapon authorized to be carried, the requirements and qualifications of that state's law are adequate to prevent possession of 18 19 a permit or license by persons who would be denied a permit in the Commonwealth under this article. 20 The Superintendent of State Police shall enter into agreements for reciprocal recognition with such other 21 states that require an agreement to be in place before such state will recognize a Virginia concealed handgun permit as valid in such state. The Attorney General shall provide the Superintendent with any 22 23 legal assistance or advice necessary for the Superintendent to perform his duties set forth in this 24 subsection. If the Superintendent determines that another state requires that an agreement for reciprocal 25 recognition be executed by the Attorney General or otherwise formally approved by the Attorney 26 General as a condition of such other state's entering into an agreement for reciprocal recognition, the 27 Attorney General shall (a) execute such agreement or otherwise formally approve such agreement and 28 (b) return to the Superintendent the executed agreement or, in a form deemed acceptable by such other 29 state, documentation of his formal approval of such agreement within 30 days after the Superintendent 30 notifies the Attorney General, in writing, that he is required to execute or otherwise formally approve 31 such agreement The Superintendent of State Police shall (a) in consultation with the Office of the 32 Attorney General determine whether states meet the requirements and qualifications of this subsection, 33 (b) maintain a registry of such states on the Virginia Criminal Information Network (VCIN), and (c) 34 make the registry available to law-enforcement officers for investigative purposes. The Superintendent of 35 State Police, in consultation with the Attorney General, may also enter into agreements for reciprocal

36 recognition with any state qualifying for recognition under this subsection.

37 B. For the purposes of participation in concealed handgun reciprocity agreements with other 38 jurisdictions, the official government-issued law-enforcement identification card issued to an active-duty 39 law-enforcement officer in the Commonwealth who is exempt from obtaining a concealed handgun 40 permit under this article shall be deemed a concealed handgun permit.

41 C. A Virginia resident who has not been issued a valid concealed handgun permit pursuant to 42 § 18.2-308.02 may not use a concealed handgun or concealed weapon permit or license issued by 43 another state to carry a concealed handgun in the Commonwealth.

2. That the Superintendent of State Police, in consultation with the Office of the Attorney General, 44 45 shall review any agreements for reciprocal recognition that are in place with any other states pursuant to § 18.2-308.014 of the Code of Virginia as of July 1, 2024, to determine whether the 46 requirements and qualifications of those states' laws are adequate to prevent possession of a 47 permit or license by persons who would be denied a permit in the Commonwealth as required by **48** § 18.2-308.014 of the Code of Virginia, as amended by this act, and revoke any reciprocity 49 50 agreement or recognition of any states that do not meet such requirements or qualifications by December 1, 2024. The Attorney General shall provide a written explanation for any 51 52 determination that a state's laws are adequate to prevent possession of such permit or license by 53 persons who would be denied such permit in the Commonwealth.
